FIG. 16 is a front elevational view thereof, the undisclosed rear being the same;

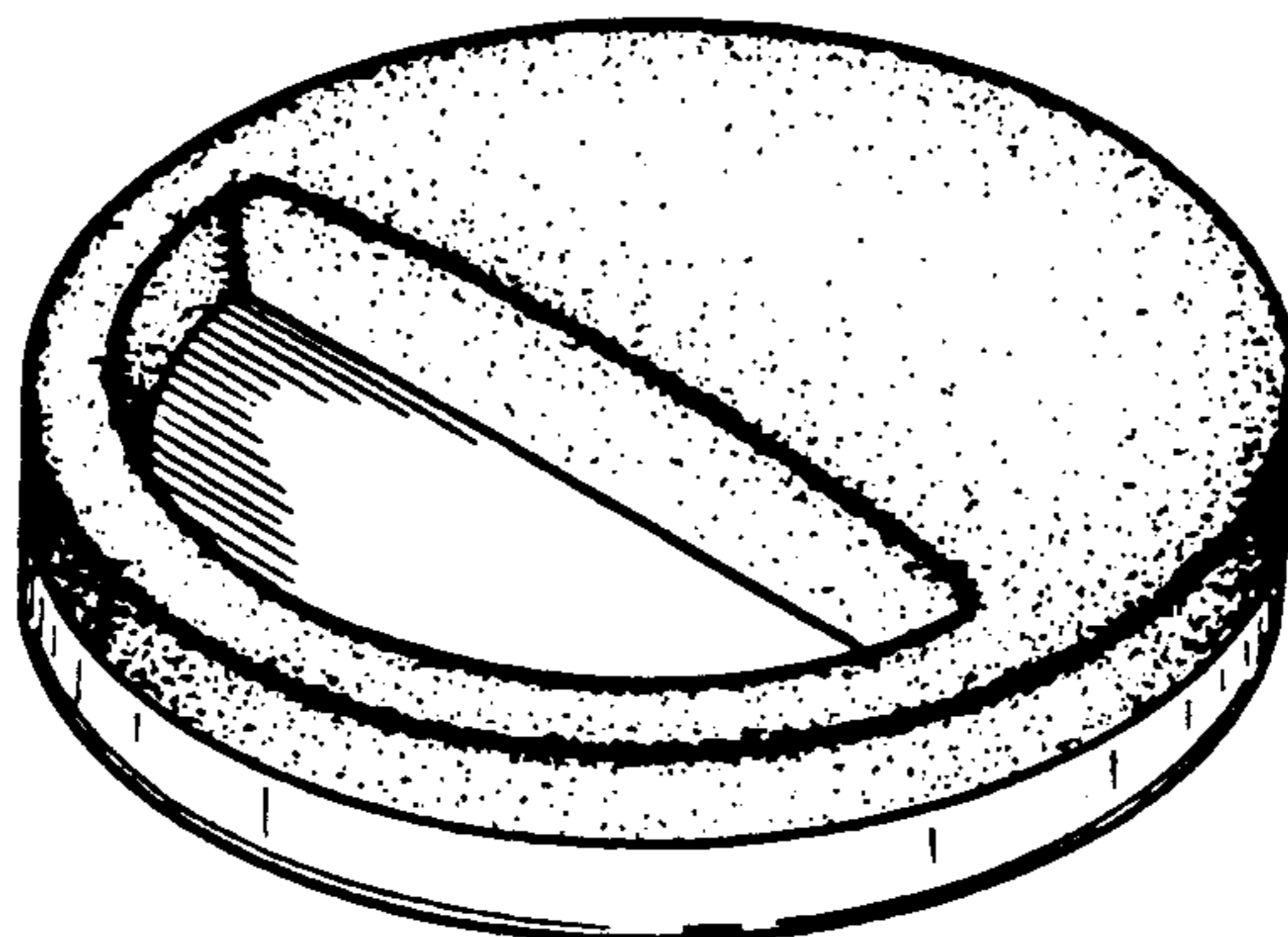
FIG. 17 is a top perspective view of a fourth embodiment of FIG. 1;

FIG. 18 is a bottom perspective view thereof;

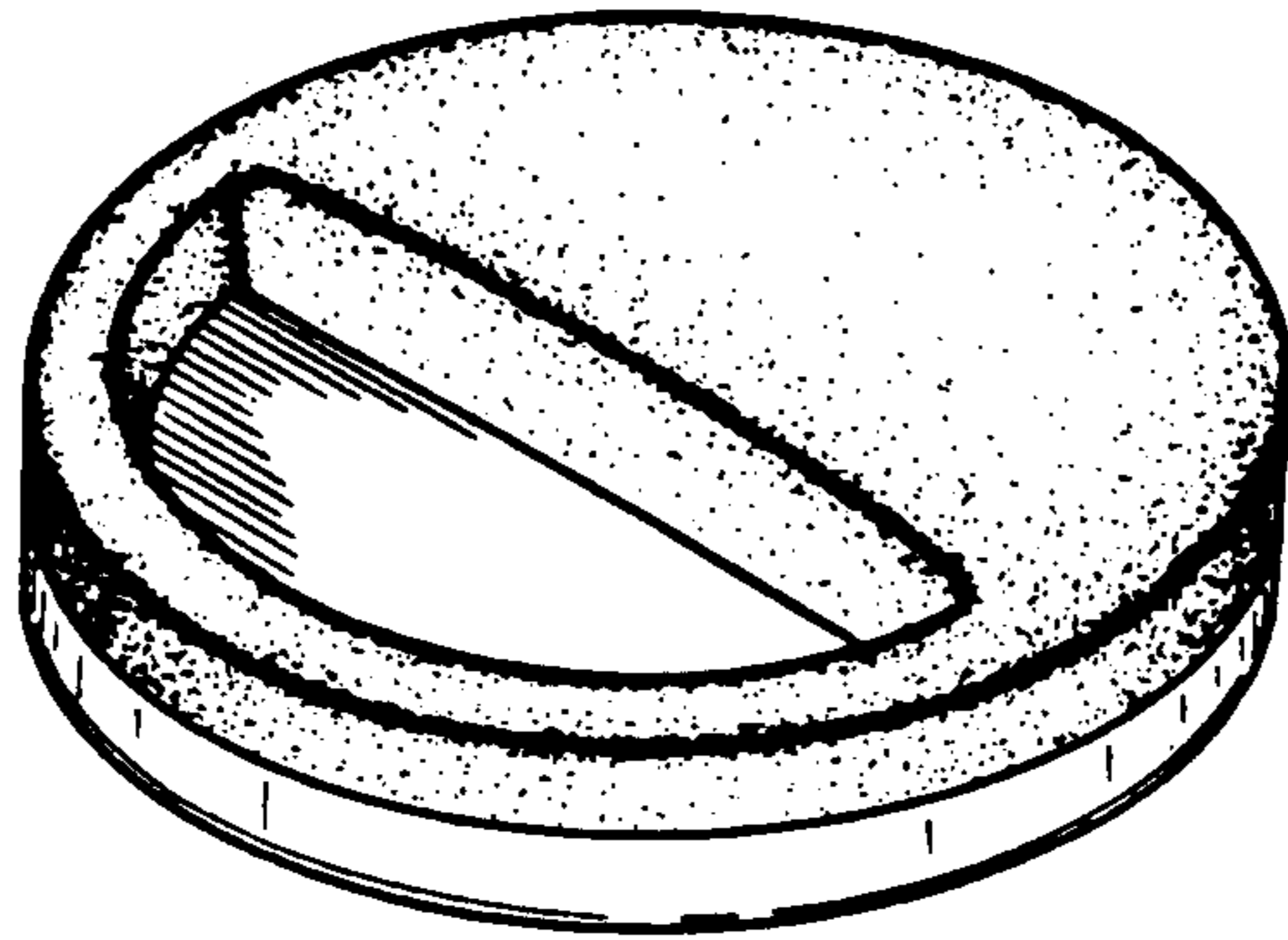
FIG. 19 is a top plan view thereof;

FIG. 20 is a bottom plan view thereof; and

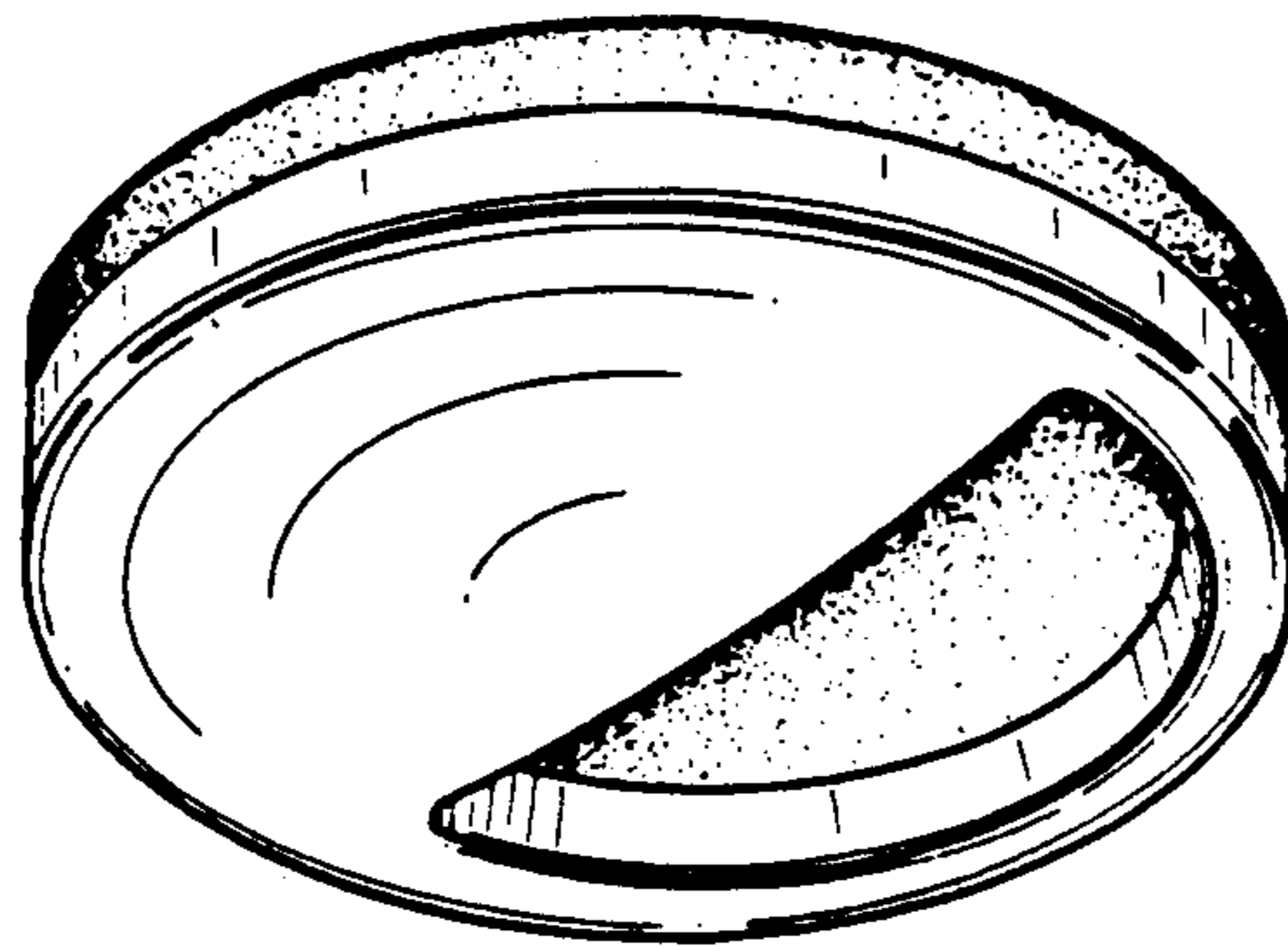
FIG. 21 is a side elevational view thereof, the undisclosed sides being the same;



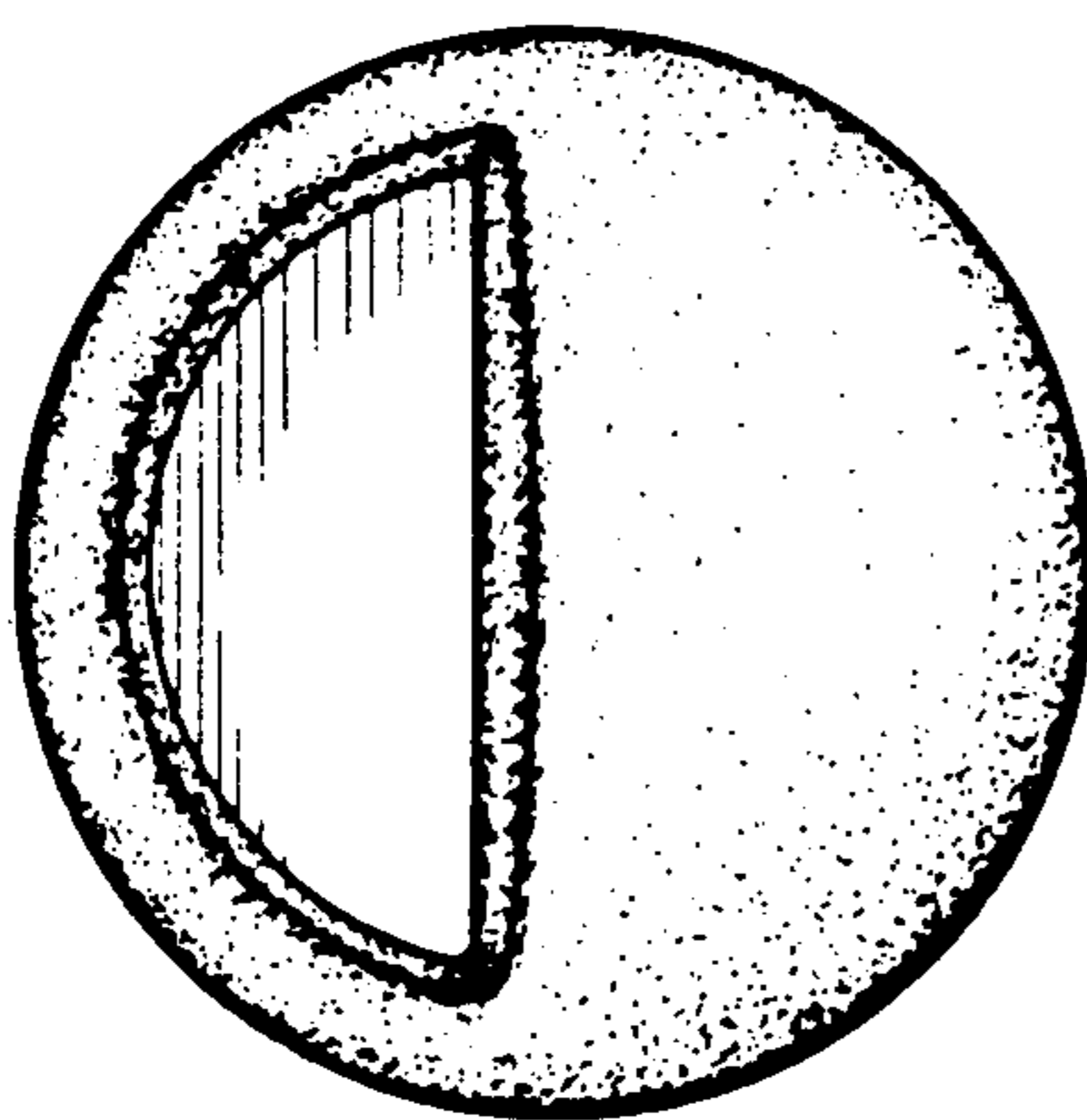

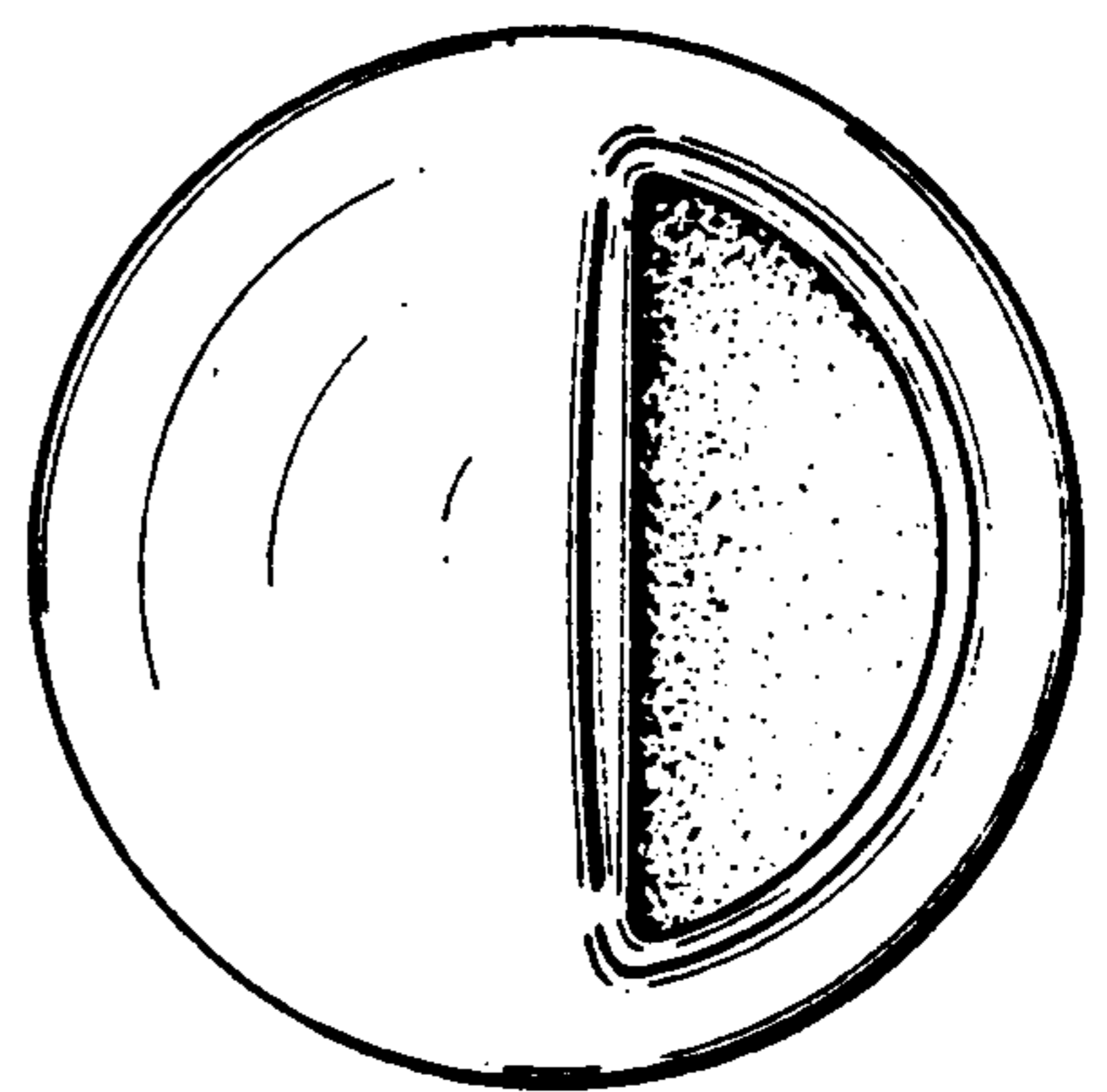

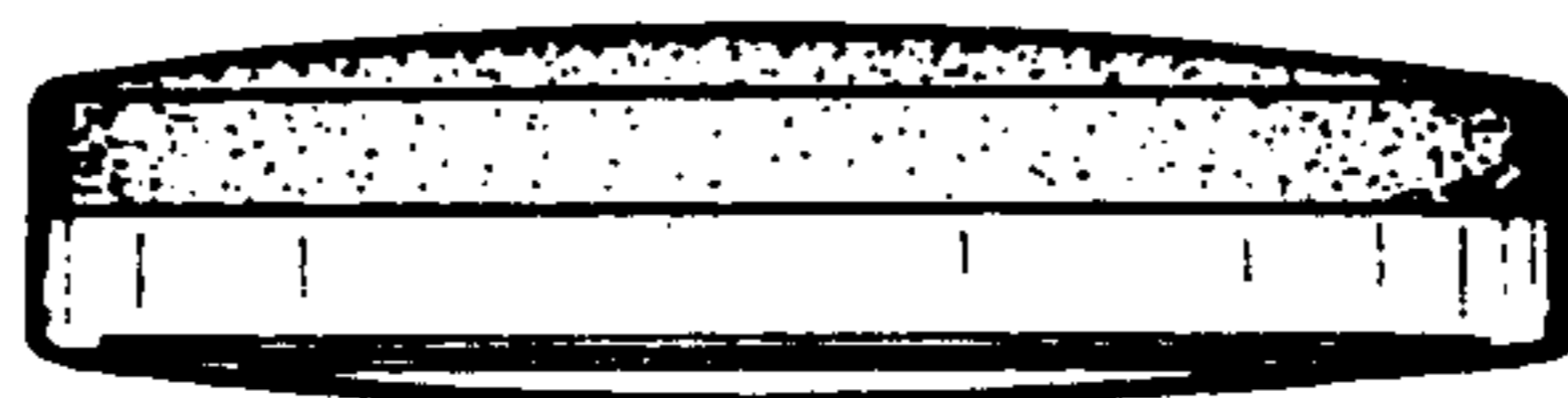

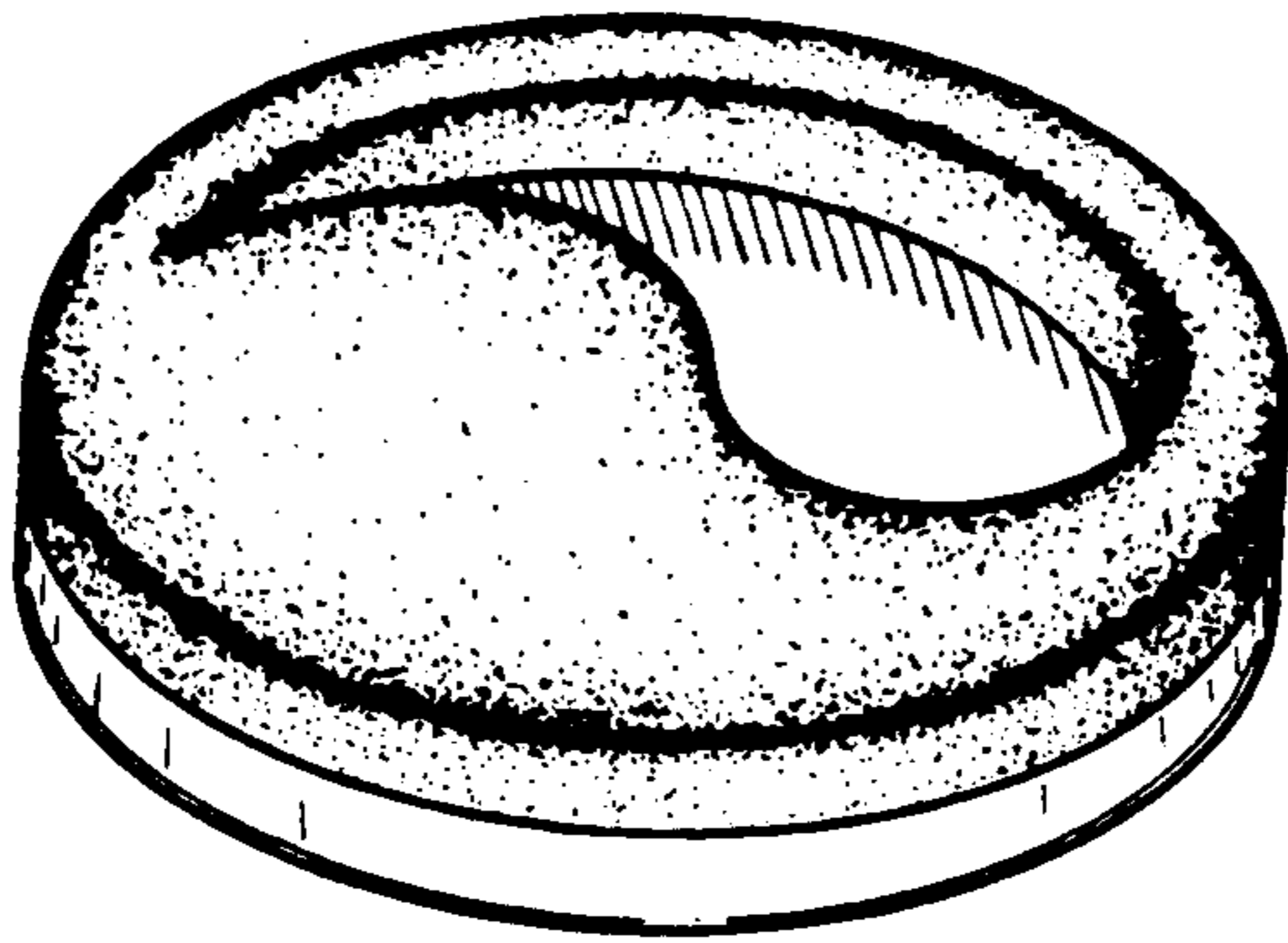

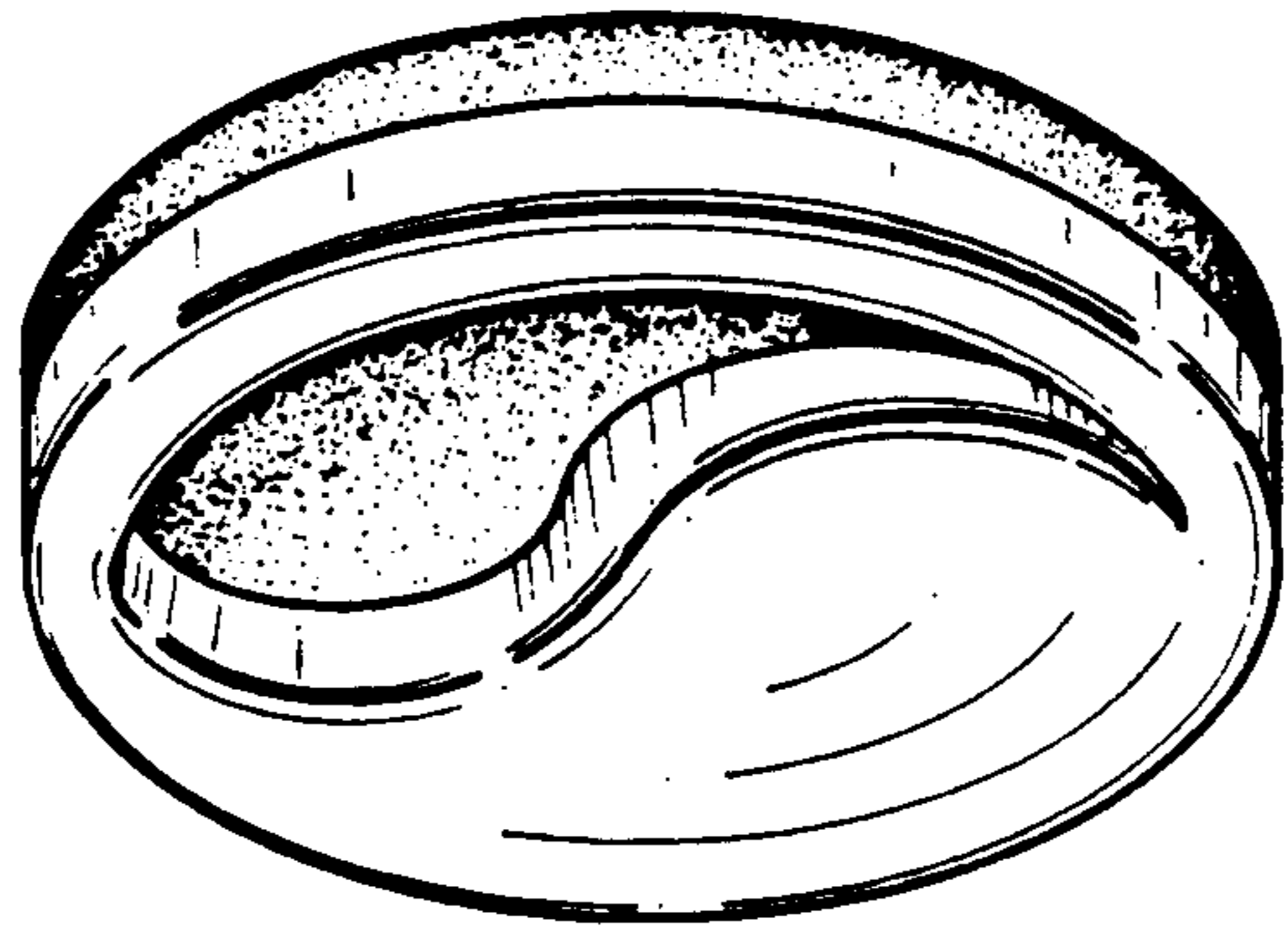

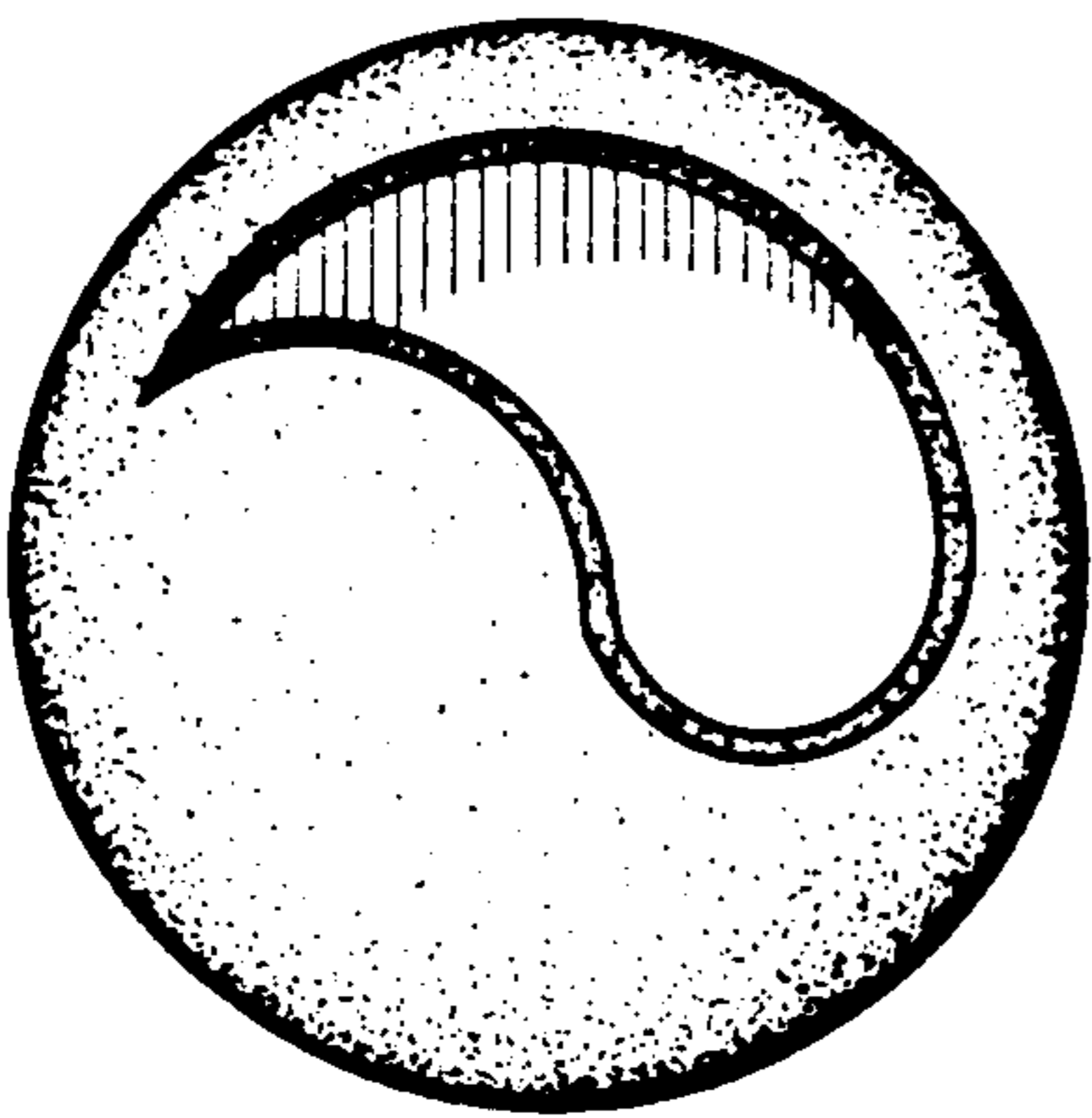

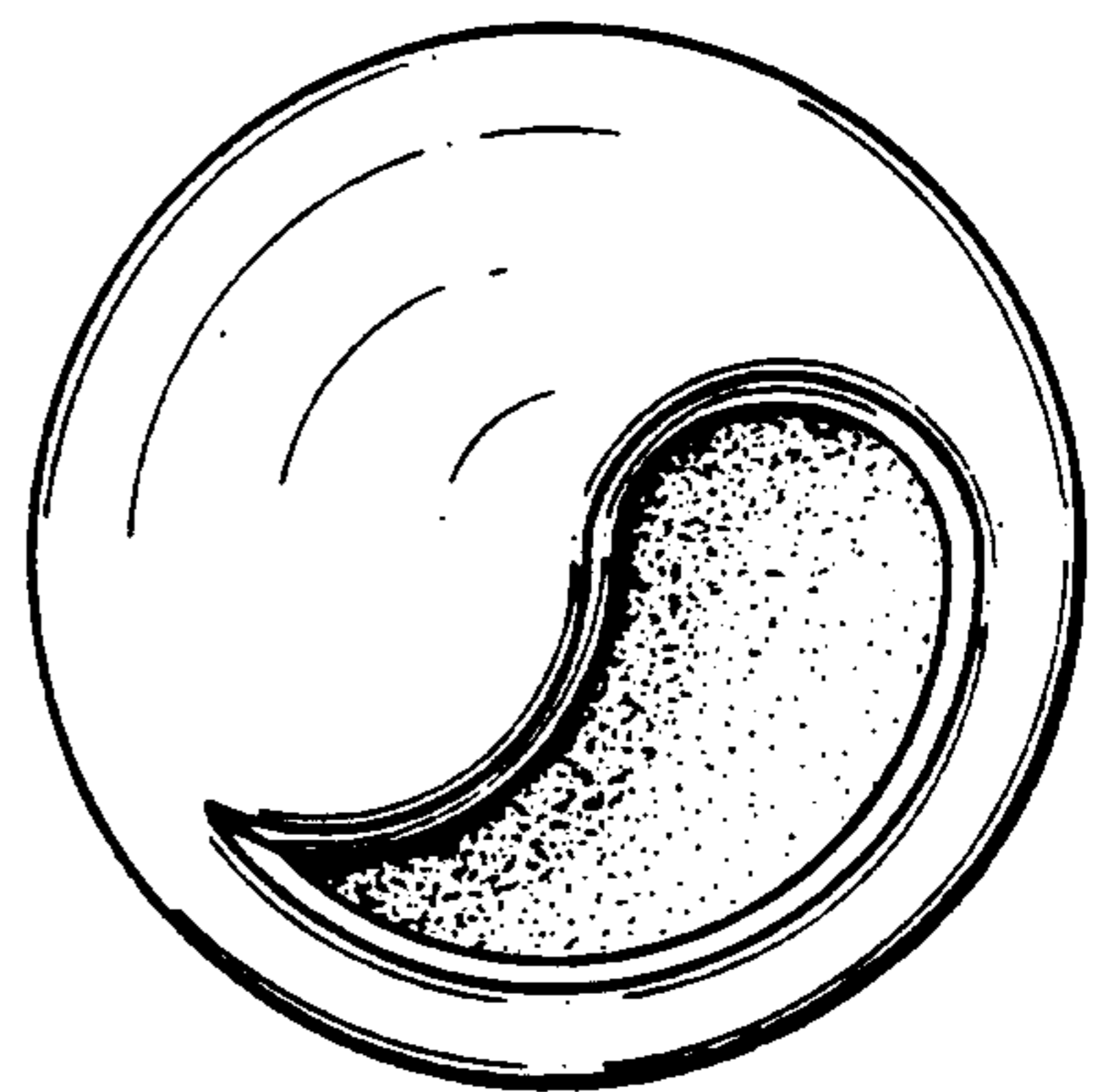
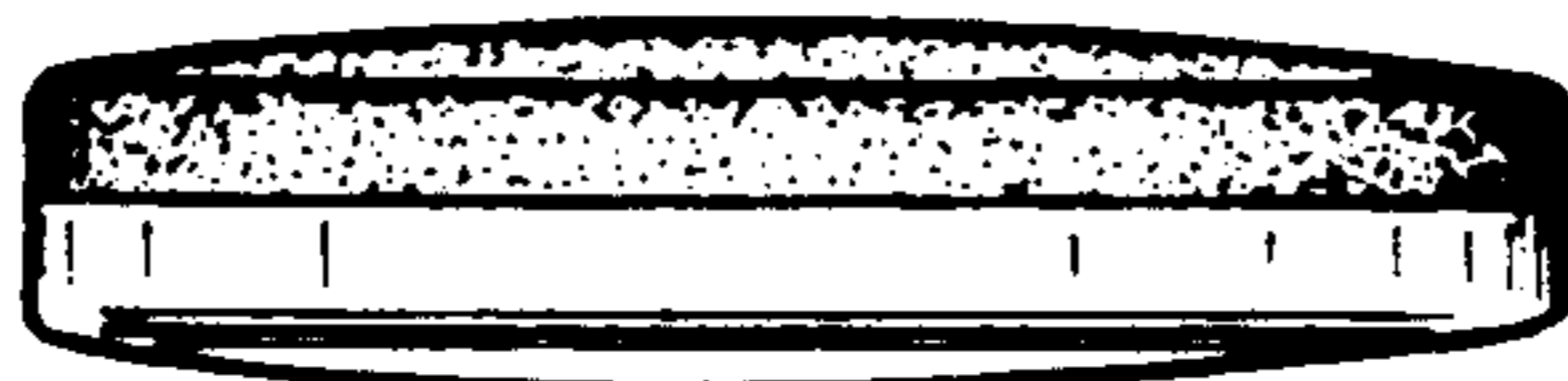
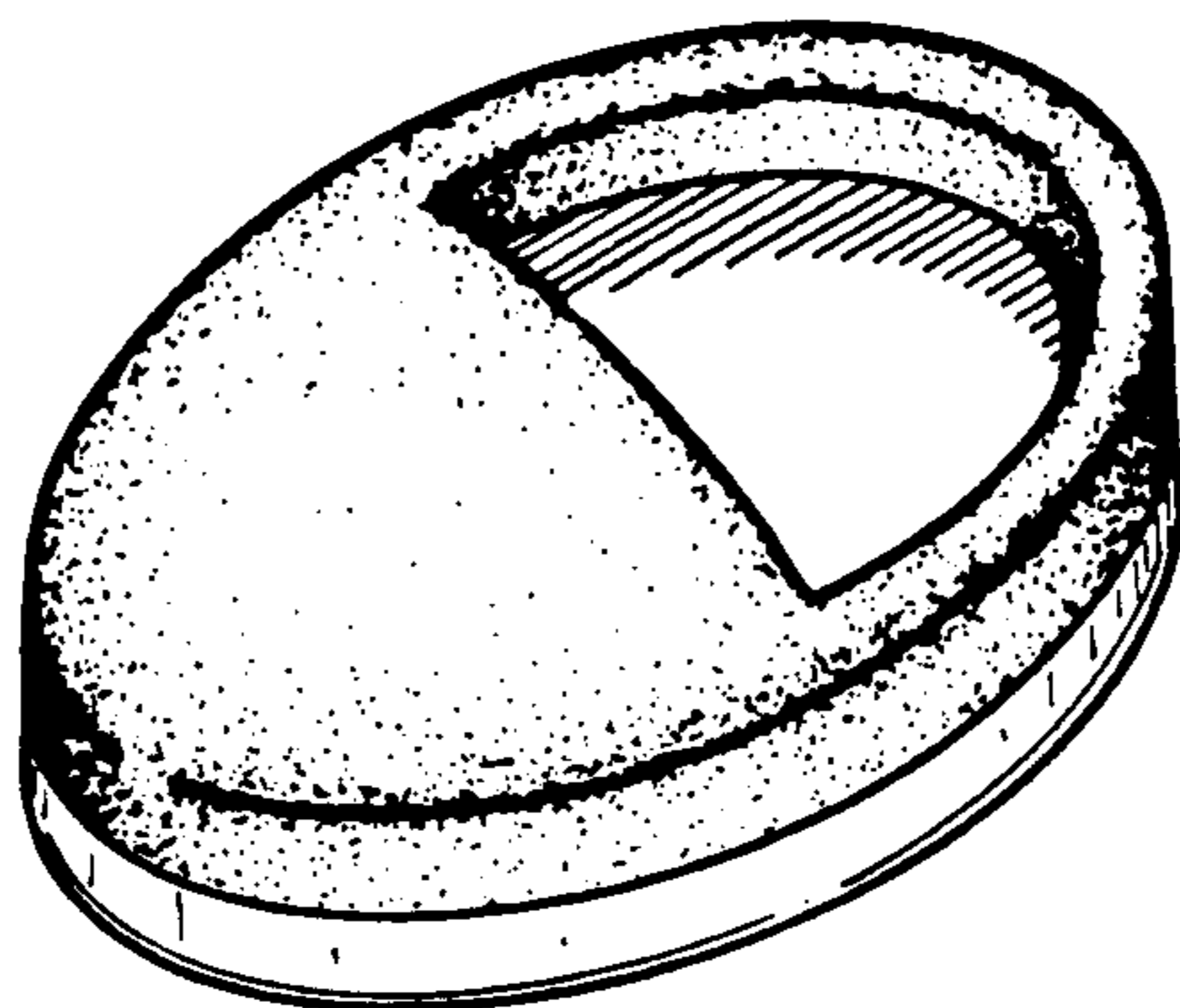

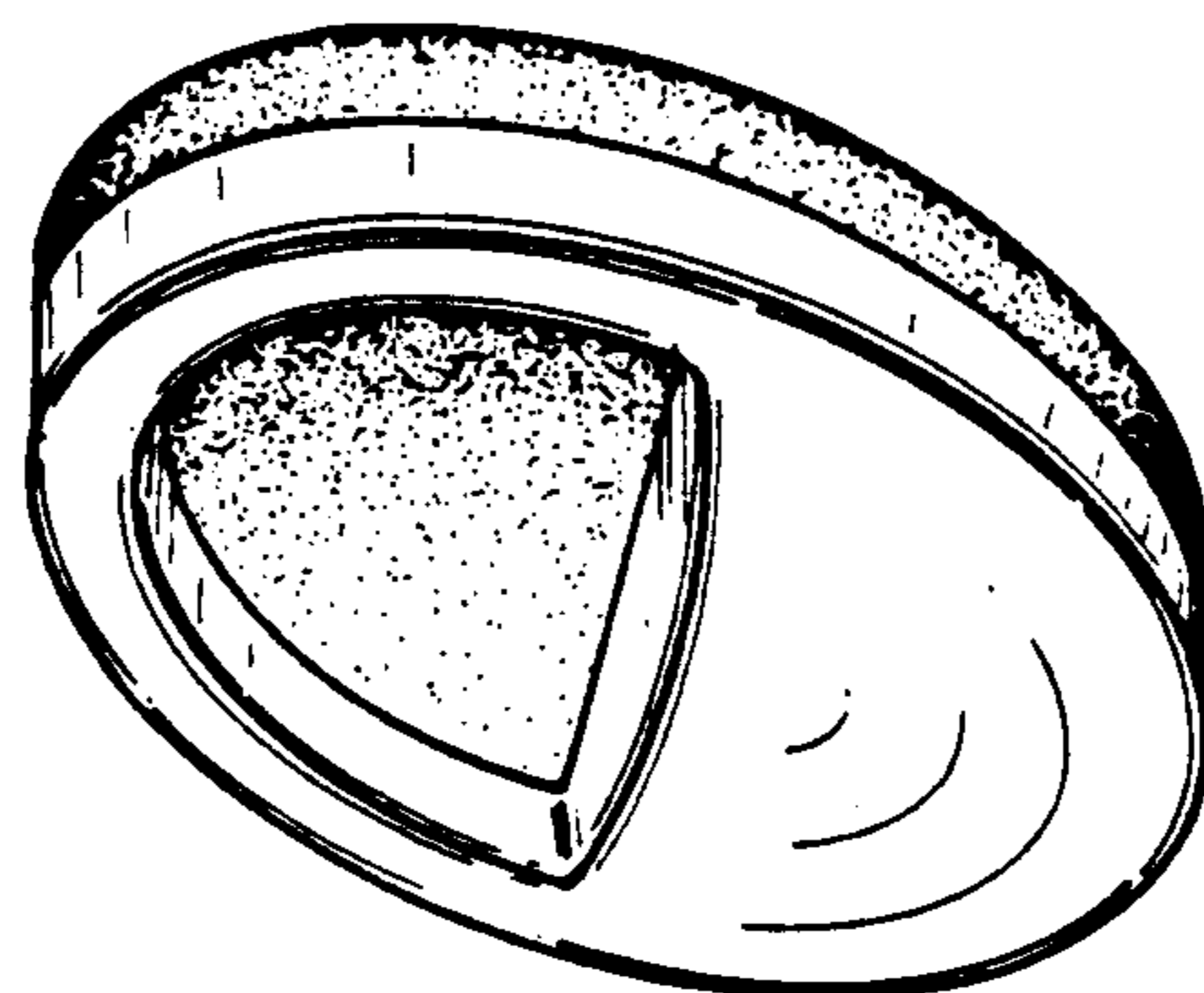




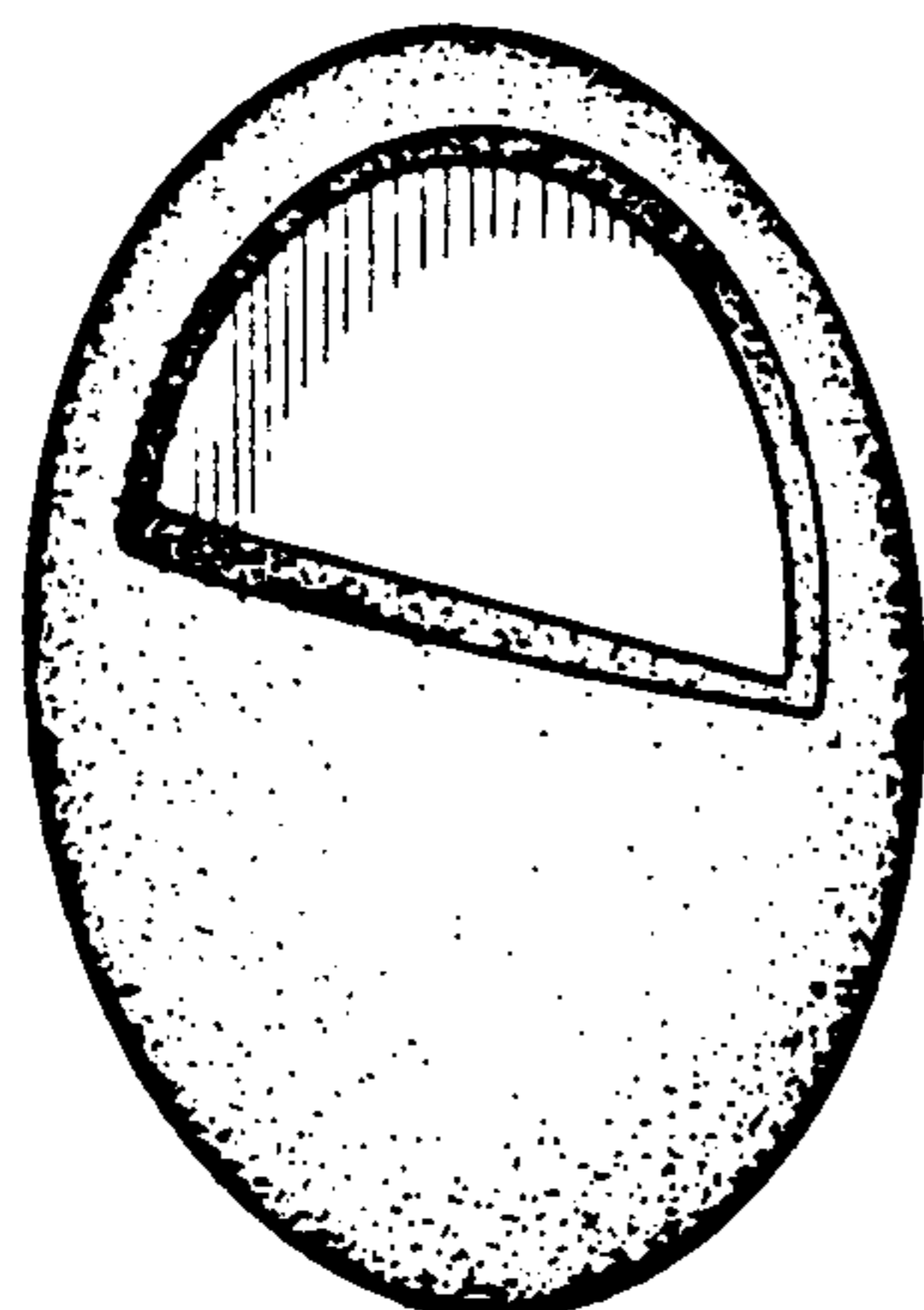

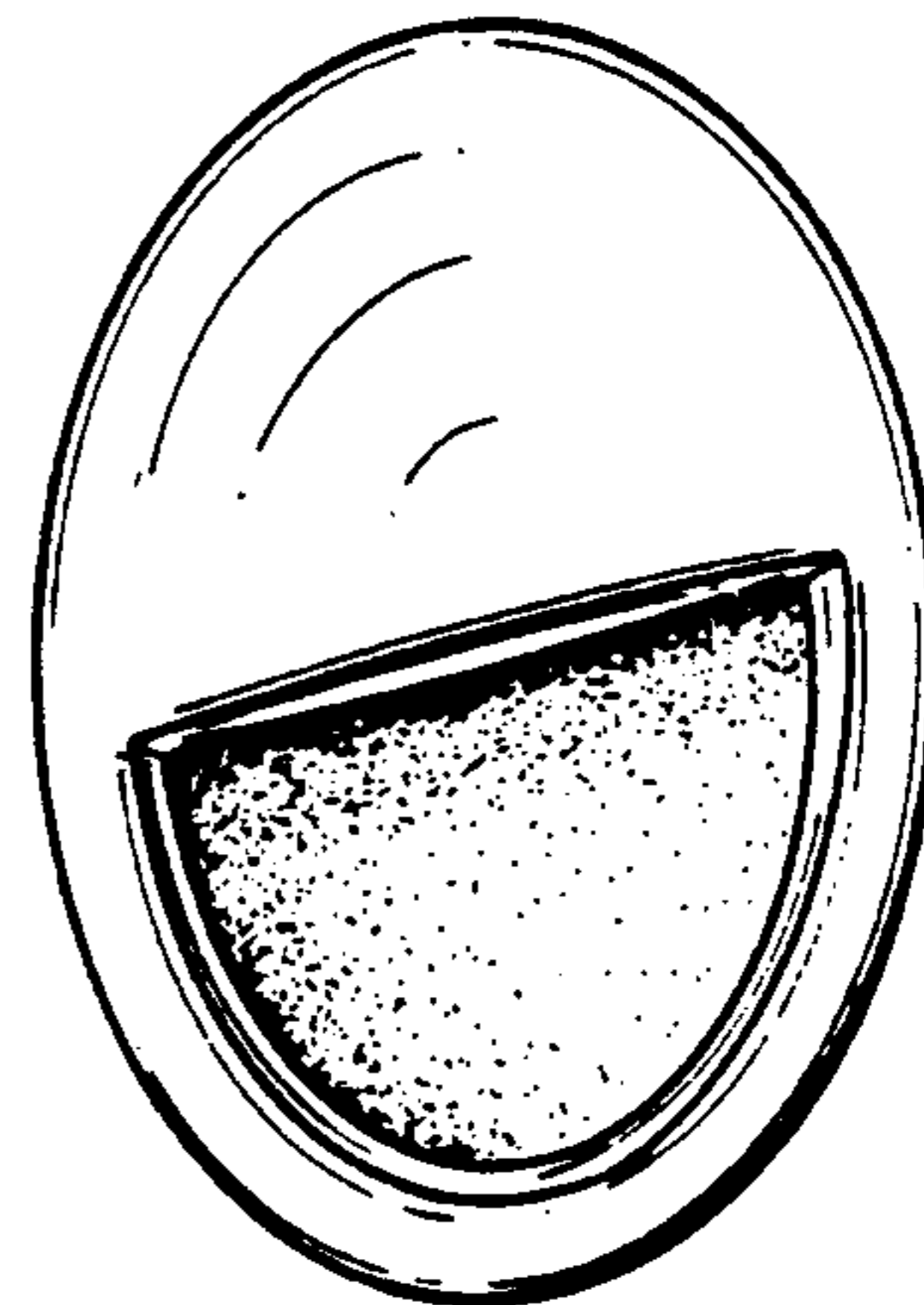

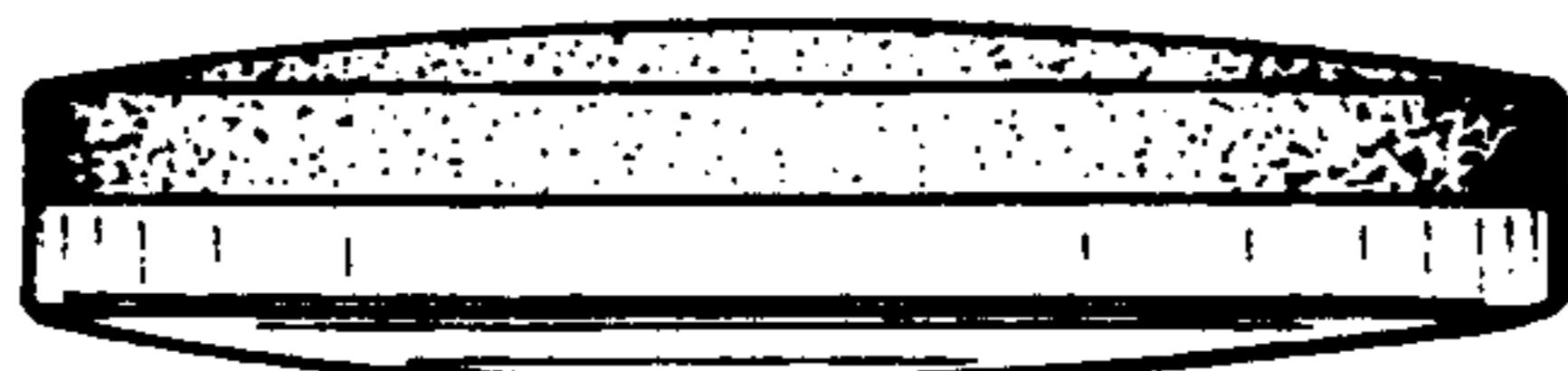

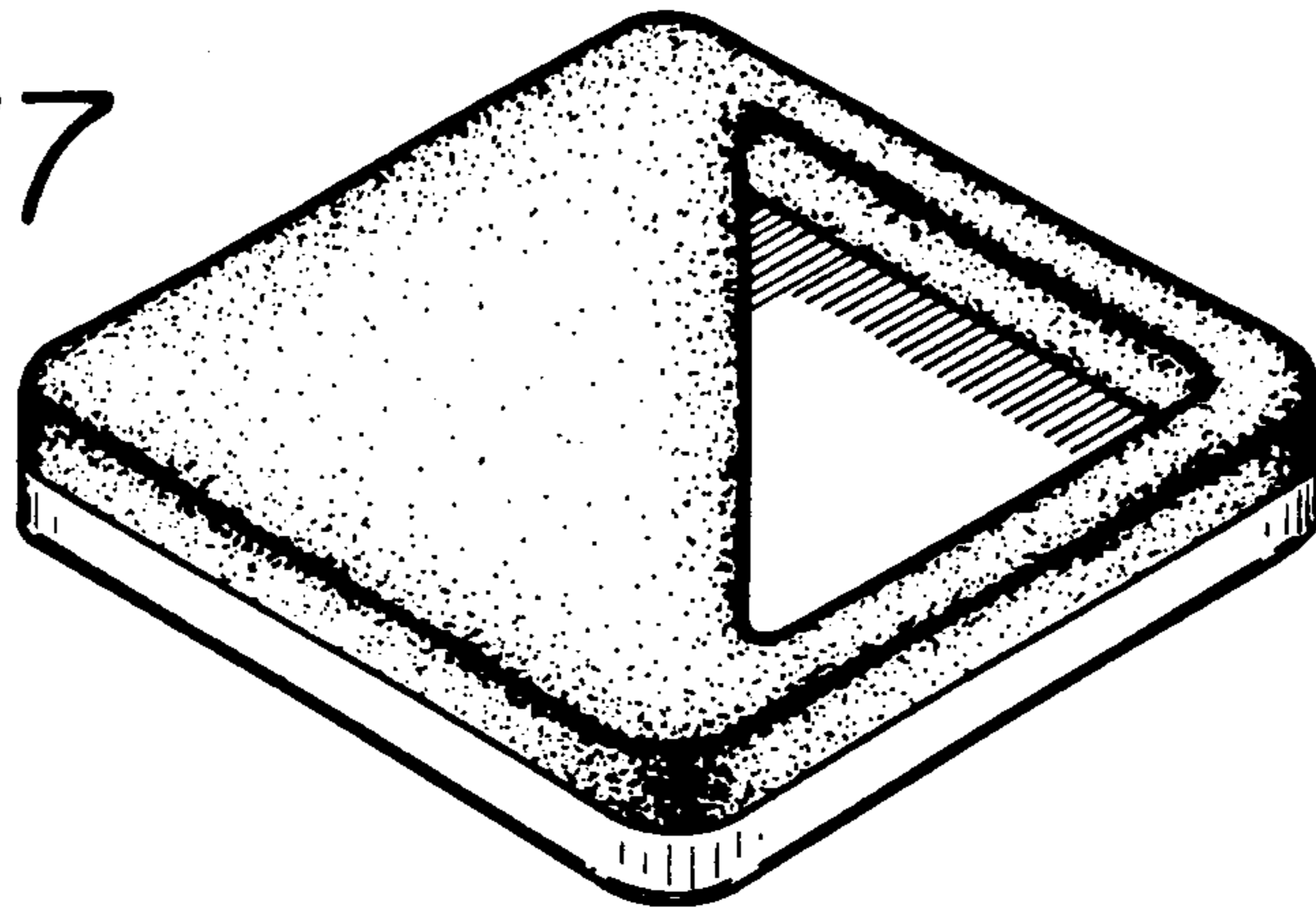

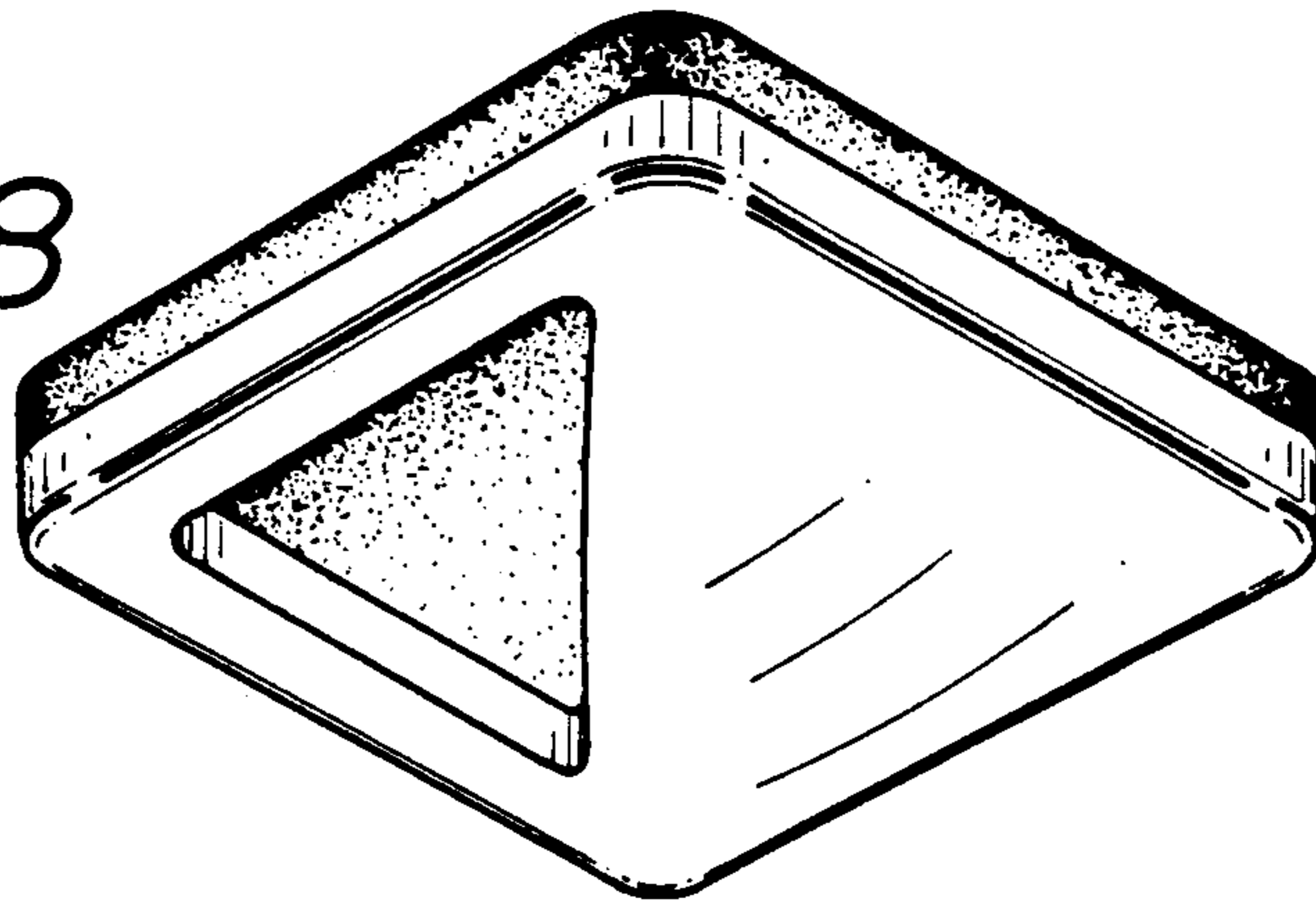

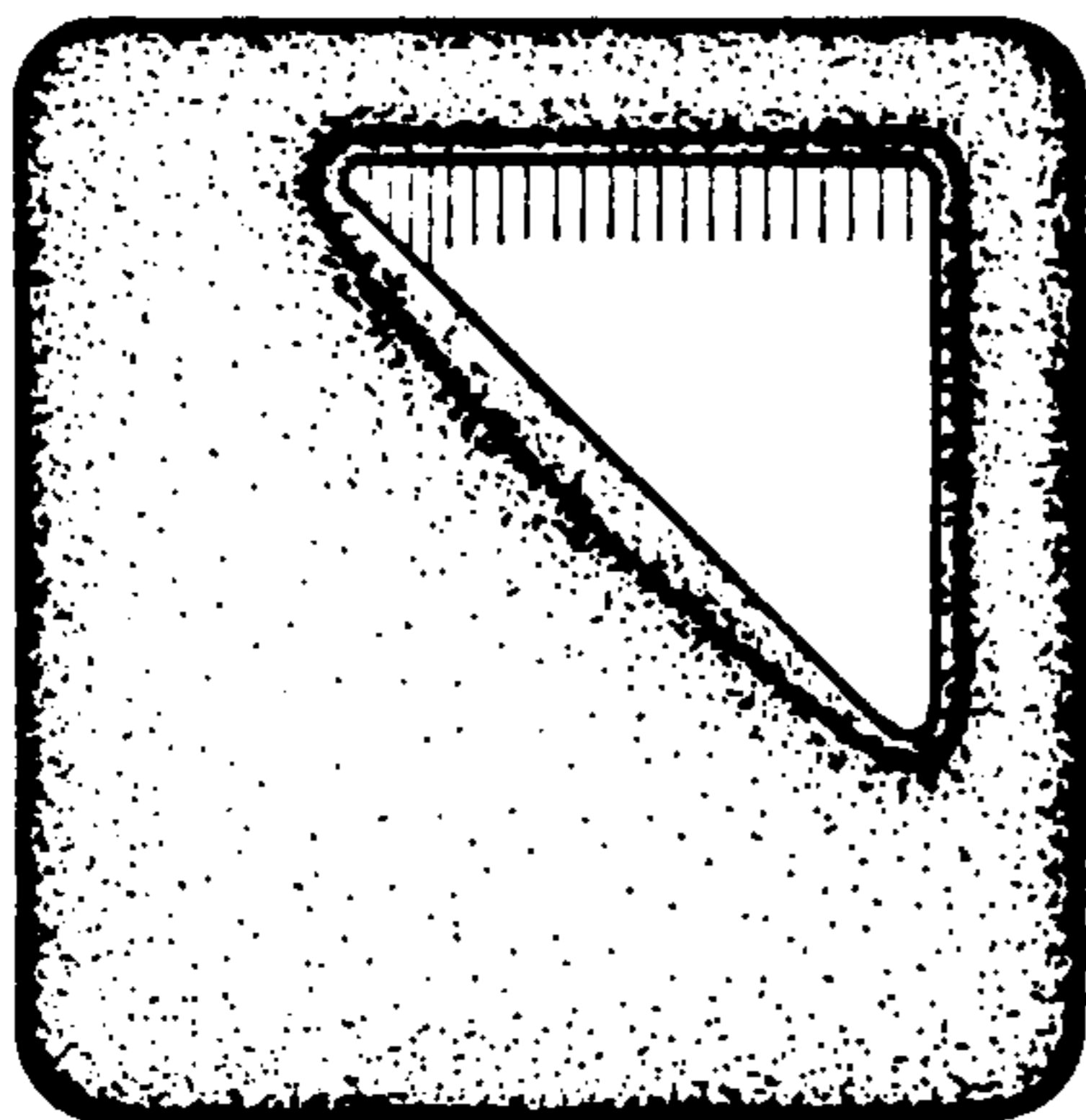

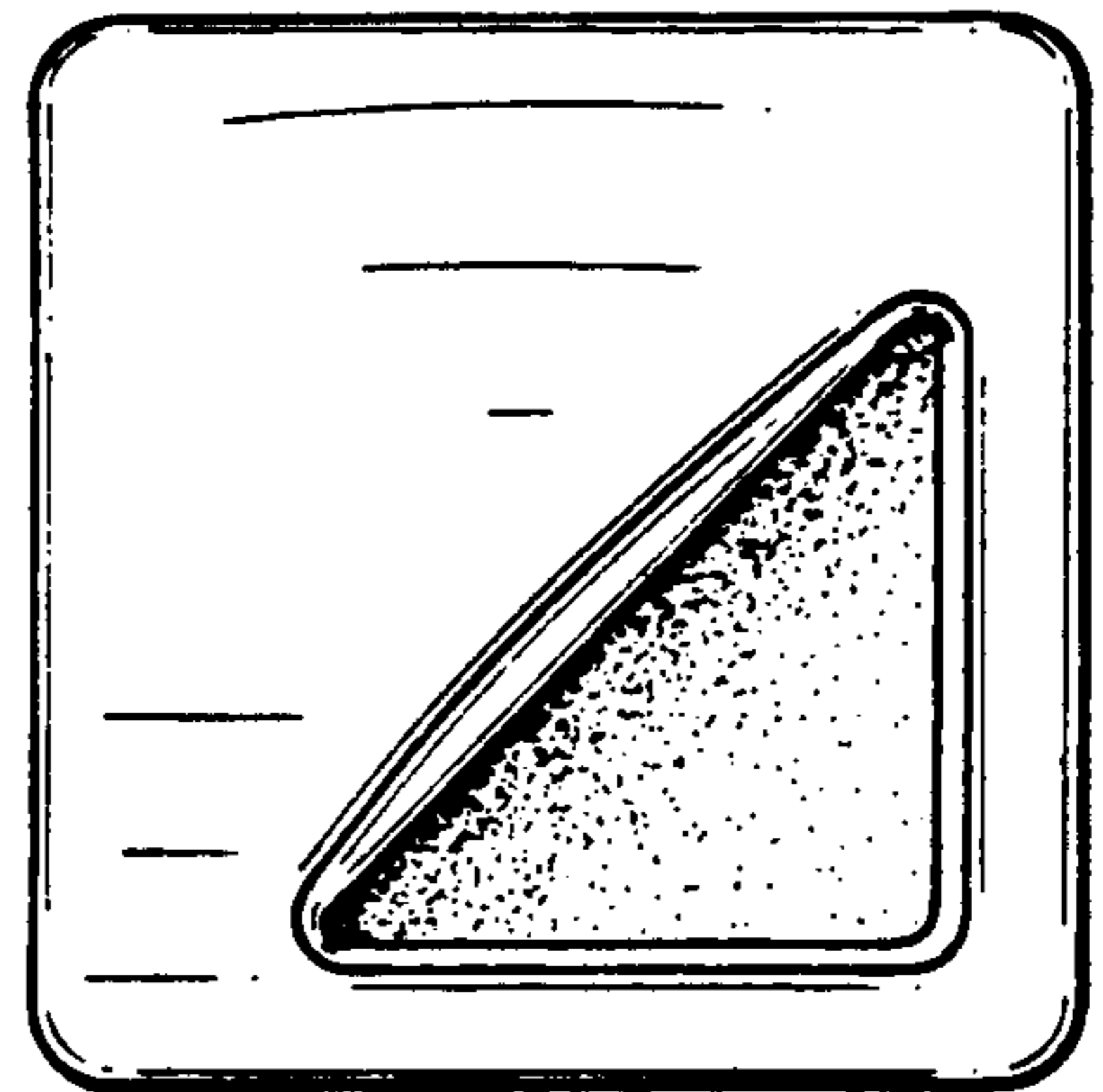
