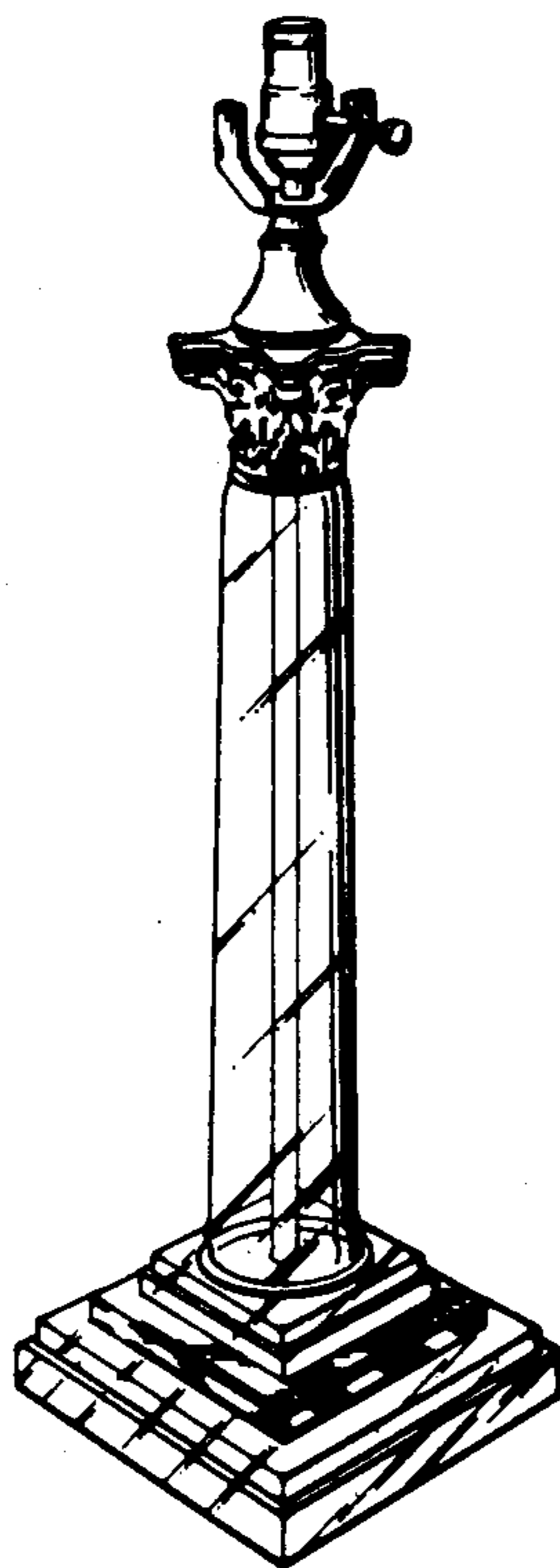

The ornamental design for a table lamp base, as shown and described.

DESCRIPTION

FIG. 1 is a front, right side perspective view of a table lamp base showing my new design;
 FIG. 2 is a front elevational view thereof, the rear being a mirror image;
 FIG. 3 is a right side elevational view thereof, the left side being identical except for the omission of the switch;
 FIG. 4 is a top plan view thereof;
 FIG. 5 is a bottom plan view thereof;
 FIG. 6 is a front, right side perspective view of a second embodiment of my new design;
 FIG. 7 is a front elevational view thereof, the rear being a mirror image;
 FIG. 8 is a right side elevational view thereof, the left side being identical except for the omission of the switch;
 FIG. 9 is a top plan view thereof;
 FIG. 10 is a bottom plan view thereof;
 FIG. 11 is a front, right side perspective view of a third embodiment of my new design;
 FIG. 12 is a front elevational view thereof, the rear being a mirror image;
 FIG. 13 is a right side elevational view thereof, the left side being identical except for the omission of the switch;
 FIG. 14 is a top plan view thereof;
 FIG. 15 is a bottom plan view thereof.



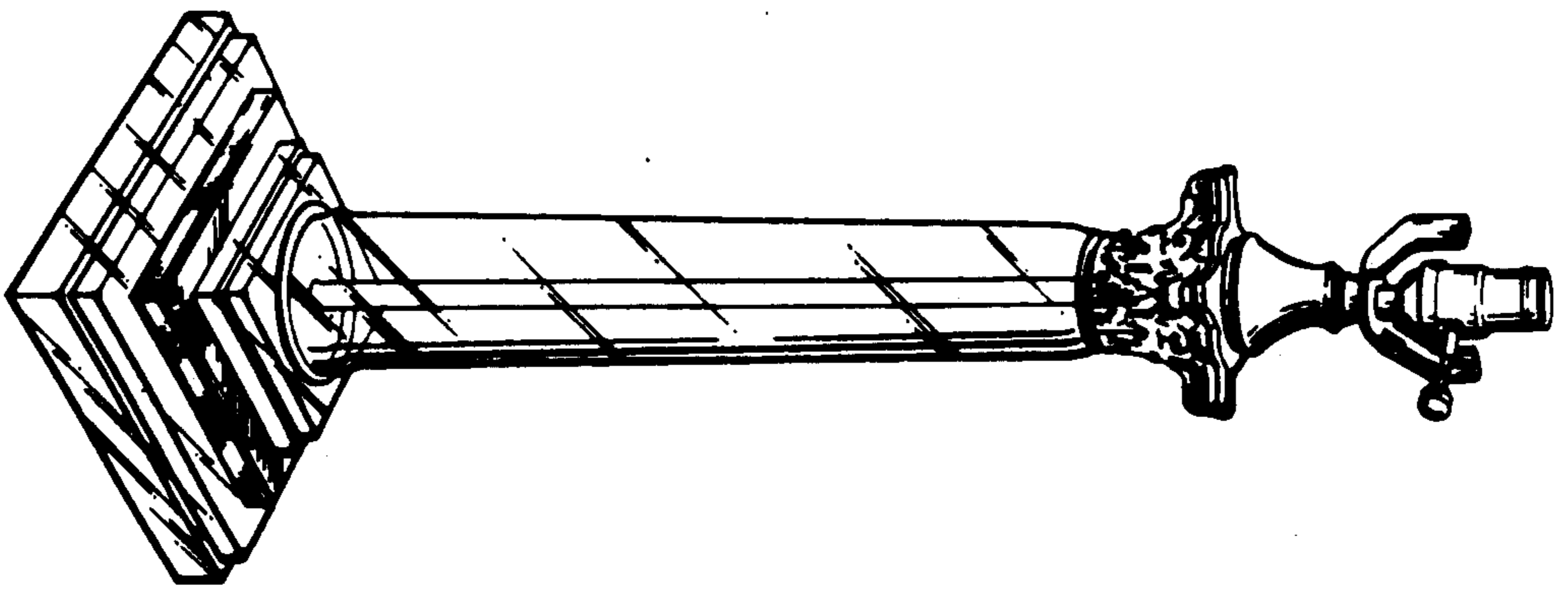

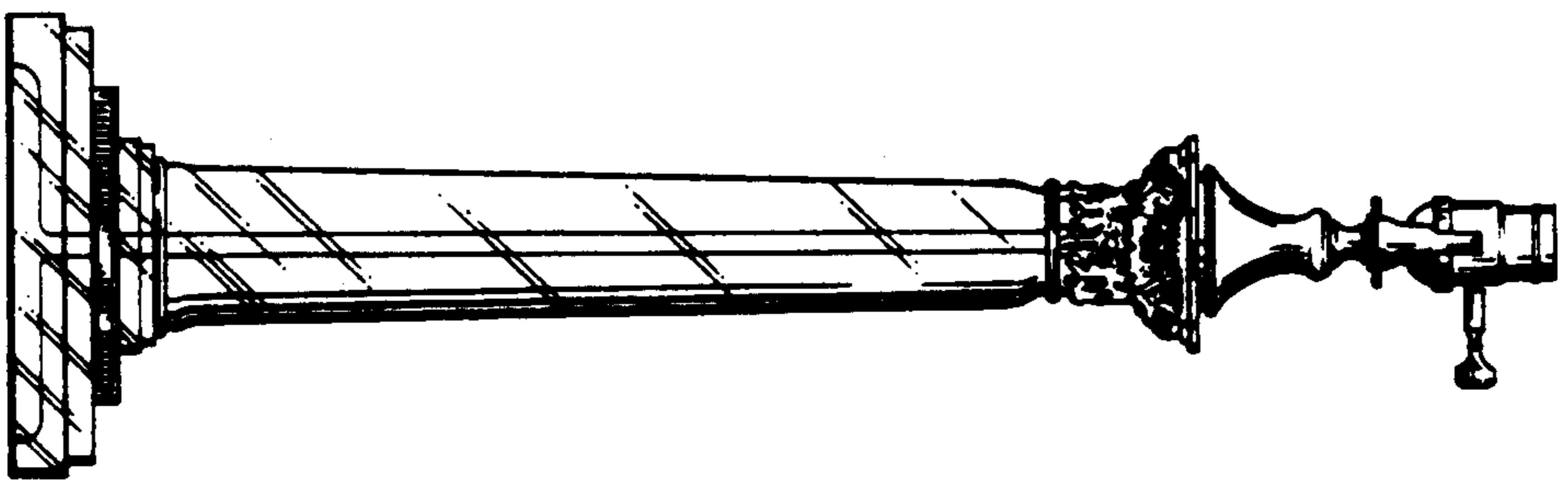

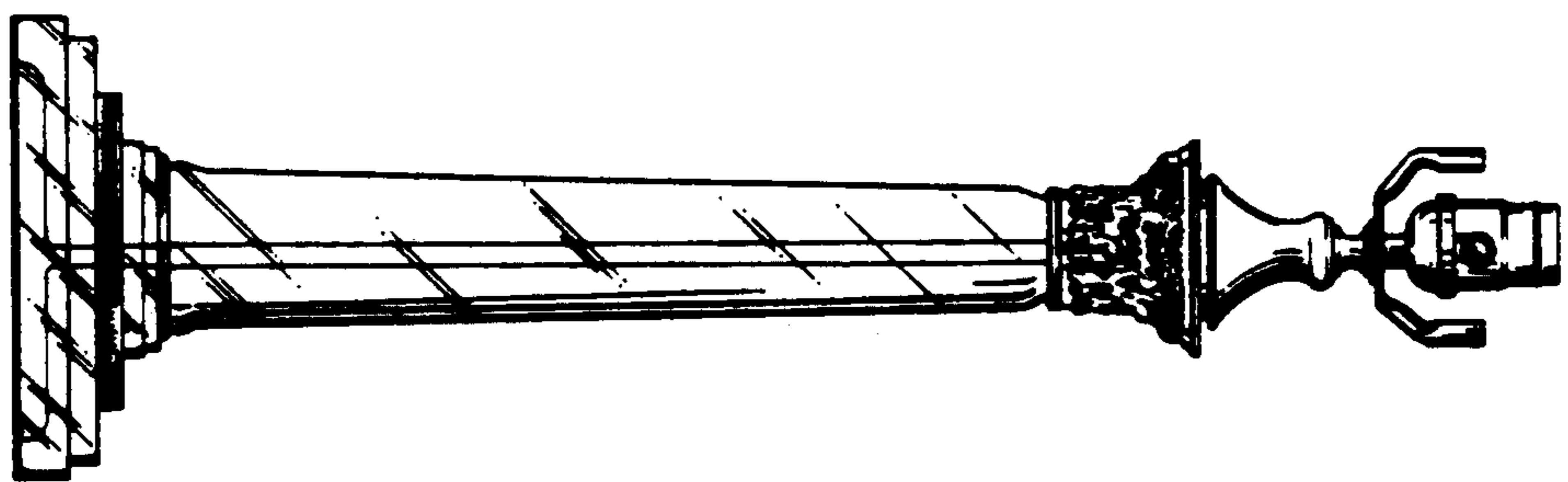

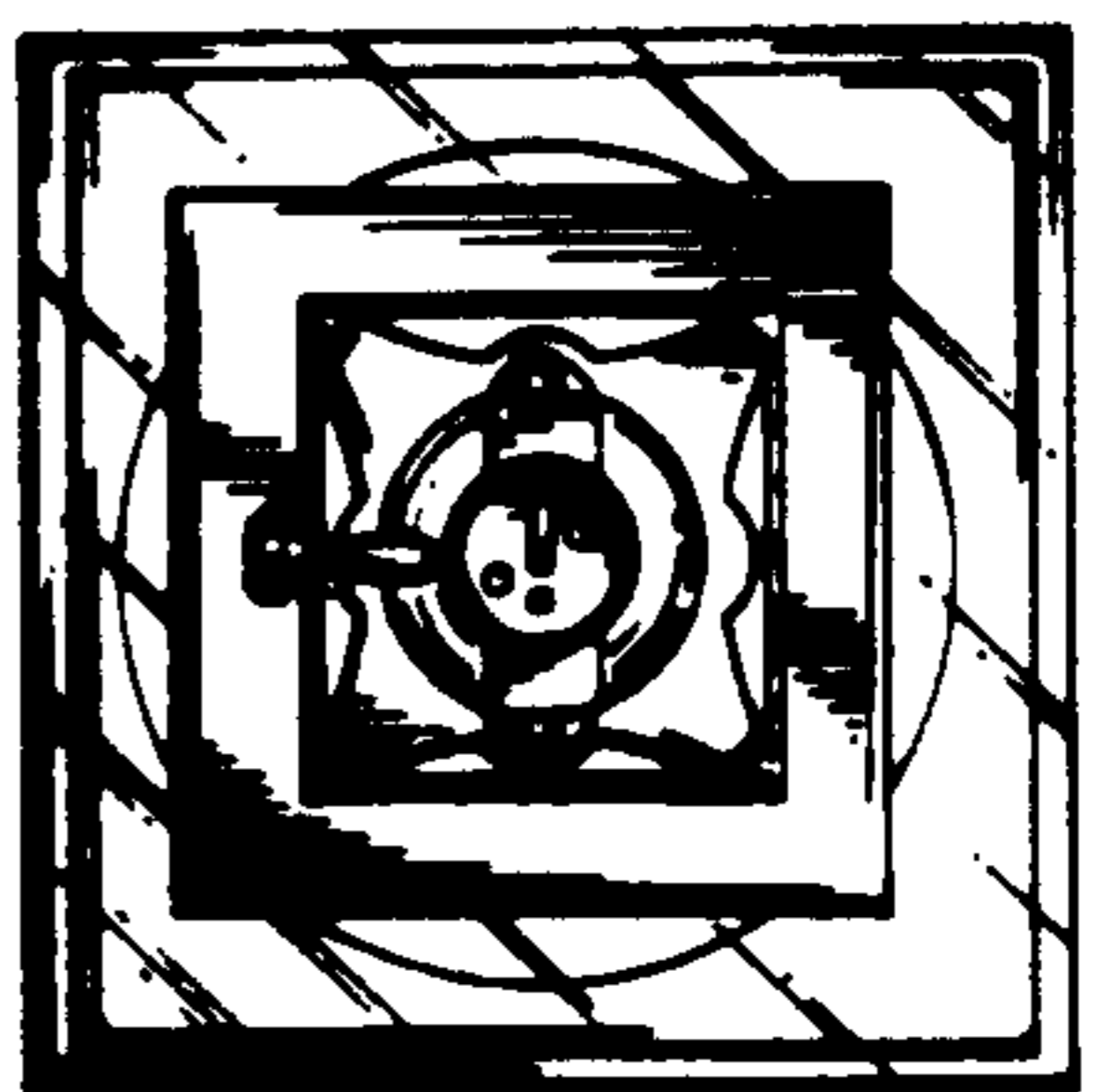

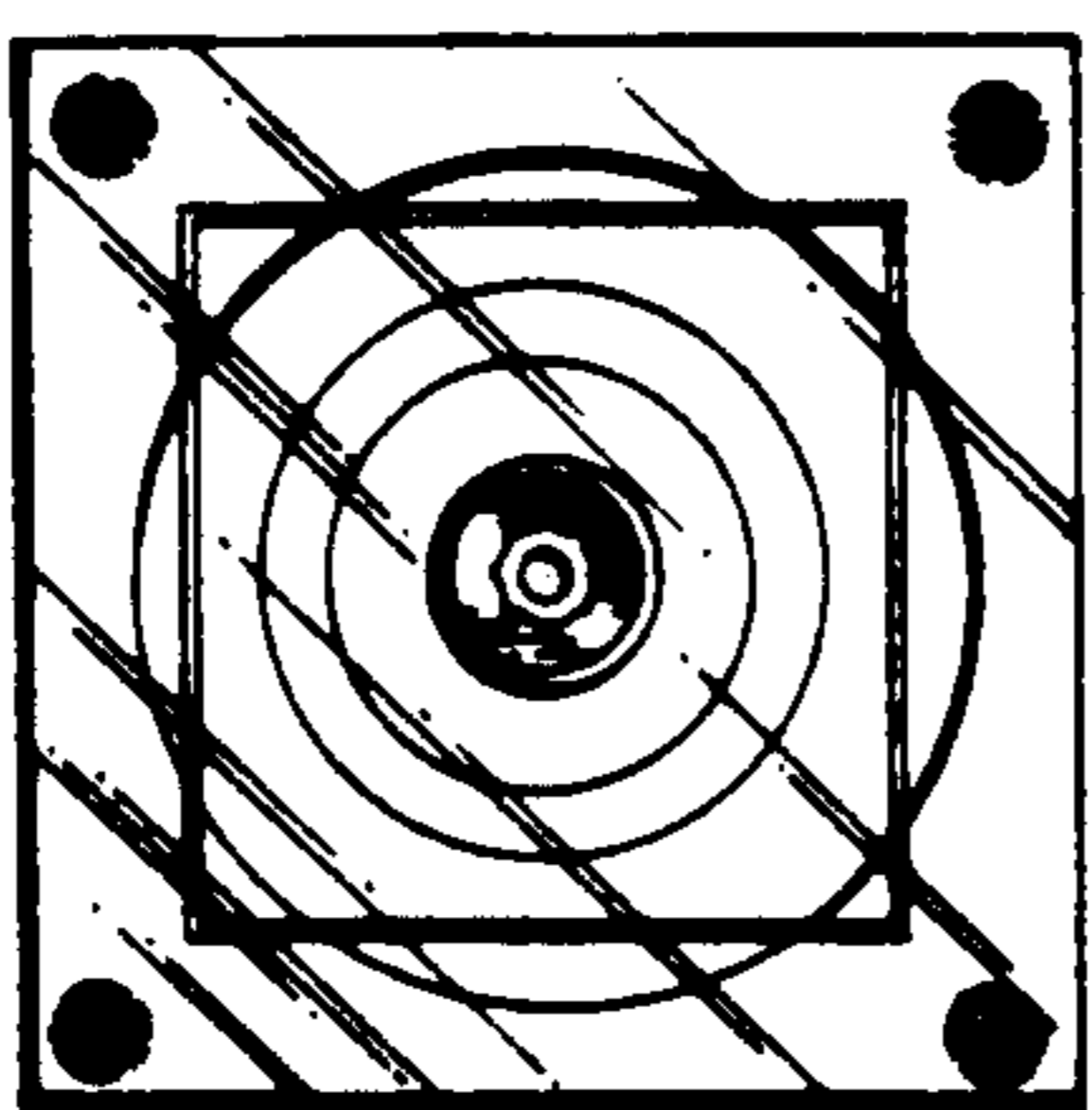

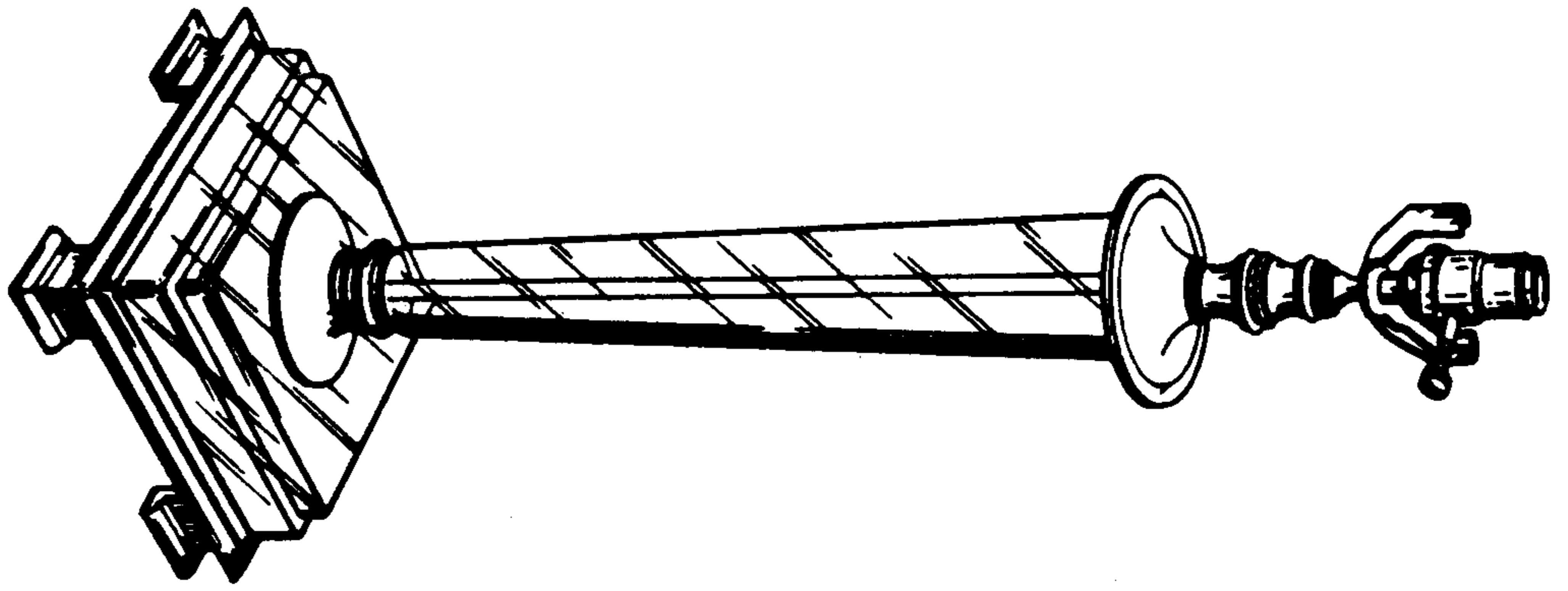

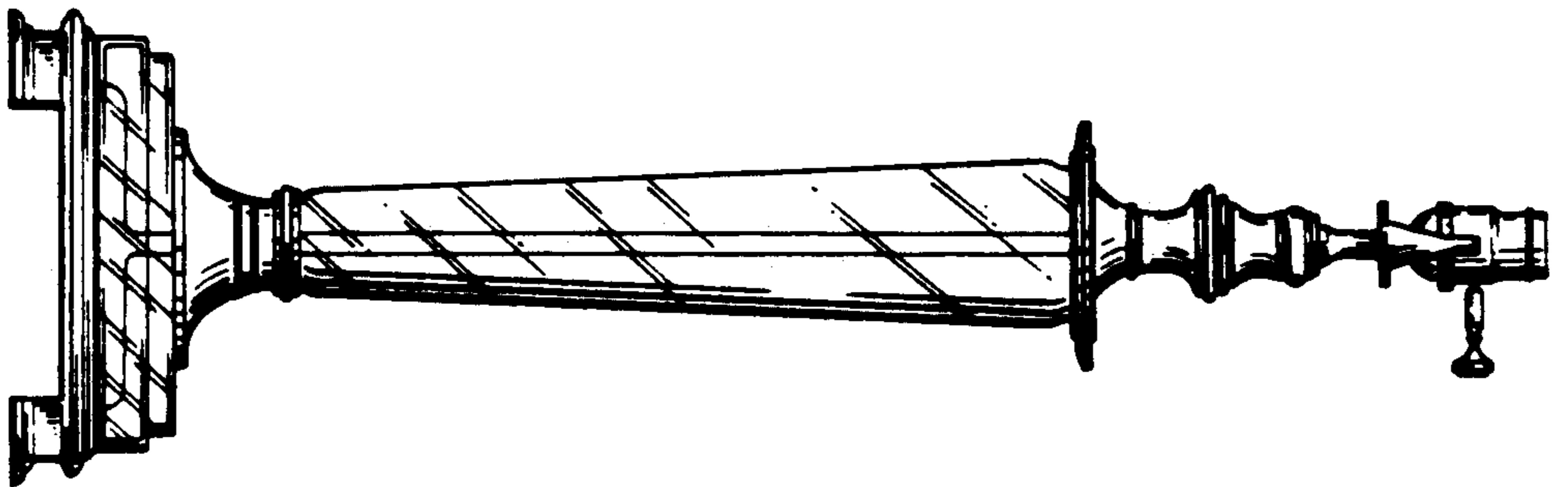

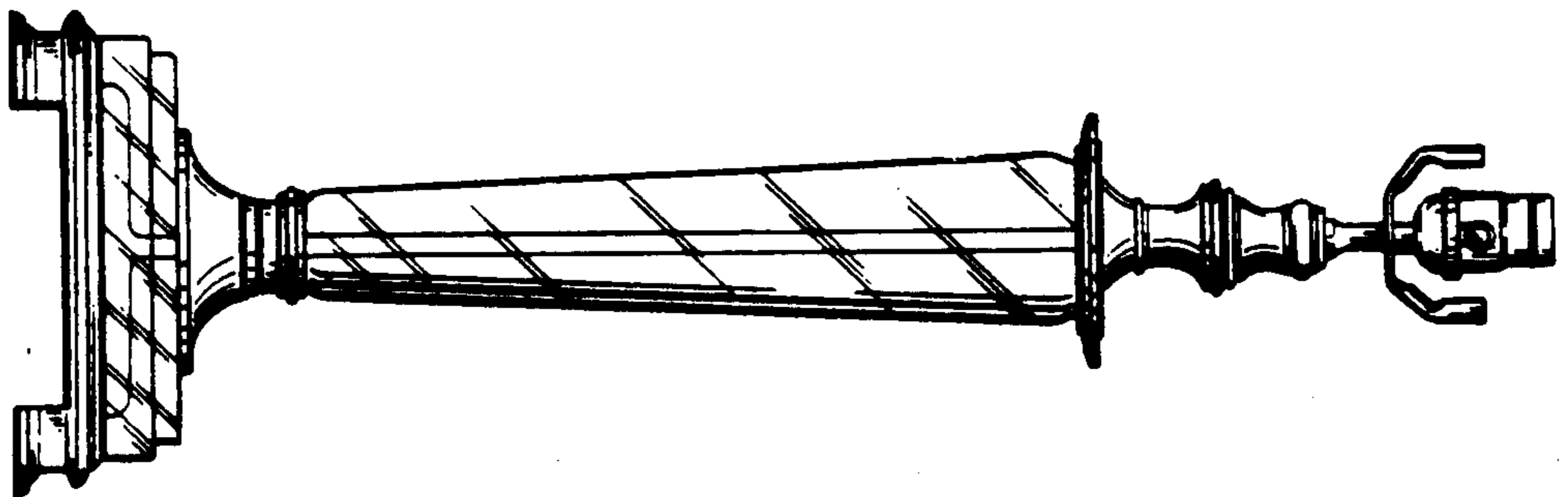

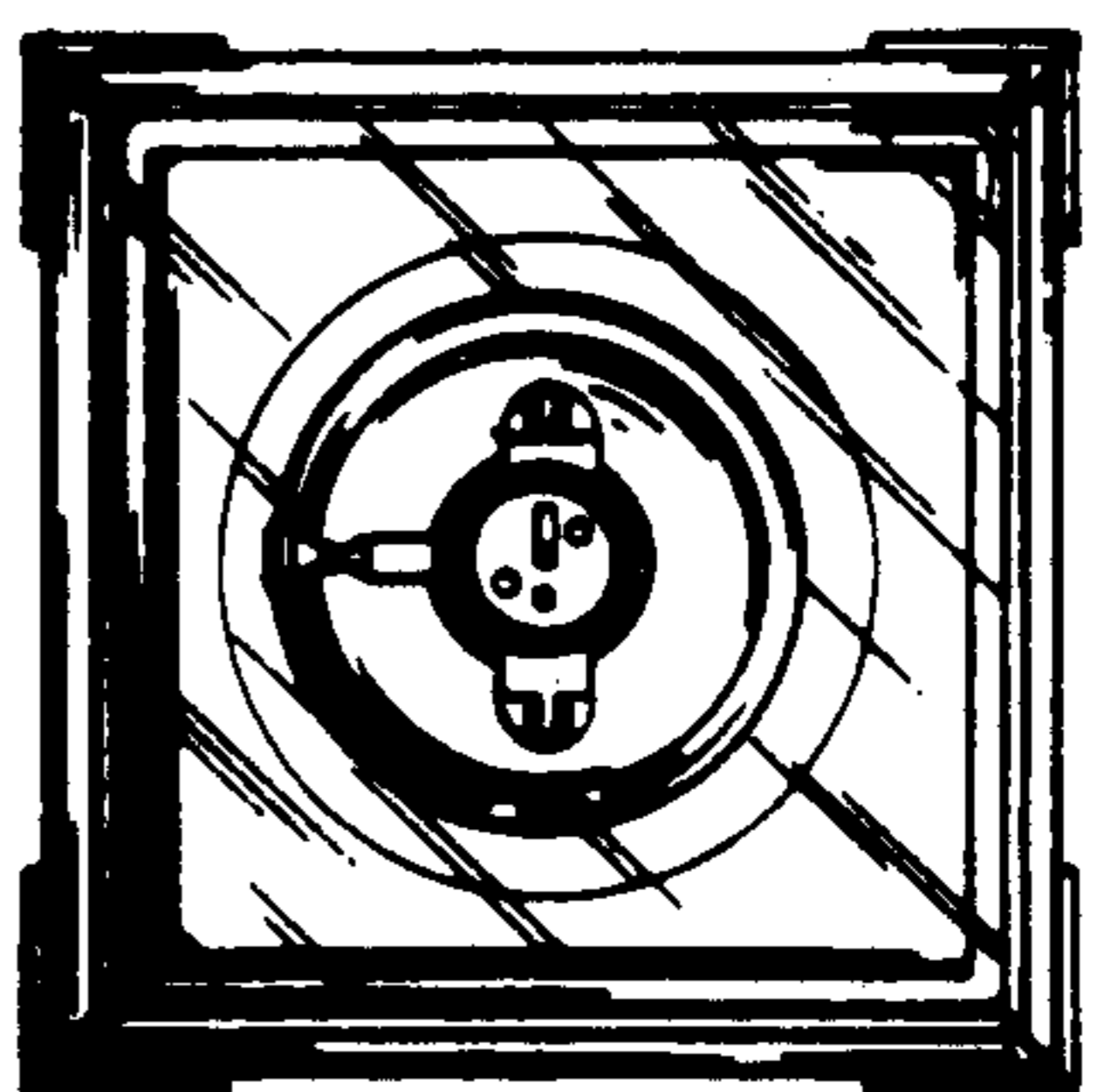

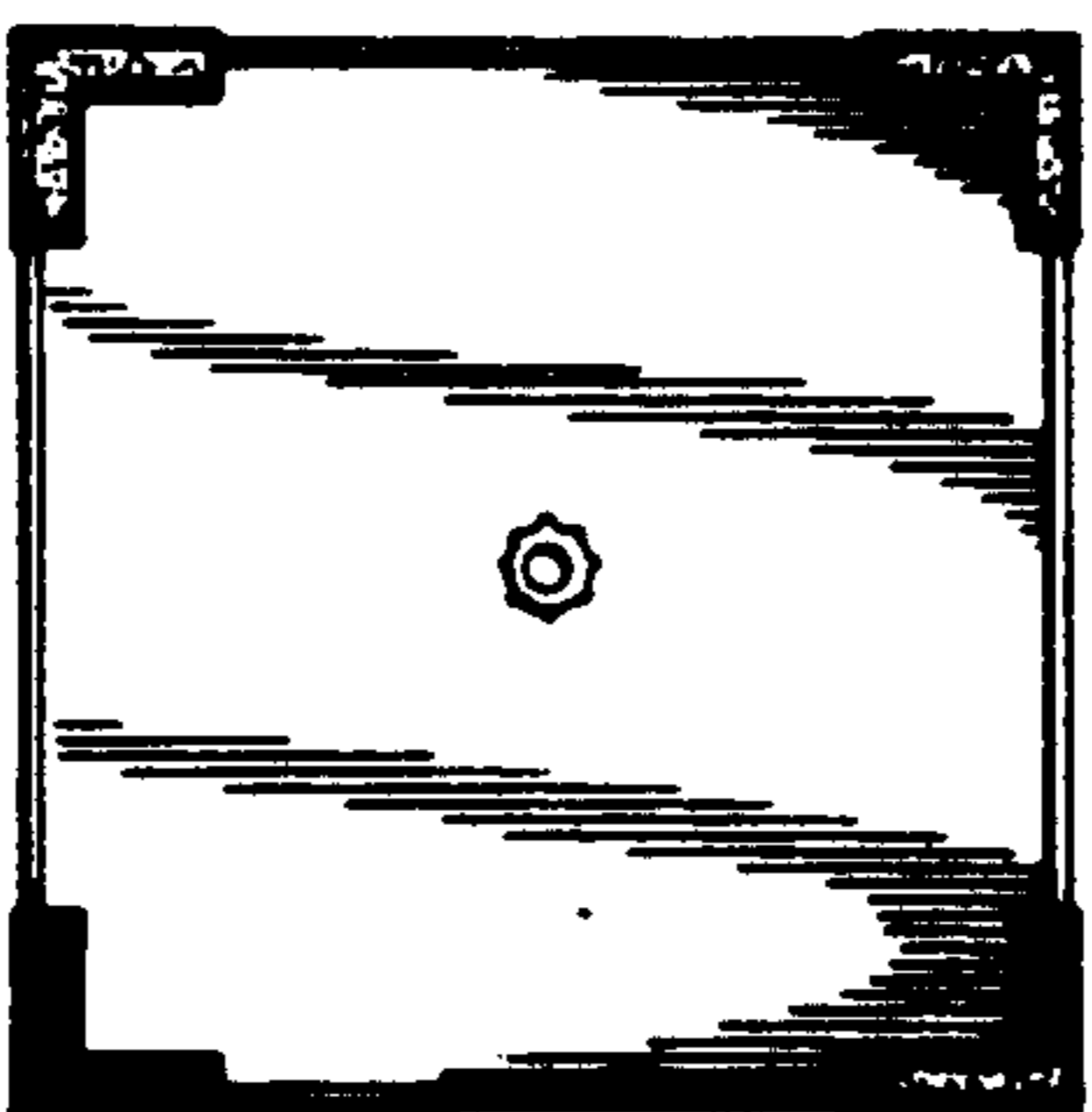

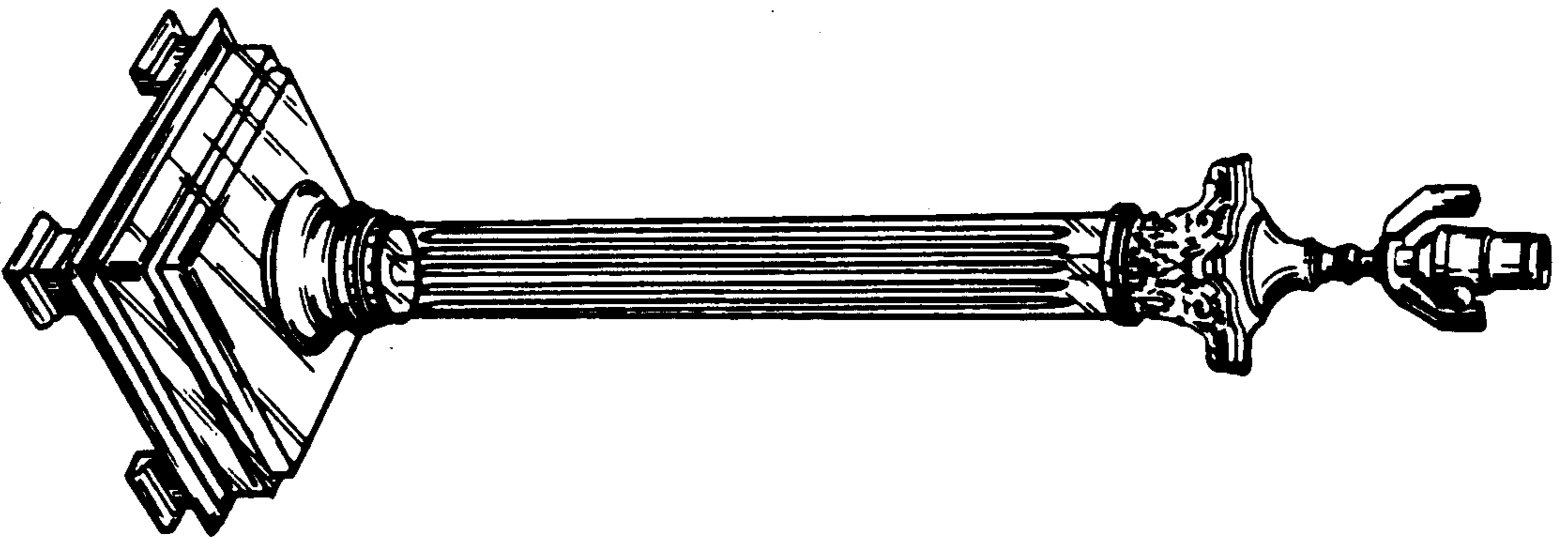

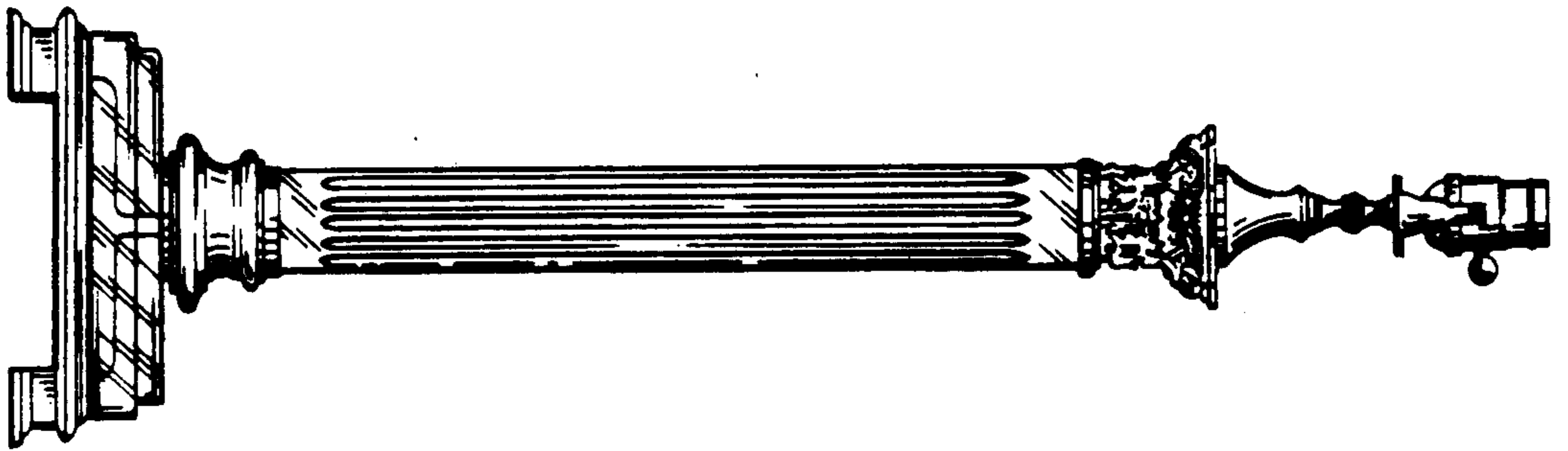

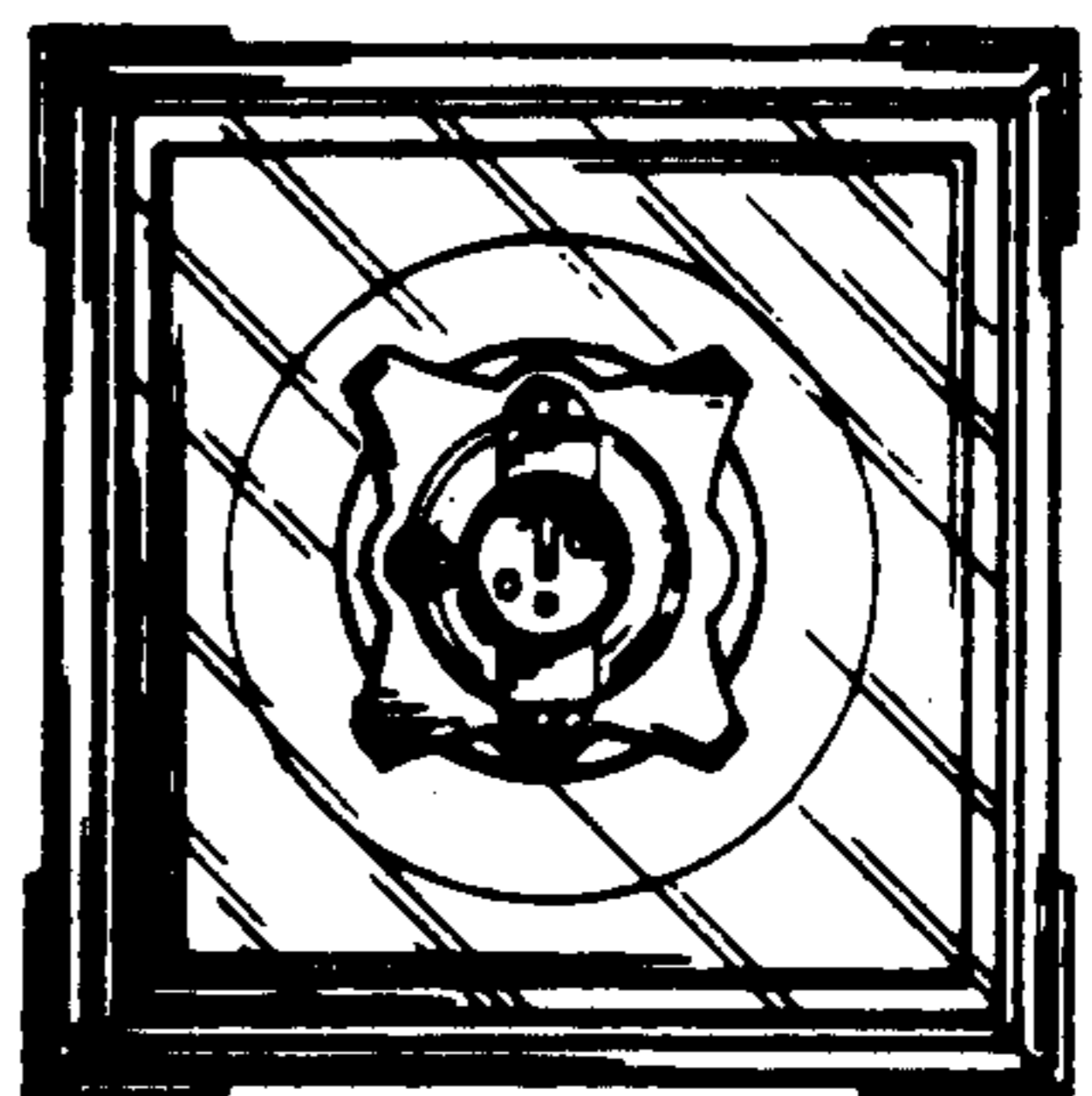

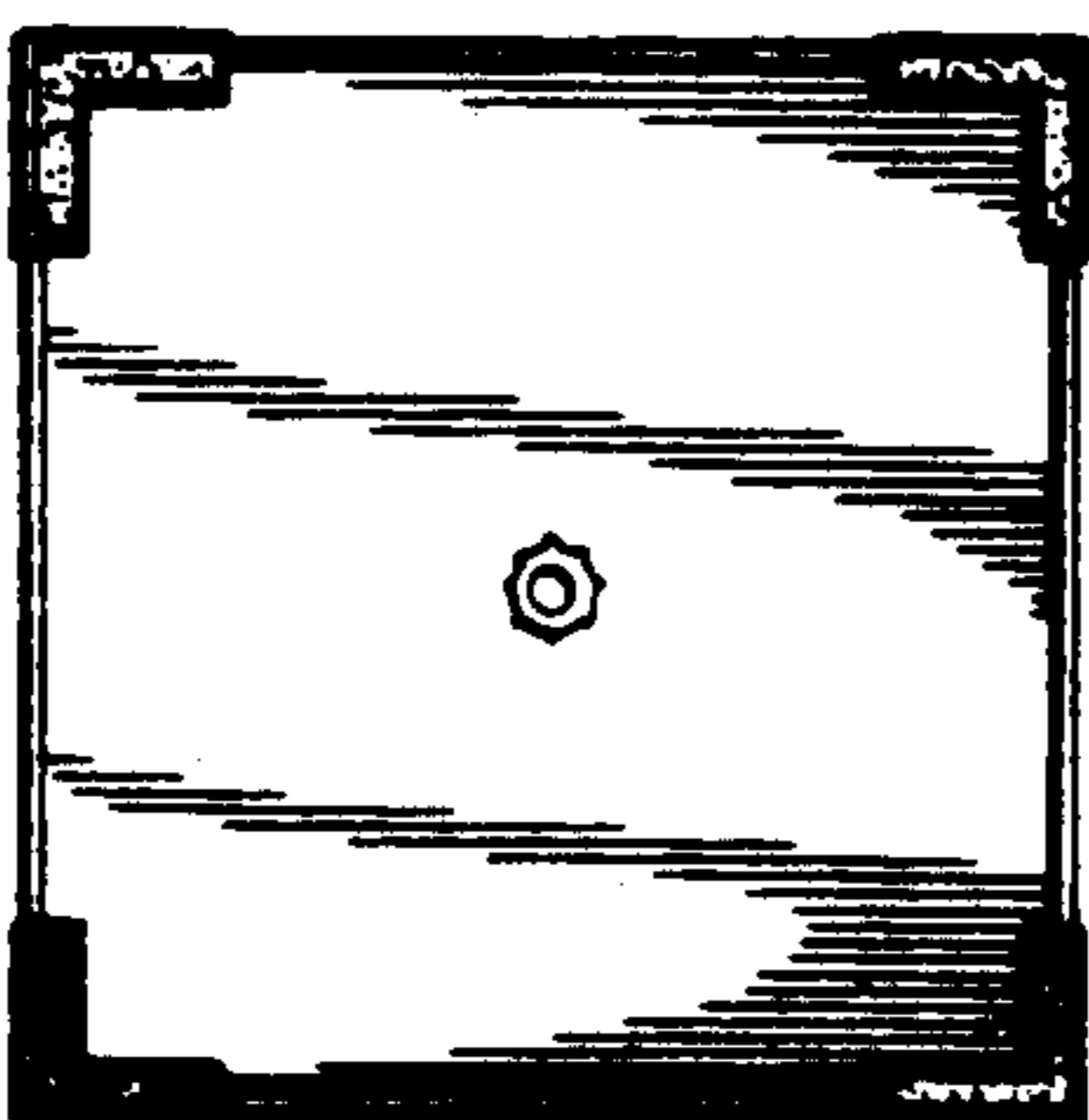
