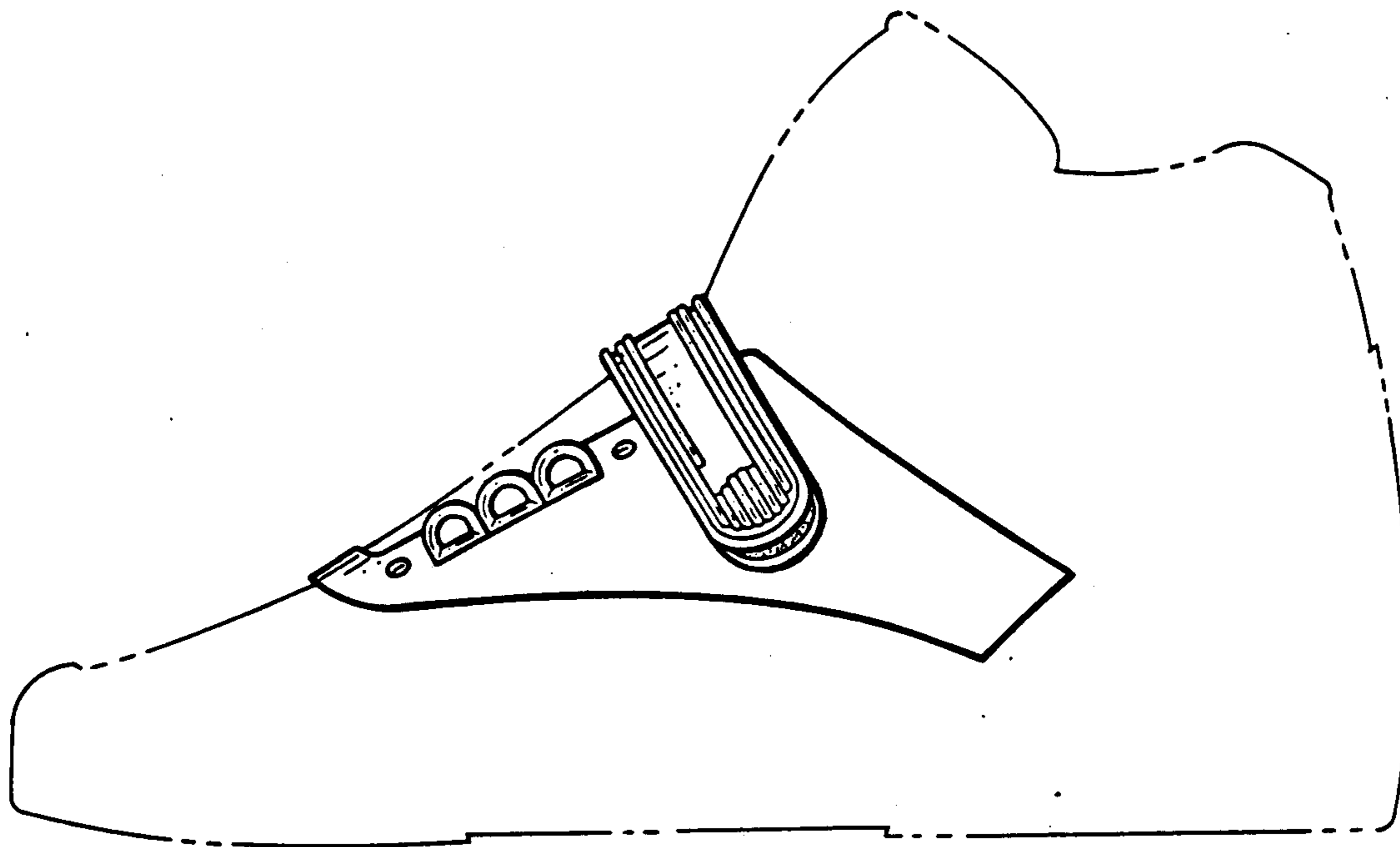

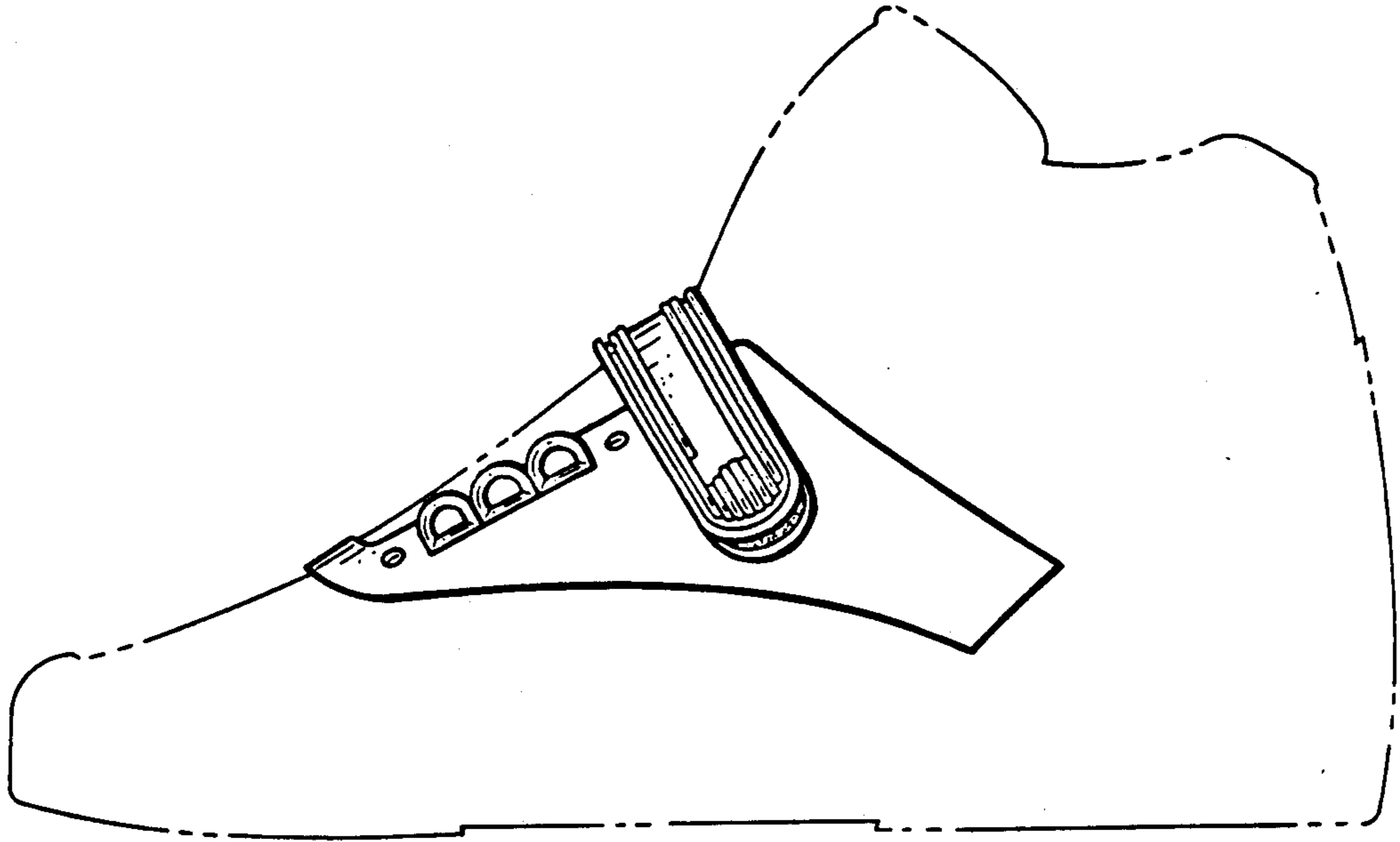
[57] **CLAIM**

The ornamental design of an element of a shoe upper, as shown and described.

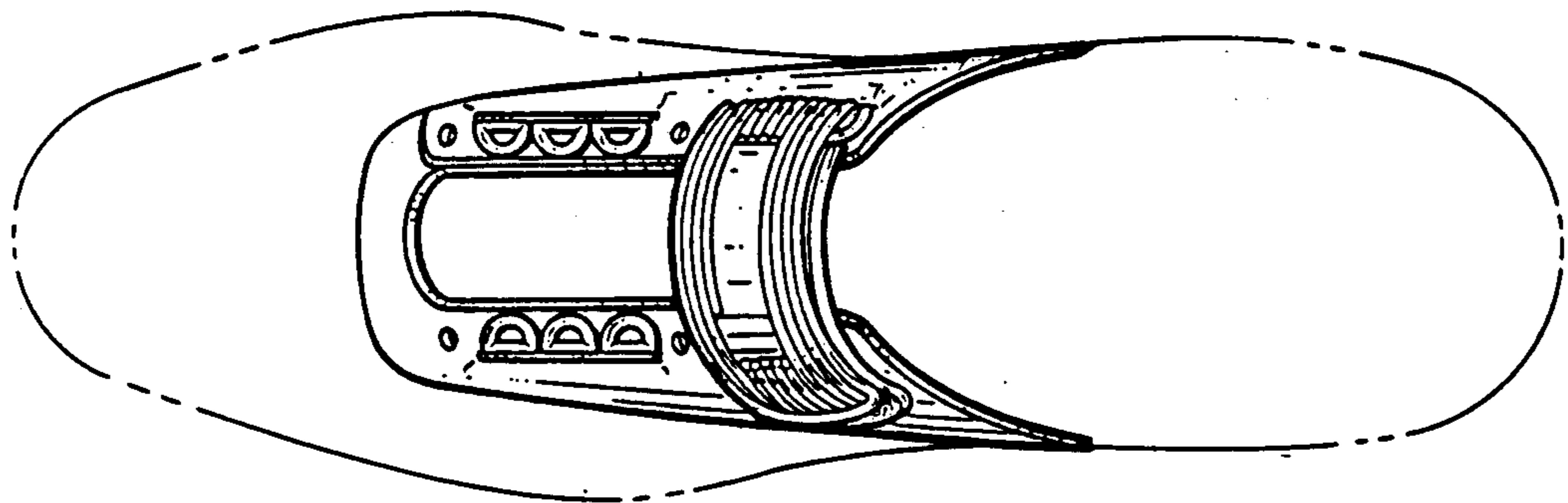
**DESCRIPTION**

FIG. 1 is a right side elevational view of an element of a shoe upper showing my new design. The broken line showing a shoe outline is for illustrative purposes only and forms no part of the claimed invention. FIG. 2 is a top plan view thereof; FIG. 3 is a right side elevational view thereof; FIG. 4 is a front elevational view thereof; and FIG. 5 is a rear elevational view thereof.

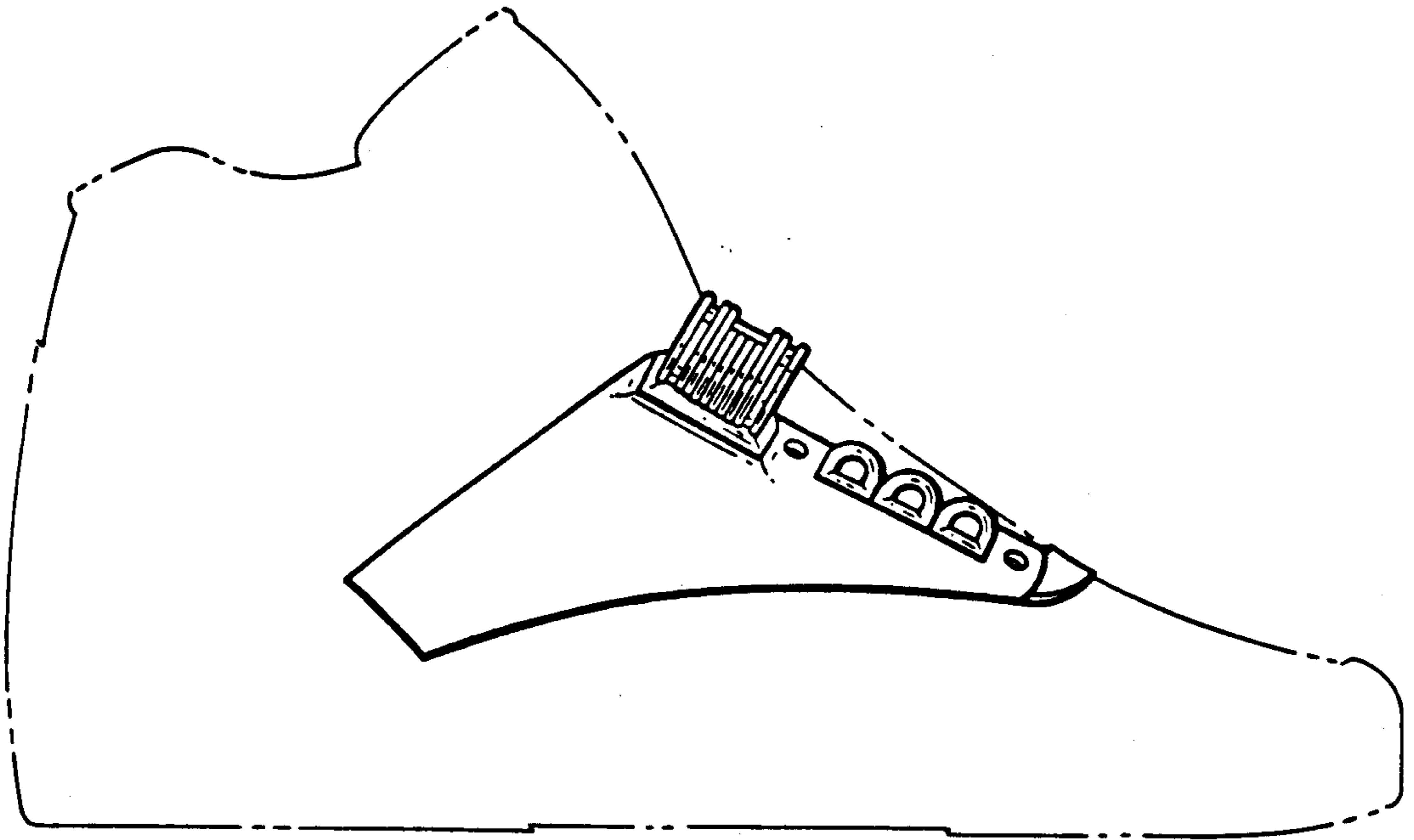




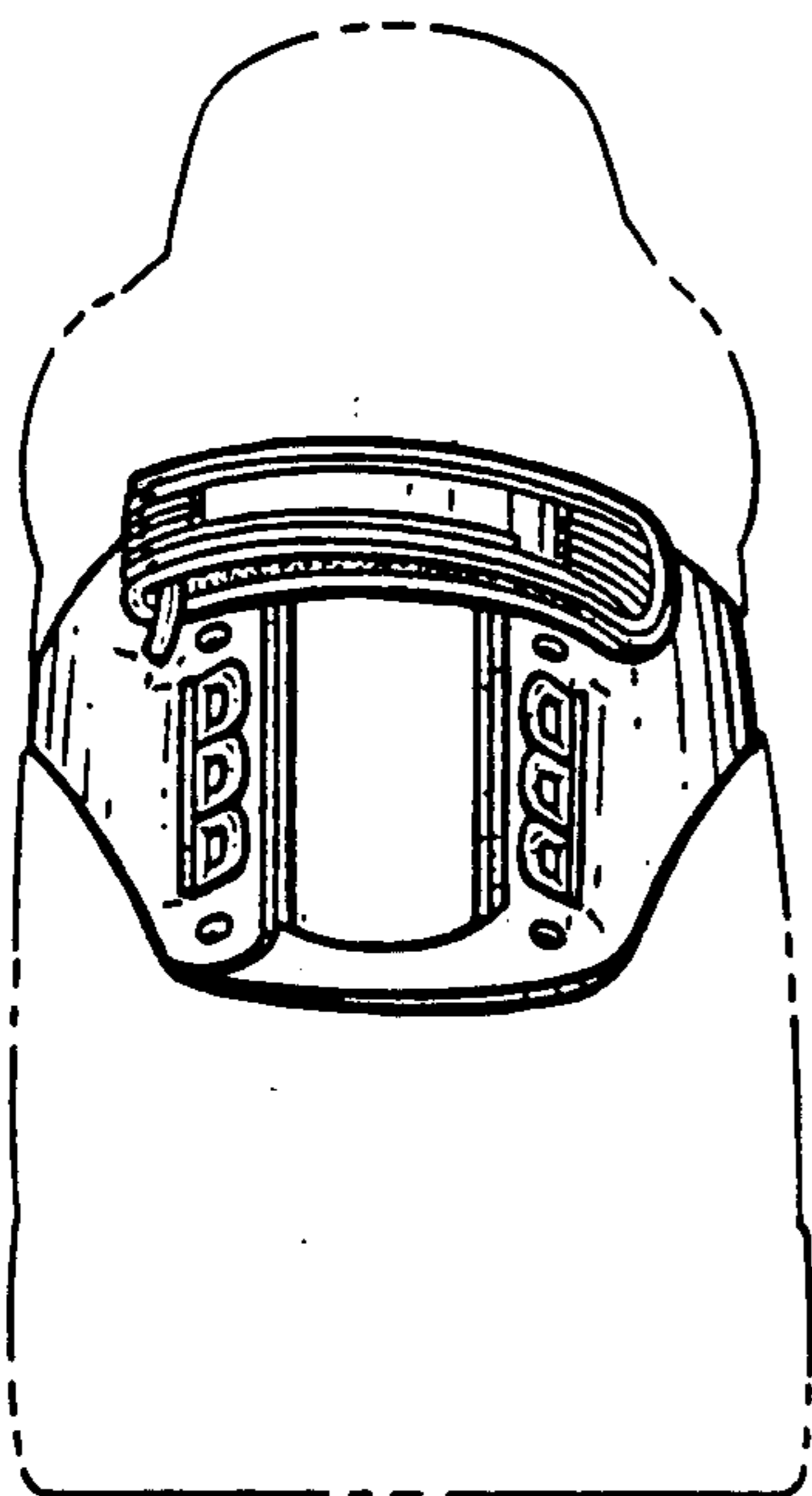

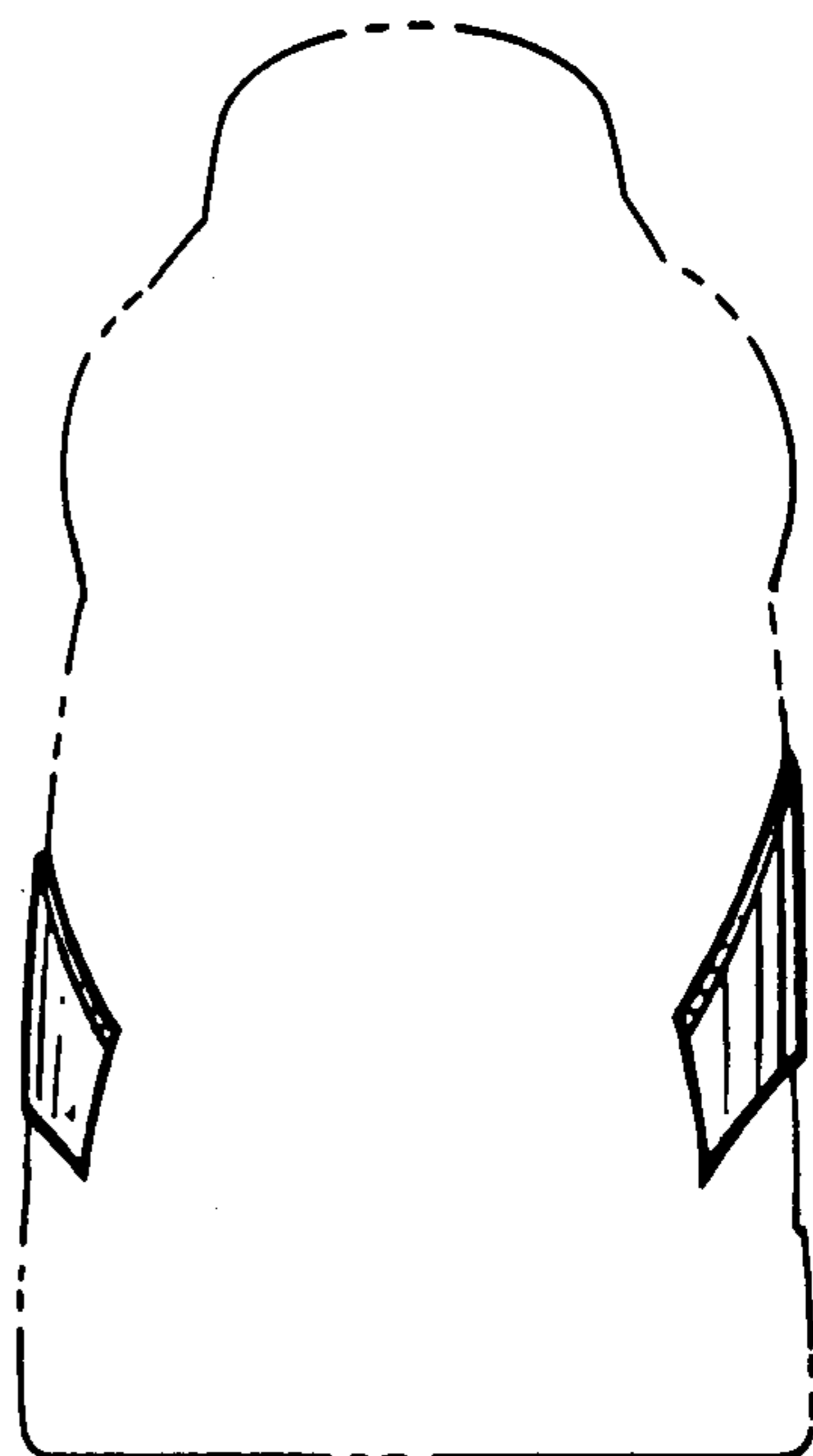
