DESCRIPTION

FIG. 1 is a front perspective view of a combined bottle and cap showing our new design;

 FIG. 14 is a bottom plan view of FIG. 8.

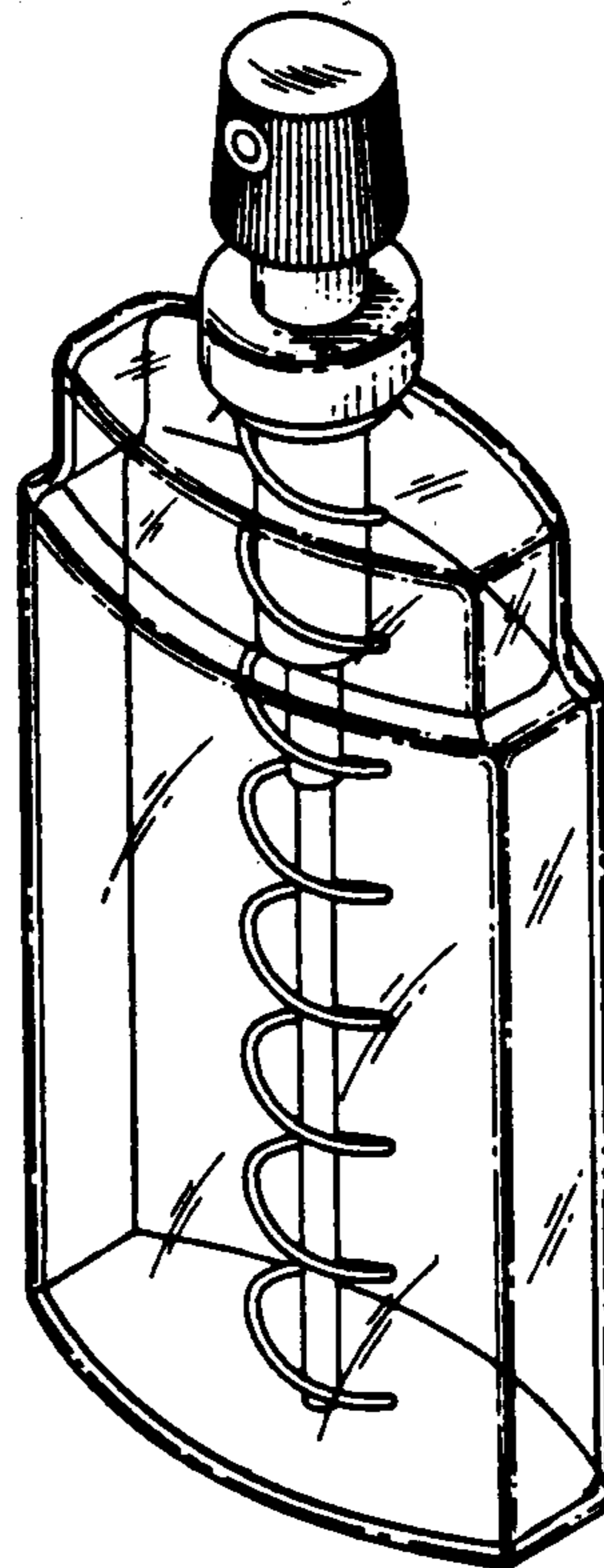
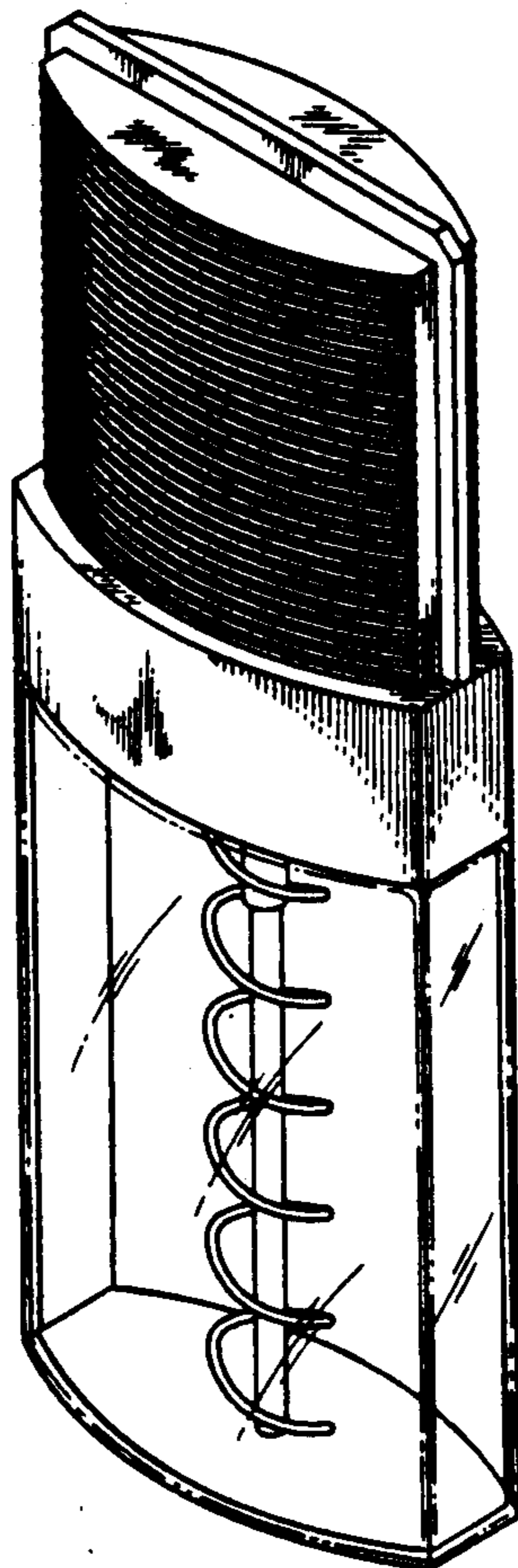

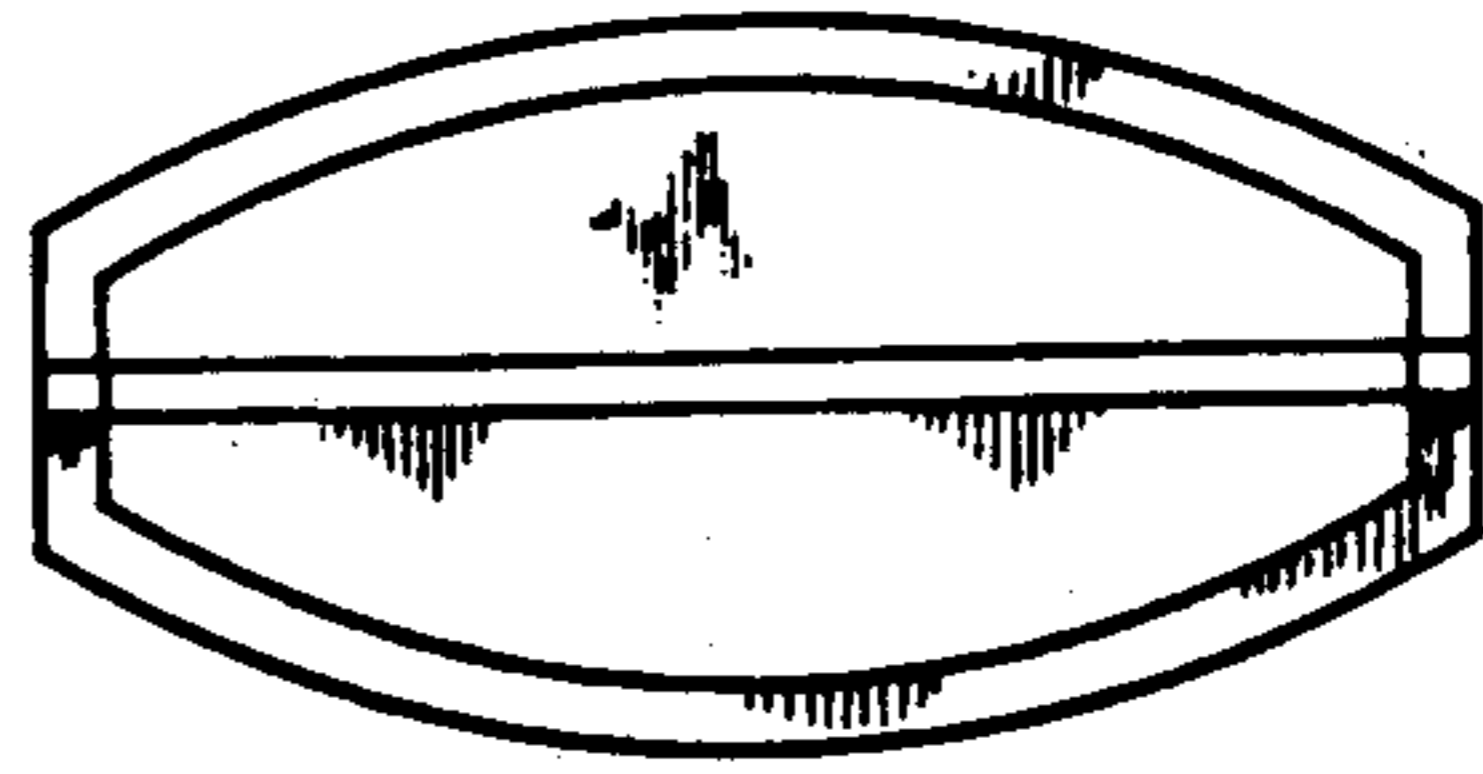

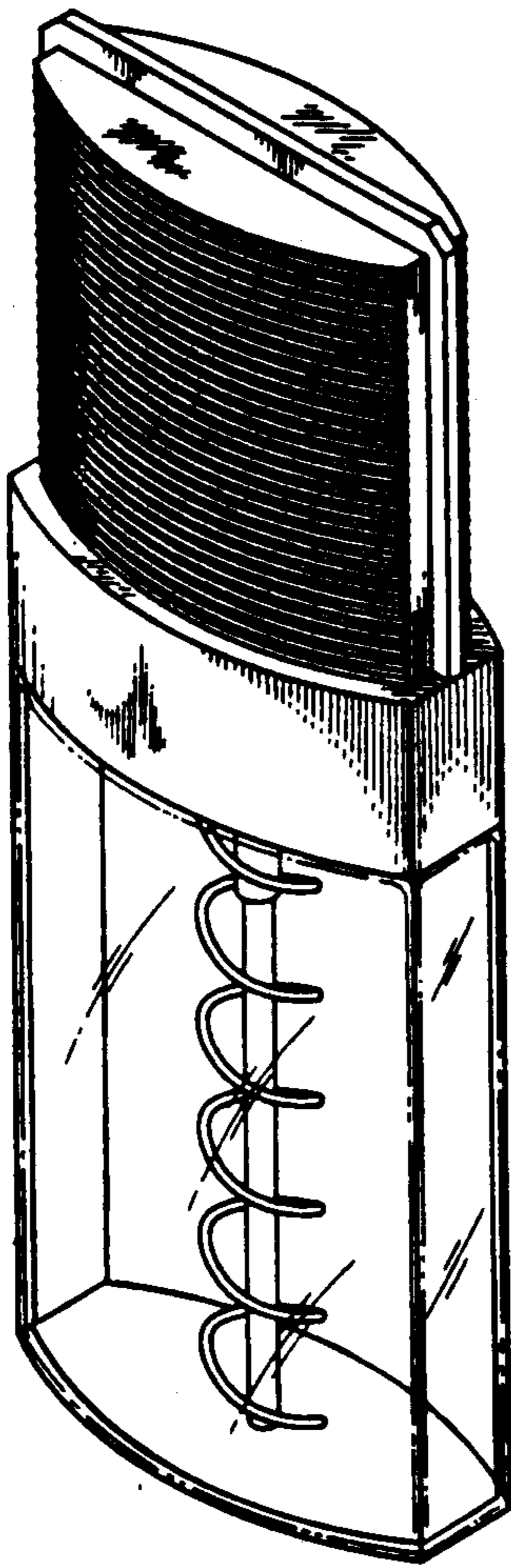

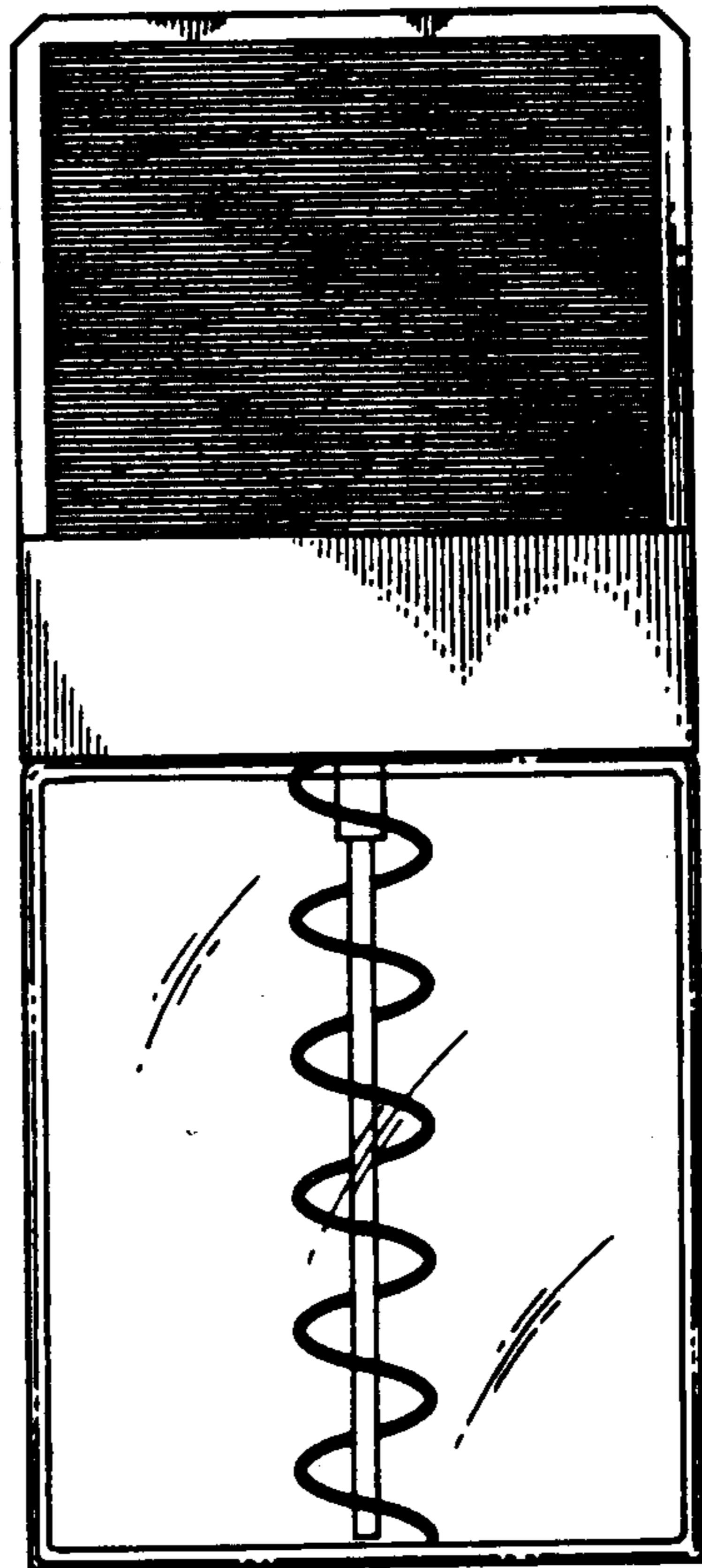

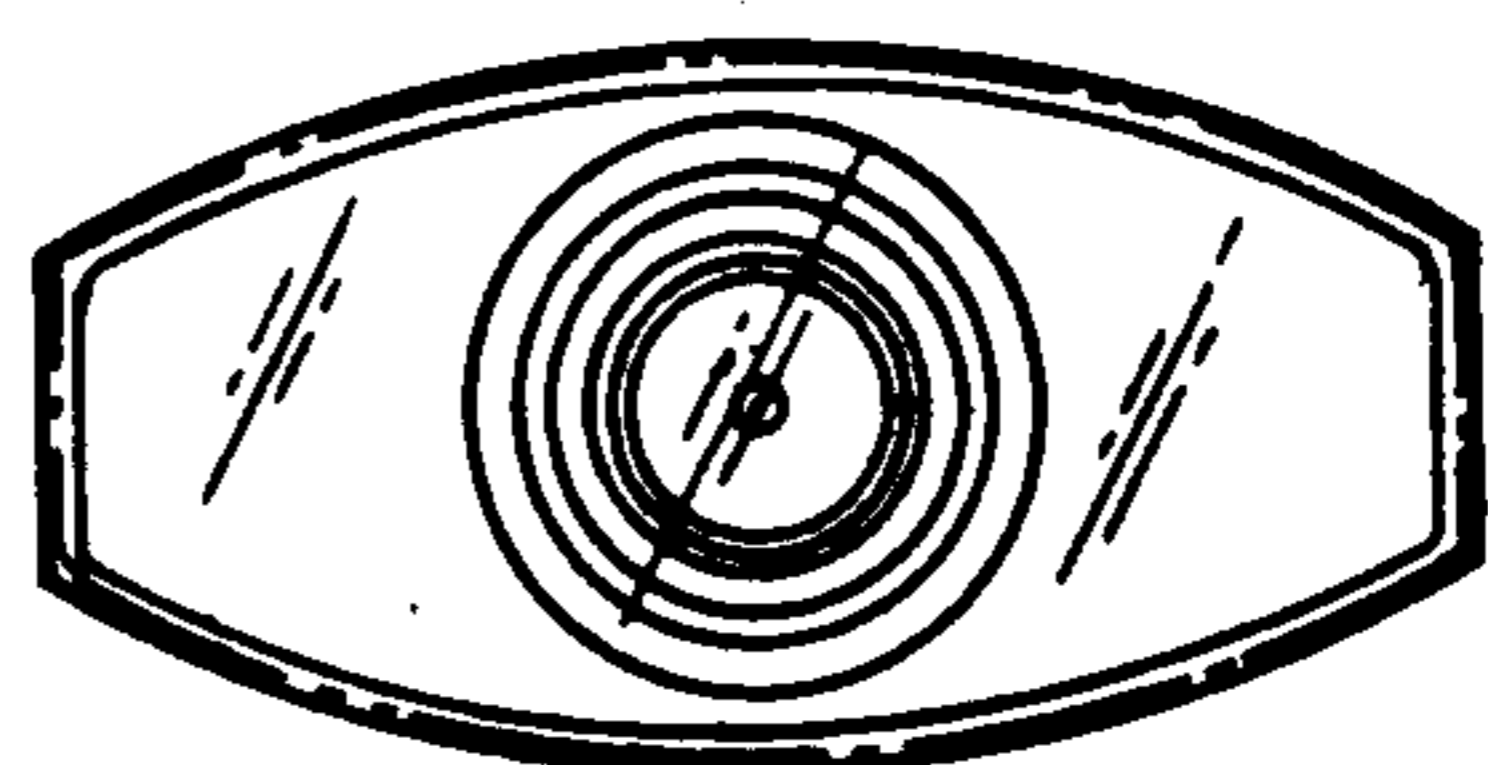

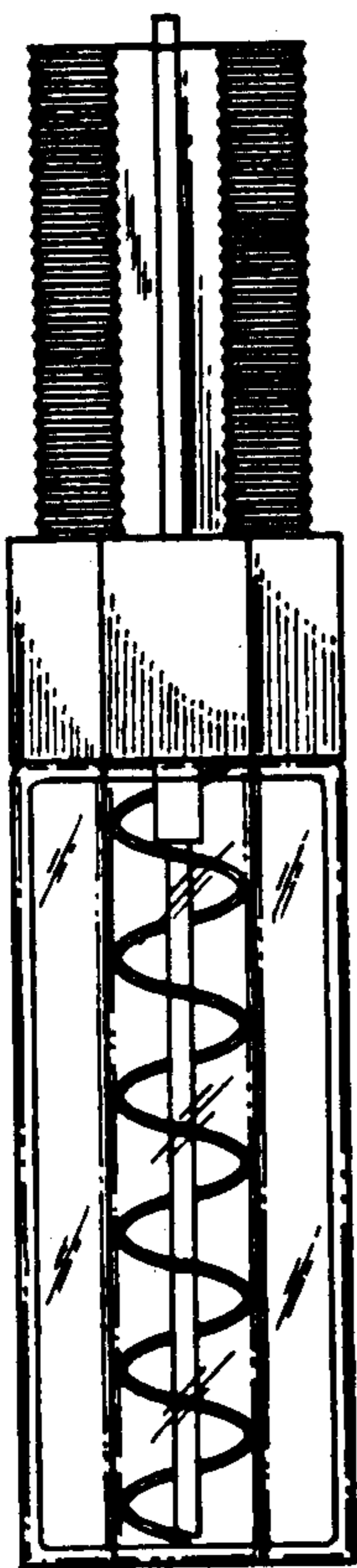

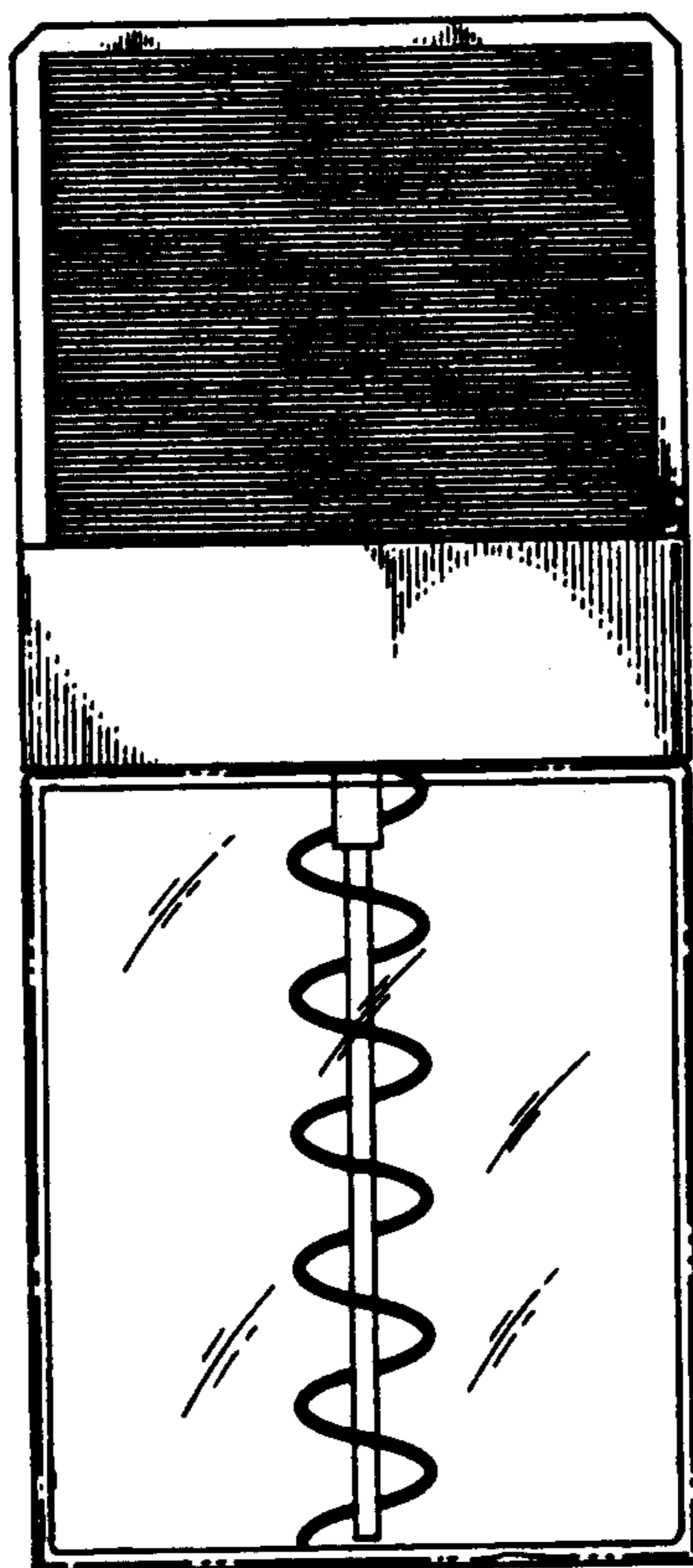

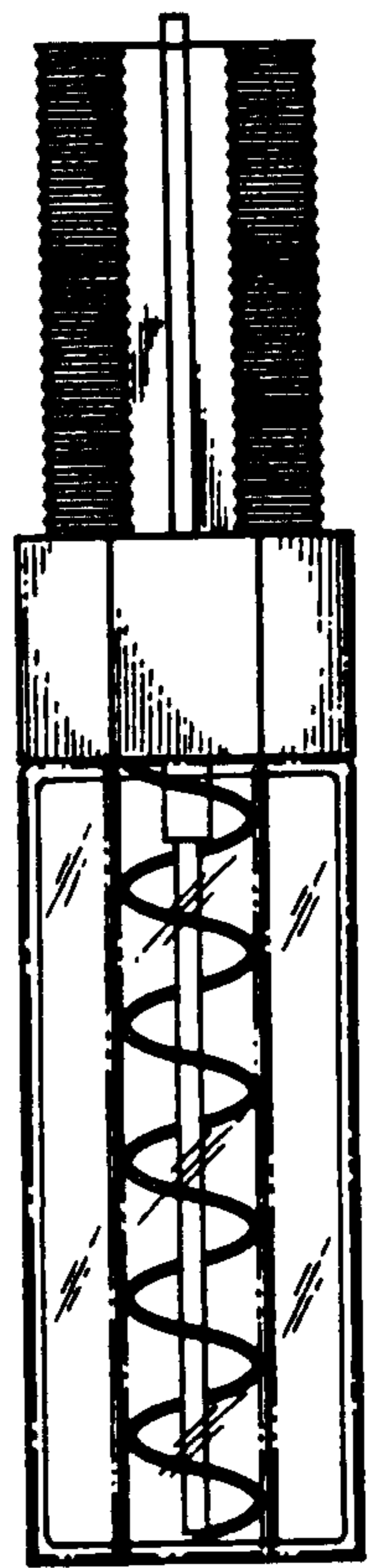

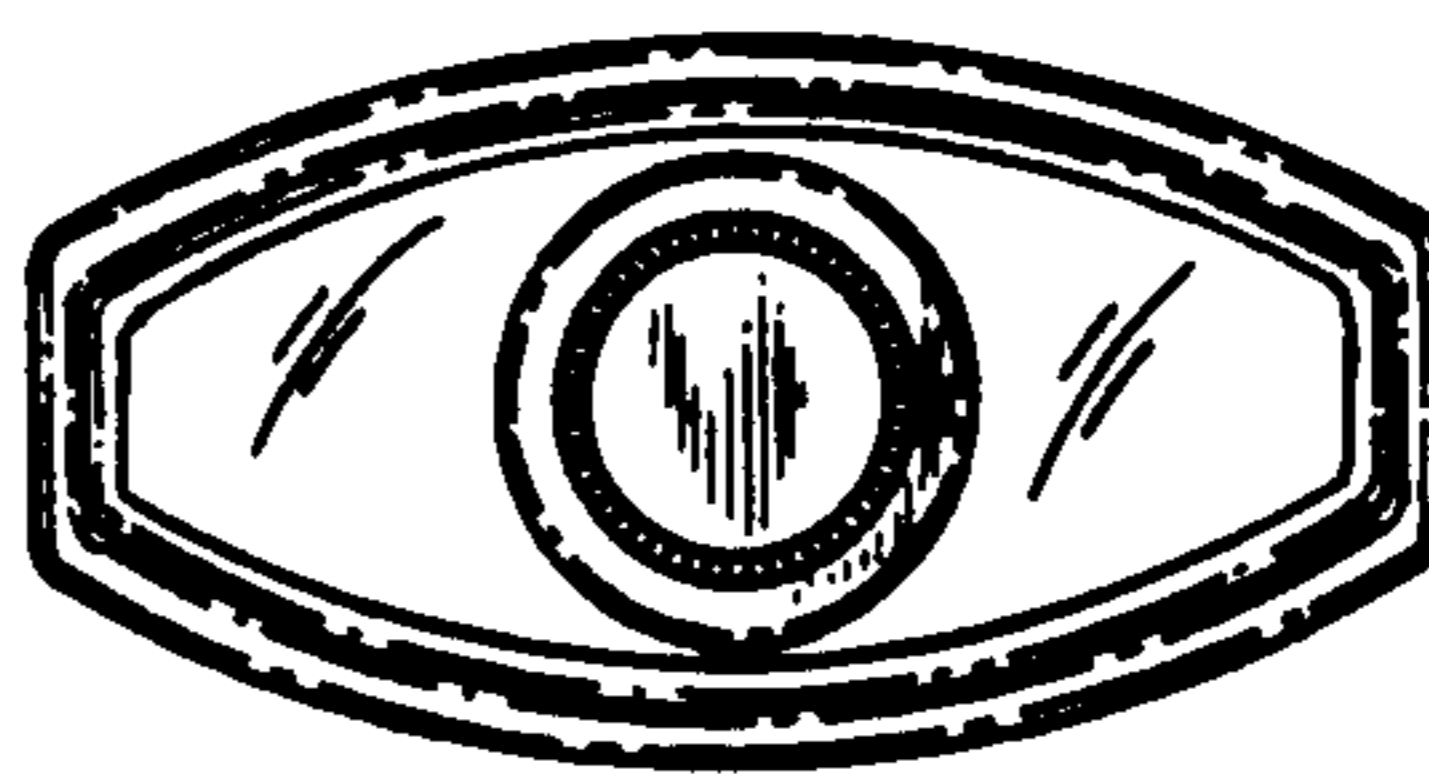

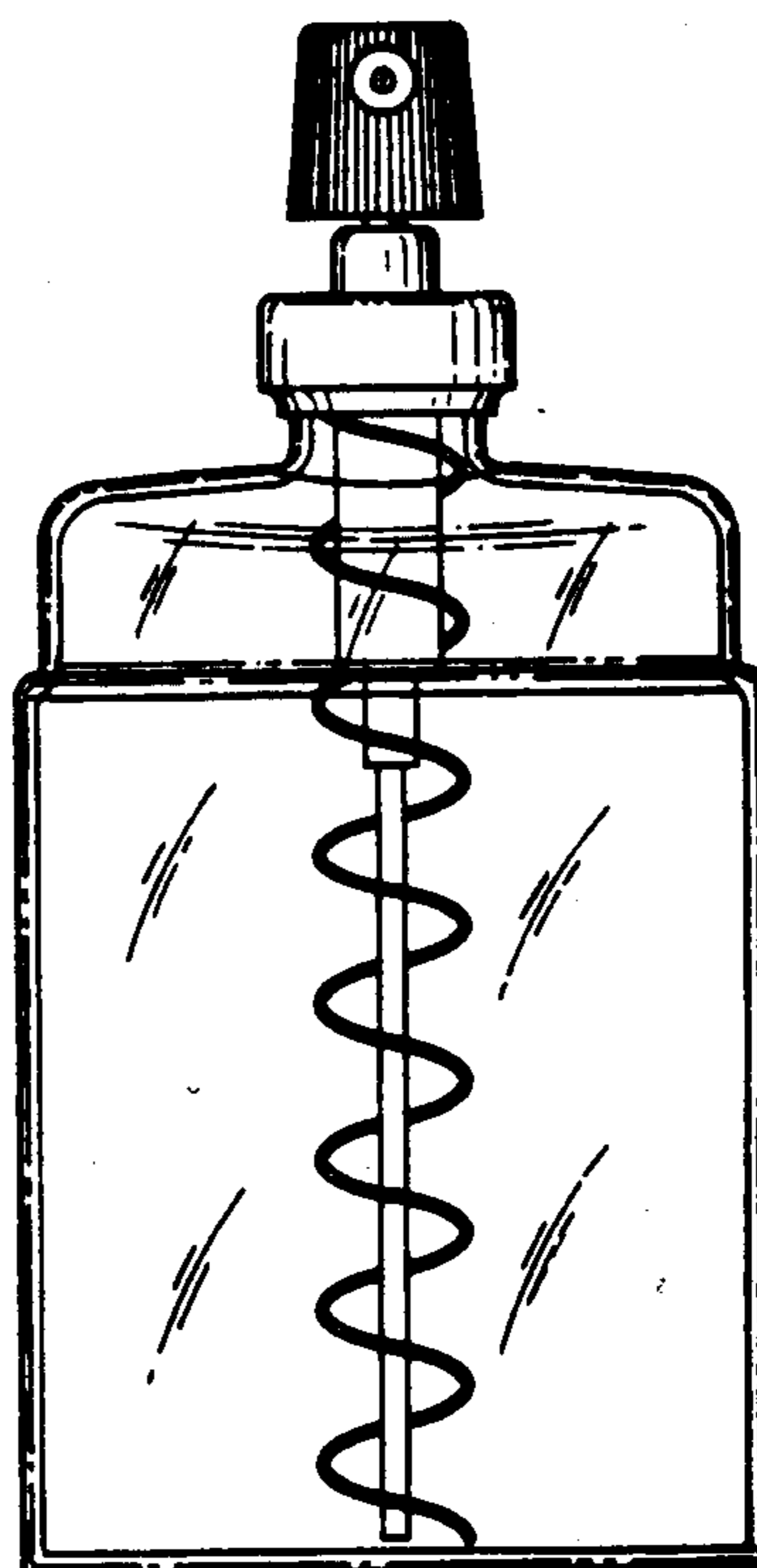

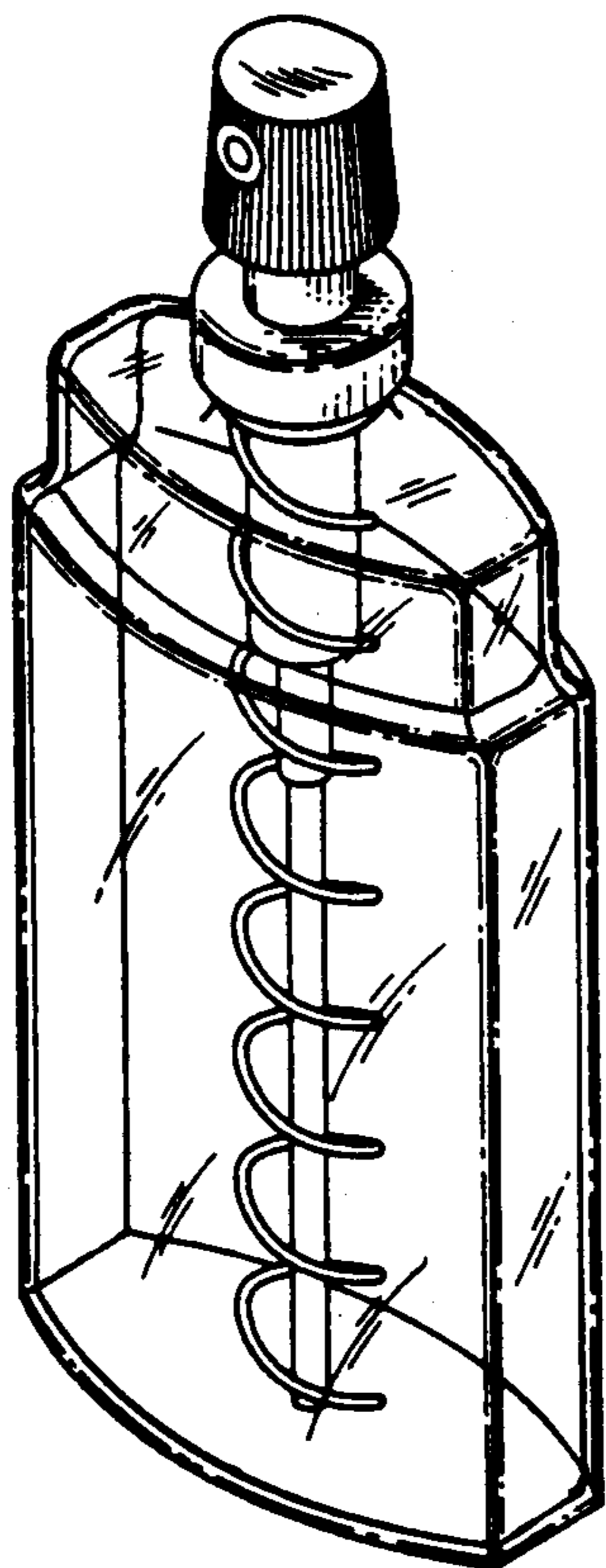

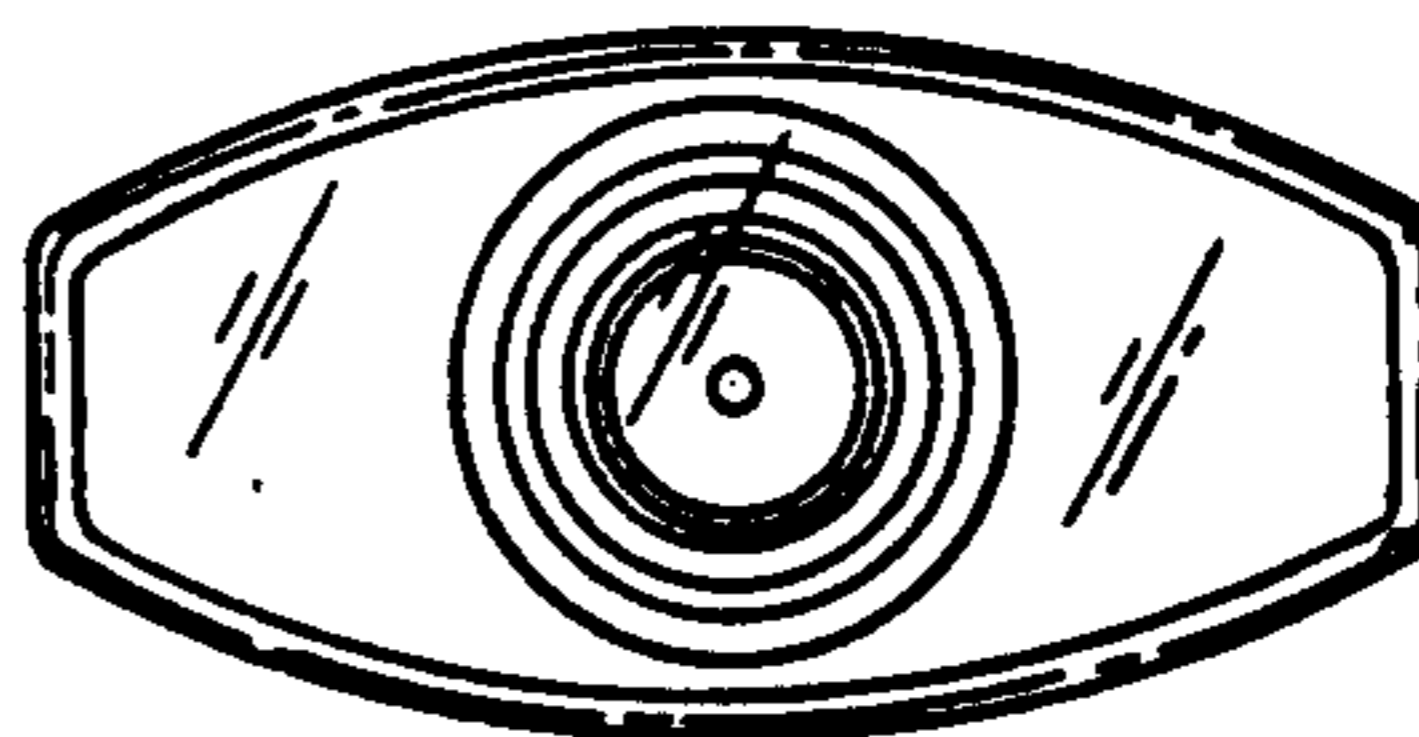

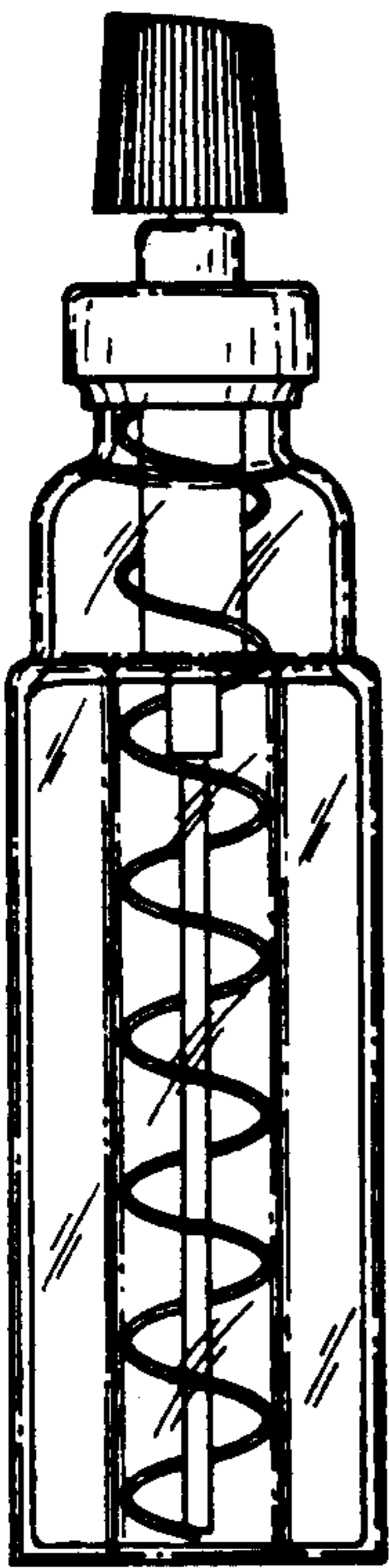

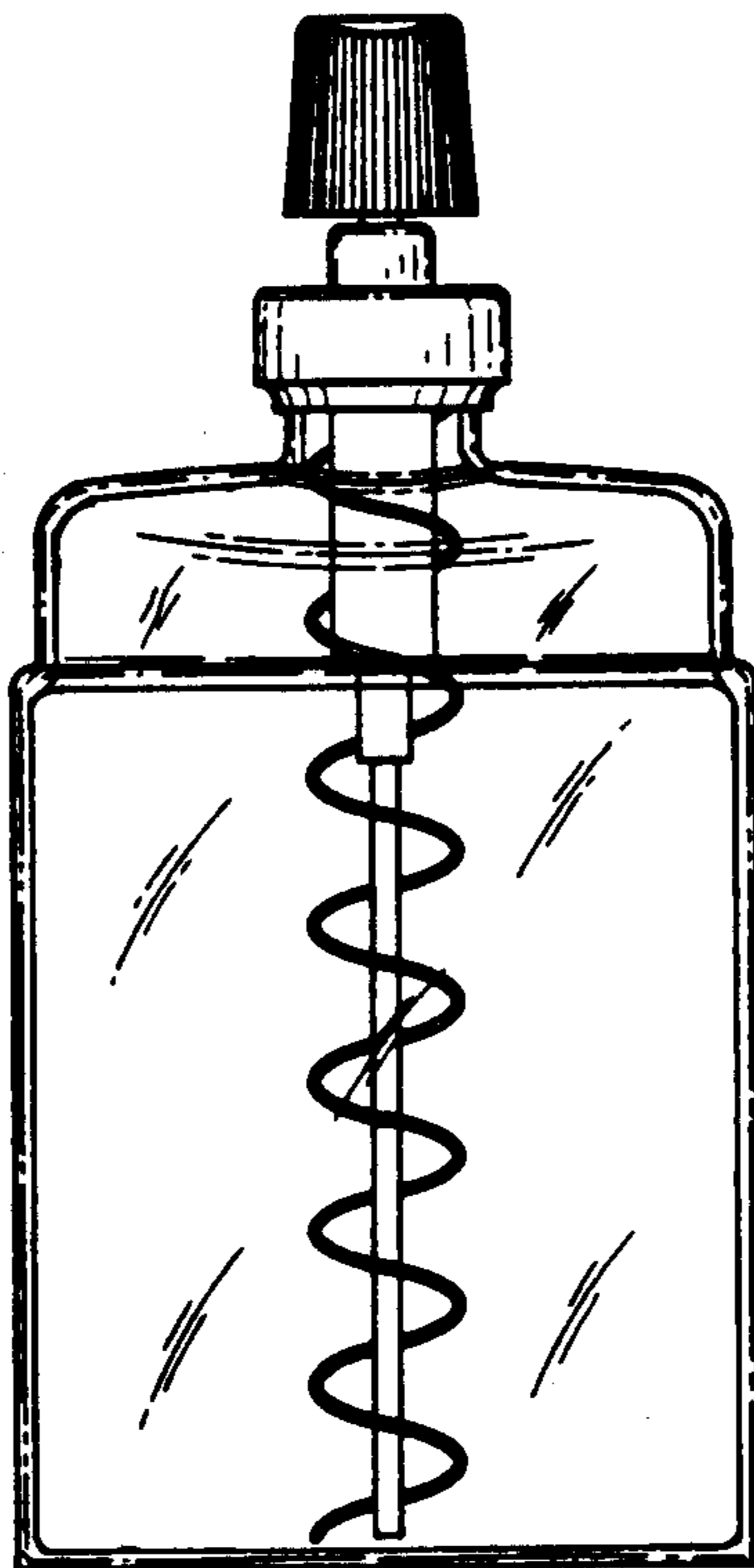
