[57] **CLAIM**

The ornamental design for a trim brush paint container, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a trim brush paint container showing our new design;
FIG. 2 is a top view thereof;
FIG. 3 is a bottom plan view thereof;
FIG. 4 is a left side elevation thereof;
FIG. 5 is a right side elevation thereof;
FIG. 6 is a front elevation thereof; and
FIG. 7 is a rear elevation thereof, in a reduced scale;
The broken lines showing of handle in FIG. 7 is for illustrative purposes only and forms no part of the claim.

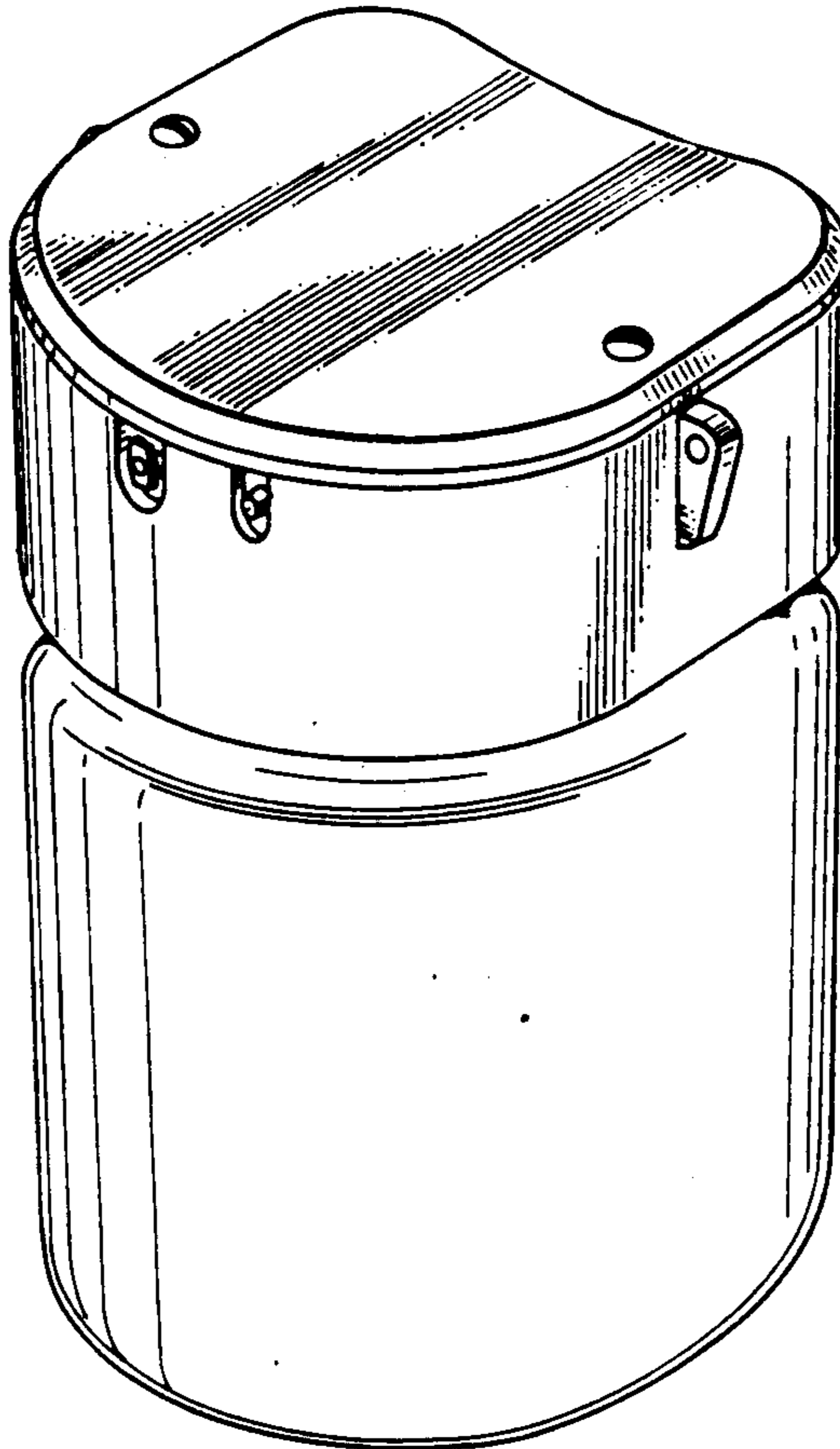

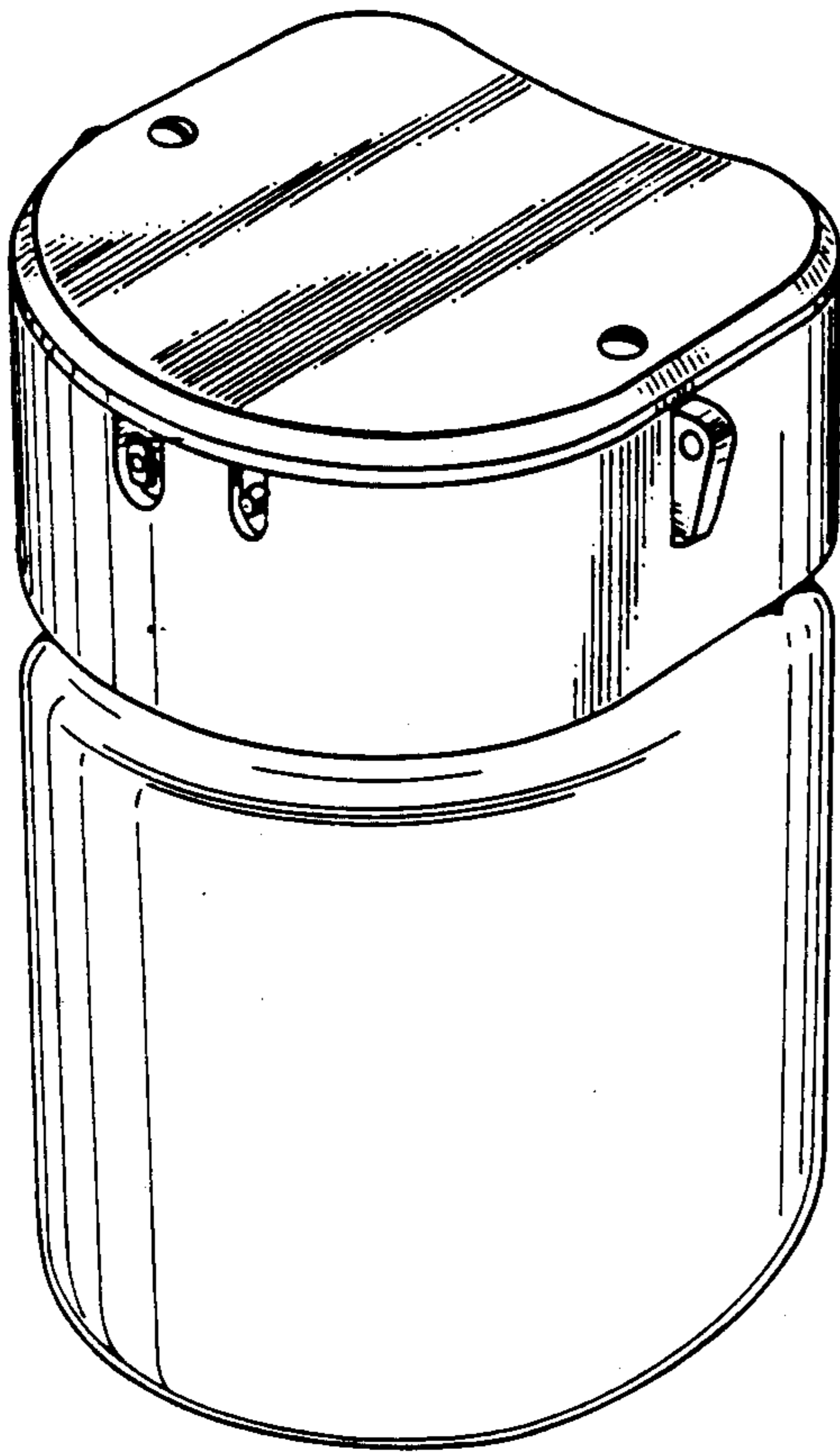

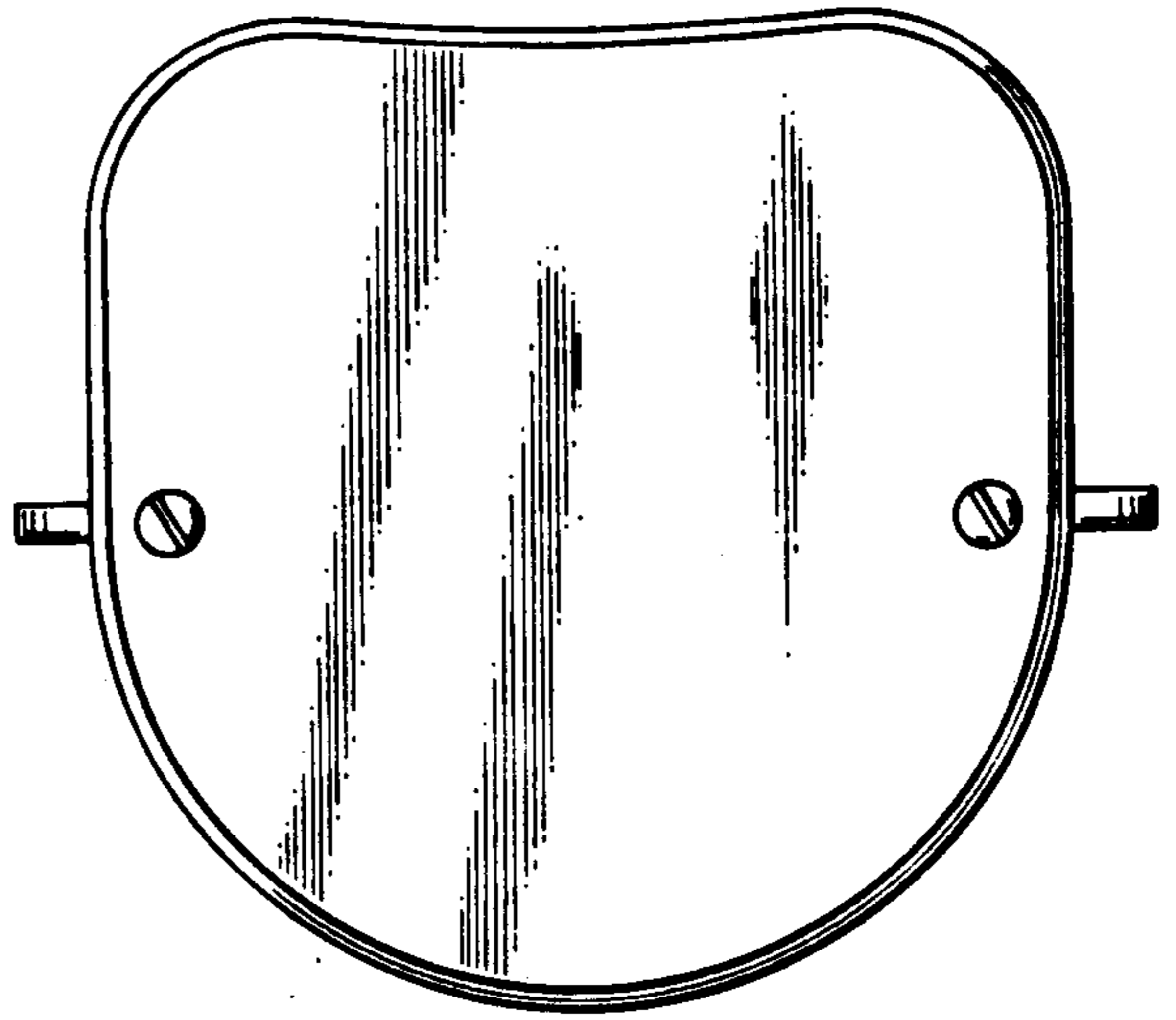

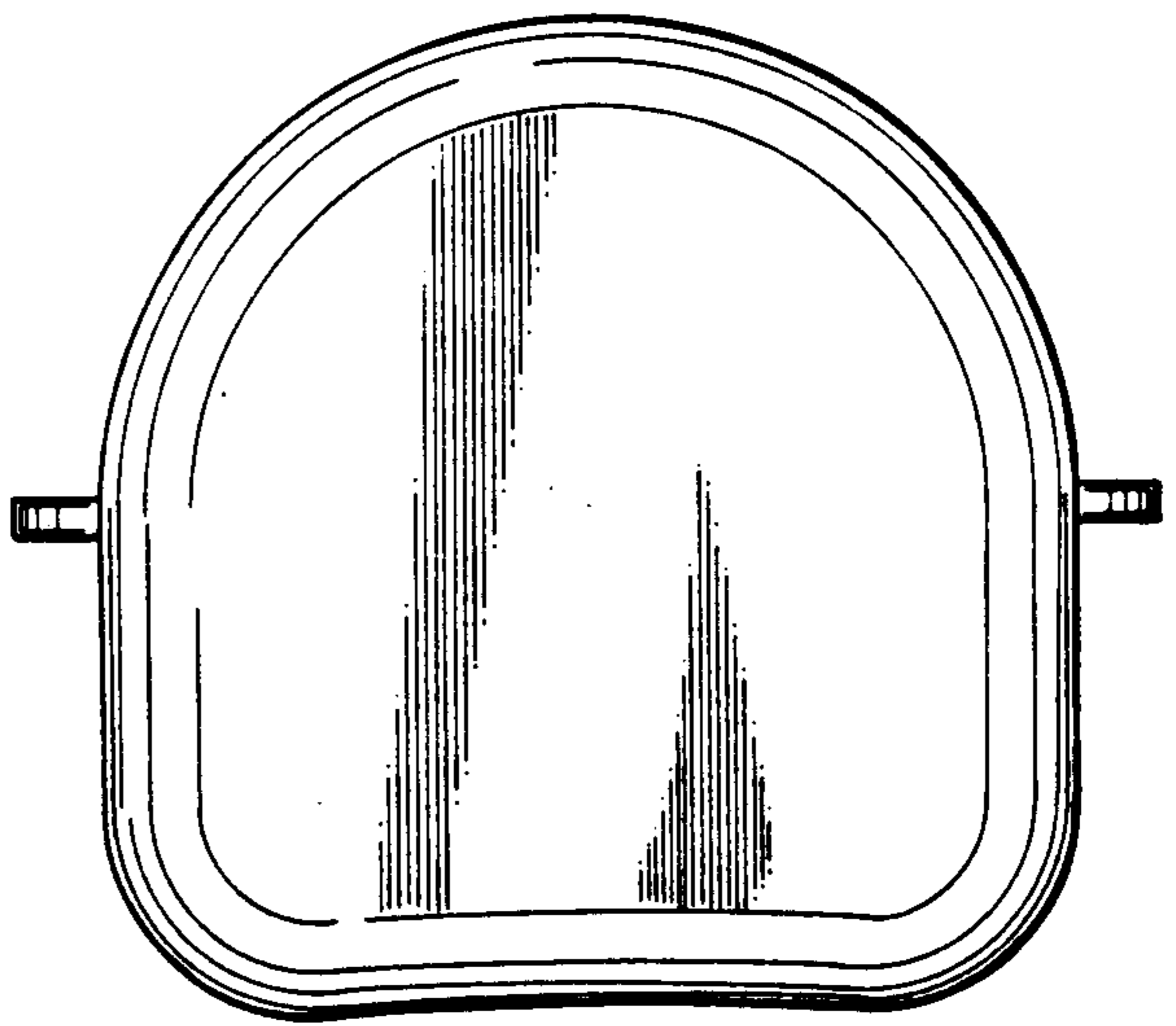

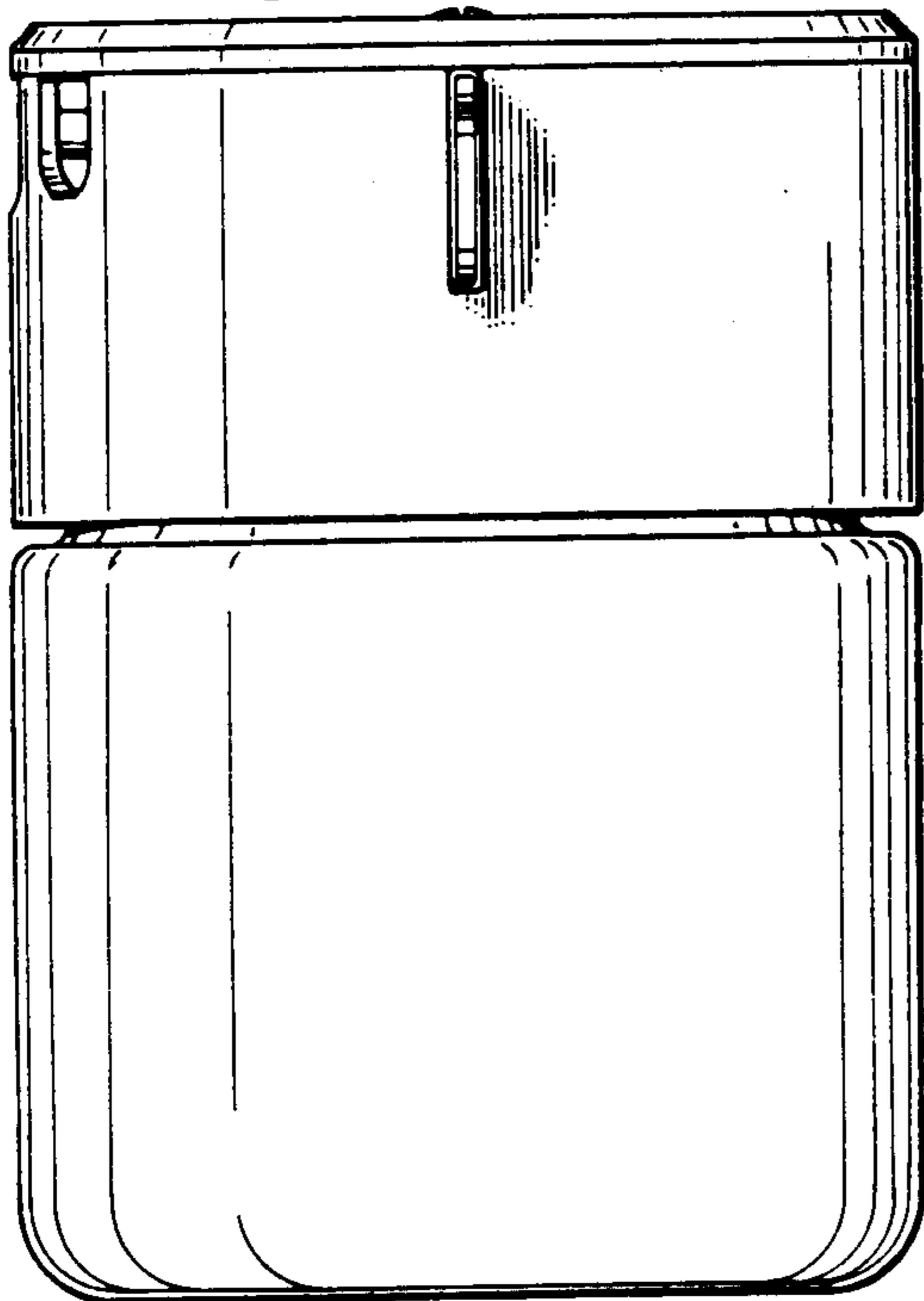

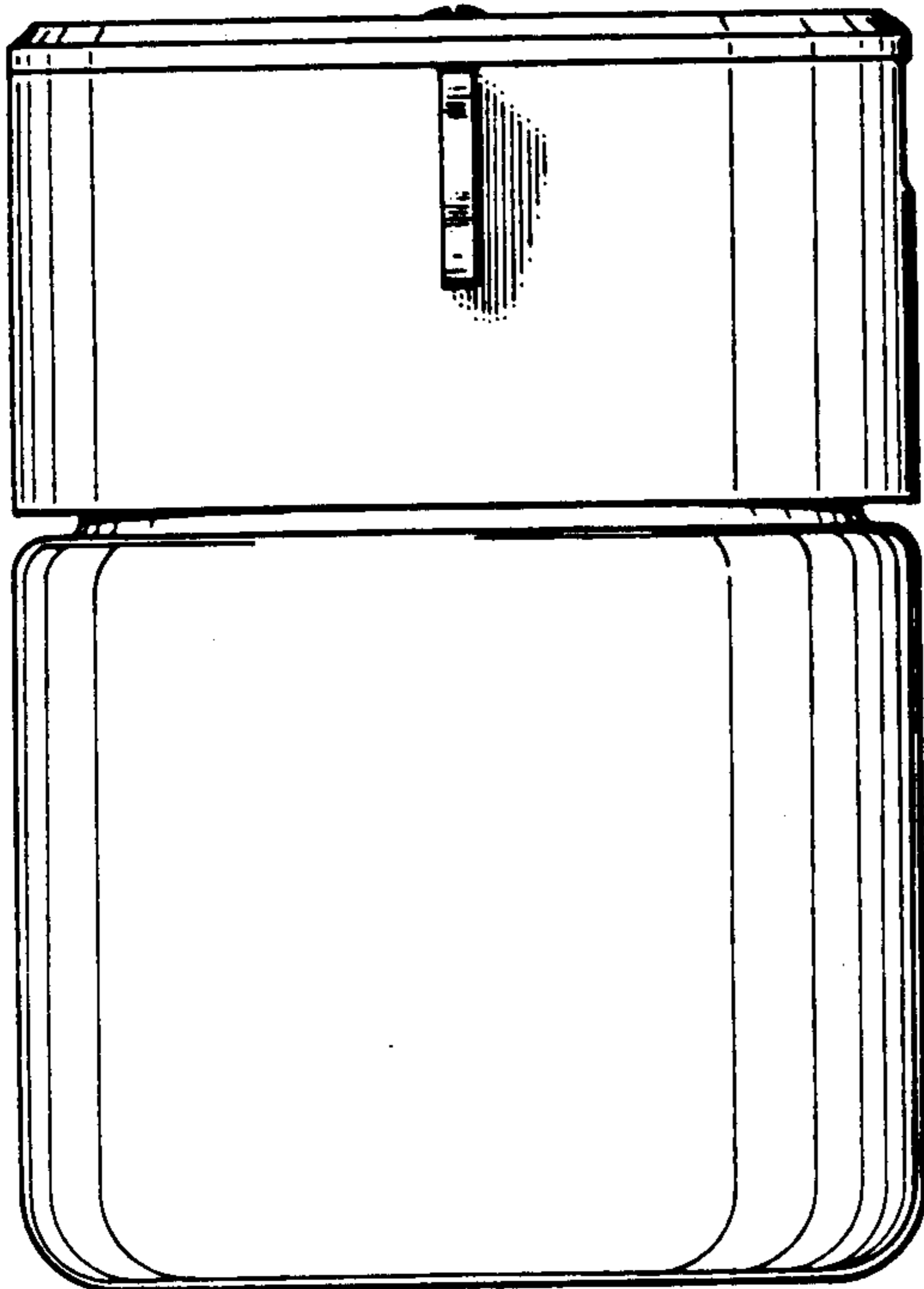

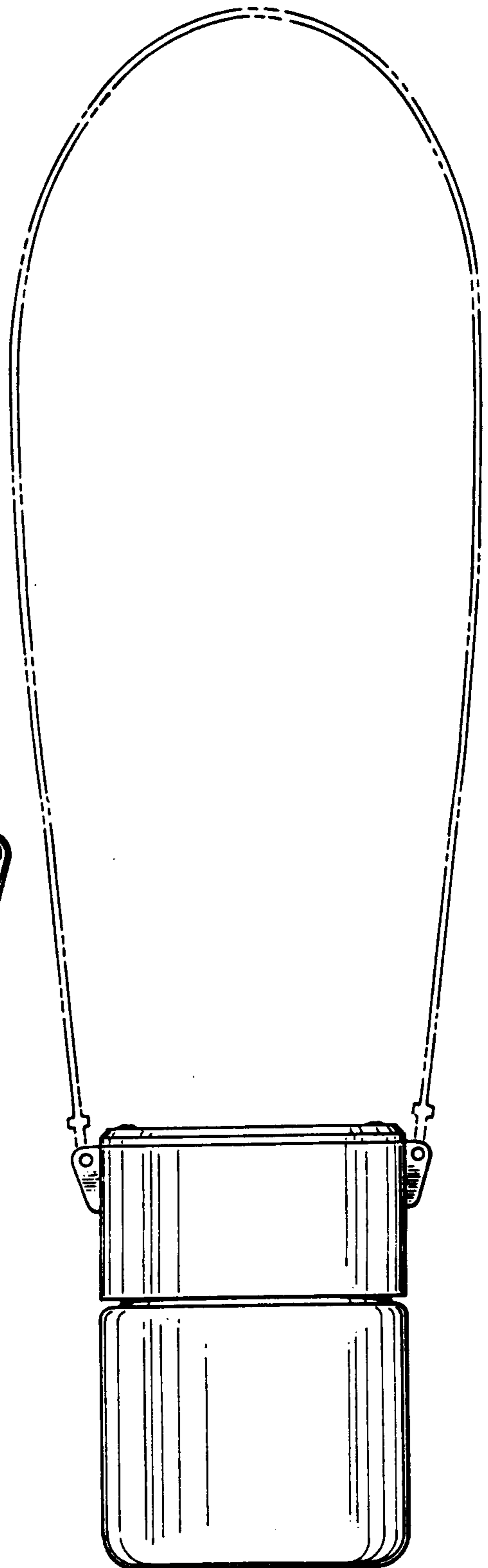
