DESCRIPTION

and FIG. 7 is a right-side view of the design as shown in FIG. 1.

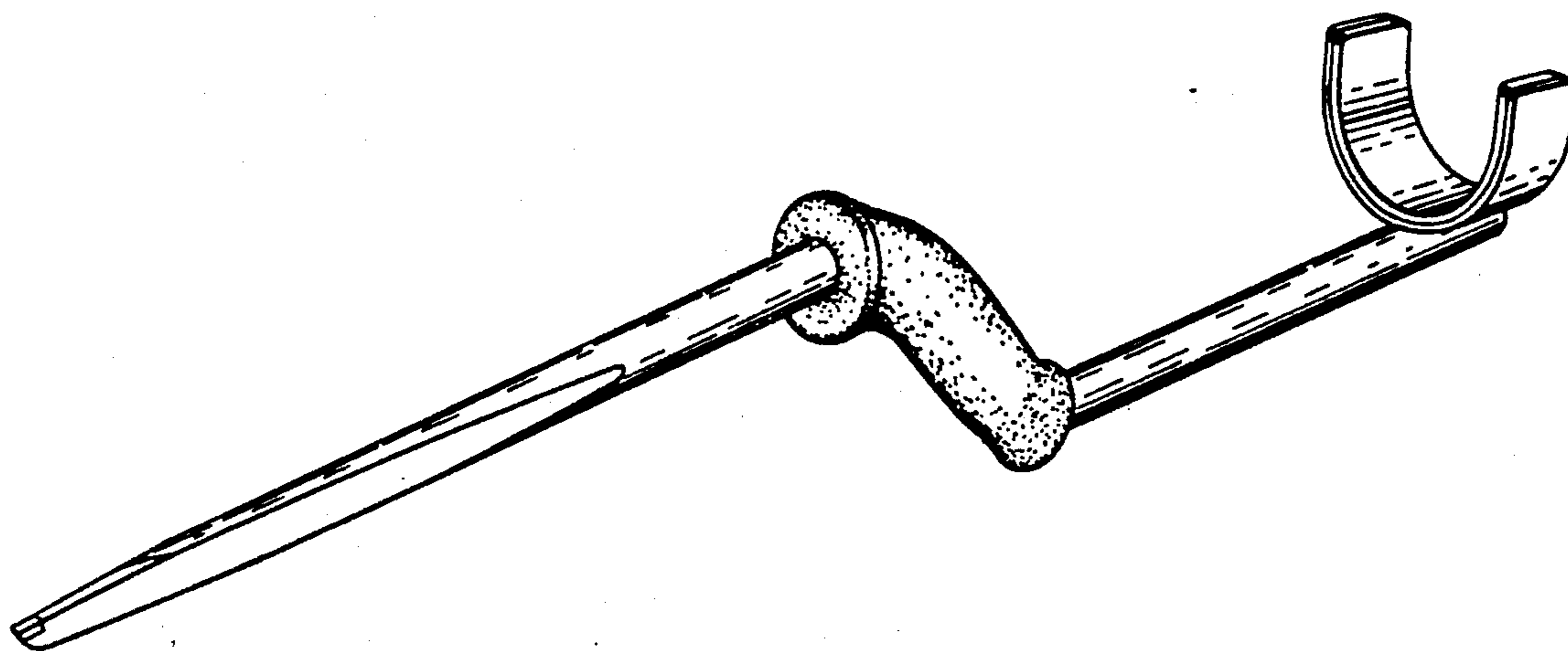

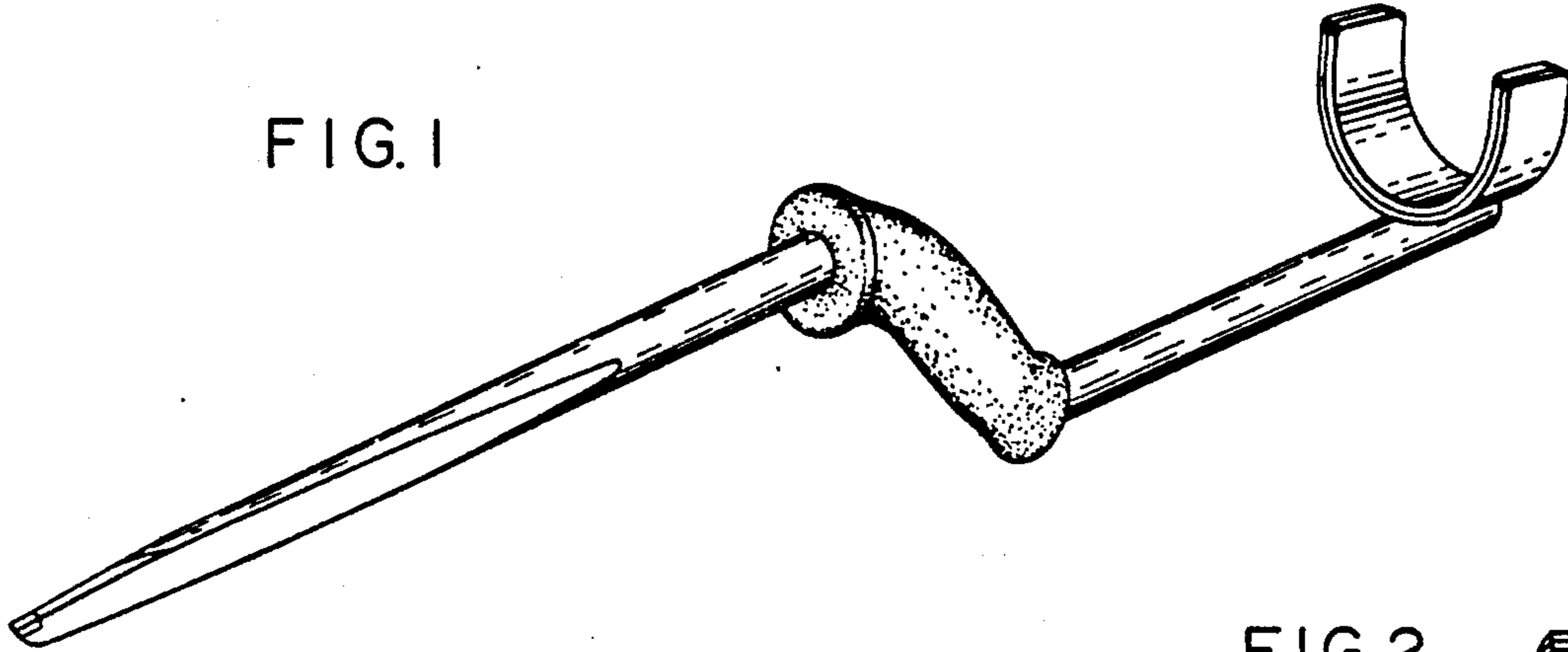

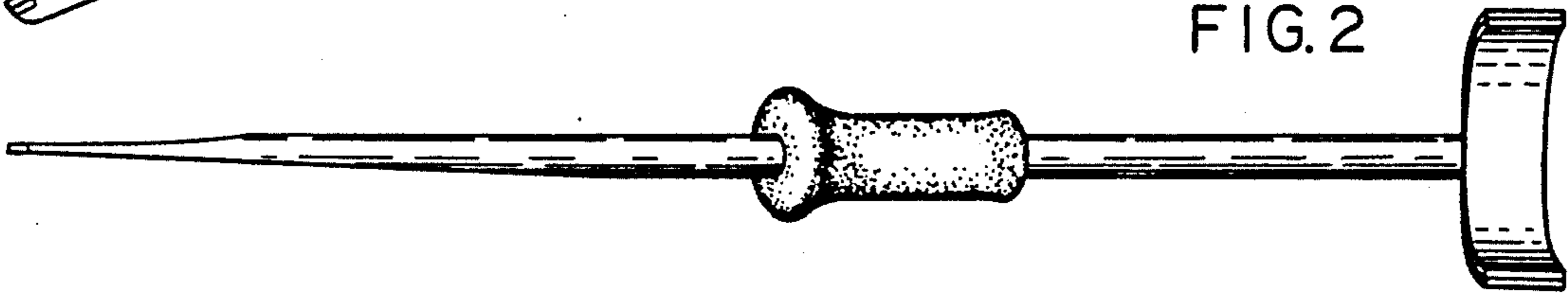

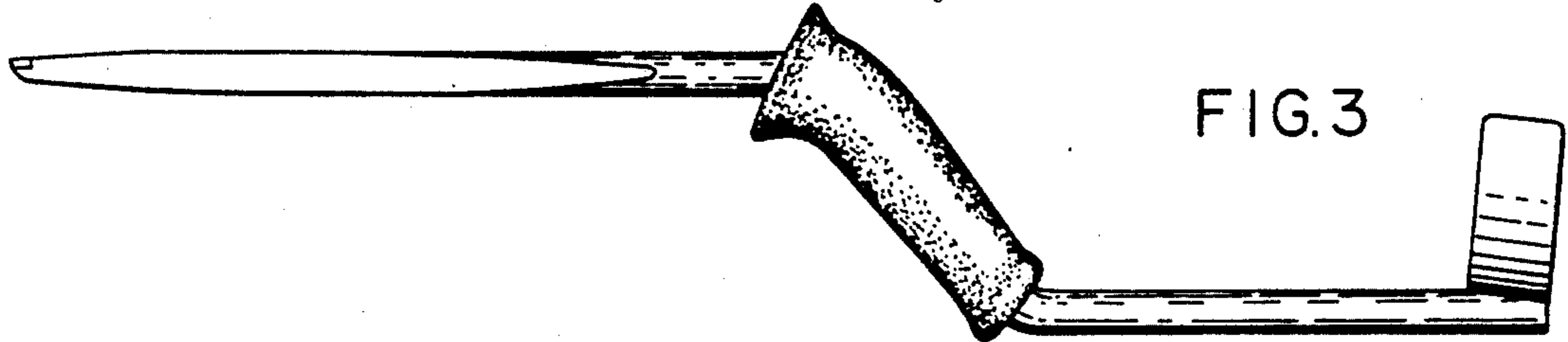

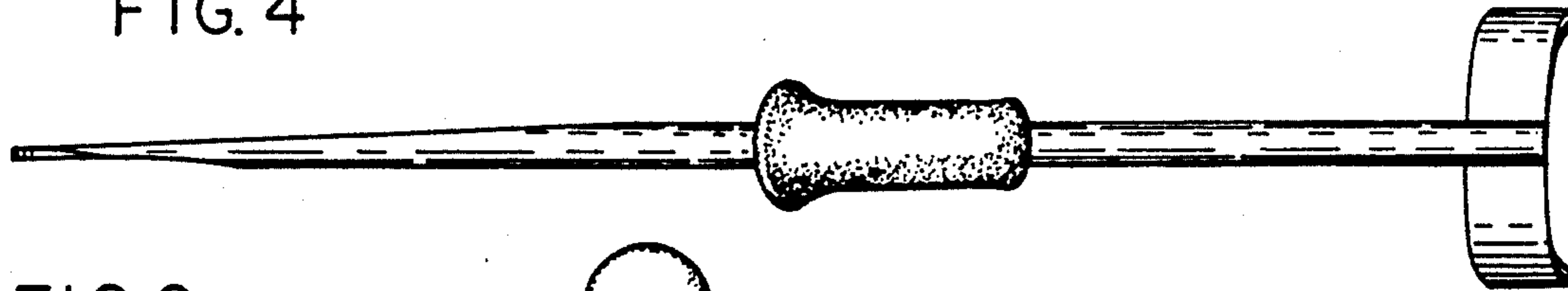

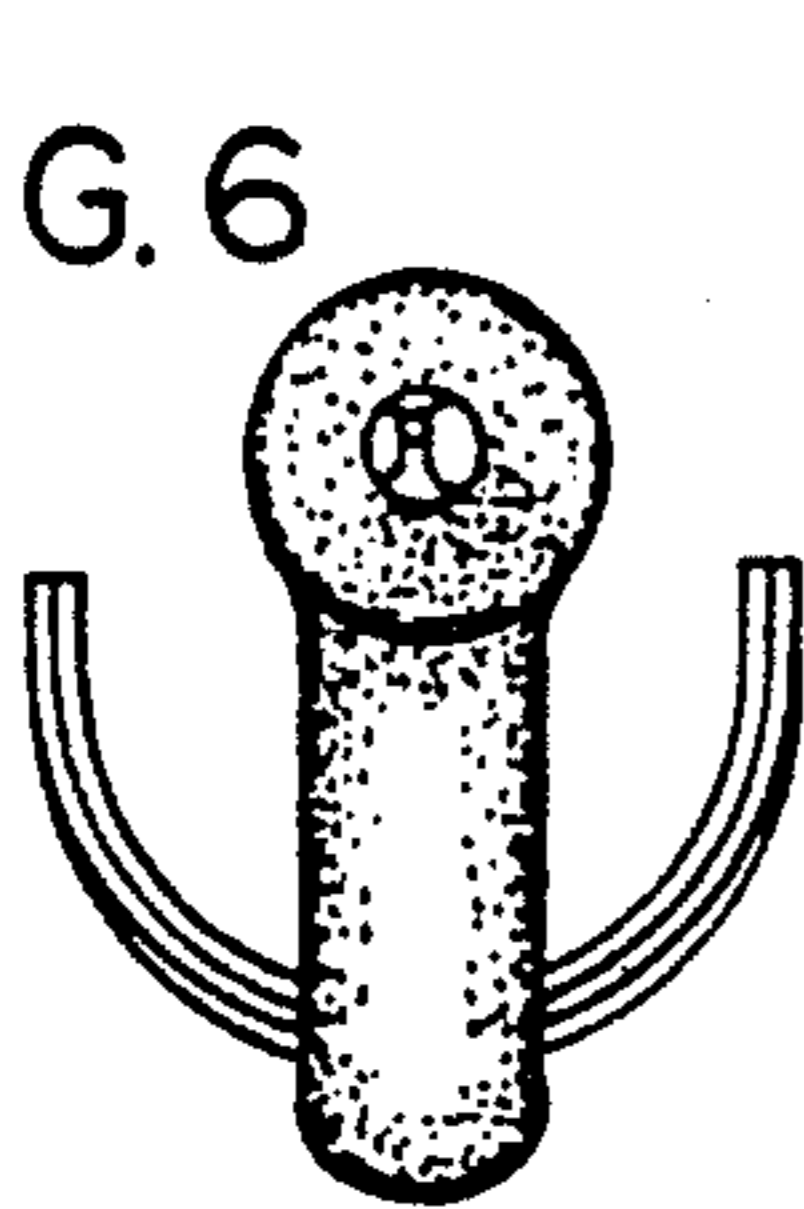

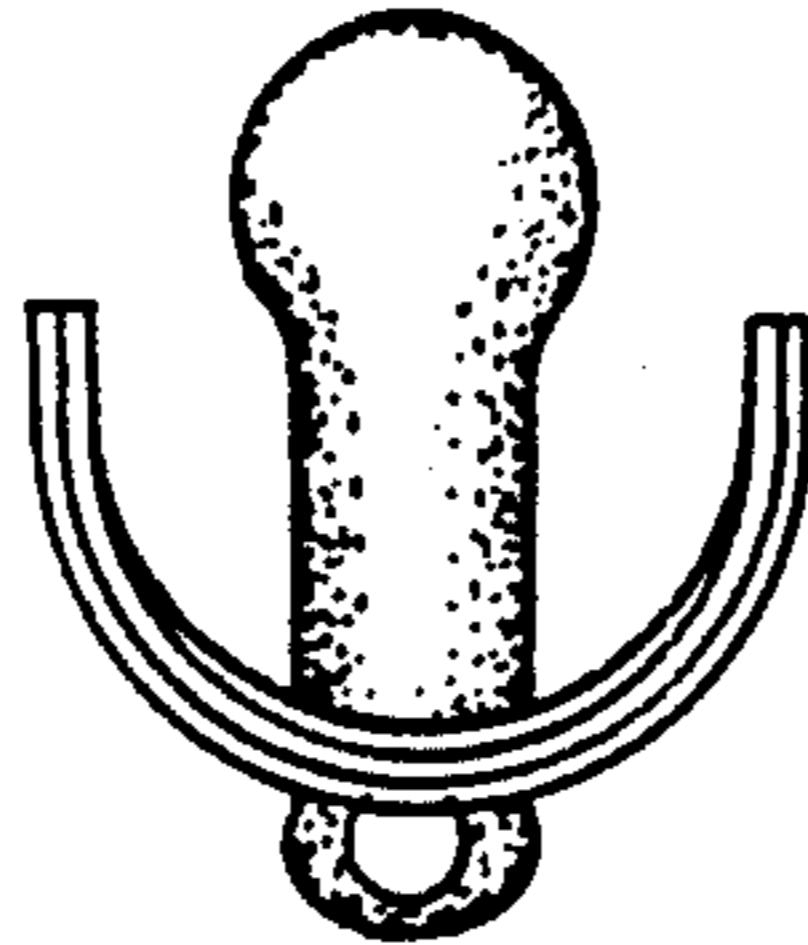
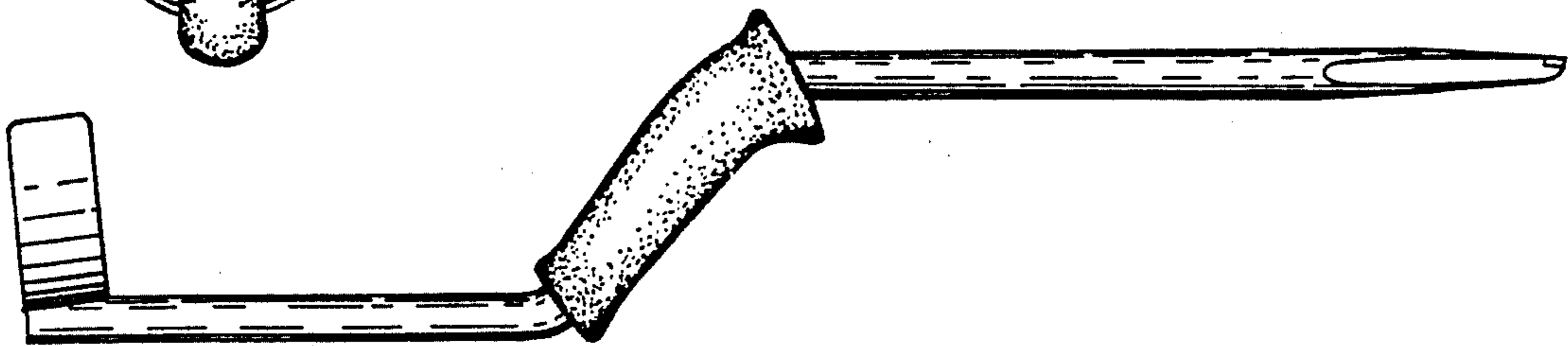
