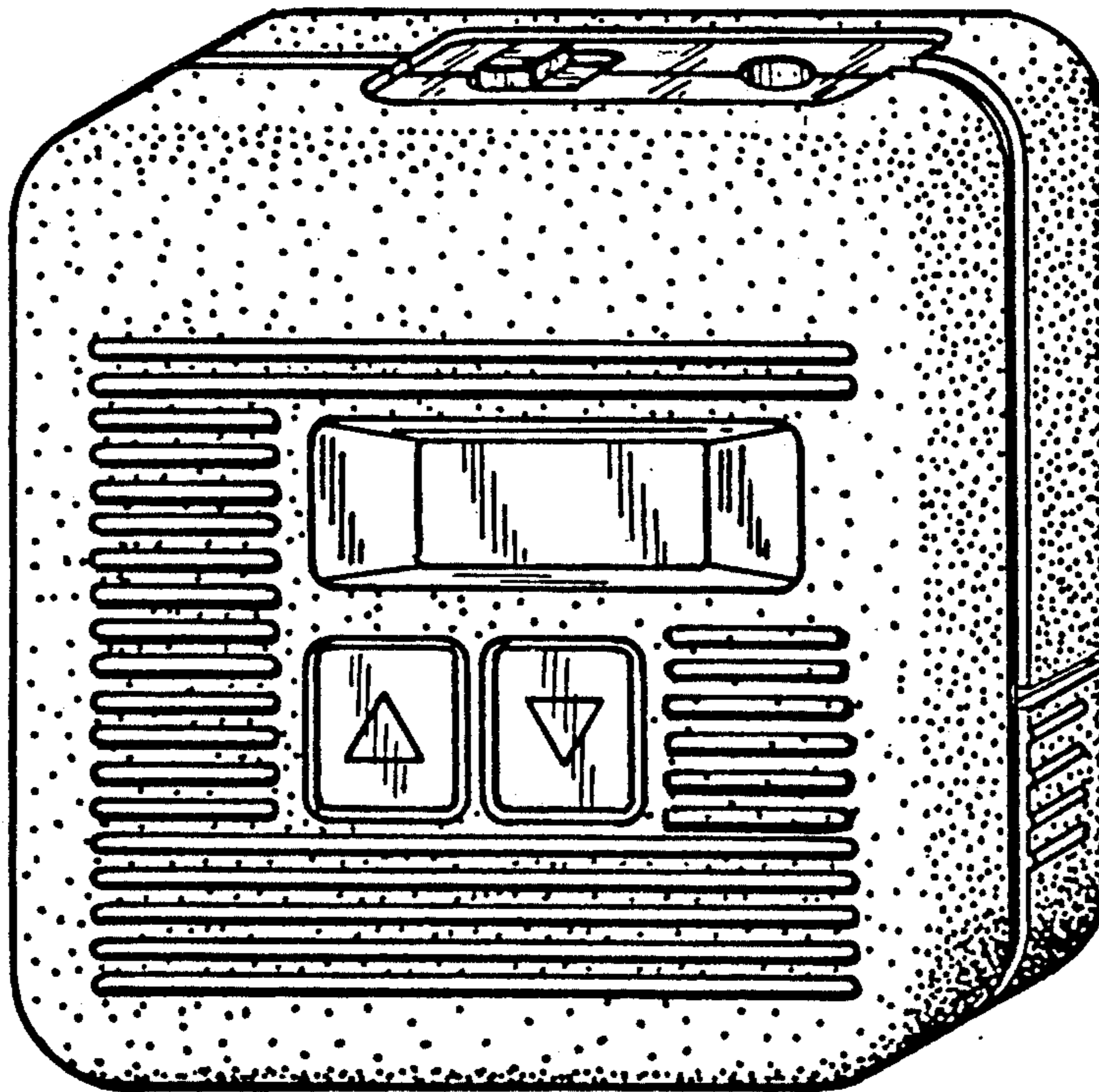

[57] **CLAIM**

The ornamental design for a tactile annunciator for alerting persons with or without hearing impairments, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a tactile annunciator for alerting persons with or without hearing impairments, showing my new design;
FIG. 2 is a front elevational view thereof;
FIG. 3 is a side elevational view thereof;
FIG. 4 is a side elevational view thereof, opposite that shown in FIG. 3;
FIG. 5 is a top plan view thereof;
FIG. 6 is a bottom plan view thereof; and
FIG. 7 is a rear elevational view thereof.



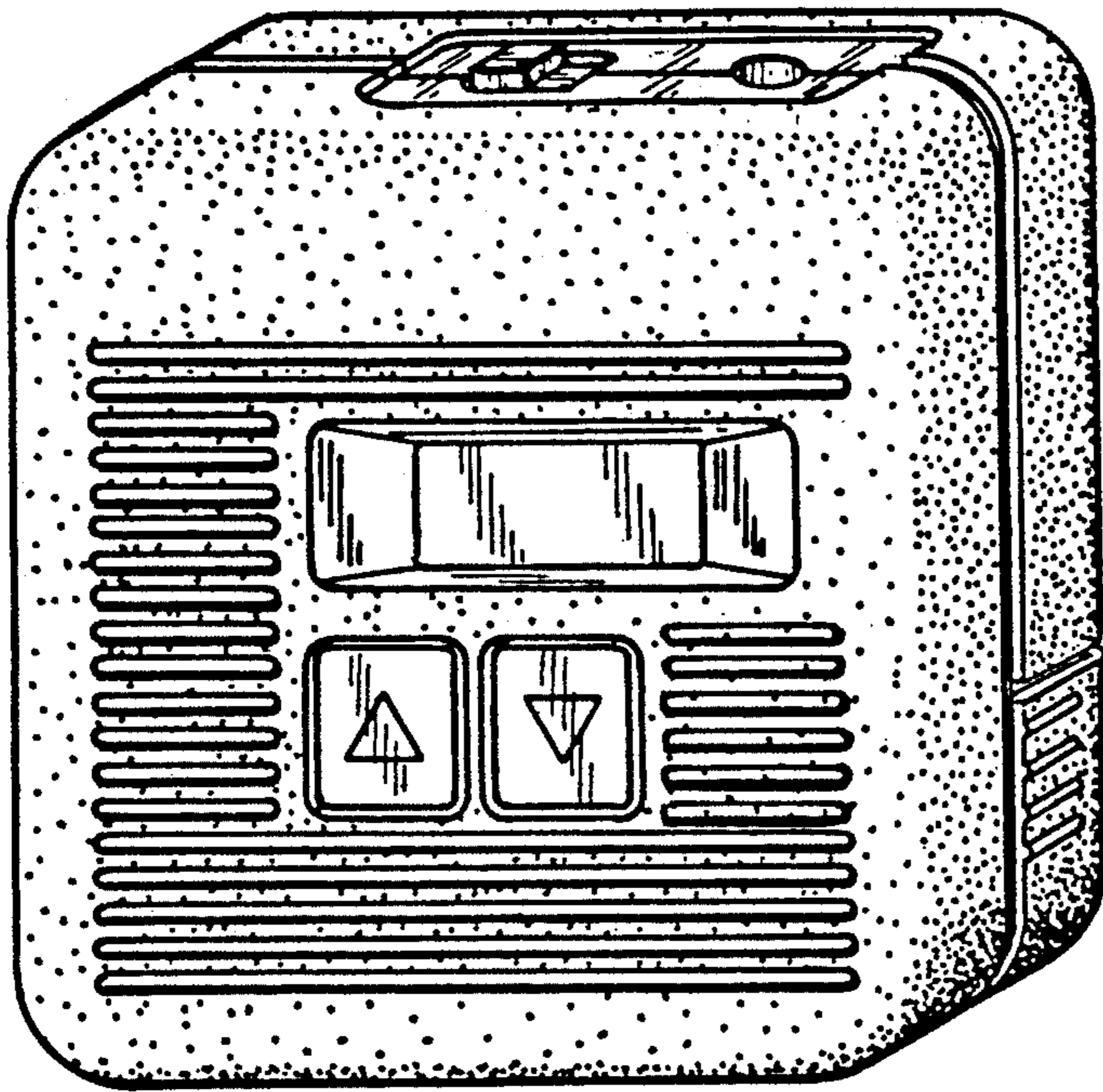

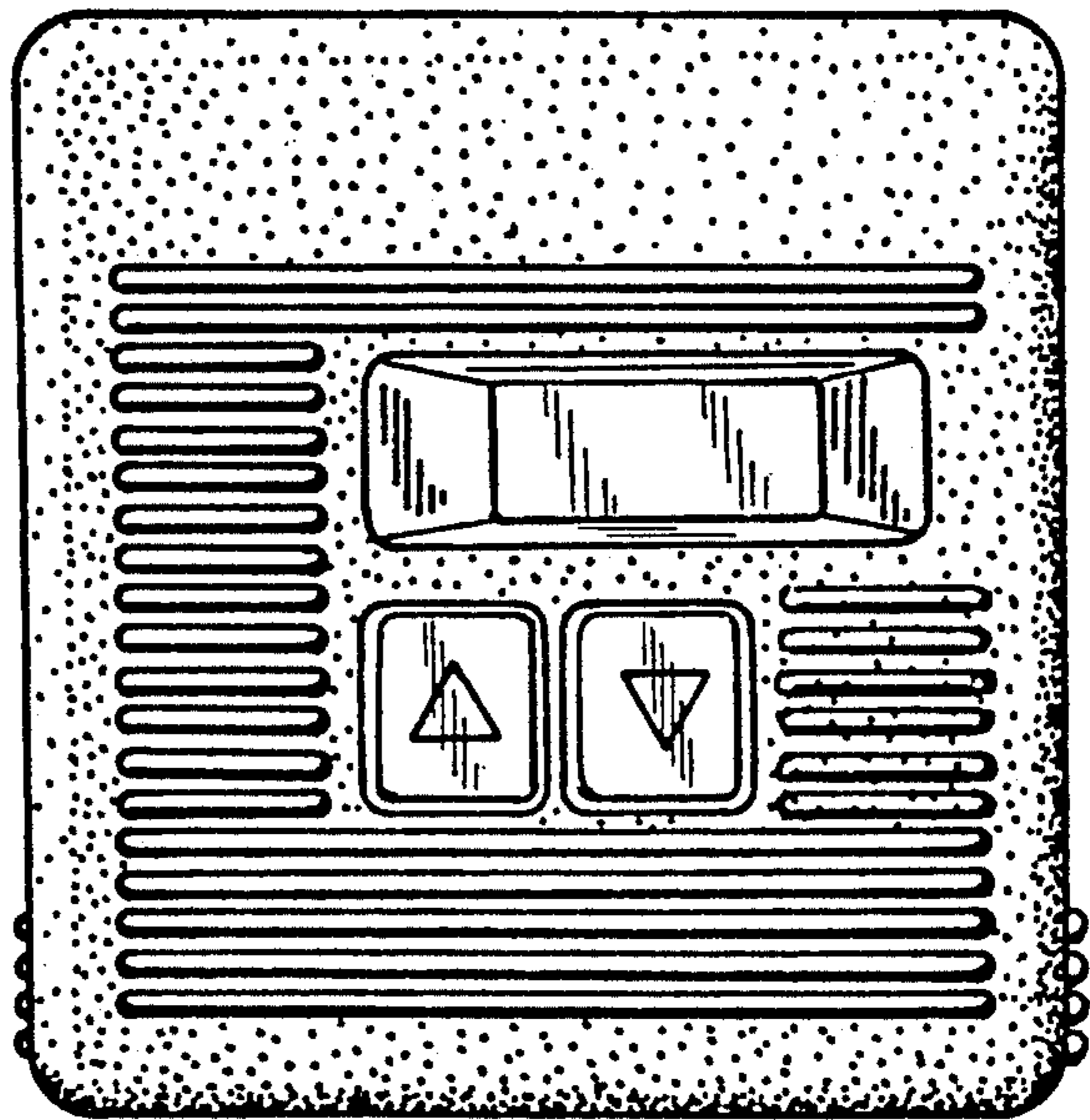

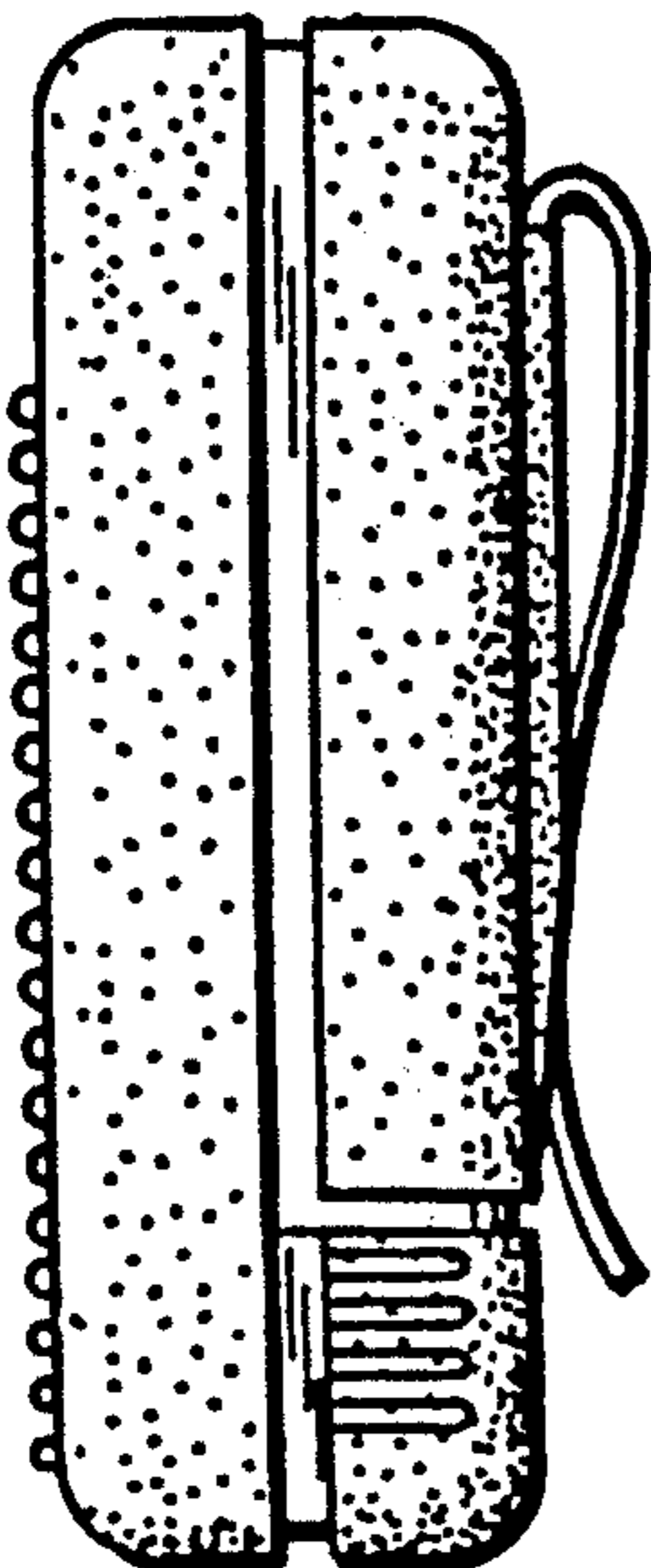

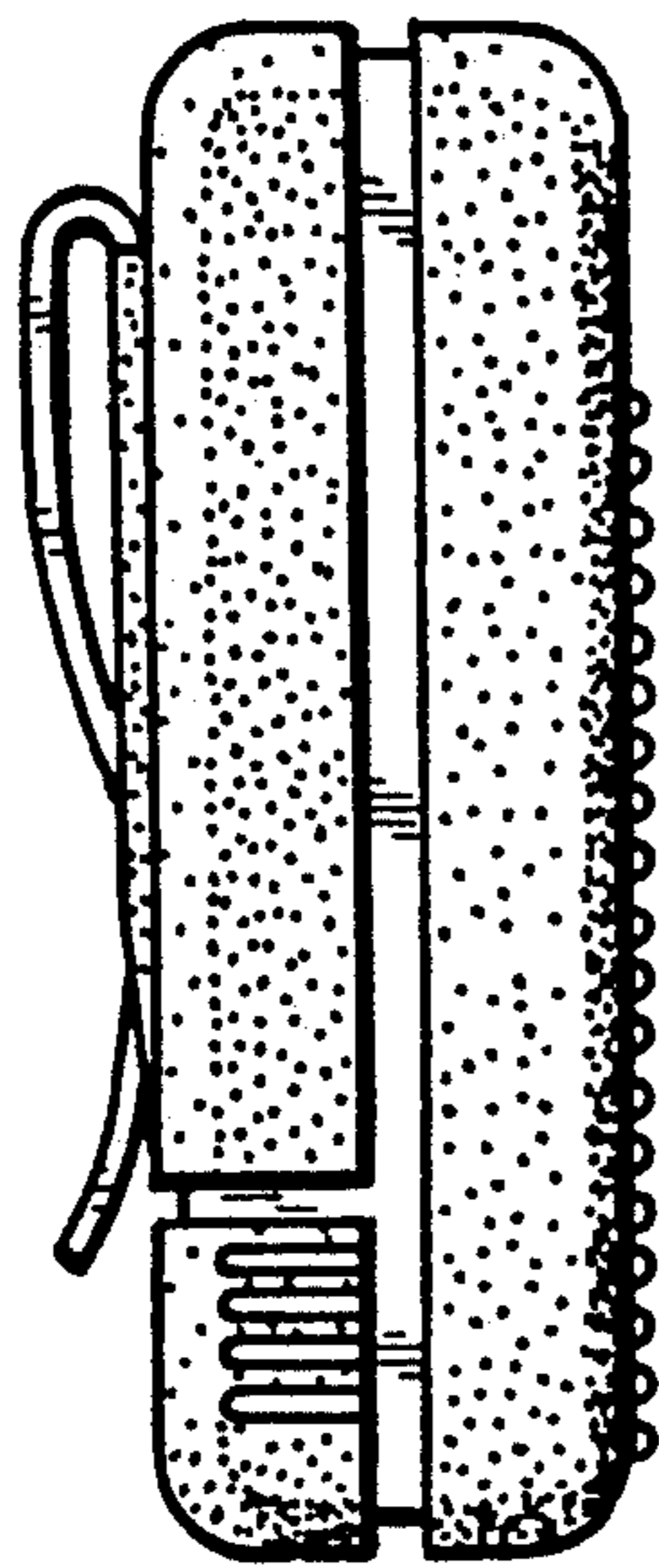

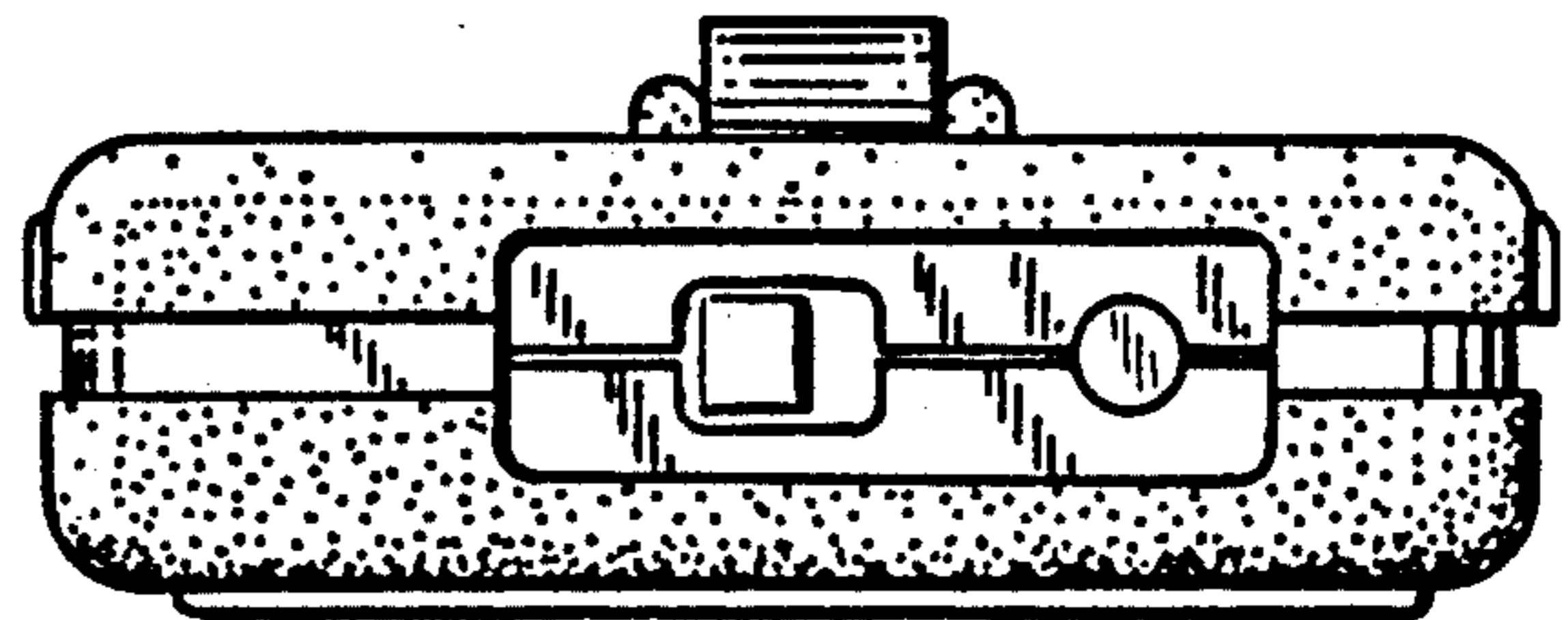

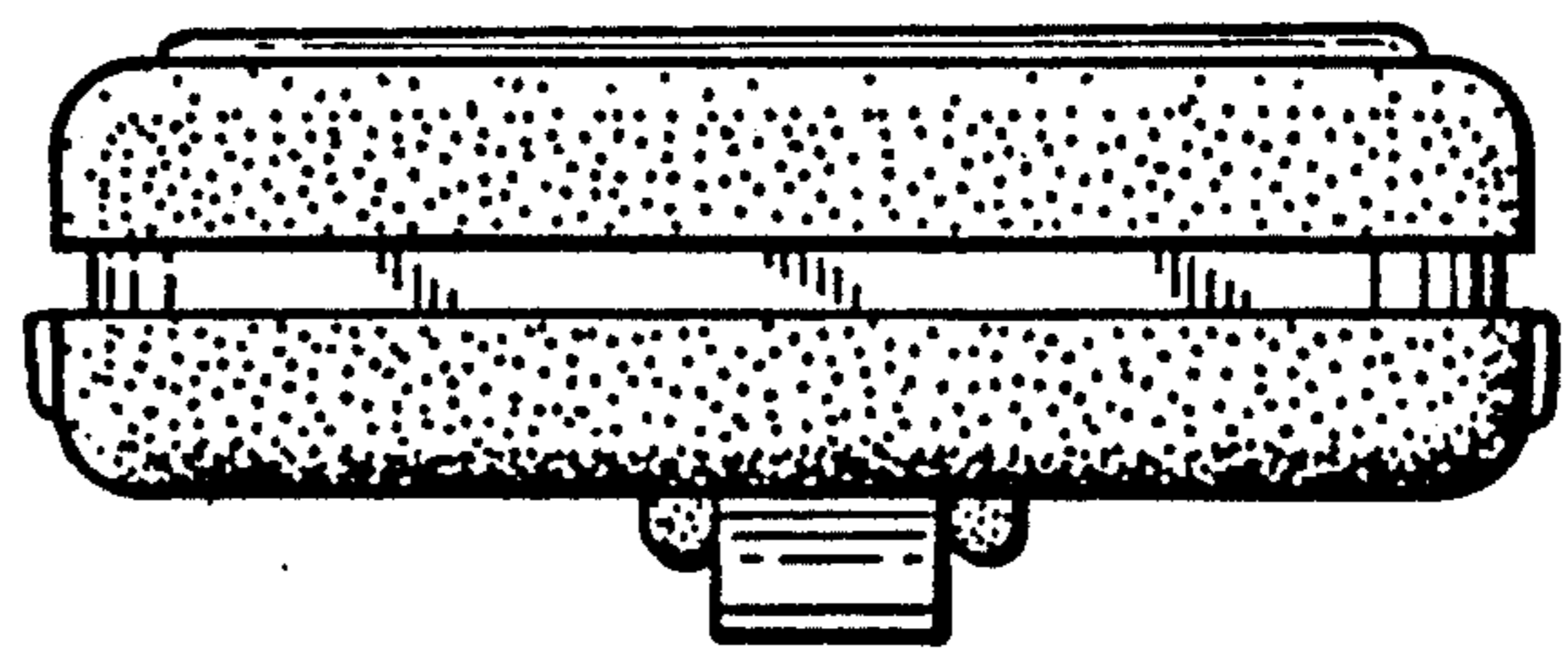

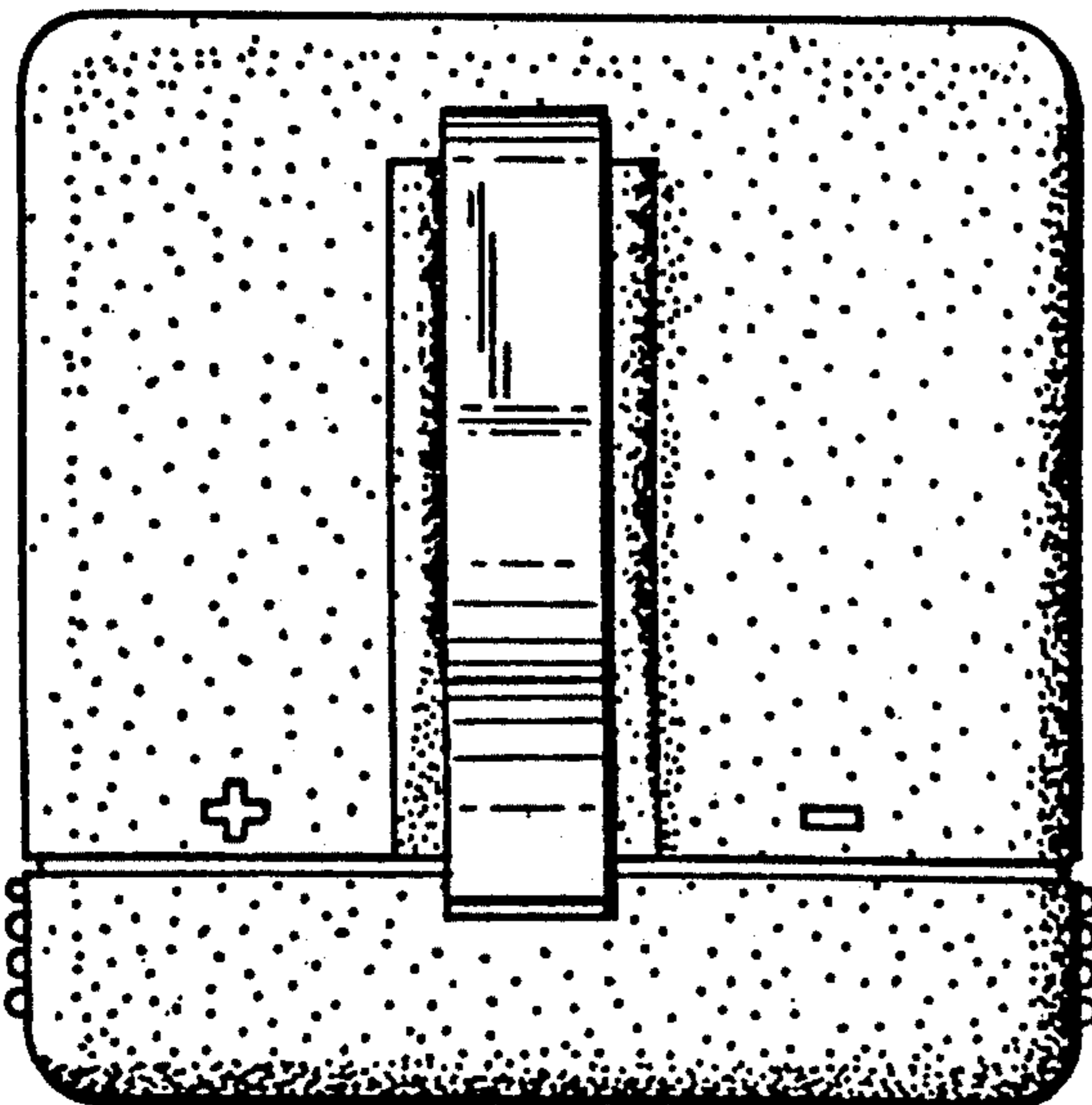
