The ornamental design for a loading module for currency cartridges, as shown and described.

FIG. 3 is a rear elevational view thereof on an enlarged scale;

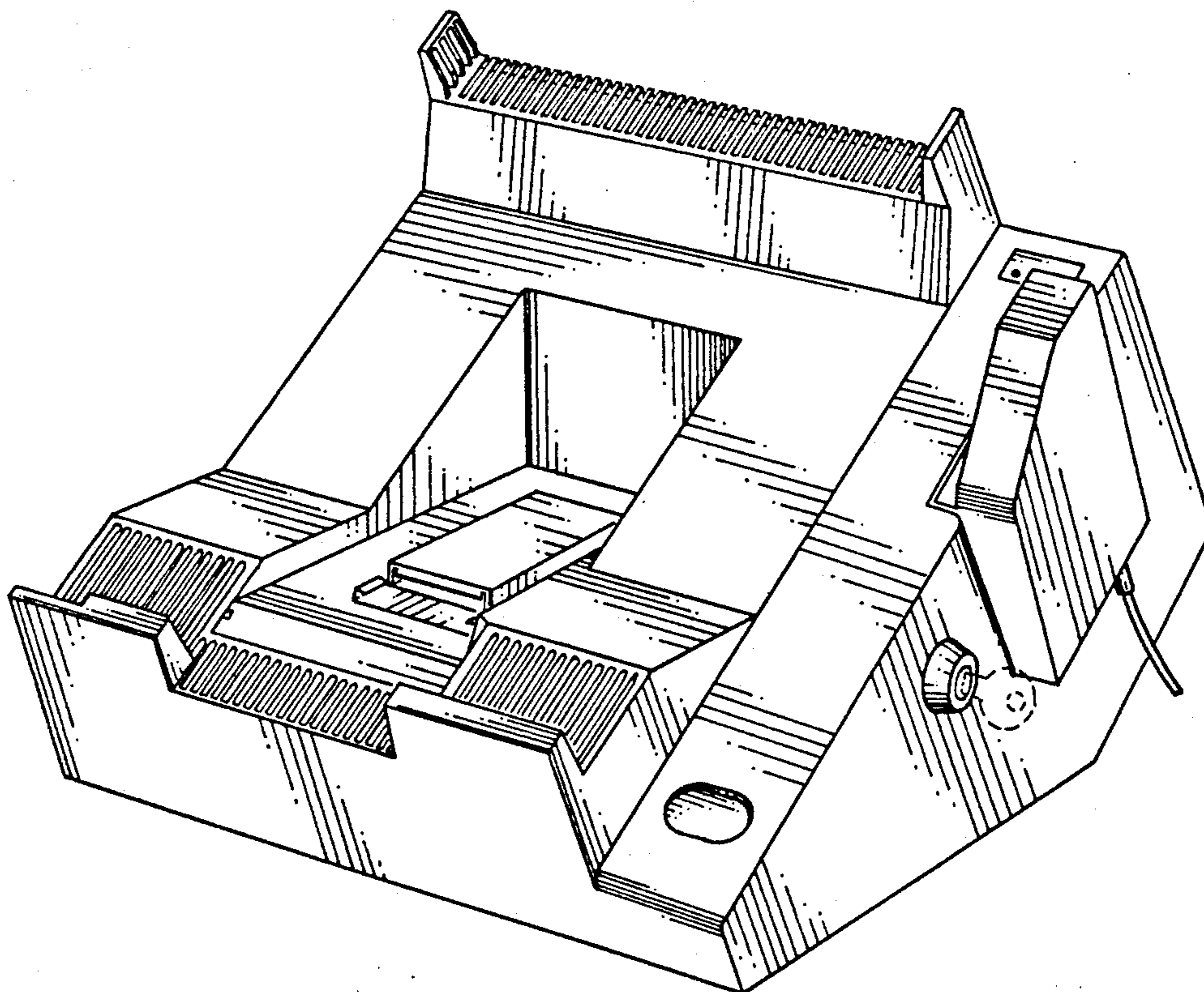
FIG. 4 is a left side elevational view thereof on an enlarged scale;

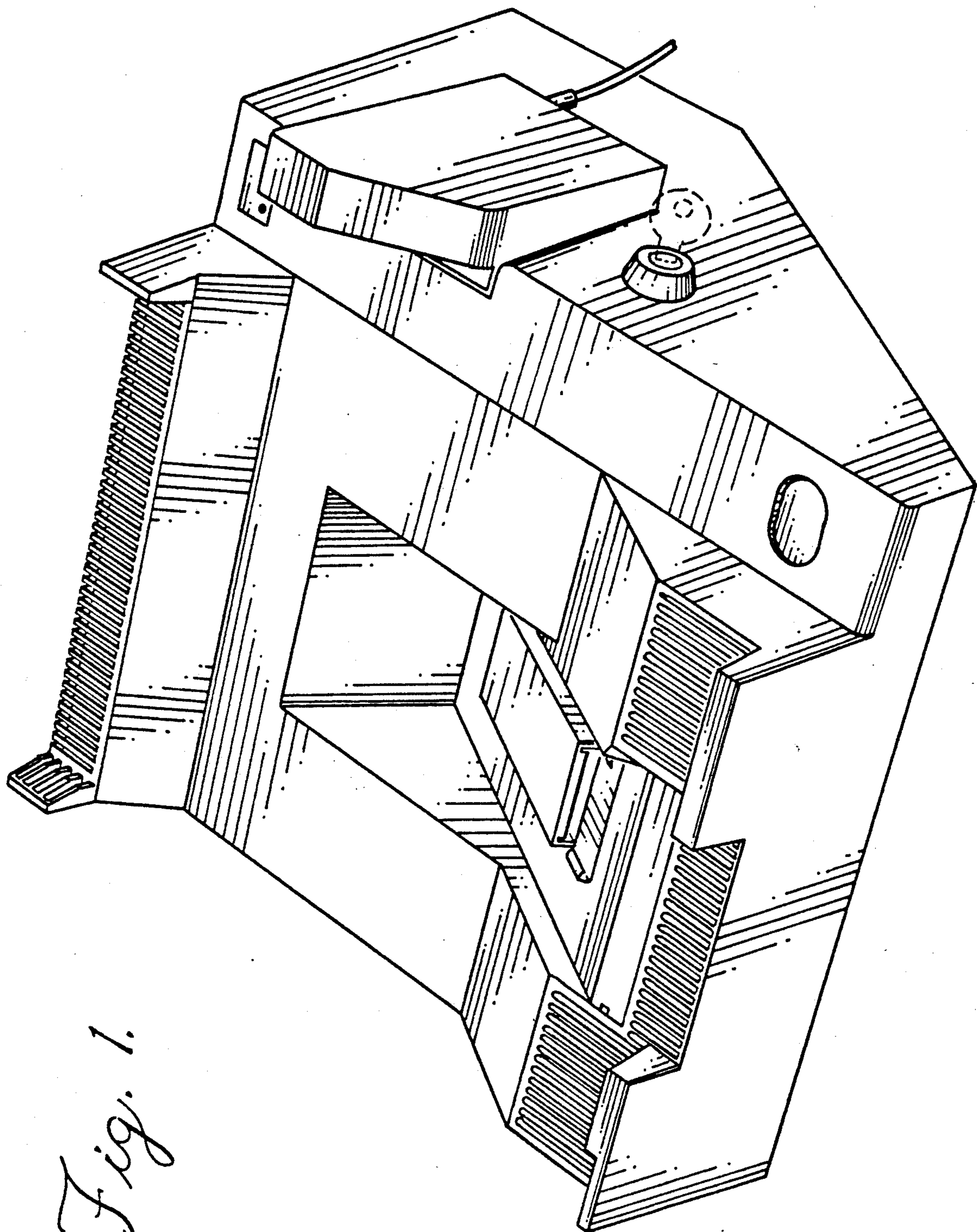
FIG. 5 is a right side elevational view thereof on an enlarged scale;

FIG. 7 is a bottom plan view thereof on an enlarged scale.

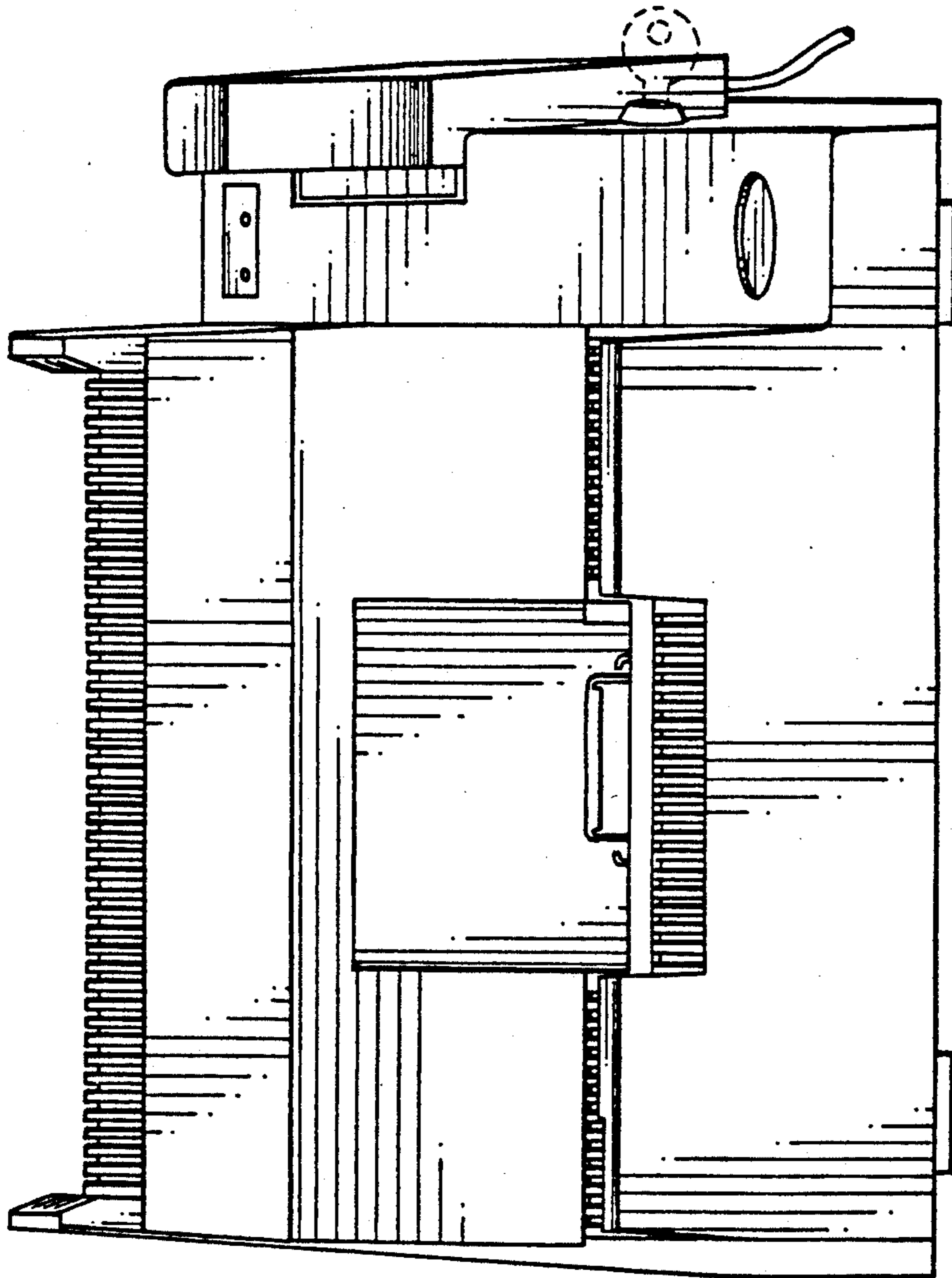
The key shown in broken lines in FIGS. 1, 2, 3, 5, 6, and 7 is shown for illustrative purposes only and forms no part of the claimed design.

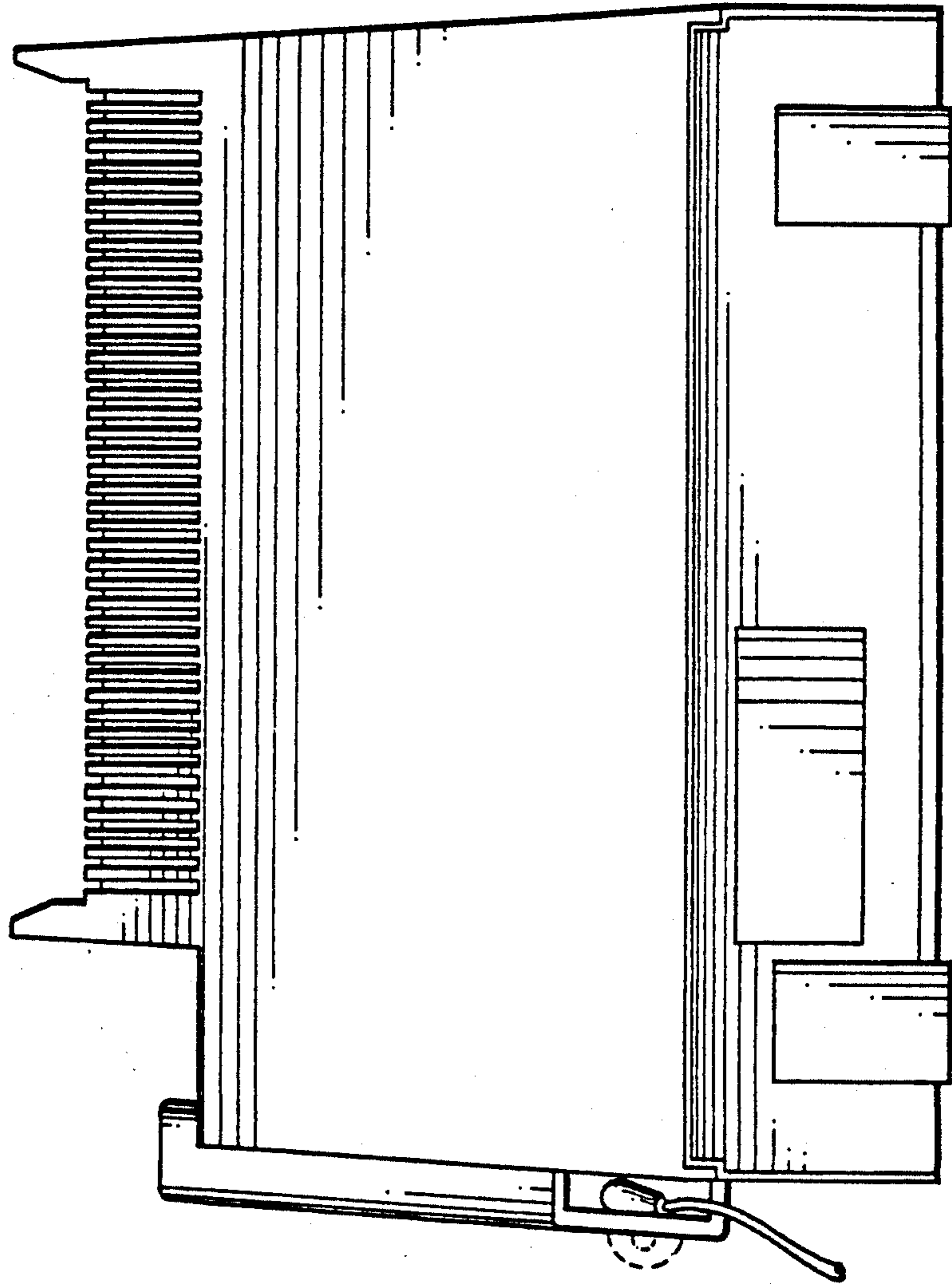

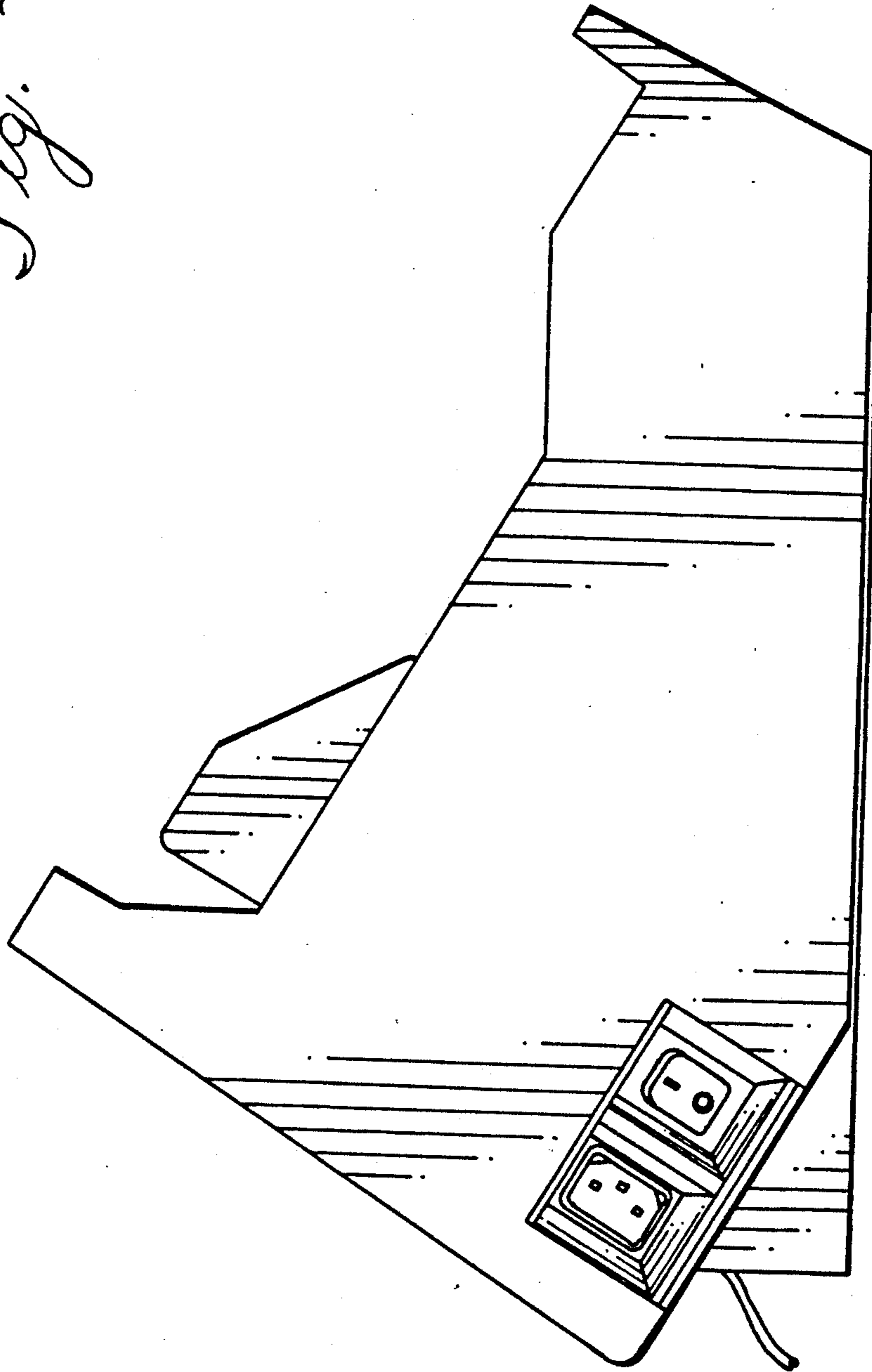

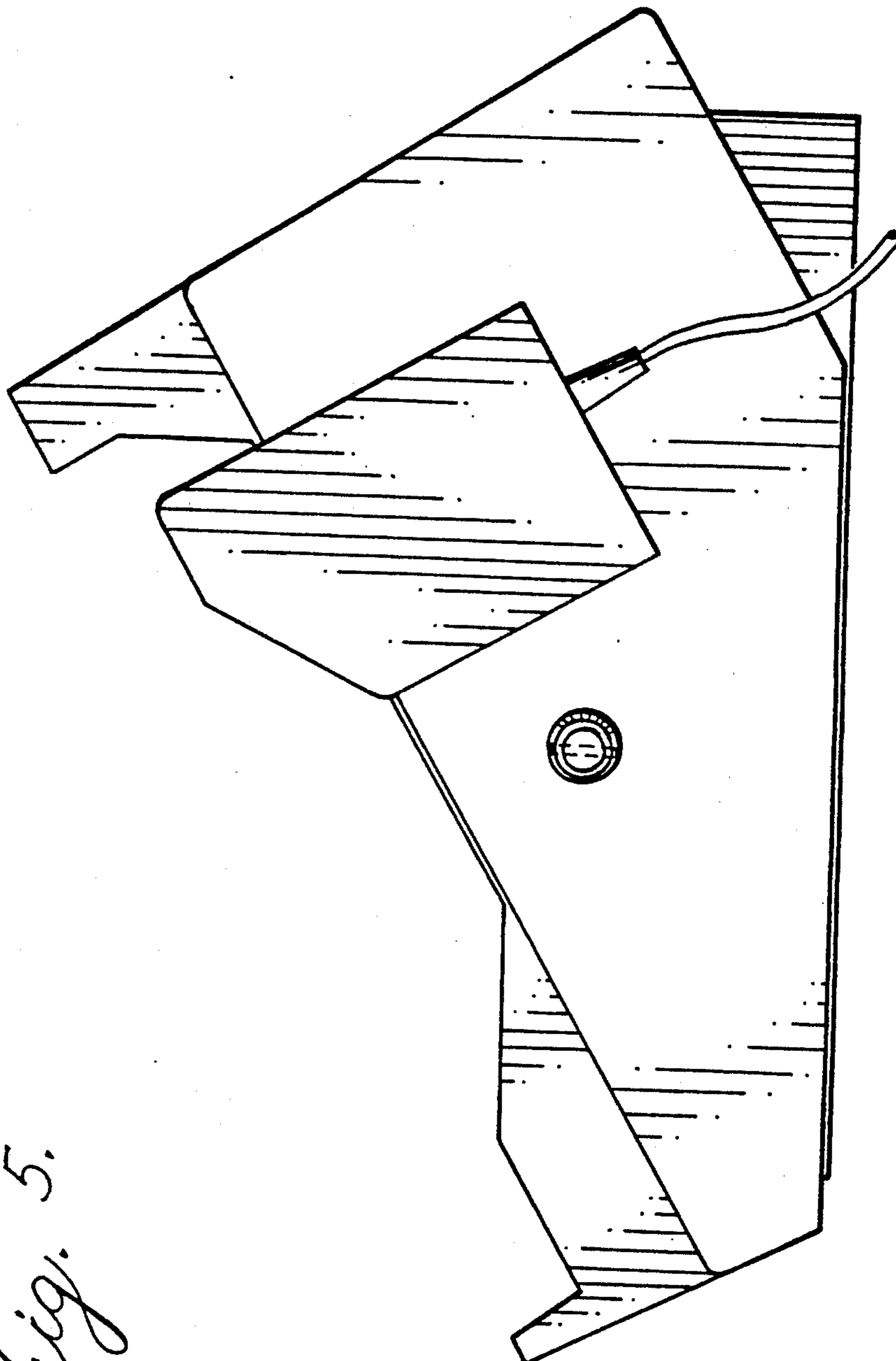

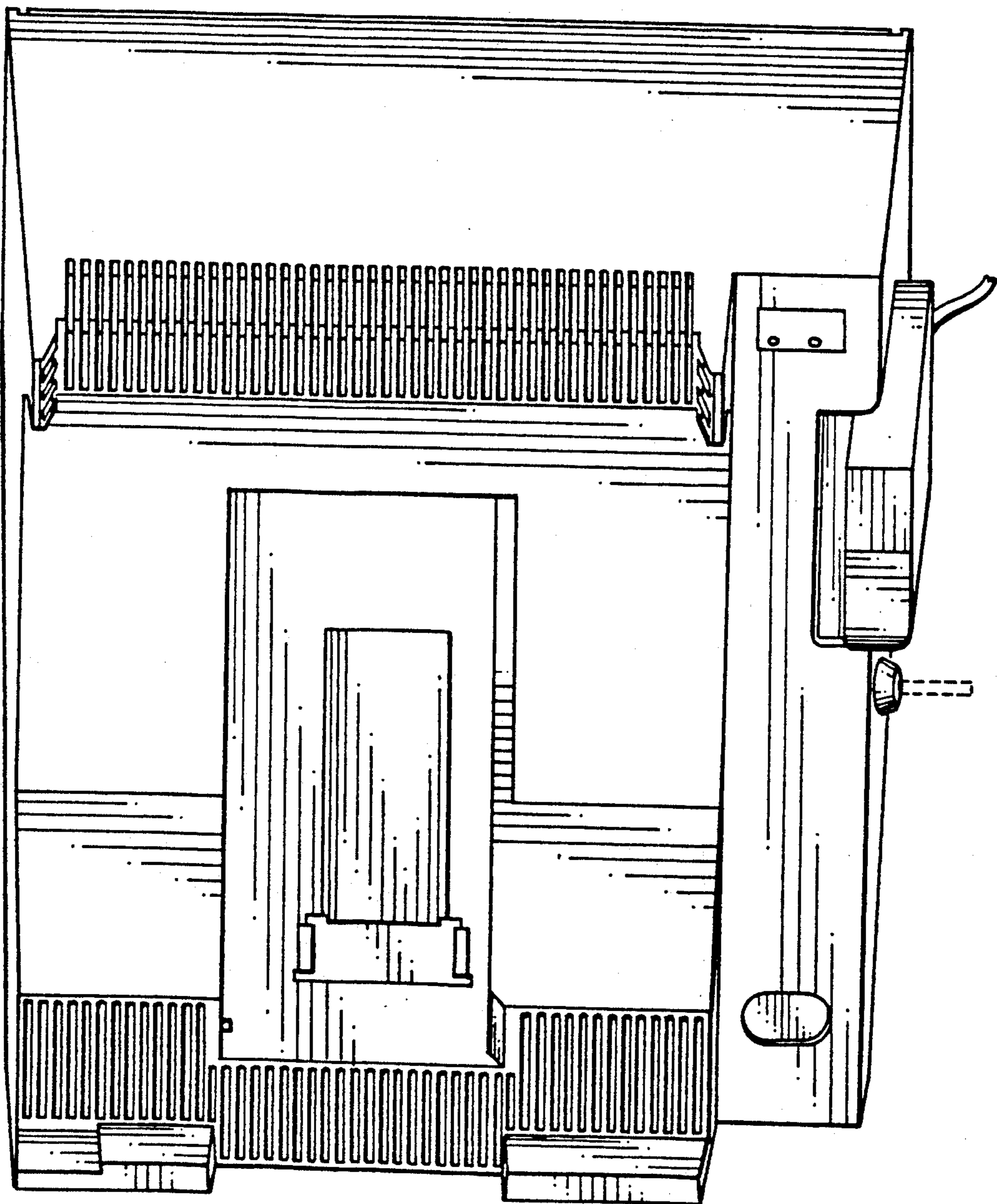

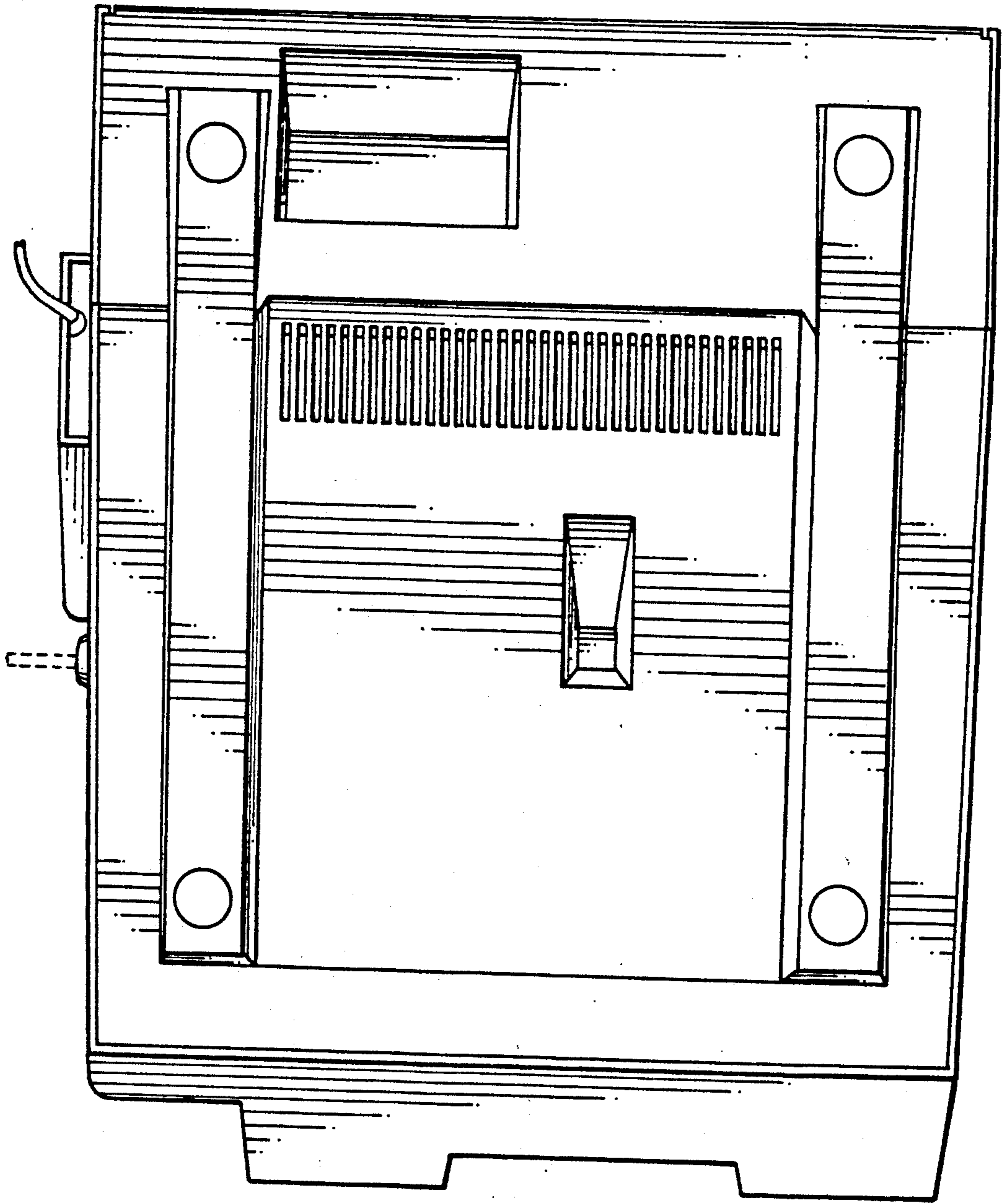
