[57] CLAIM

The ornamental design for a combined bathtub and shower stall, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view taken from the top and front of a combined bathtub and shower stall showing our new design;

FIG. 2 is another perspective view taken from the top, front and left side thereof;

FIG. 3 is a left side elevational view thereof;

FIG. 4 is a front side elevational view thereof;

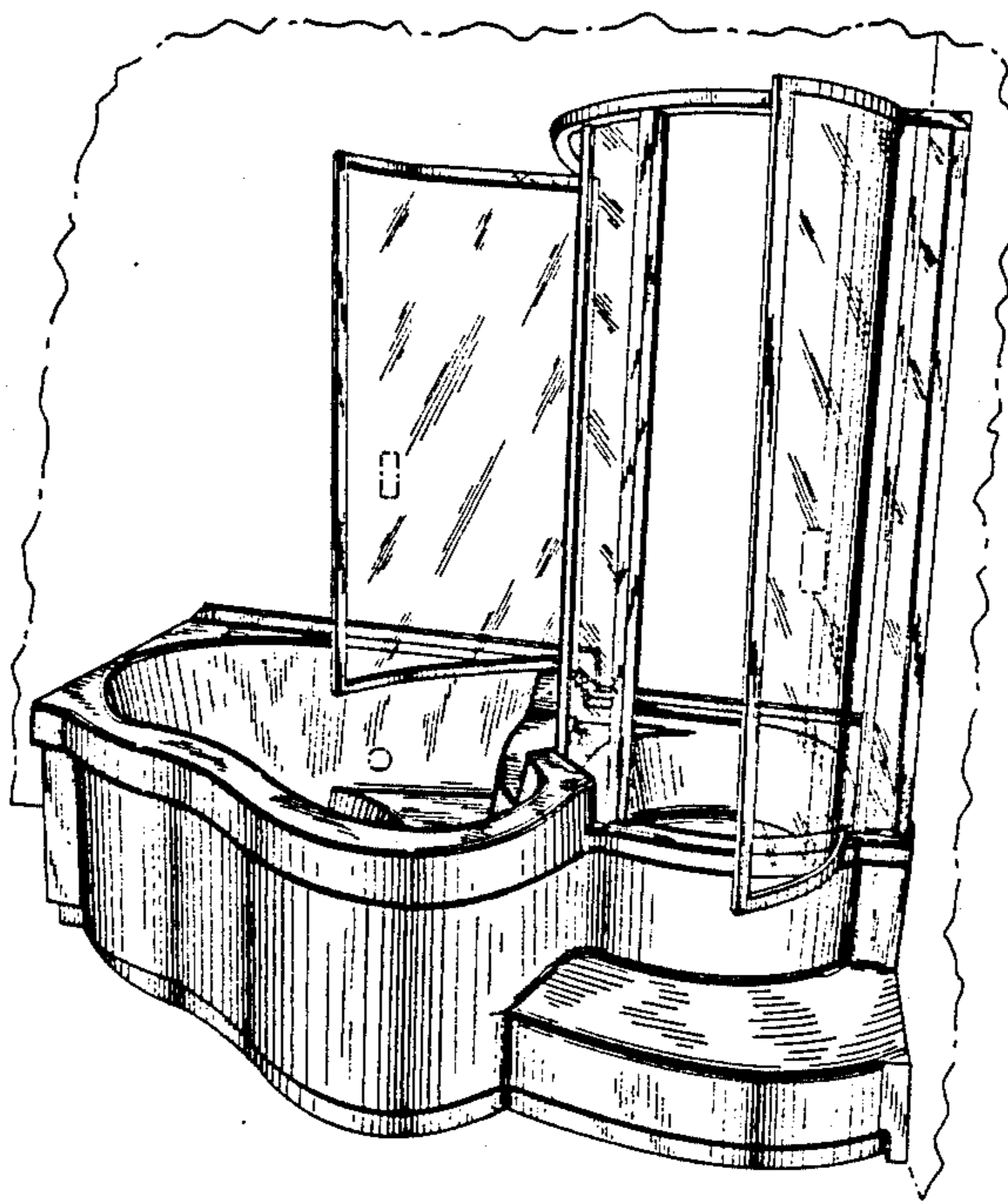
FIG. 5 is a top plan view thereof;

FIG. 6 is a cross-sectional view taken on line 6—6 of FIG. 5 with only a portion of the shower enclosure shown;

FIG. 7 is a cross-sectional view taken on line 7—7 of FIG. 5 with only a portion of the shower enclosure shown; and

FIG. 8 is a top plan view of a second embodiment thereof.

The fragmentary broken line representations of whirlpool jet wells in FIGS. 2 and 5-8, of holes in FIGS. 1, 2, and 5-8, of door handles in FIGS. 1-4, and of walls in FIGS. 1 and 2 are for the purpose of illustration only and forms no part of the claimed design.



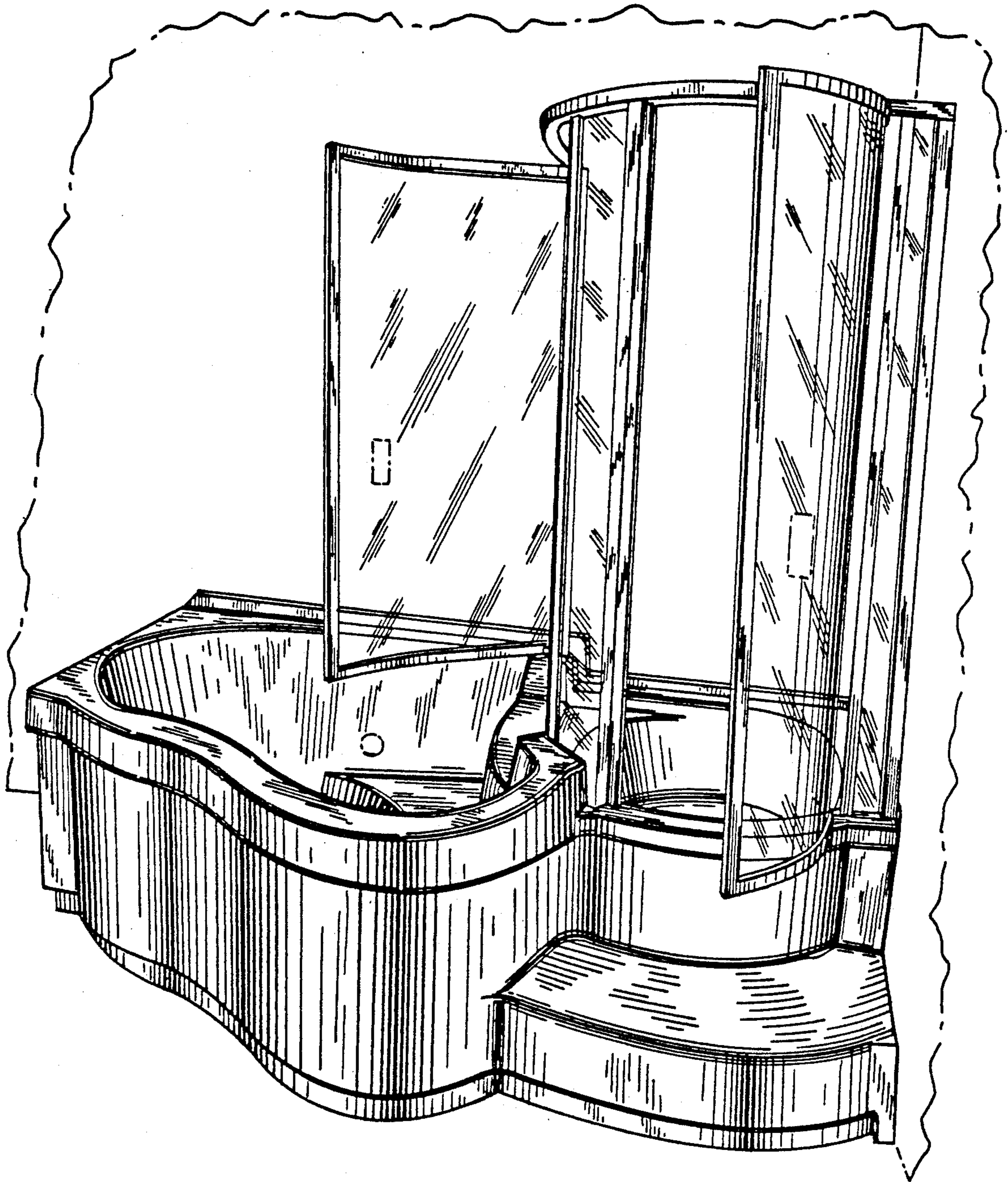

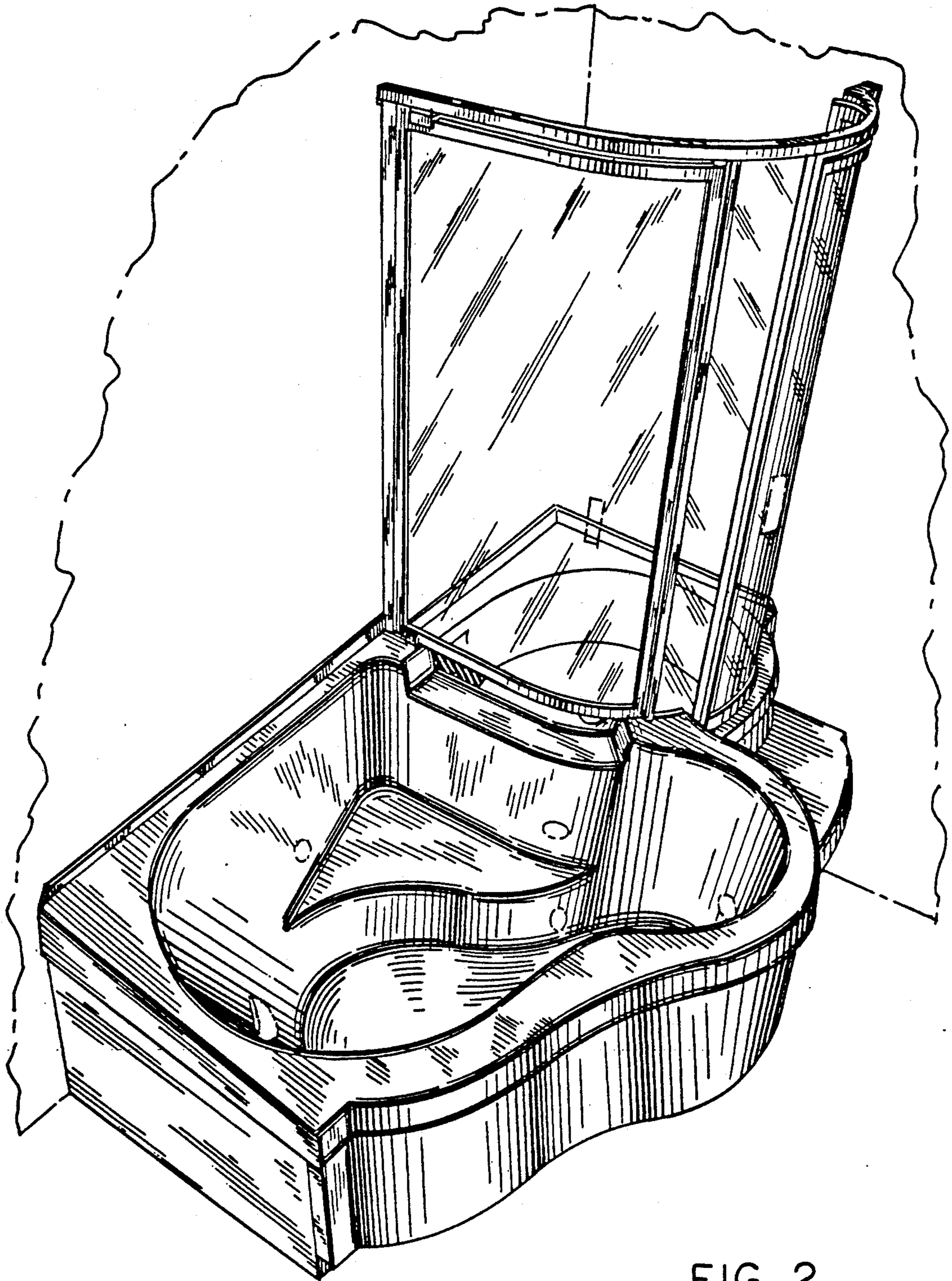

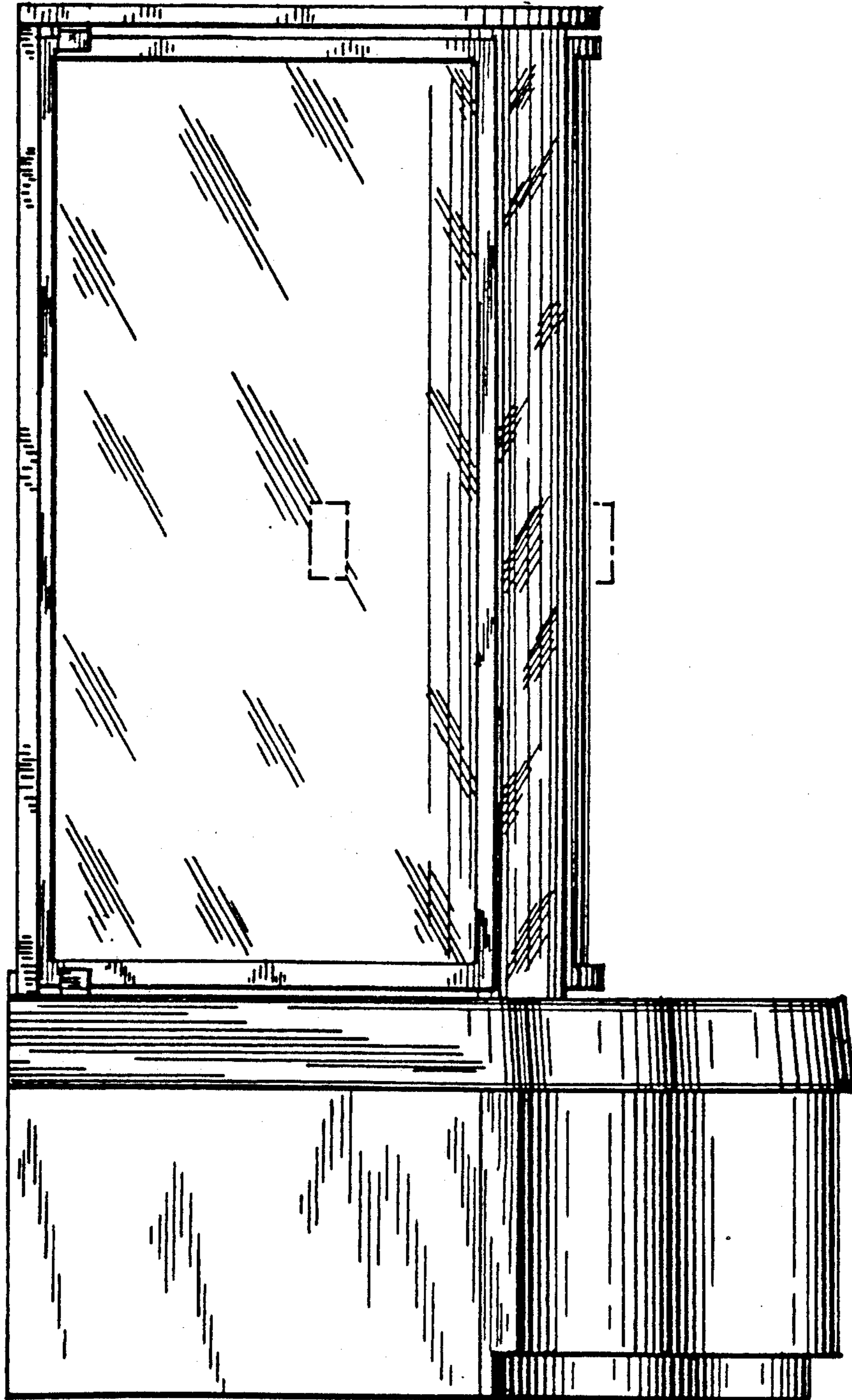
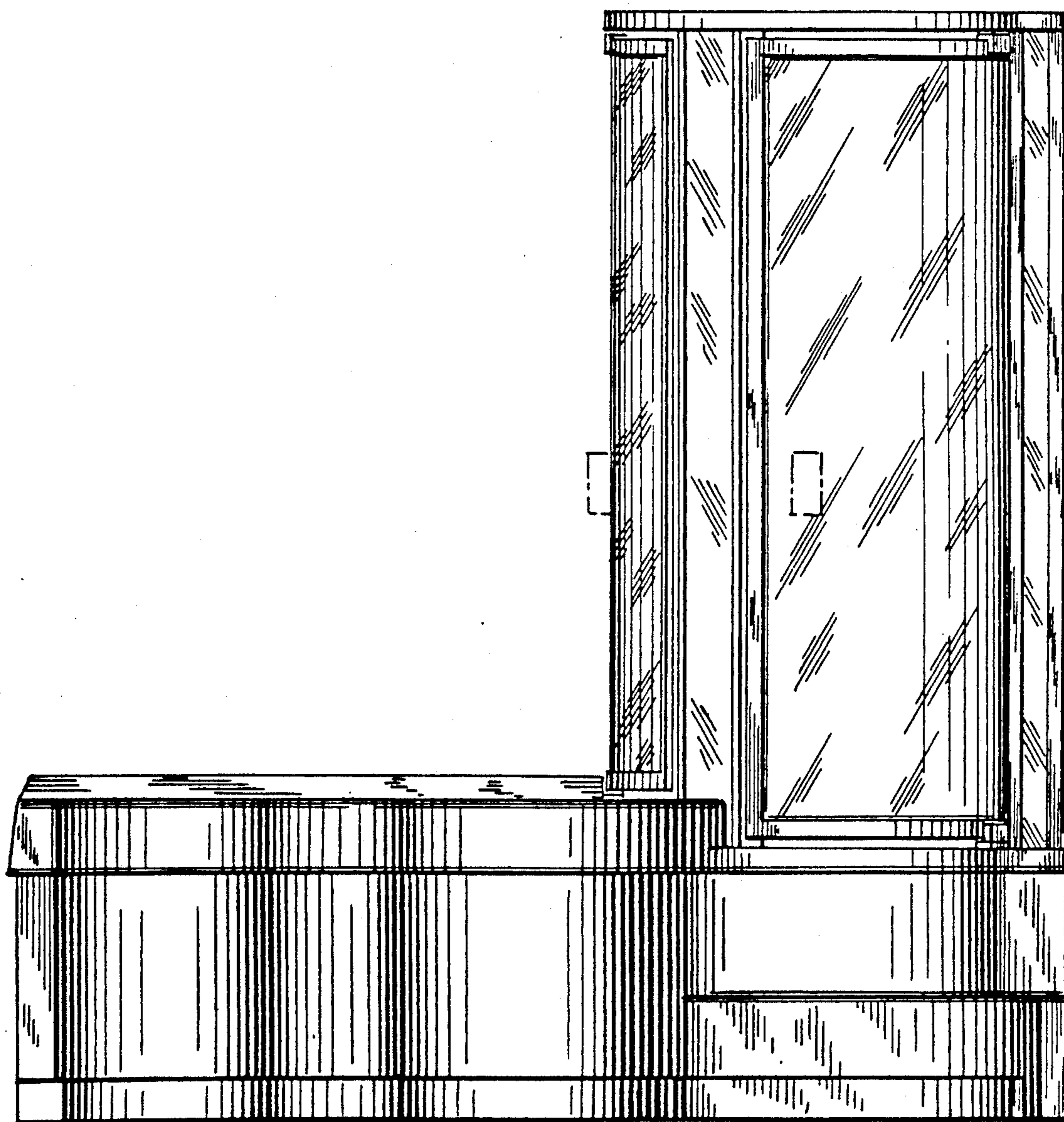
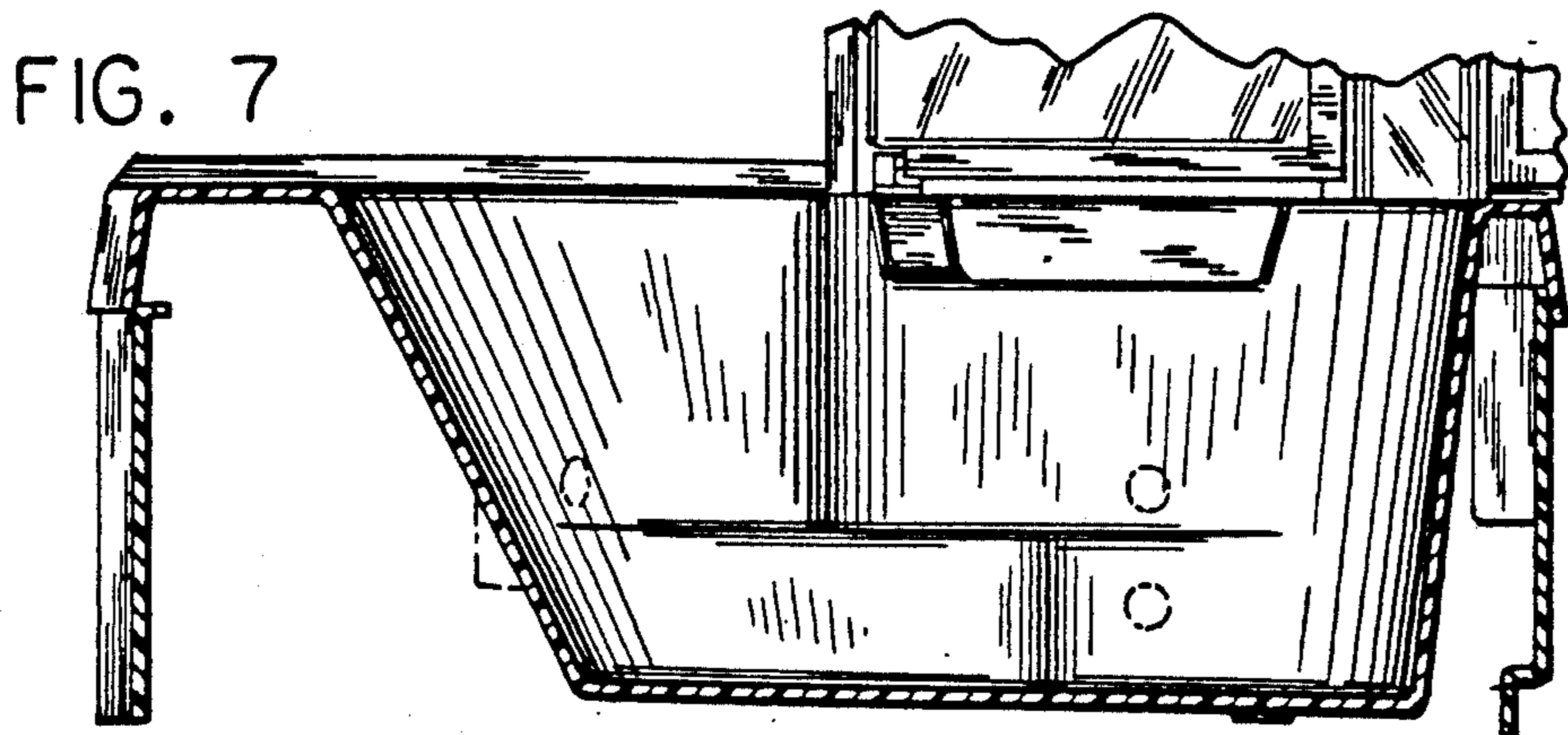
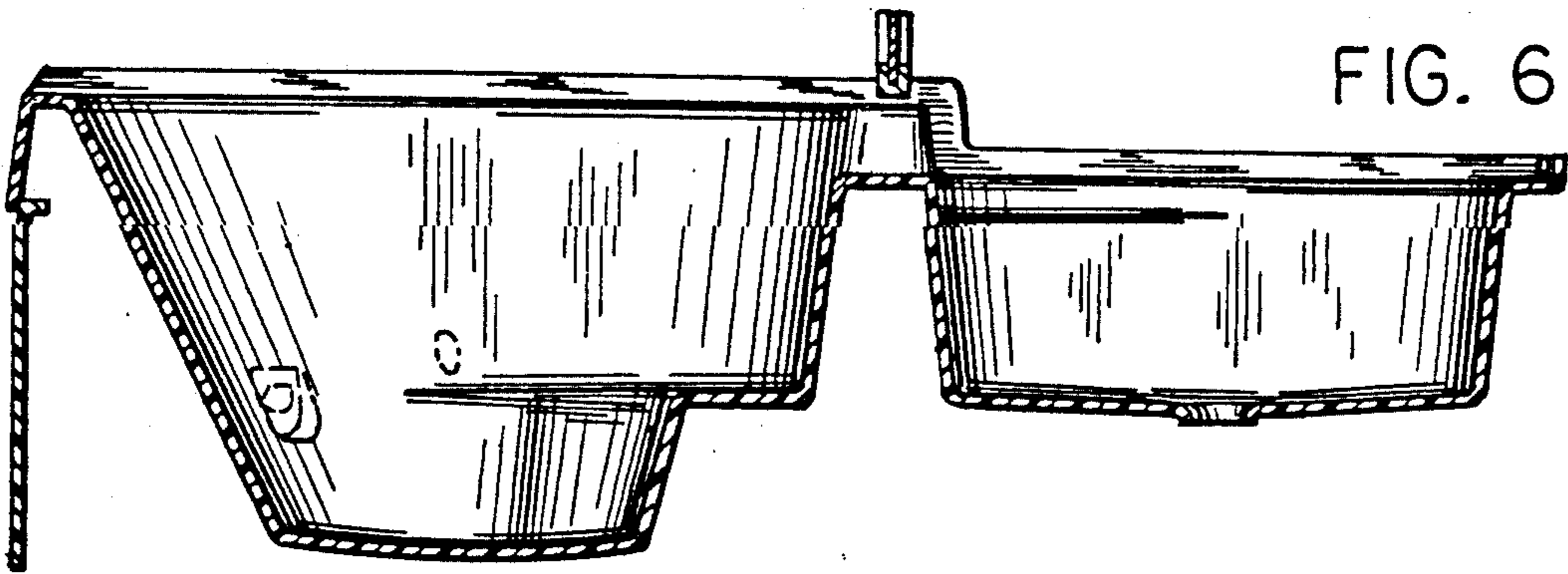
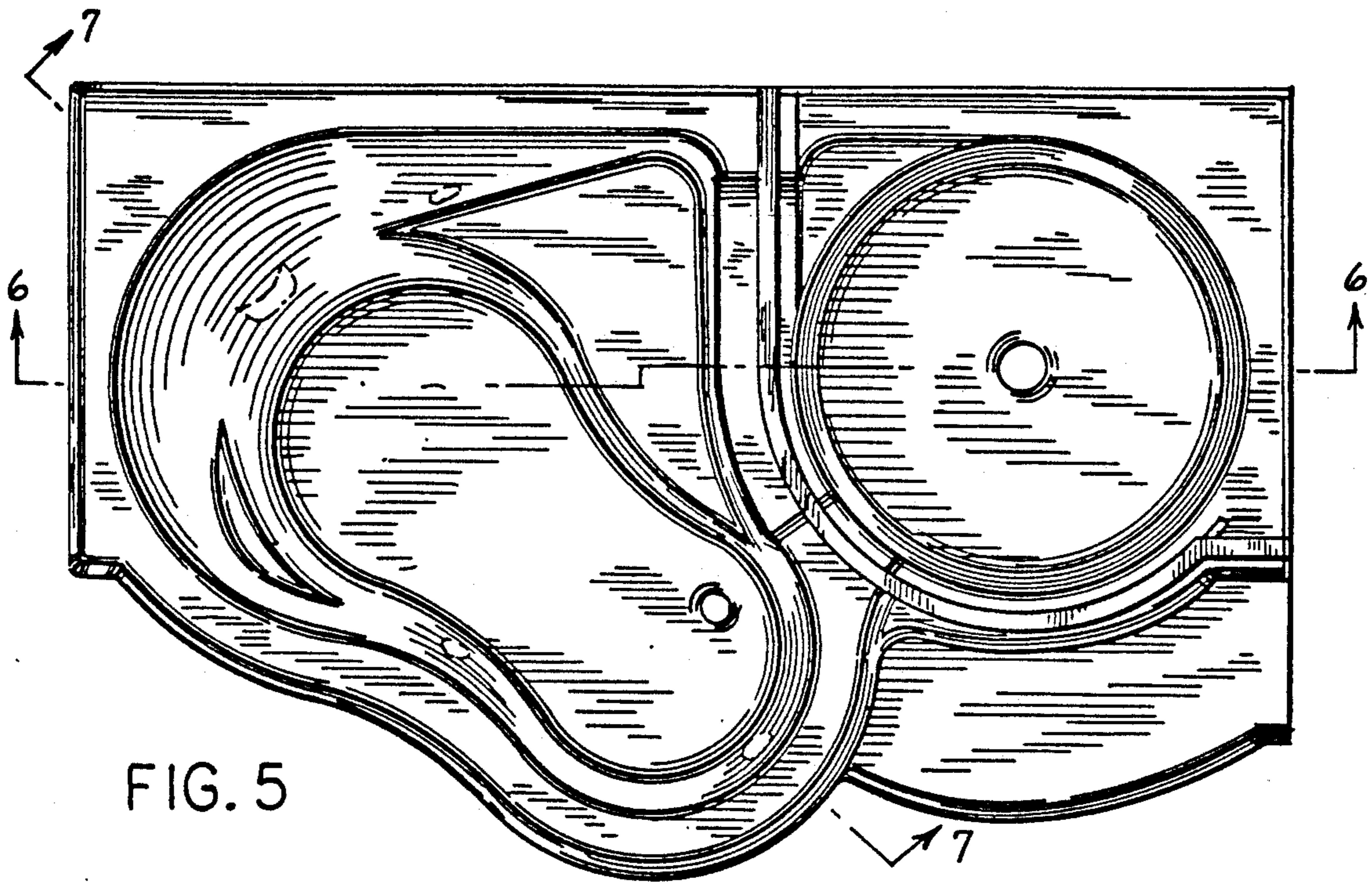

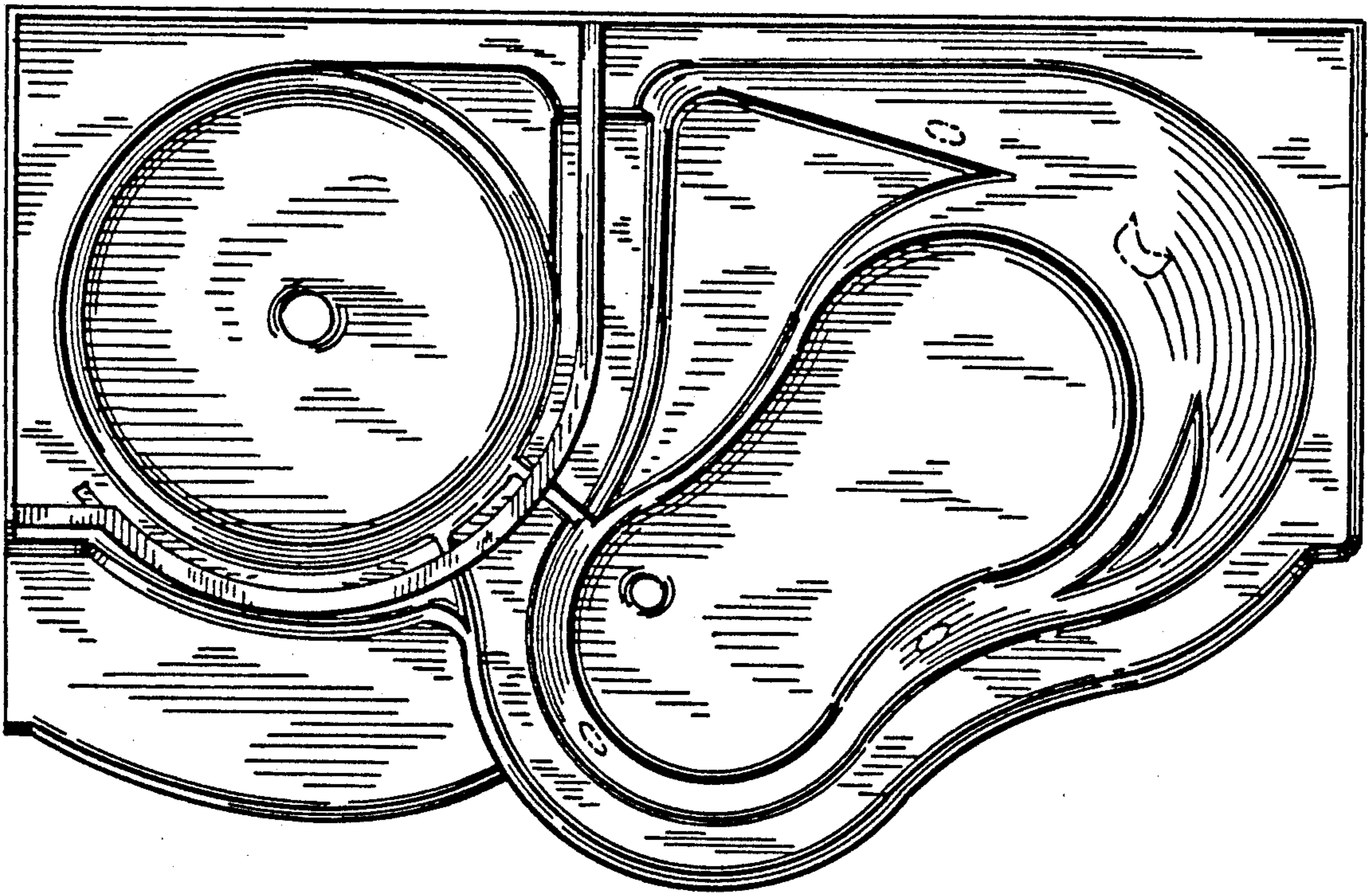
