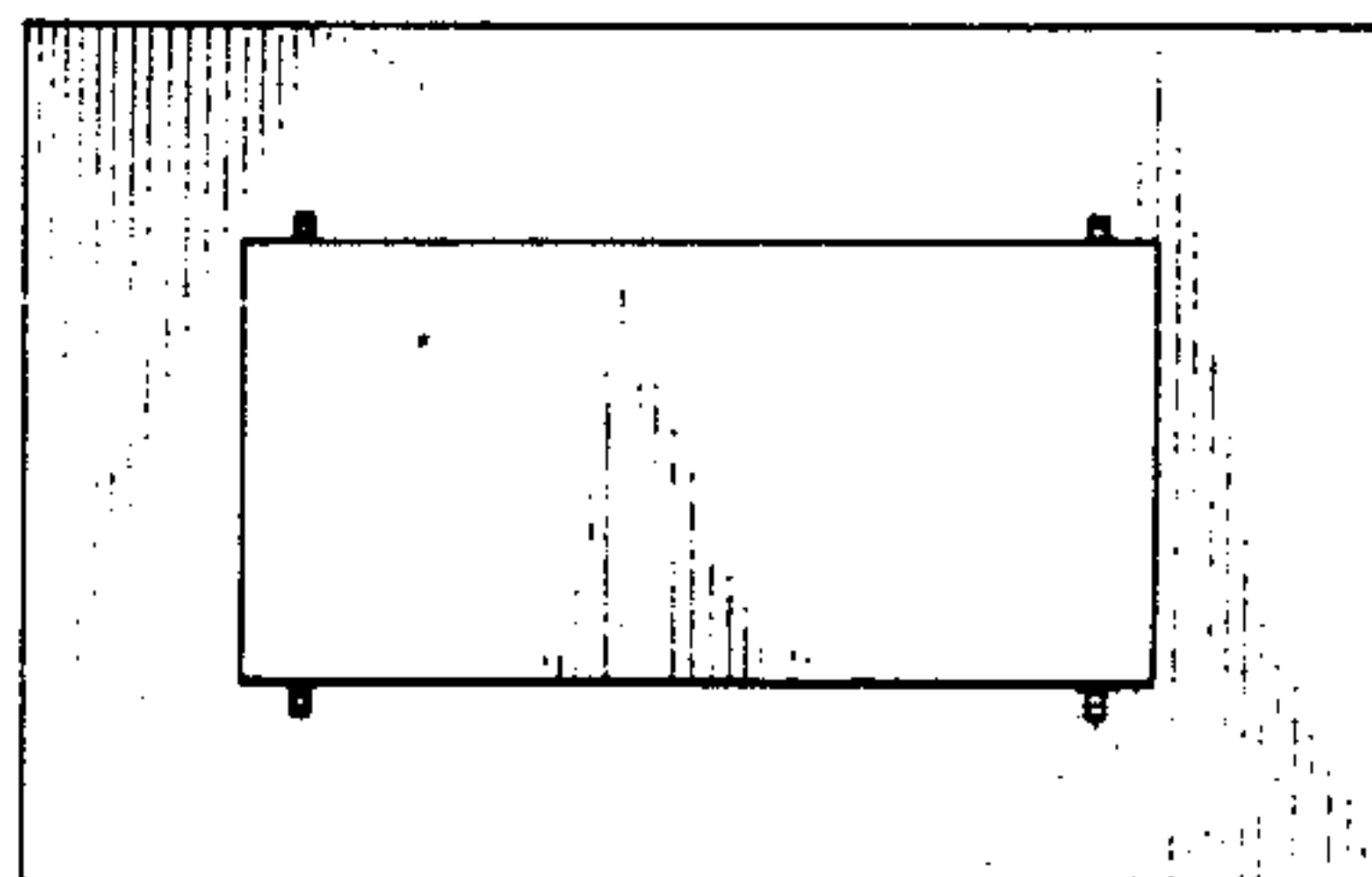
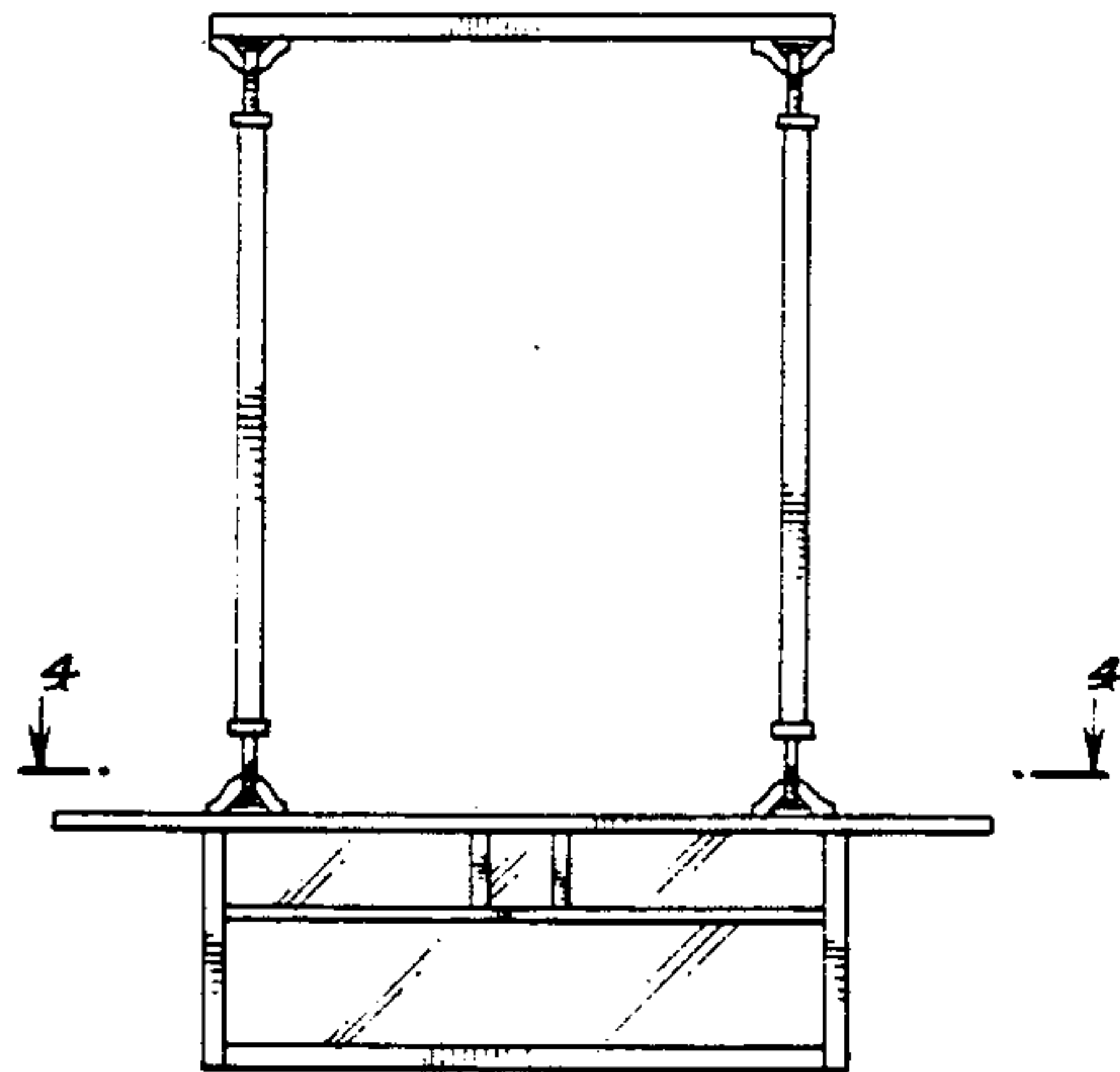

[57] CLAIM

The ornamental design for the ceiling lighting fixture, as shown and described.

DESCRIPTION

FIG. 1 is a front elevational view of a ceiling lighting fixture showing my new design, the rear being identical; FIG. 2 is a top plan view thereof; FIG. 3 is a side elevational view thereof, the opposite side being identical; FIG. 4 is a sectional view taken along the line 4—4 of FIG. 1, with the suspension hooks omitted; FIG. 5 is a bottom plan view thereof; and FIG. 6 is a front elevational view of a second embodiment of my new design, the rear being identical; FIG. 7 is a side elevational view of the second embodiment, the opposite side being identical; FIG. 8 is a sectional view taken along the line 8—8 of FIG. 6, with the suspension hooks omitted. The top and bottom view of the second embodiment are identical to those of the first embodiment as shown in FIGS. 2 and 5.



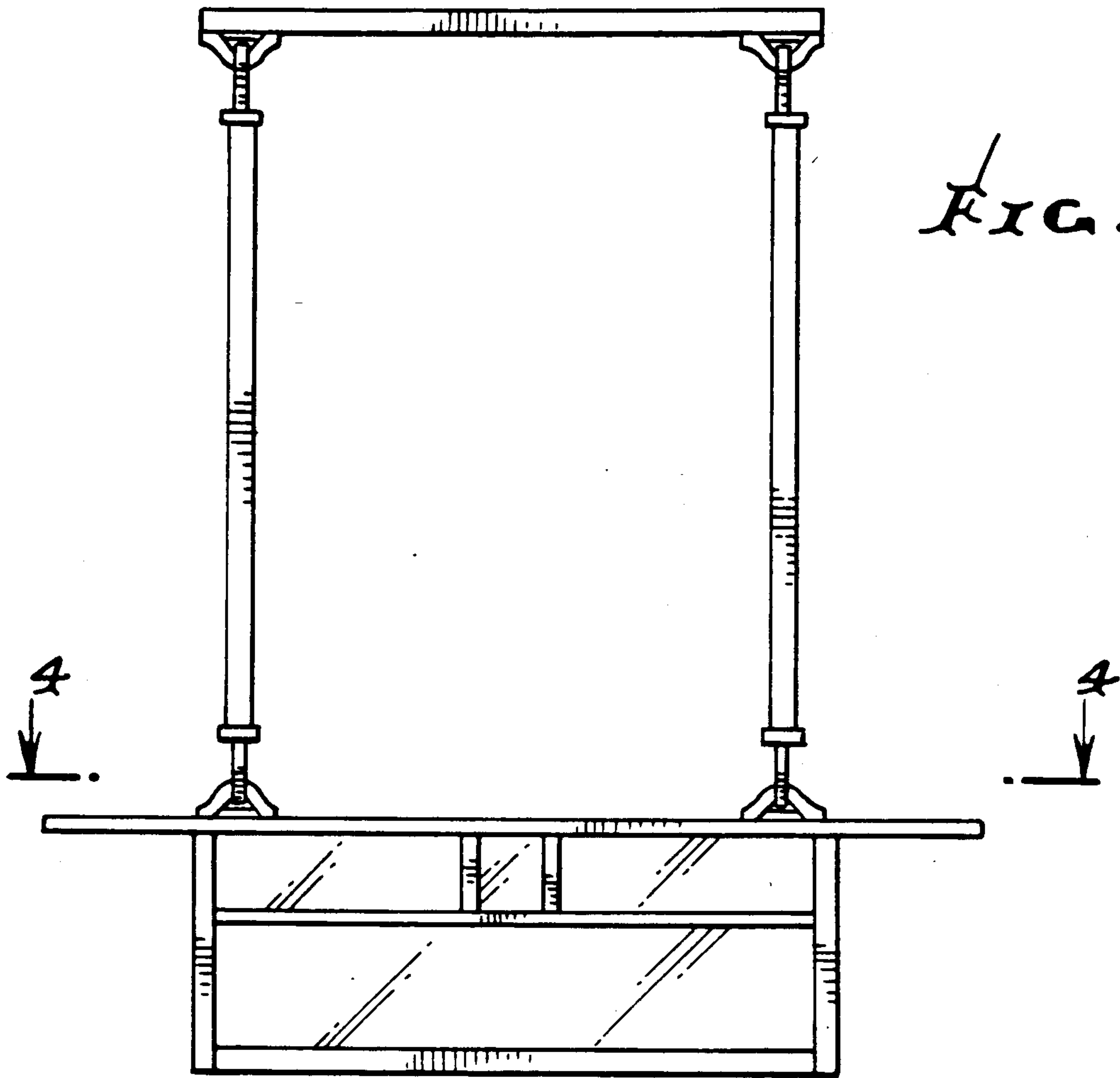
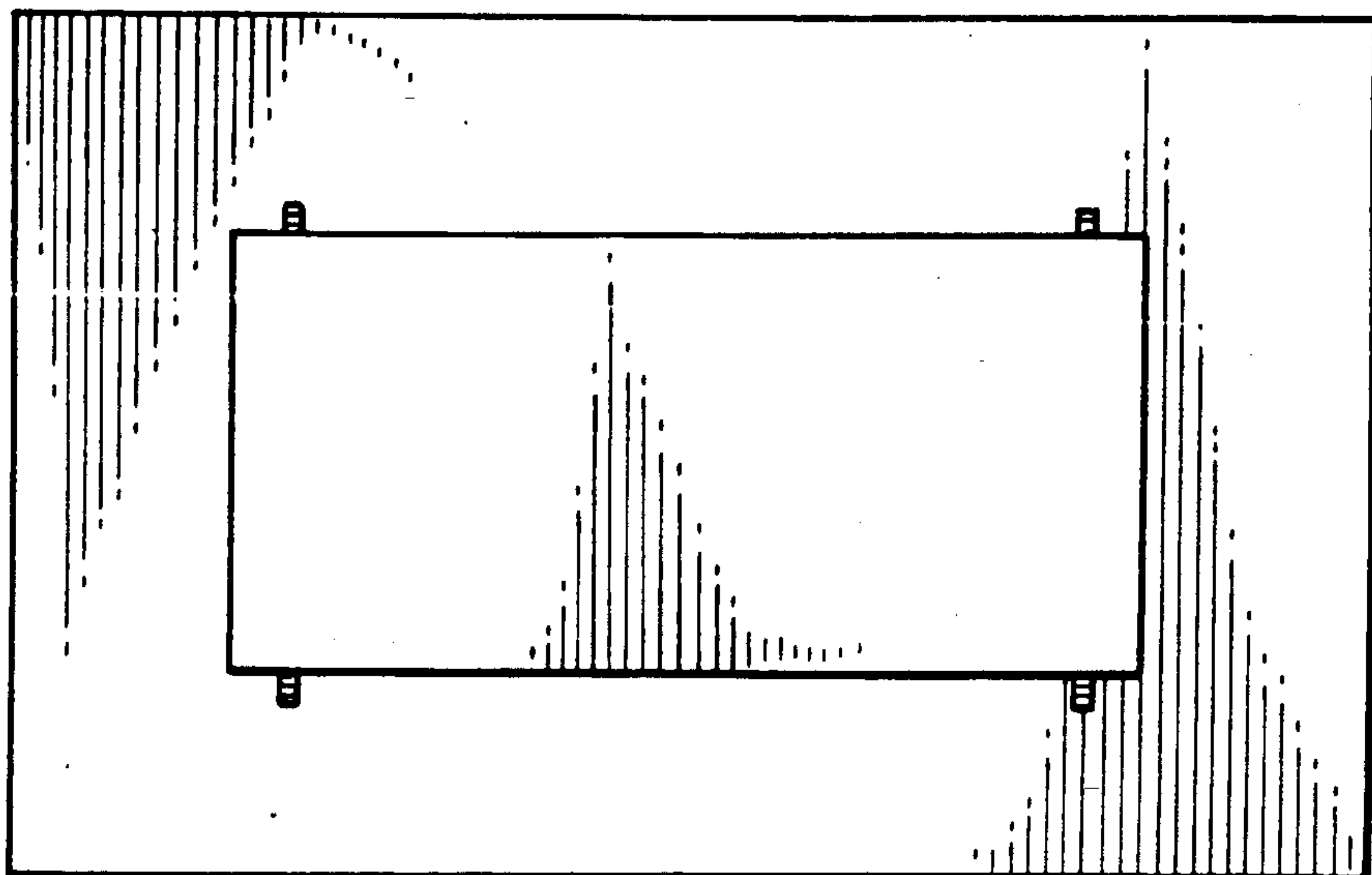

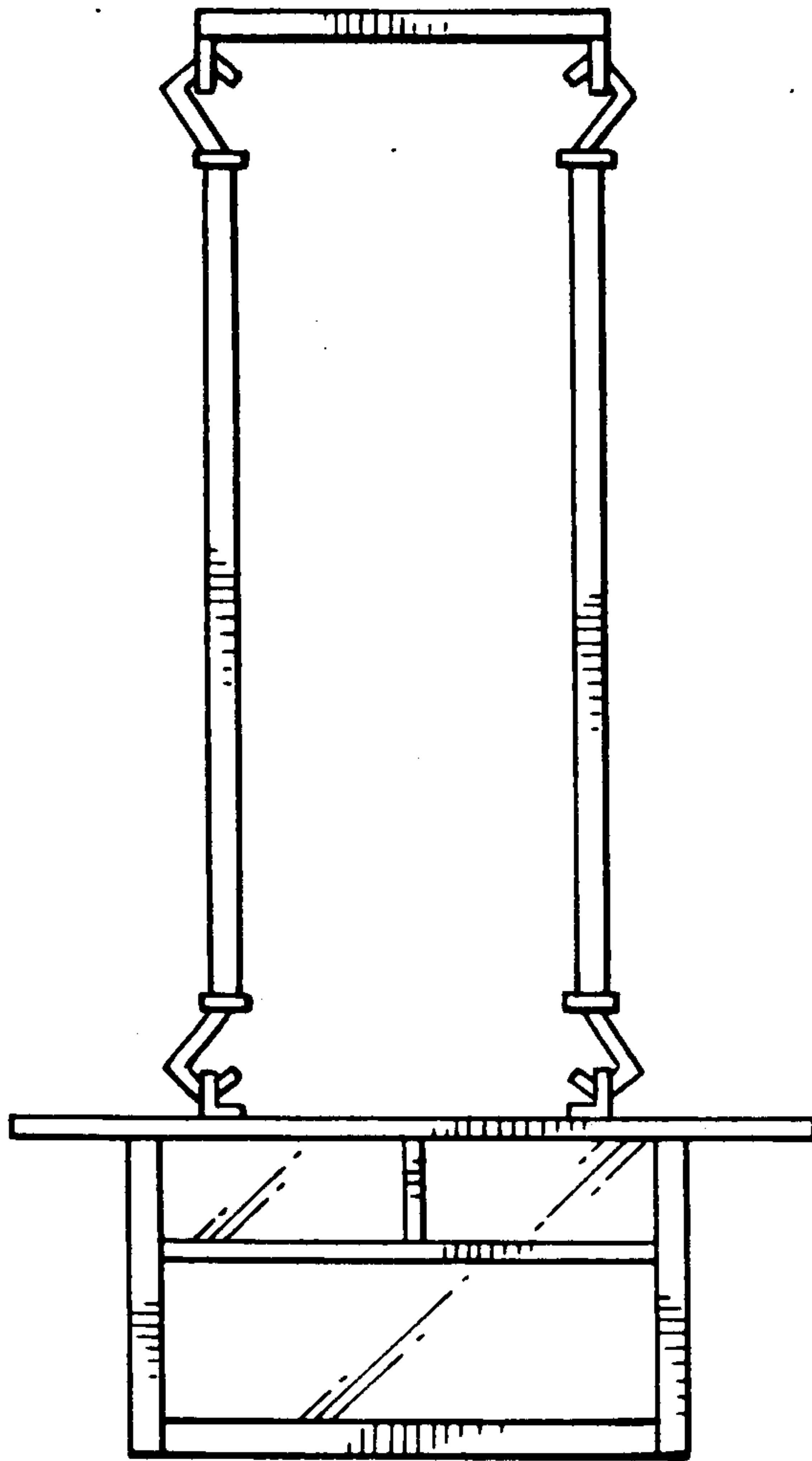
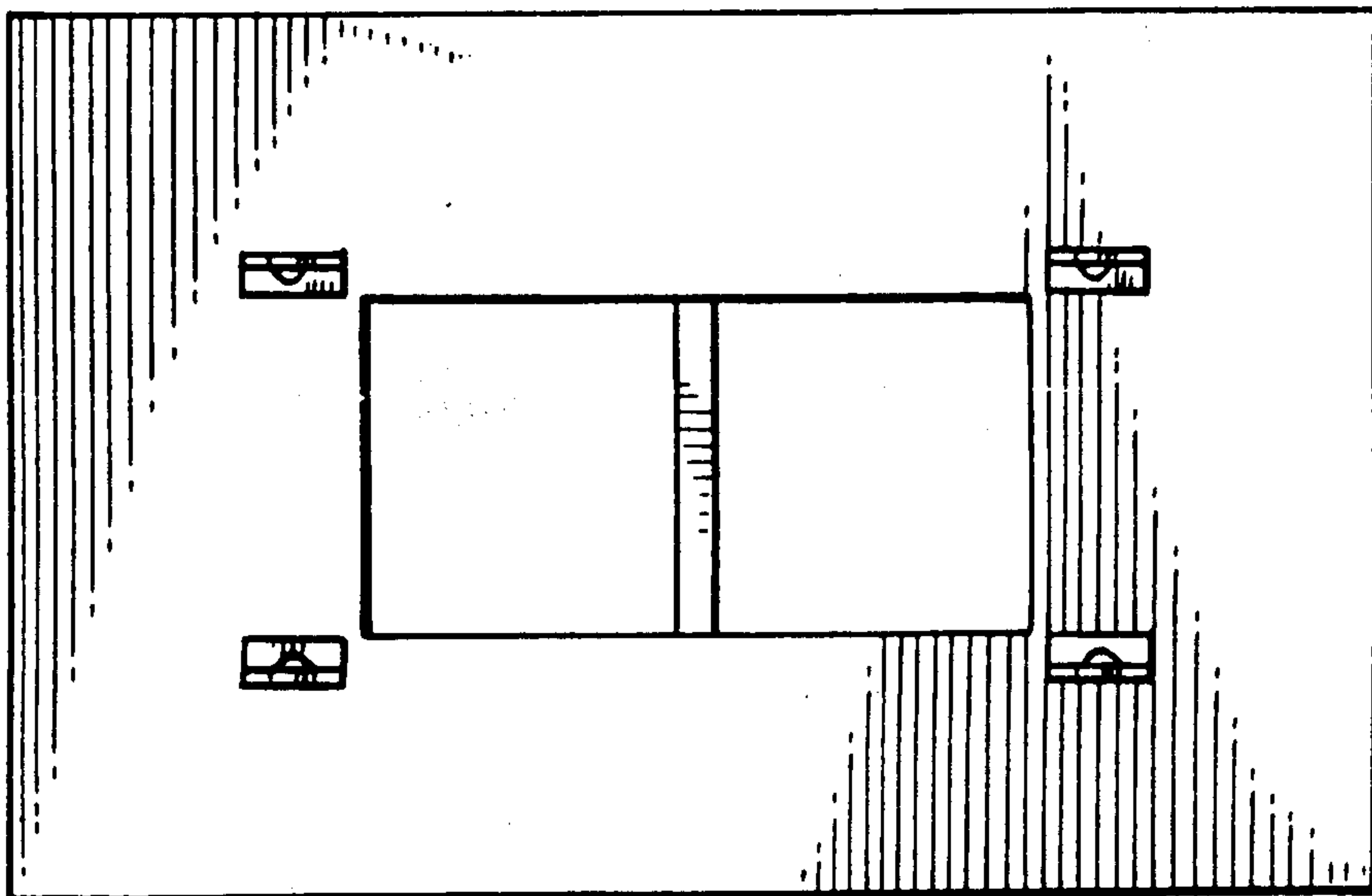

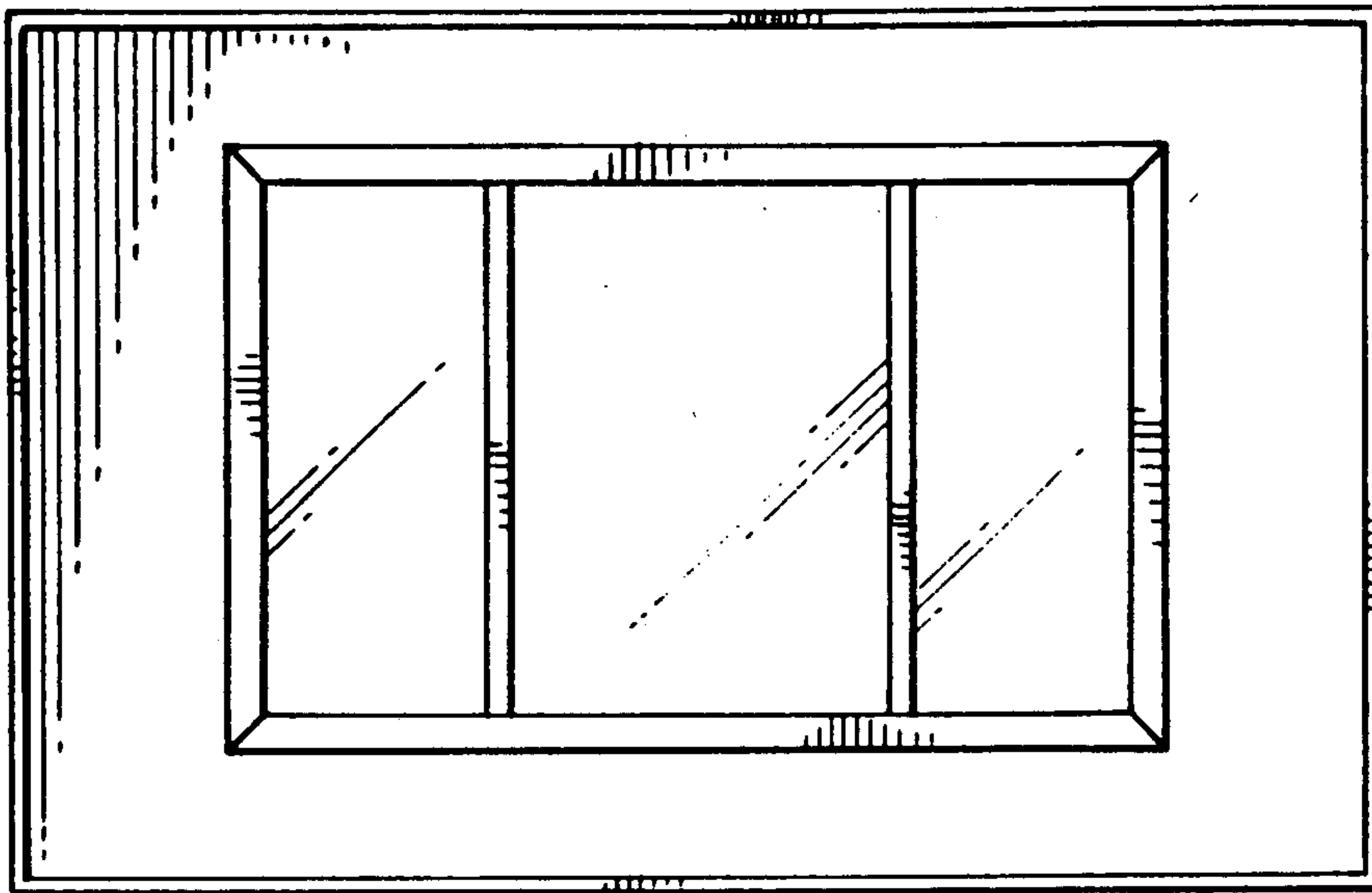

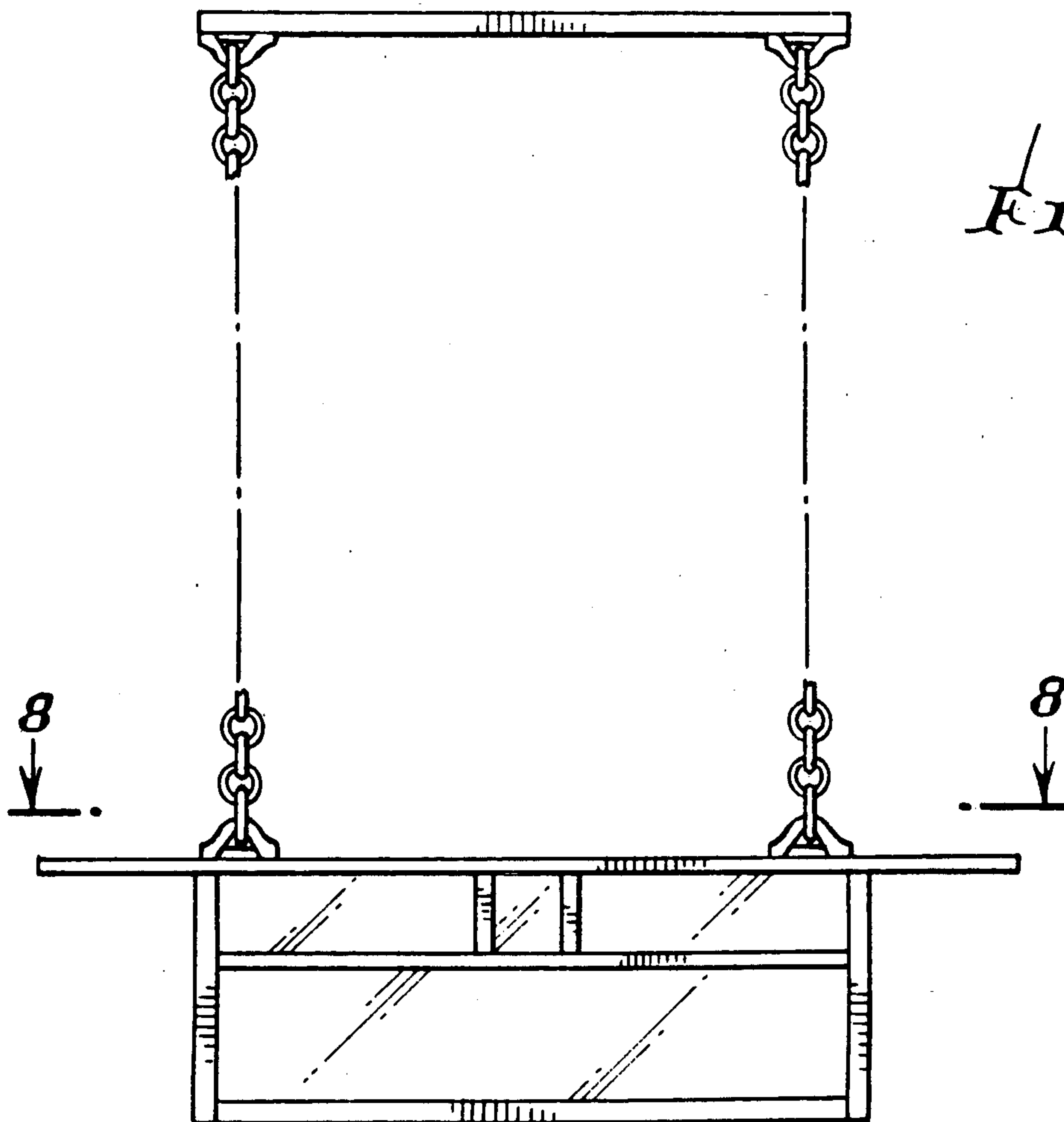

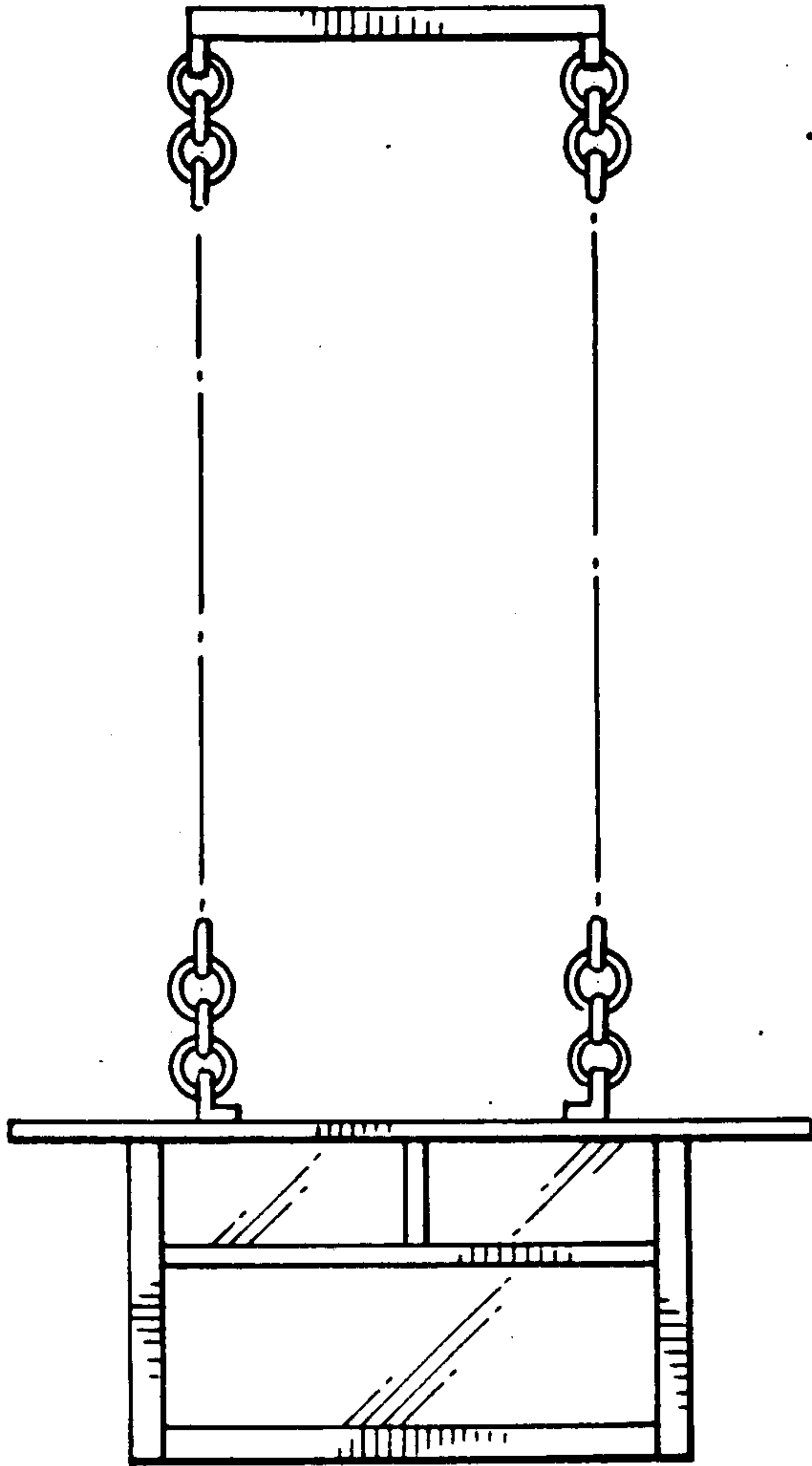
