The ornamental design for a portable blower, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a portable blower showing our new design;

FIG. 2 is a side elevational view thereof;

FIG. 3 is a top plan view thereof;

FIG. 5 is a front elevational view thereof;

FIG. 6 is a rear elevational view thereof;

FIG. 18 is a rear elevational view.

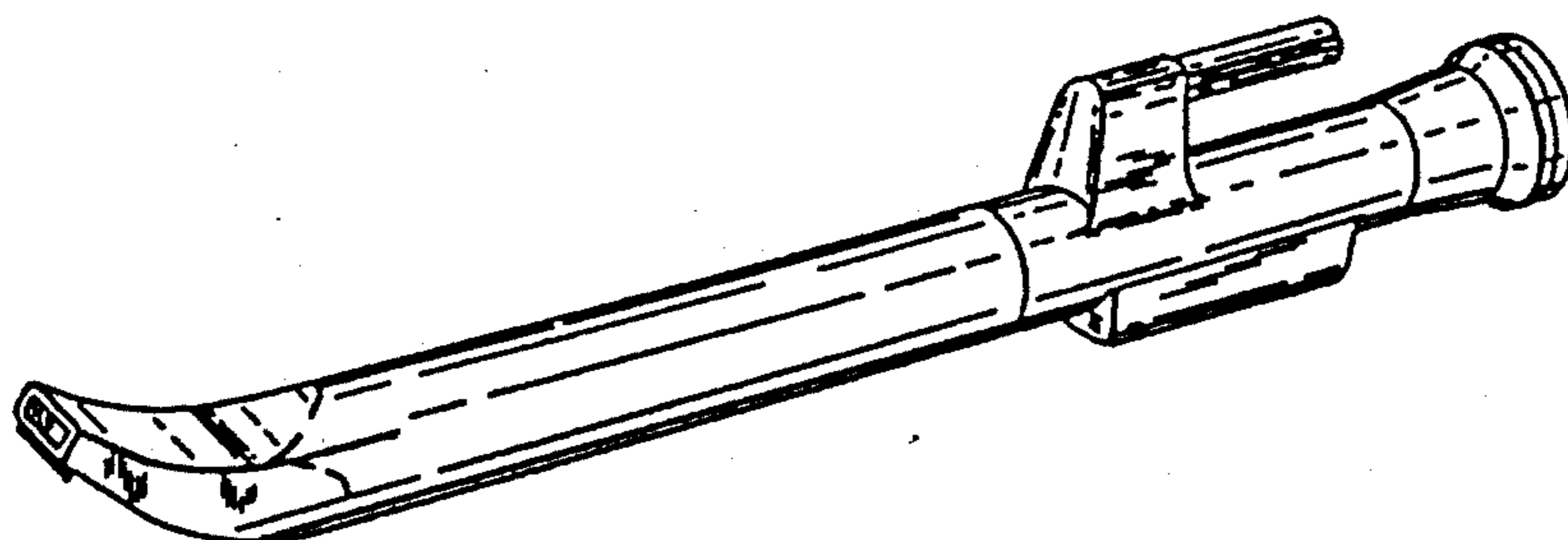

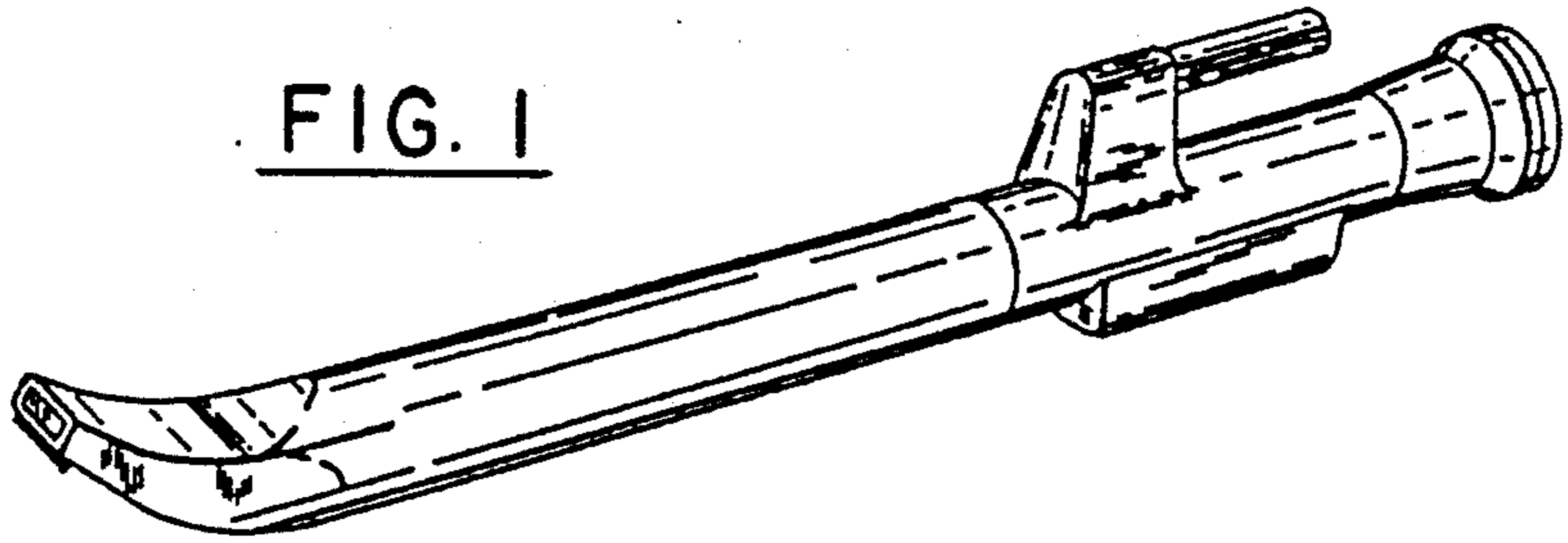

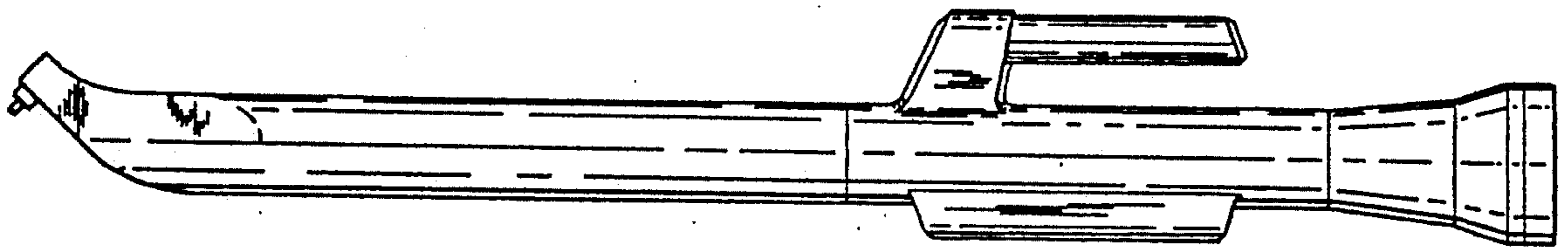

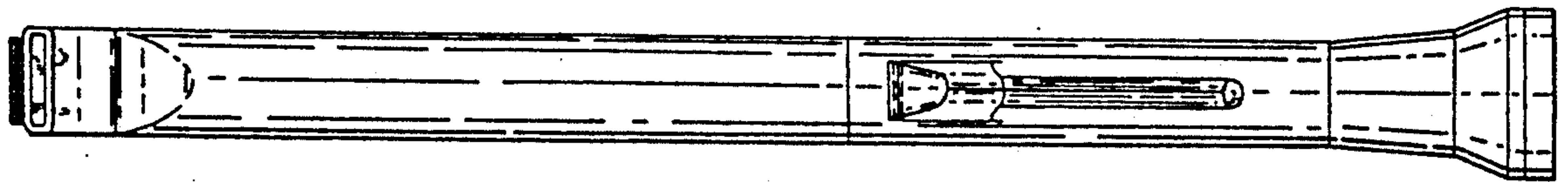

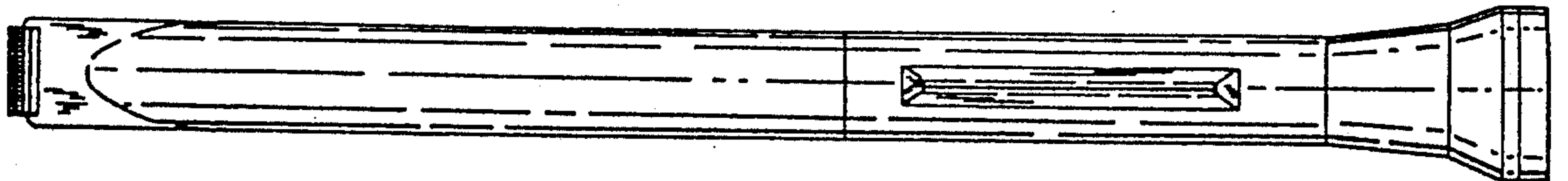

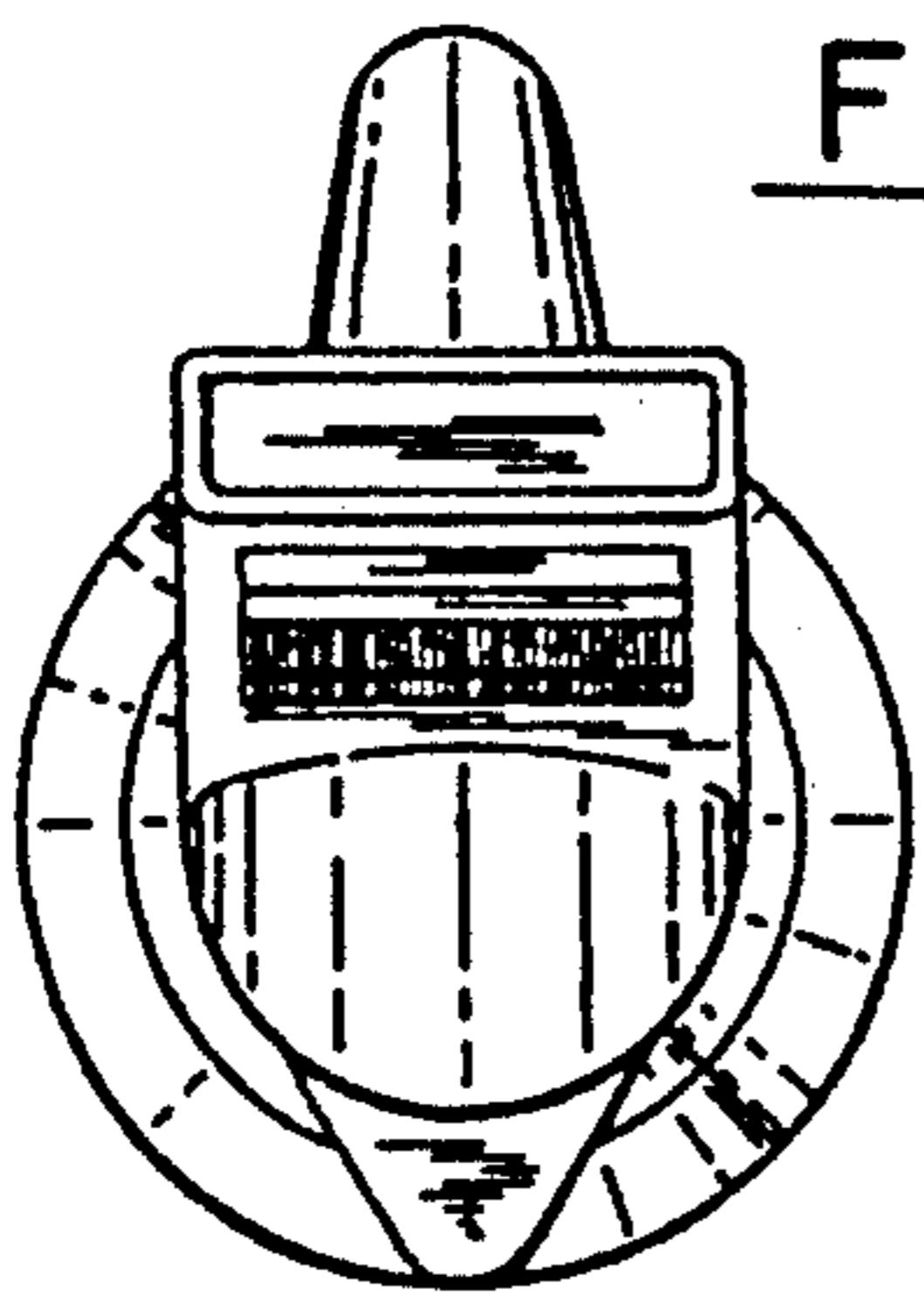

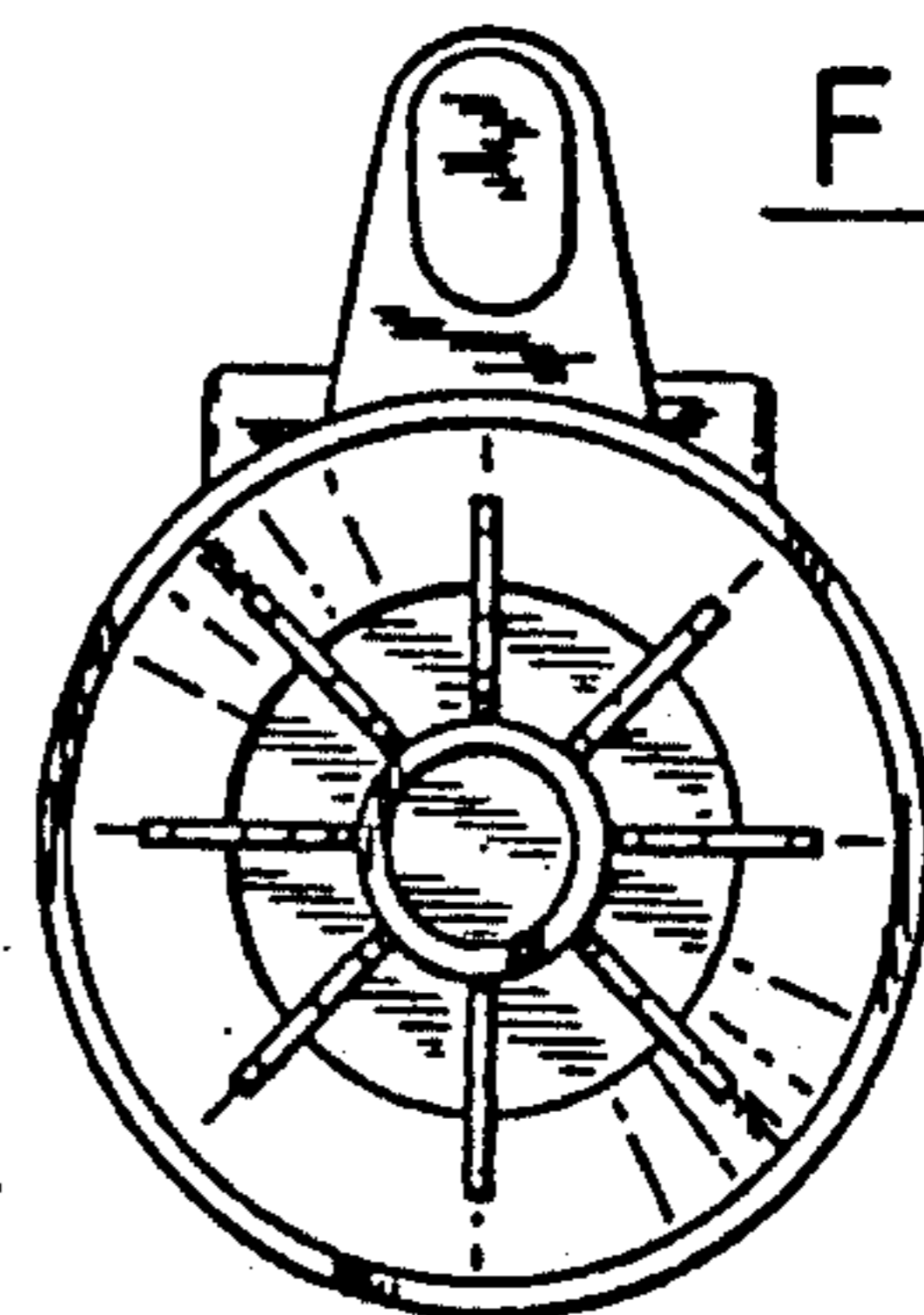

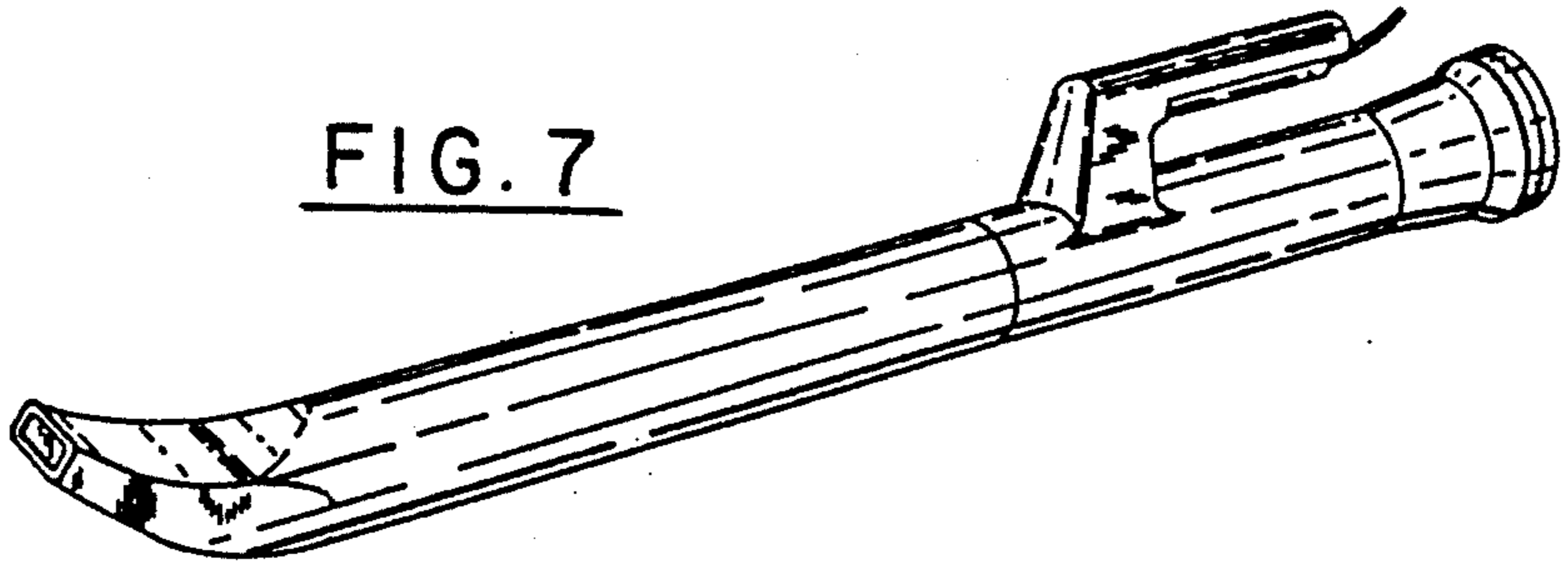

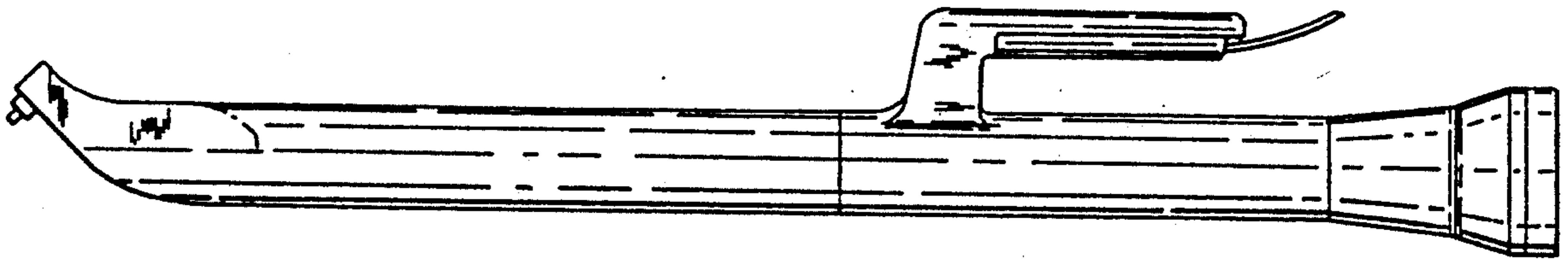

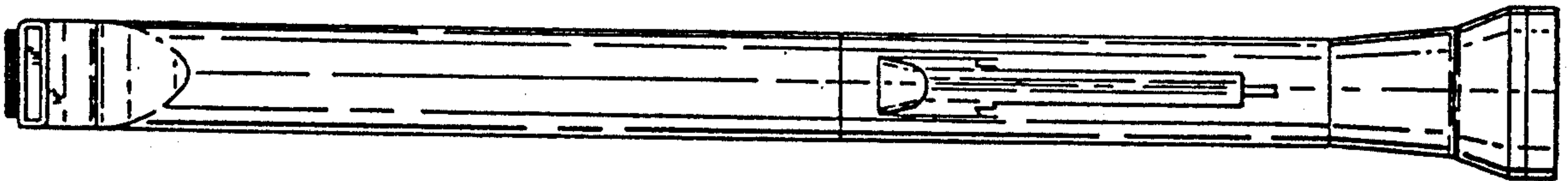

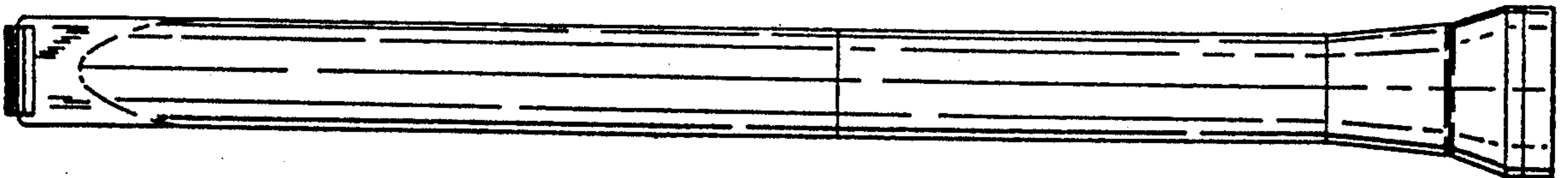

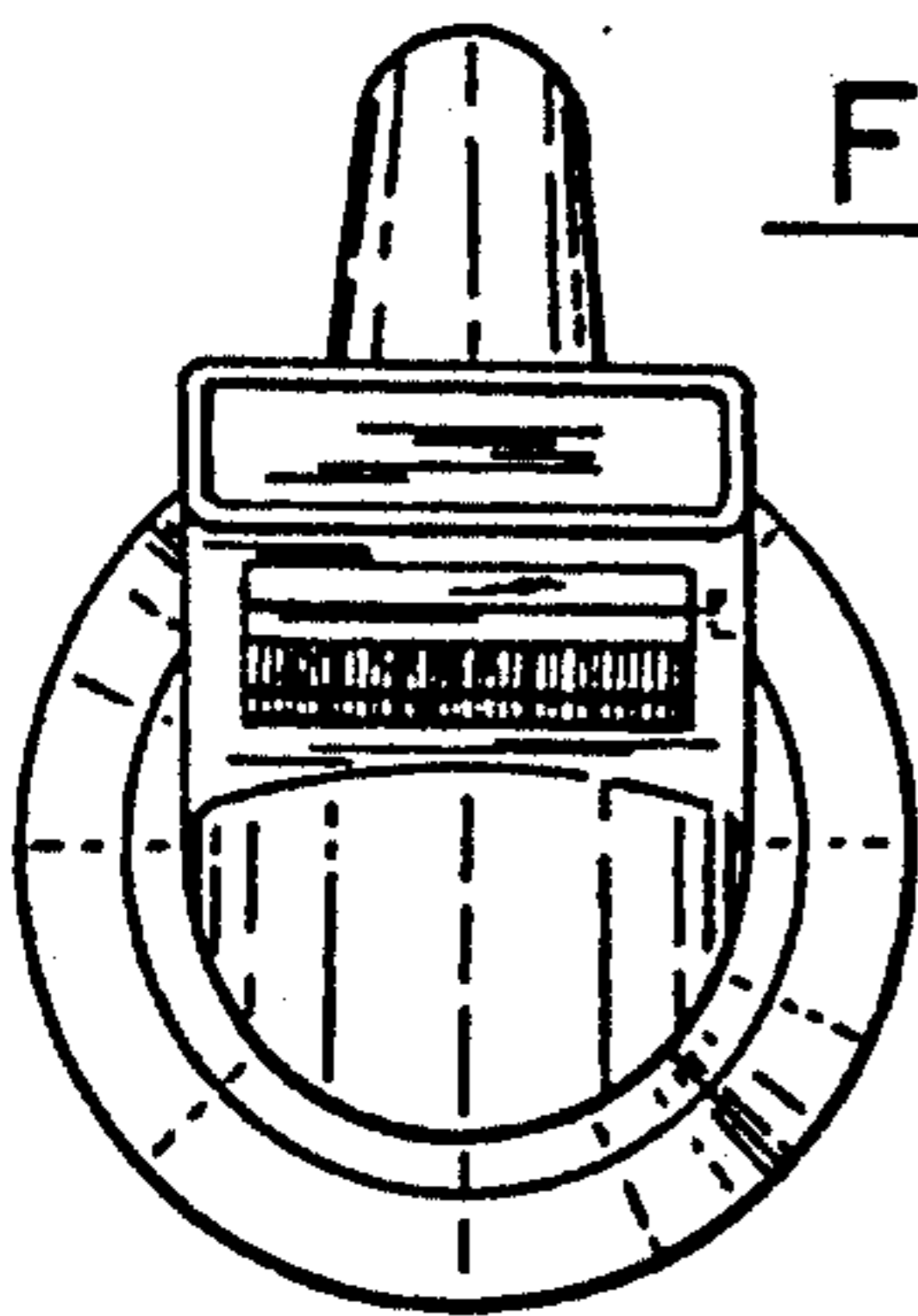
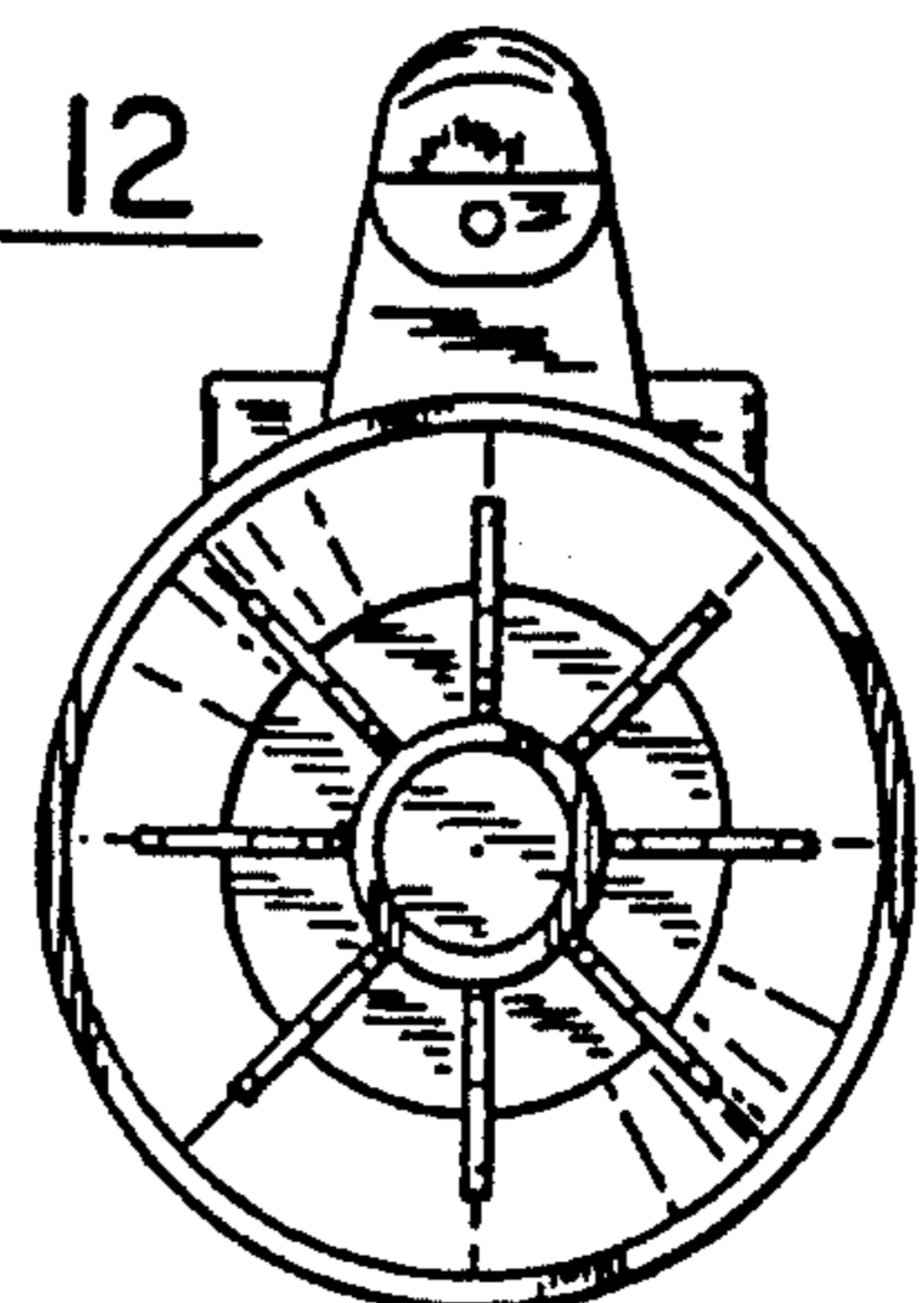

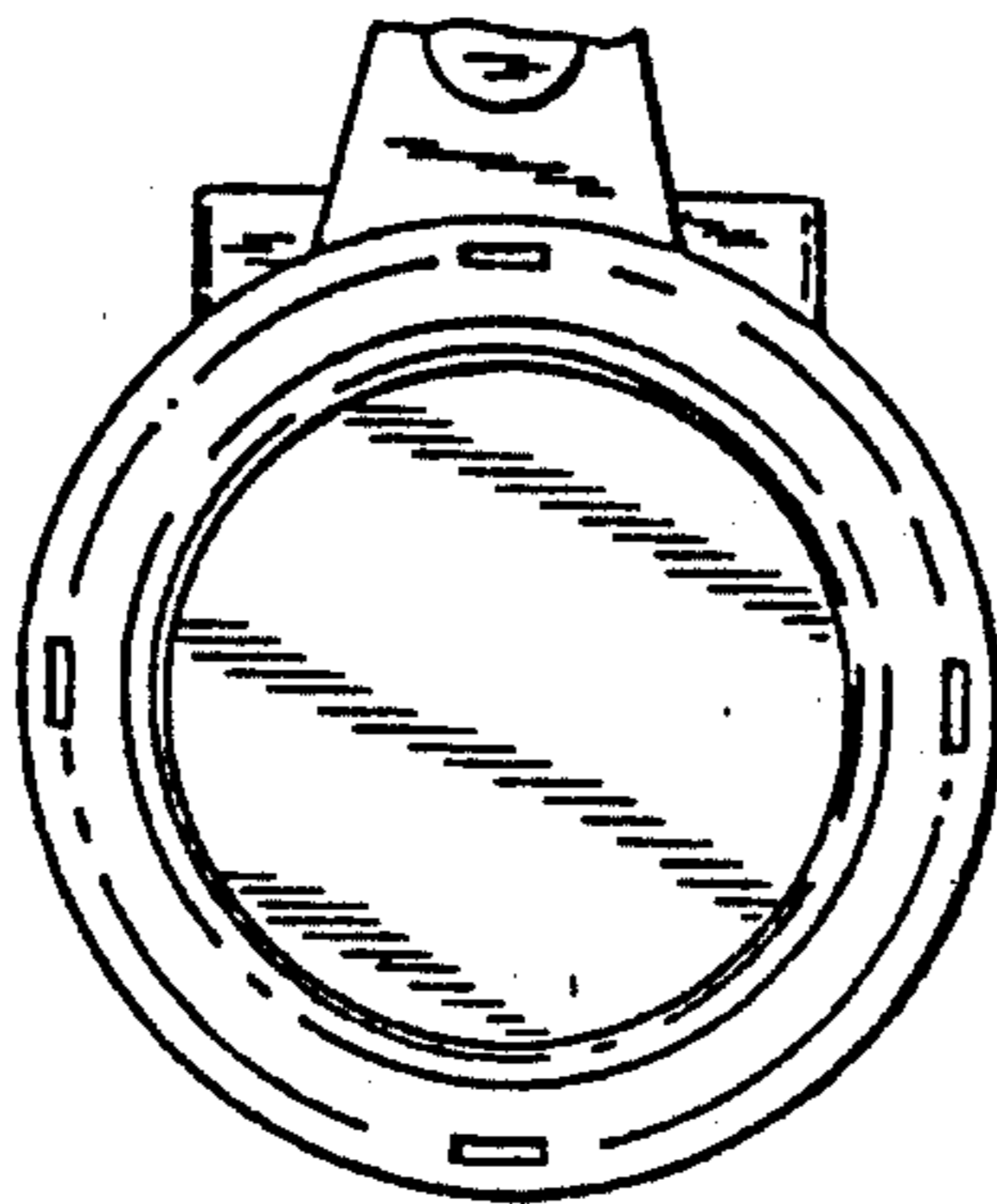

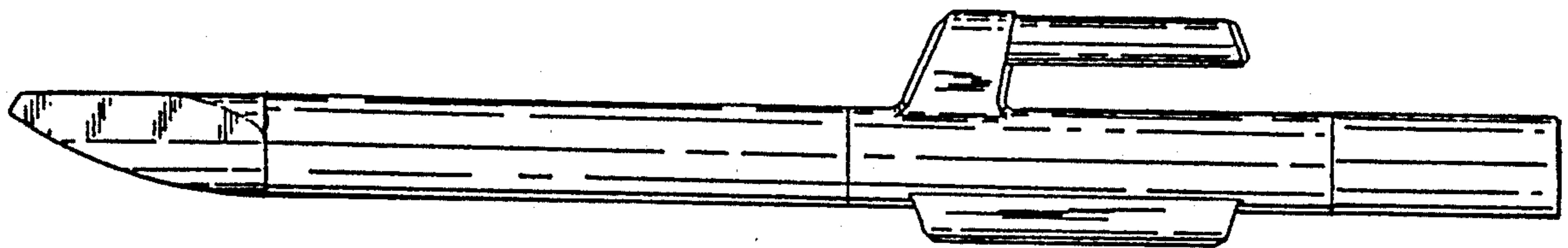

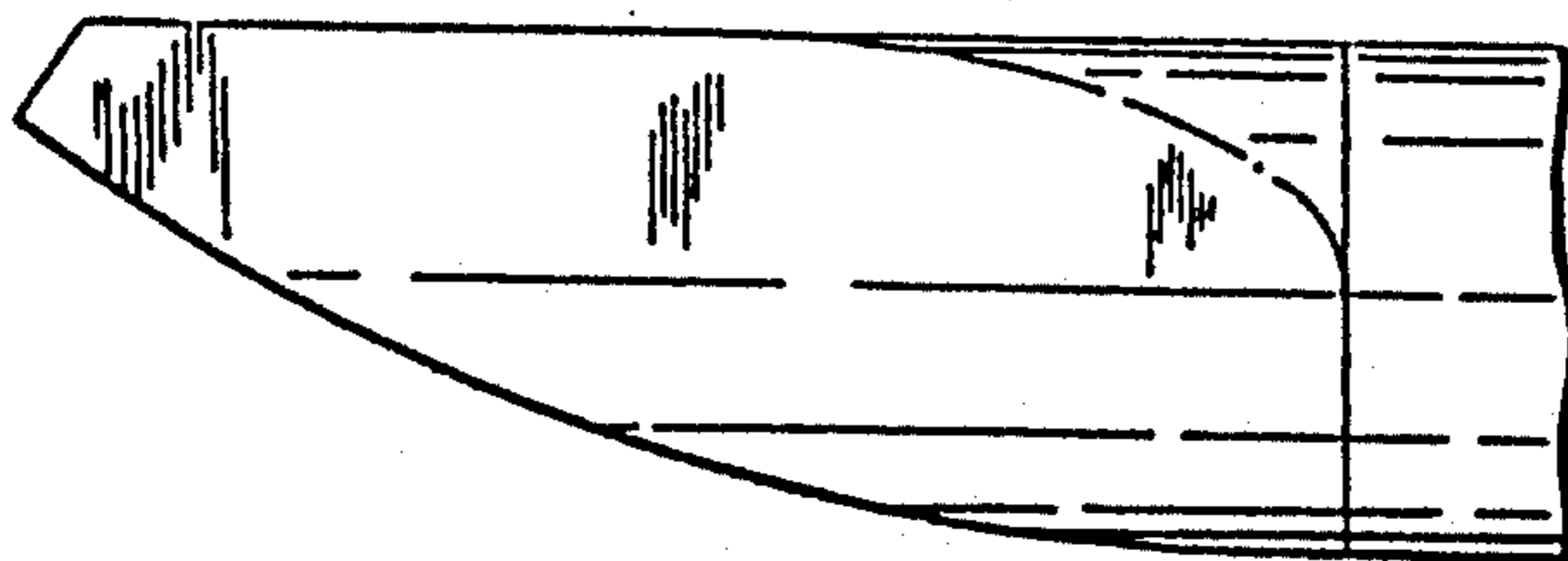

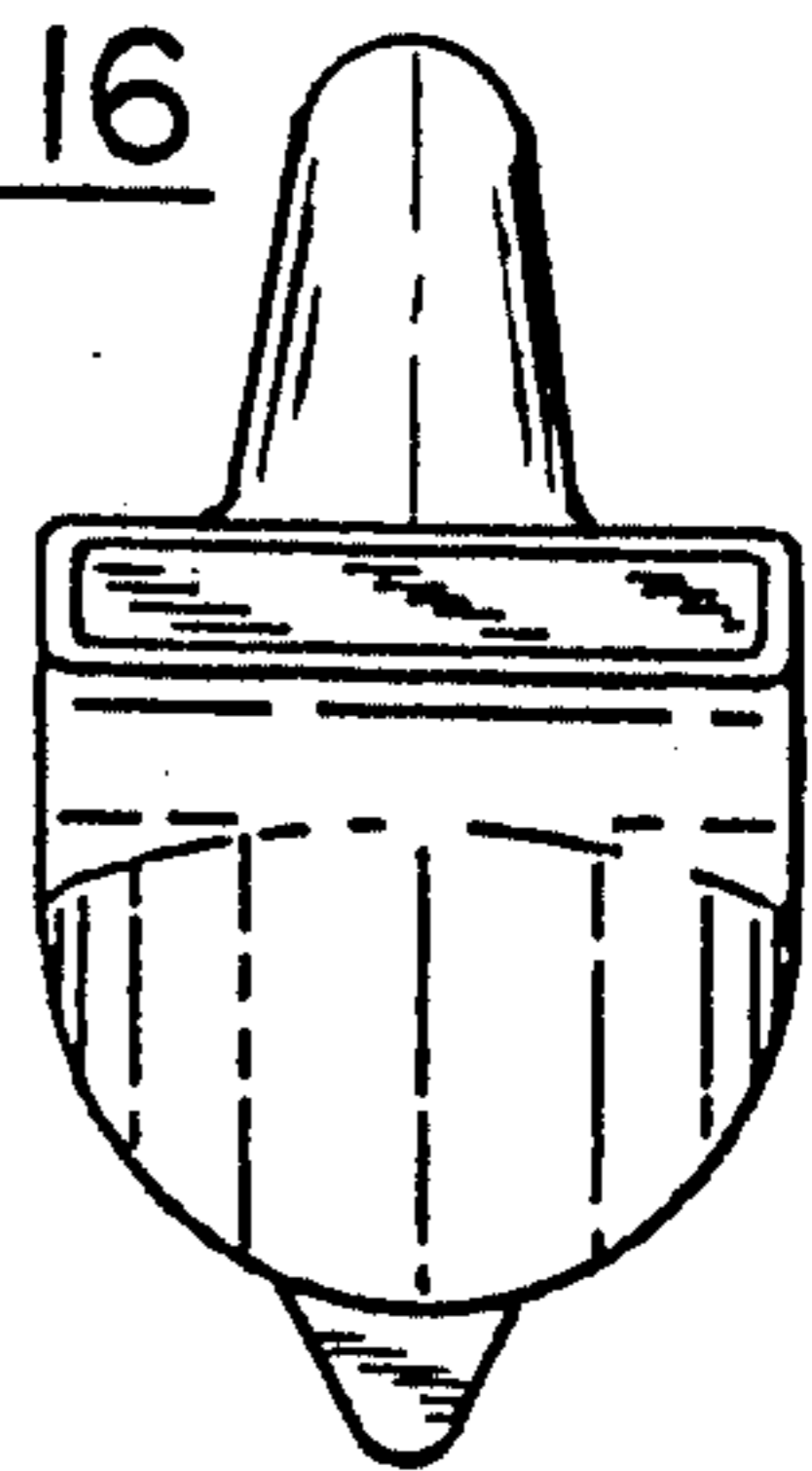

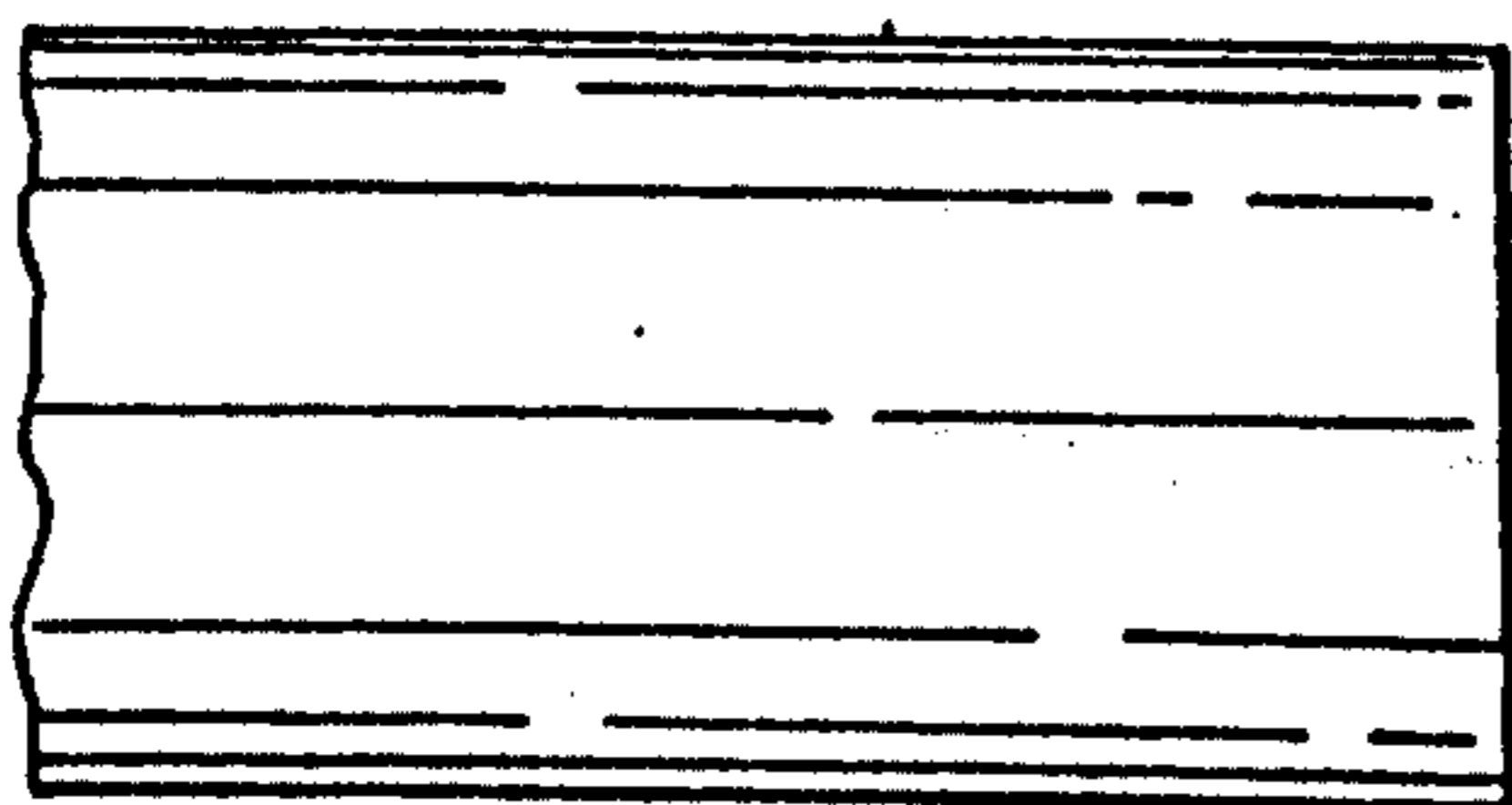

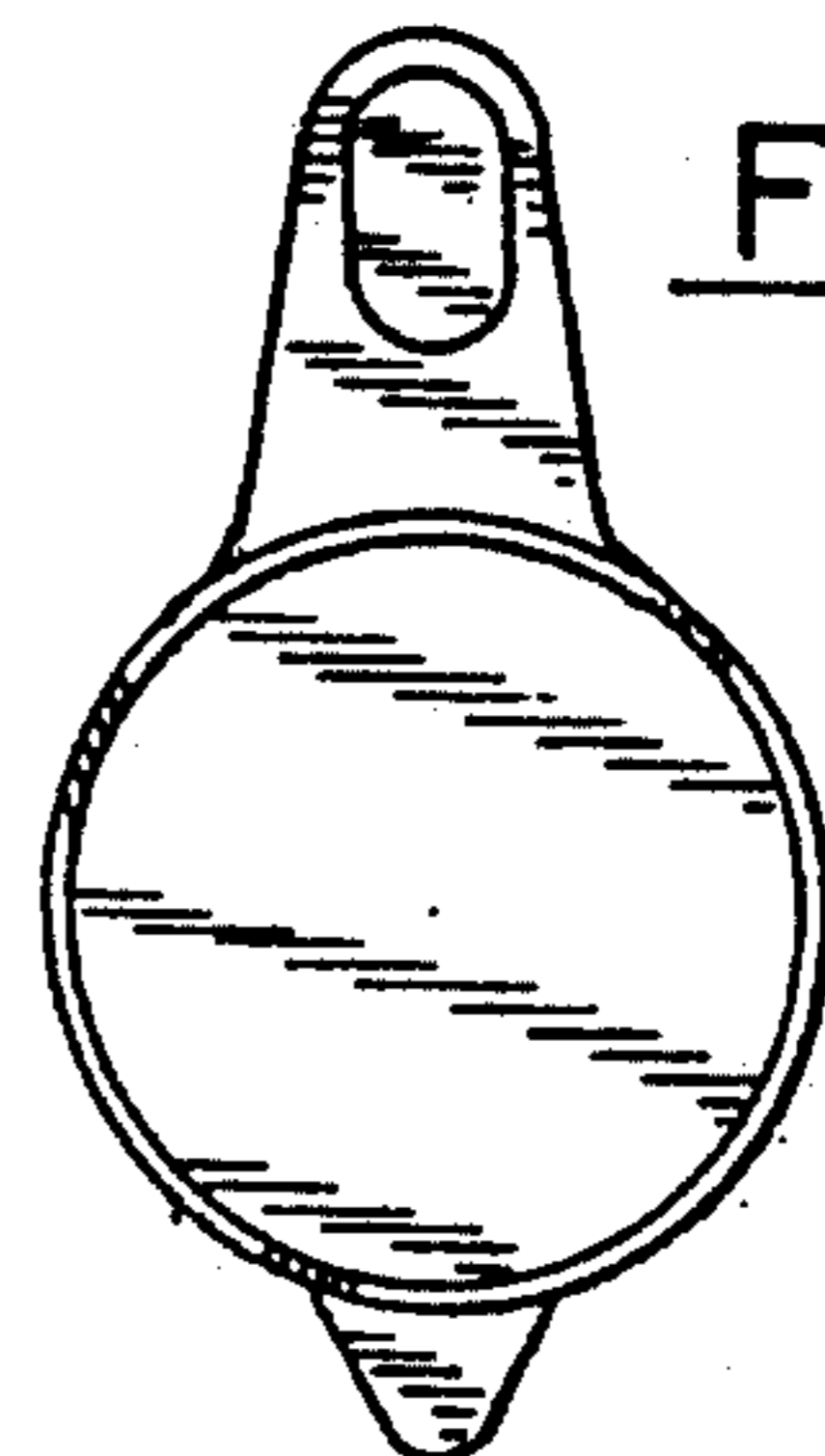
