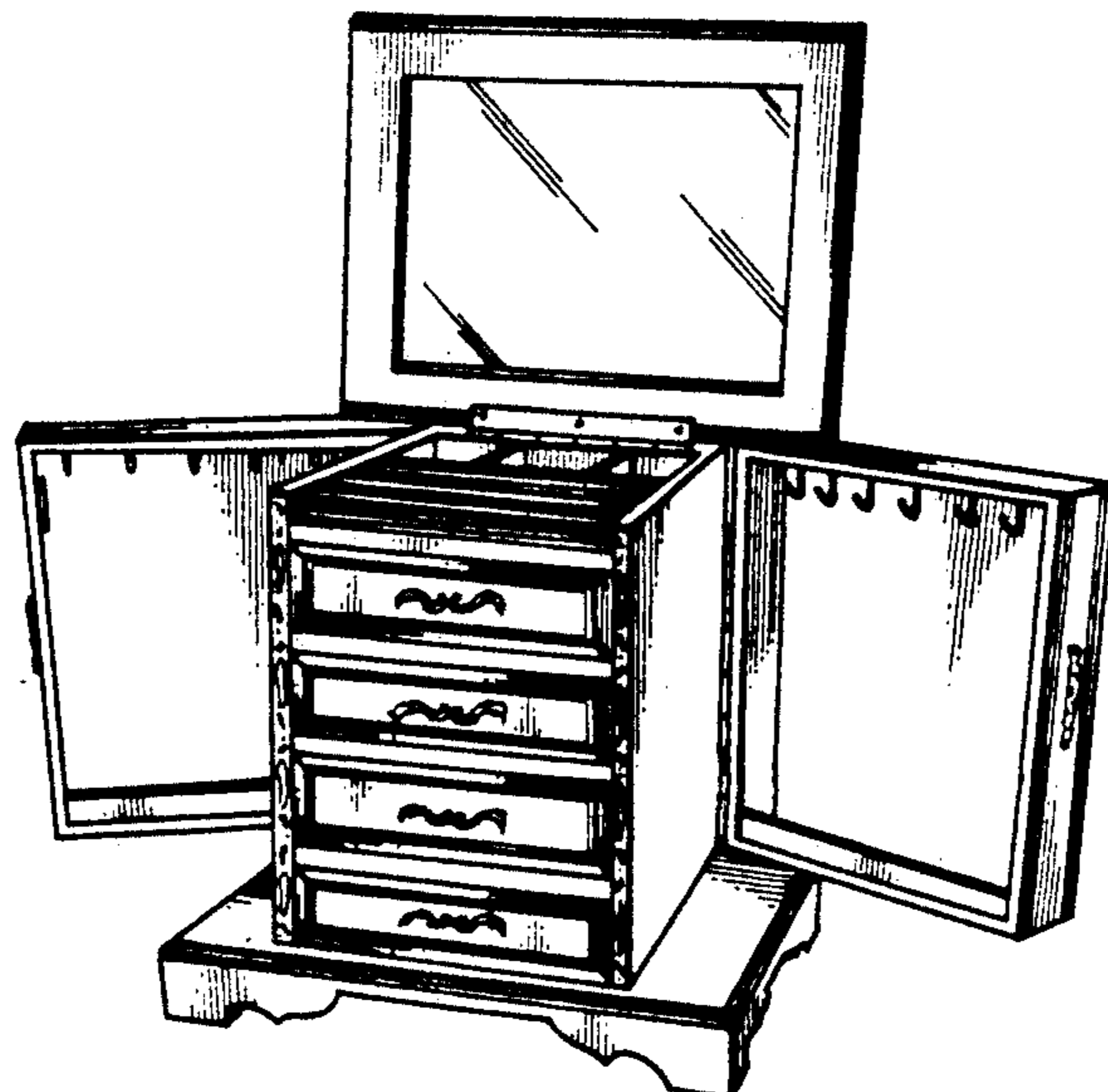

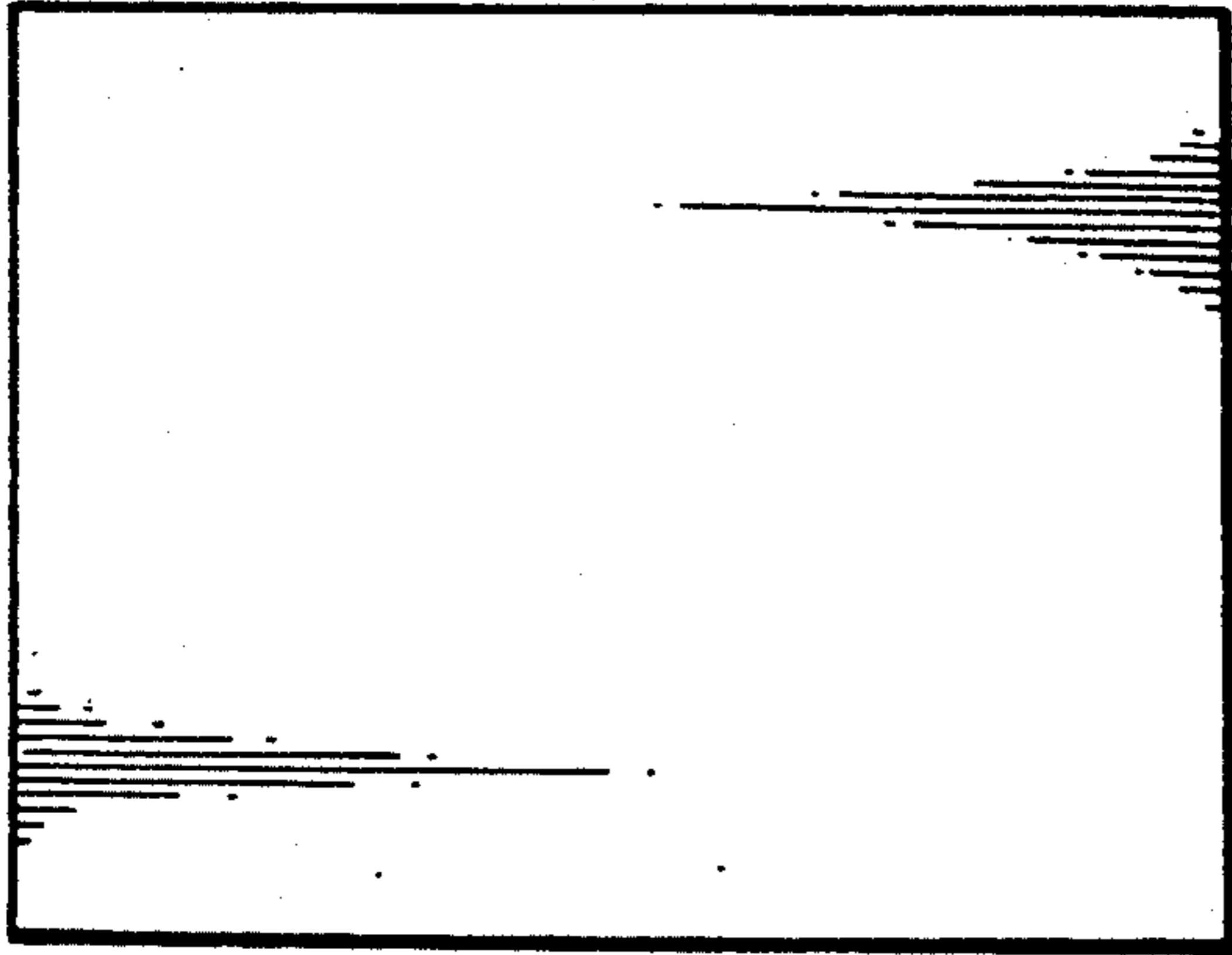
The ornamental design for a jewelry armoire, as shown and described.

**DESCRIPTION**

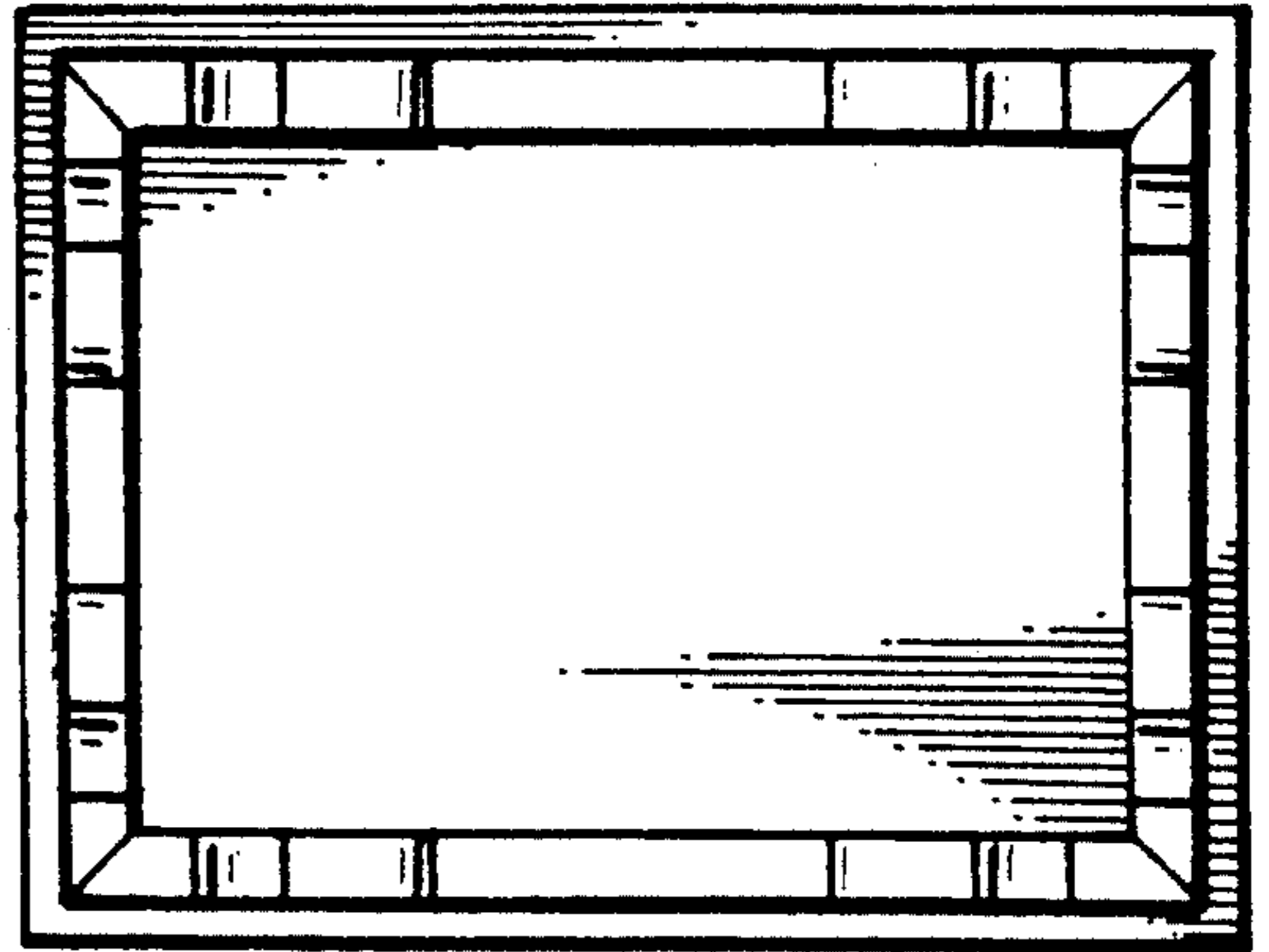
FIG. 1 is a front elevational view of a jewelry armoire showing my new design;  
FIG. 2 is a top plan view of the jewelry armoire of FIG. 1;  
FIG. 3 is a right side elevational view of the jewelry armoire of FIG. 1 the left being a mirror image thereof;  
FIG. 4 is a bottom plan view of the jewelry armoire of FIG. 1;  
FIG. 5 is a rear elevational view of the jewelry armoire of FIG. 1; and  
FIG. 6 is a perspective view of the jewelry armoire of FIG. 1 showing the side doors and top thereof opened.



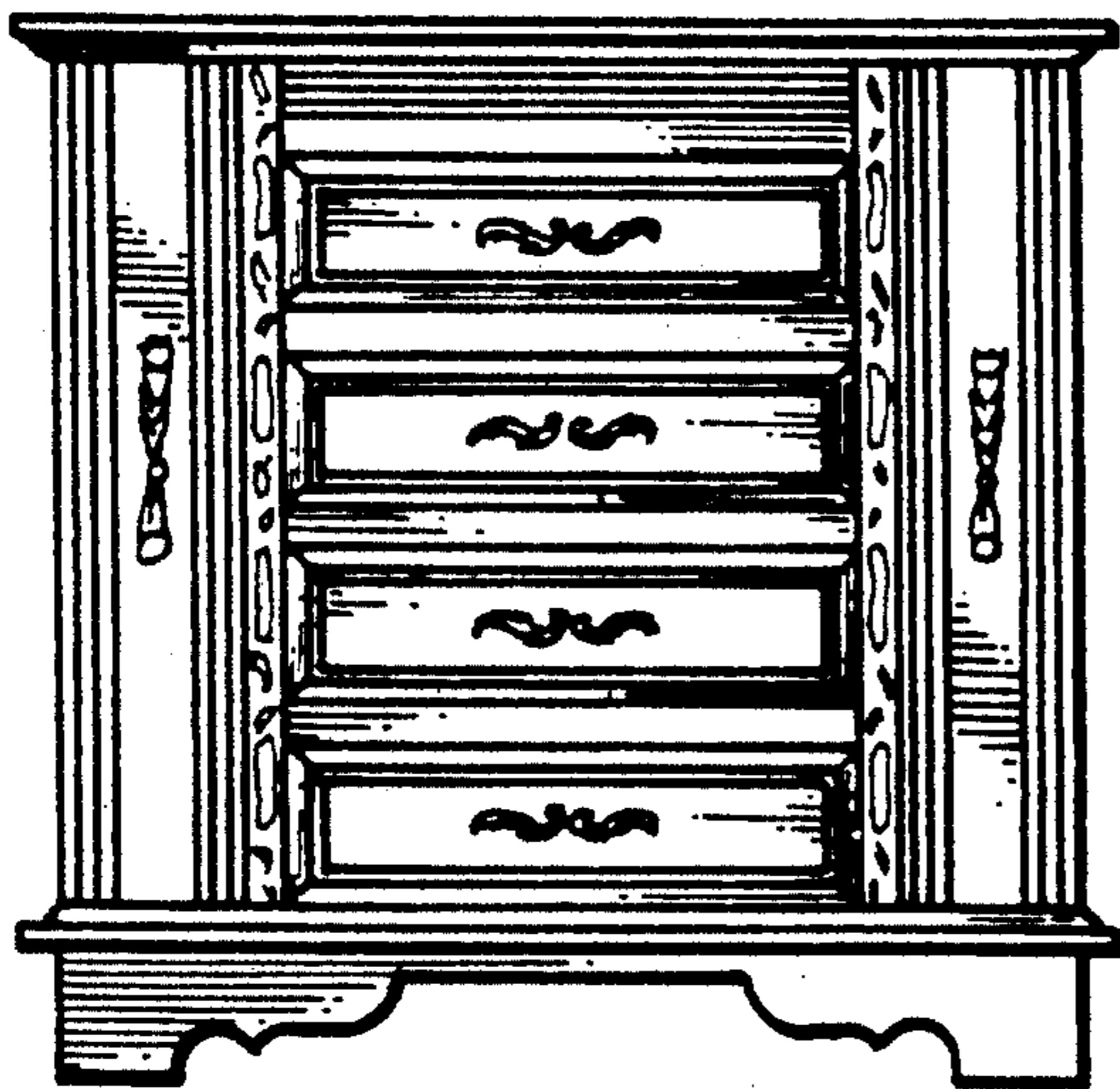

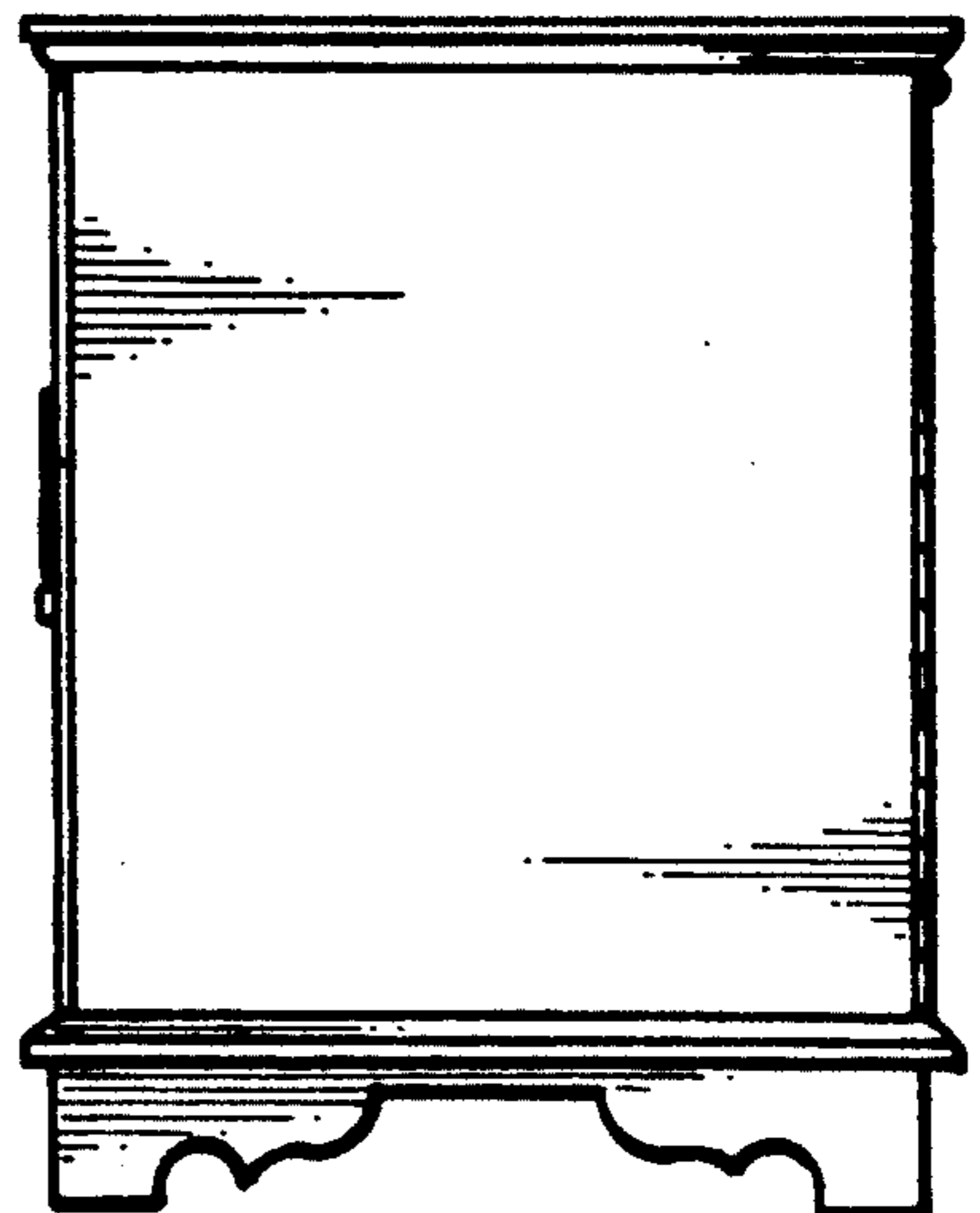

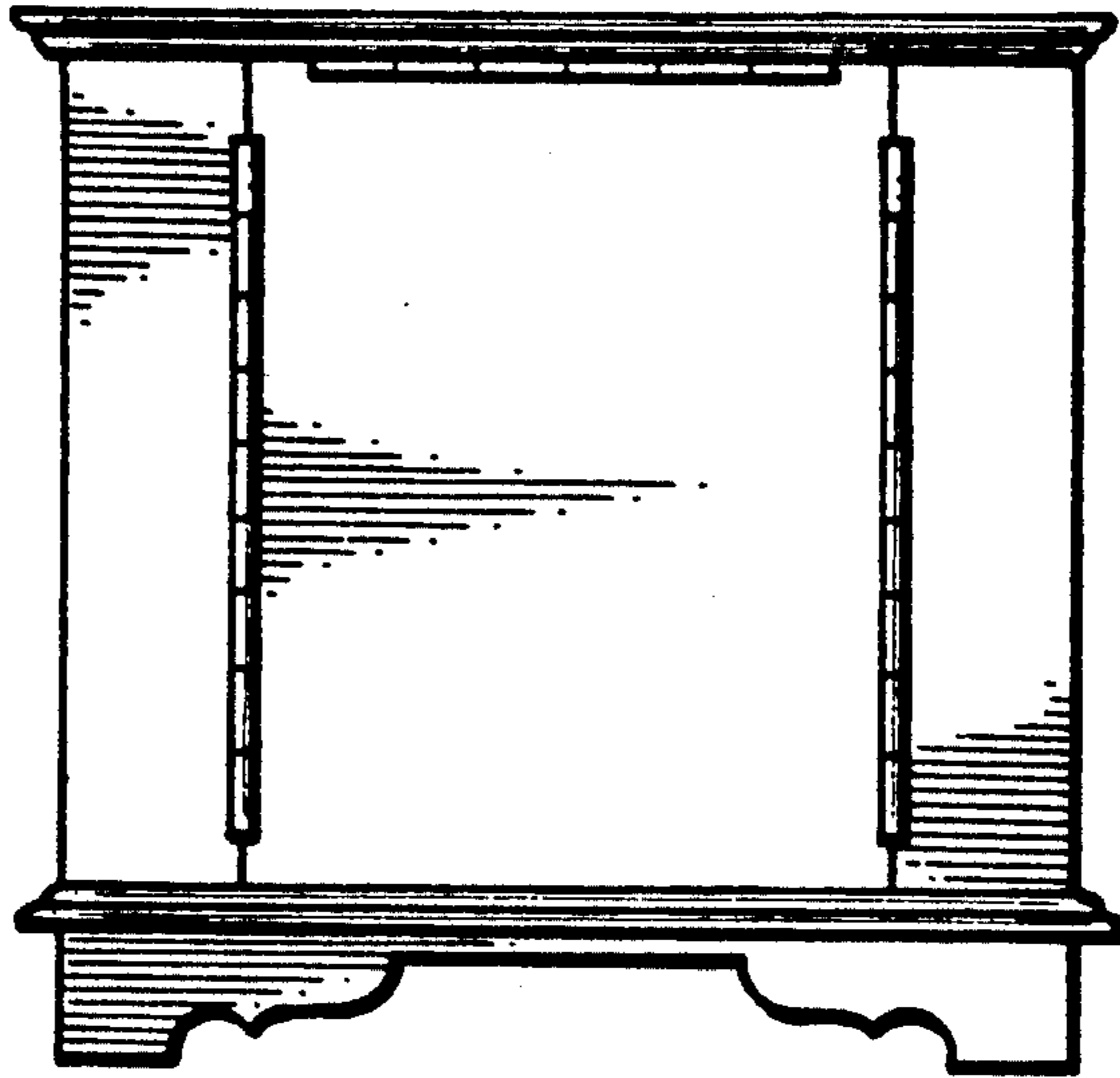
