[57] CLAIM

The ornamental design for a magnetic fastener for
clothing, as shown and described.

DESCRIPTION

FIG. 1 is a left side elevational view of a magnetic
fastener for clothing, showing a first embodiment of my
new design.

FIG. 2 is a top plan view thereof;

FIG. 3 is a front elevational view thereof;

FIG. 4 is a rear elevational view thereof;

FIG. 5 is a cross-sectional view thereof, taken on line
5—5 of FIG. 3.

FIG. 6 is a front elevational view of the rear member of
FIG. 4, shown separately for clarity of illustration;

FIG. 7 is a top plan view thereof;

FIG. 8 is a rear elevational view thereof;

FIG. 9 is a left side elevational view thereof;

FIG. 10 is a cross-sectional view thereof, taken on line
10—10 of FIG. 6;

FIG. 11 is a rear elevational view of the front member of
FIG. 3, shown separately for clarity of illustration;

FIG. 12 is a top plan view thereof;

FIG. 13 is a front elevational view thereof;

FIG. 14 is a left side elevational view thereof;

FIG. 15 is a cross-sectional view thereof, taken on line
15—15 of FIG. 13;

FIG. 16 is a cross-sectional view taken on line 16—16 of
FIG. 4 showing the magnetic fastener applied to cloth-
ing, the broken lines indicating fragmentary pieces of
fabric being shown for illustrative purposes only;

FIG. 17 is a front elevational view of a magnetic fas-
tener for clothing, showing a second embodiment of my
new design;

FIG. 18 is a top plan view thereof;

FIG. 19 is a rear elevational view thereof;

FIG. 20 is a right side elevational view thereof;

FIG. 21 is a front elevational view of one part of the
magnetic fastener of FIG. 20, shown separately for
clarity of illustration;

FIG. 22 is a top plan view thereof;

FIG. 23 is a rear elevational view thereof;

FIG. 24 is a right side elevational view thereof;

FIG. 25 is a front elevational view of the other part of
the magnetic fastener of FIG. 20, shown separately for
clarity;

FIG. 26 is a top plan view thereof;

FIG. 27 is a rear elevational view thereof;

FIG. 28 is a right side elevational view thereof;

FIG. 29 is an enlarged perspective view of the other
part of the magnetic fastener as shown in FIGS. 25—28;

FIG. 30 is an enlarged perspective view of the one part
of the magnetic fastener as shown in FIGS. 21—24;

FIG. 31 is an enlarged perspective view of the magnetic
fastener as shown in FIGS. 1—4; and

FIG. 32 is an enlarged exploded perspective view of the
fastener with a section cut through the middle. The
broken line showing of clothing and fitting rings in
FIG. 32 is for illustrative purposes only and forms no
part of the claimed design.

and 32 is for illustrative purposes only and forms no part
of the claimed design.

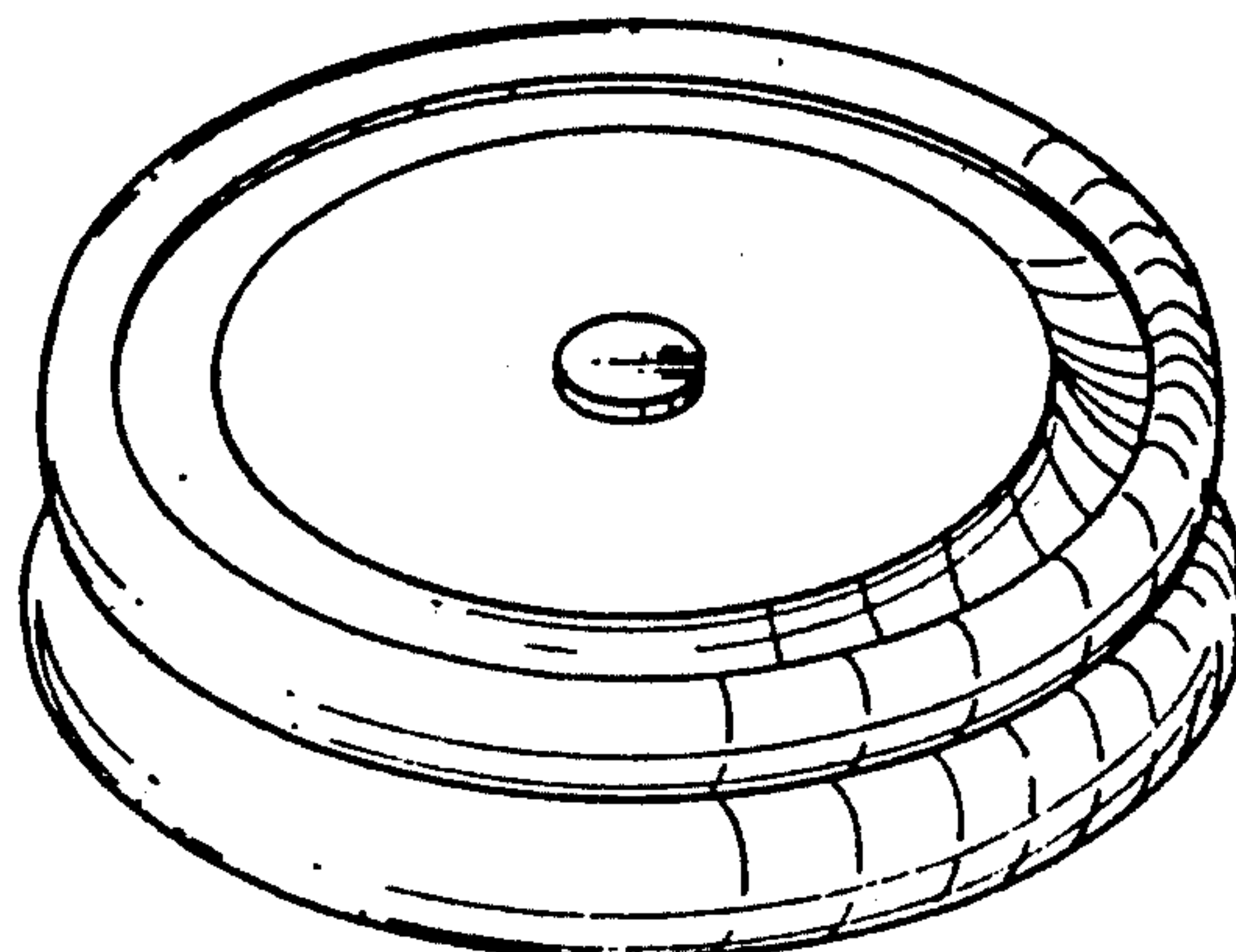

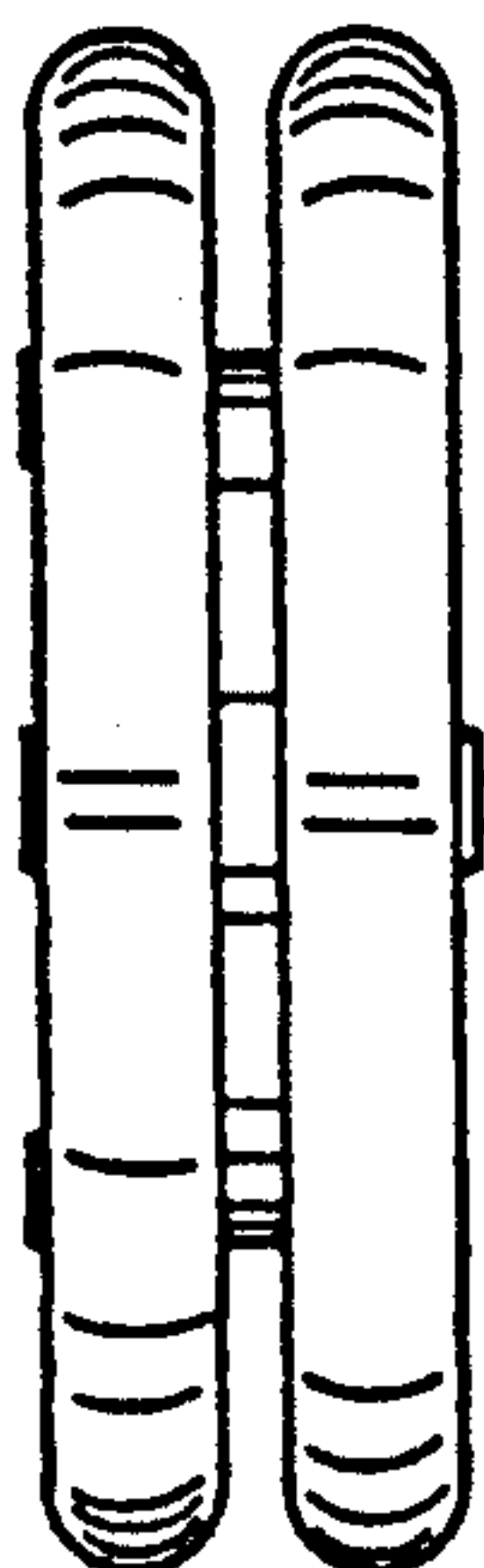

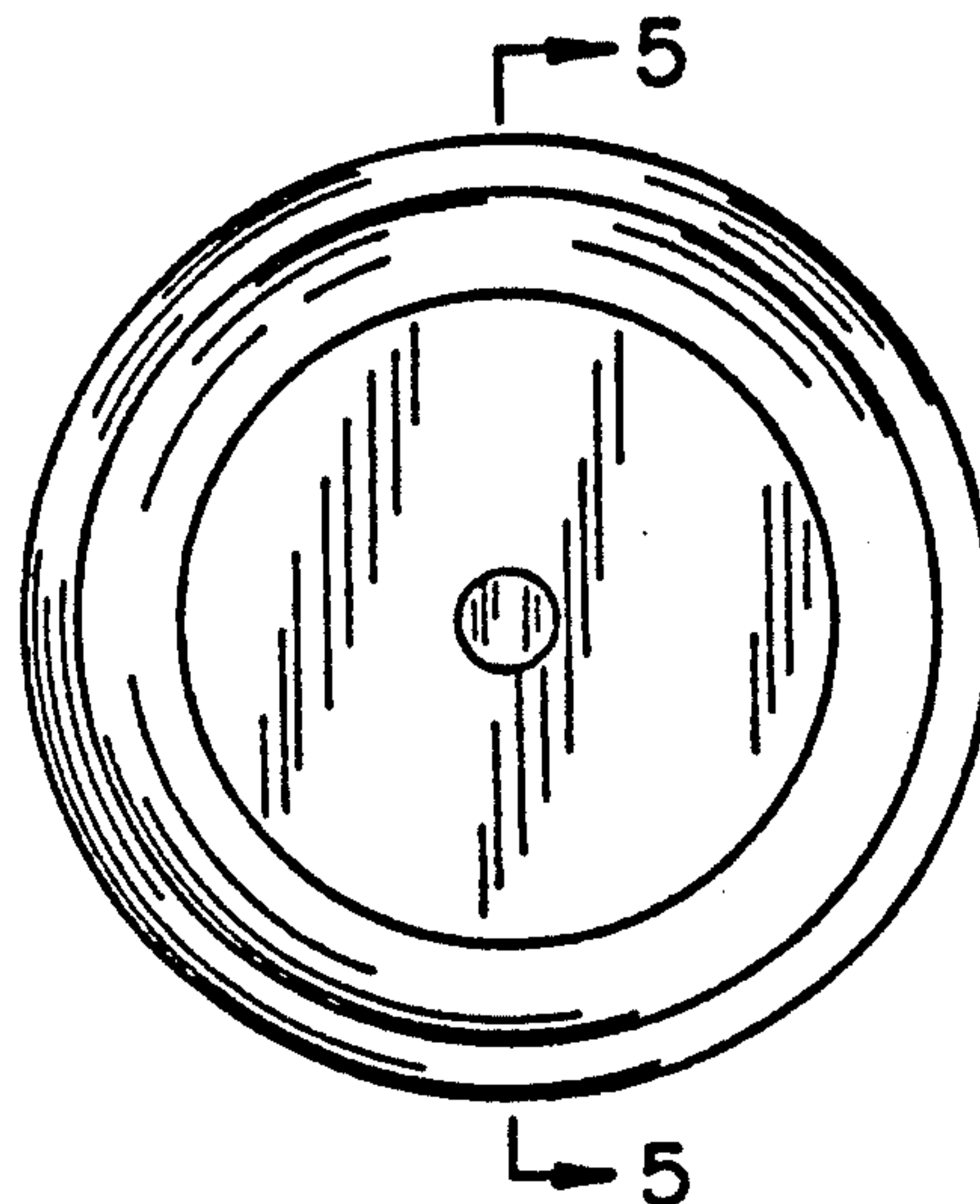

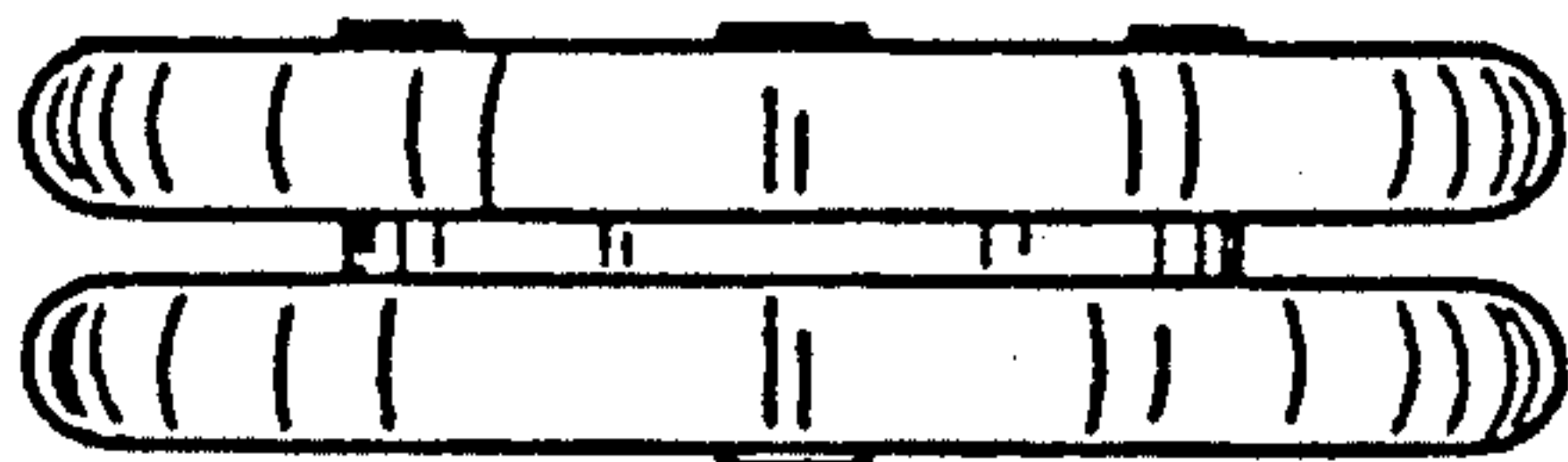

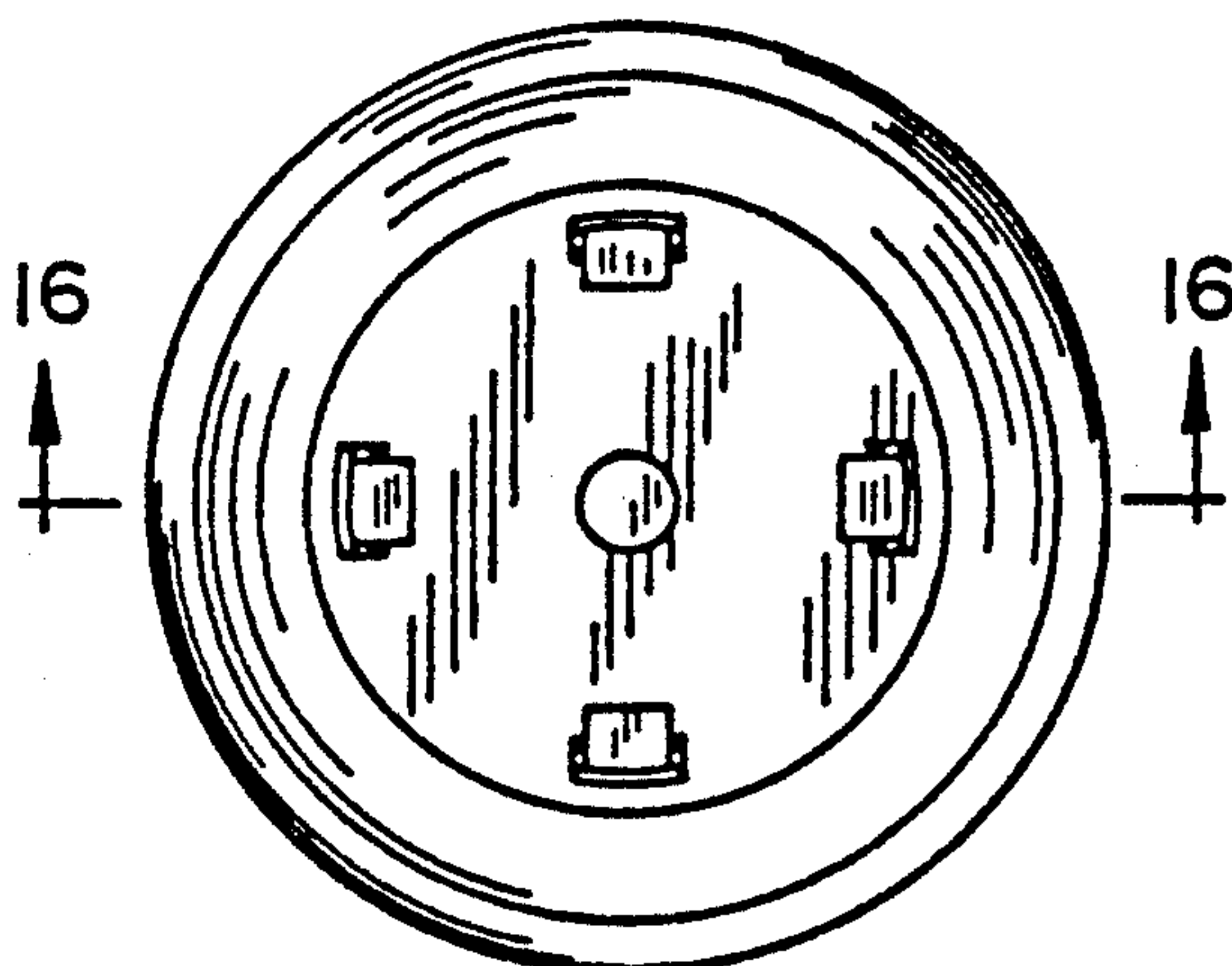

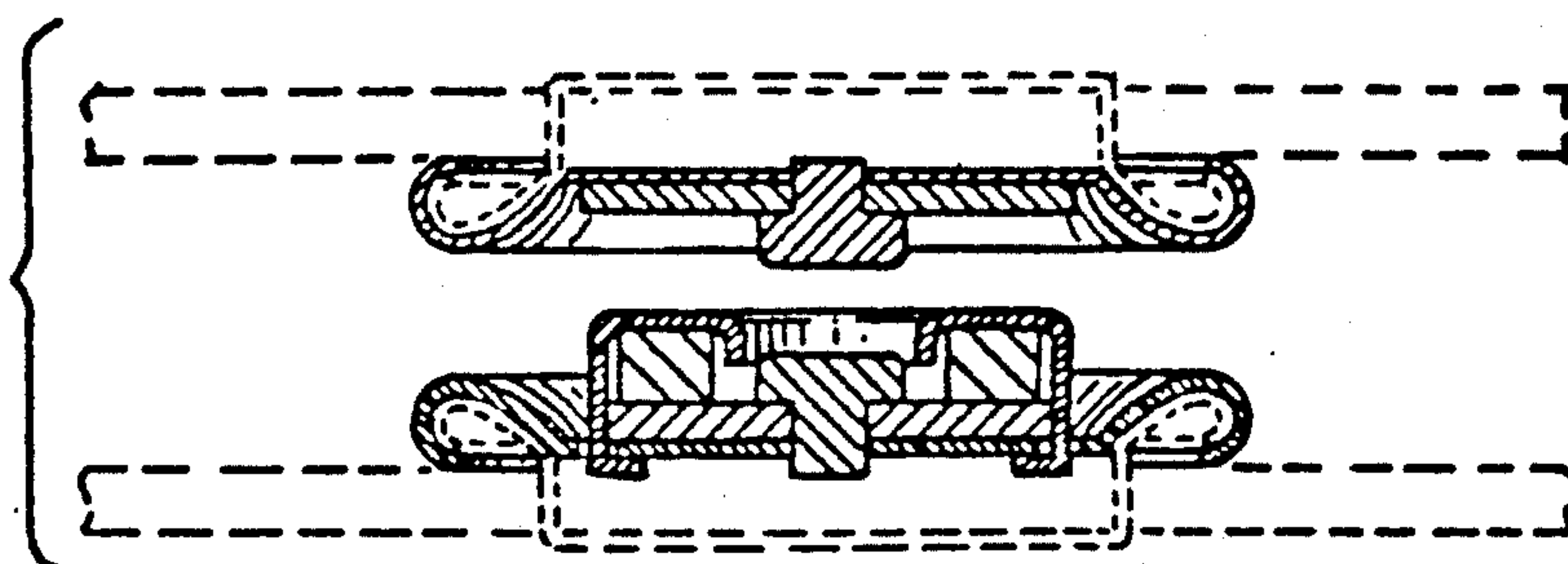

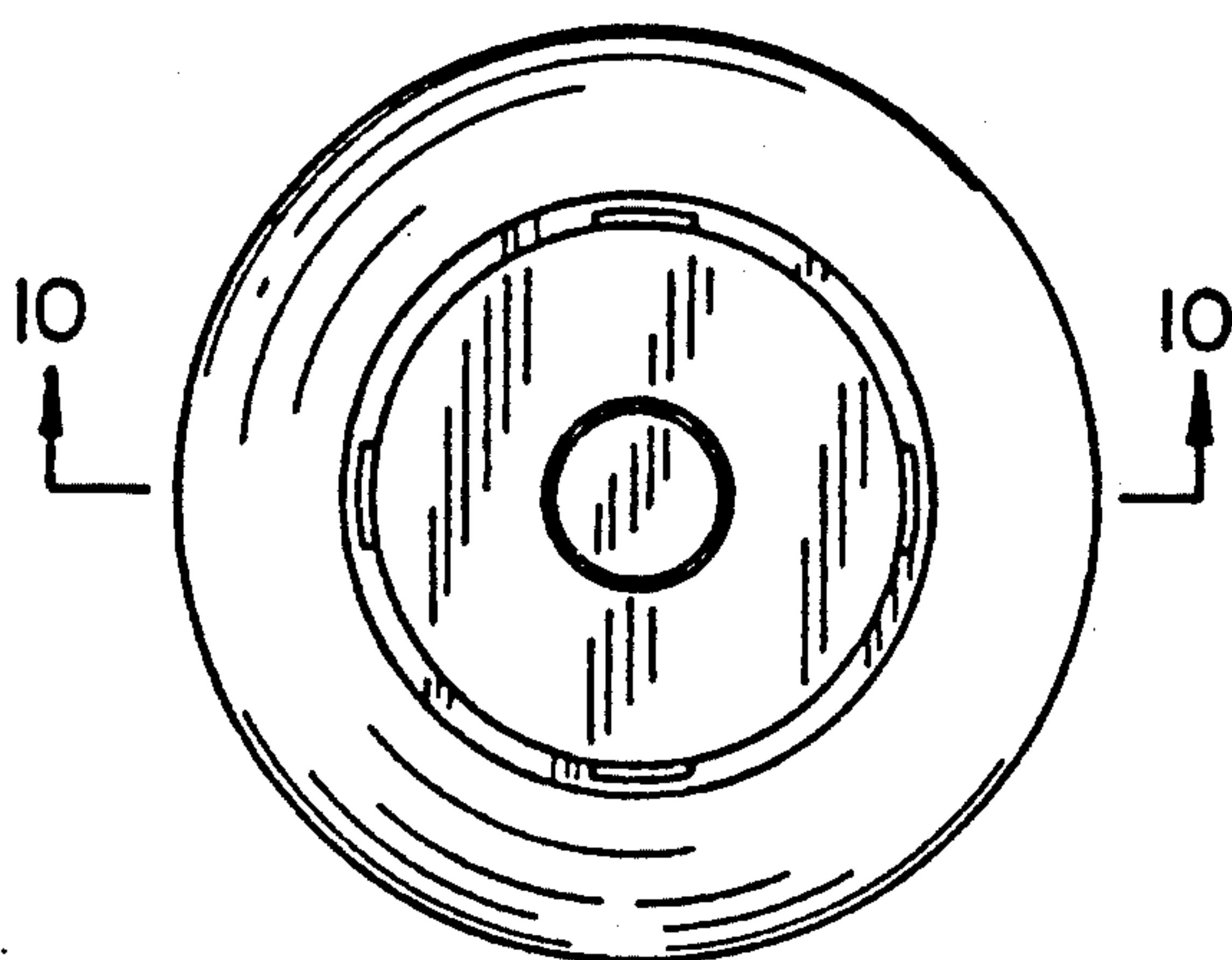

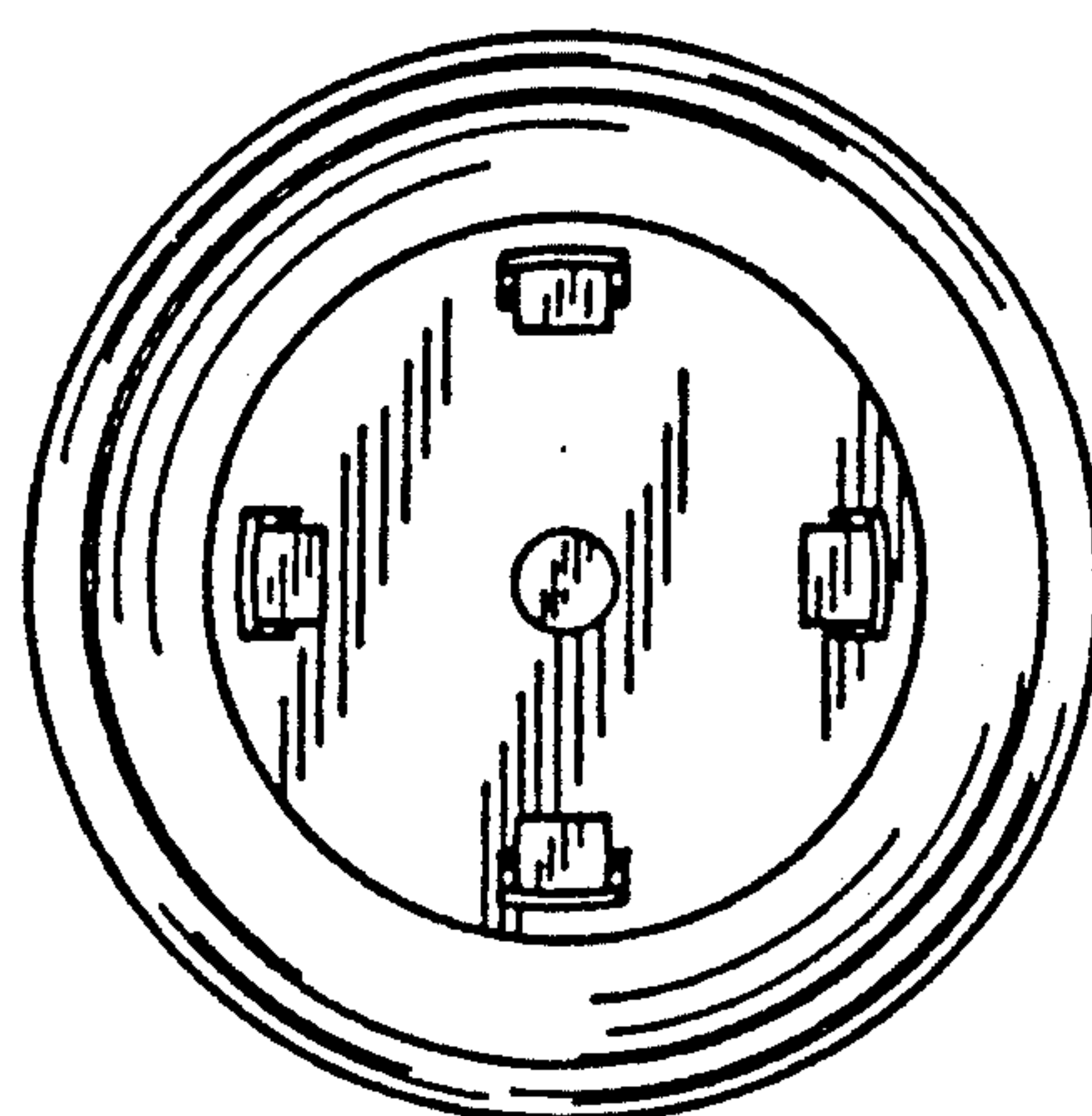

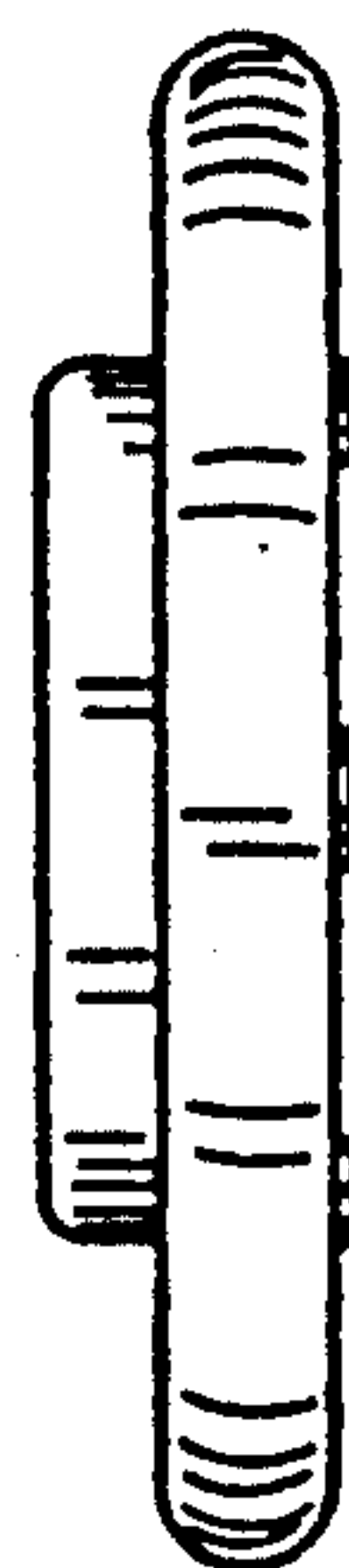

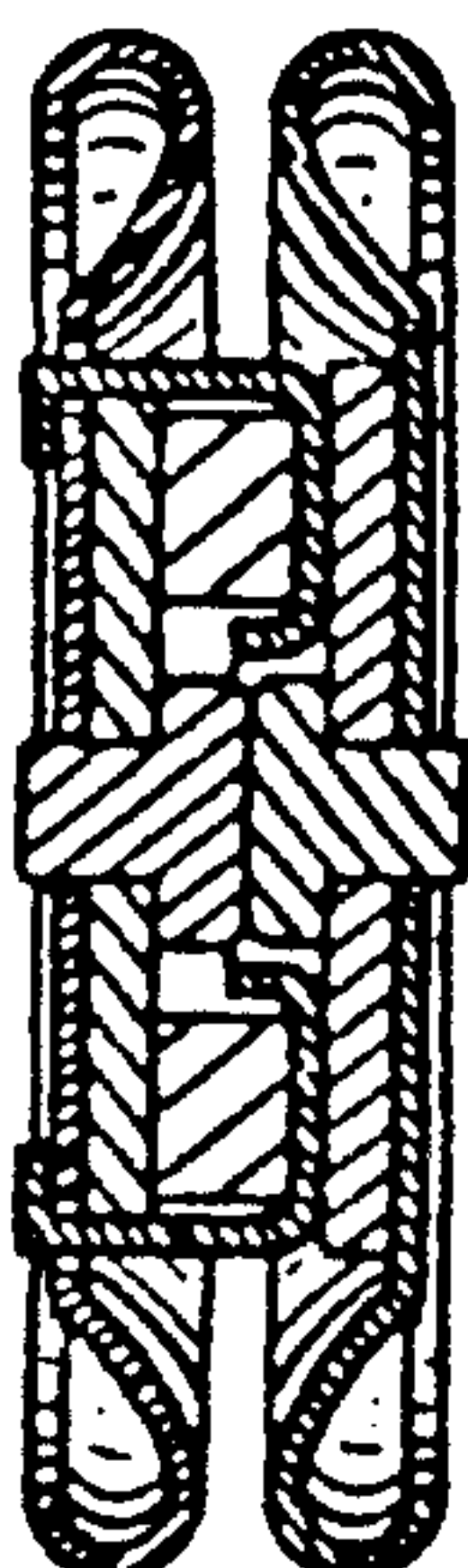

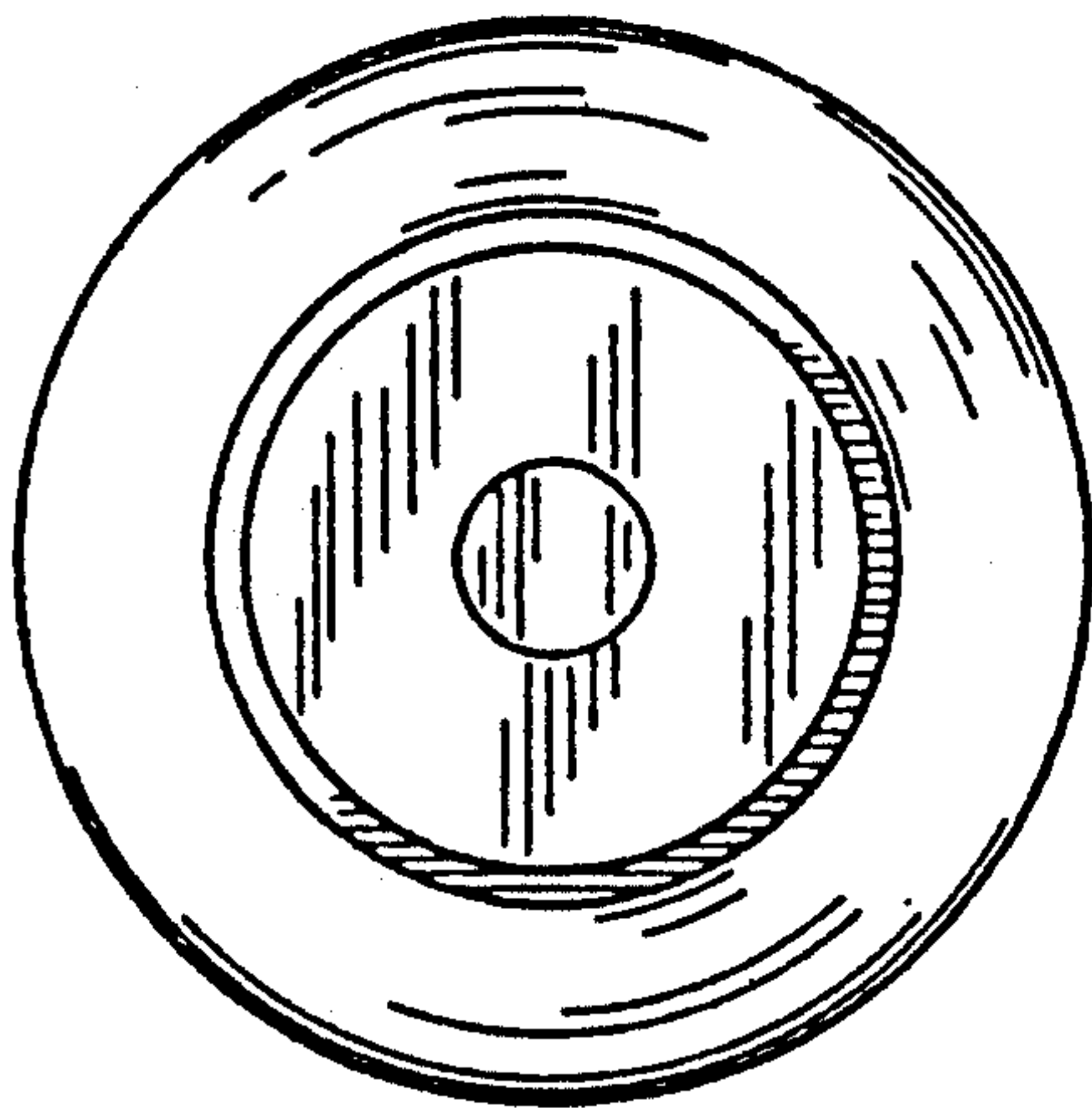

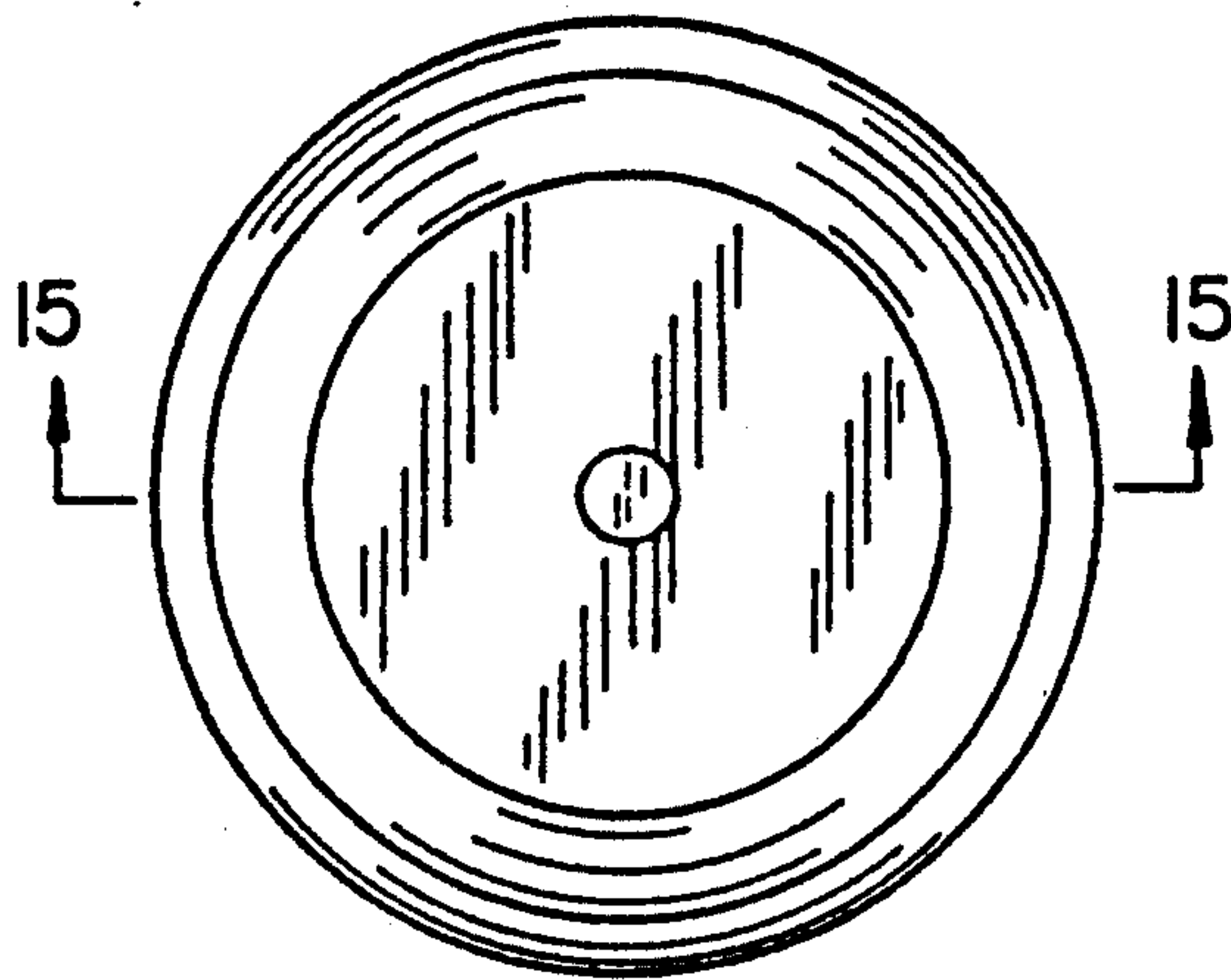

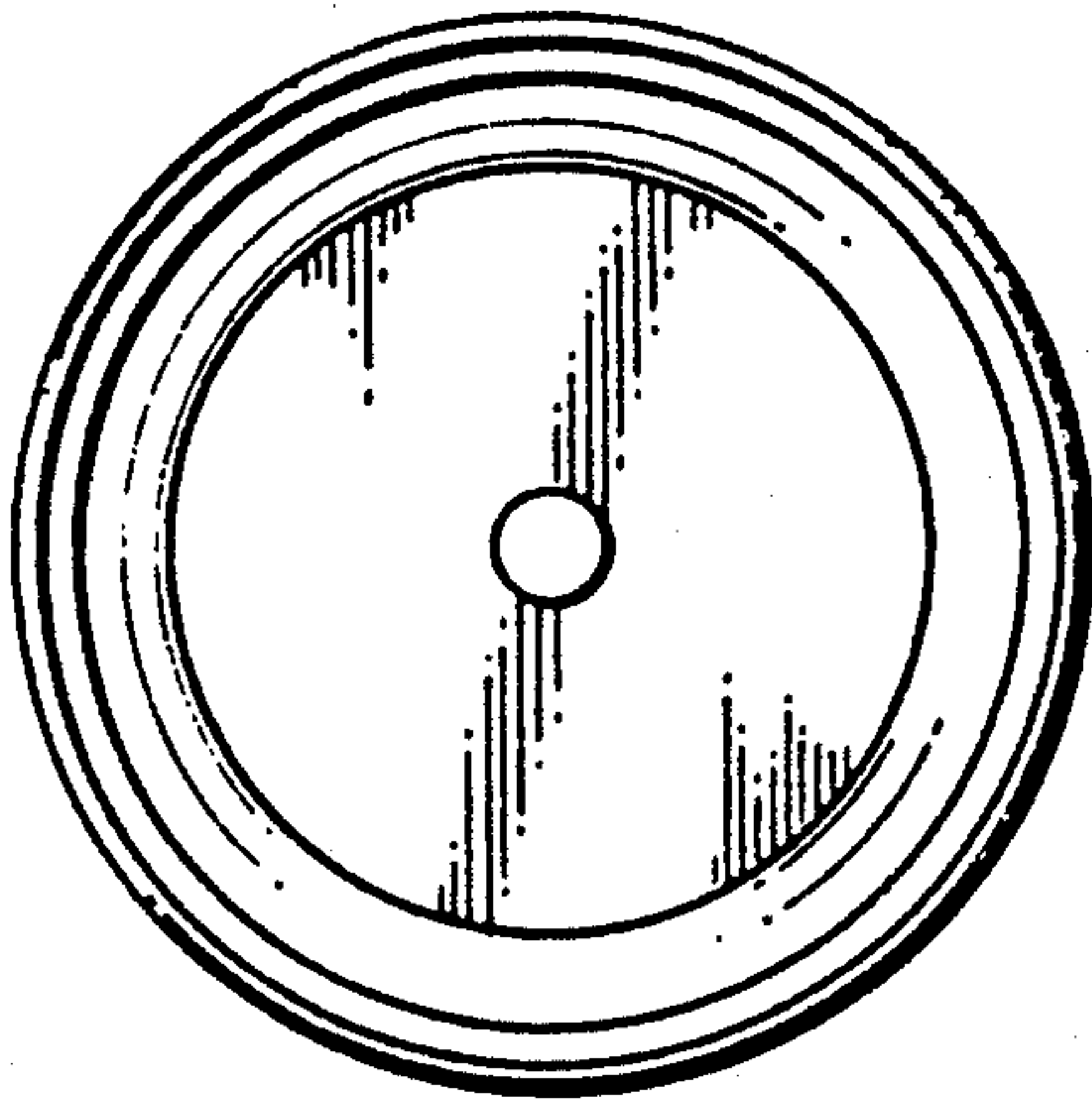

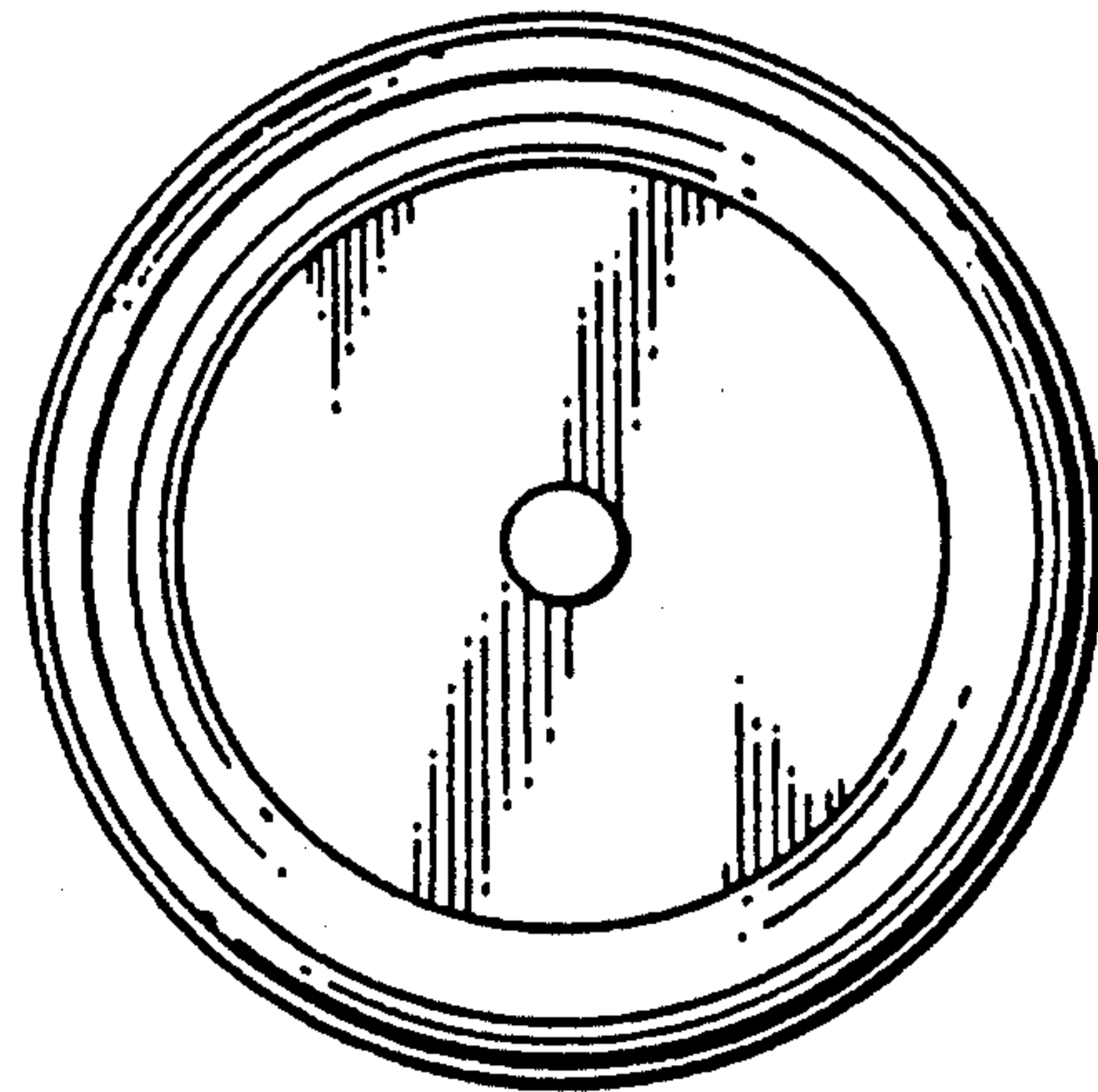

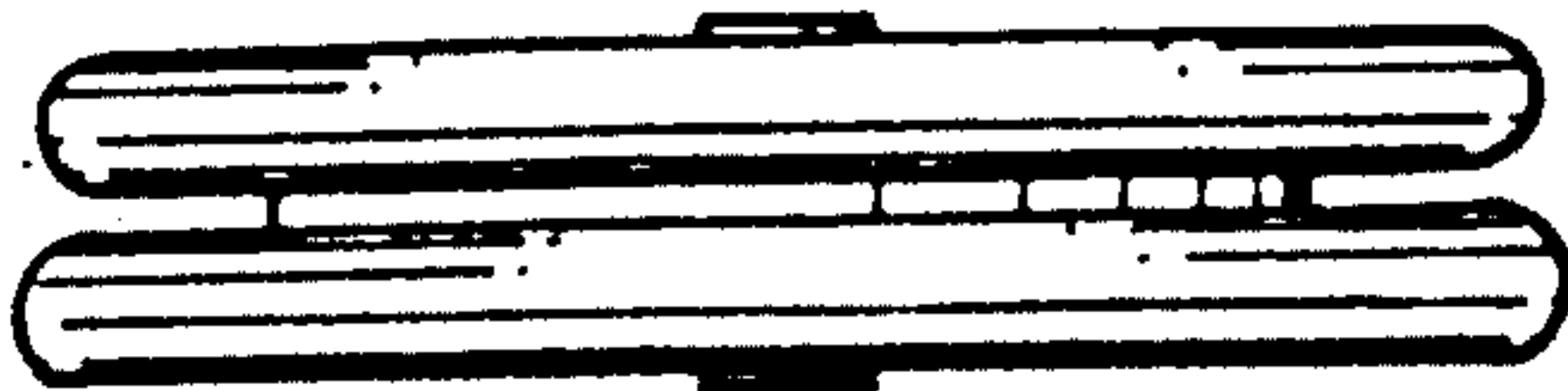

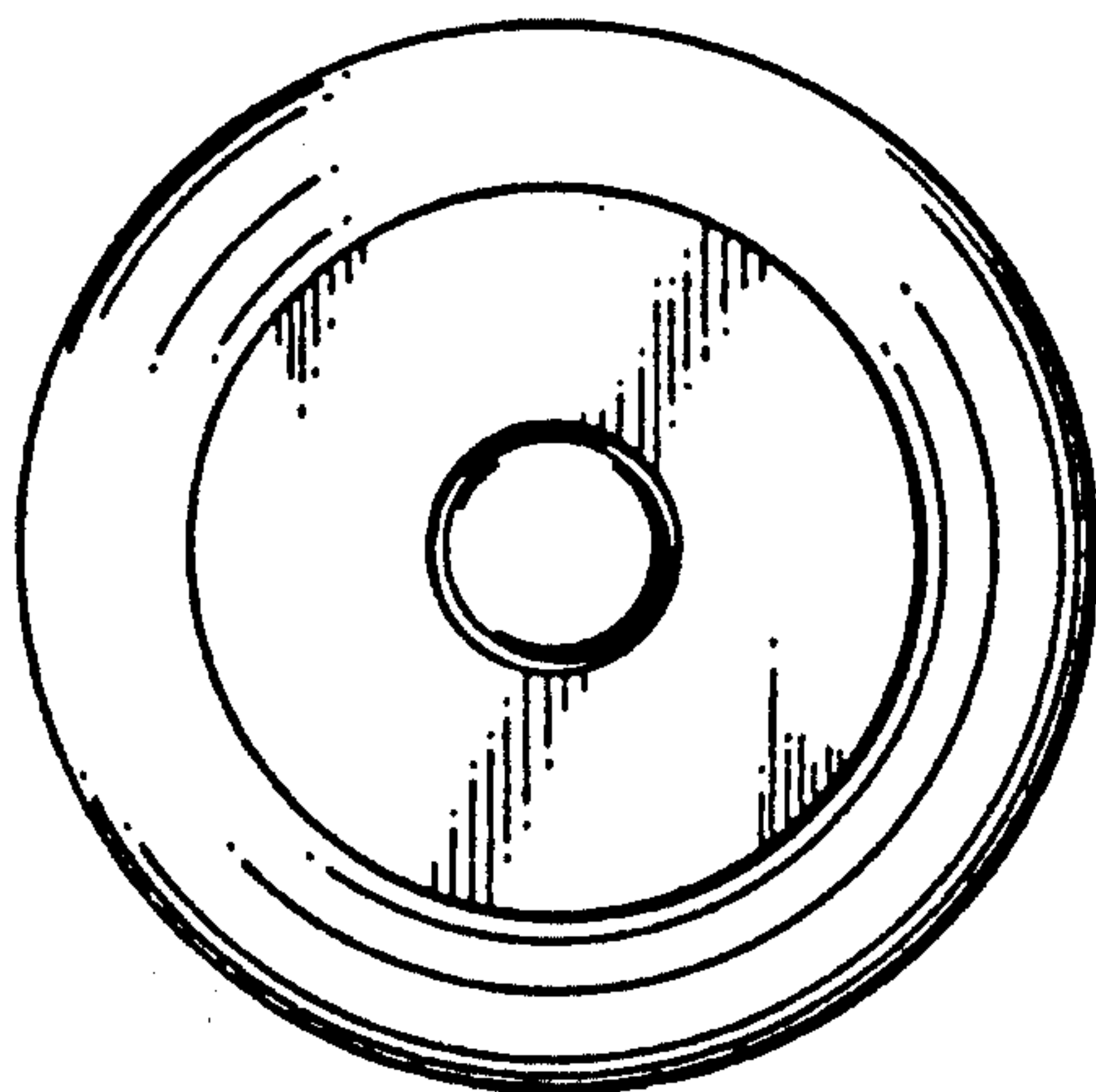

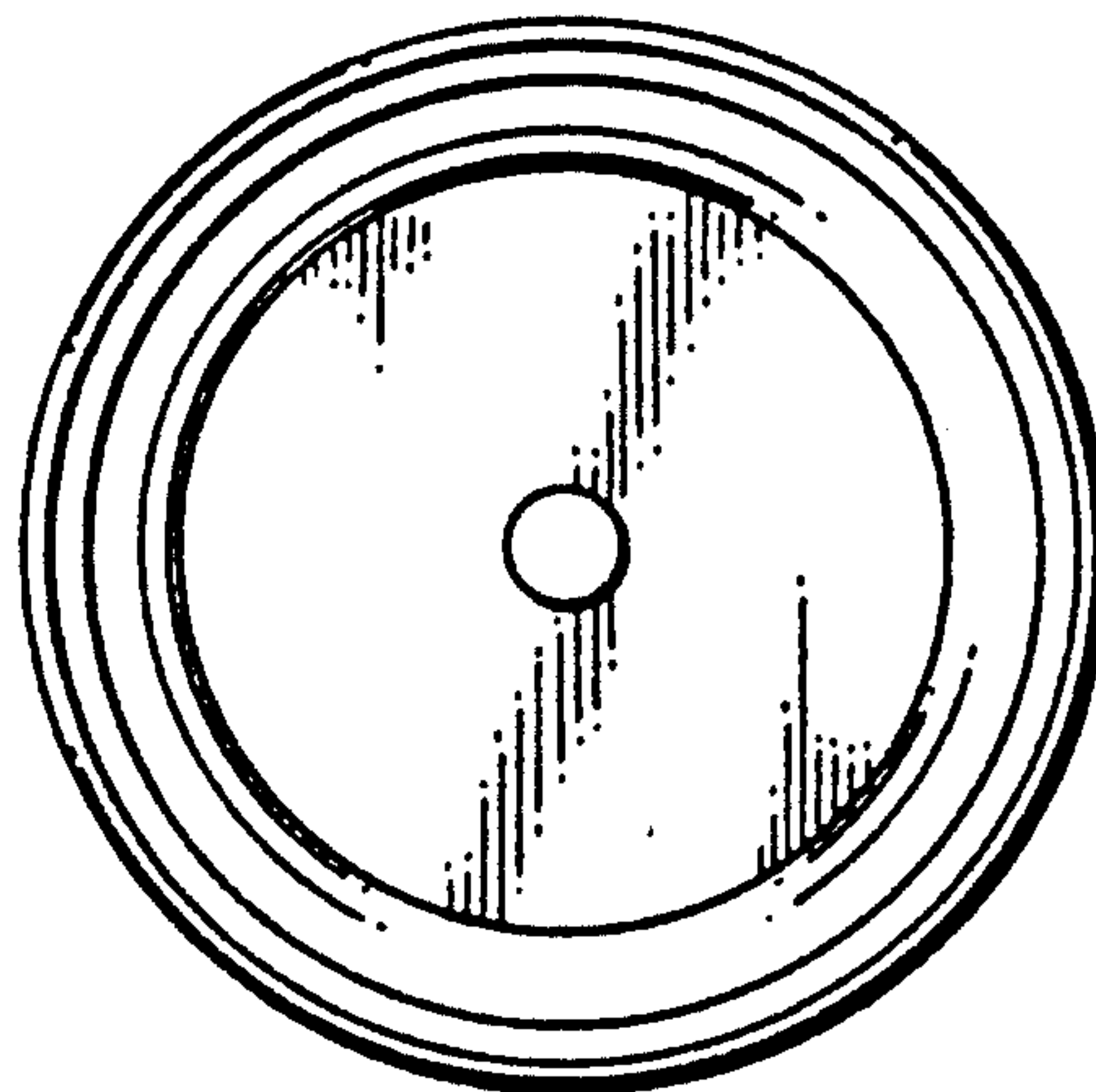

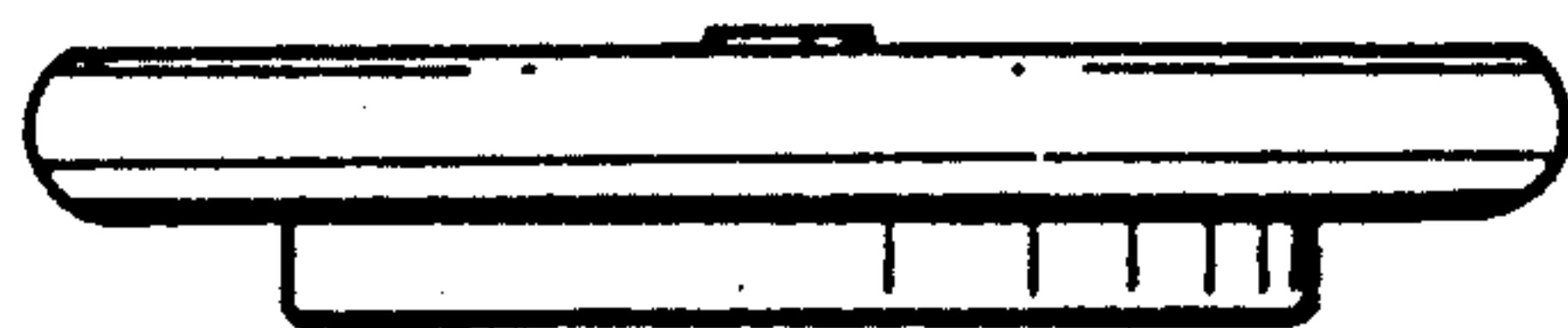

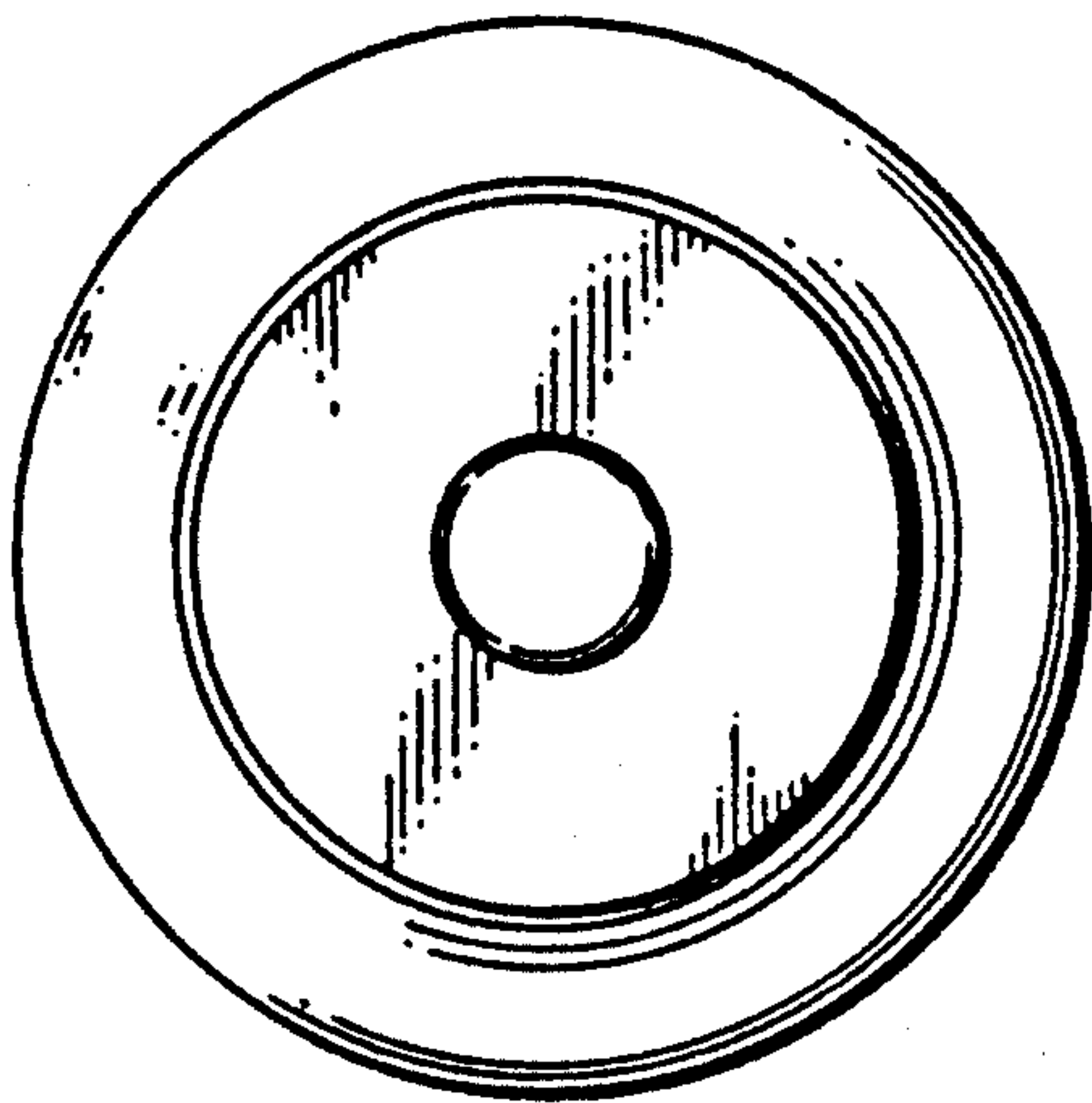

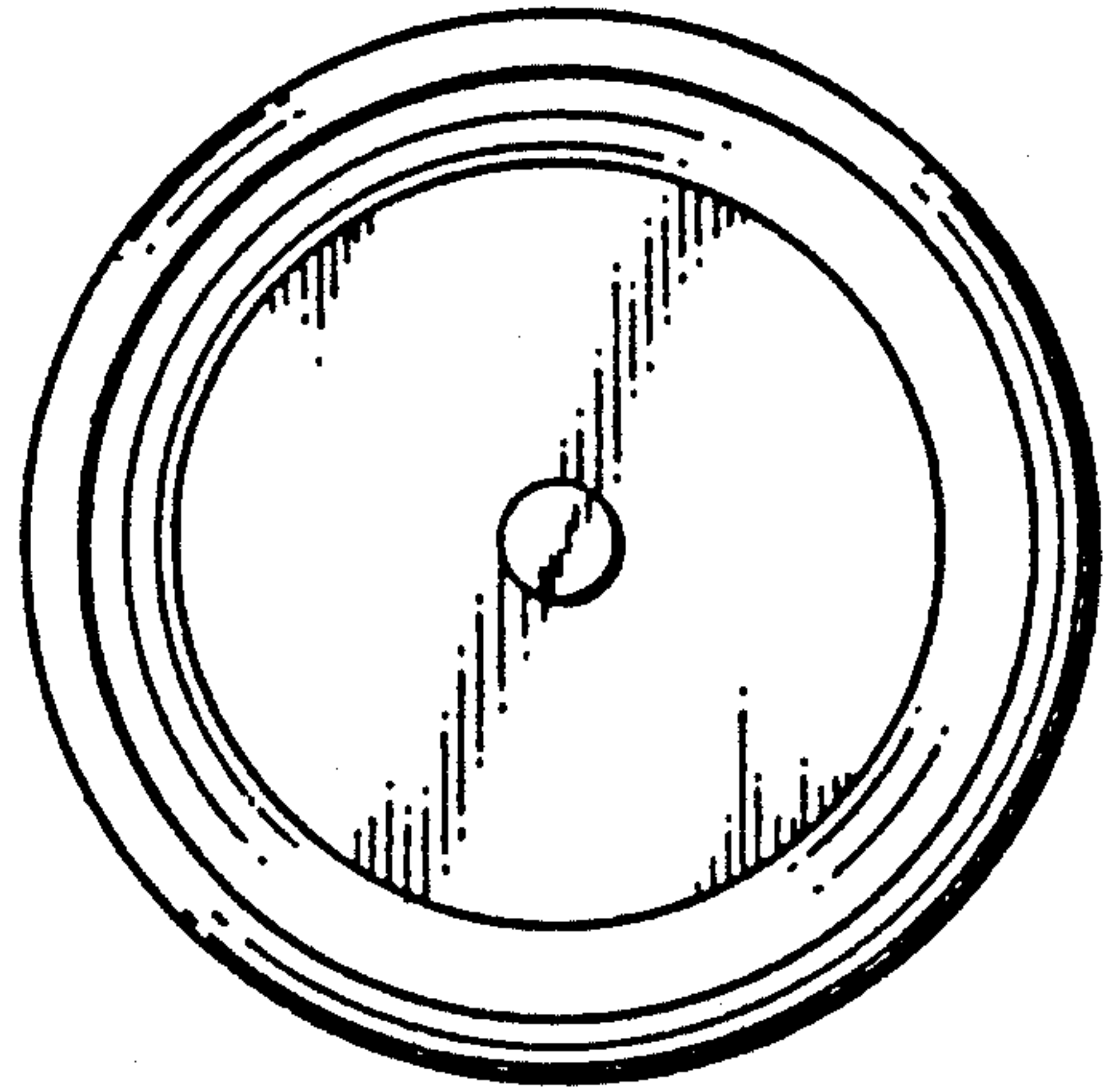

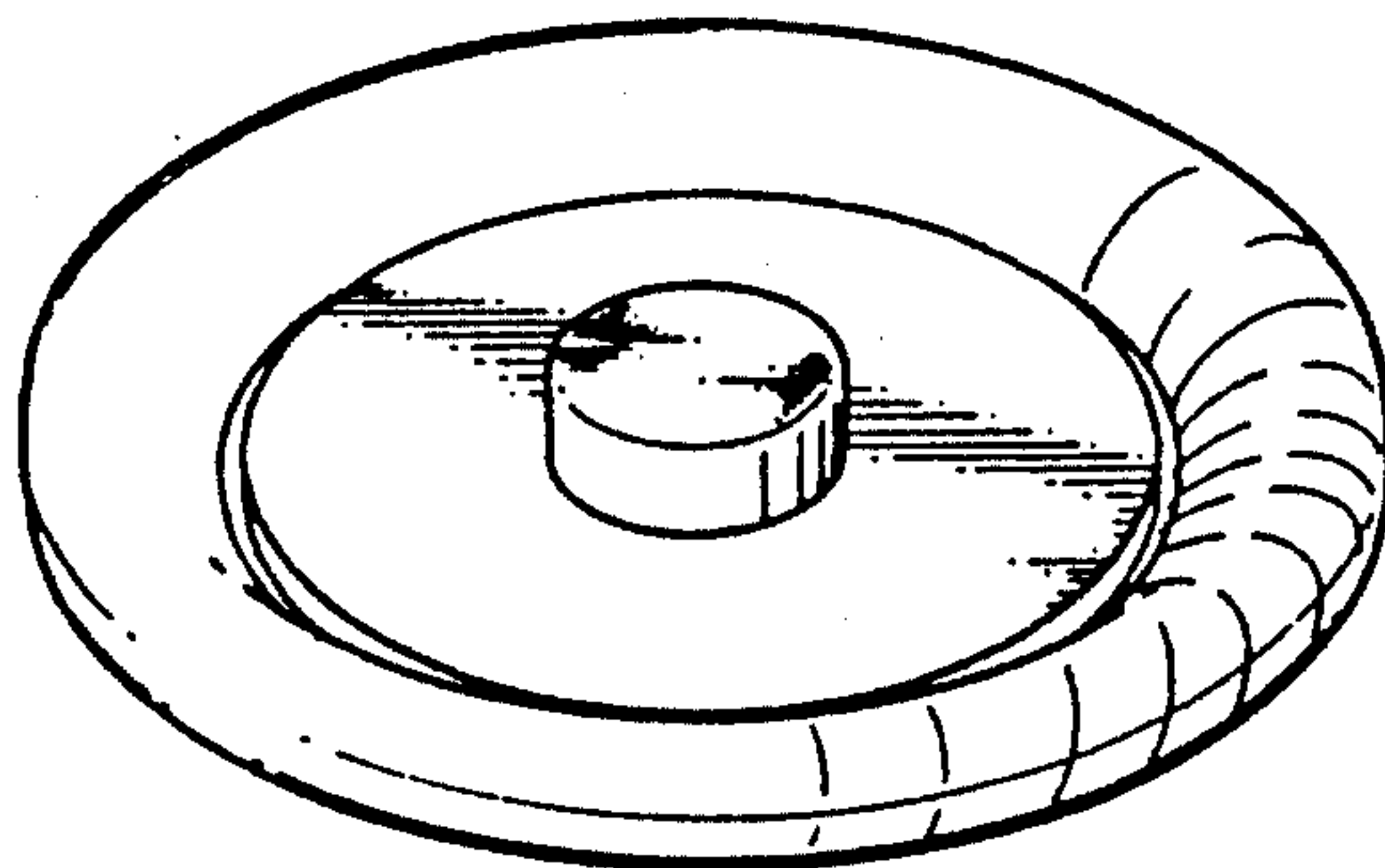

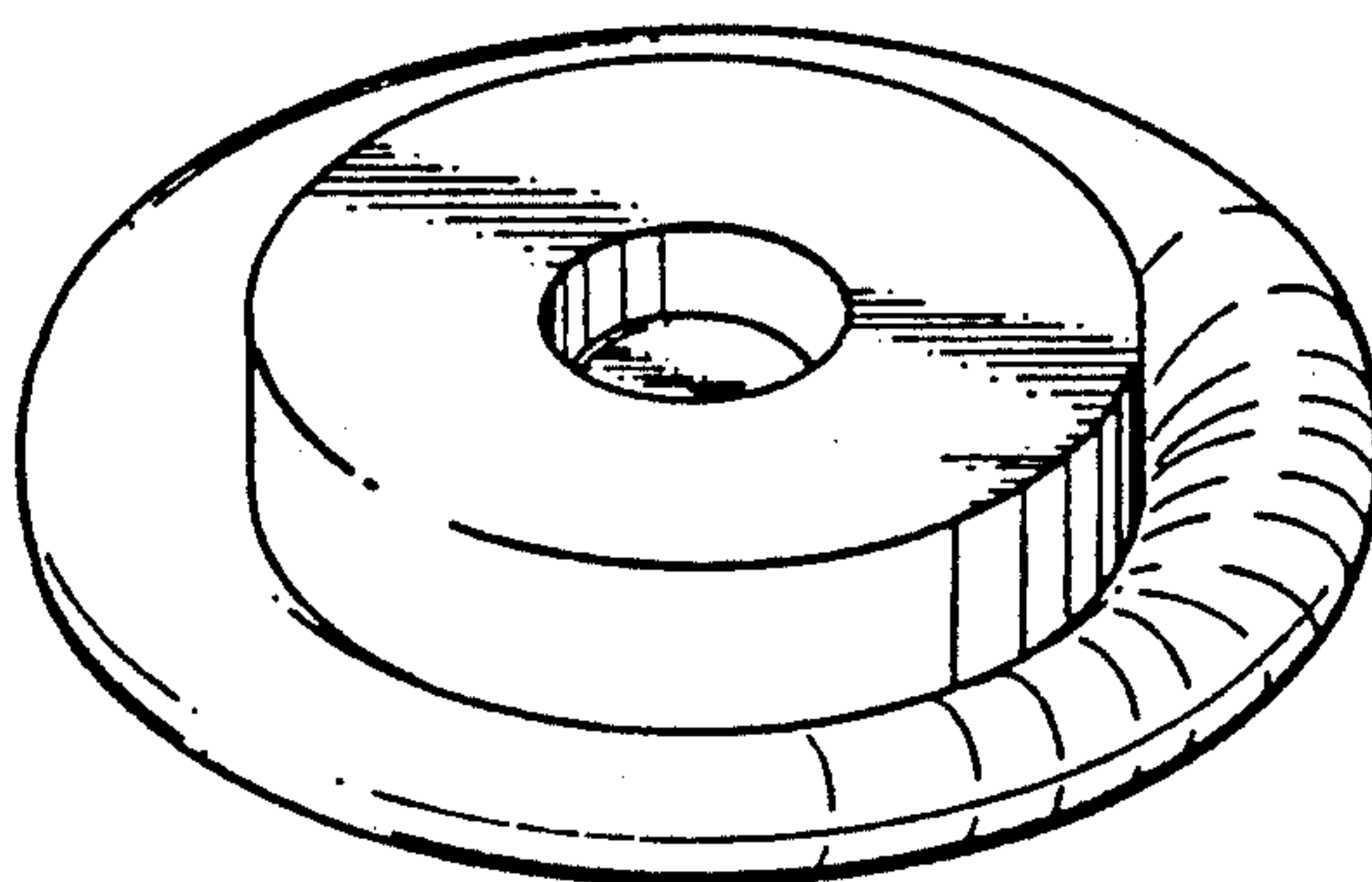

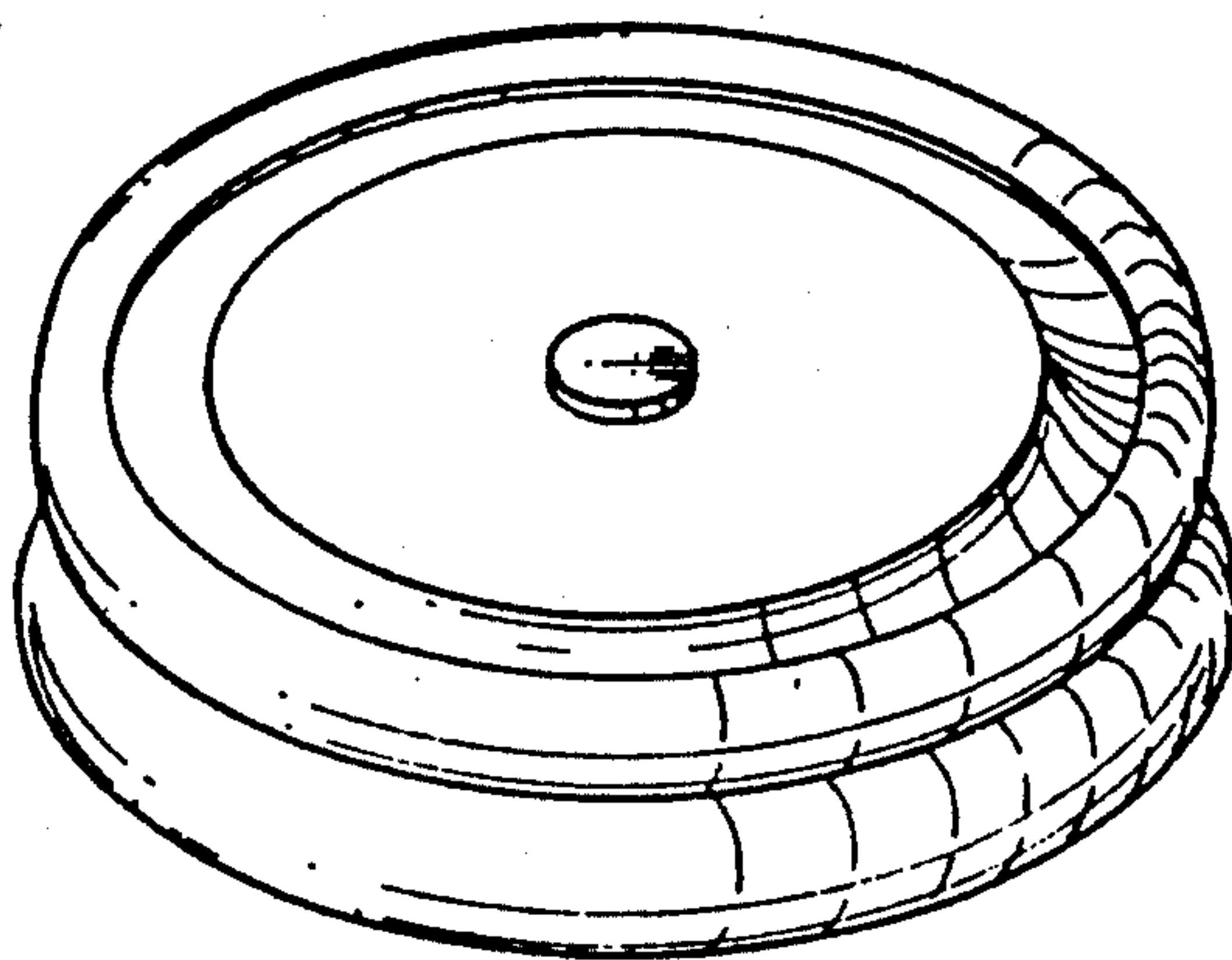
