DESCRIPTION

FIG. 1 is a front perspective view of a combination handset telephone stand showing our new design in cradled status;
FIG. 2 is a rear perspective view thereof from above;
FIG. 3 is a front and right side perspective view thereof from above;
FIG. 4 is a left side and front perspective view thereof from above; and
FIG. 5 is virtually a rear elevational view of the handset telephone shown above.

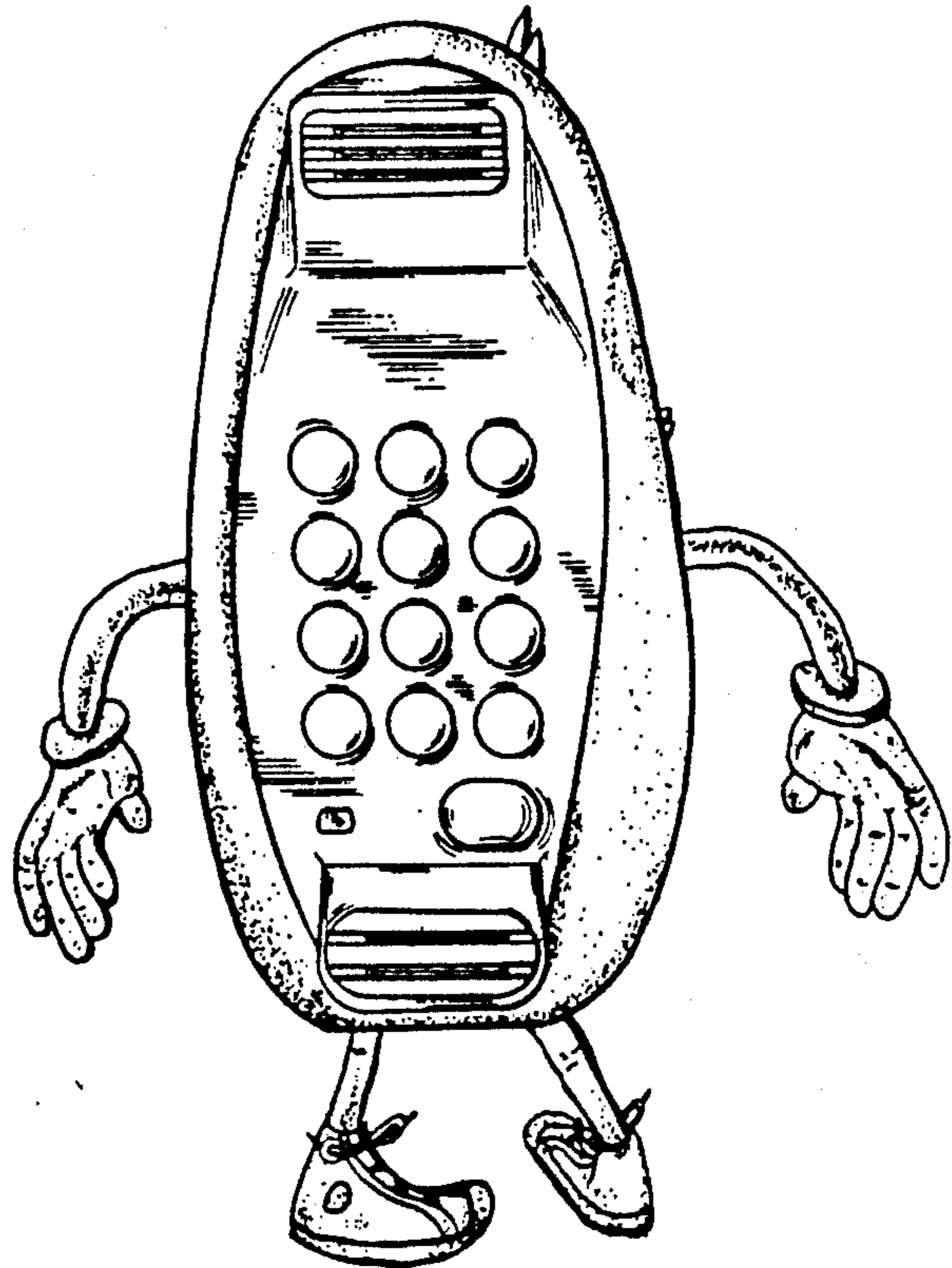
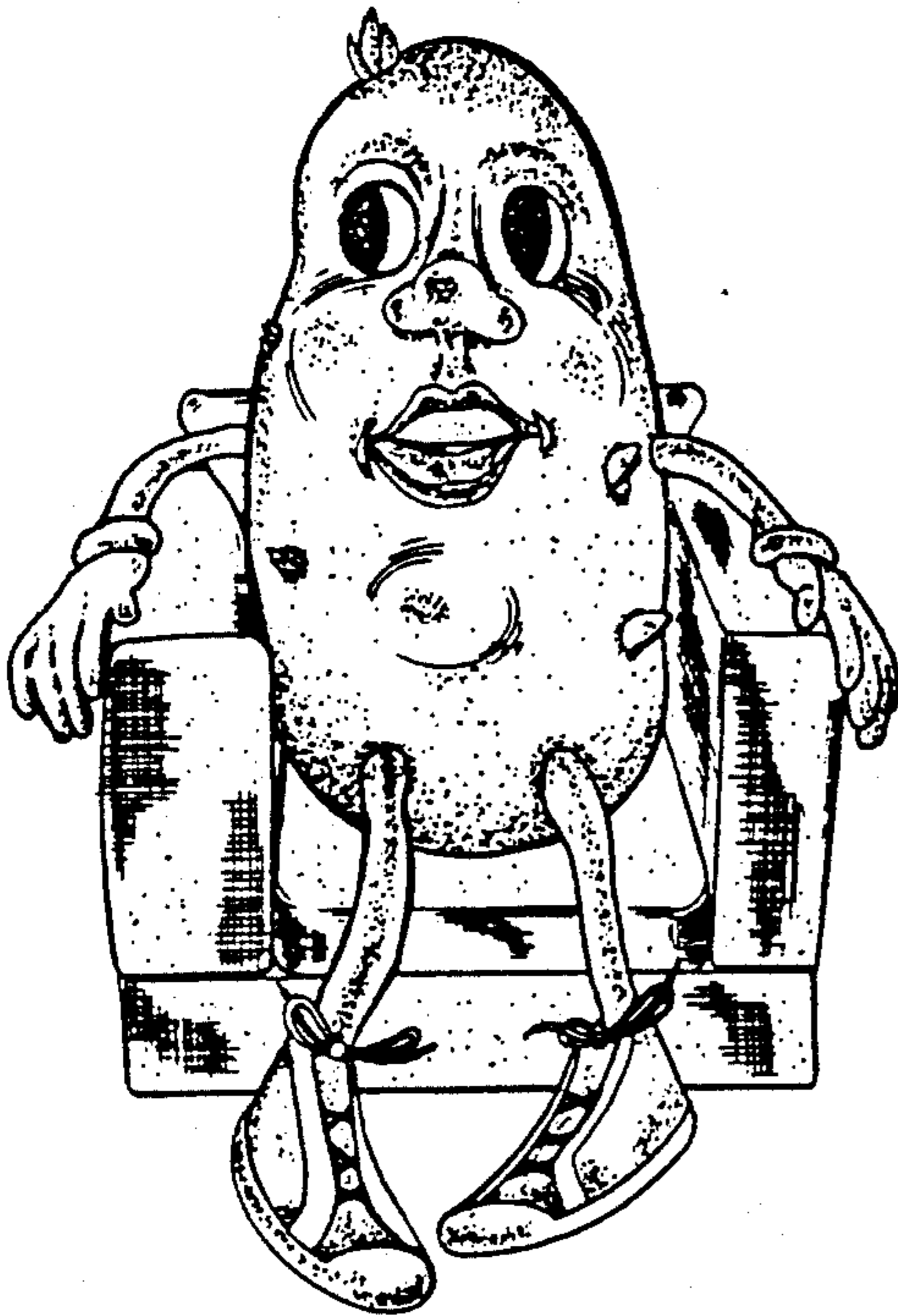

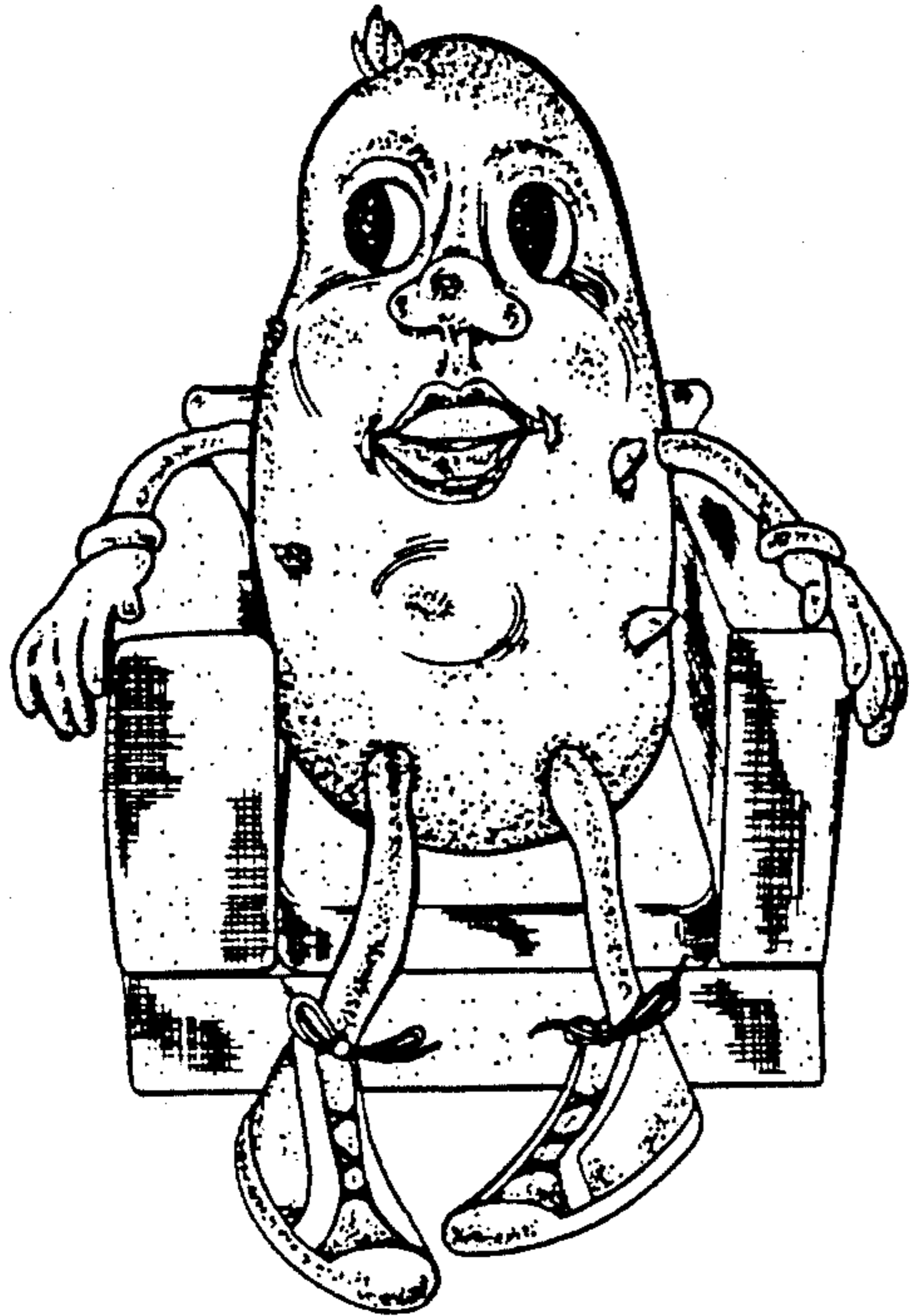

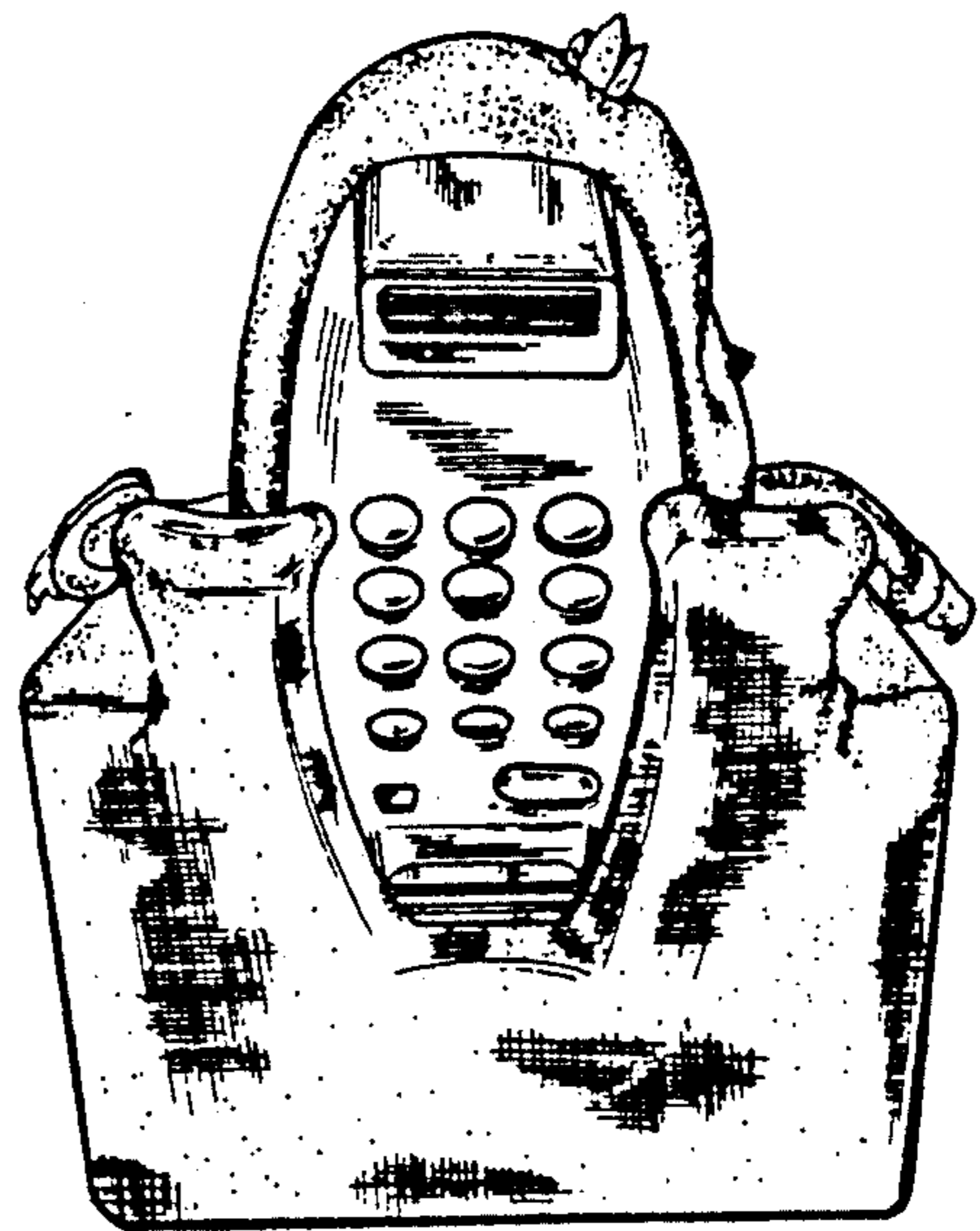
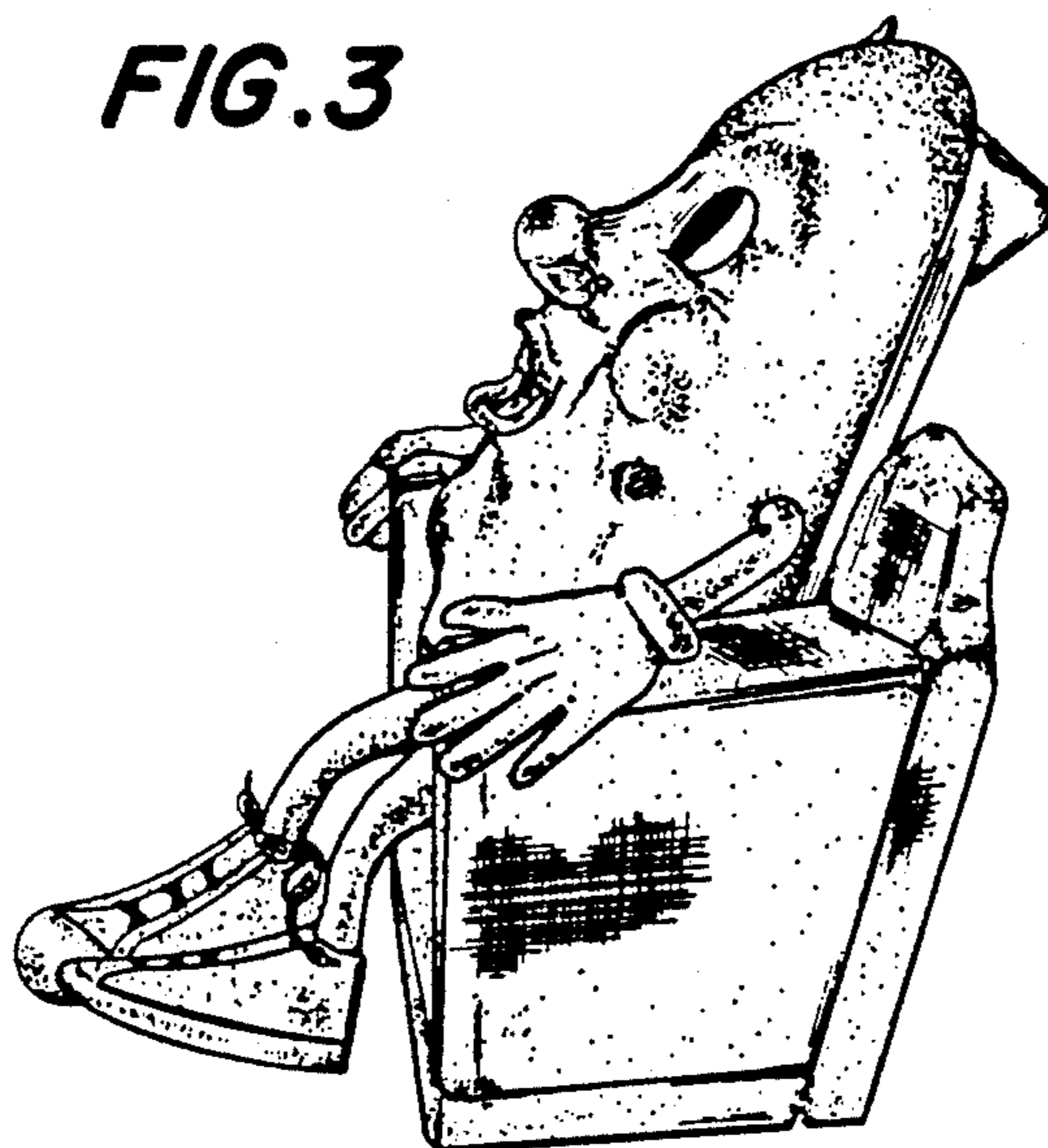

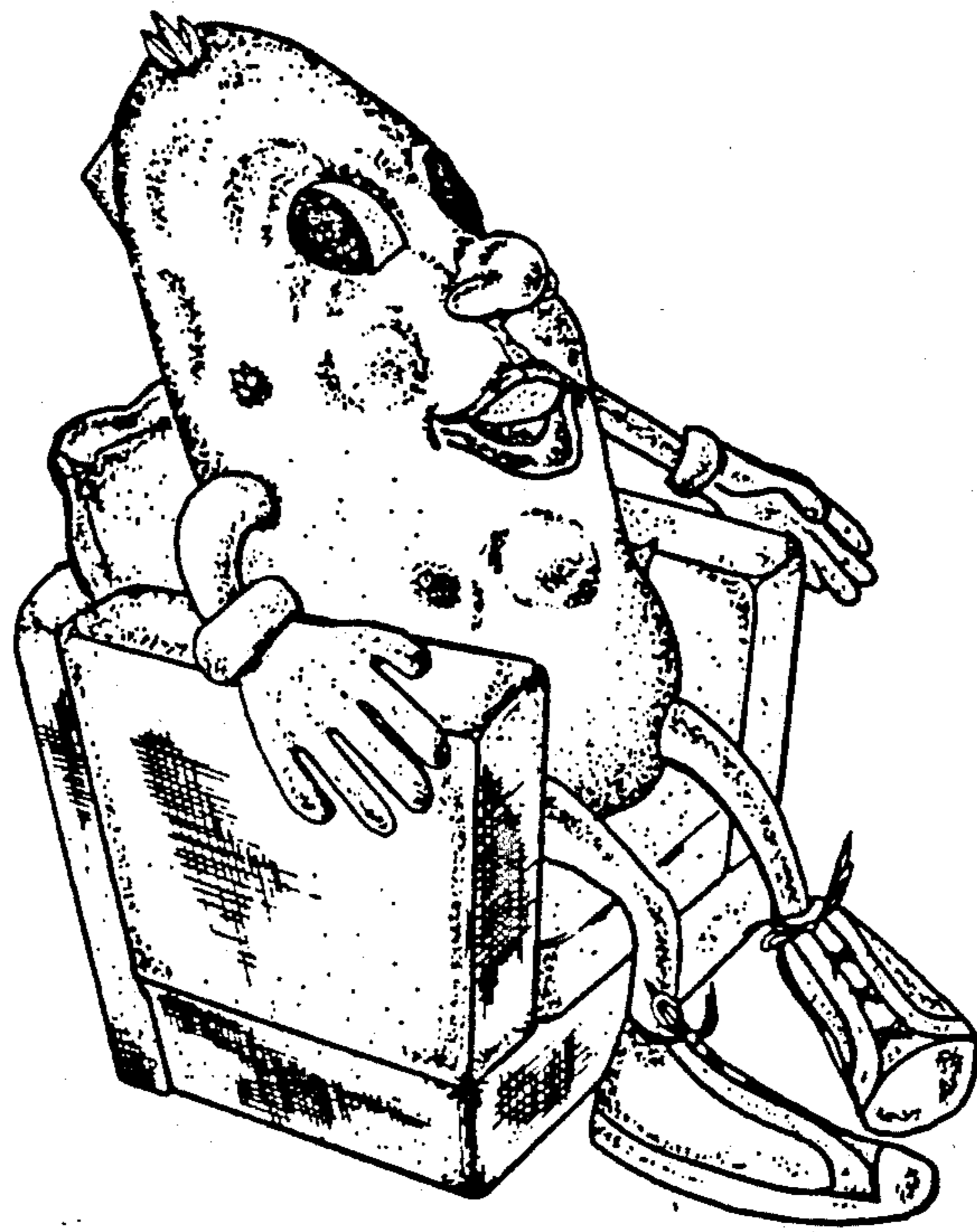

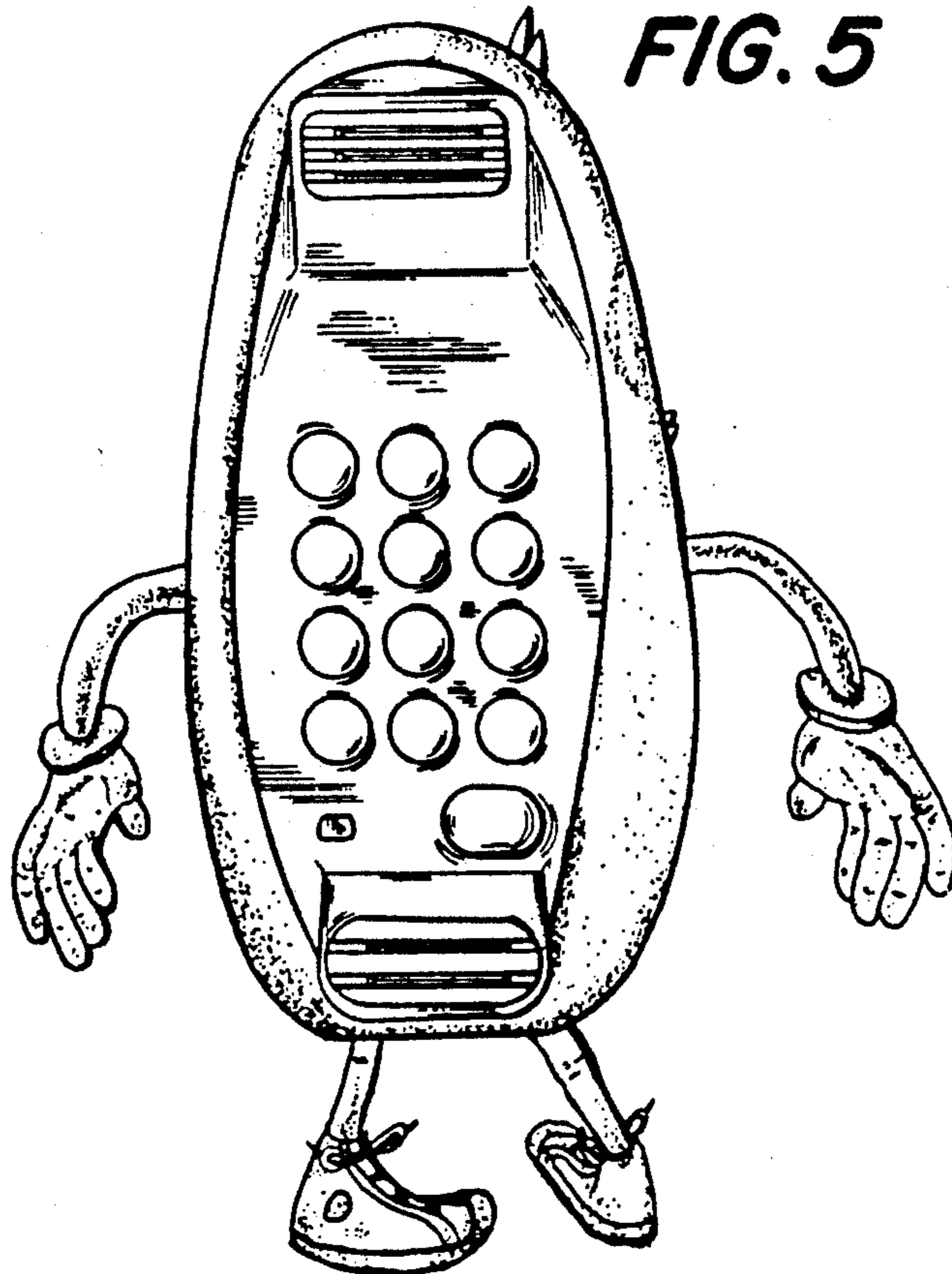
