[57] CLAIM

The ornamental design for an umbrella handle, as shown and described.

DESCRIPTION

FIG. 1 is a front elevational view of an umbrella handle showing my new design;

FIG. 2 is a right side elevational view of the handle shown in FIG. 1, the left side view being a mirror image thereof;

FIG. 3 is a rear elevational view of the handle shown in FIG. 1;

FIG. 4 is a bottom plan view of the handle shown in FIG. 1;

FIG. 5 is a top plan view of the handle shown in FIG. 1;


FIG. 6 is a front elevational view of an umbrella handle showing a modified form of my new design having no wrist strap;

FIG. 7 is a right side elevational view of the handle shown in FIG. 6, the left side view being a mirror image thereof;

FIG. 8 is a rear elevational view of the handle shown in FIG. 6;

FIG. 9 is a bottom plan view of the handle shown in FIG. 6; and

FIG. 10 is a top plan view of the handle shown in FIG. 6.






















