 FIG. 6 is a back side elevational view thereof.

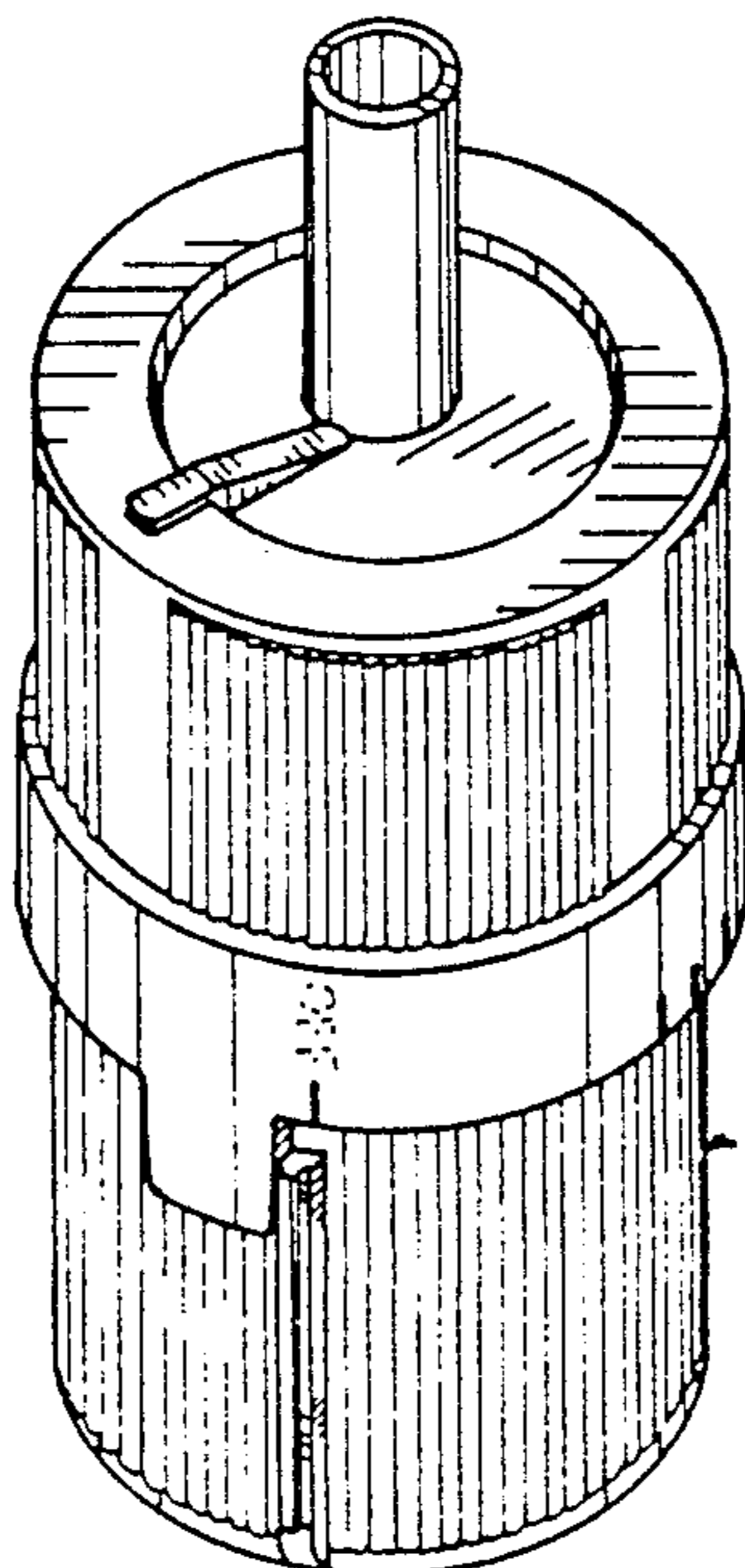

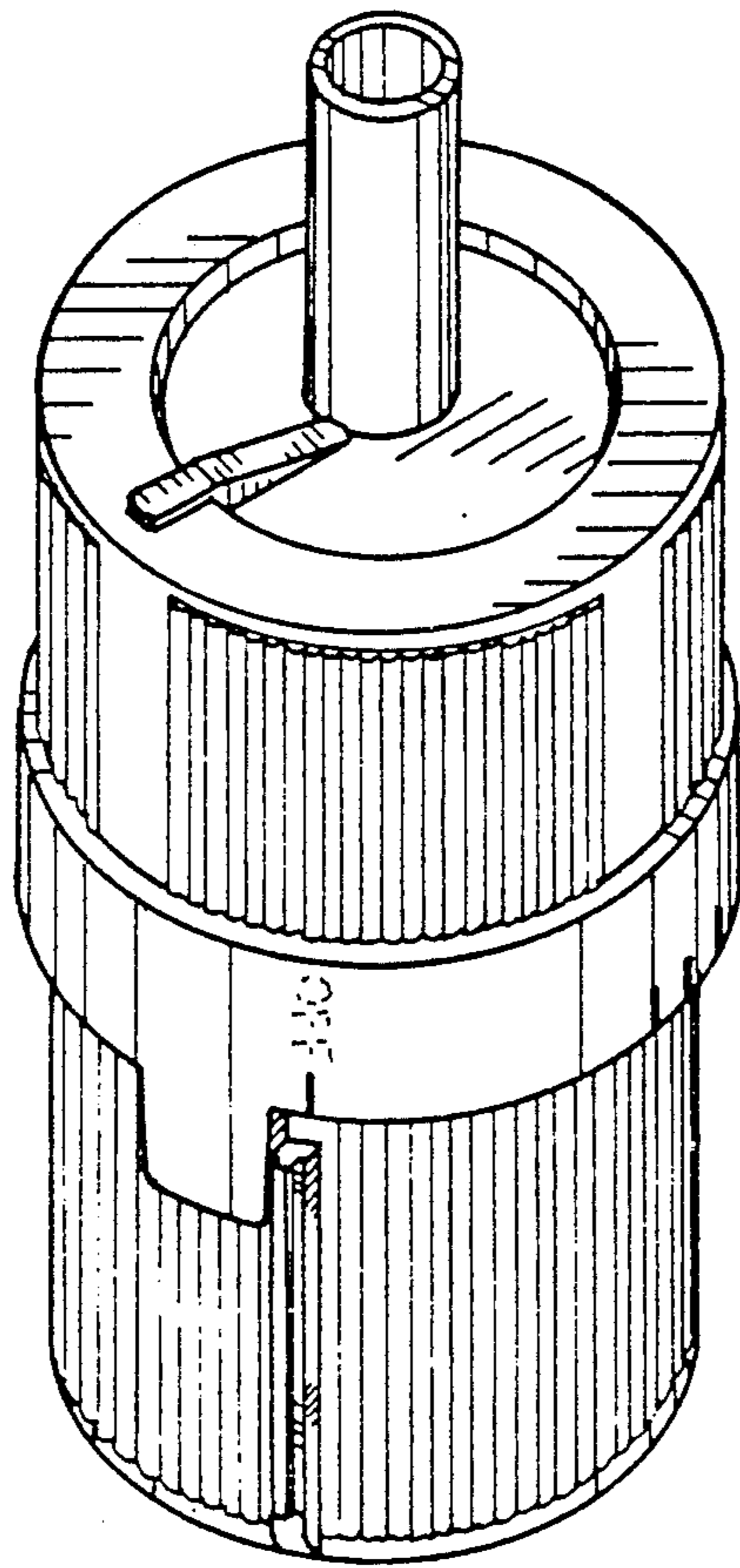

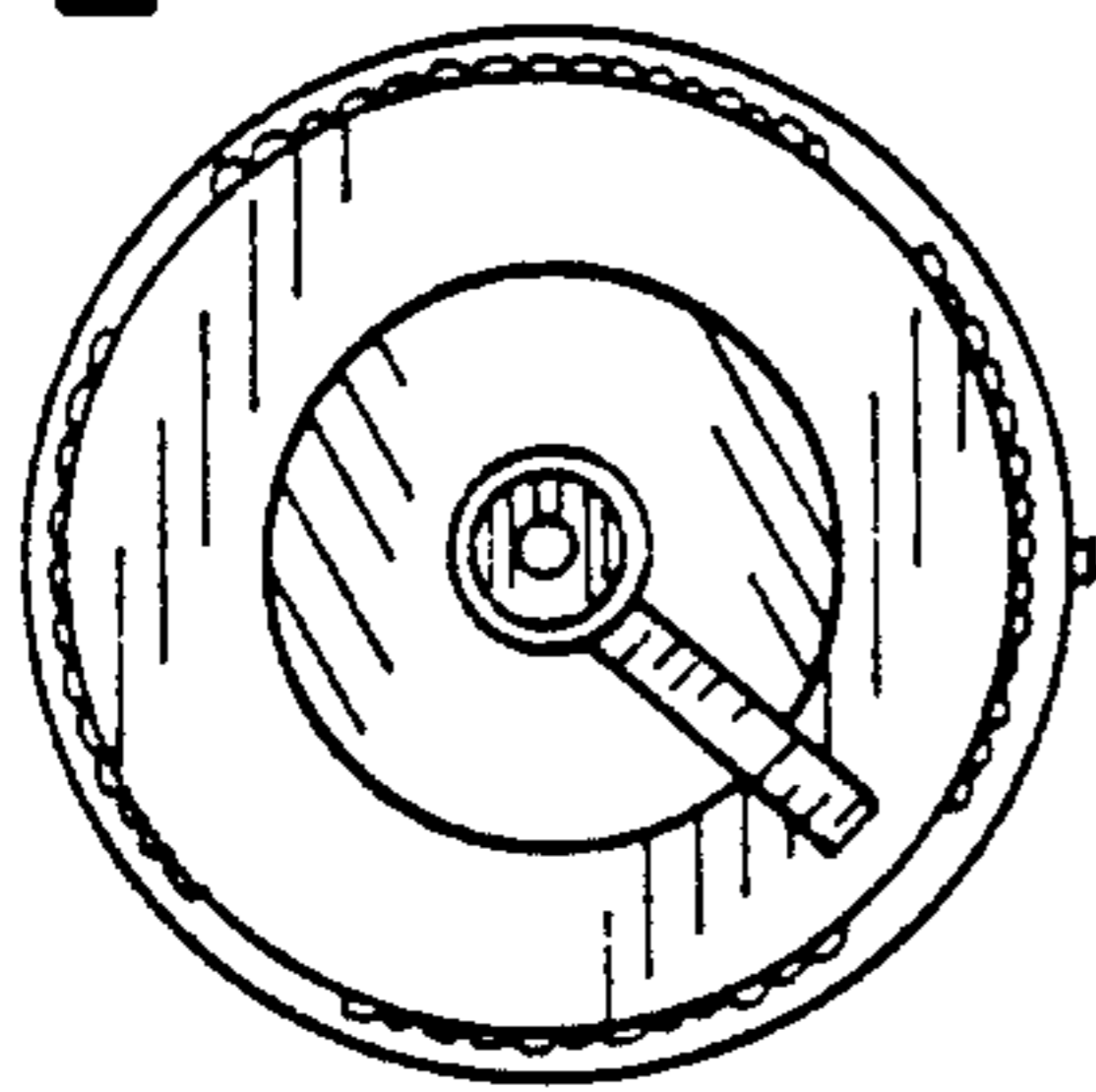

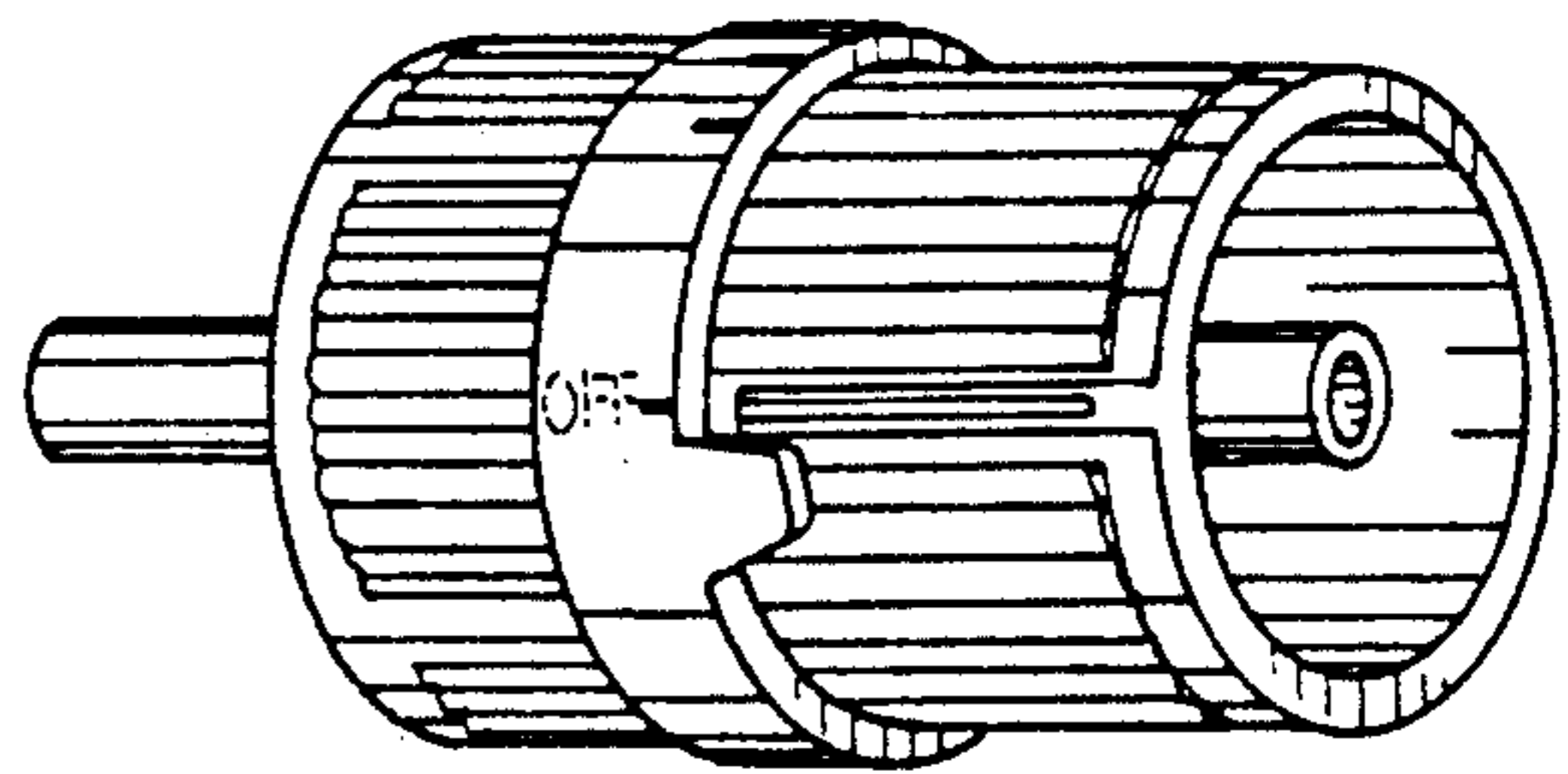

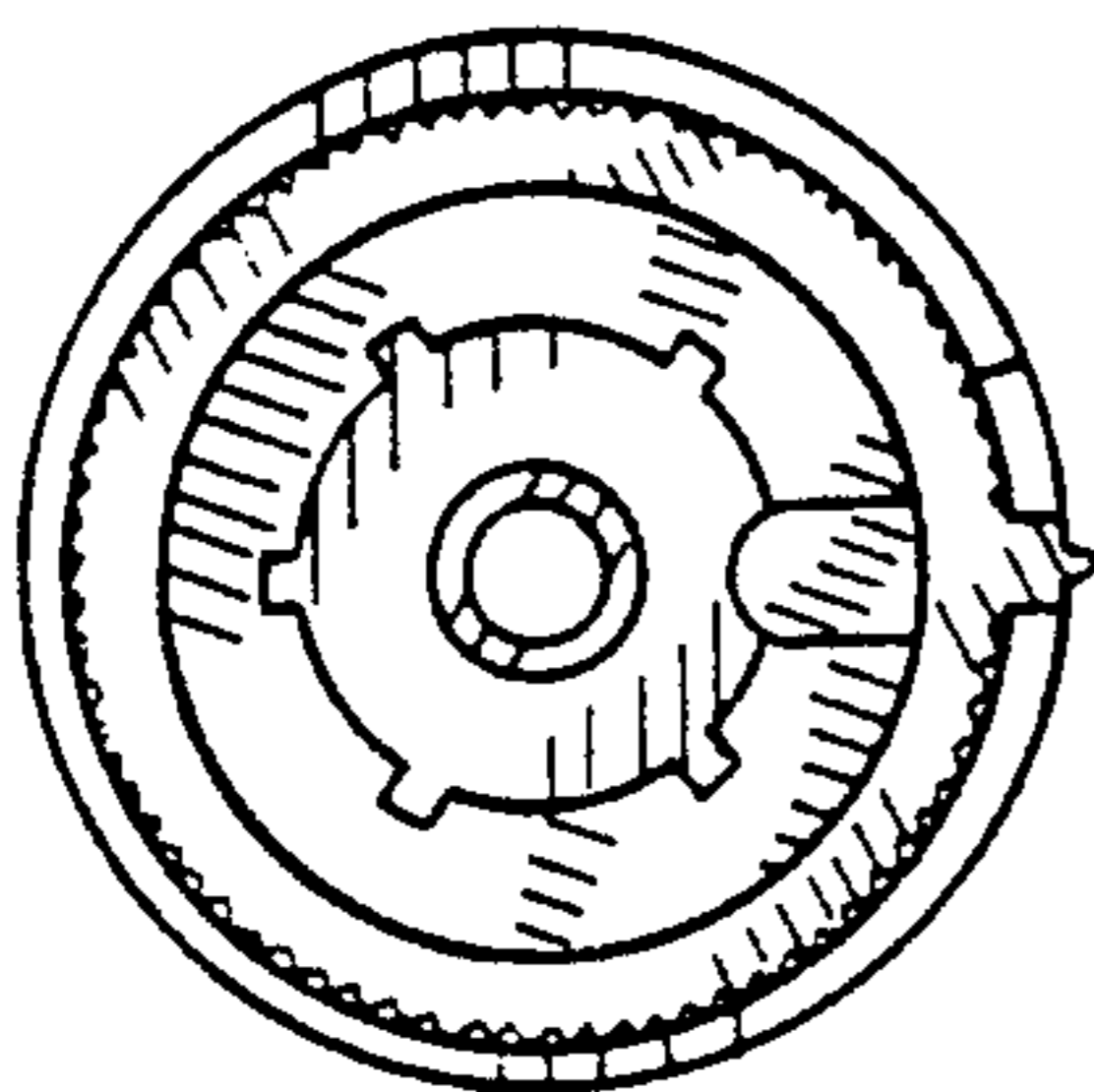
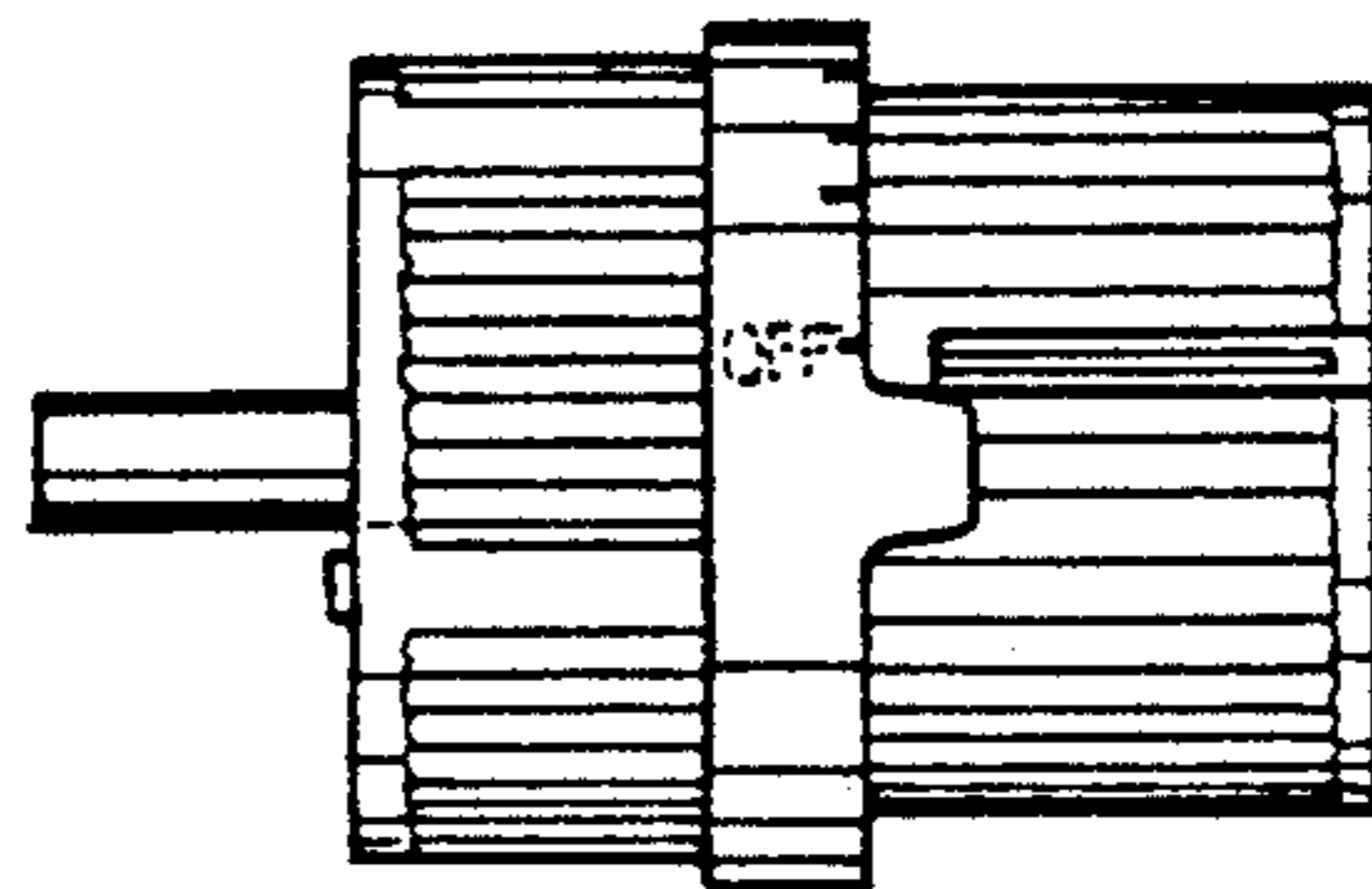

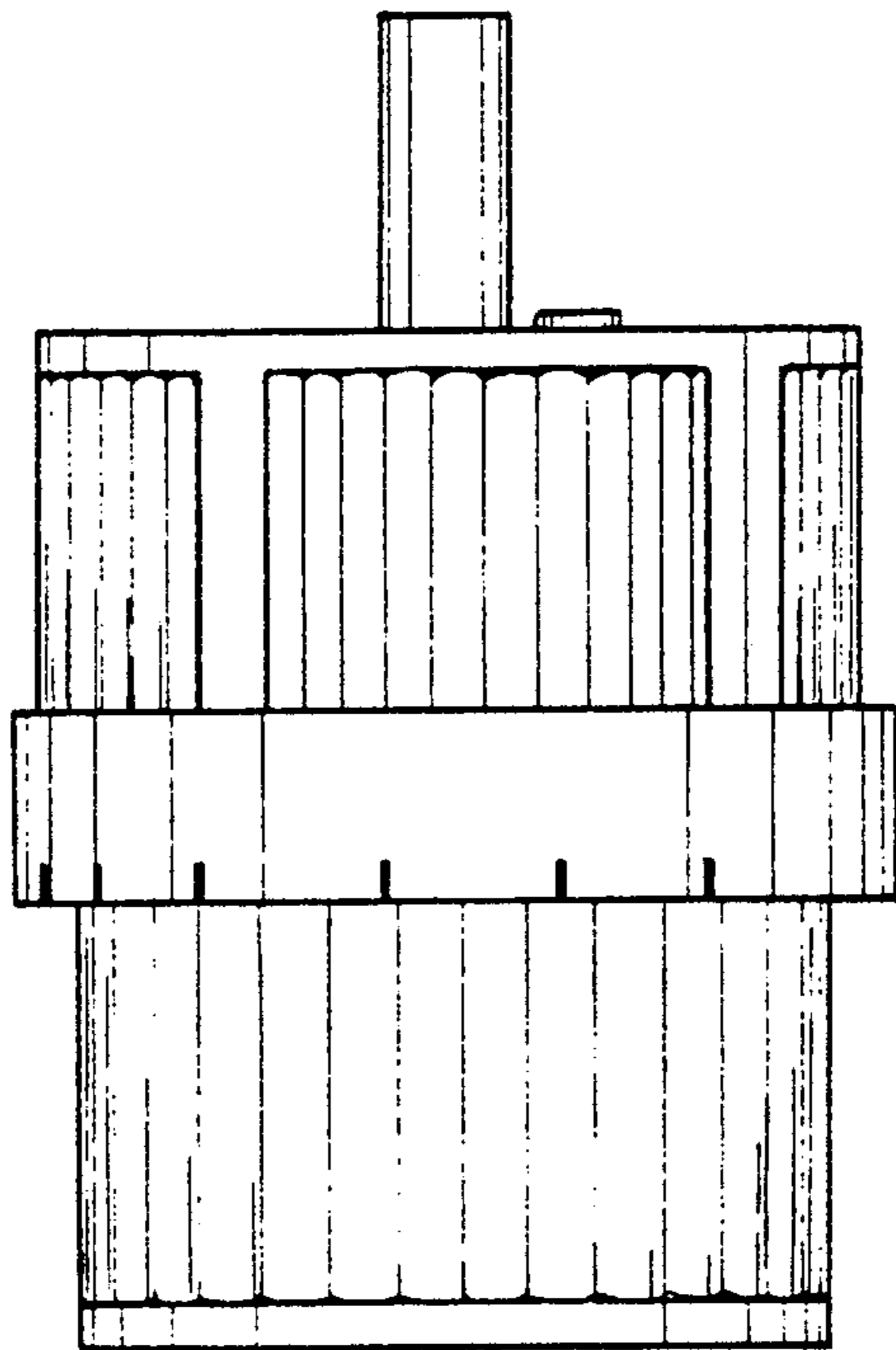
