DESCRIPTION

FIG. 1 is a front perspective view of a clock showing our new design;

FIG. 14 is a bottom plan view thereof.

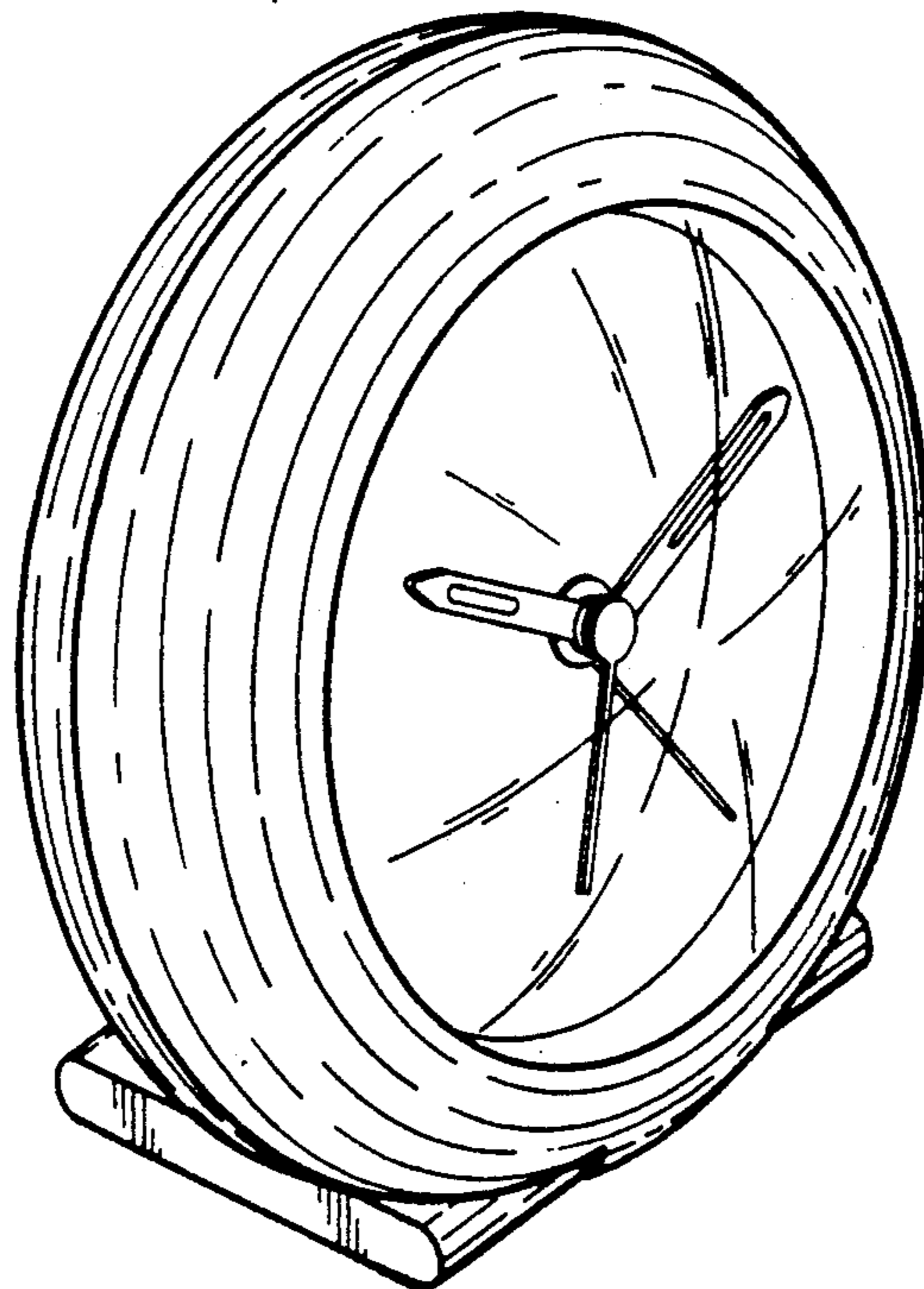
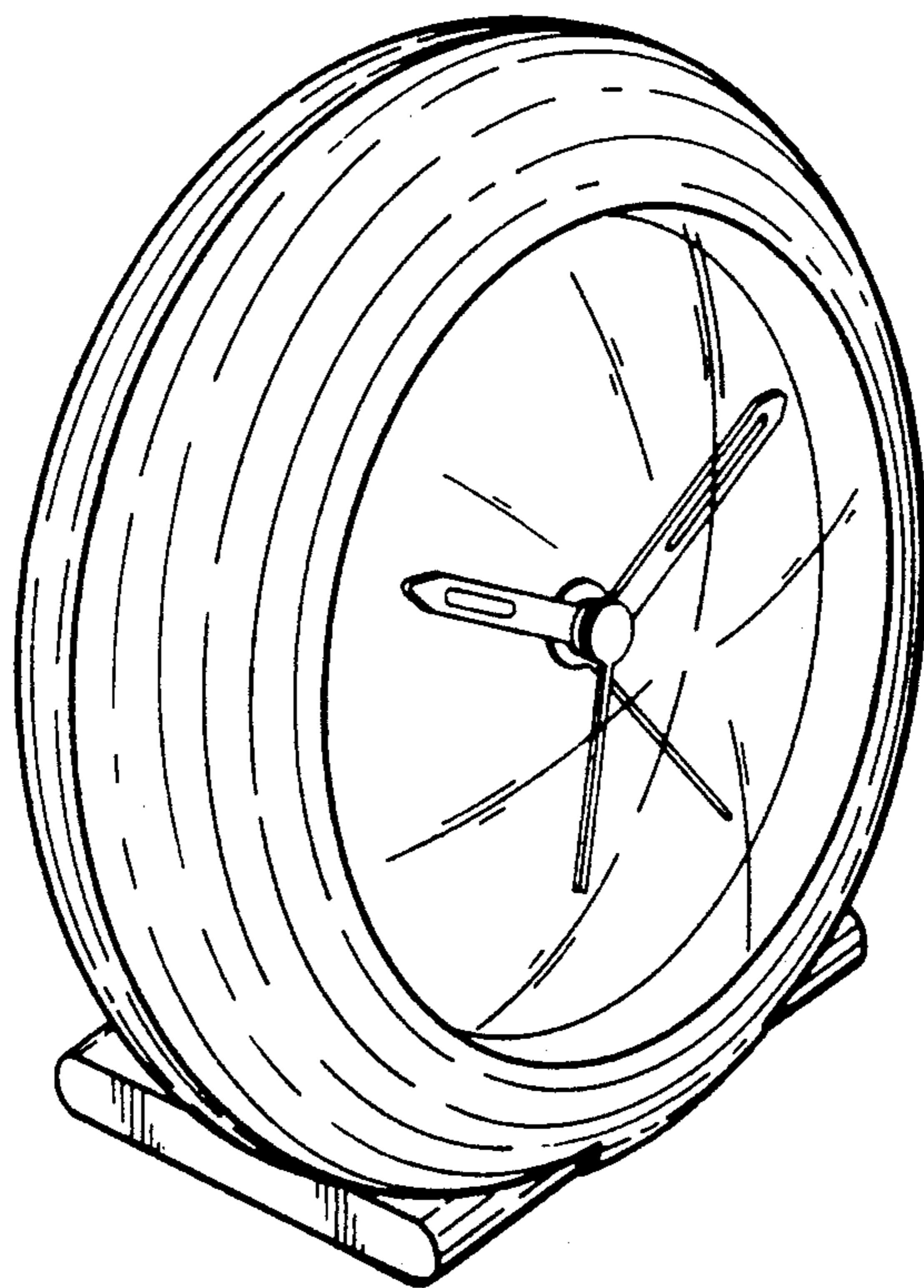

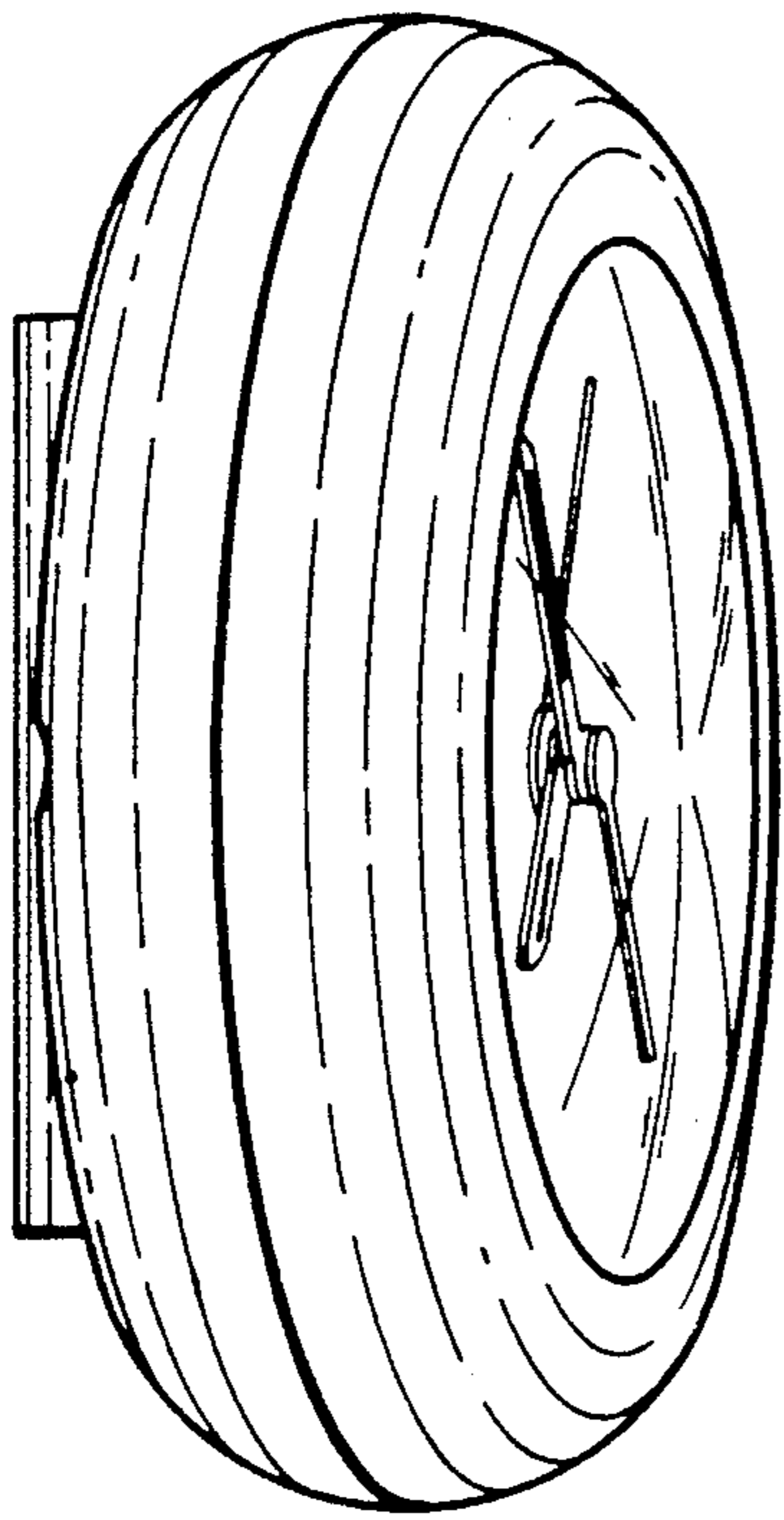

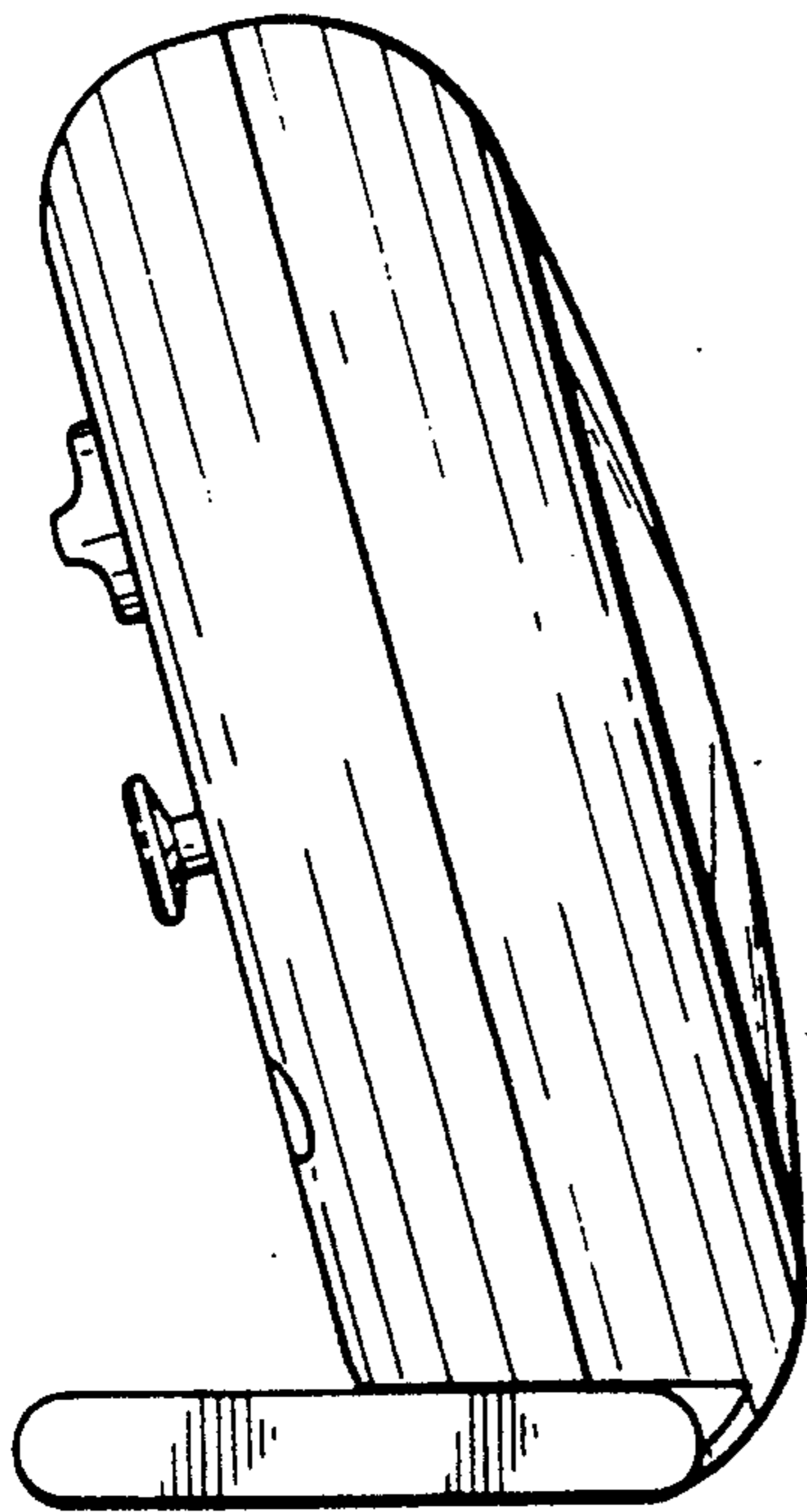

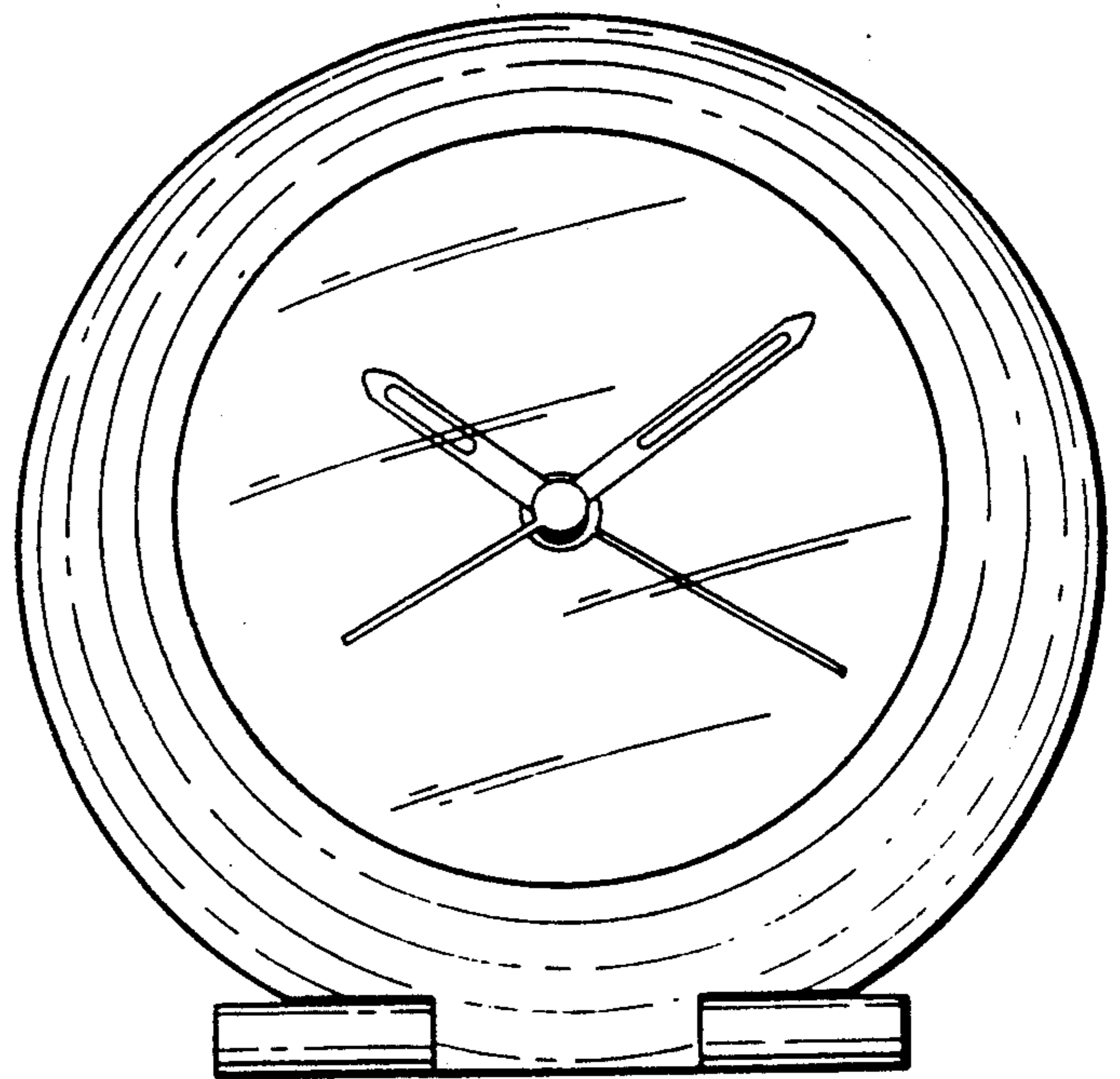

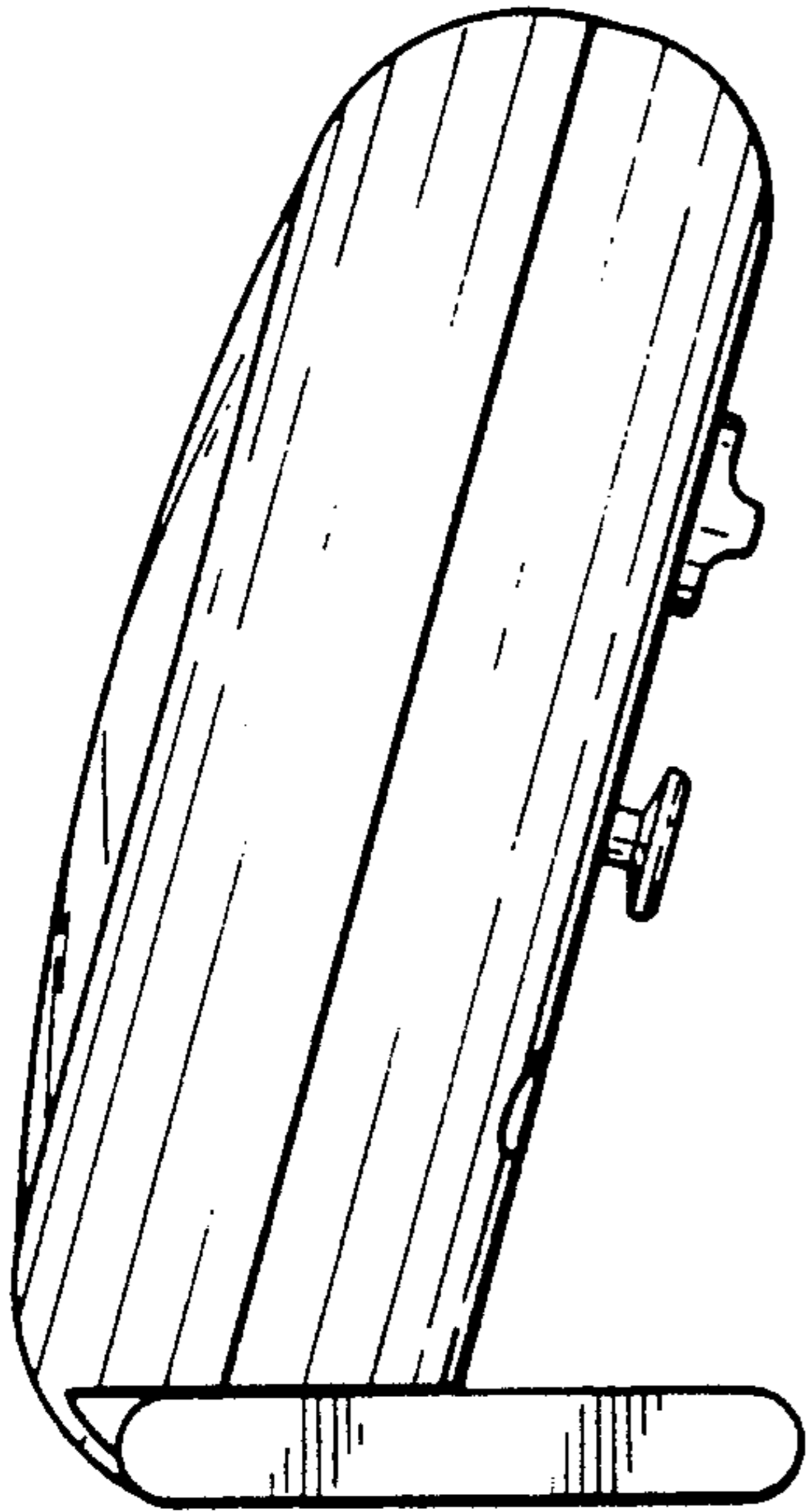

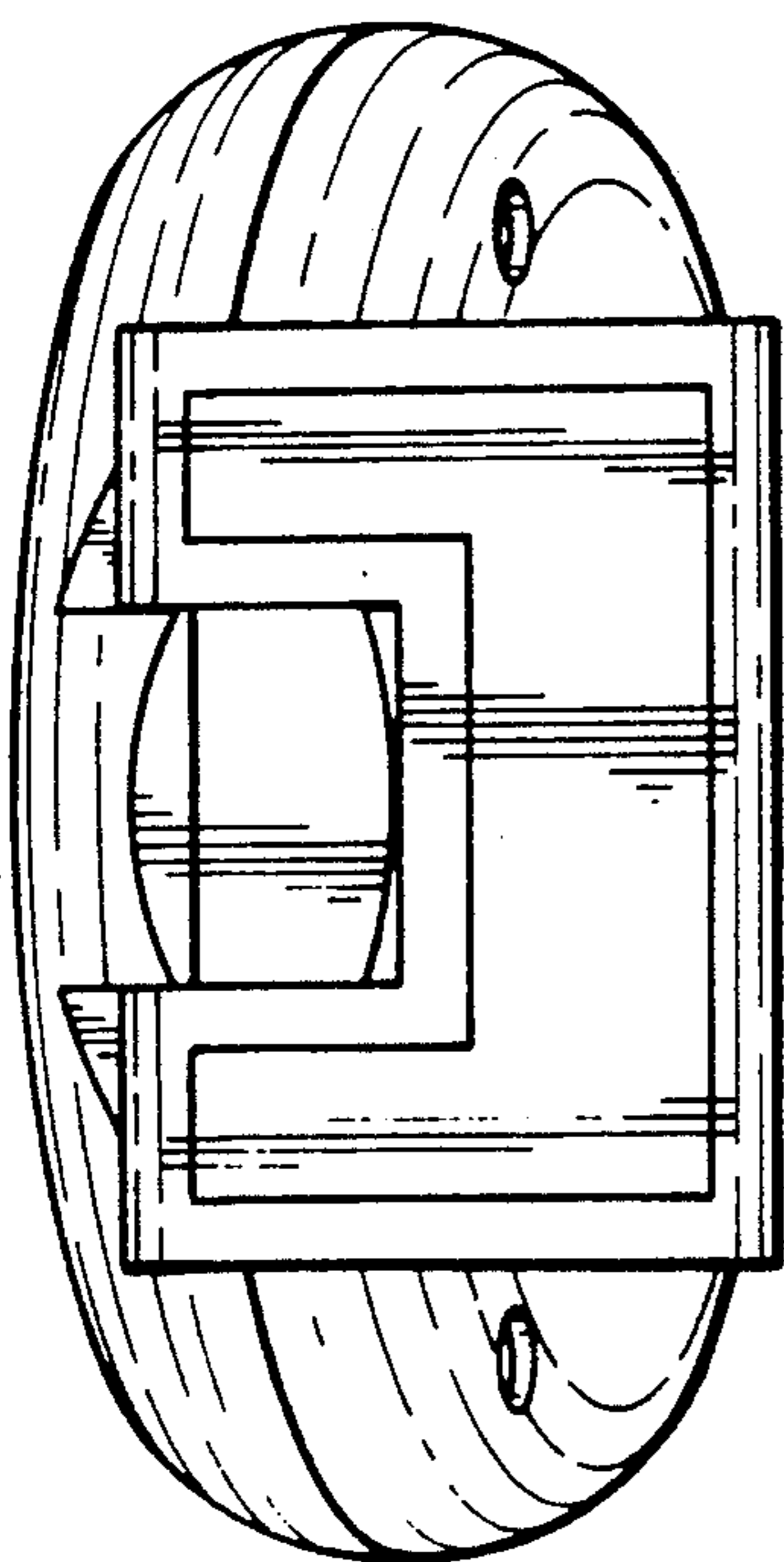
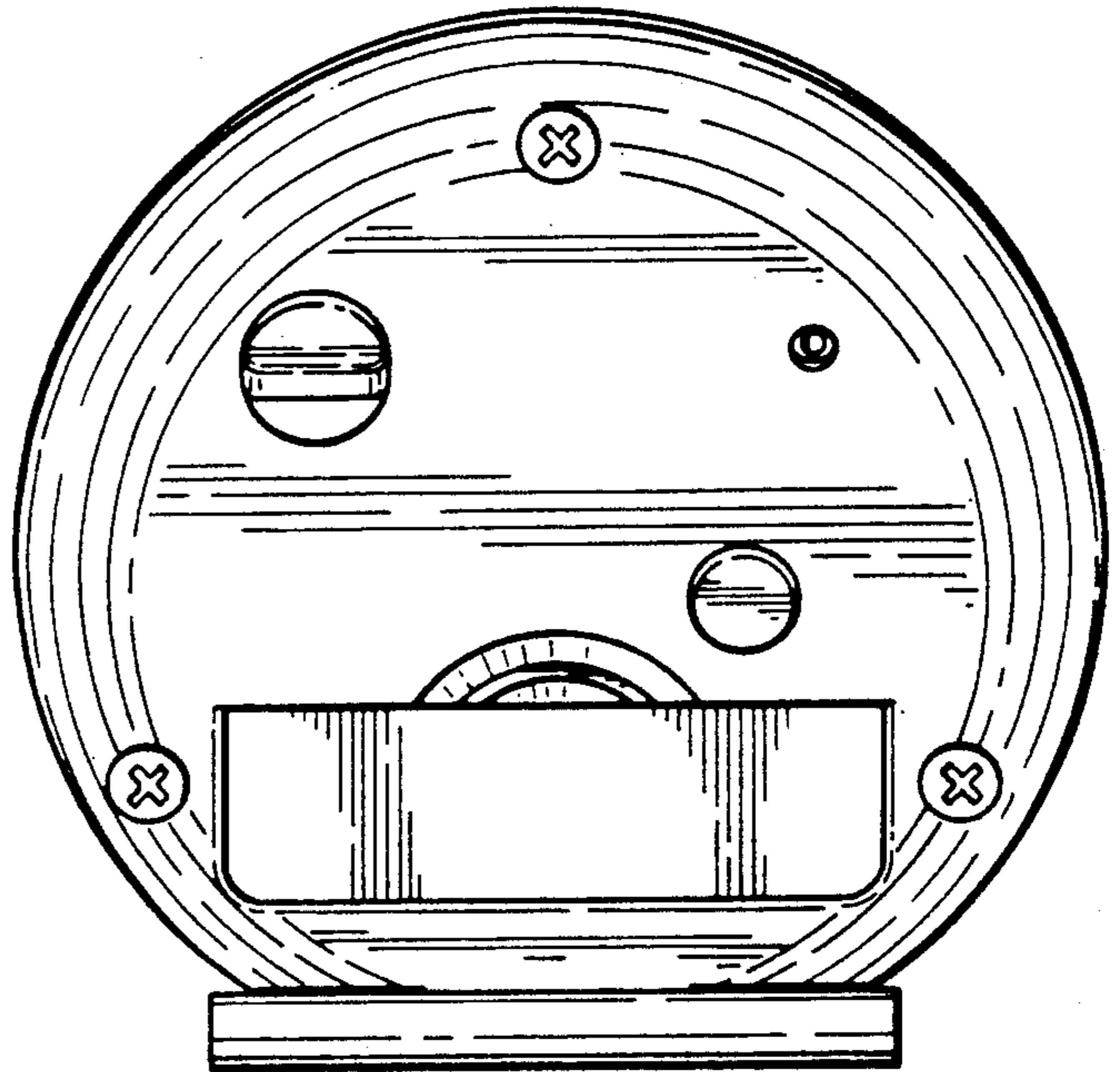
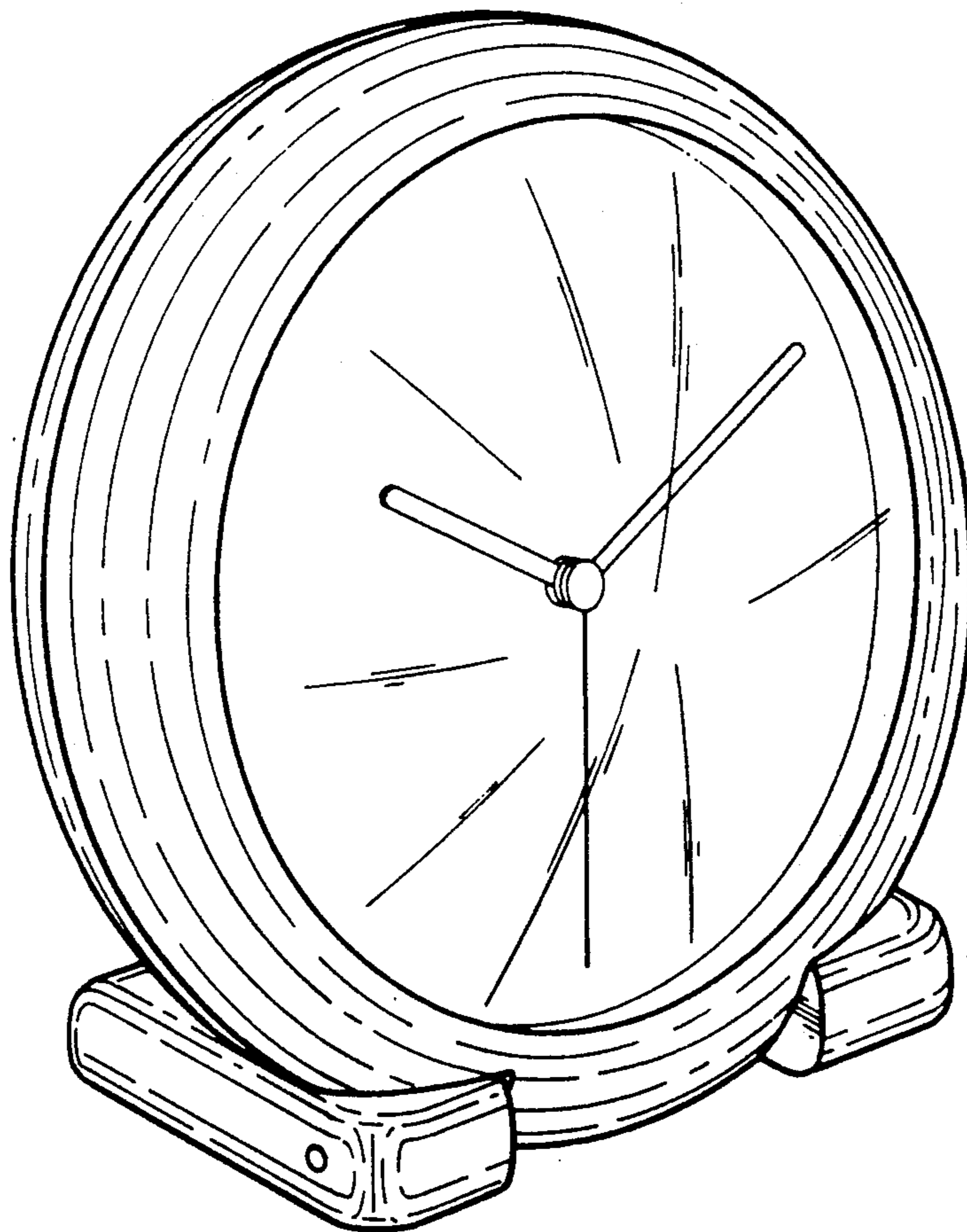

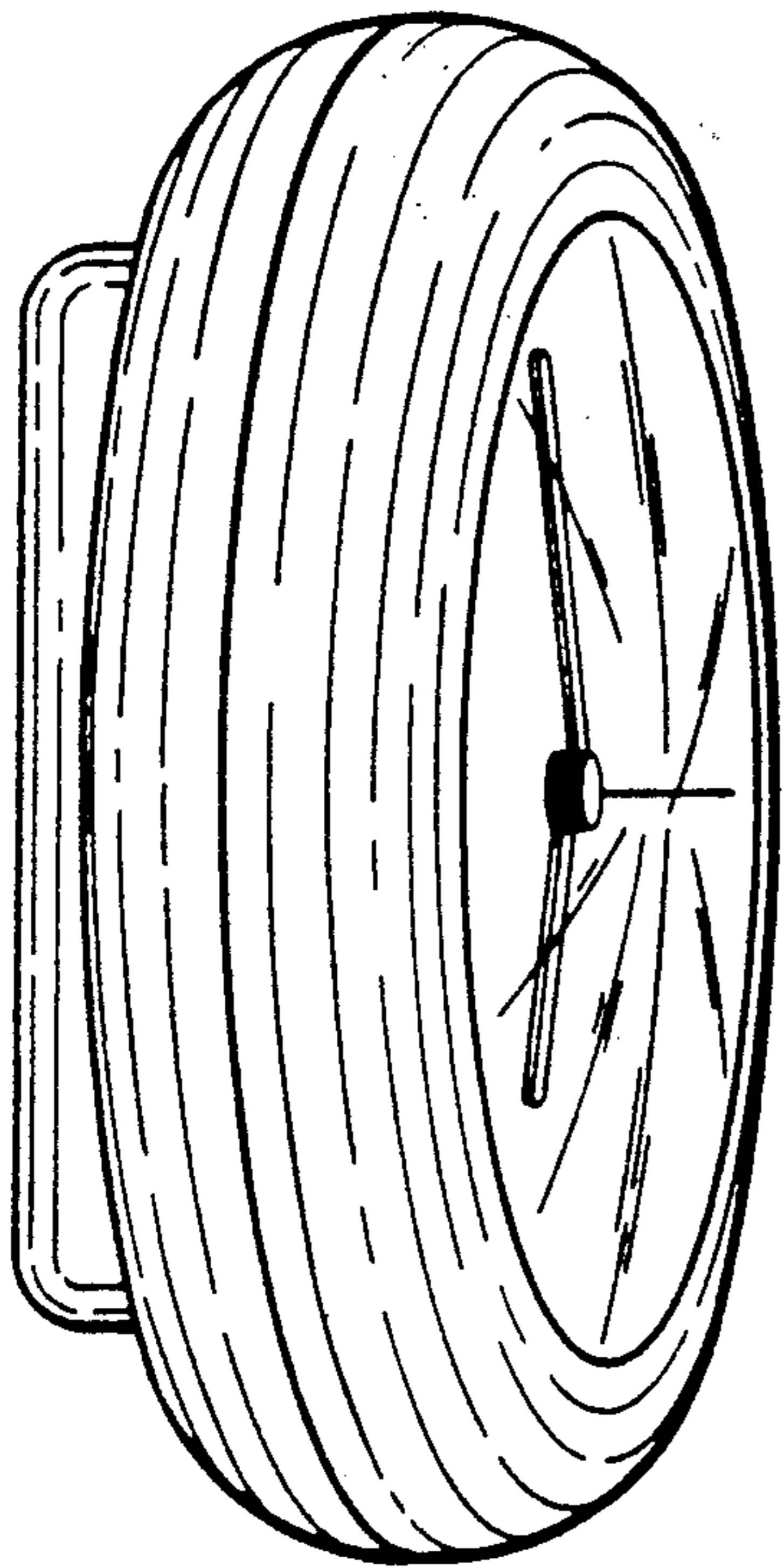

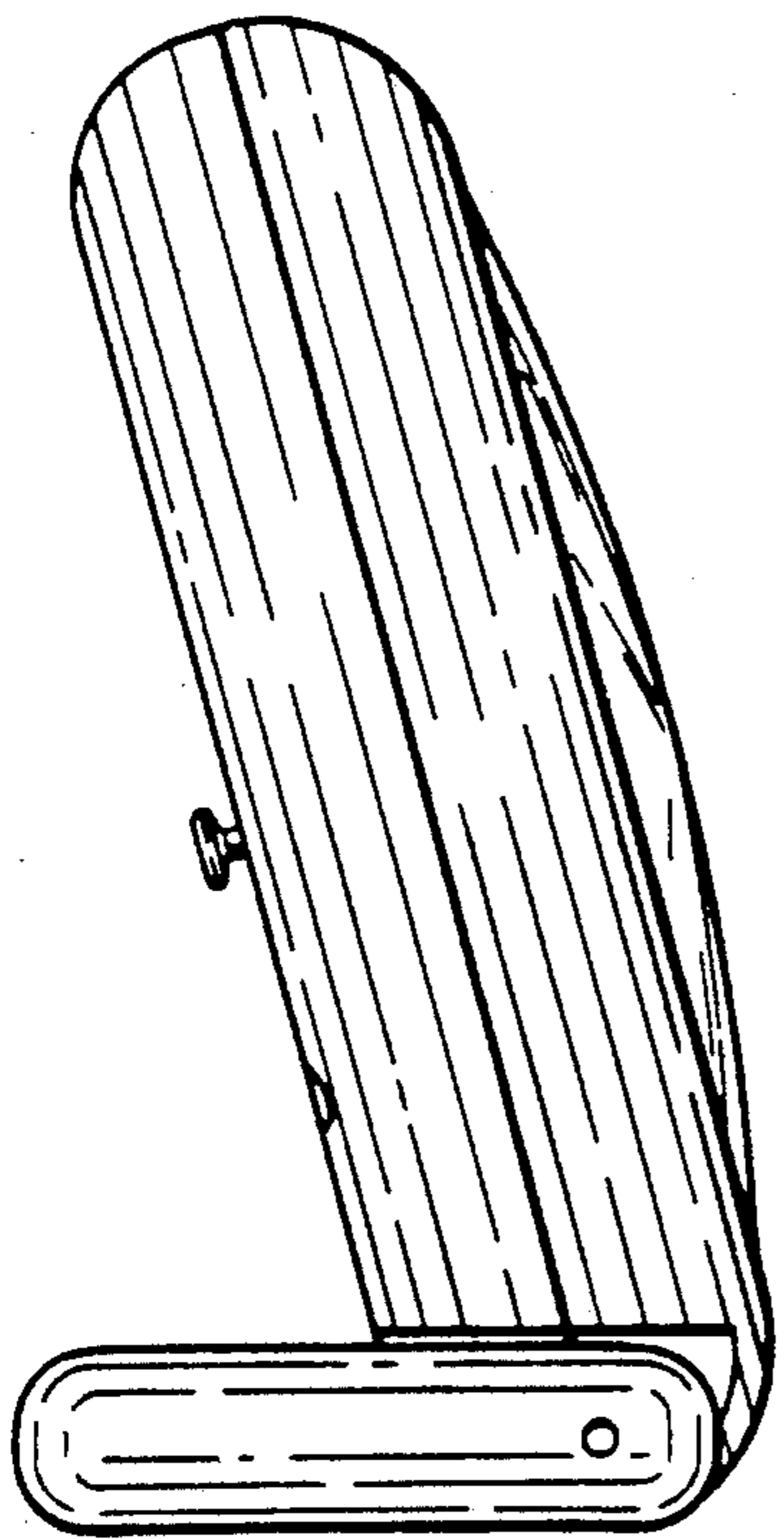
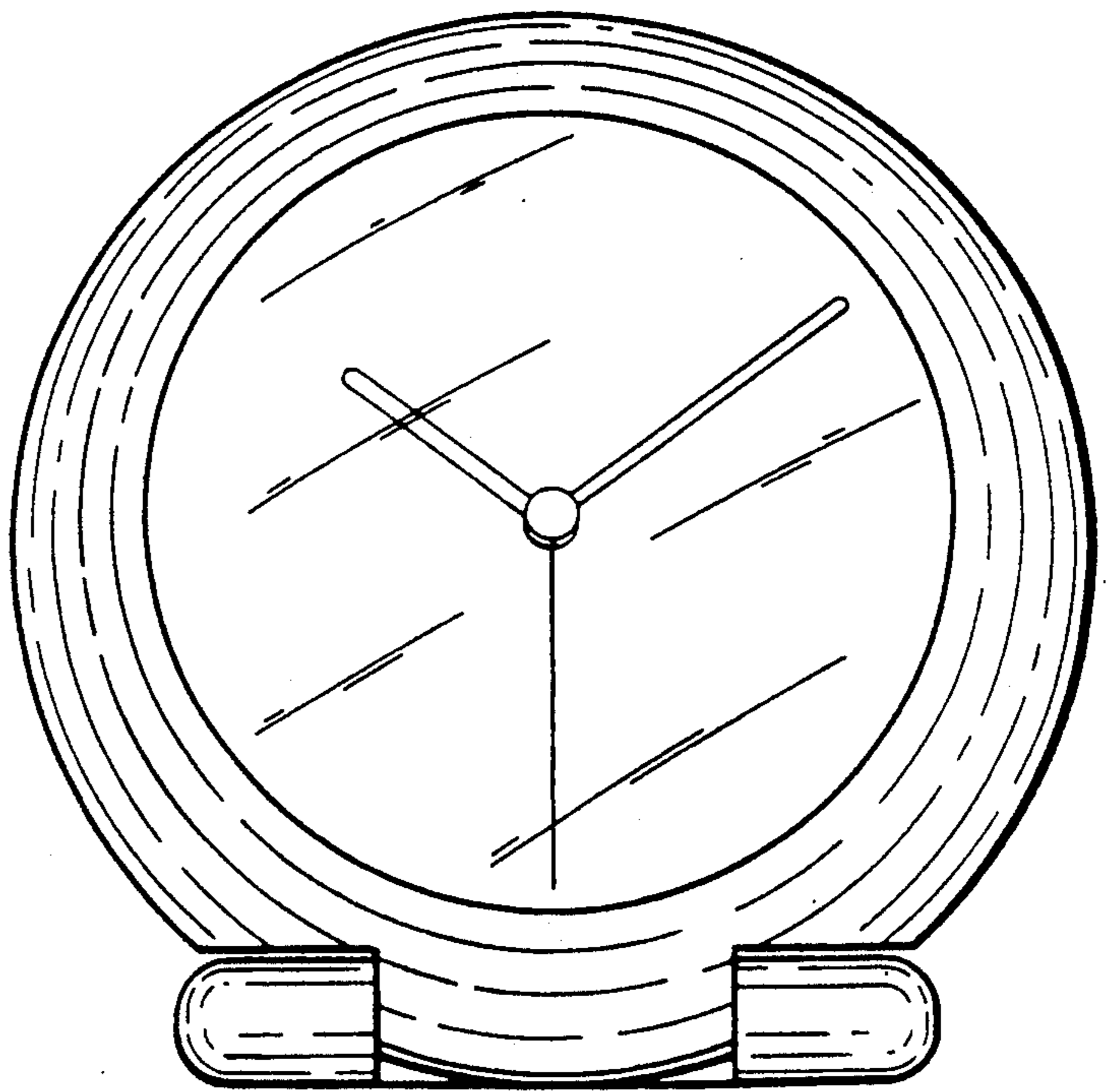

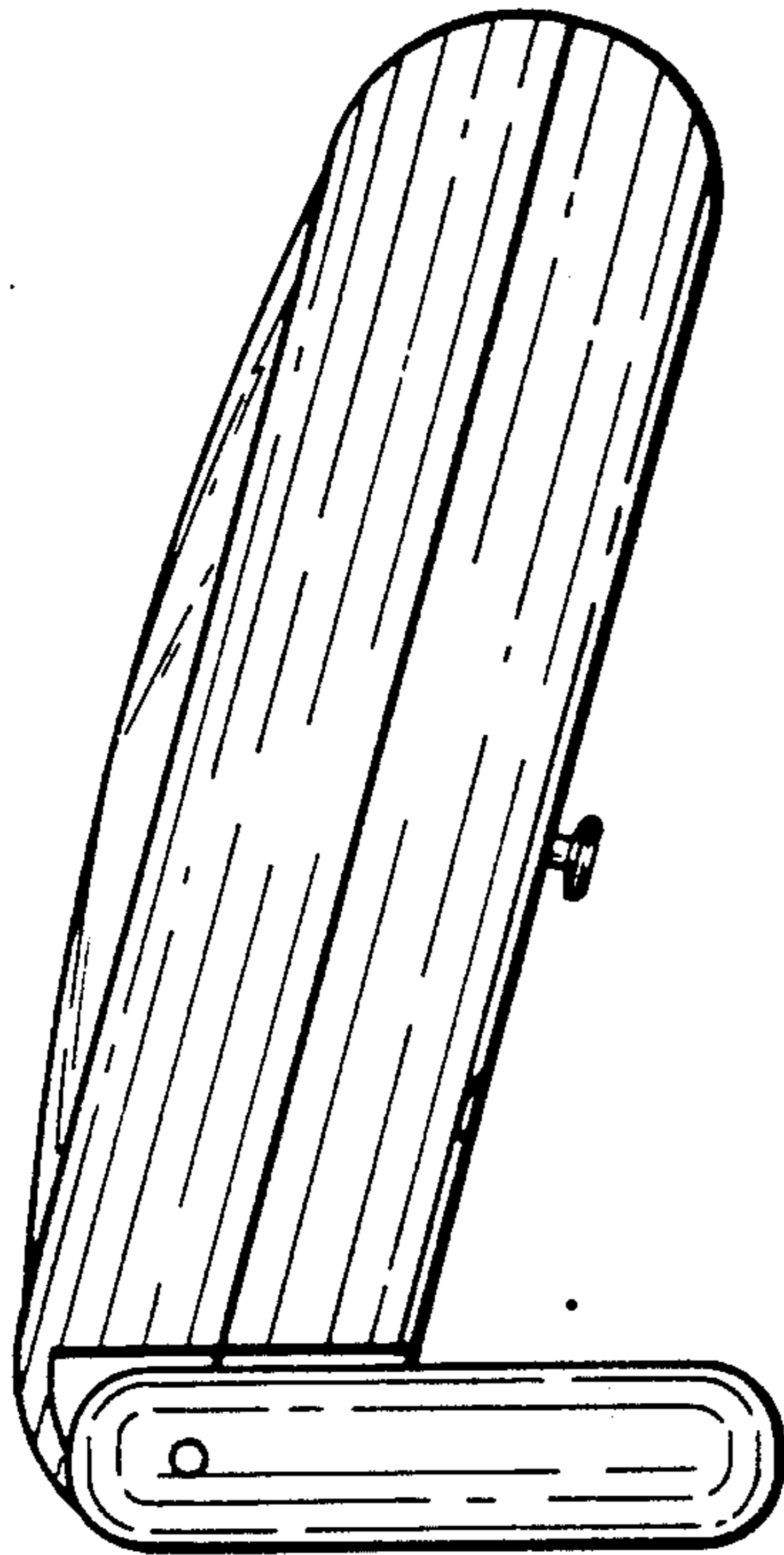

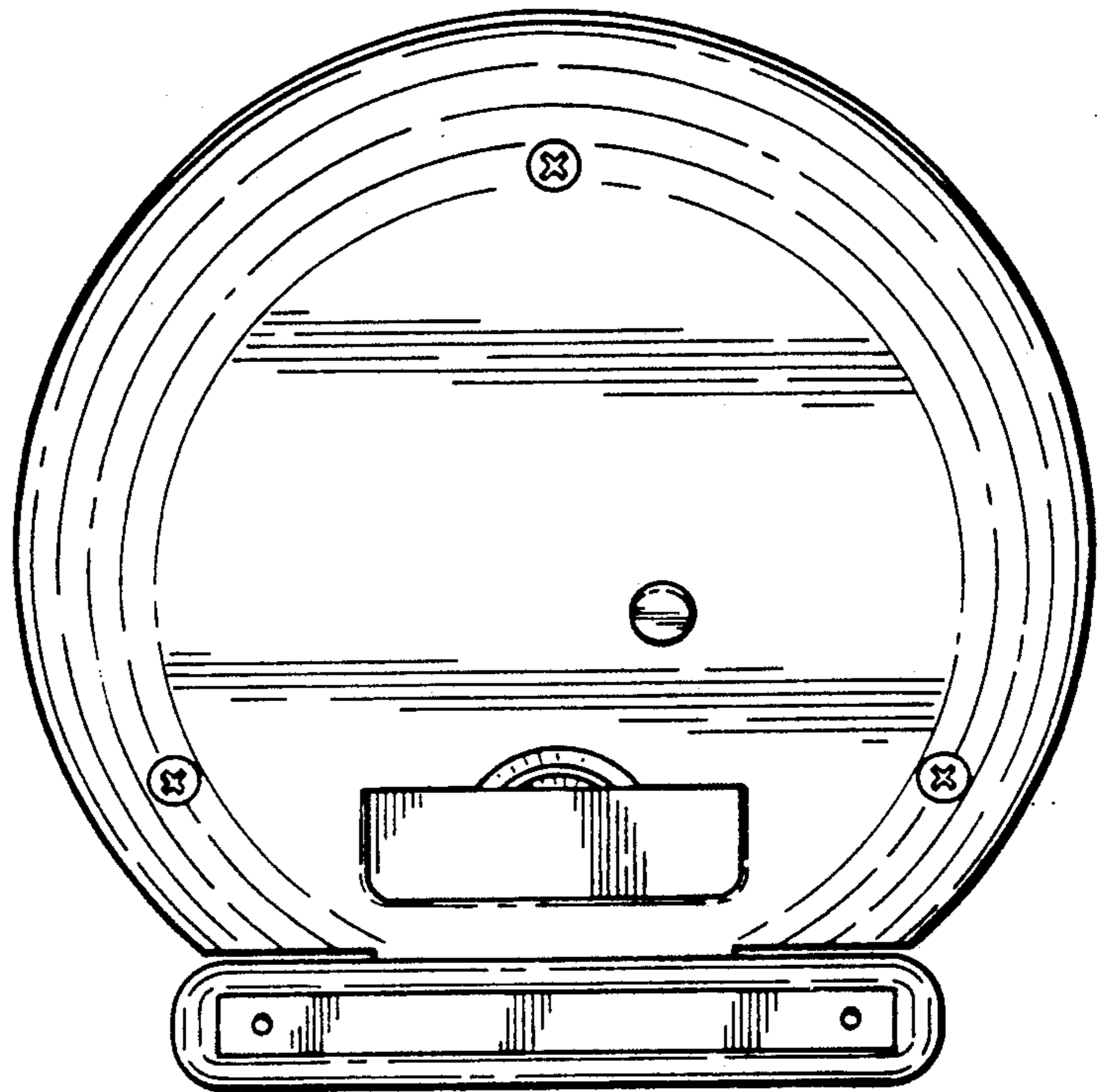

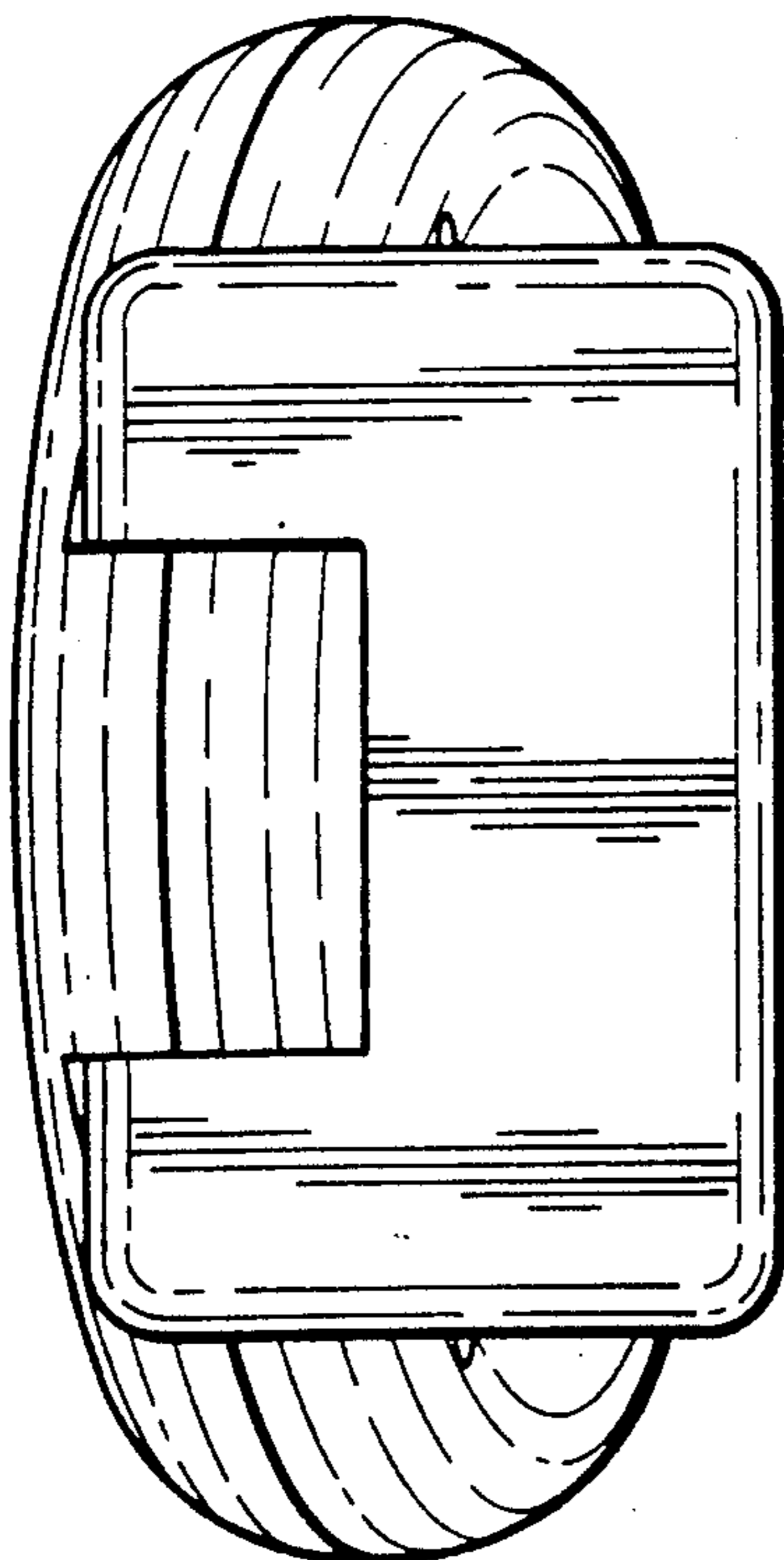
