DESCRIPTION

FIG. 1 is a front elevational view of a smoke alarm showing our new design;
FIG. 2 is a top plan view thereof;
FIG. 3 is a right side elevational view thereof;
FIG. 4 is a left side elevational view thereof;
FIG. 5 is a bottom plan view thereof;
FIG. 6 is a rear elevational view thereof;
FIG. 7 is a front elevational view of a second embodiment thereof; with the remaining views being identical to the views shown in FIGS. 2-6;
FIG. 8 is a front elevational view of a third embodiment thereof;
FIG. 9 is a right side elevational view thereof;
FIG. 10 is a bottom plan view thereof;
FIG. 11 is a left side elevational view thereof;
FIG. 12 is a top plan view thereof;
FIG. 13 is a rear elevational view thereof;
FIG. 14 is a front elevational view of a fourth embodiment thereof, with the remaining views being identical to those shown in FIGS. 9-13.

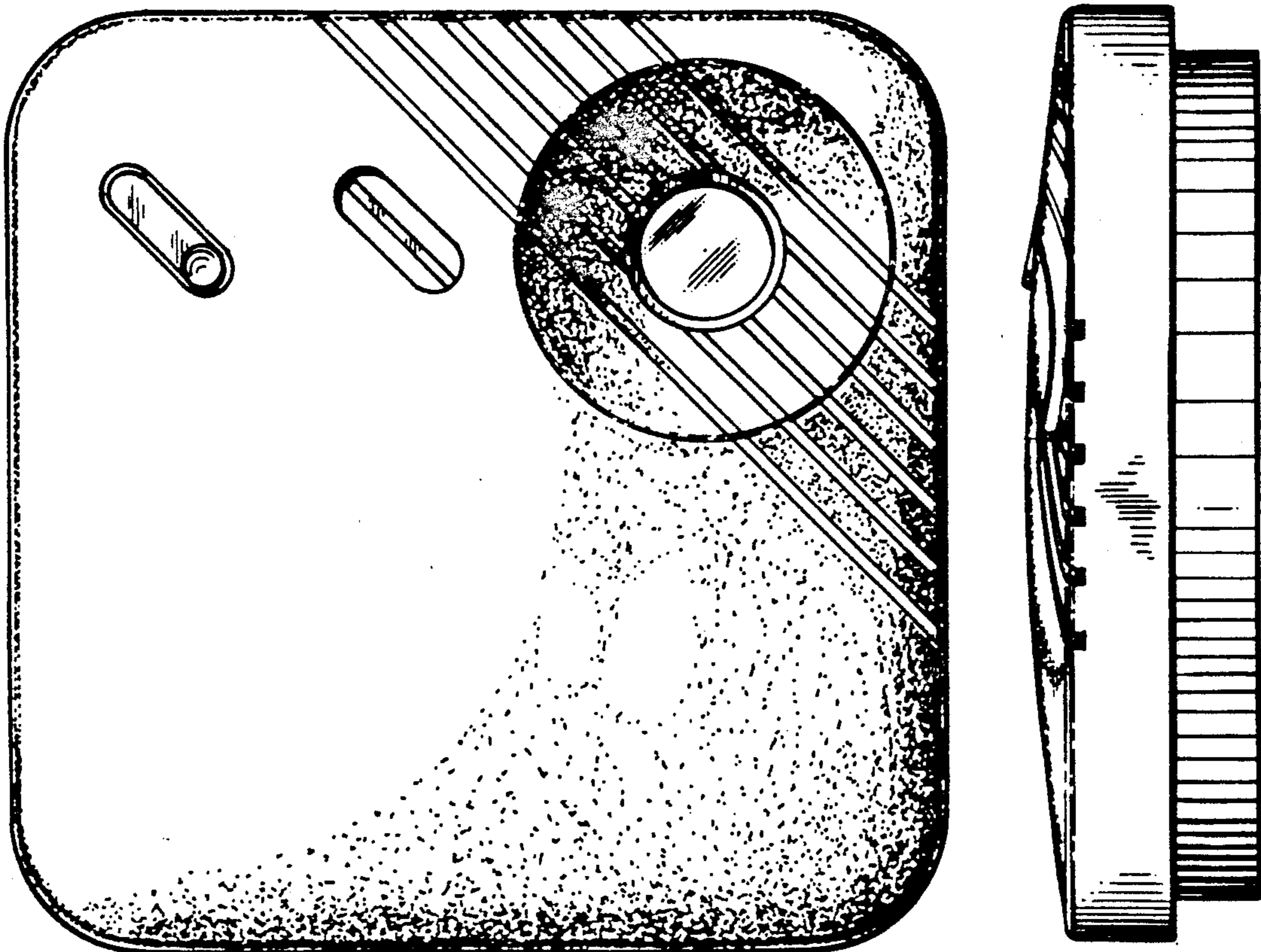

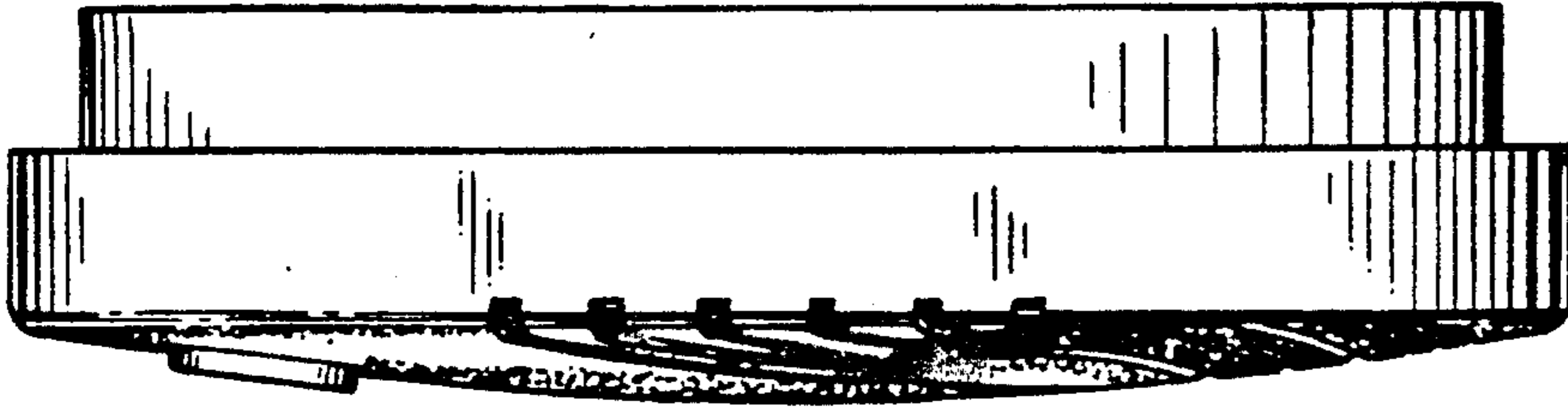

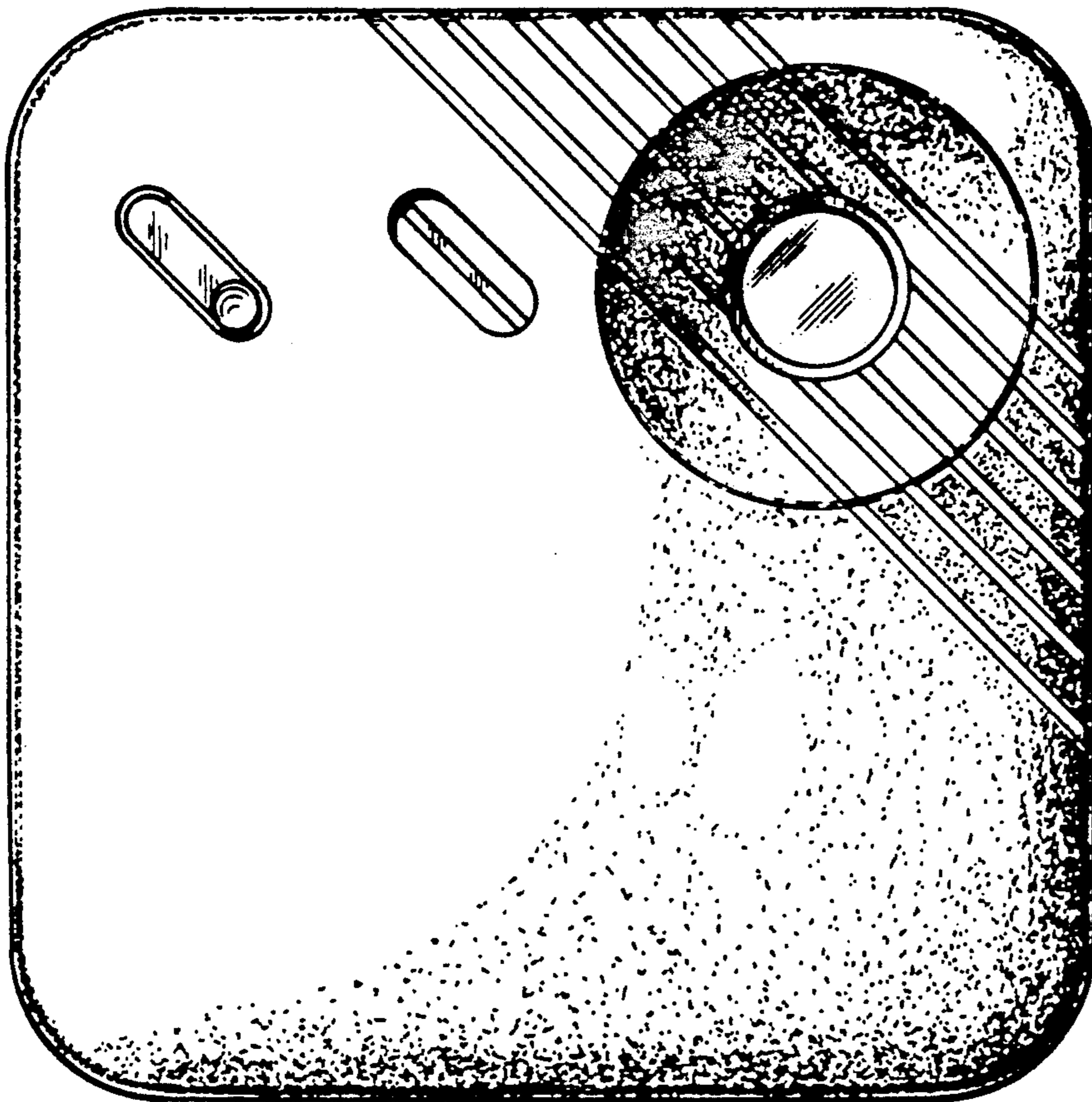

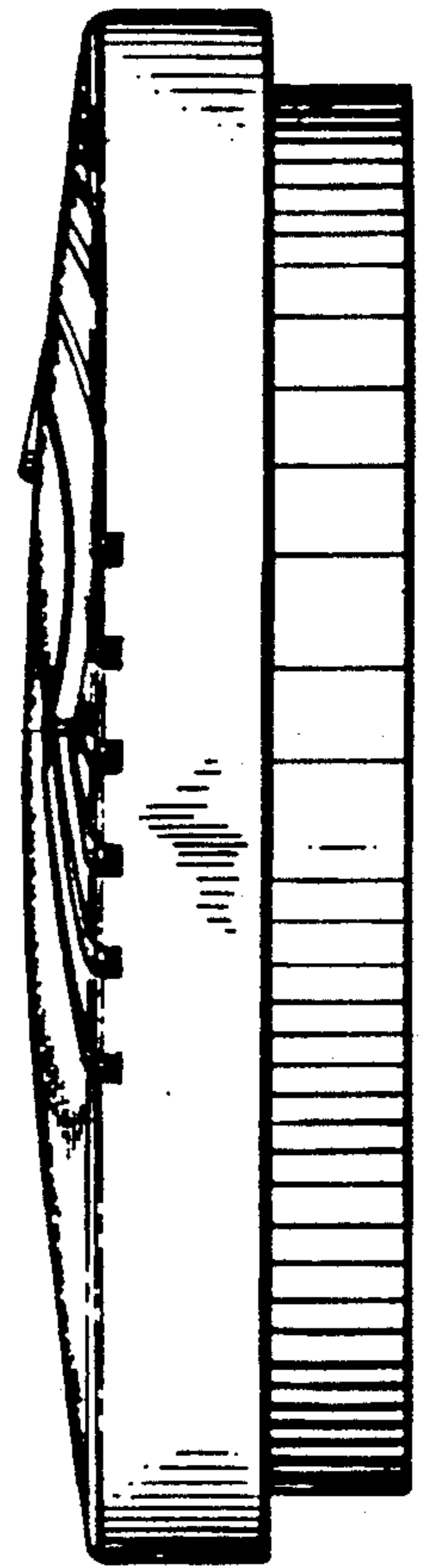
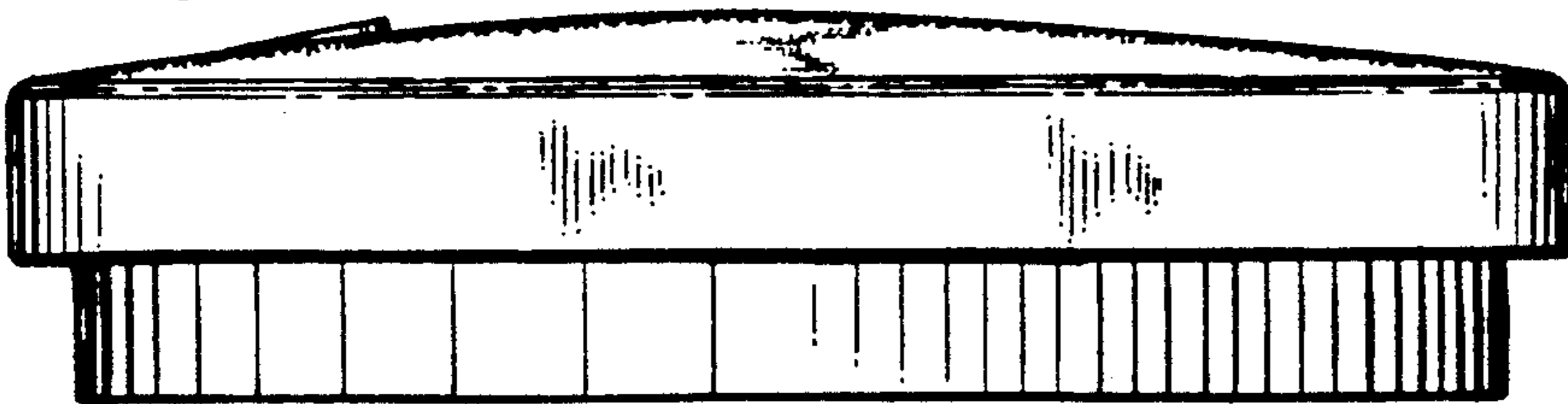

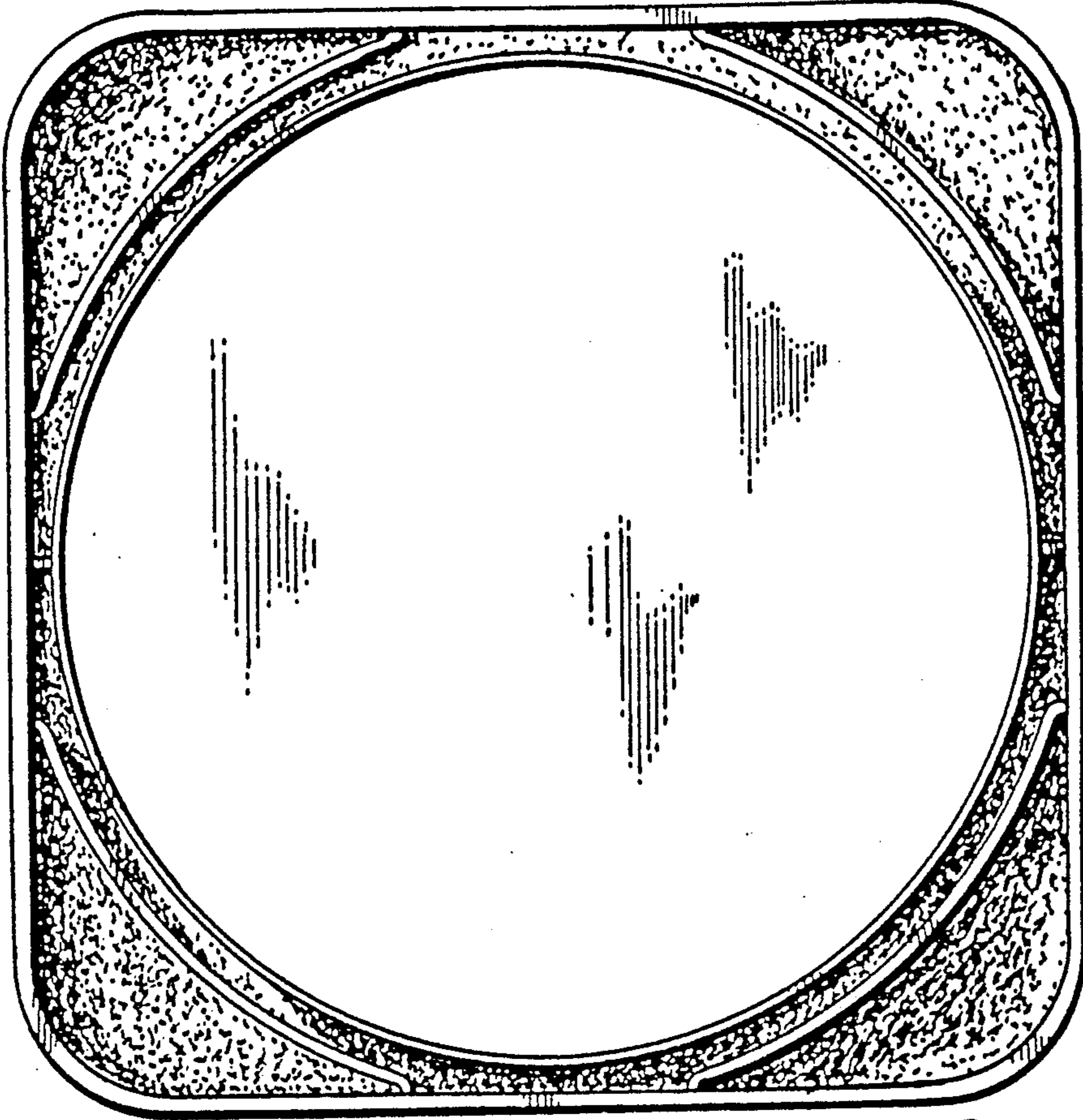

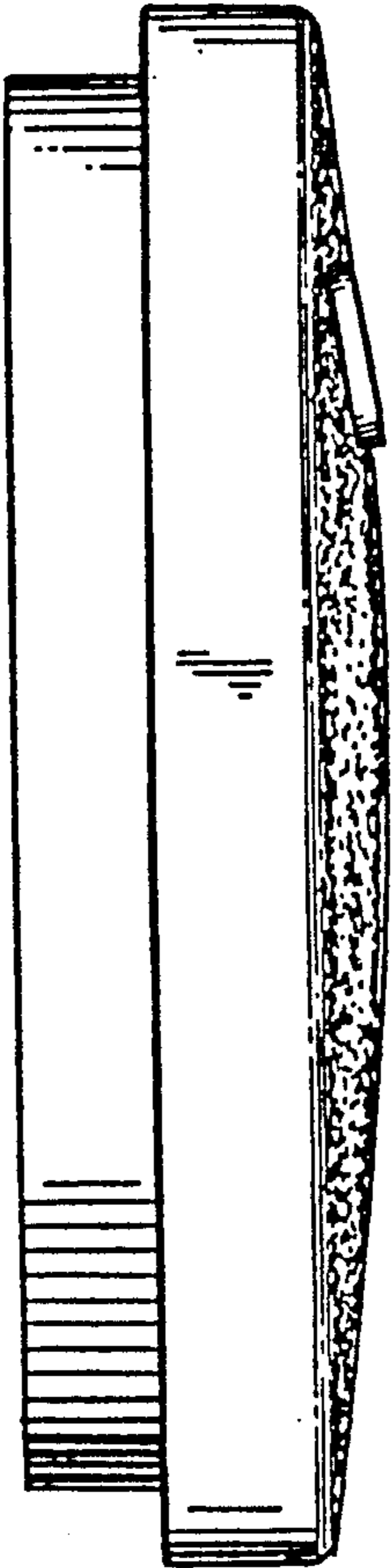

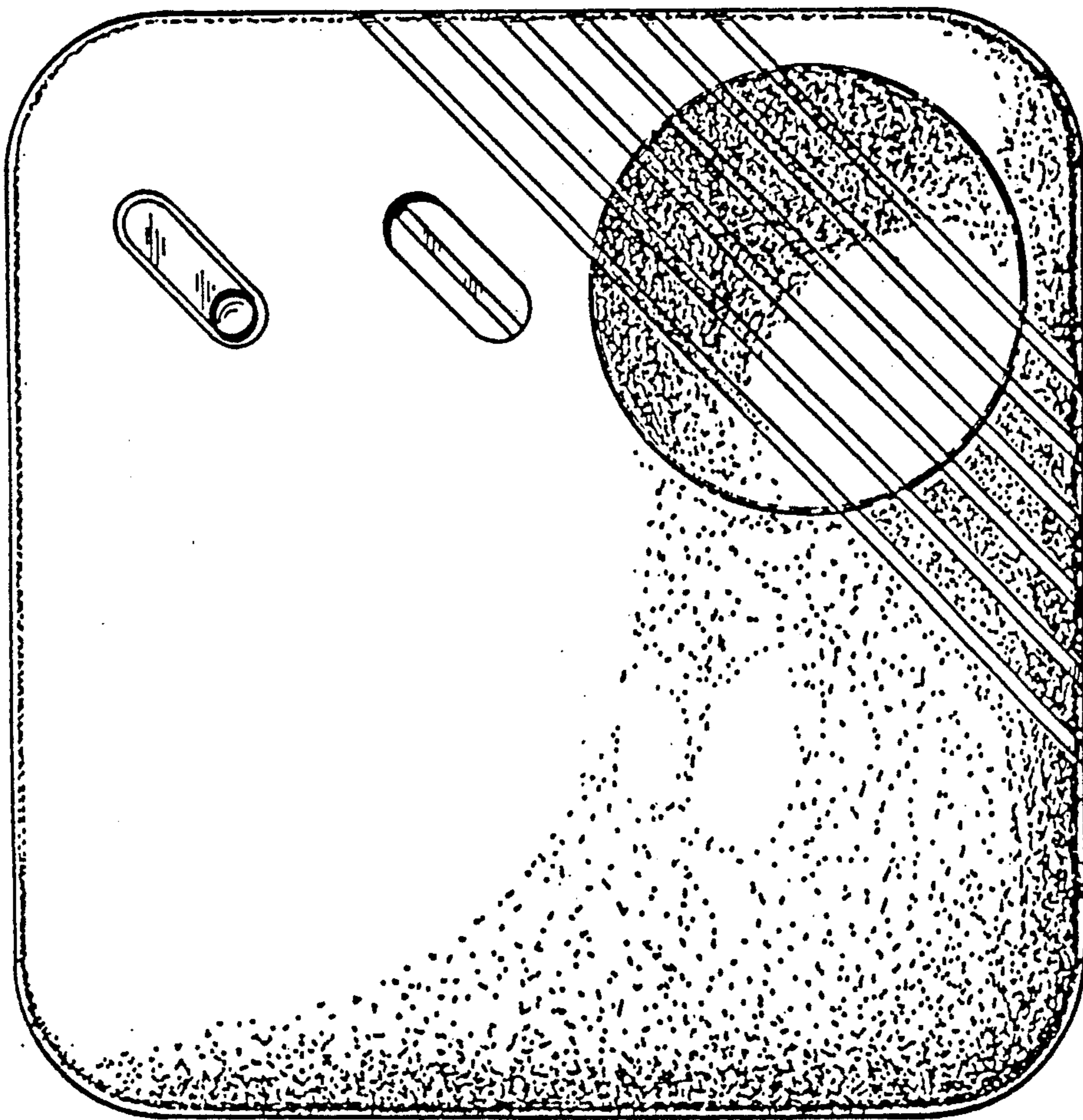

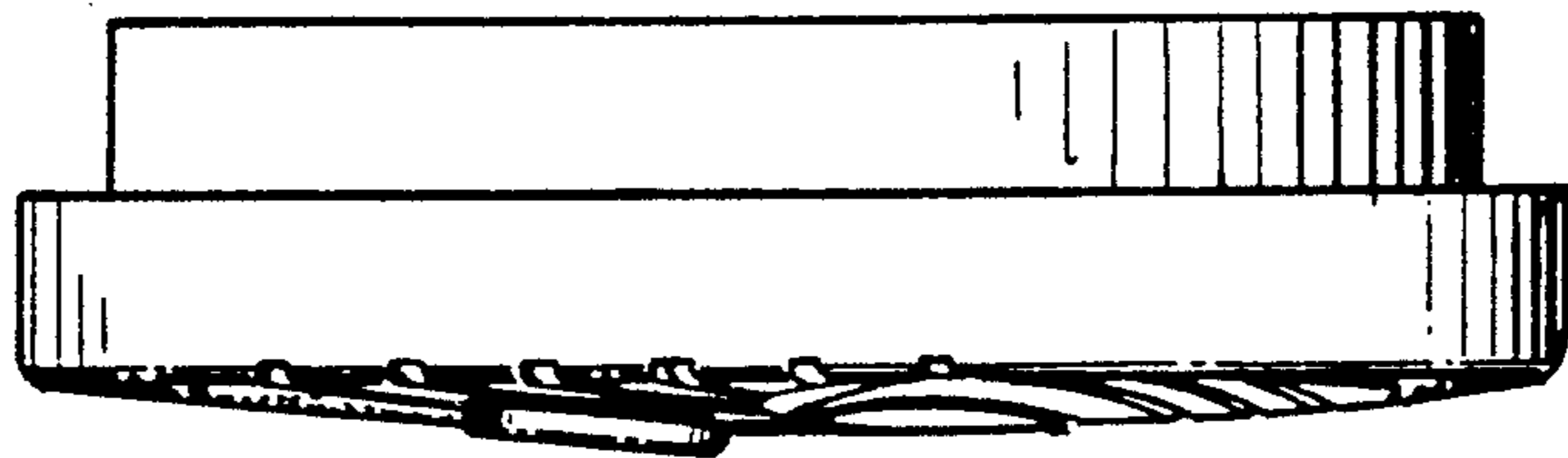

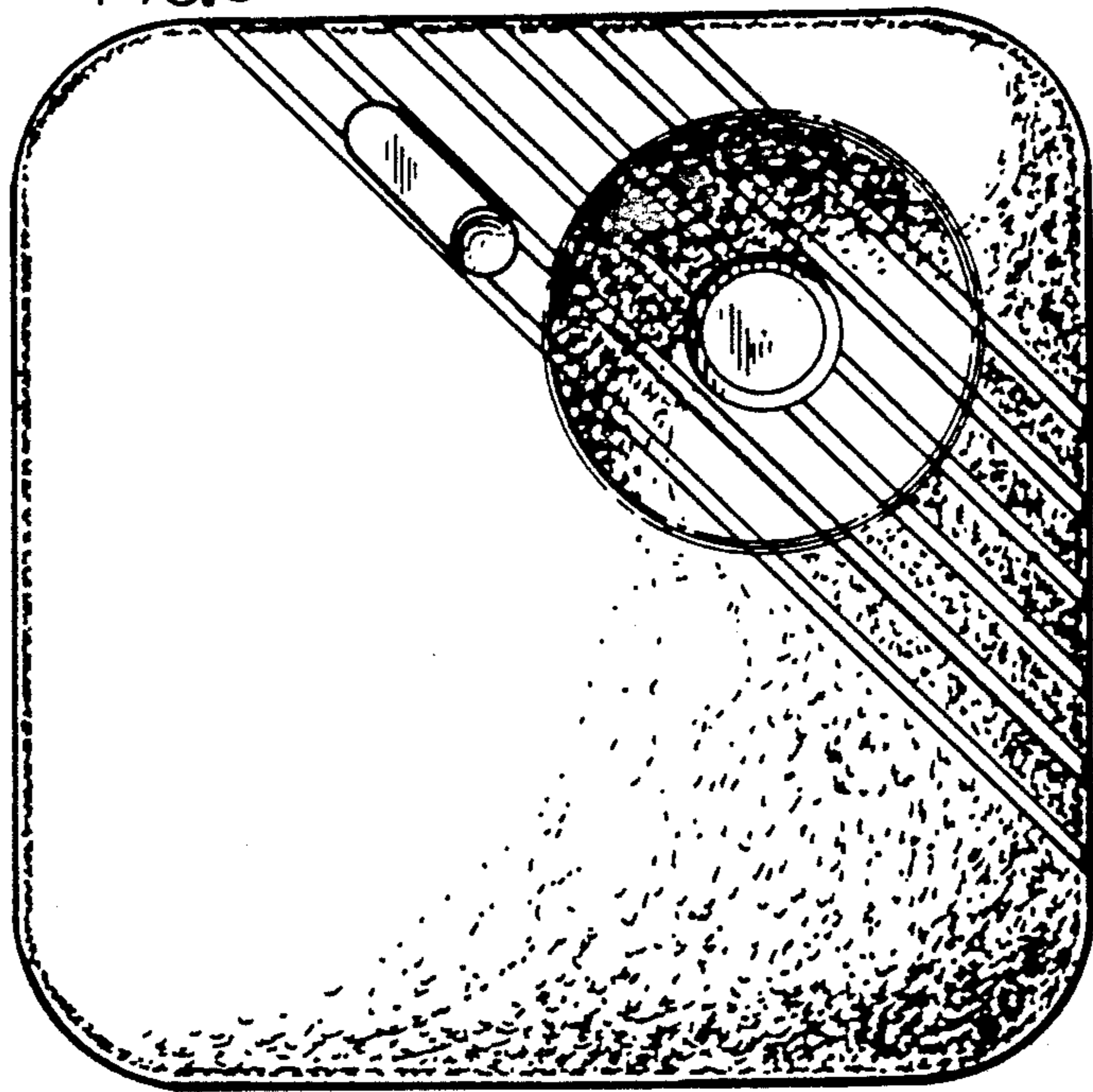

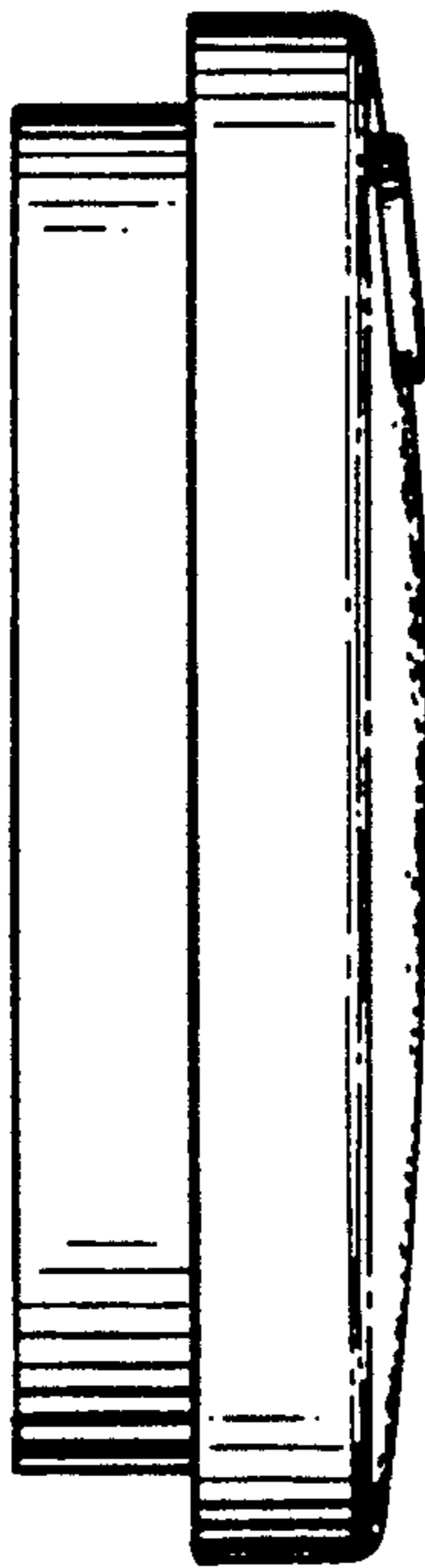
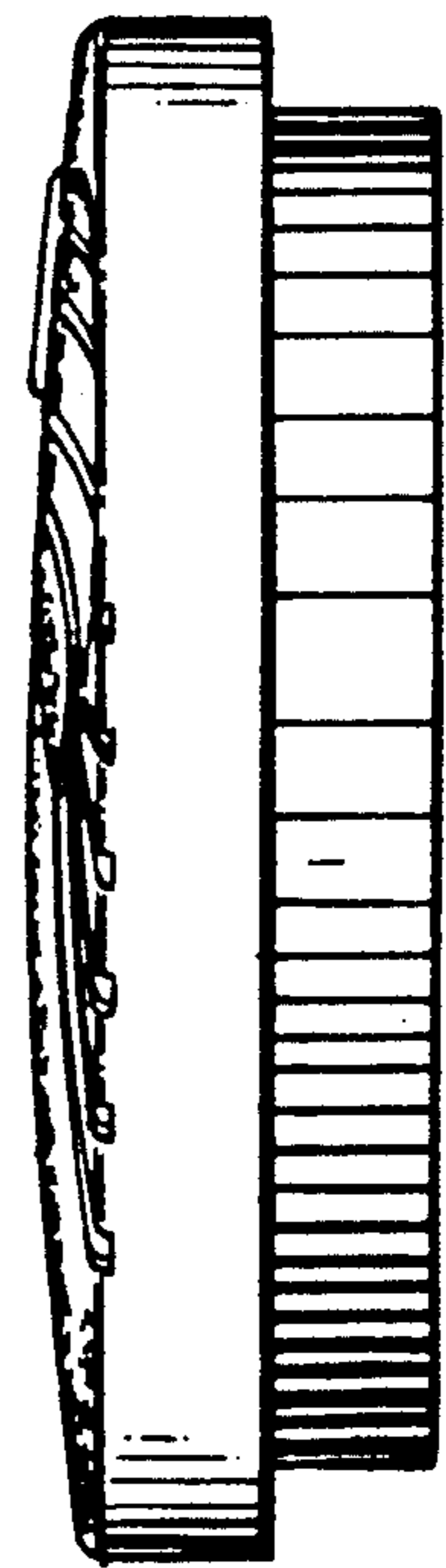

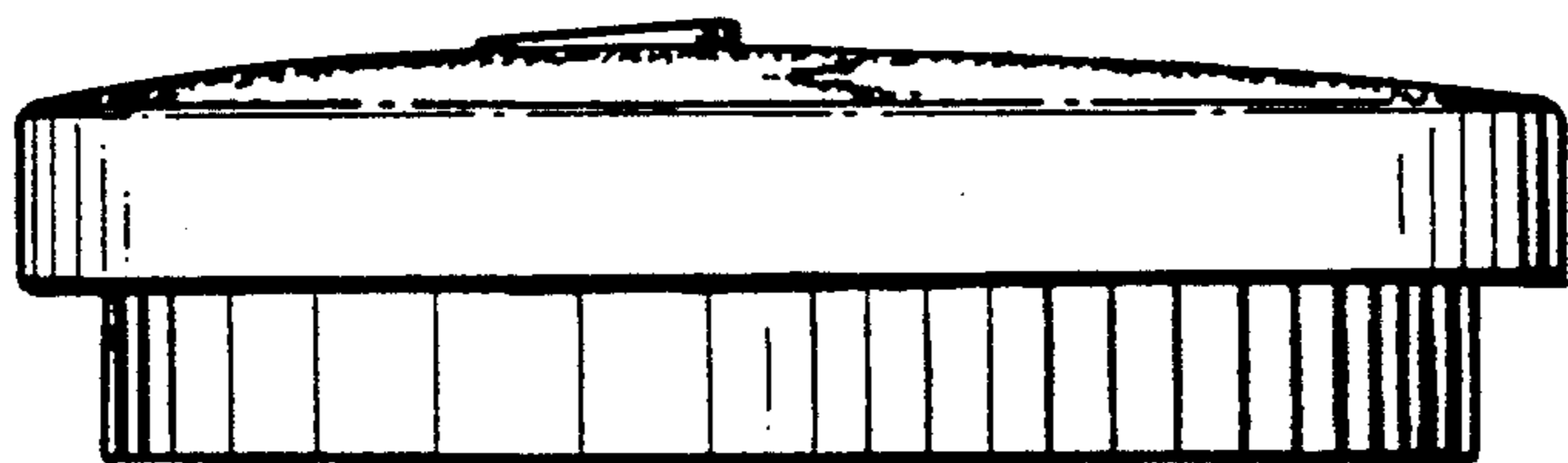

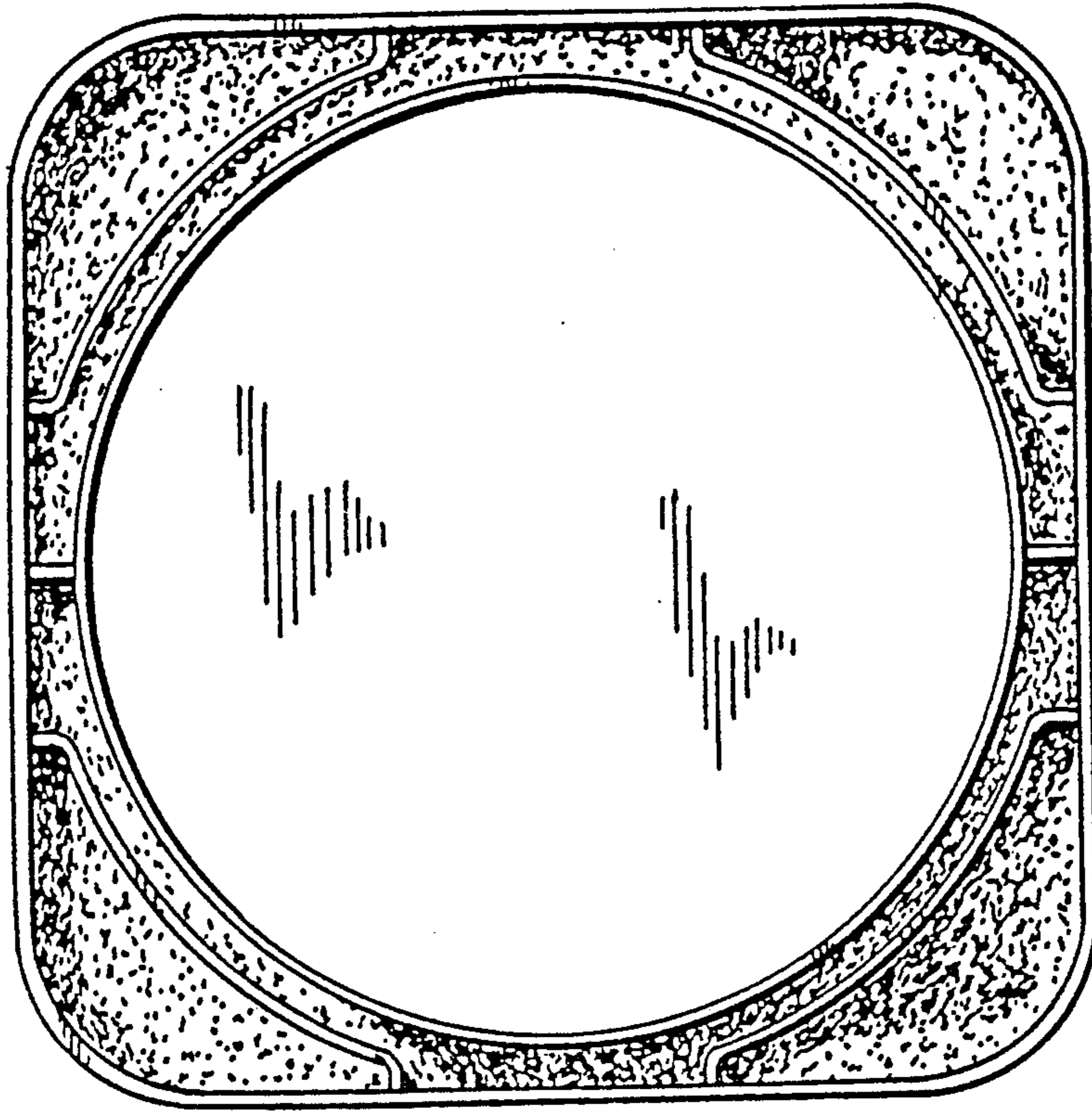
