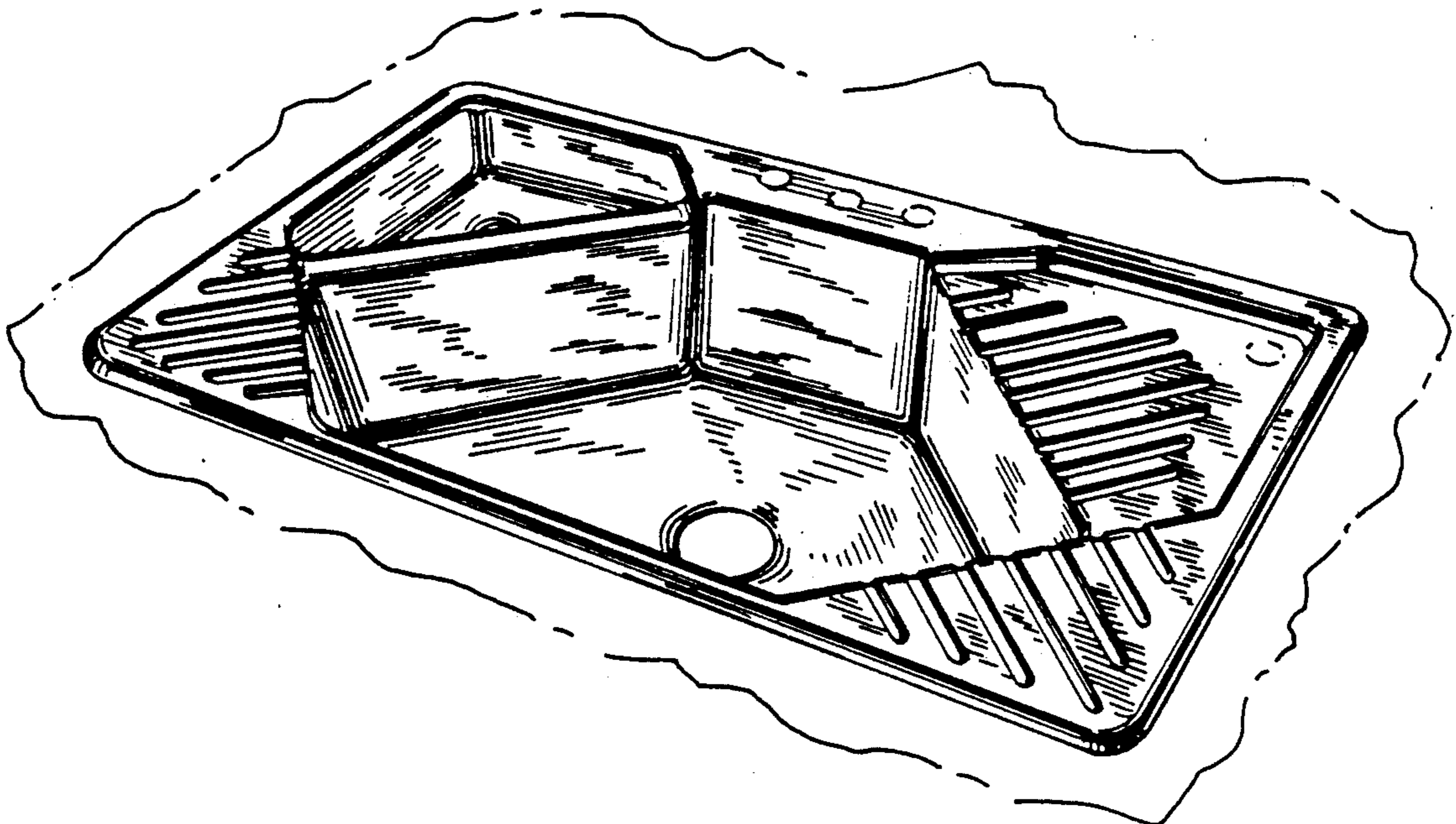
[57] CLAIM

The ornamental design for a sink, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view taken from the top, front, right side of a sink showing our new design; FIG. 2 is a top plan view thereof; FIG. 3 is a cross-sectional view taken on line 3—3 of FIG. 2; FIG. 4 is a cross-sectional view taken on line 4—4 of FIG. 2; FIG. 5 is a cross-sectional view taken on line 5—5 of FIG. 2; FIG. 6 is a cross-sectional view taken on line 6—6 of FIG. 2; FIG. 7 is a cross-sectional view taken on line 7—7 of FIG. 2; FIG. 8 is a cross-sectional view taken on line 8—8 of FIG. 2; and FIG. 9 is a top plan view of a second embodiment thereof.

The fragmentary broken line representation of a kitchen counter in FIG. 1 and the broken line representation of plumbing fitting mounting holes in FIGS. 1, 2 and 9 are for purposes of illustration only and form no part of the claimed design.



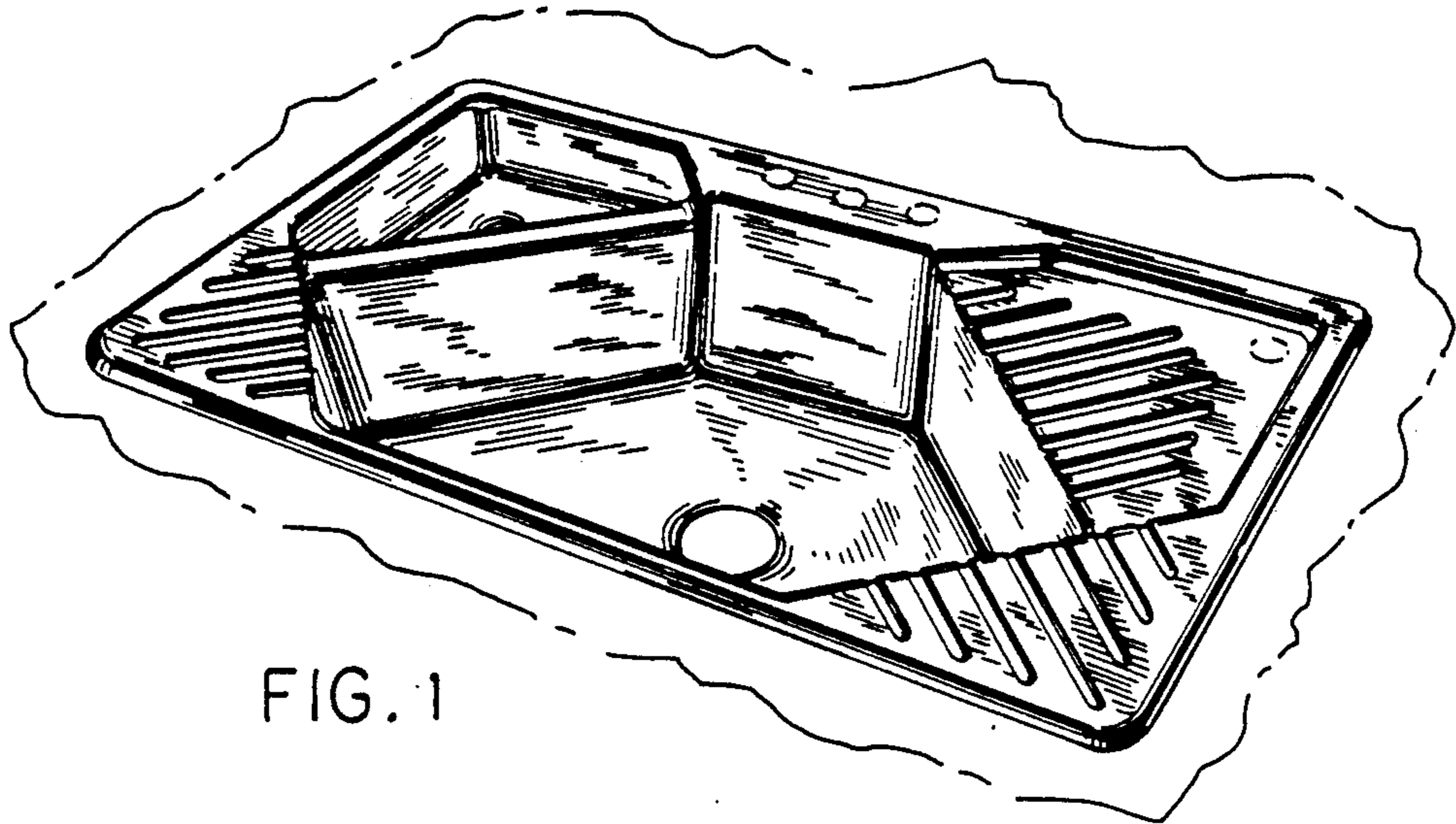

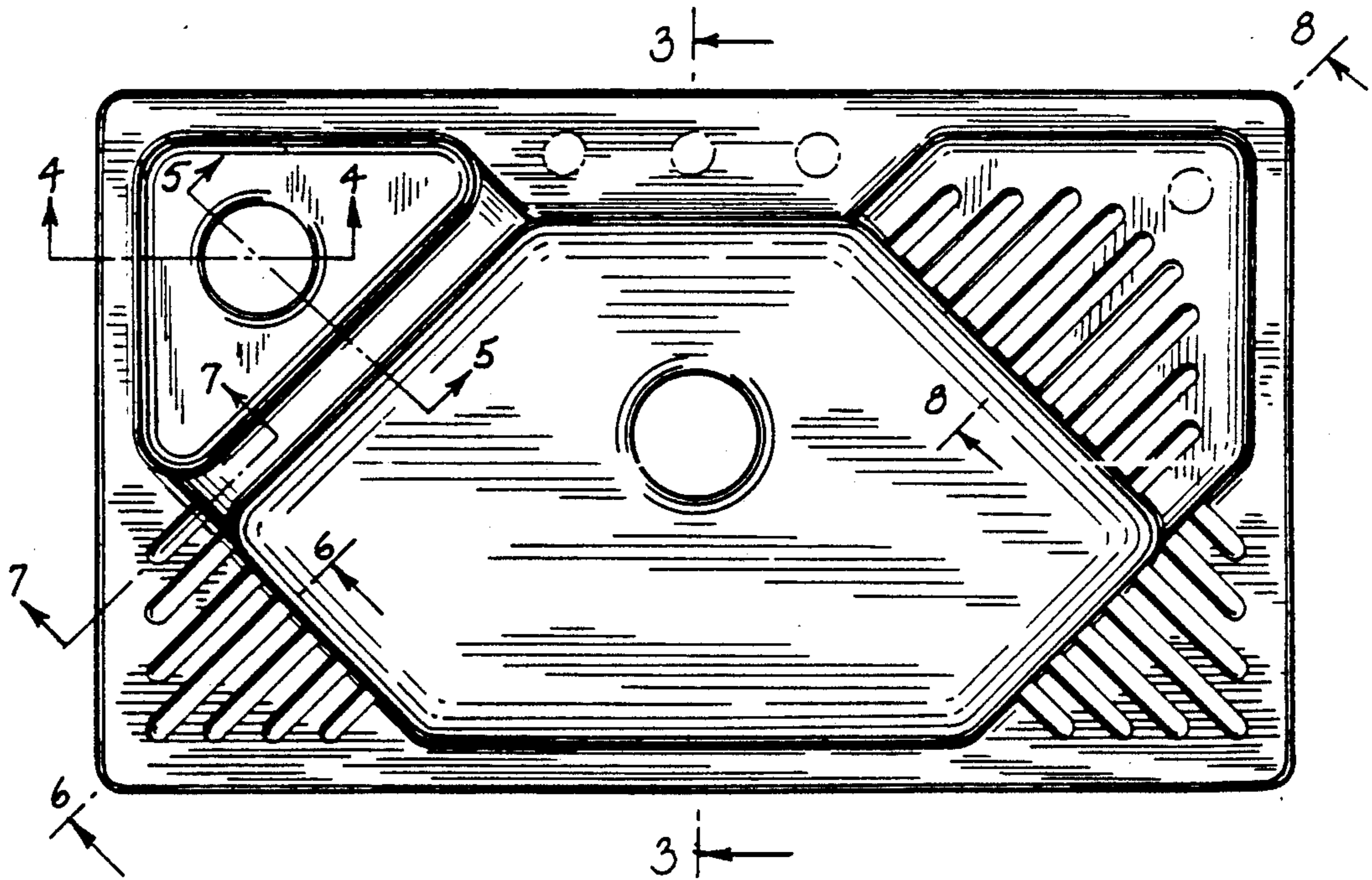

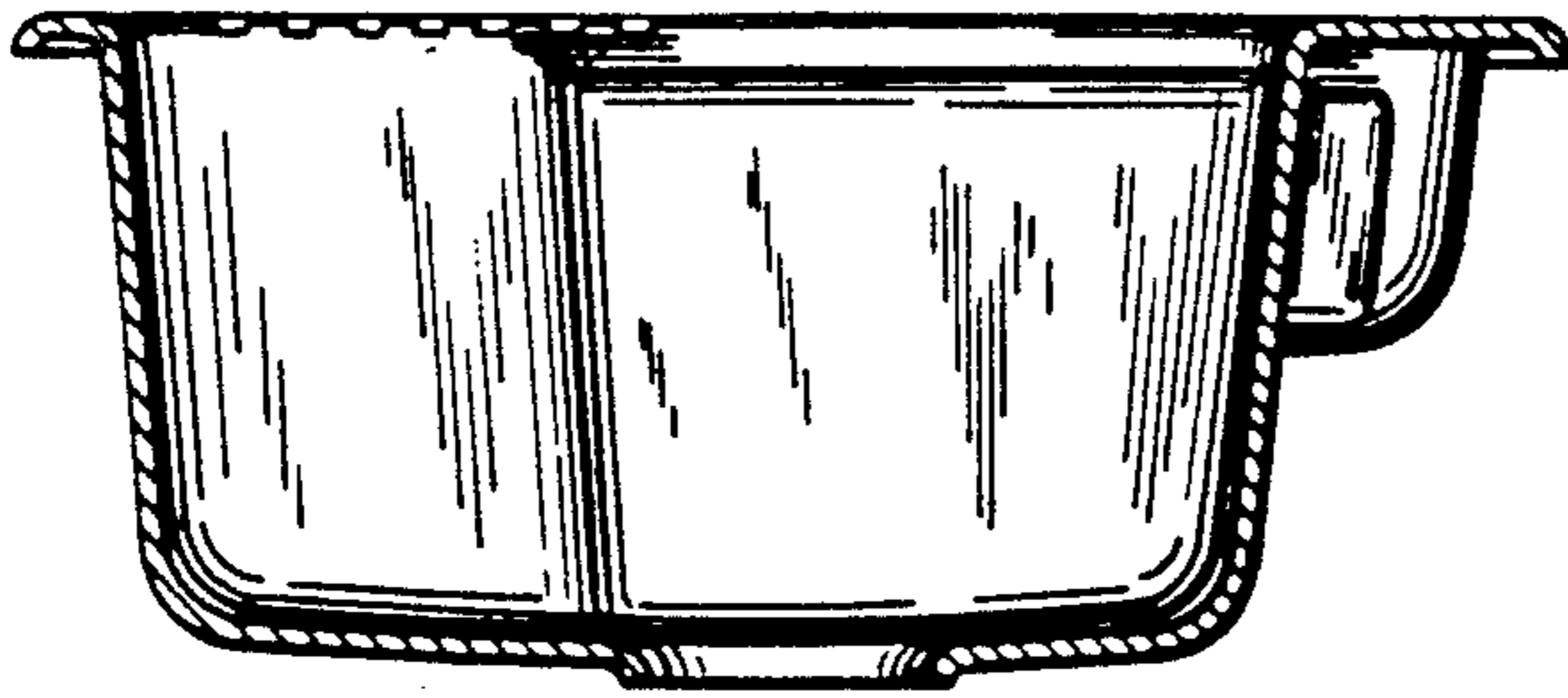

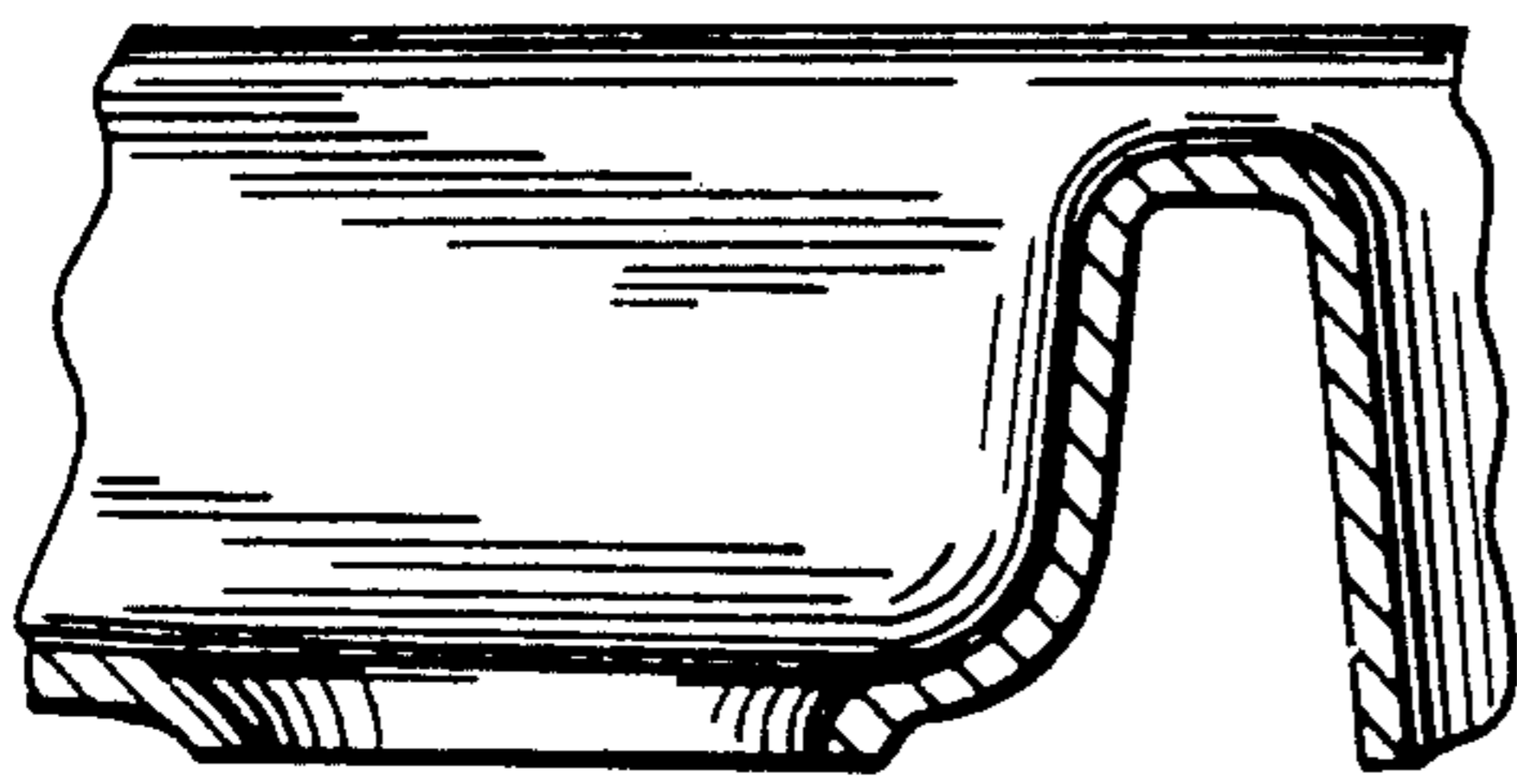
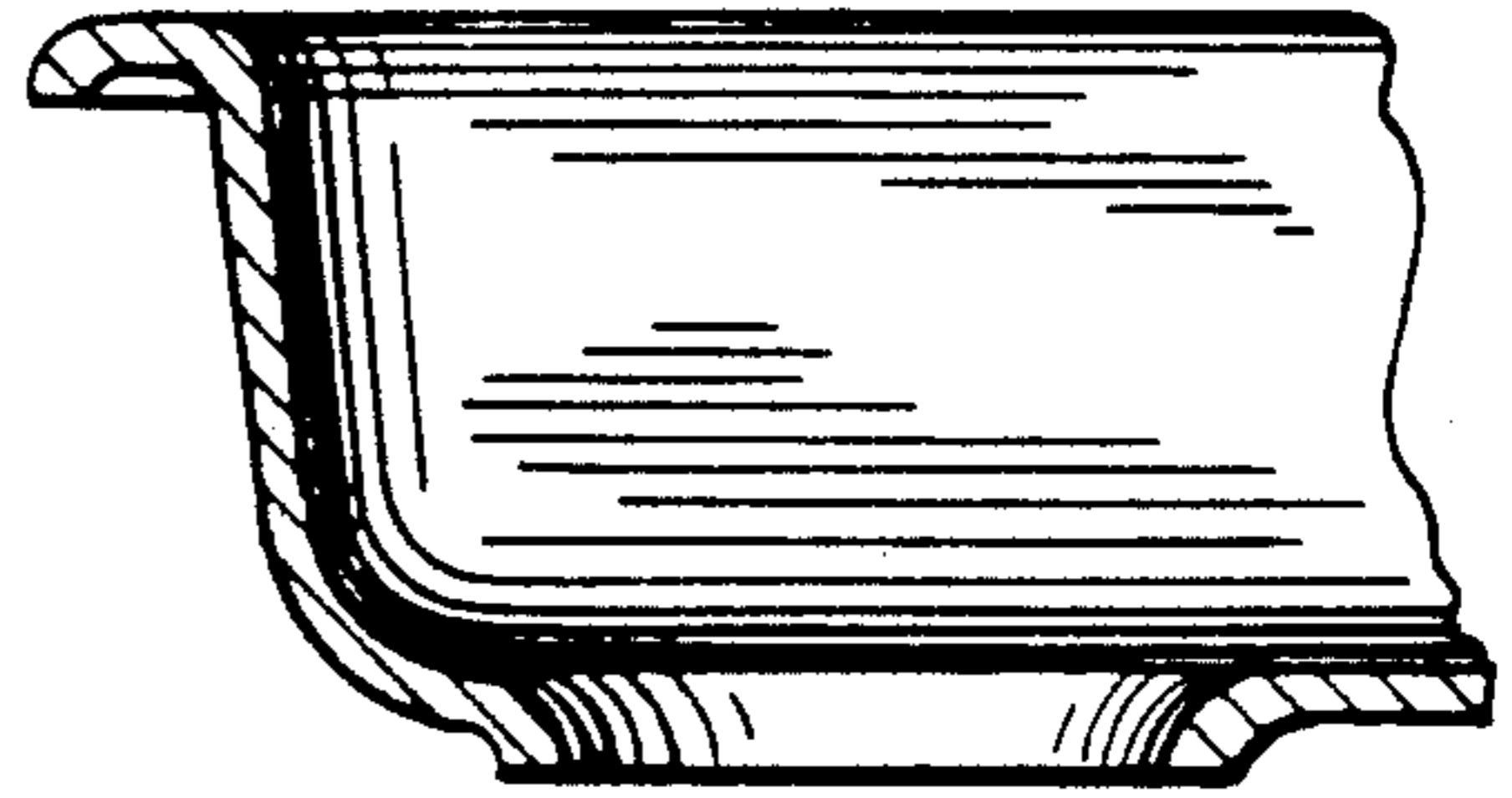

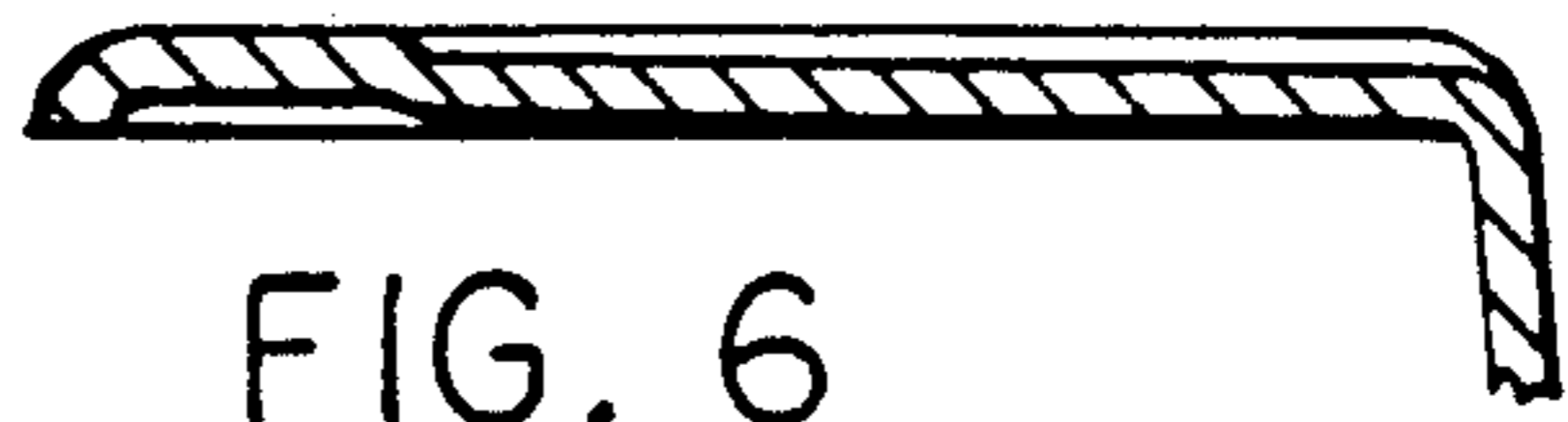

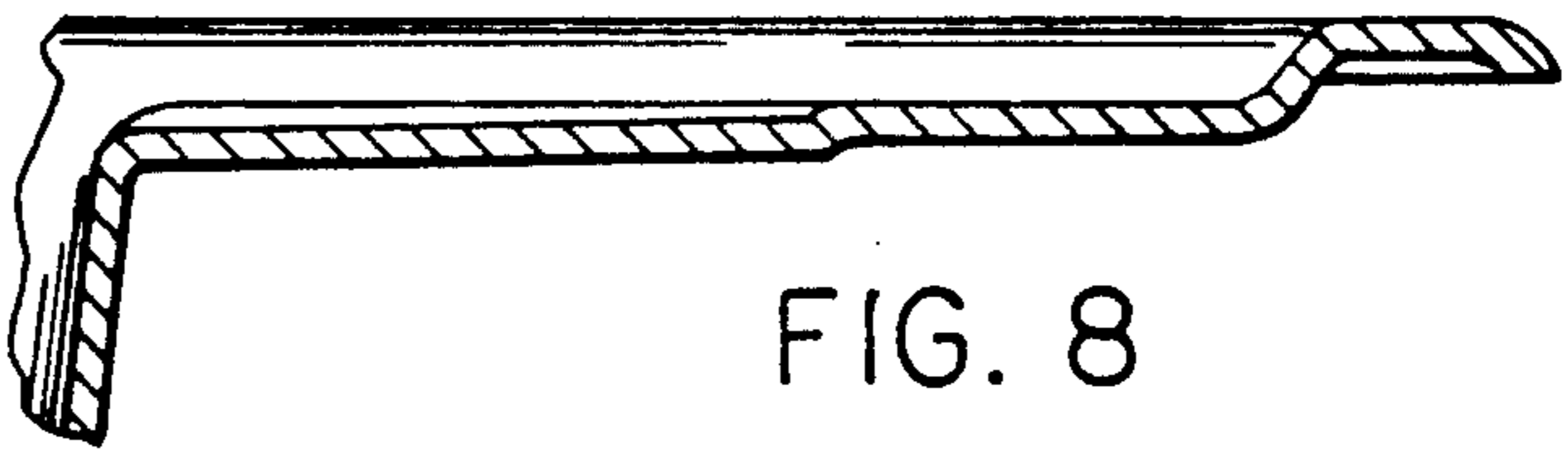

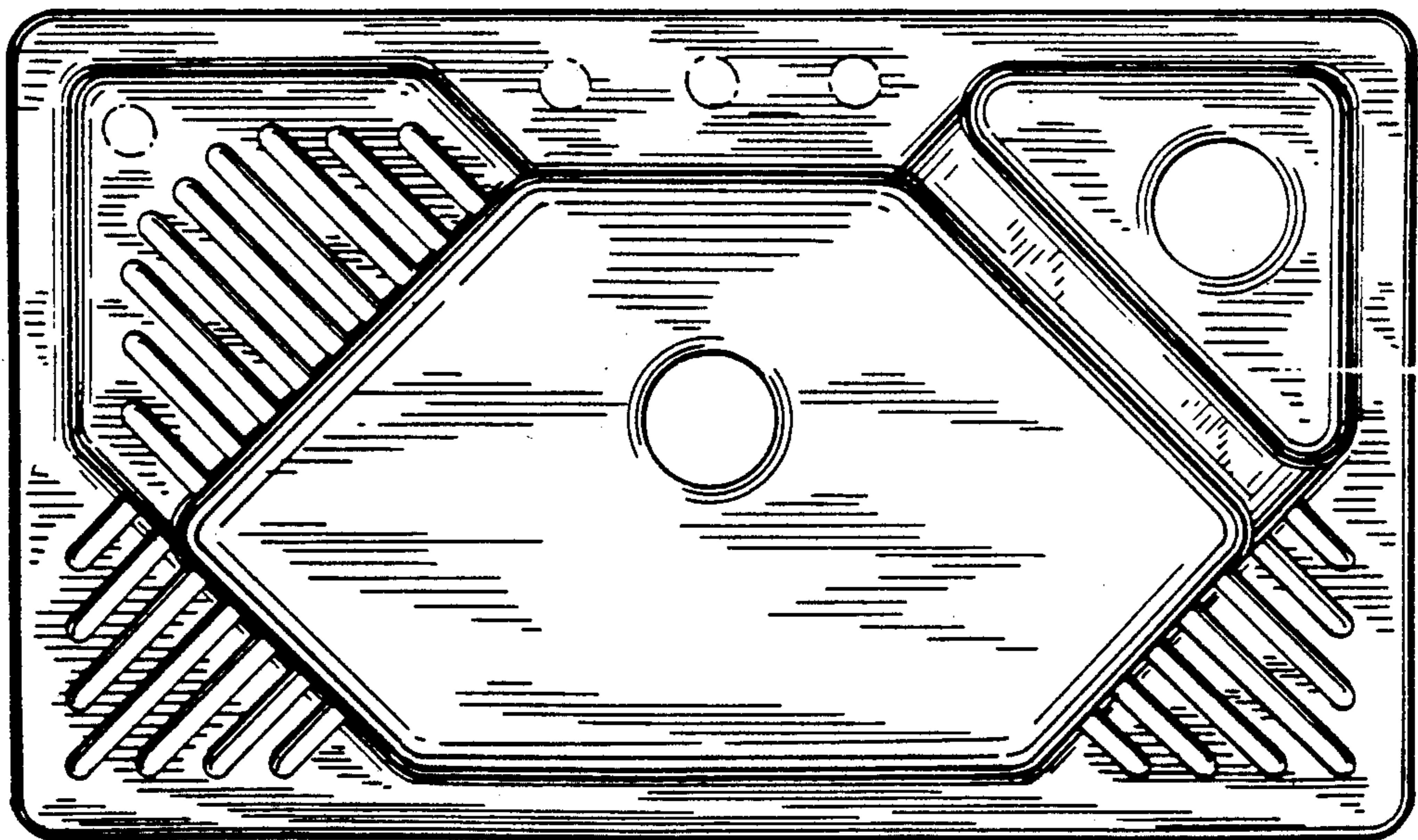
