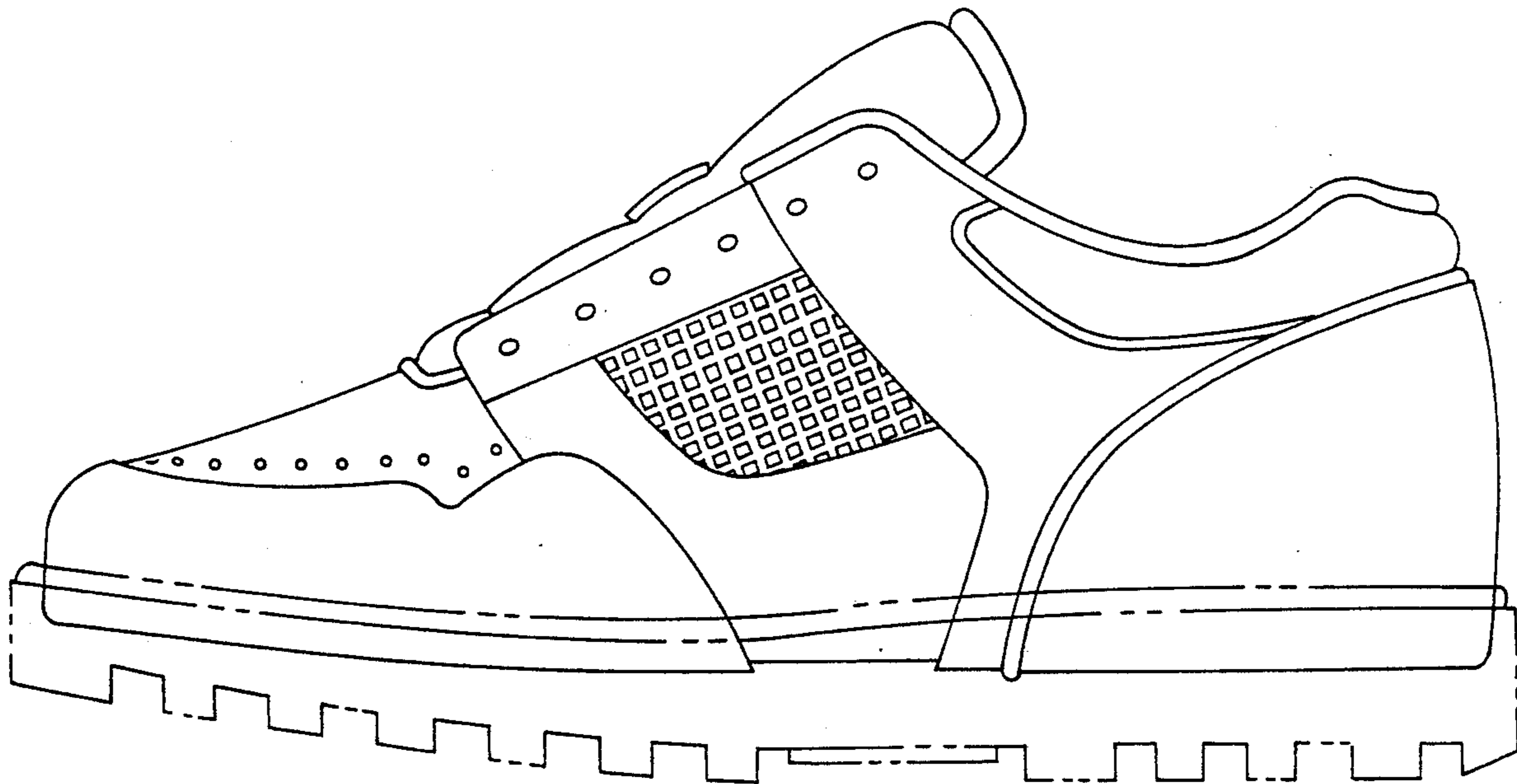

The ornamental design for a shoe upper, as shown and described.

DESCRIPTION

FIG. 1 is a right side elevational view of shoe upper showing my new design;
 FIG. 2 is a top plan view thereof;
 FIG. 3 is a bottom plan view thereof;
 FIG. 4 is a left side elevational view thereof;
 FIG. 5 is a front elevational view thereof;
 FIG. 6 is a rear elevational view thereof;
 FIG. 7 is a right side elevational view of a shoe upper showing a first alternate embodiment of my new design;
 FIG. 8 is a top plan view thereof;
 FIG. 9 is a bottom plan view thereof;
 FIG. 10 is a right side elevational view thereof;
 FIG. 11 is a front elevational view thereof; and
 FIG. 12 is a rear elevational view thereof.
 The broken lines showing shoe soles in FIGS. 1 and 7 are for environmental purposes only and form no part of the claimed invention.



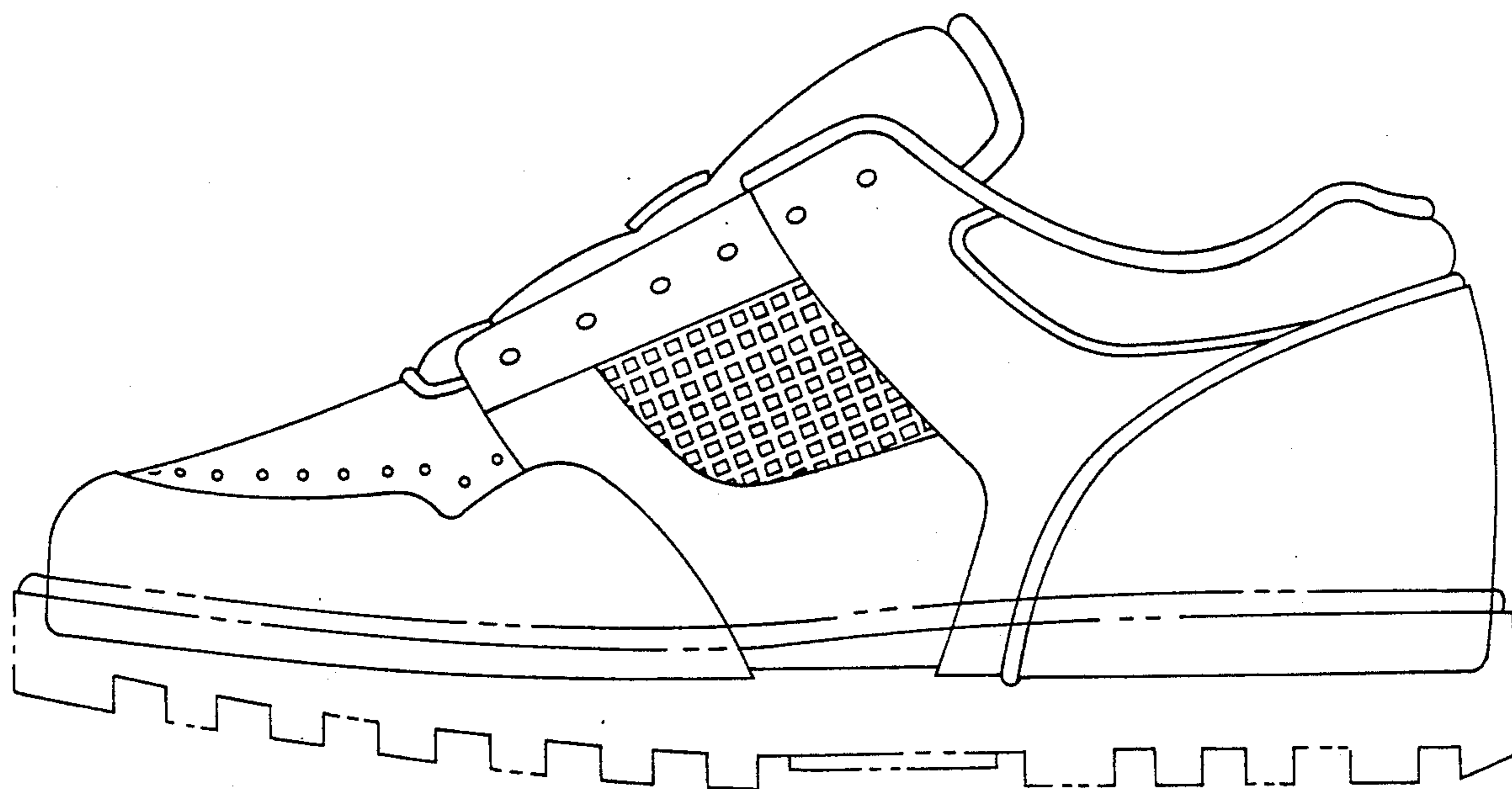

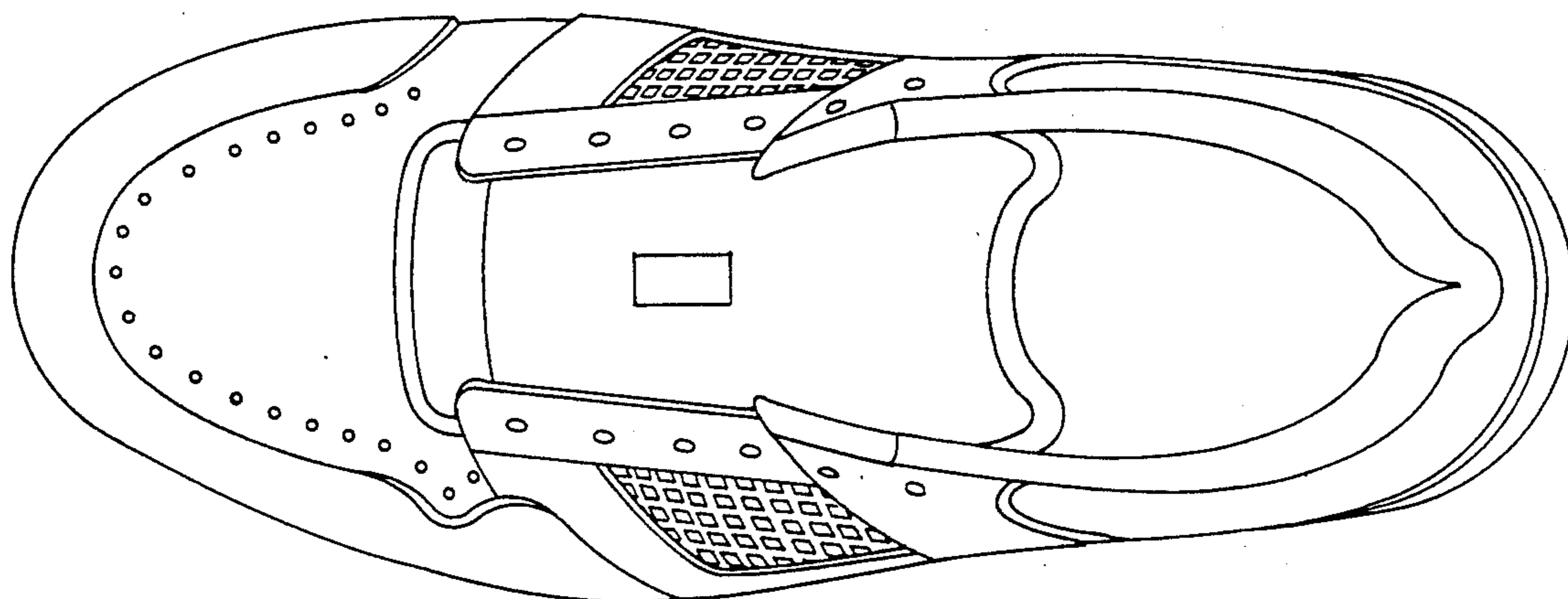

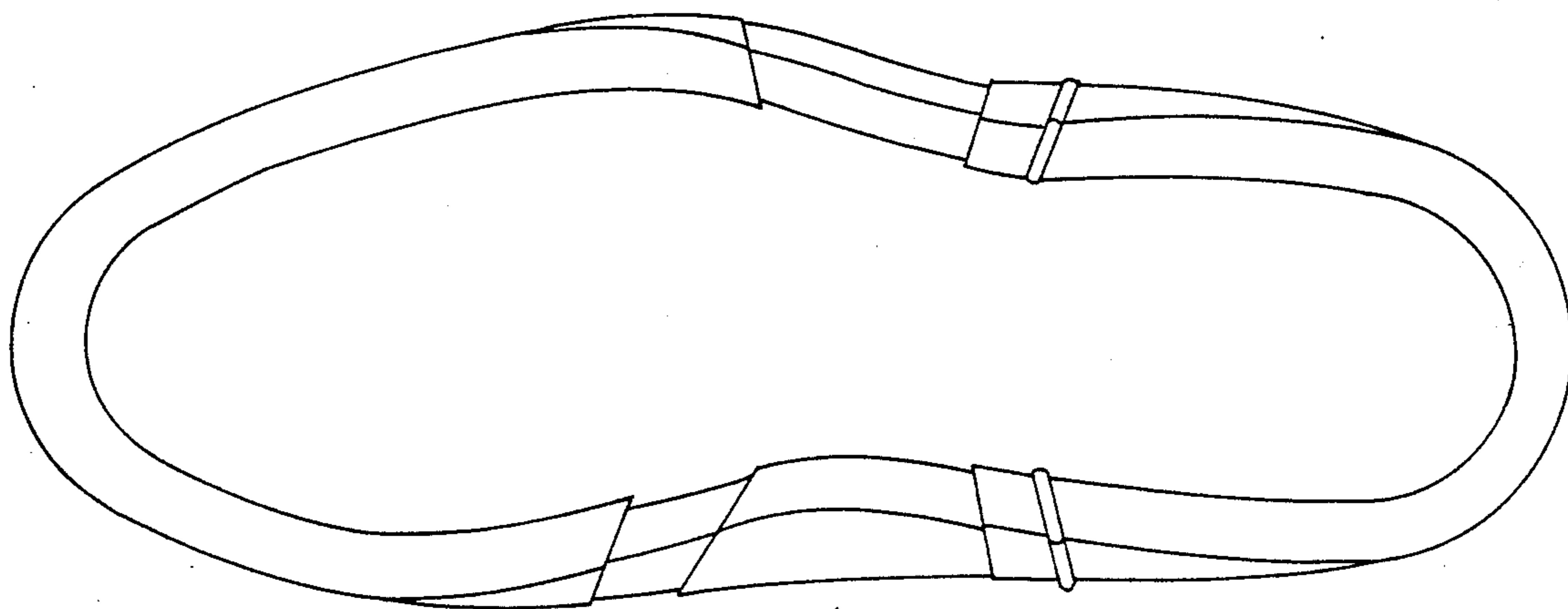

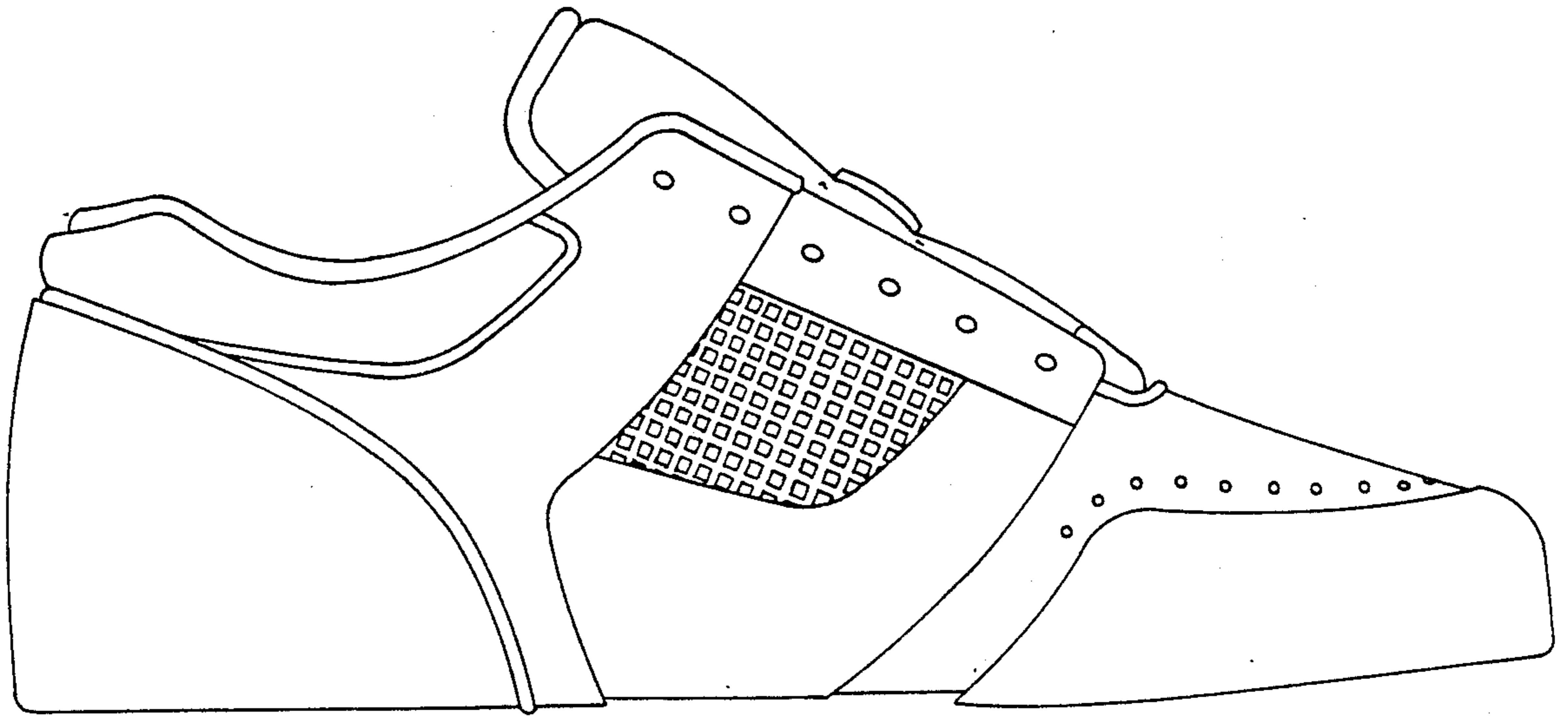

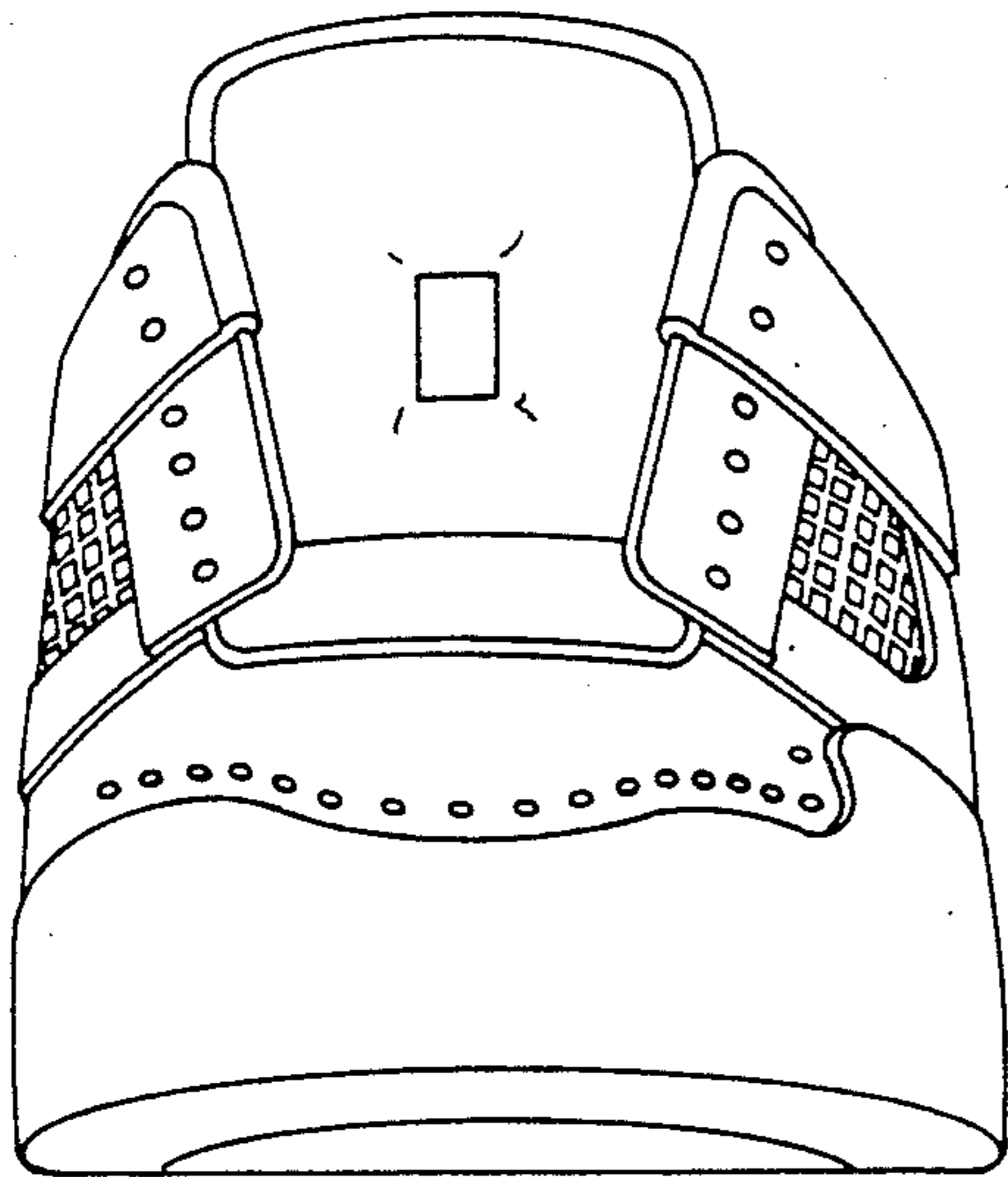

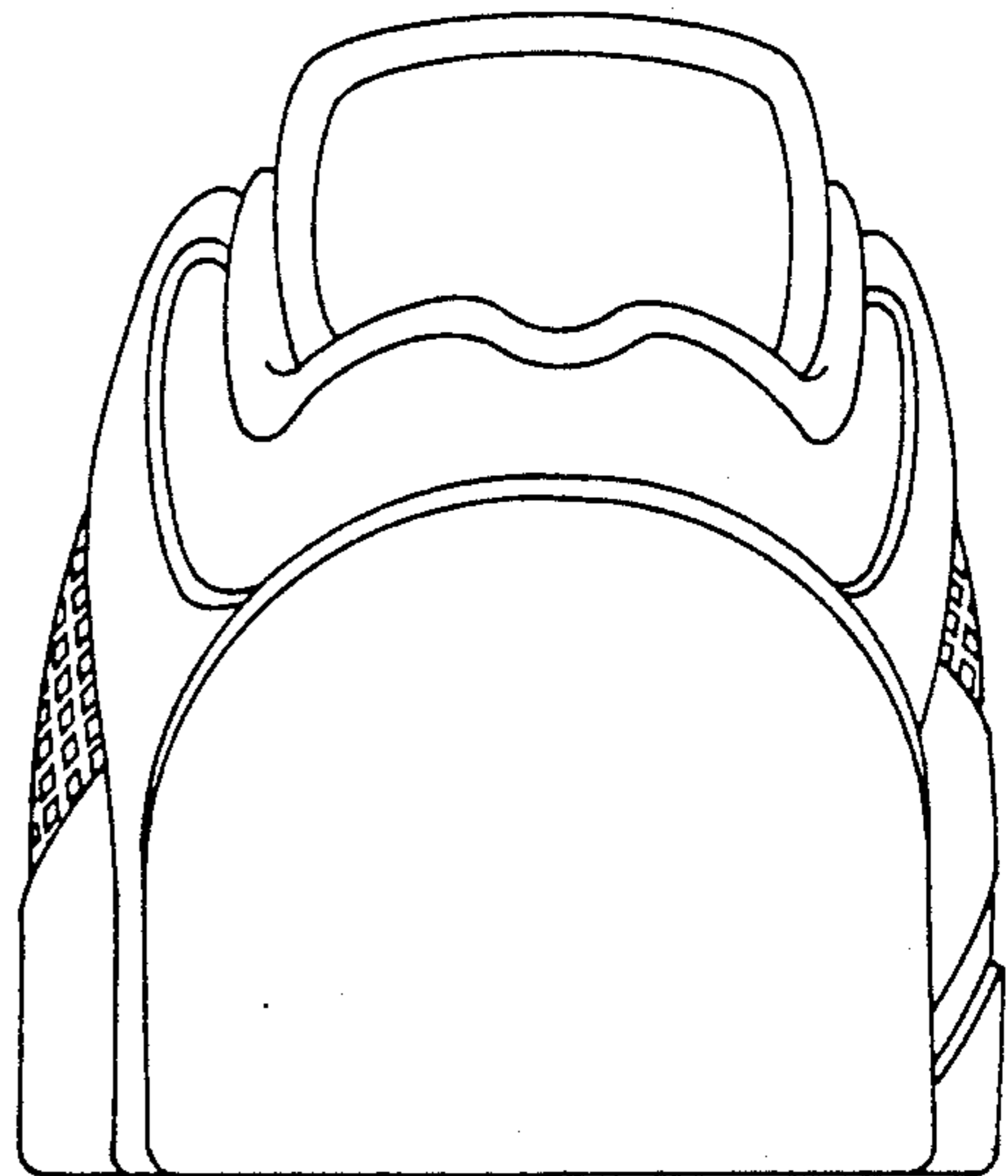

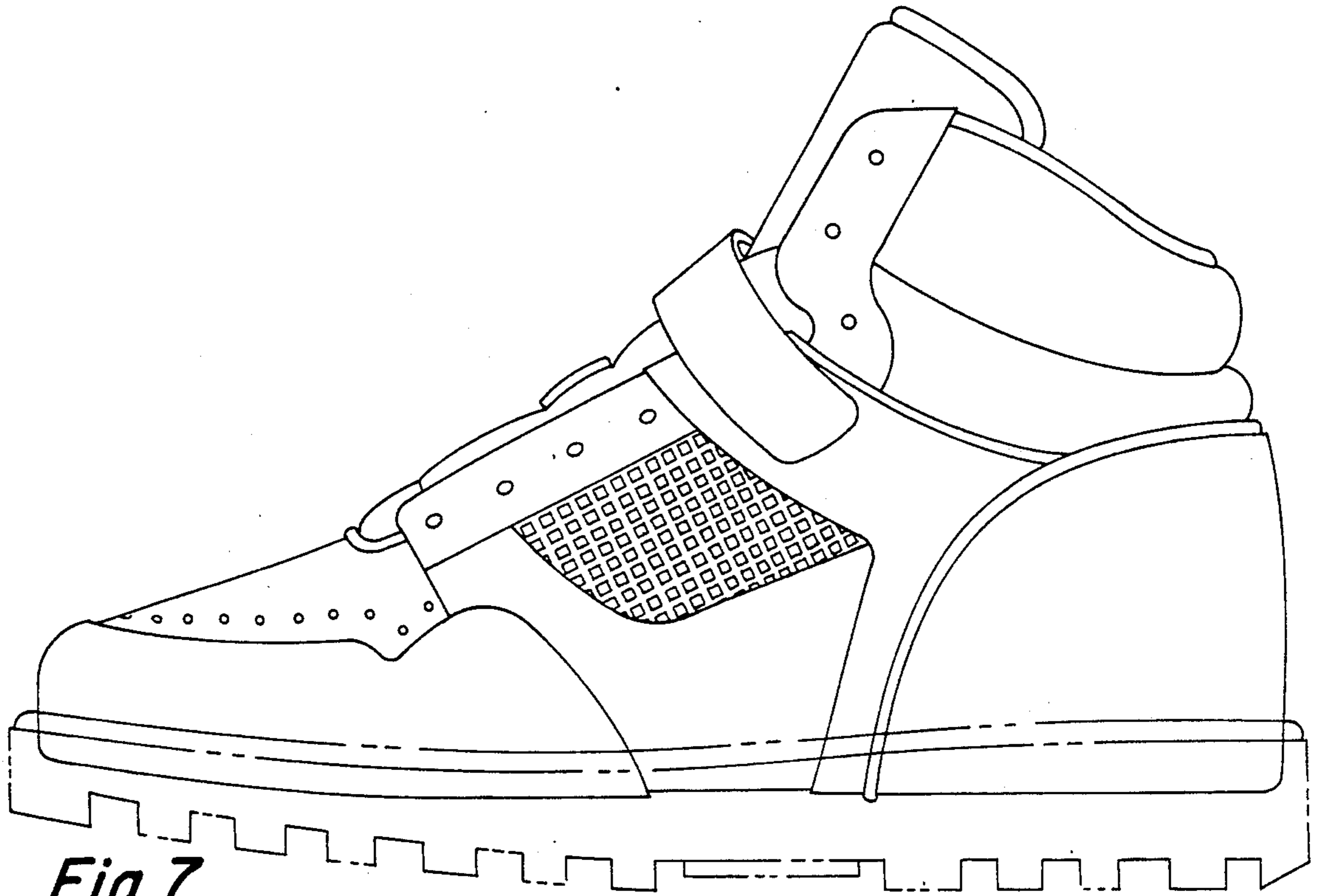

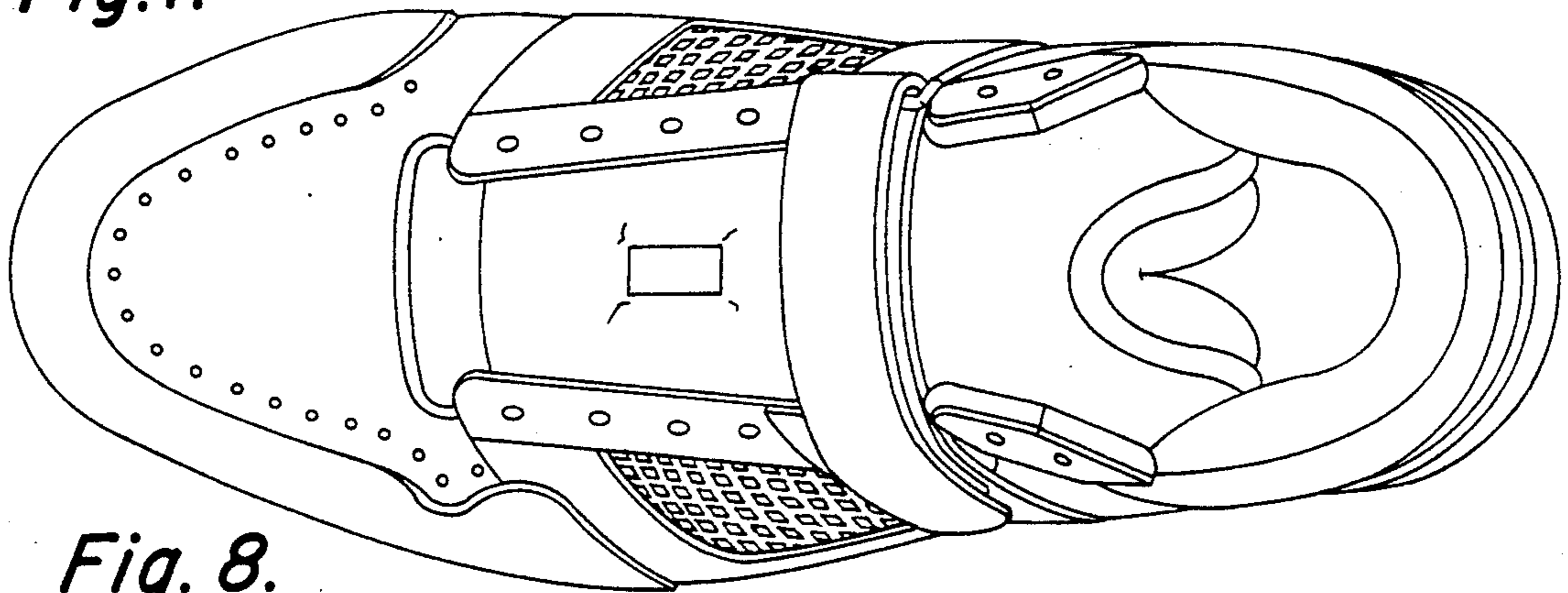

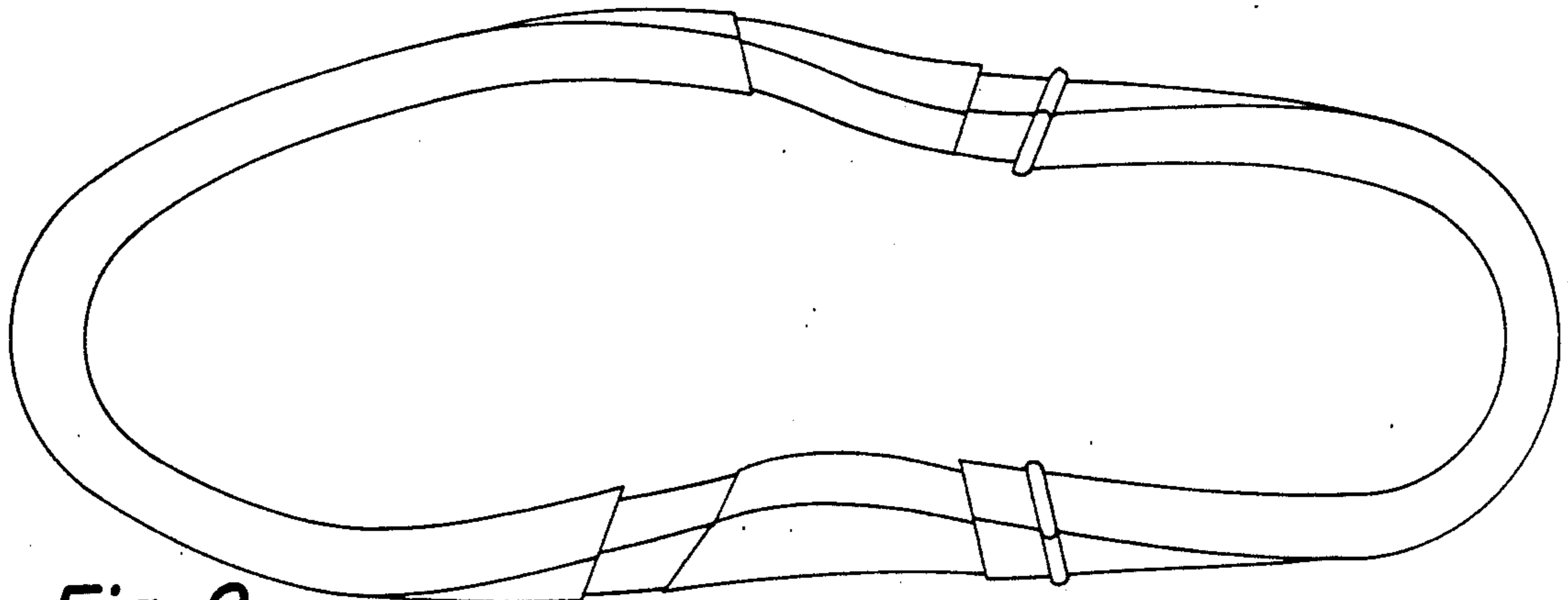

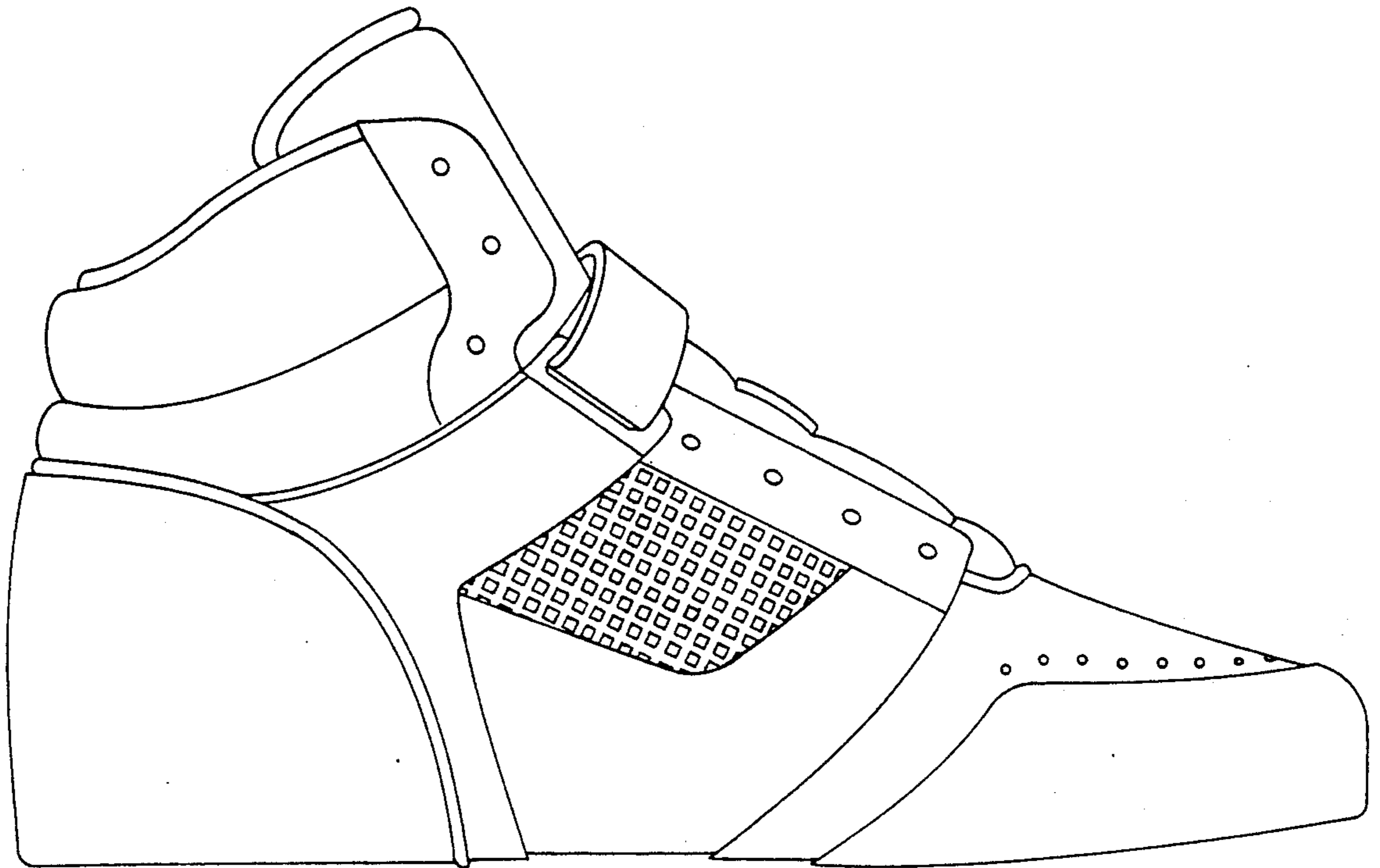

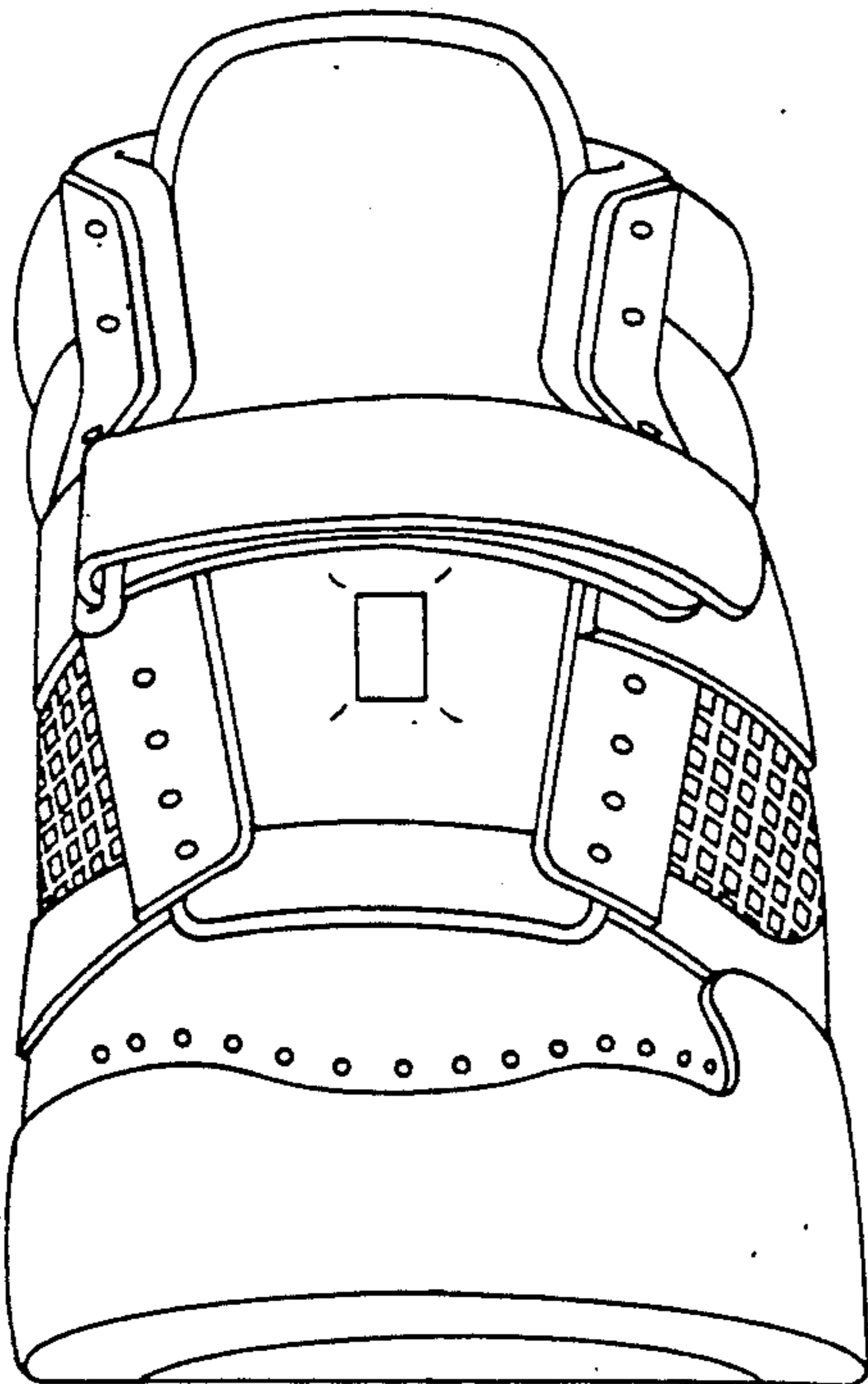

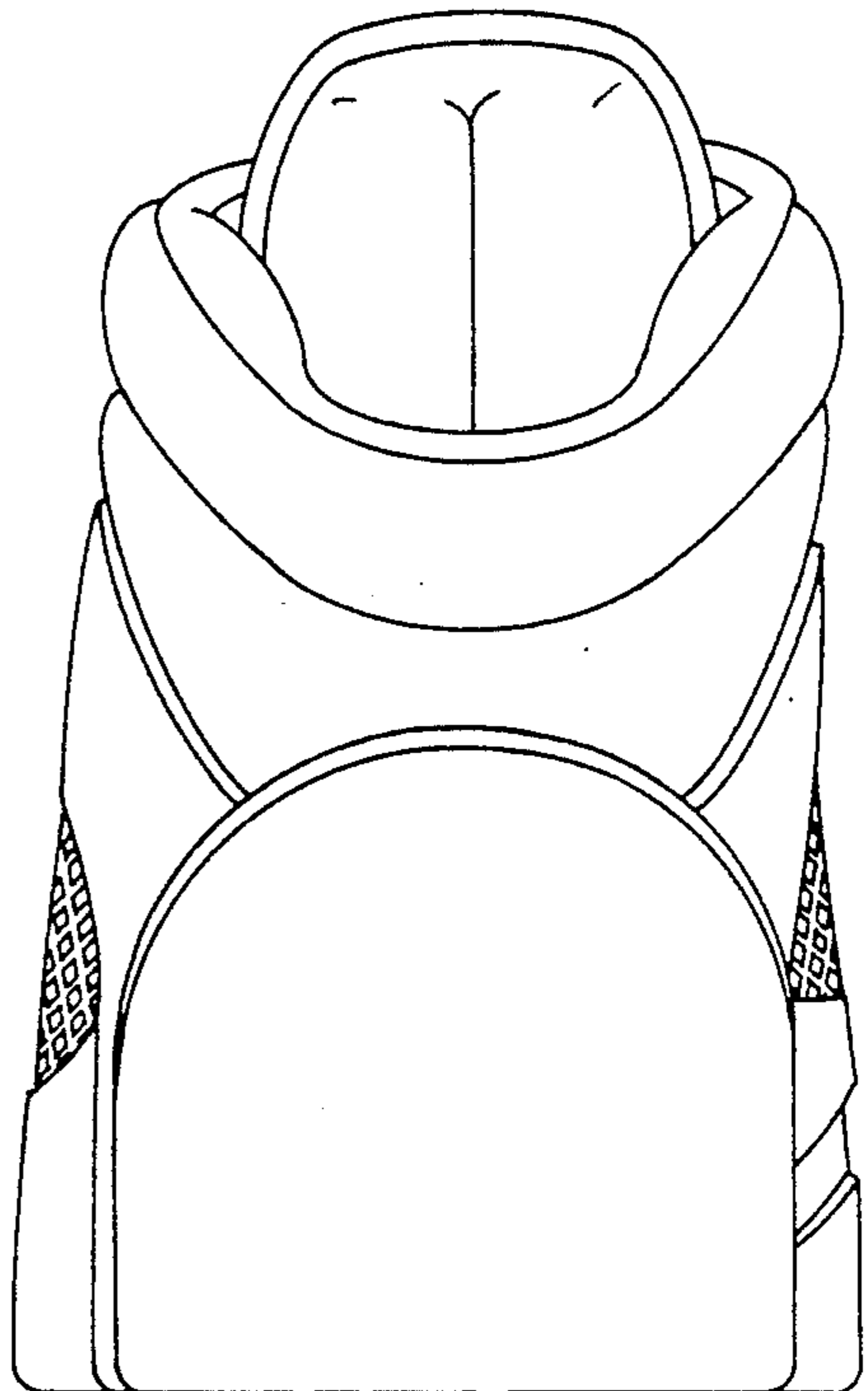
