FIG. 14 is a top plan view of FIG. 9.

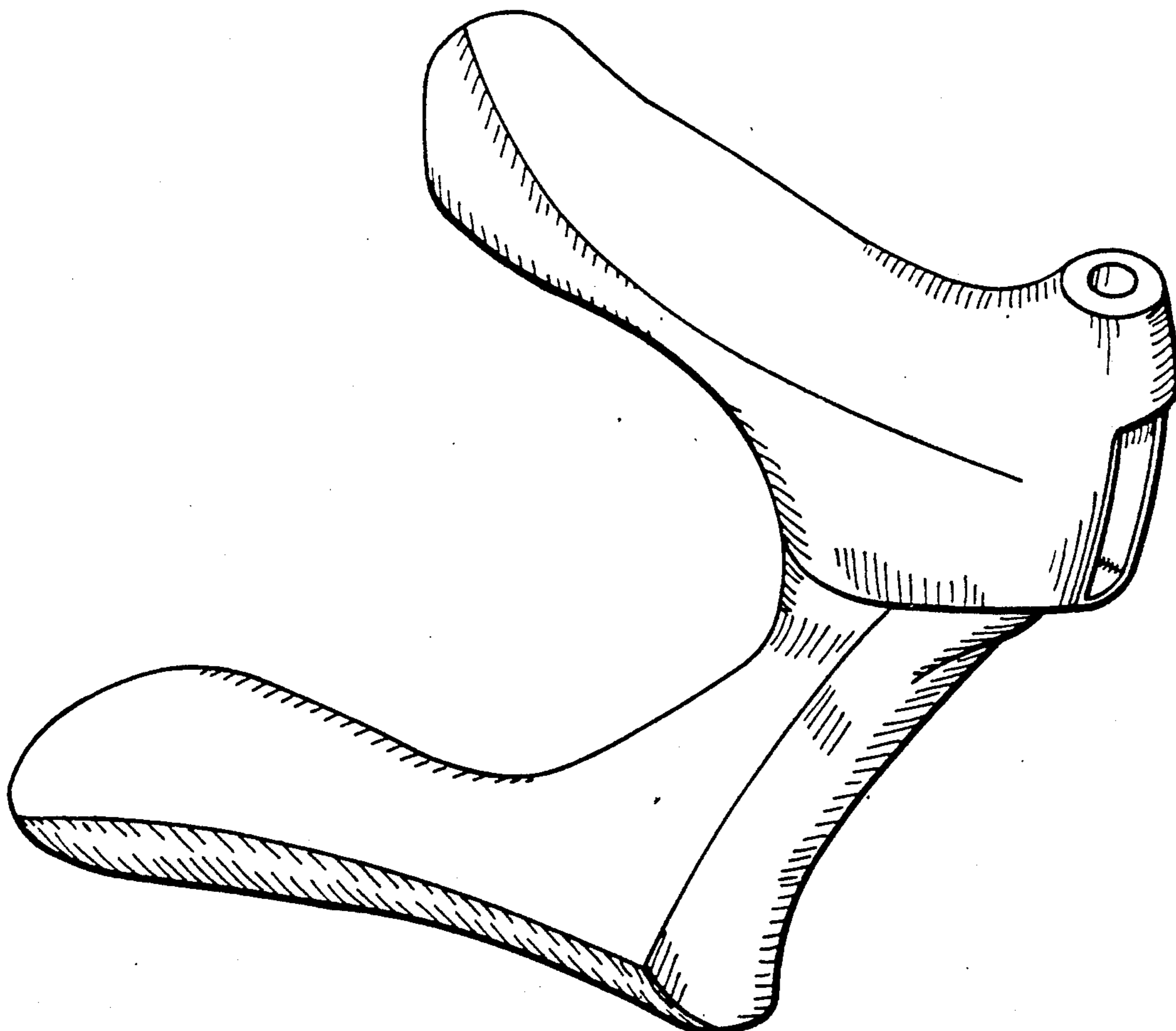

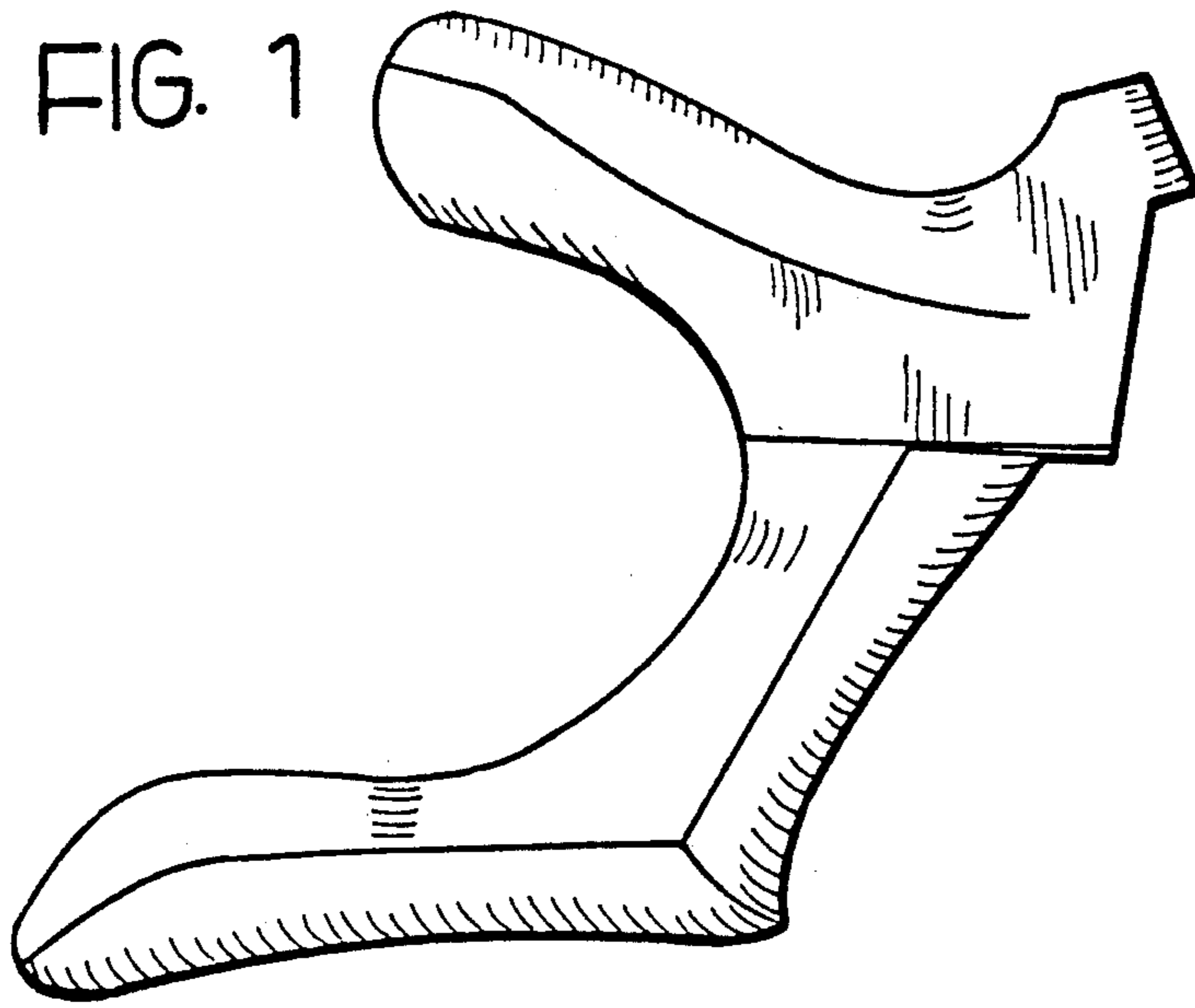

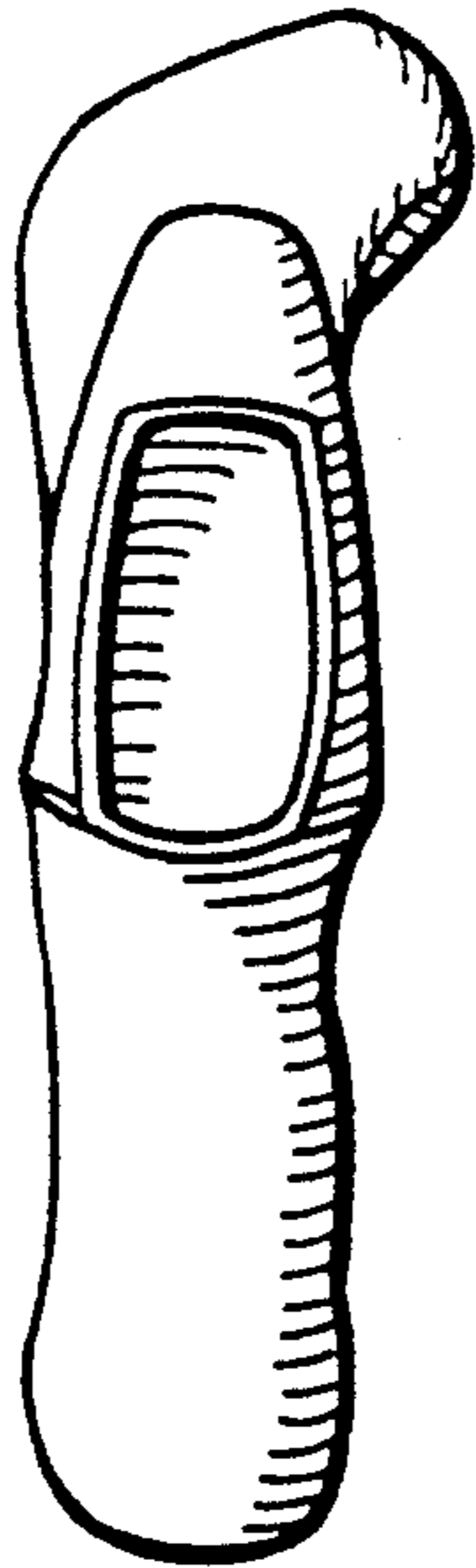

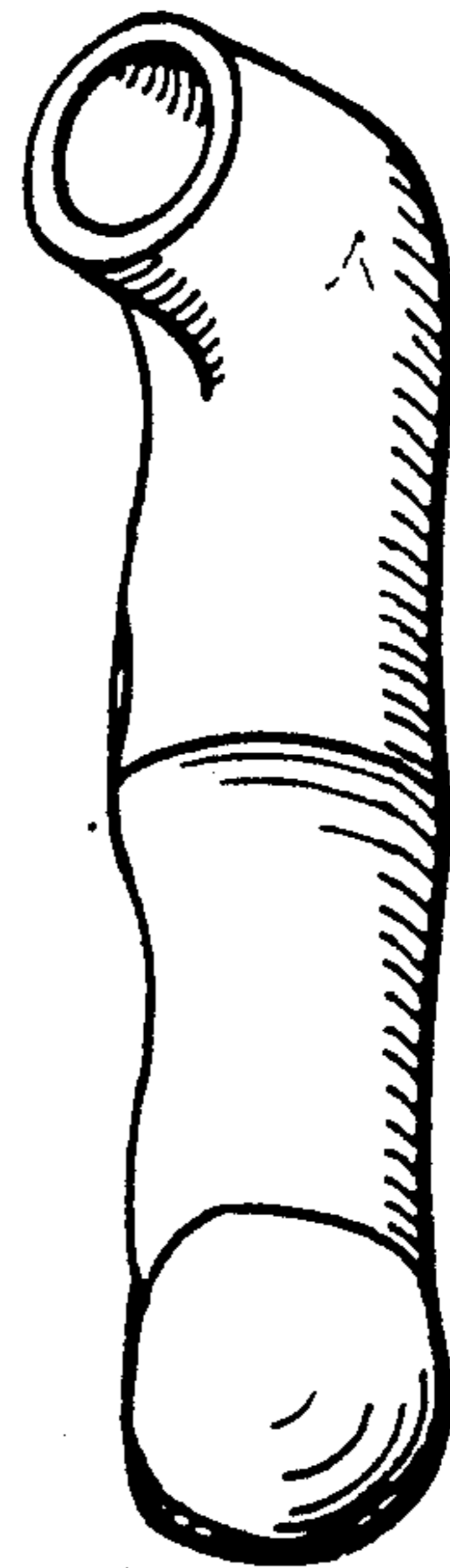

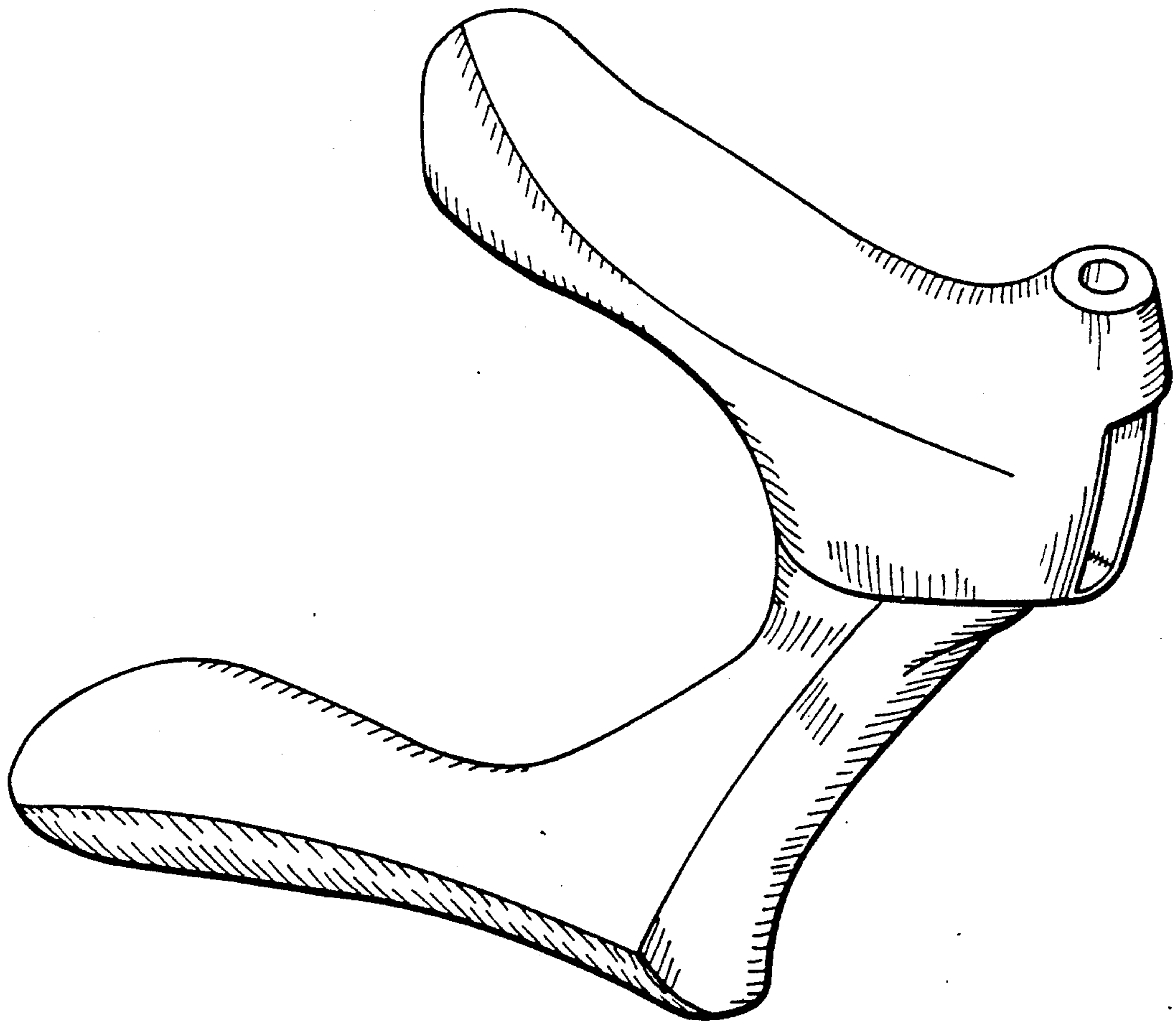

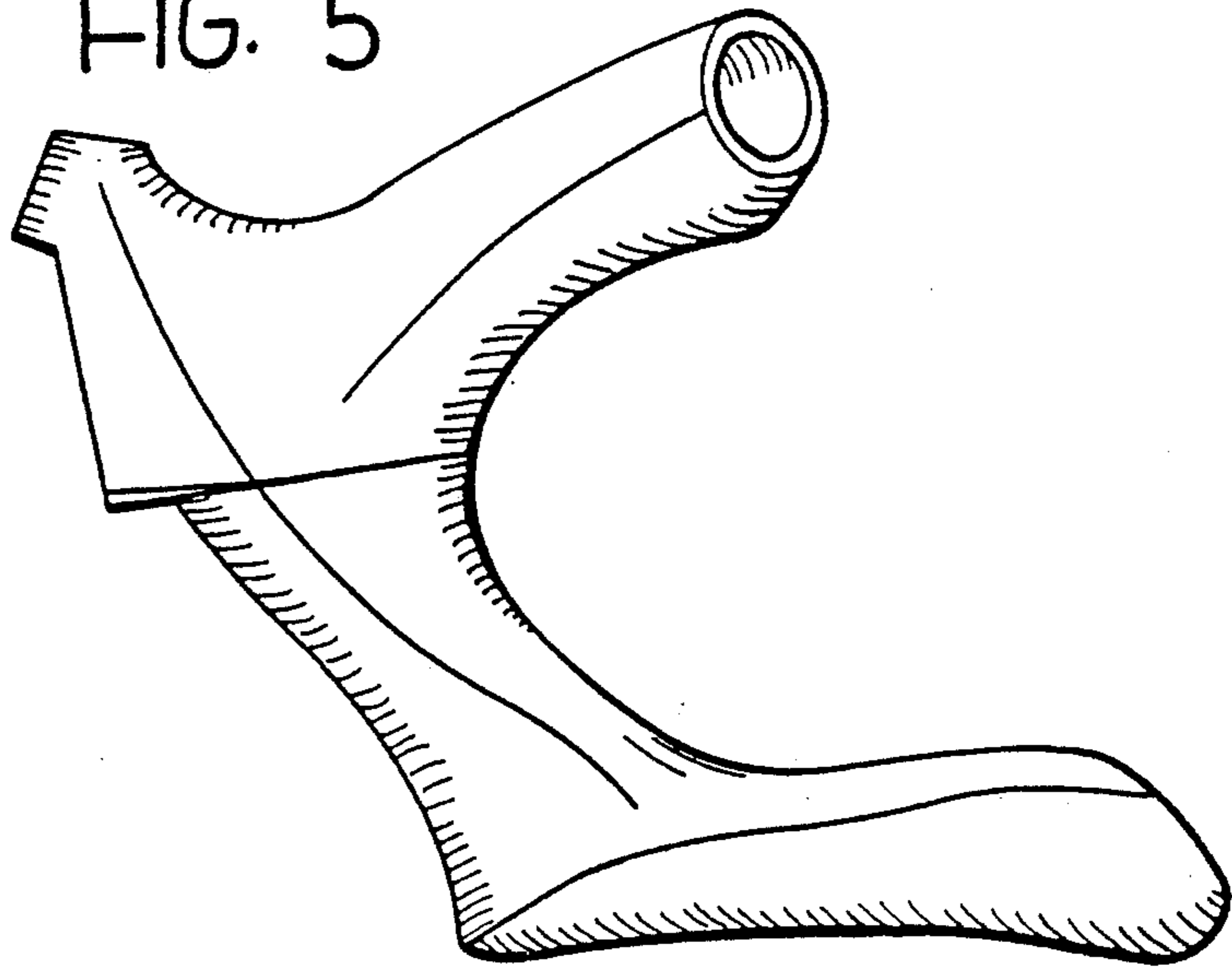

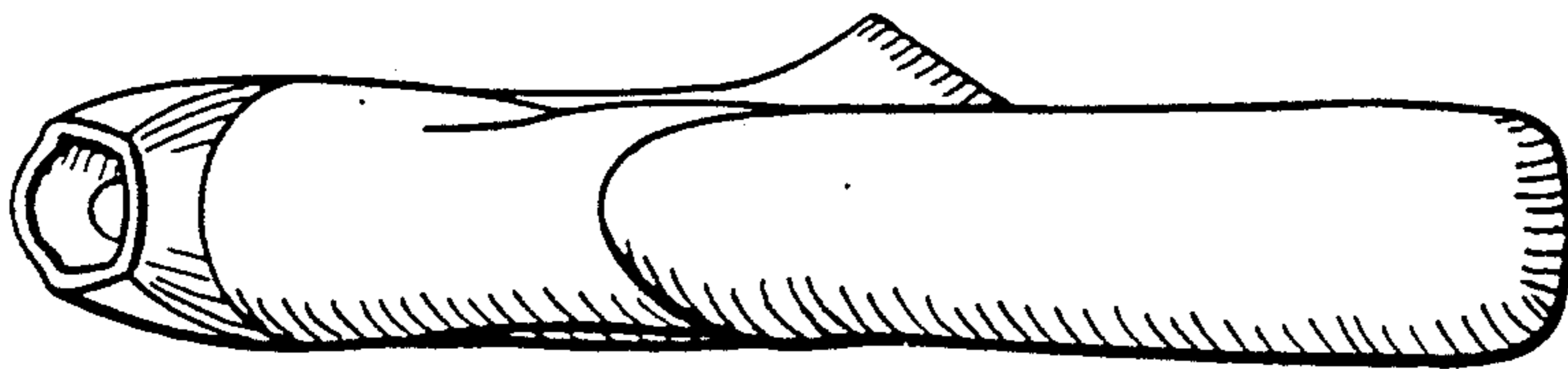

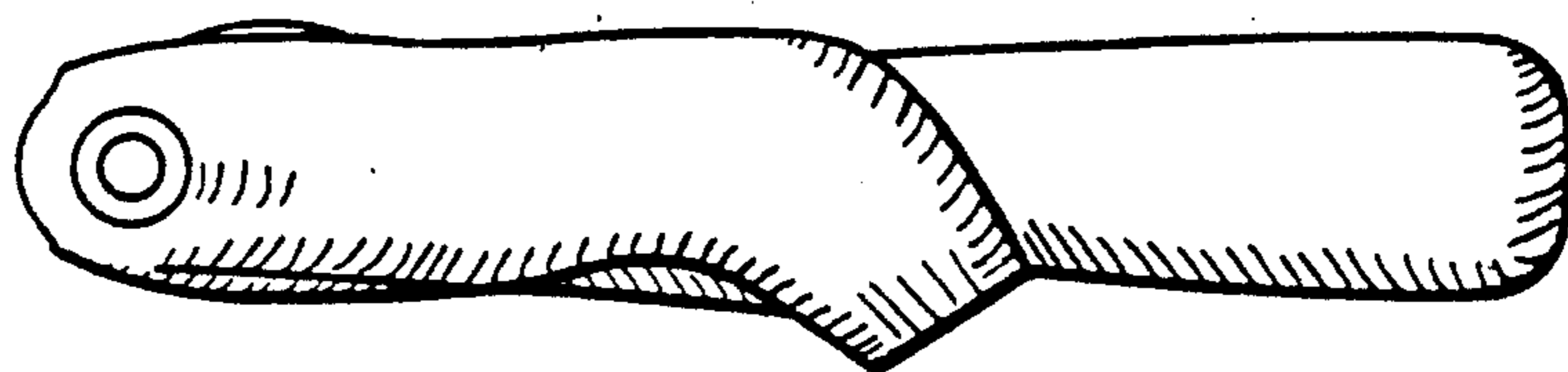

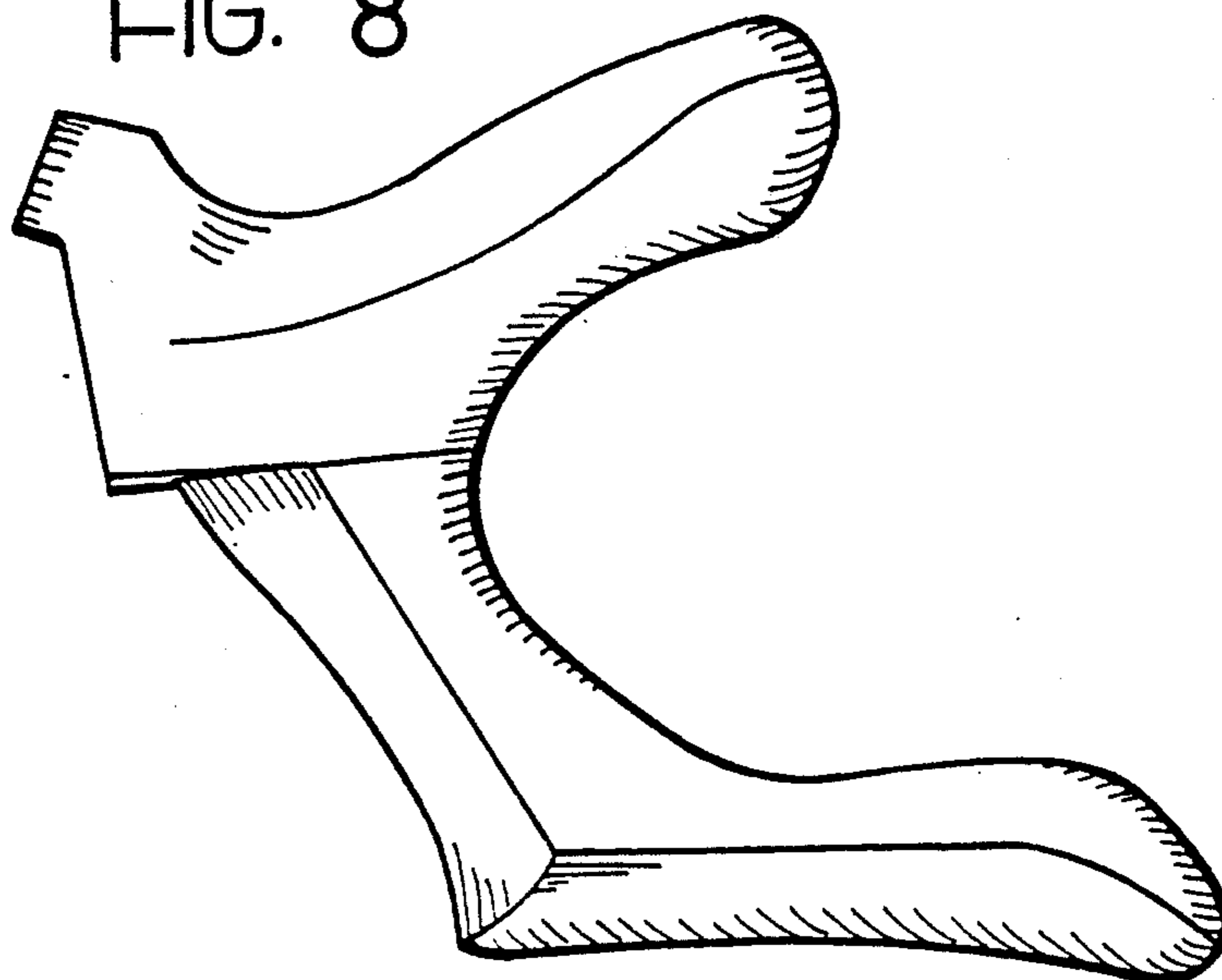

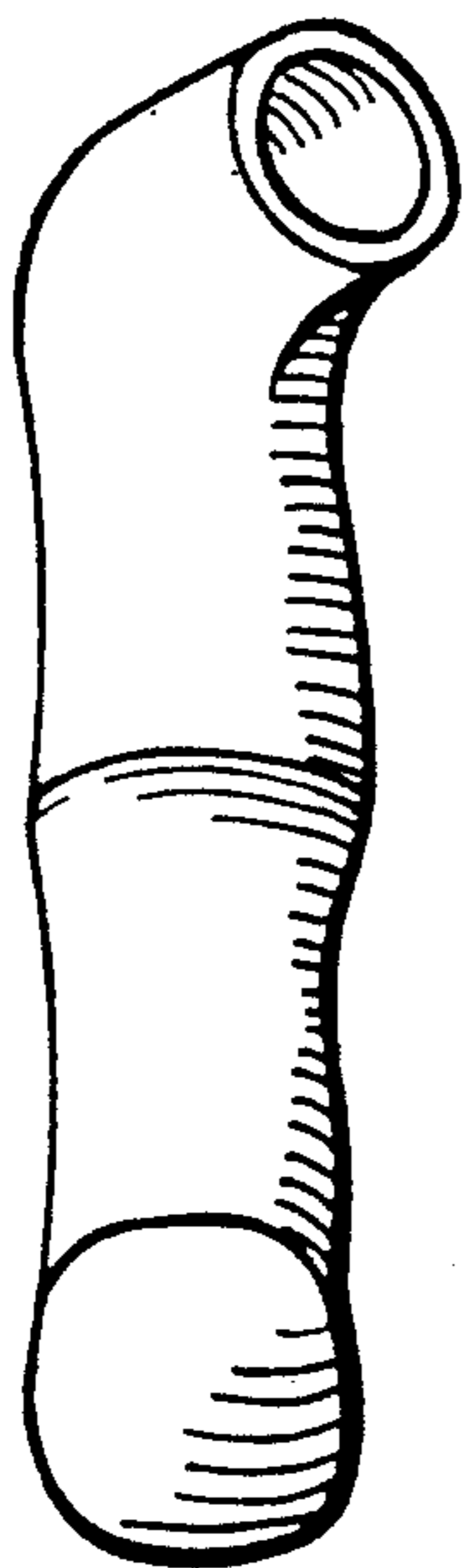

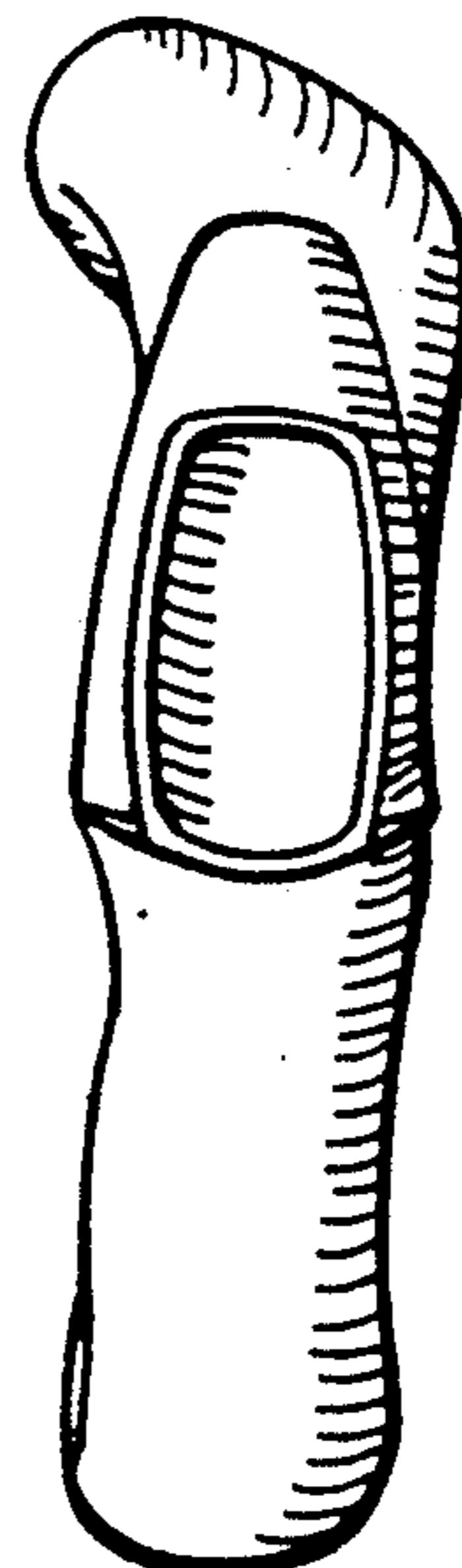

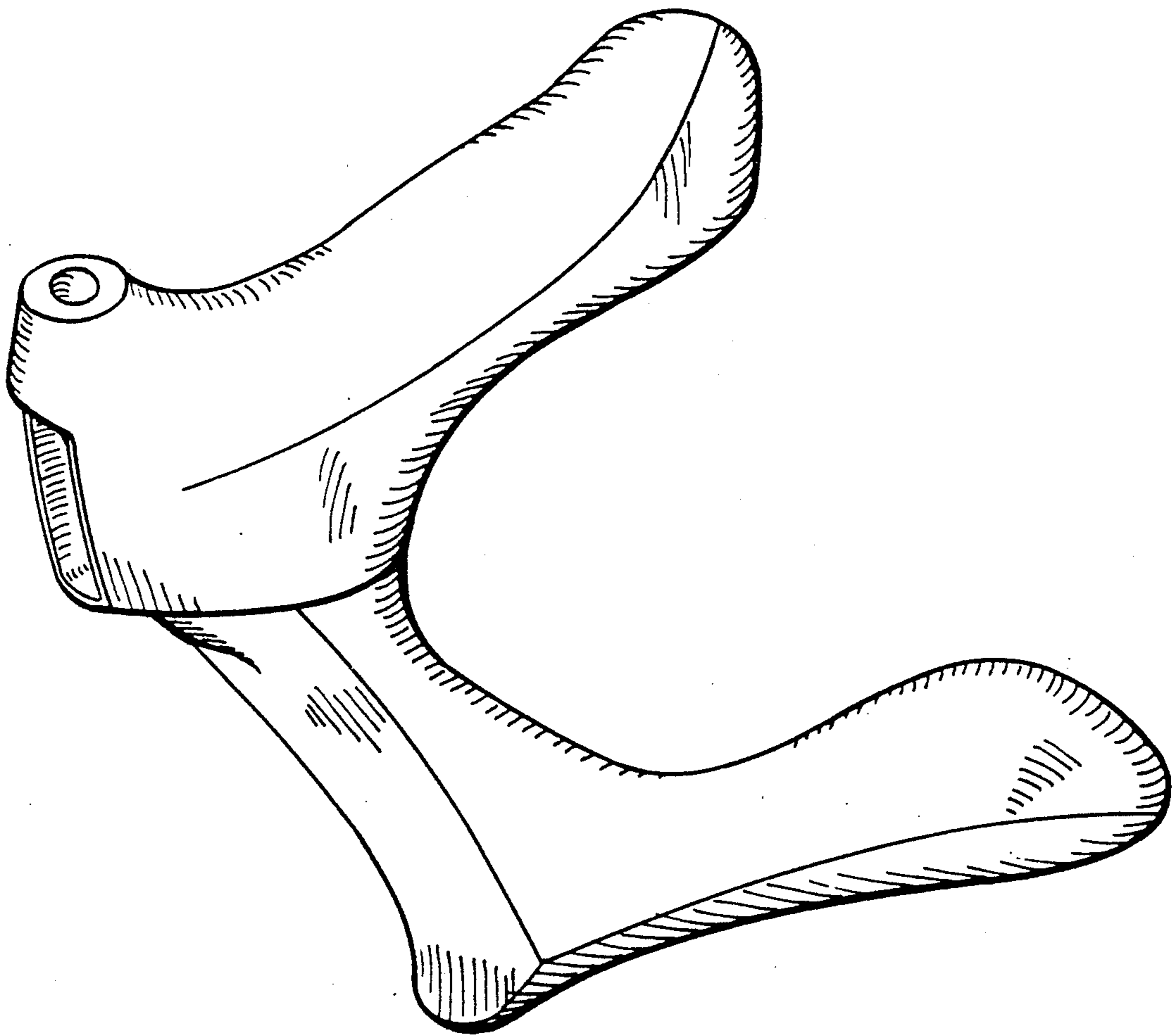

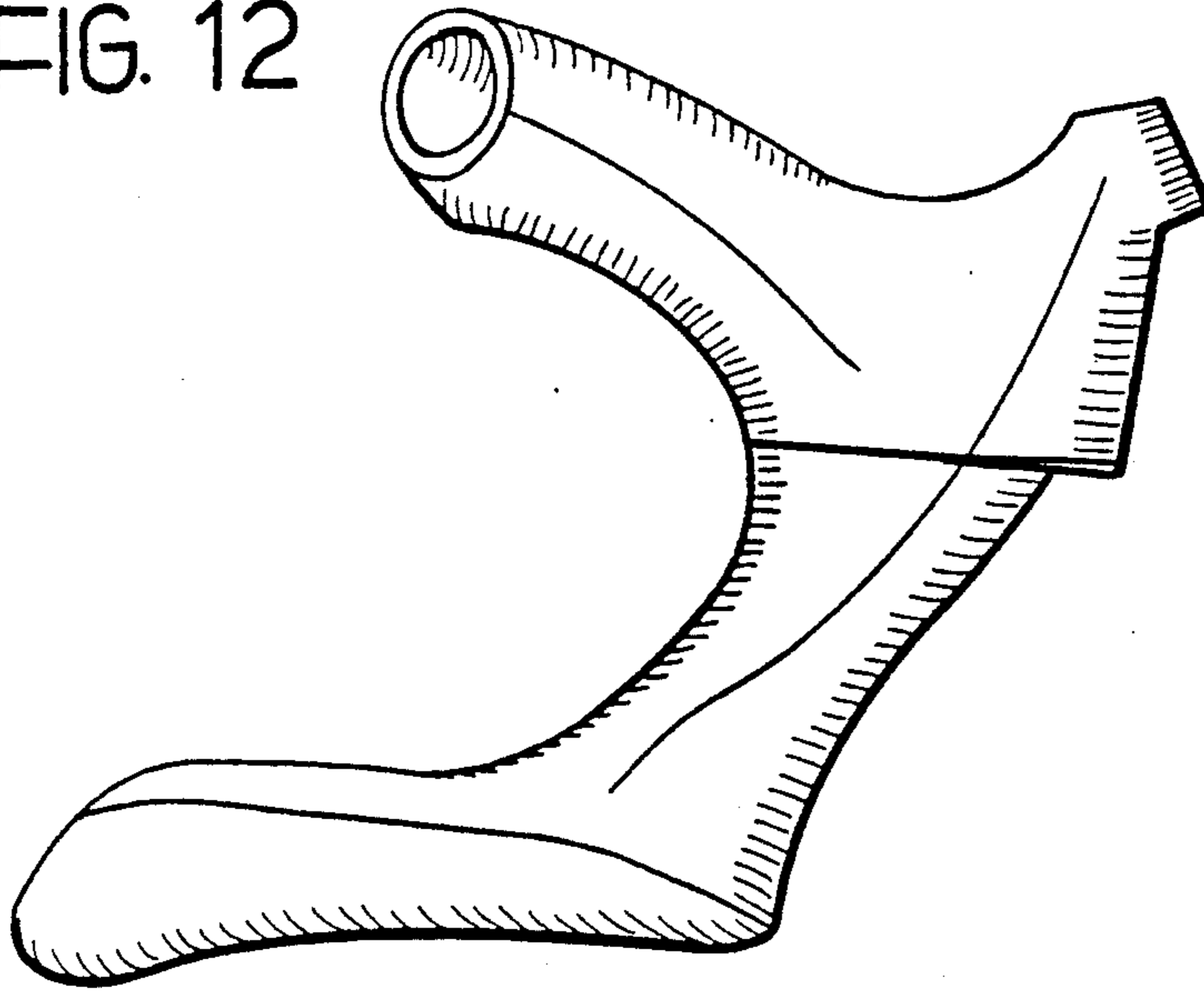

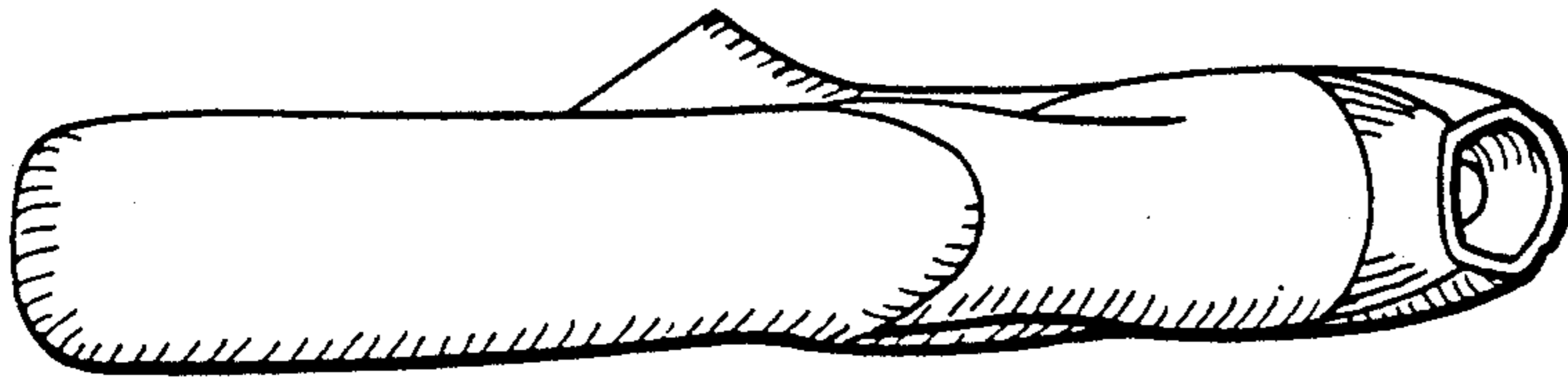
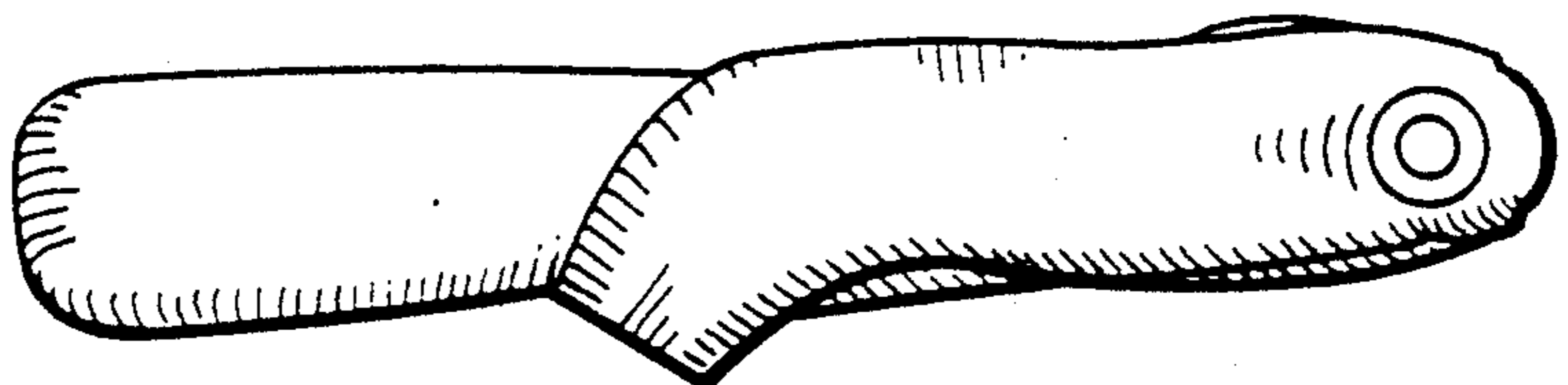
