DESCRIPTION

FIG. 1 is a top, front and right side perspective view of an ultrasonic probe showing my new design;
FIG. 2 is a front elevational view;
FIG. 3 is a top plan view;
FIG. 4 is a right side elevational view;
FIG. 5 is a left side elevational view;
FIG. 6 is a rear elevational view;
FIG. 7 is a top, front and right side perspective view of an alternative embodiment of FIGS. 1-6;

FIG. 10 is a right side elevational view;
FIG. 11 is a left side elevational view; and
FIG. 12 is a rear elevational view thereof.

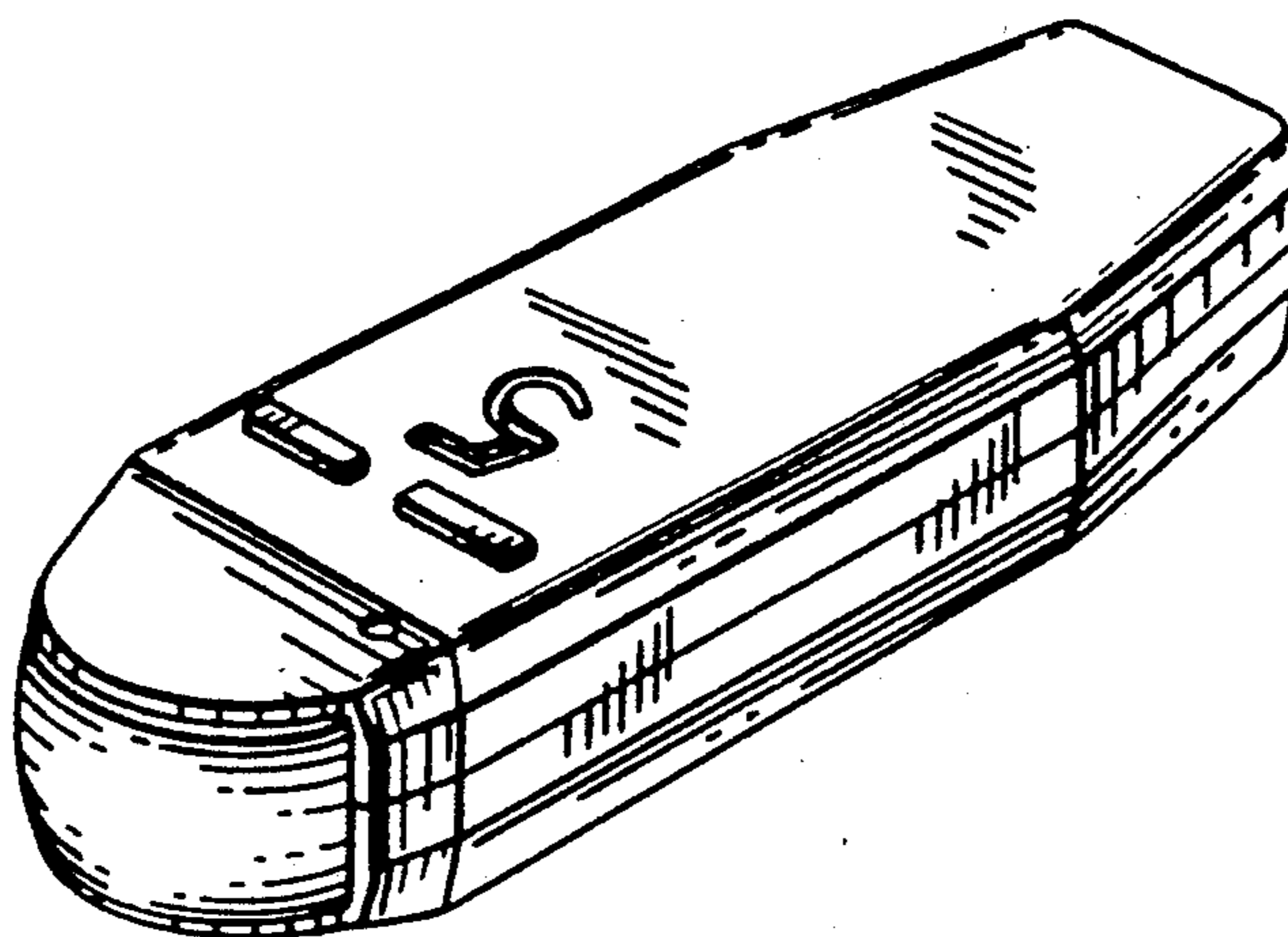

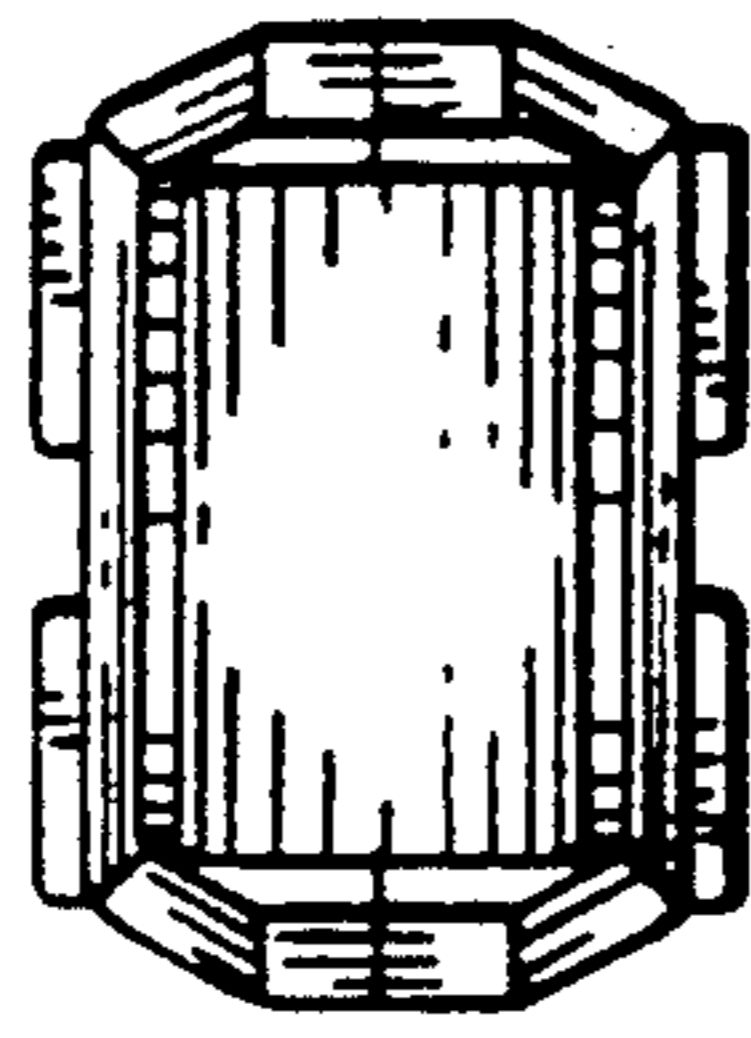

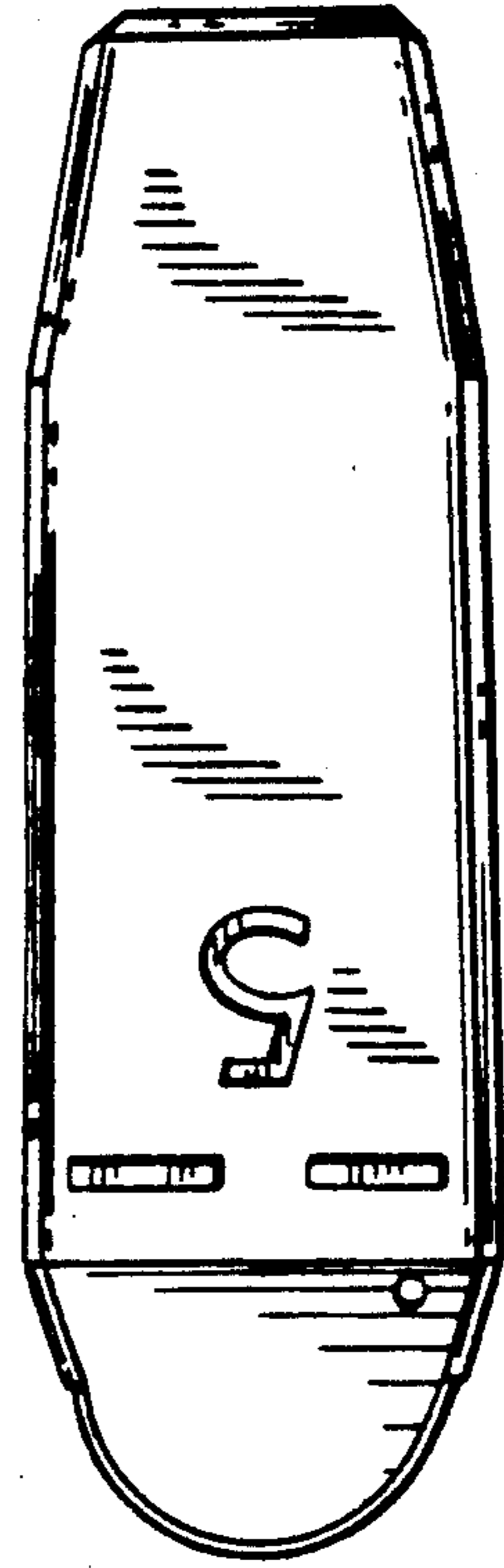
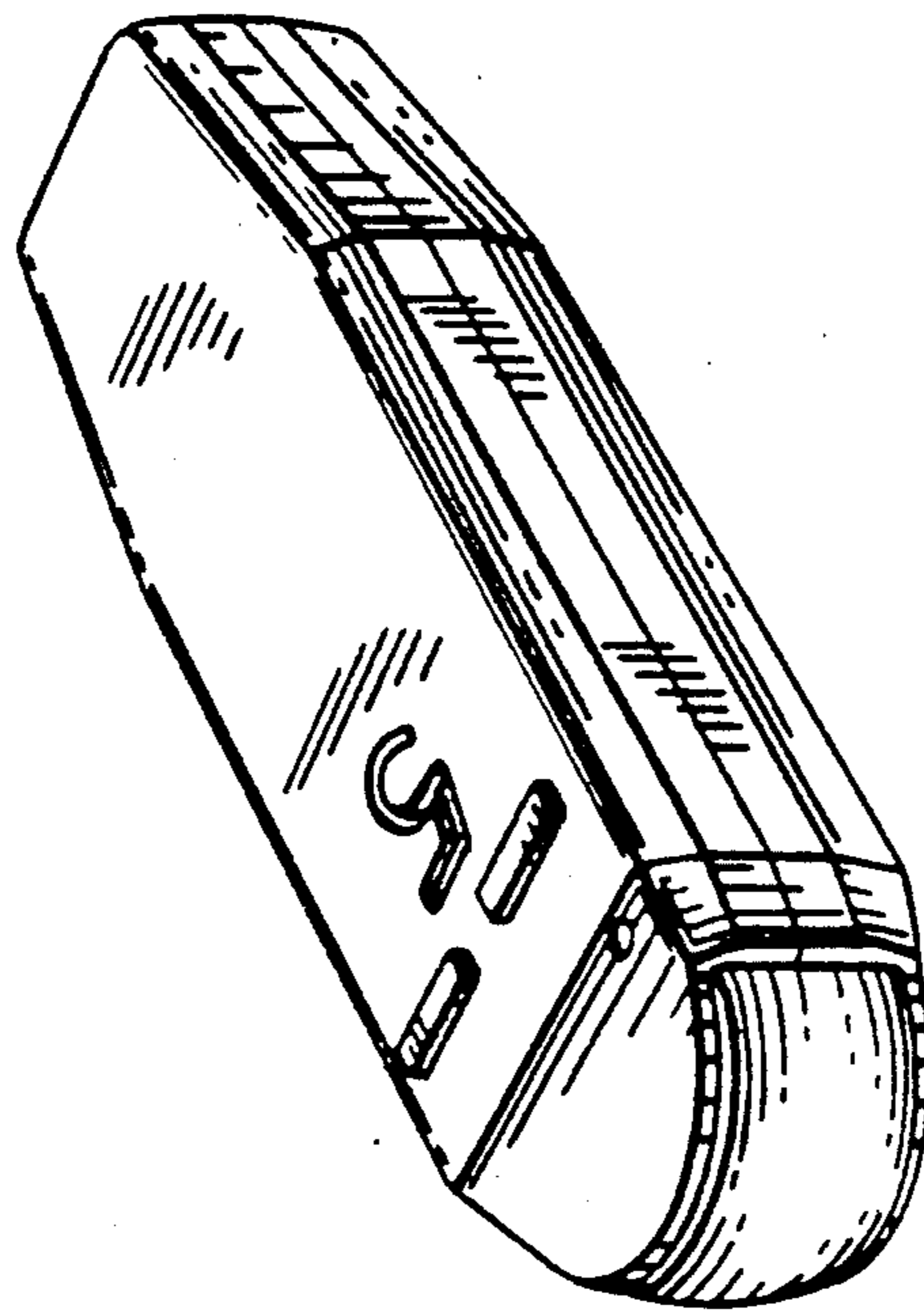

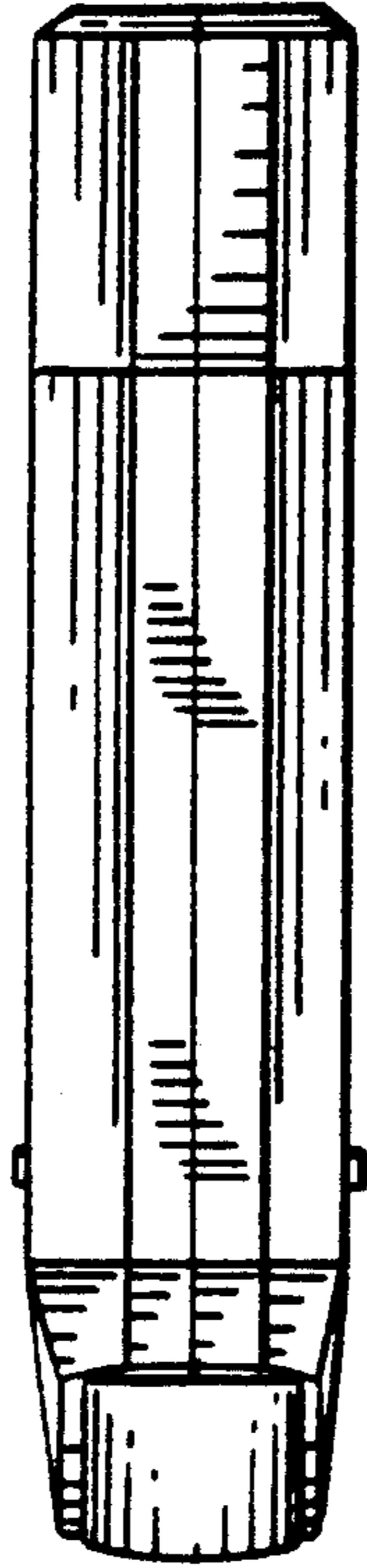

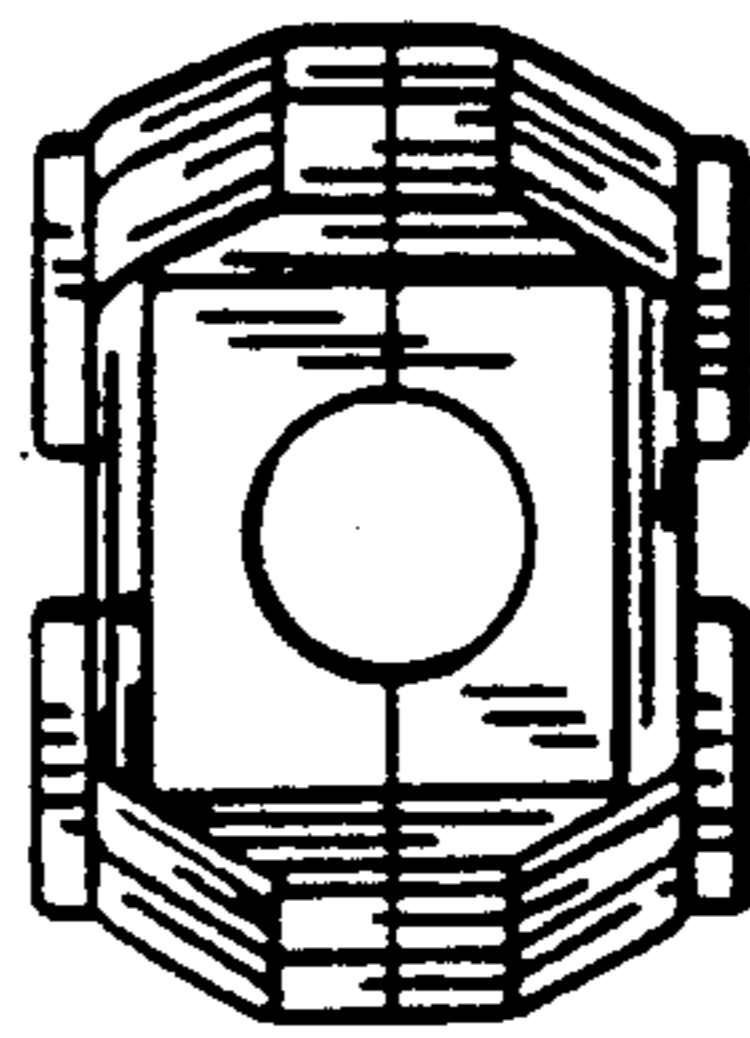
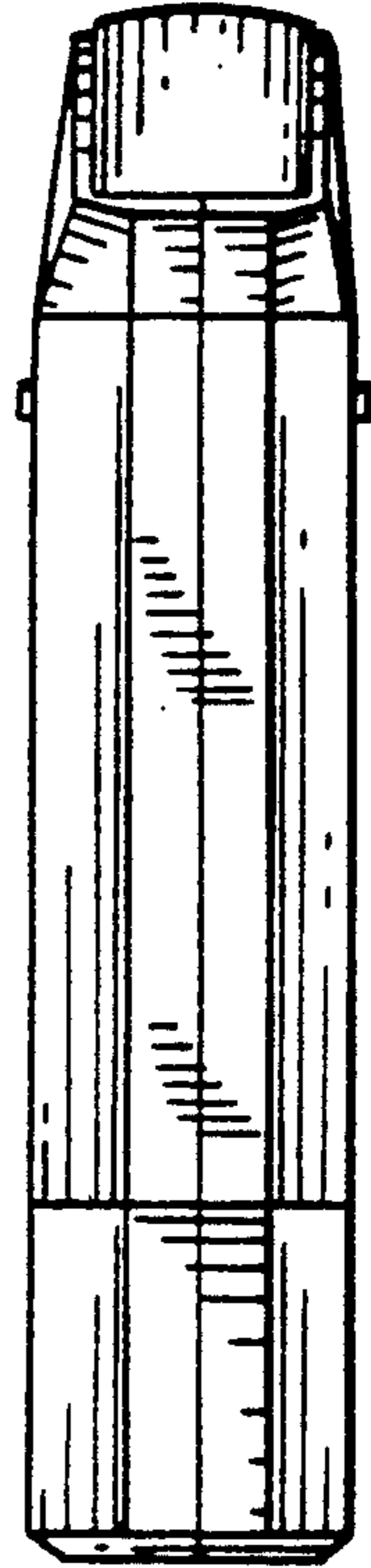

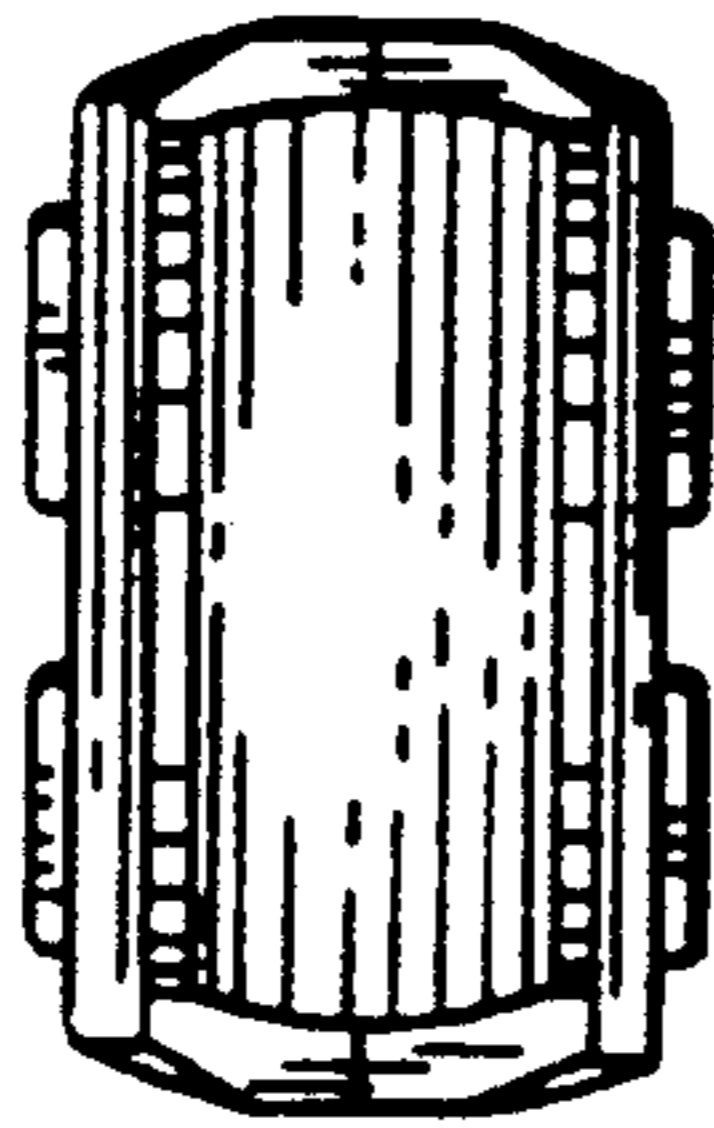

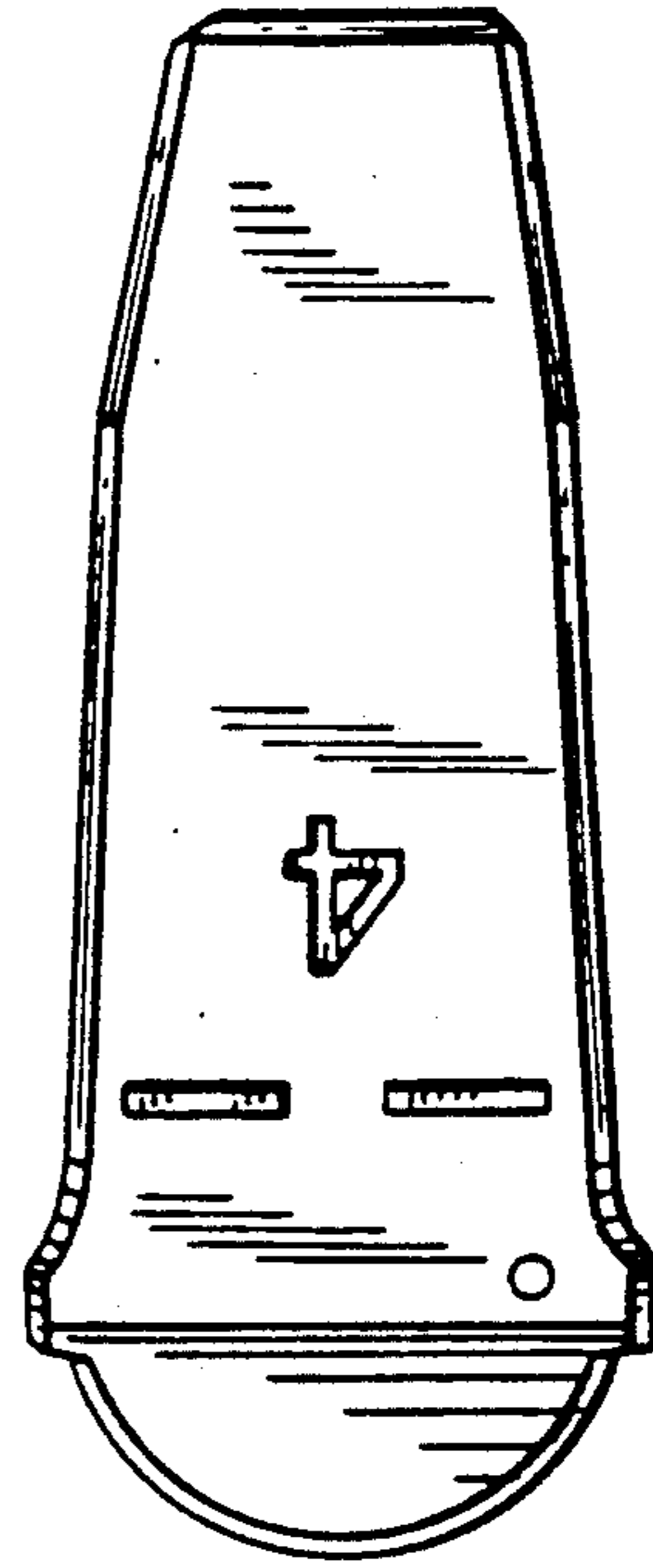
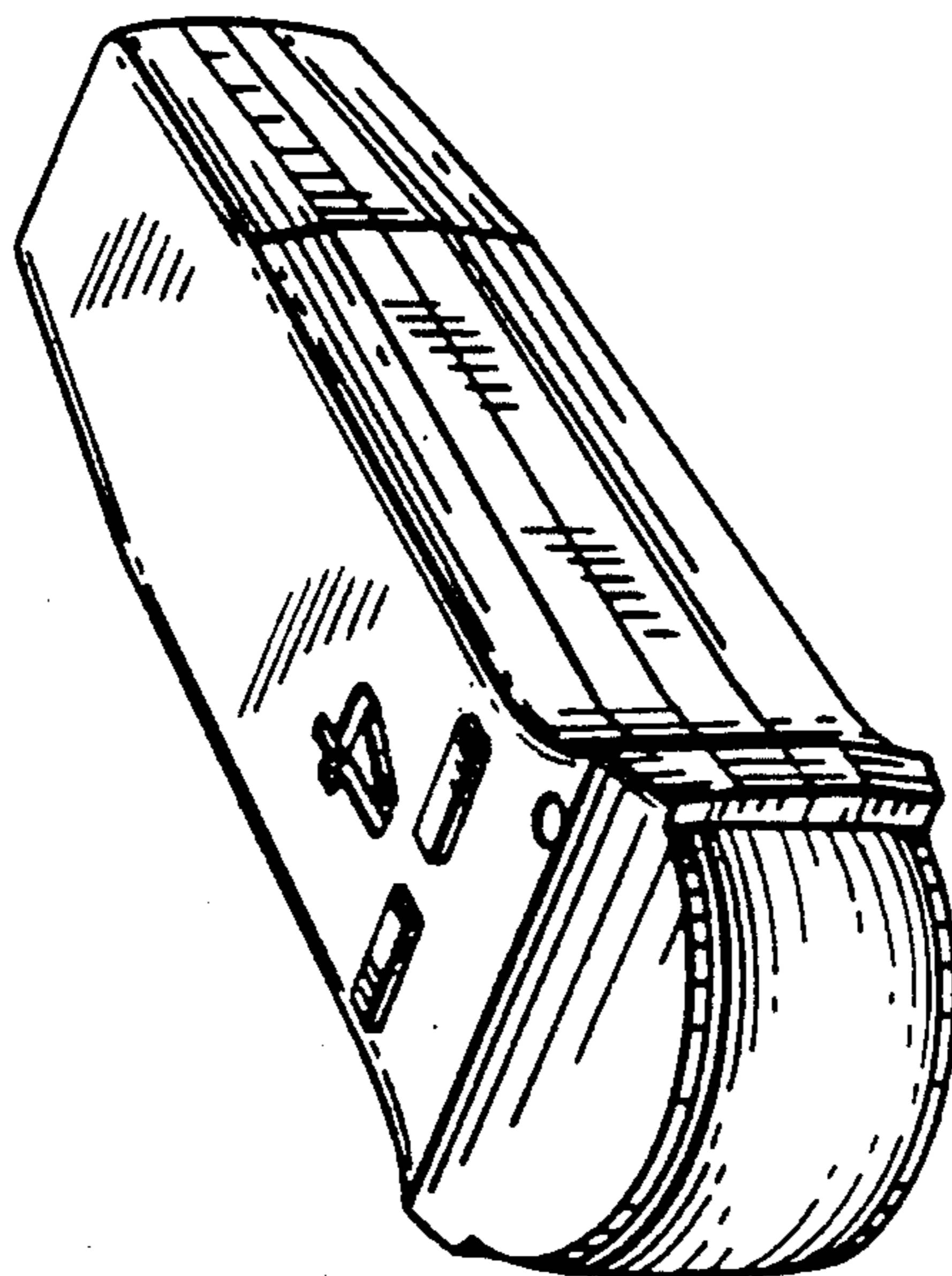

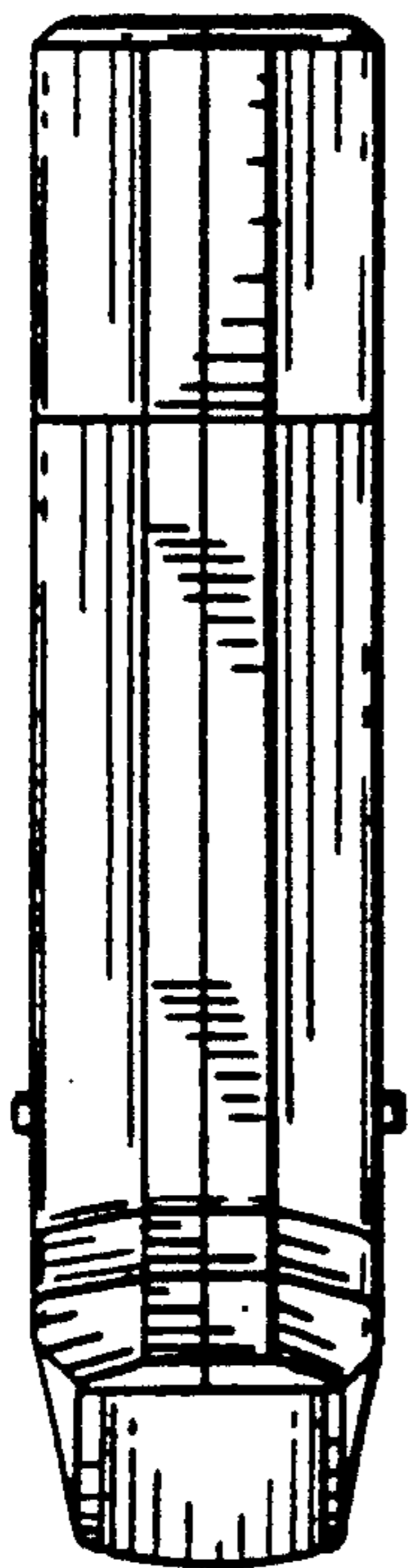

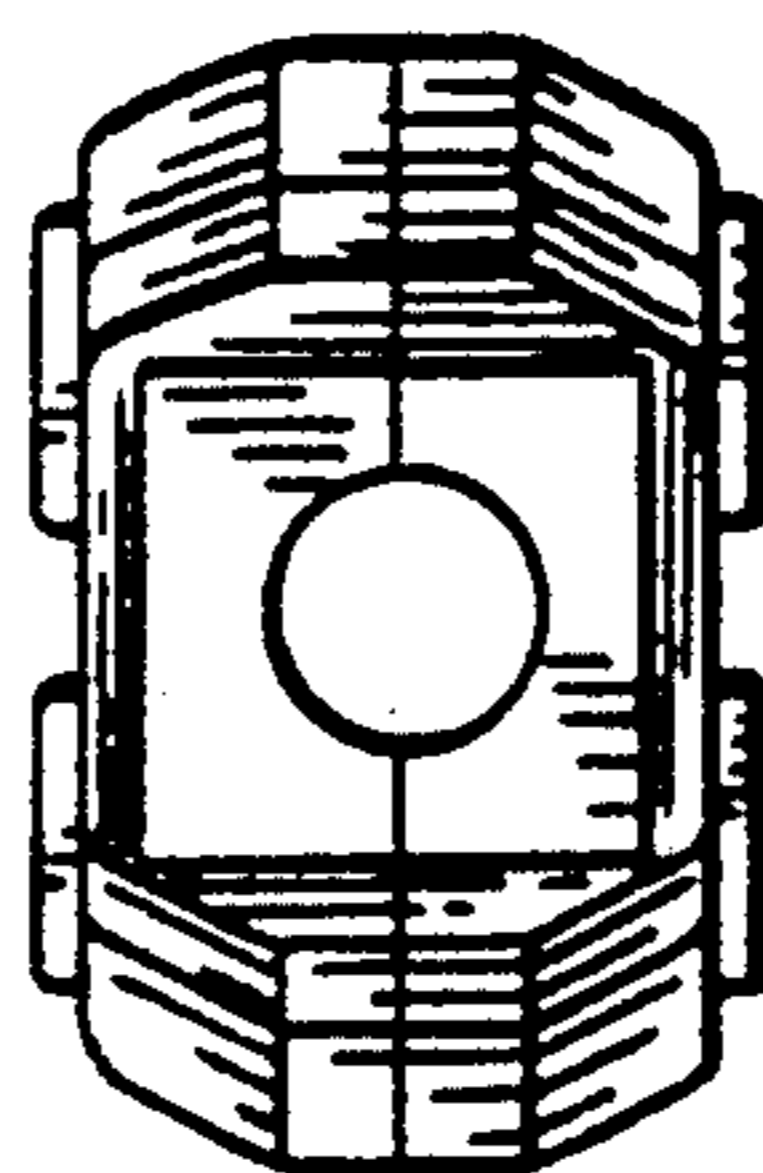
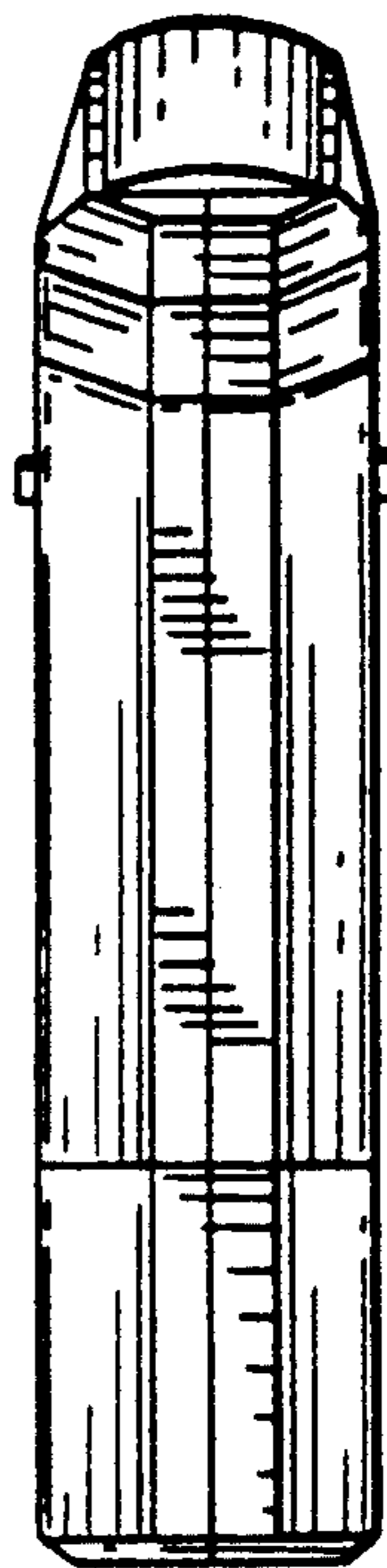
