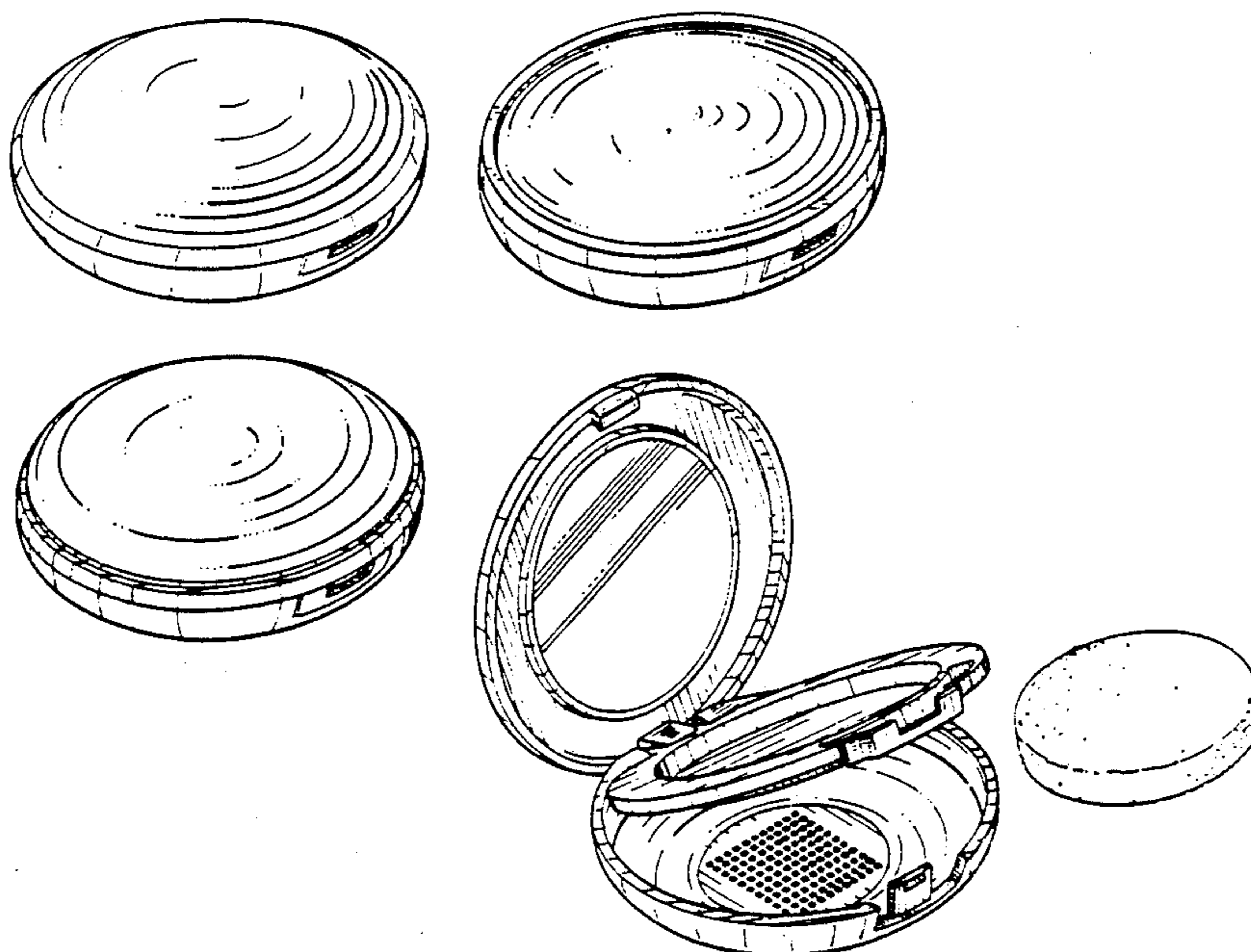

DESCRIPTION

 FIG. 24 is a rear elevational view thereof.



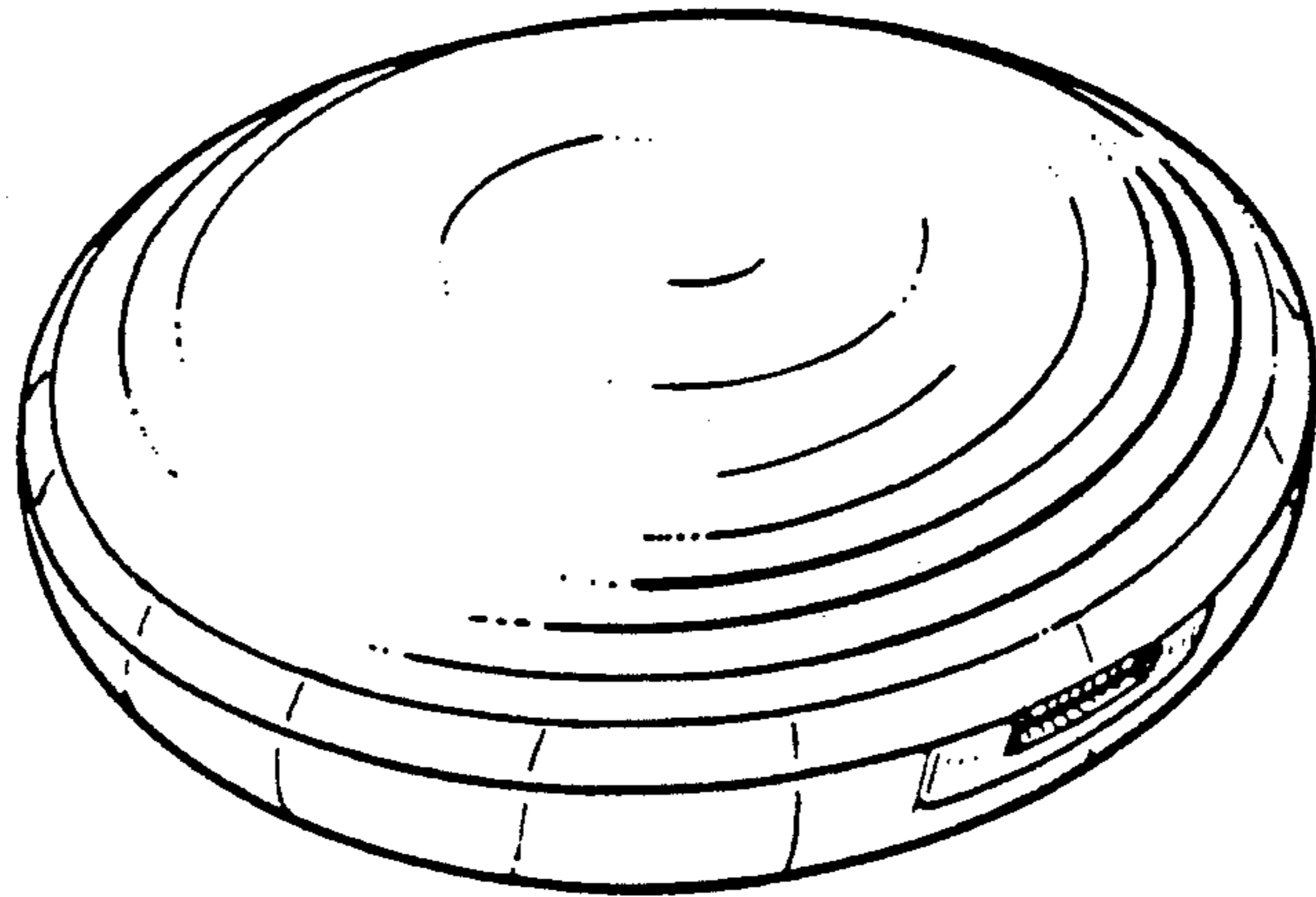

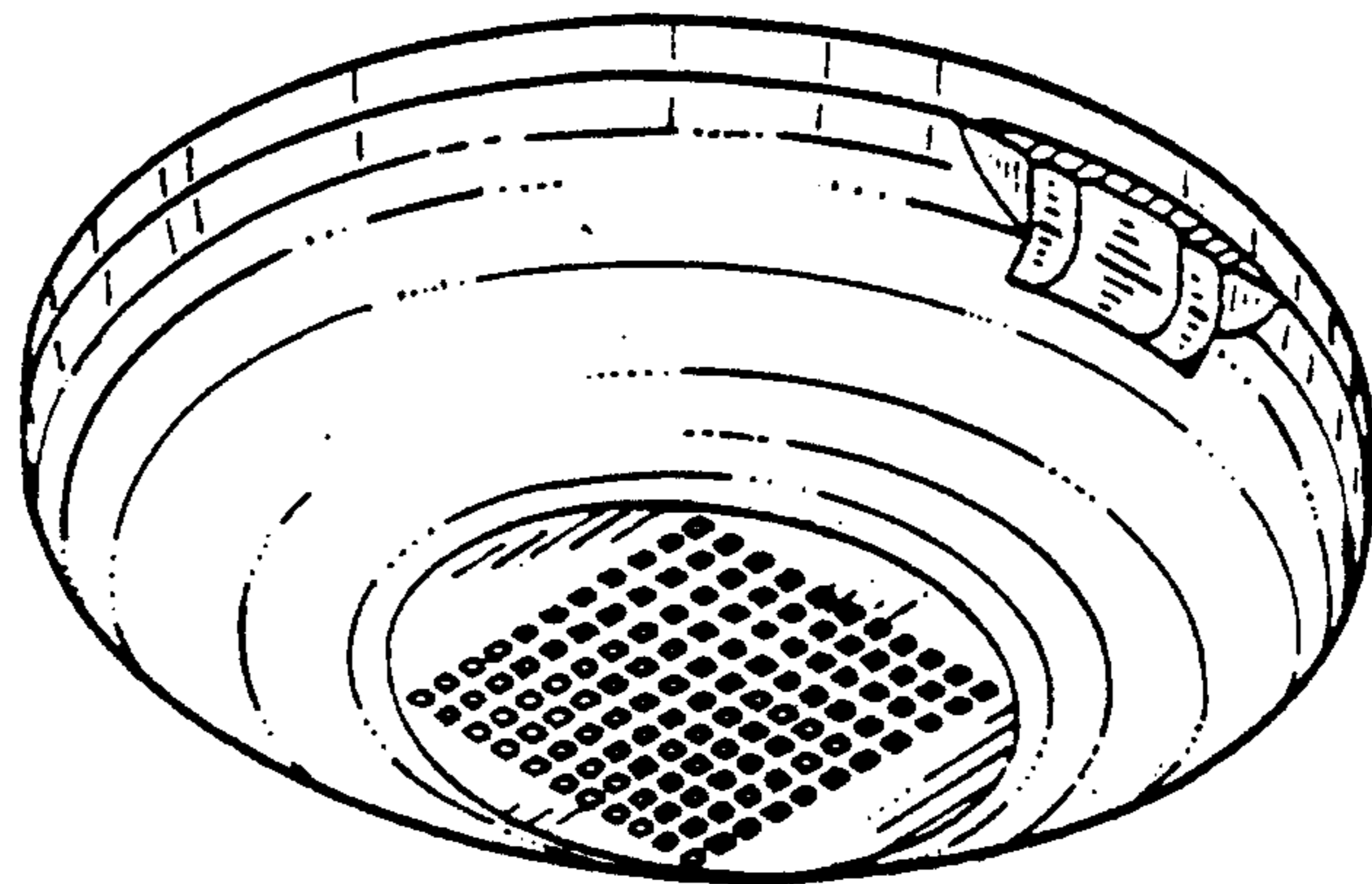

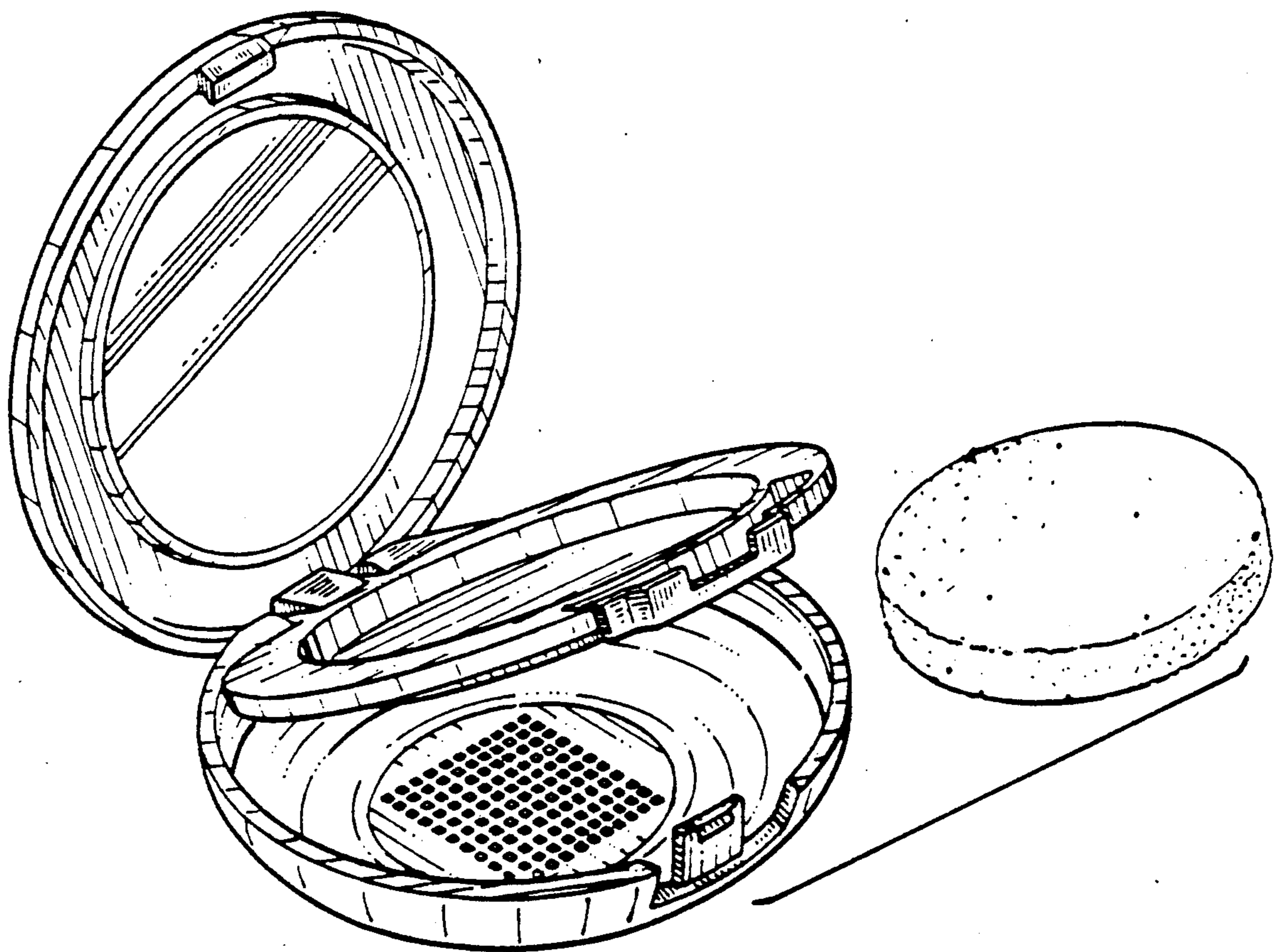

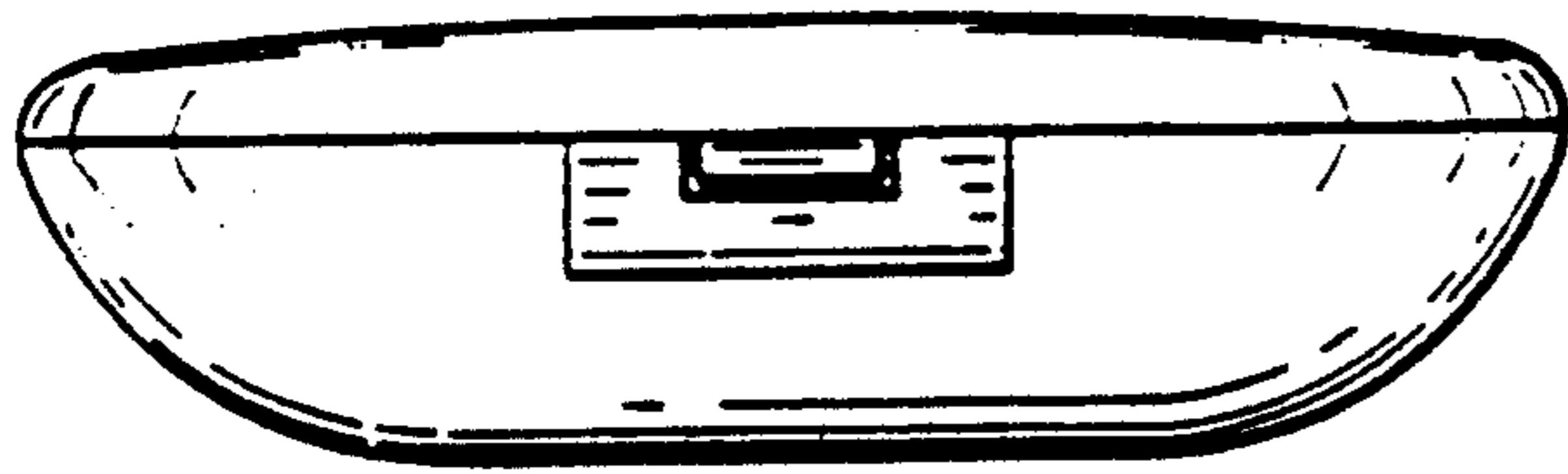

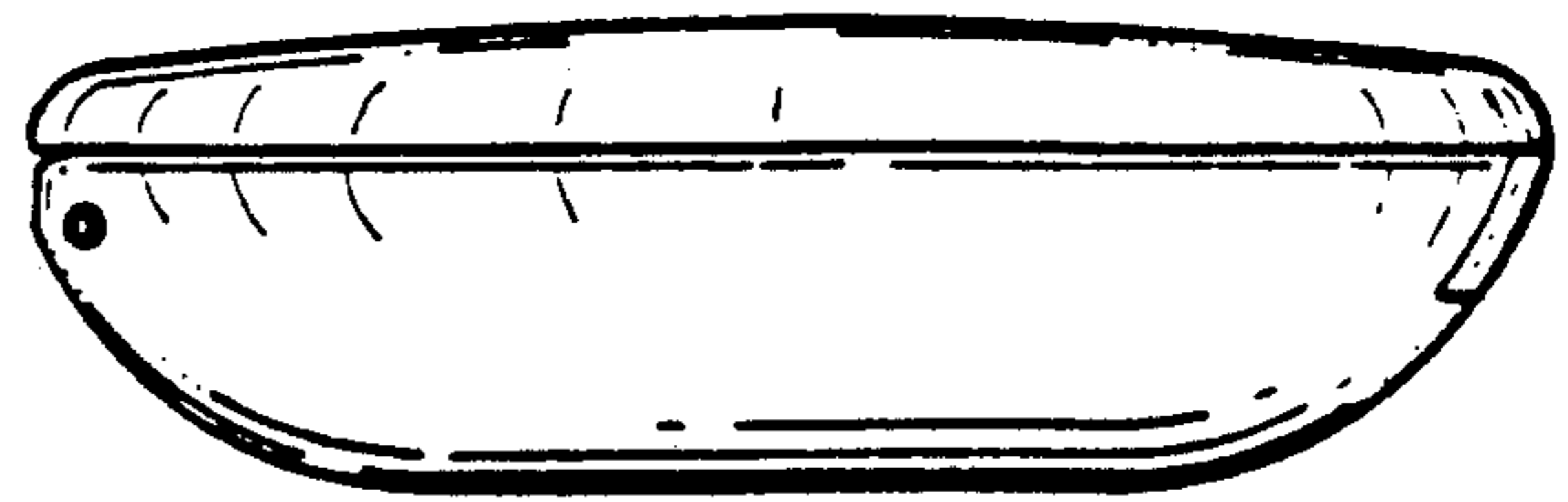

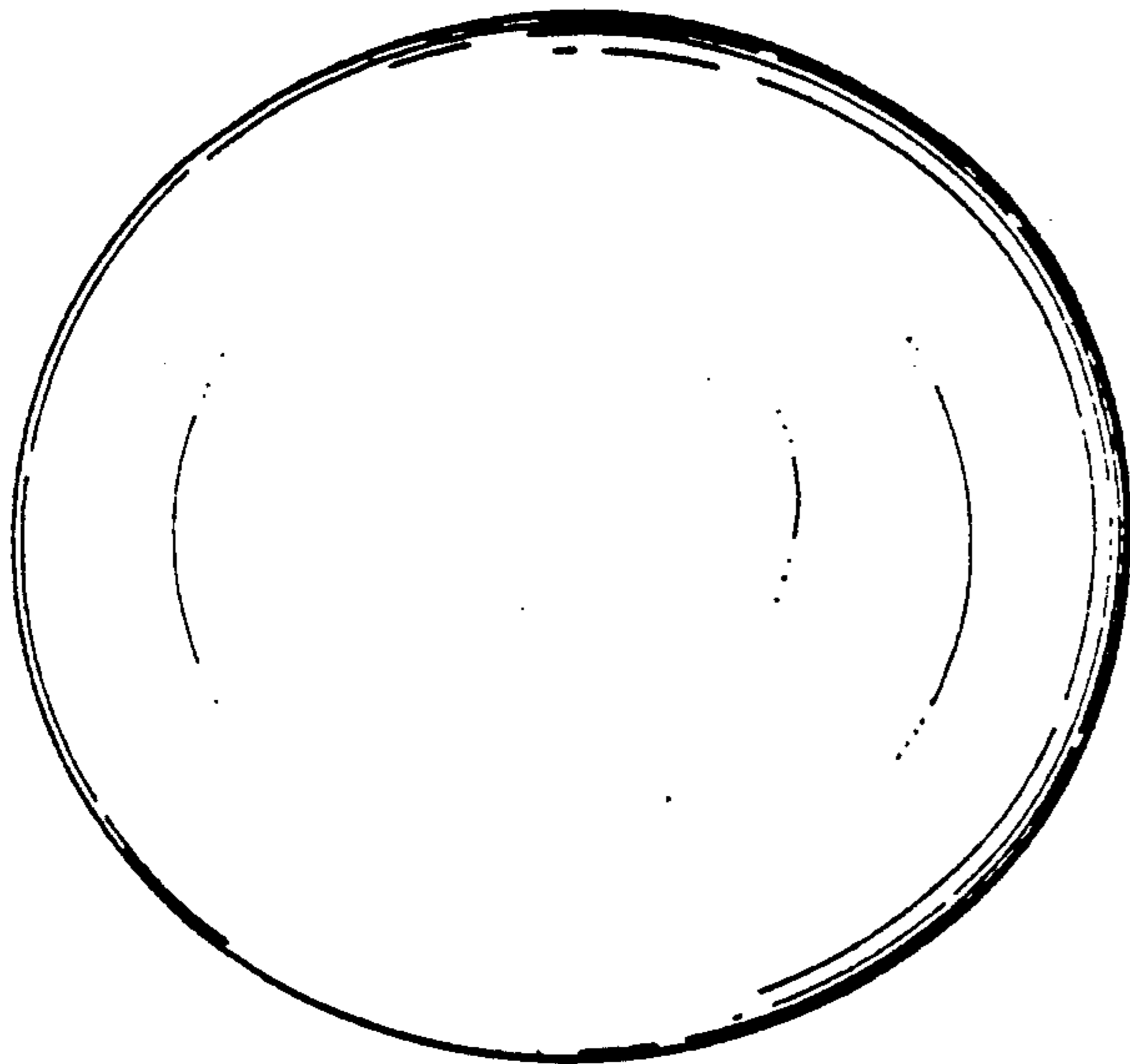

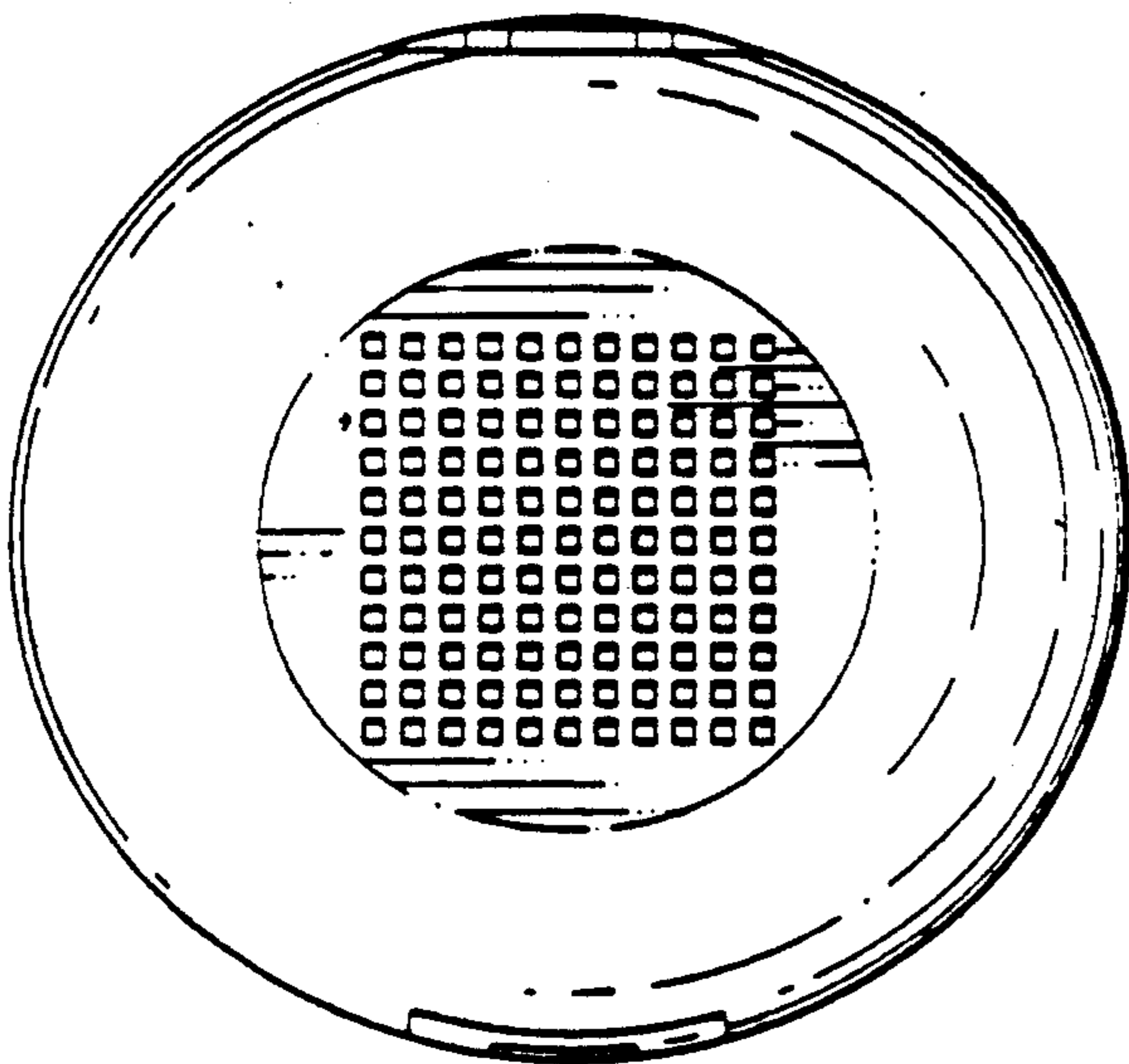

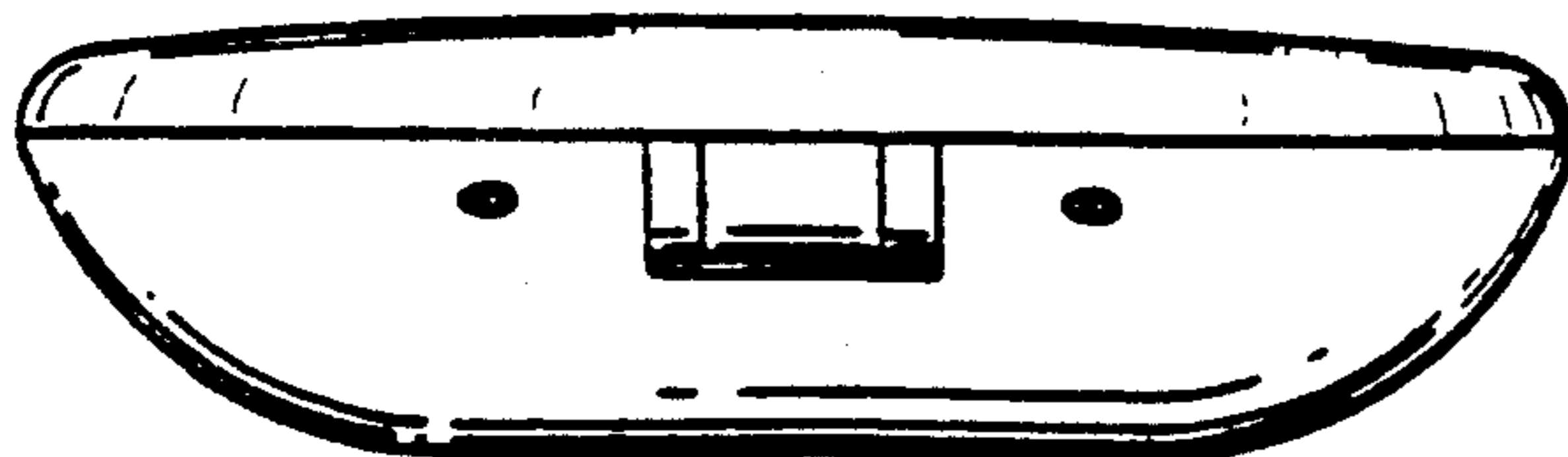

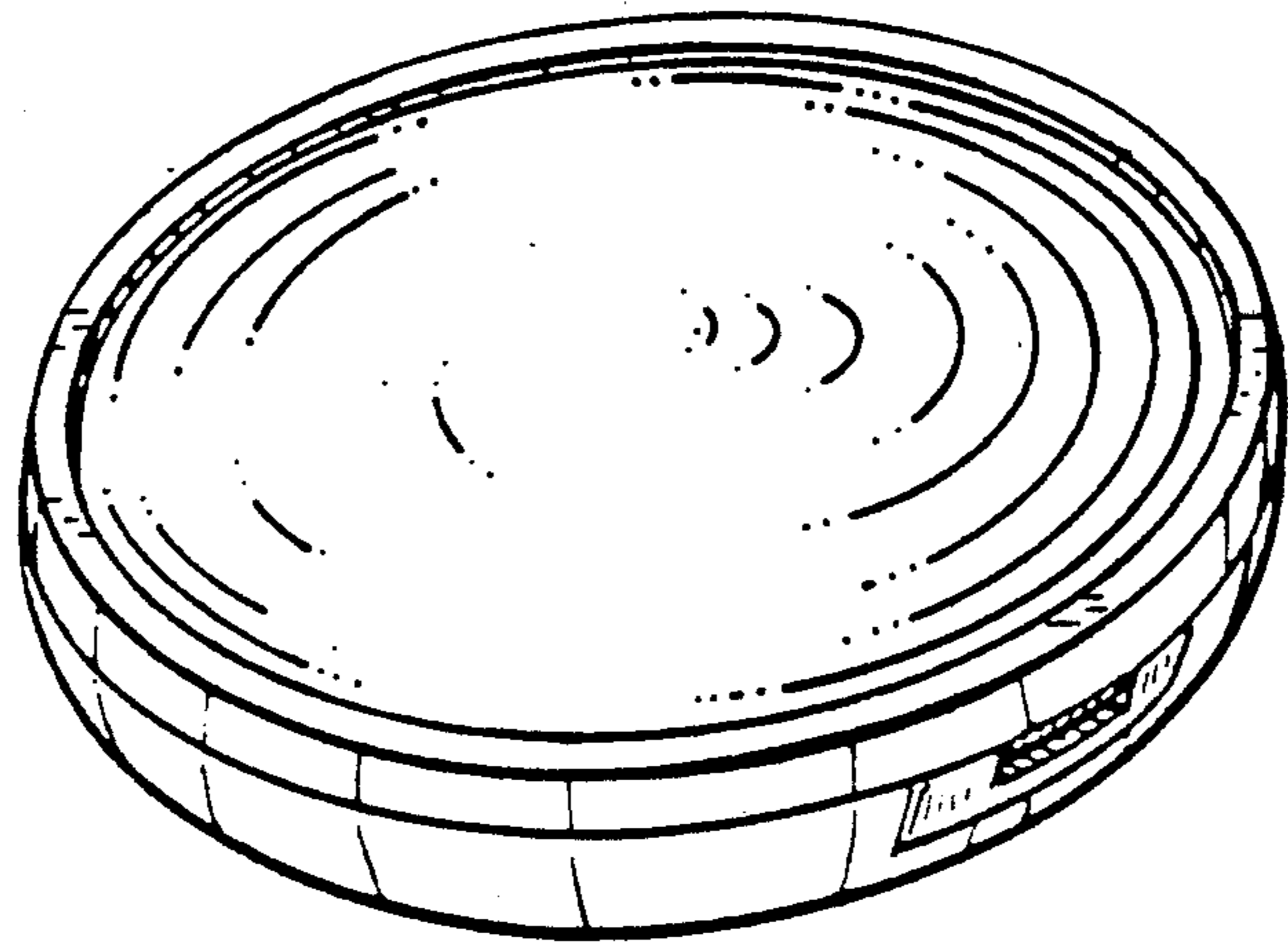

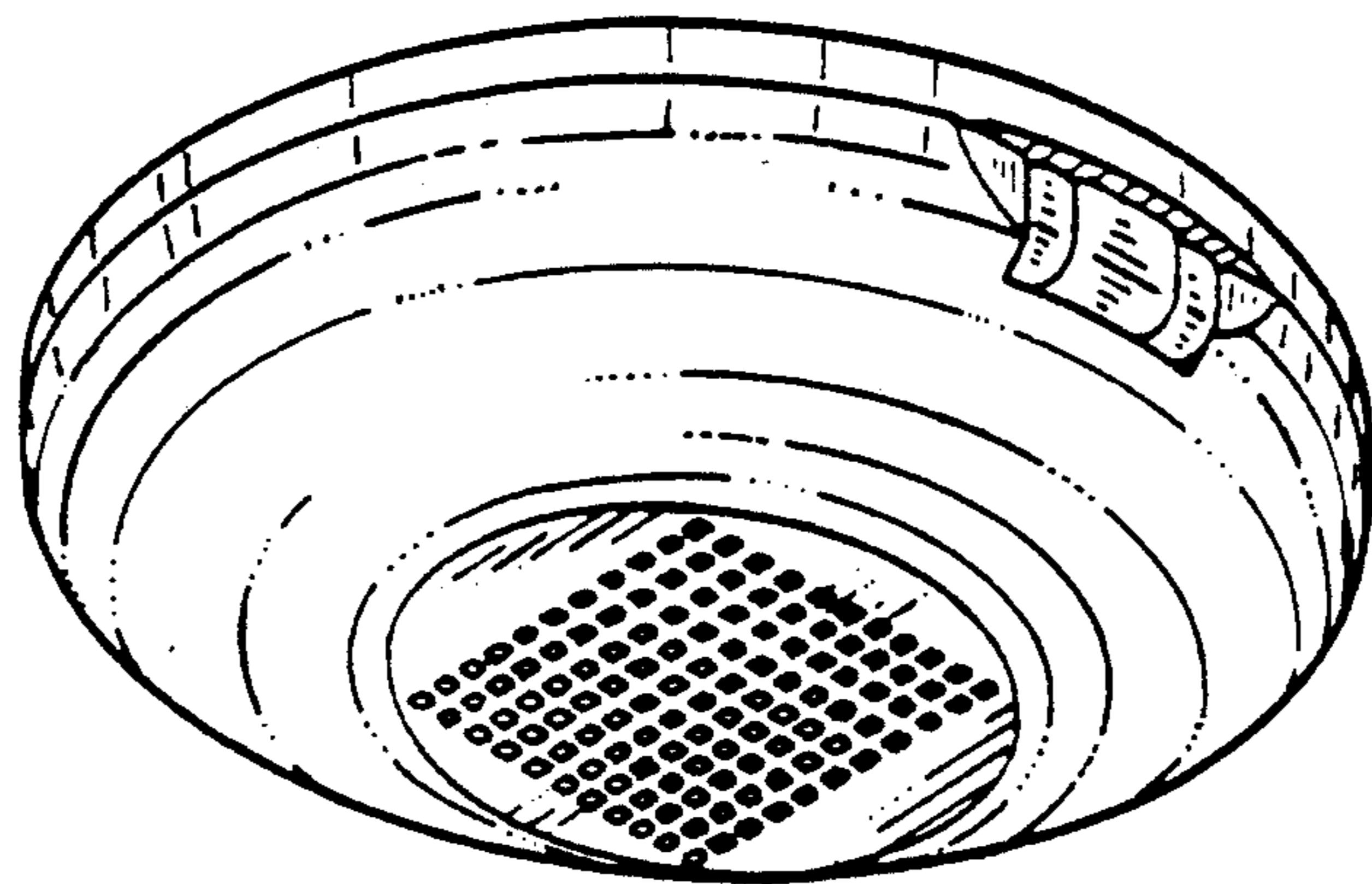

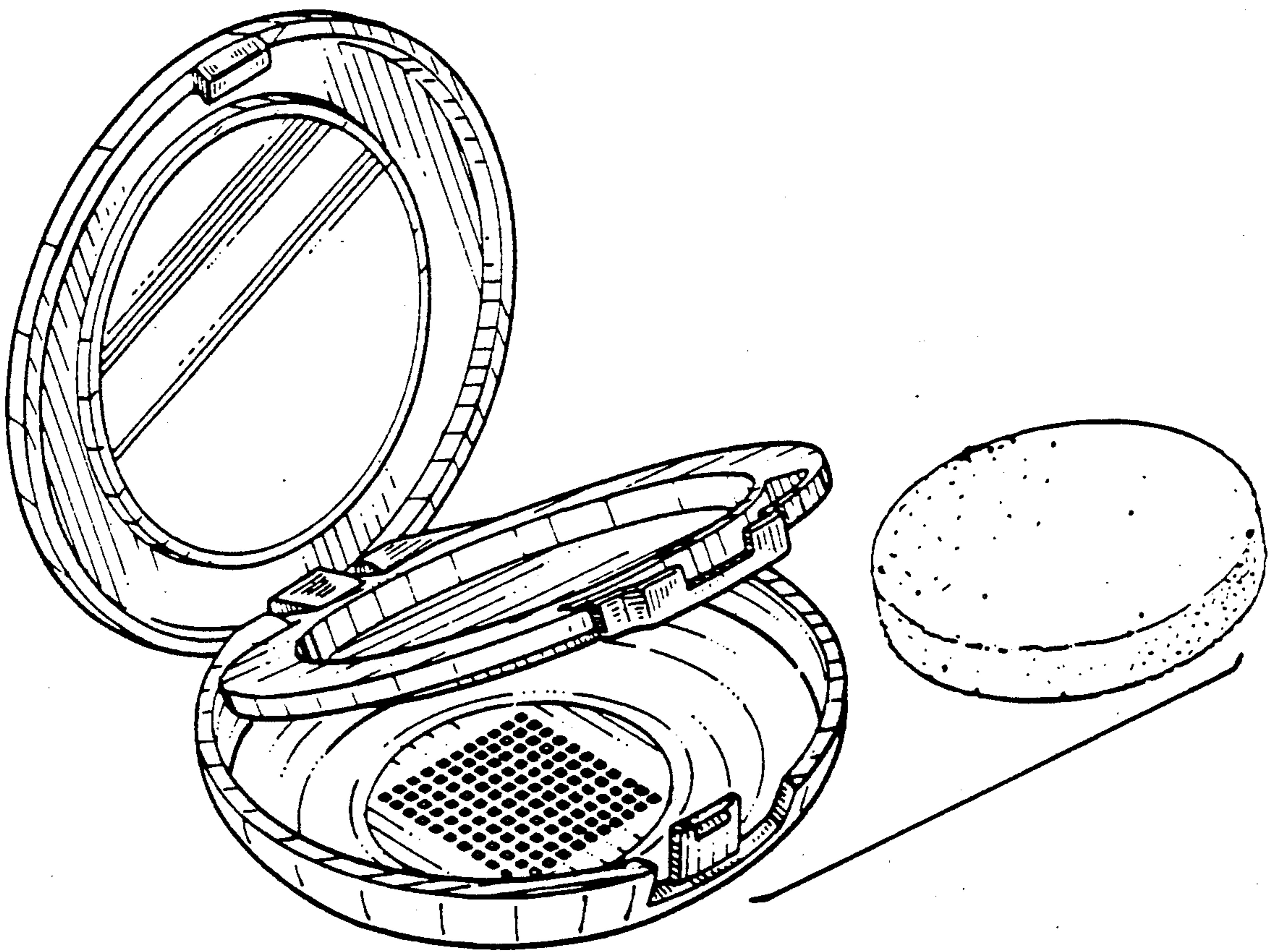

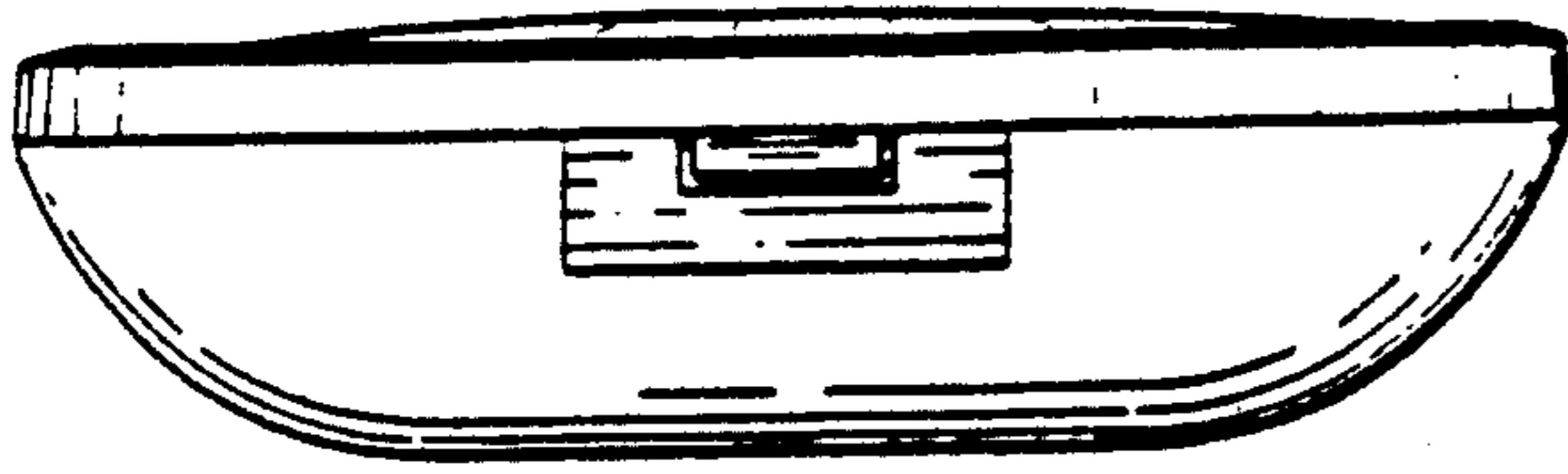

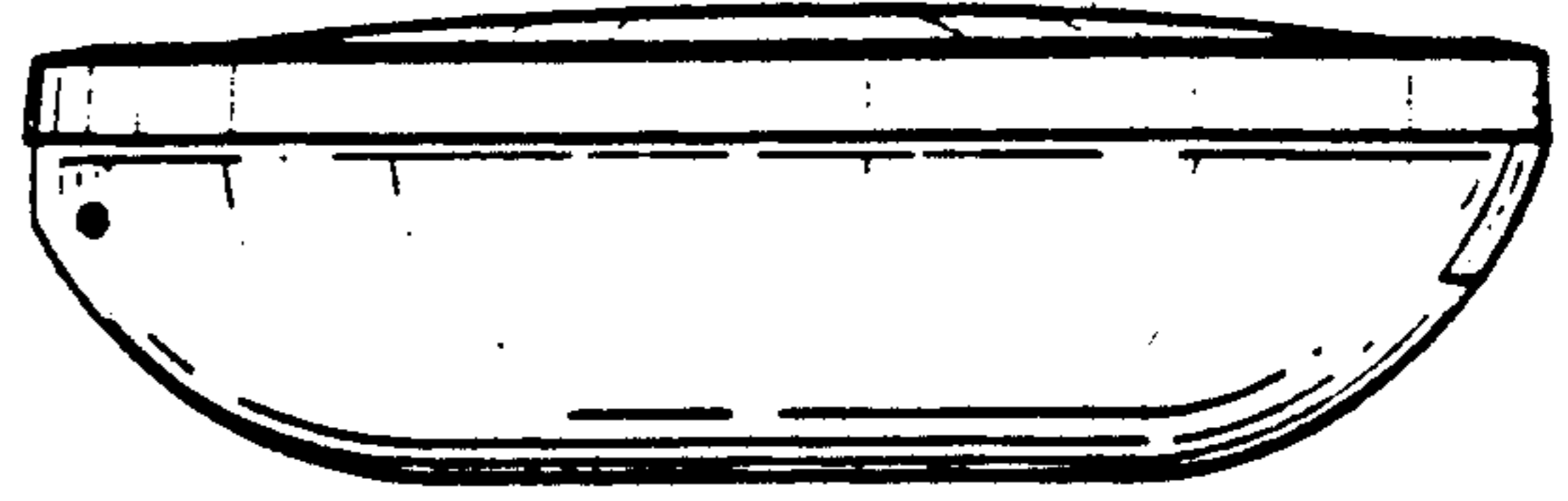

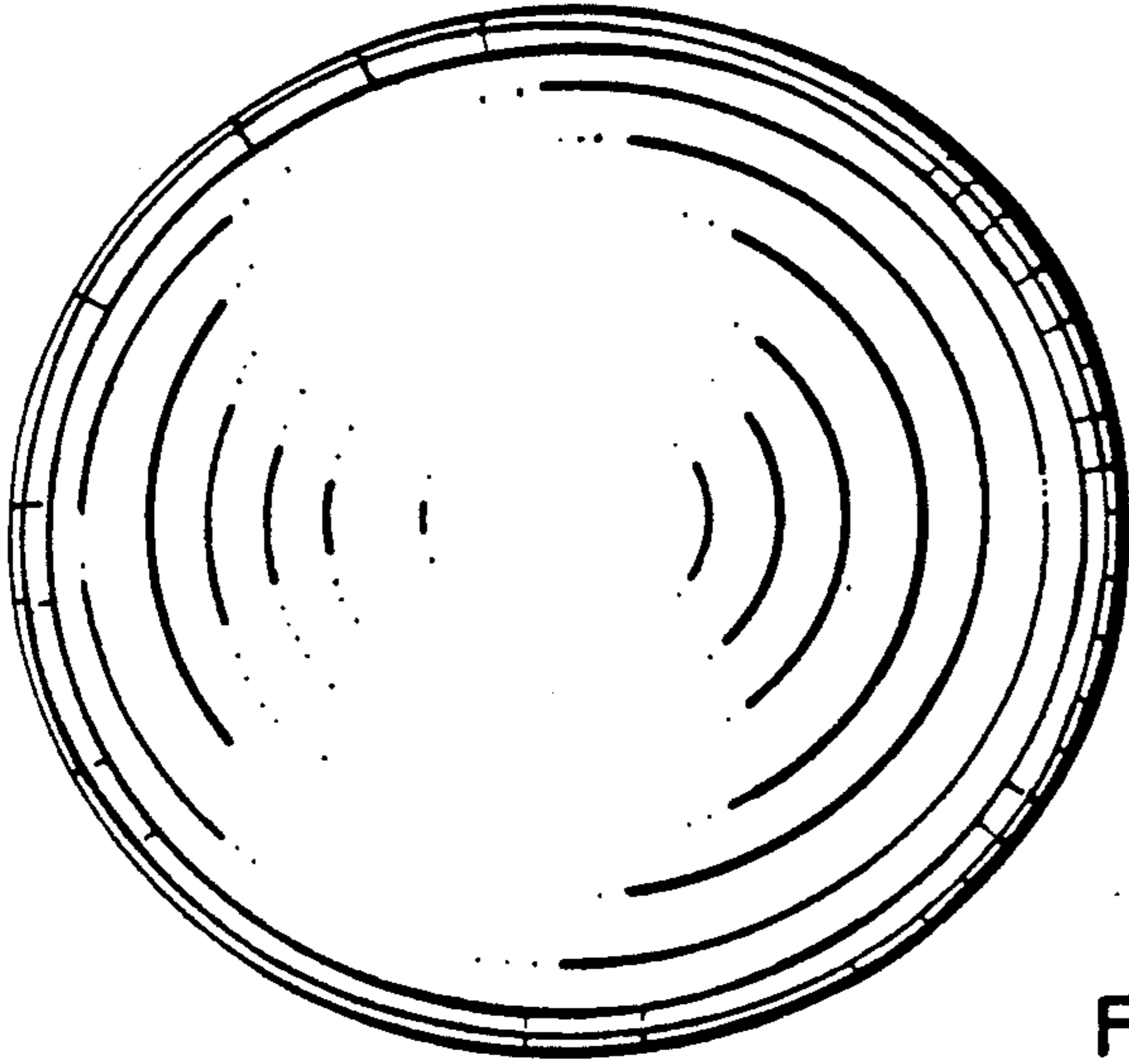

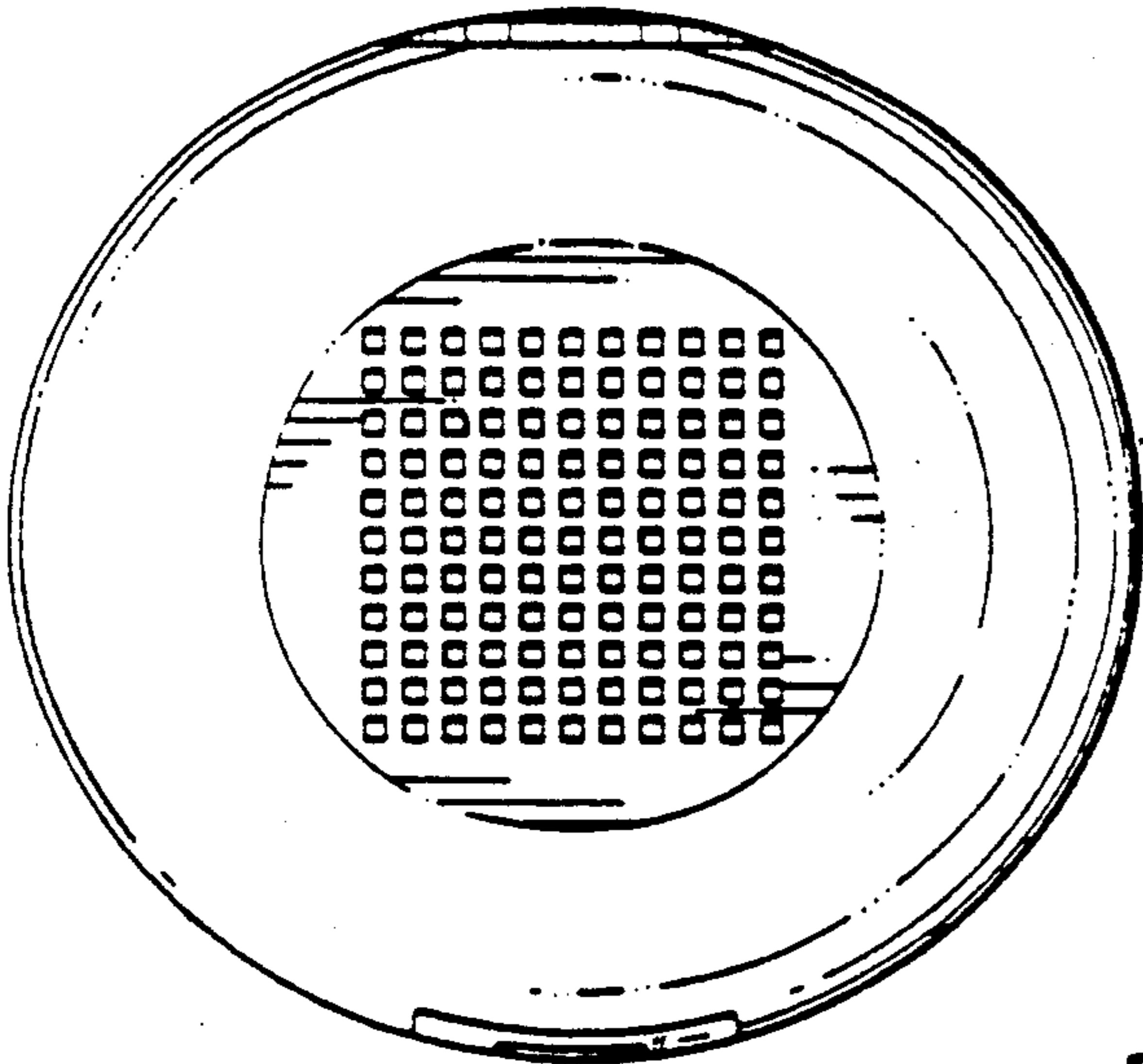

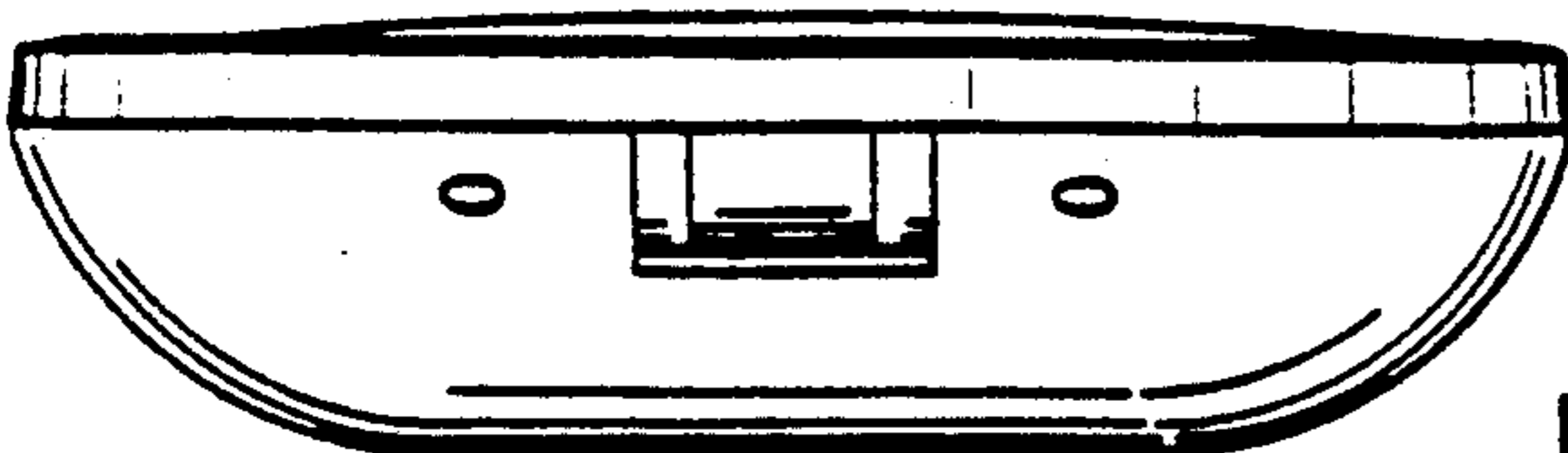

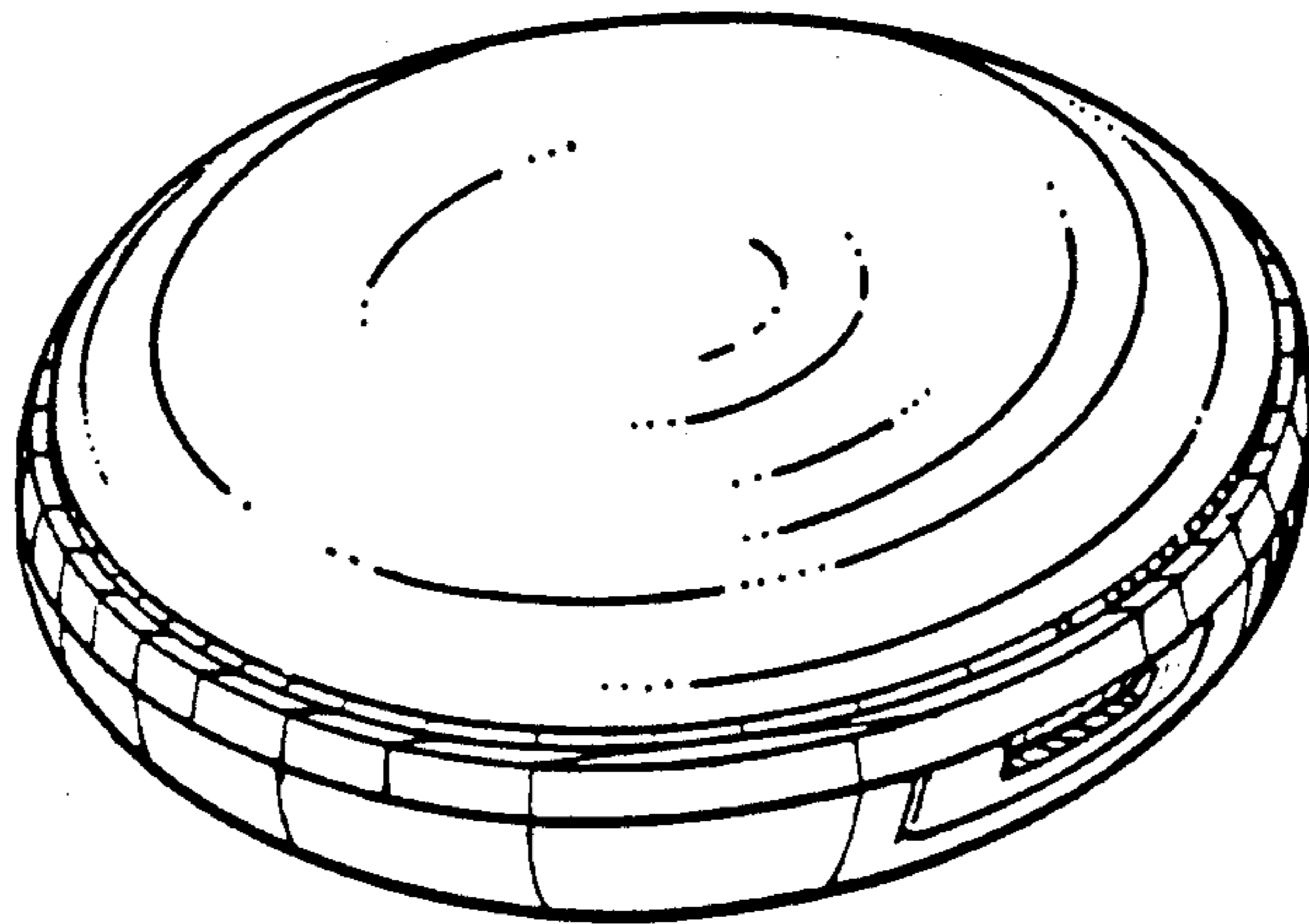

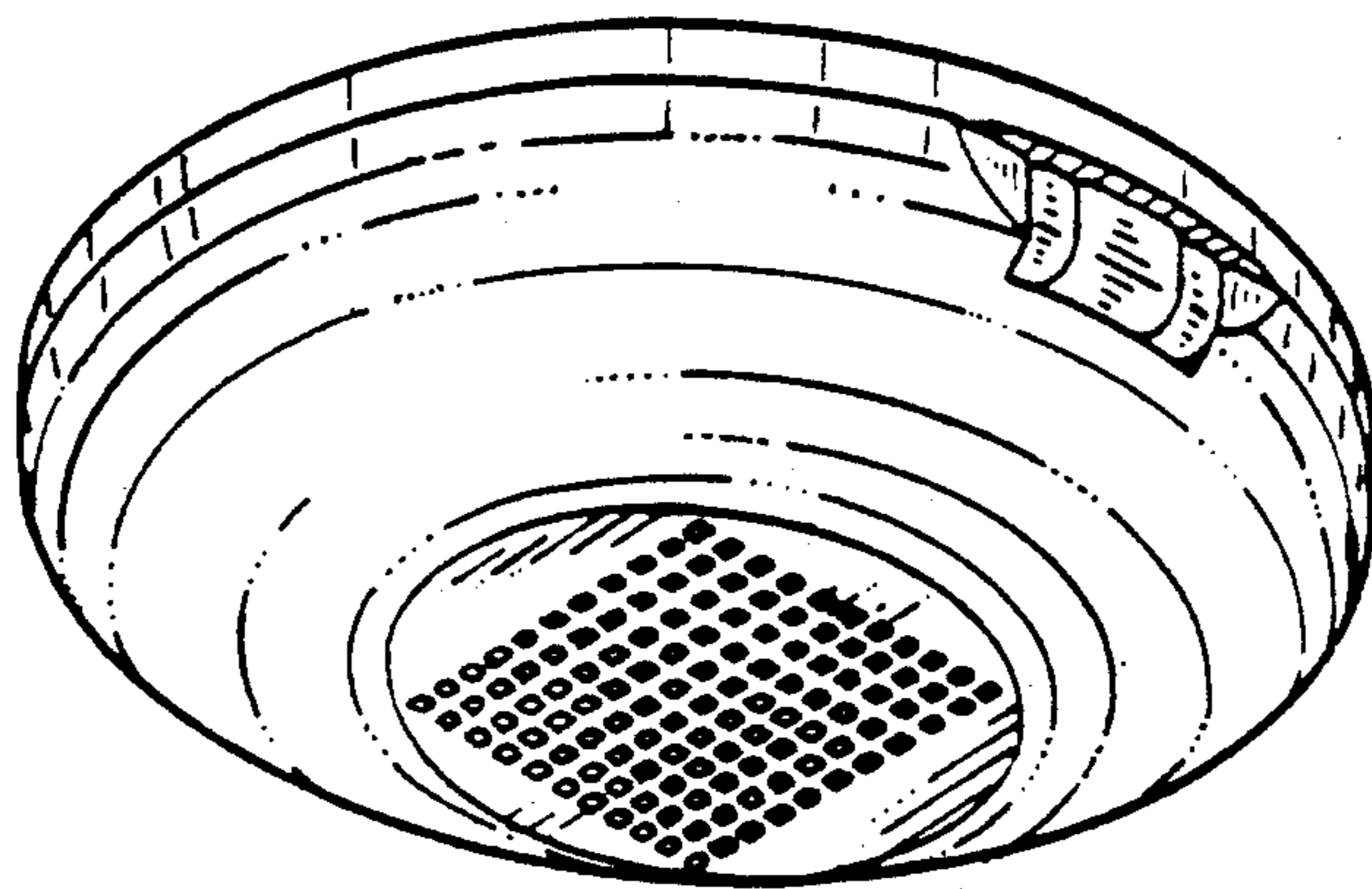

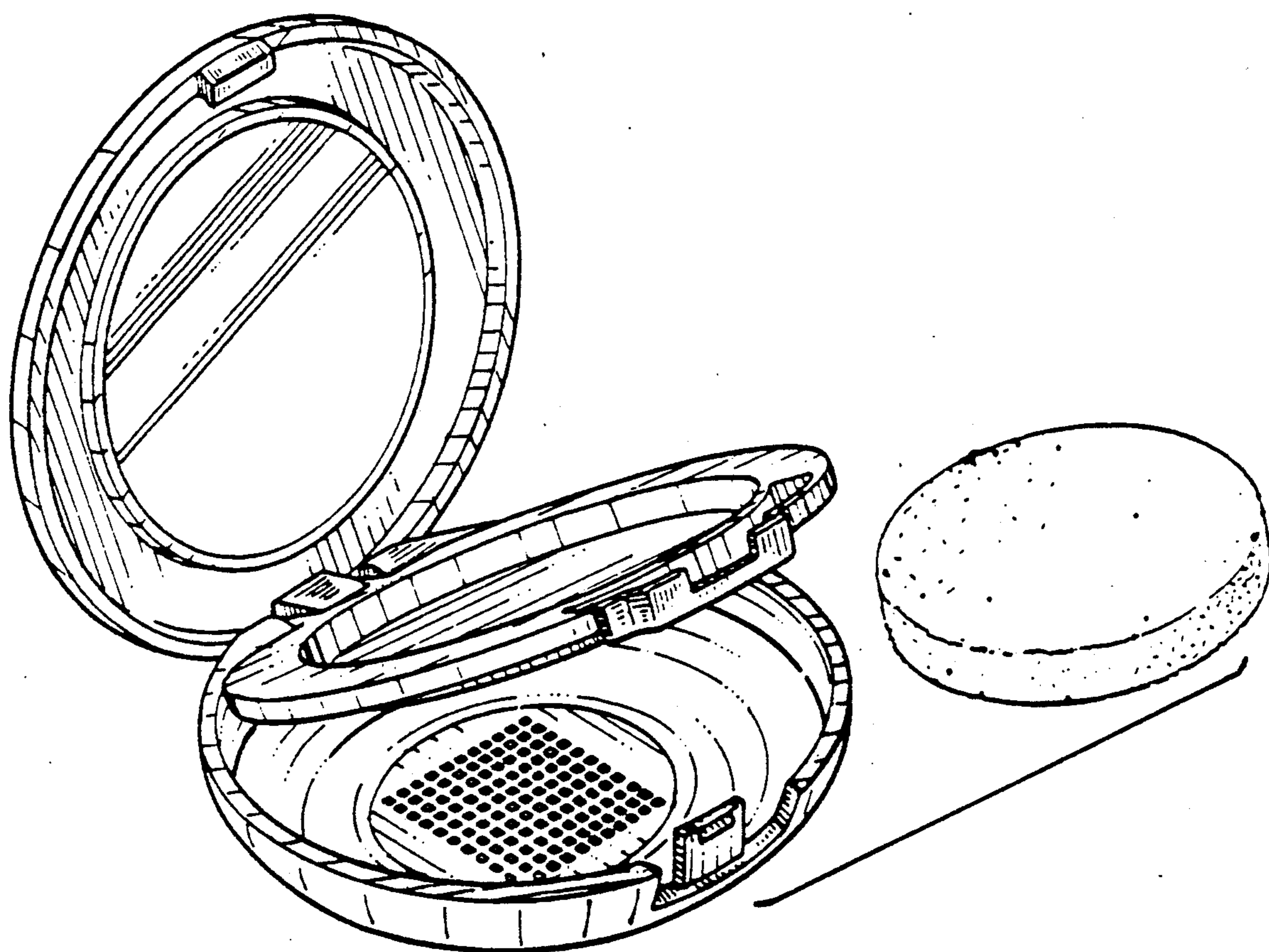

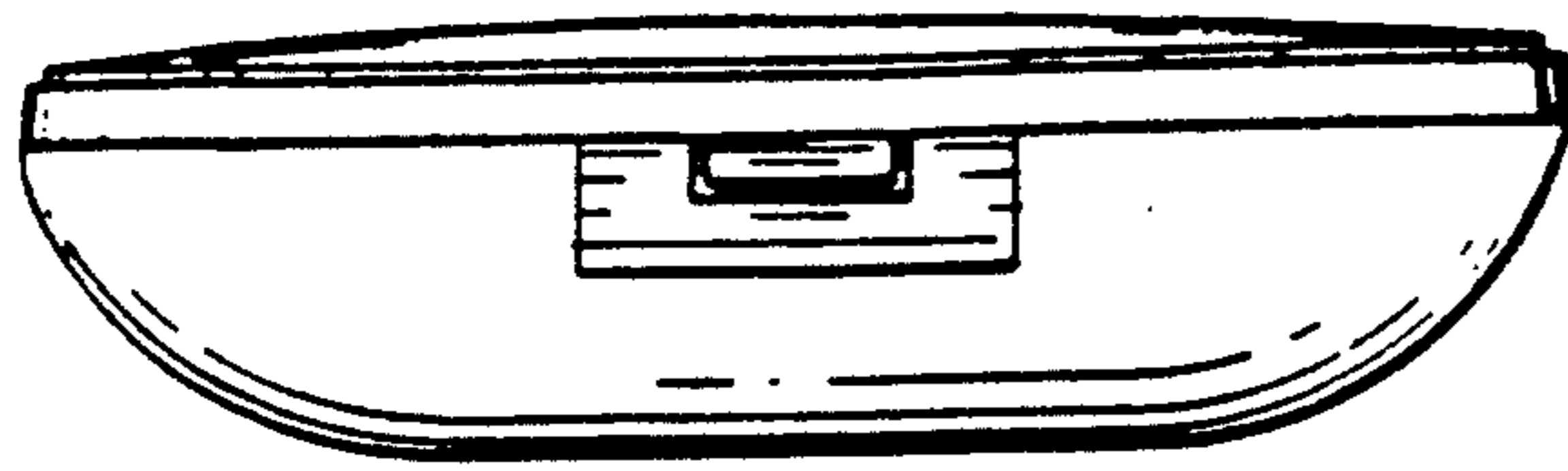

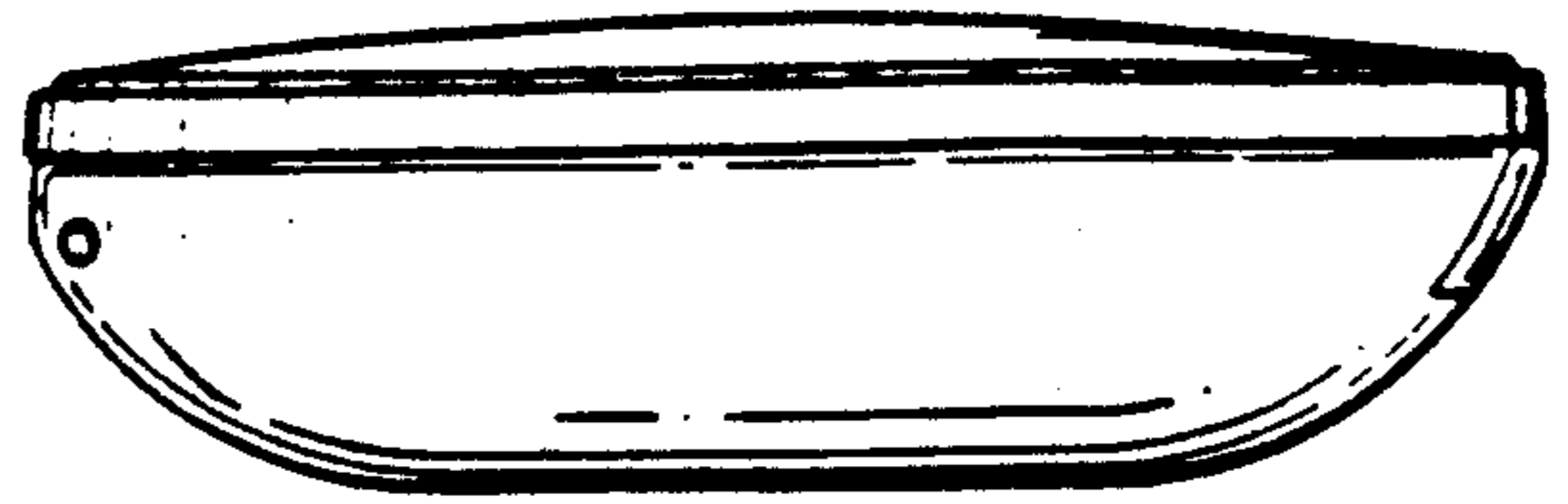

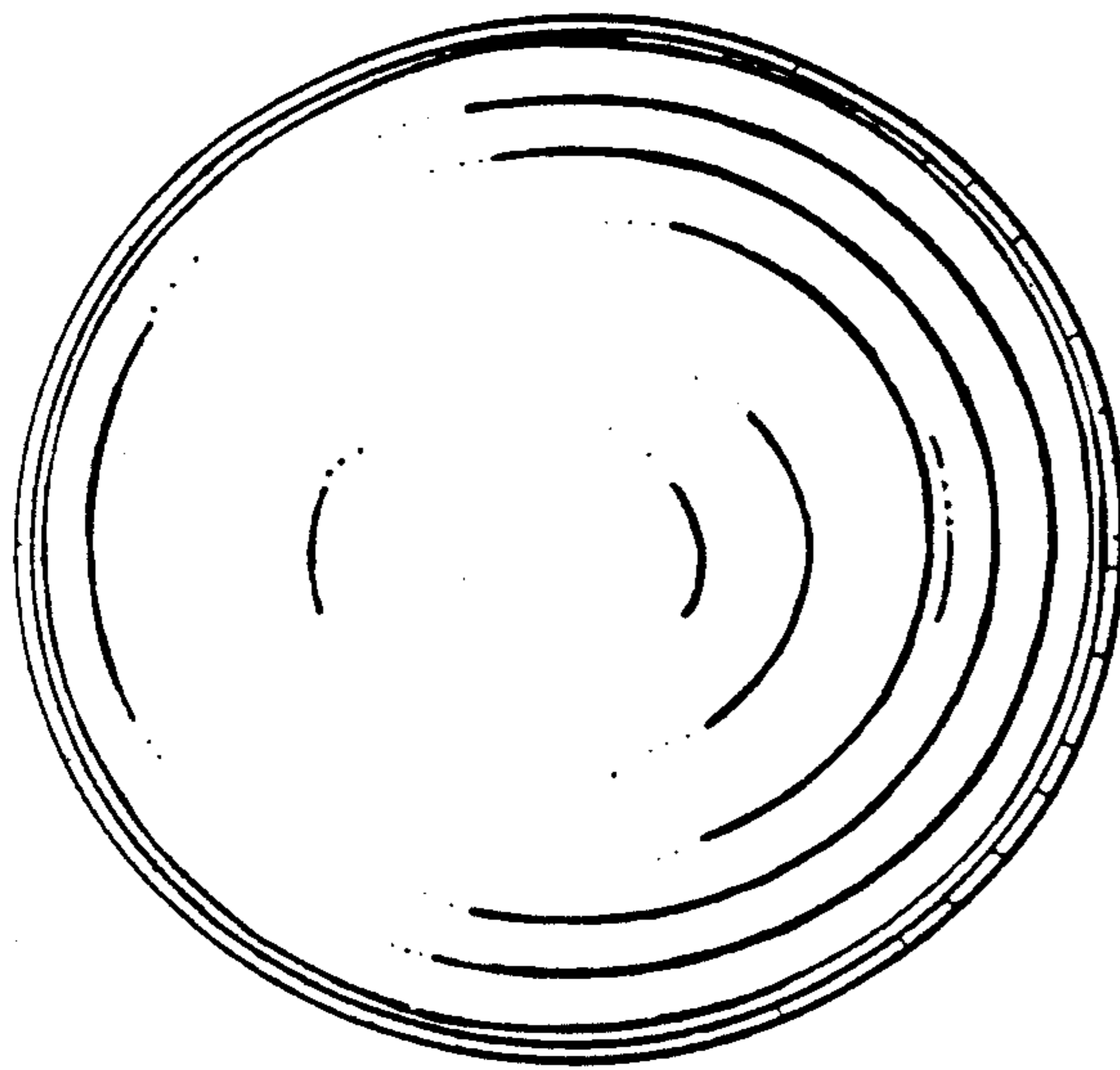

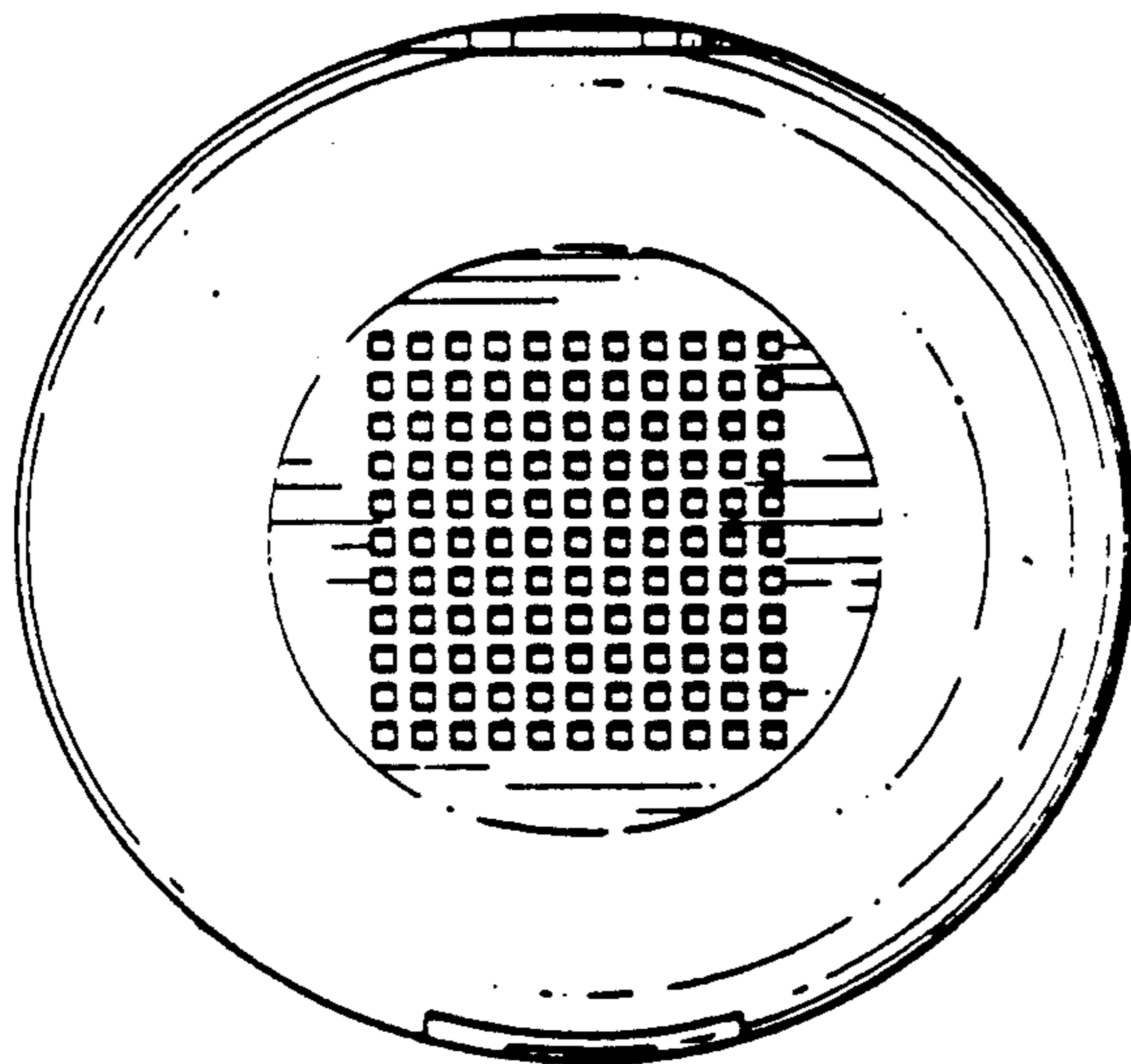

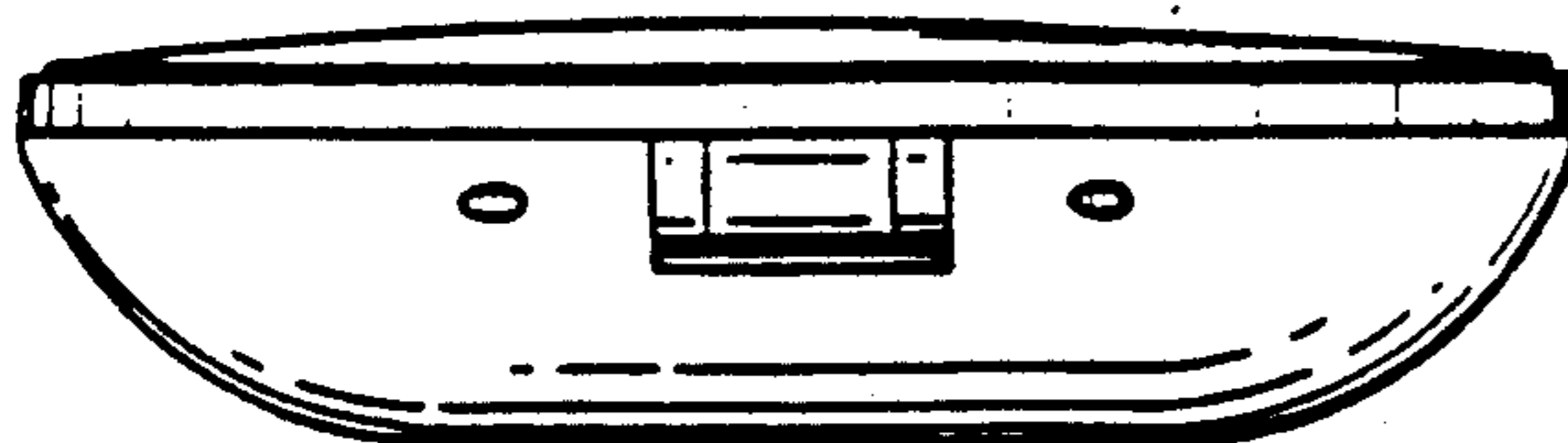
