The ornamental design for a stocking holder, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a stocking holder showing my new design;
 FIG. 2 is a top plan view thereof, the bottom being a mirror image;
 FIG. 3 is a front elevations view thereof;
 FIG. 4 is a rear elevational view thereof;
 FIG. 5 is a right side elevational view thereof, the left side being a mirror image;
 FIG. 6 is a perspective view of a second embodiment of the design shown in FIG. 1;
 FIG. 7 is a top plan view thereof, the bottom being a mirror image;
 FIG. 8 is a front elevational view thereof;
 FIG. 9 is a rear elevational view thereof;
 FIG. 10 is a left side elevational view thereof;
 FIG. 11 is a right side elevational view thereof;
 FIG. 12 is a perspective view of a third embodiment of the design shown in FIG. 1;
 FIG. 13 is a top plan view thereof, the bottom being a mirror image;
 FIG. 14 is a front elevational view thereof;
 FIG. 15 is a rear elevational view thereof; and
 FIG. 16 is a right side elevational view thereof, the left side being a mirror image.
 The broken line showing of stockings is for illustrative purposes only and forms no part of the claimed design.

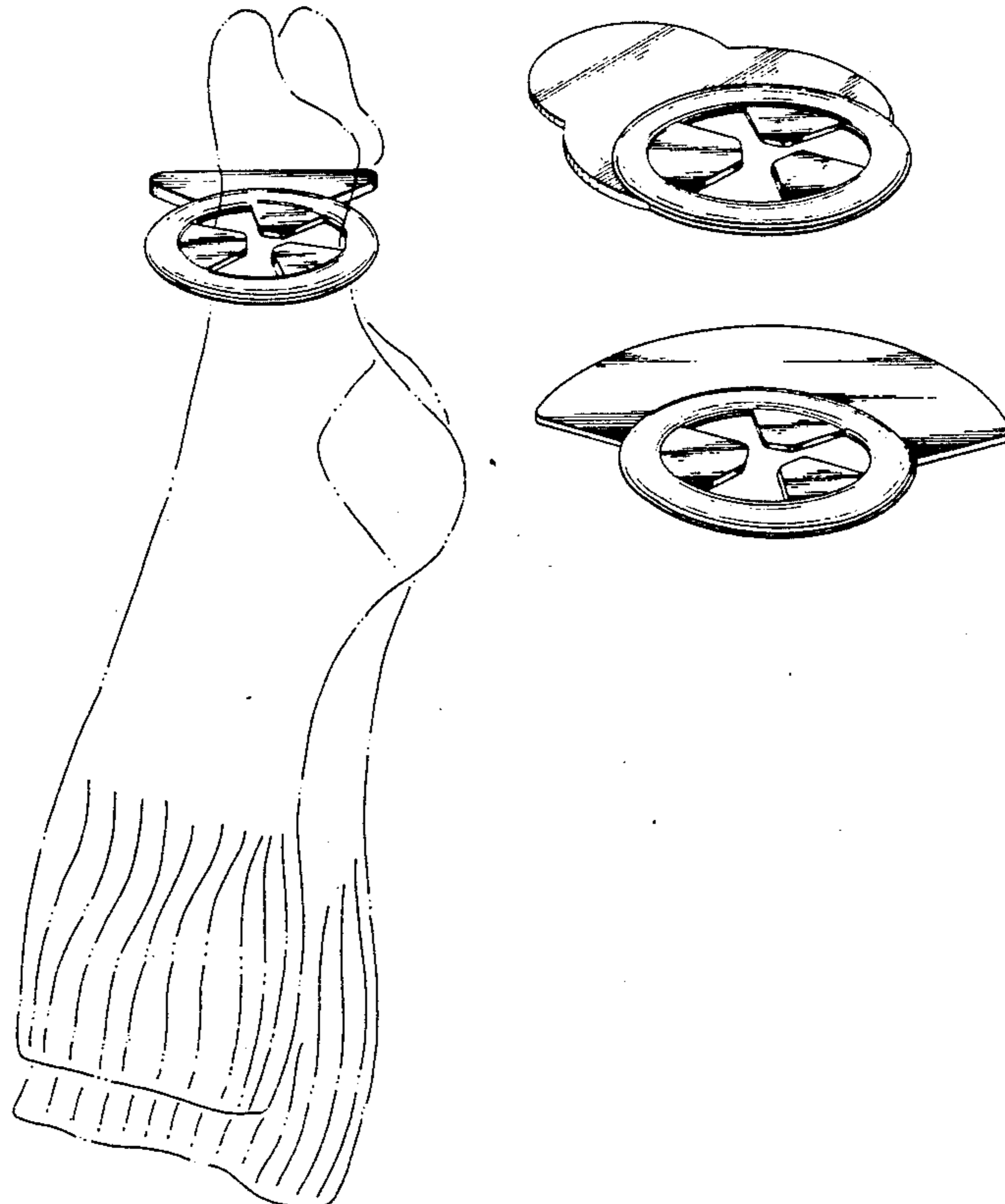

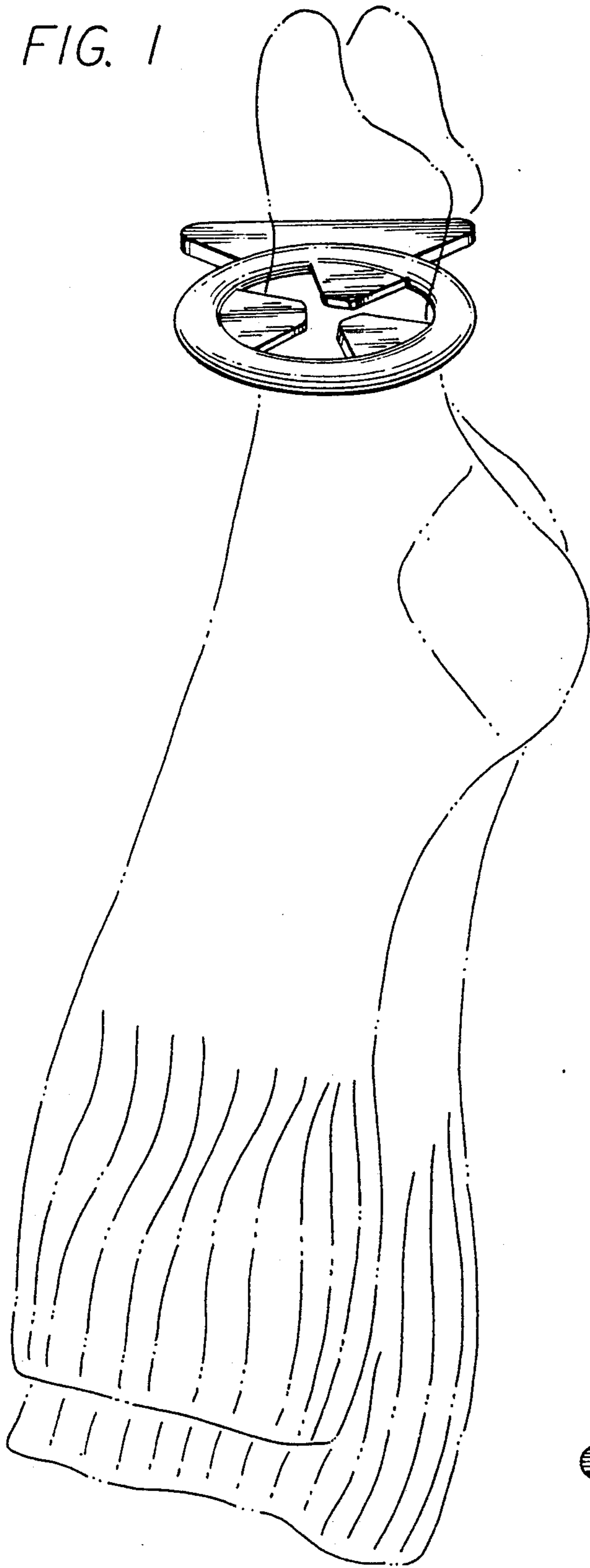

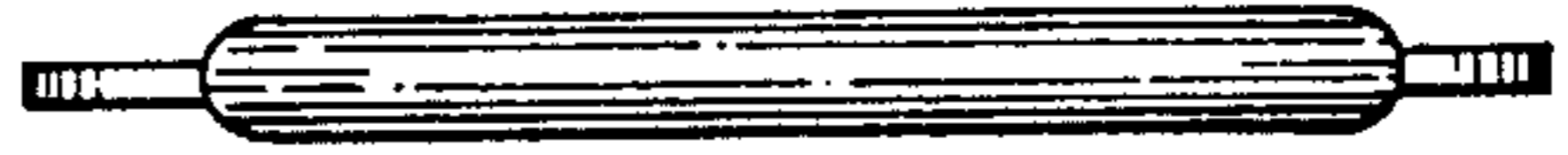
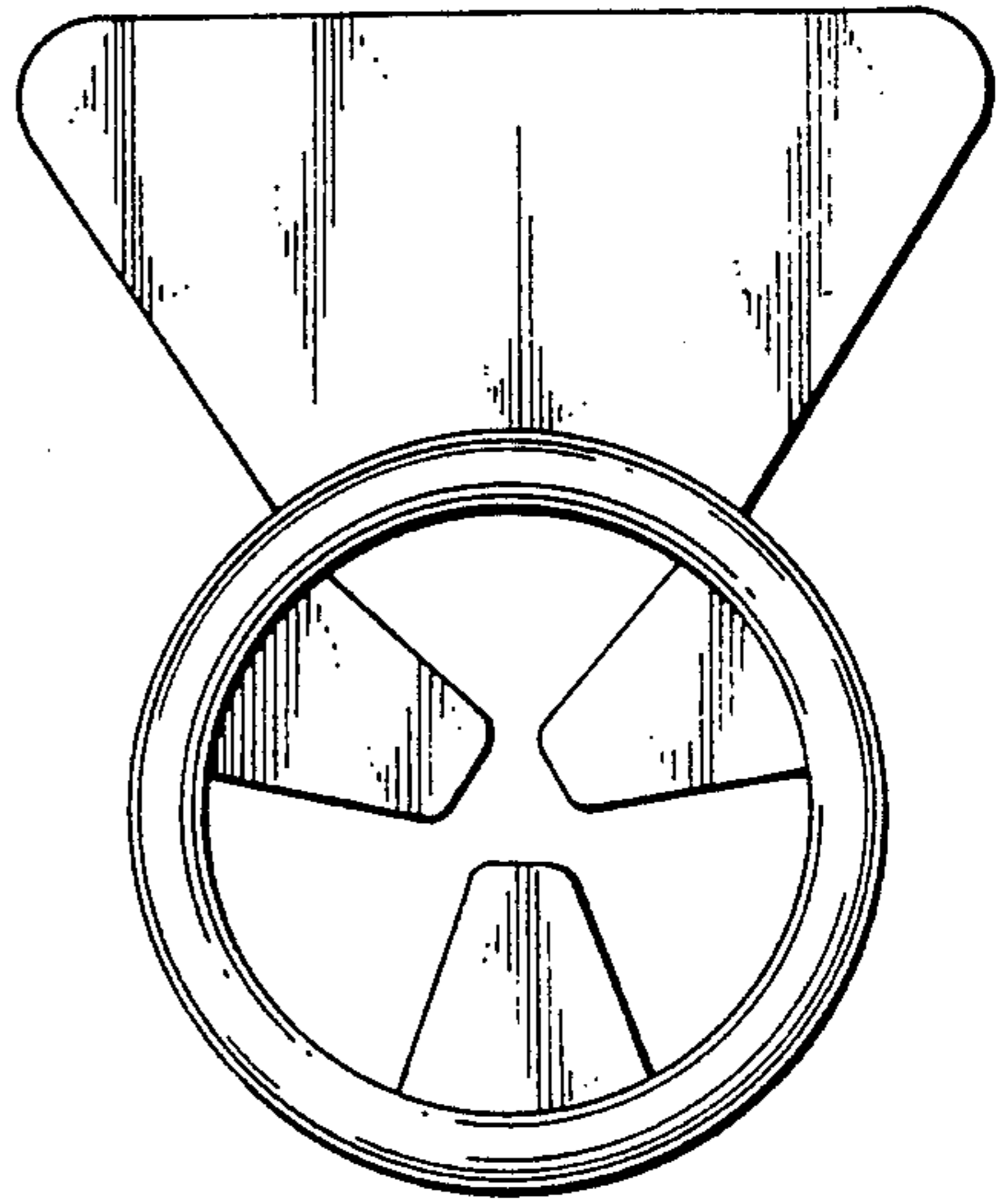

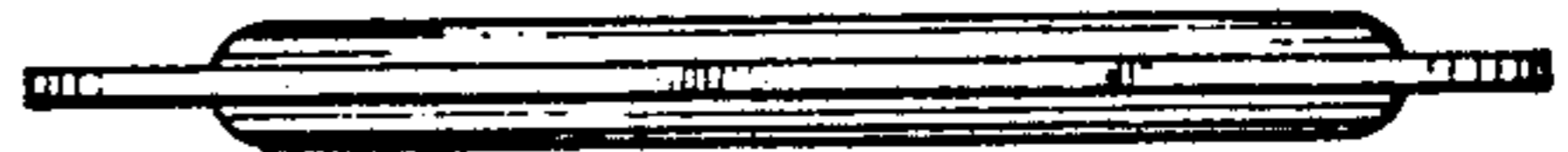

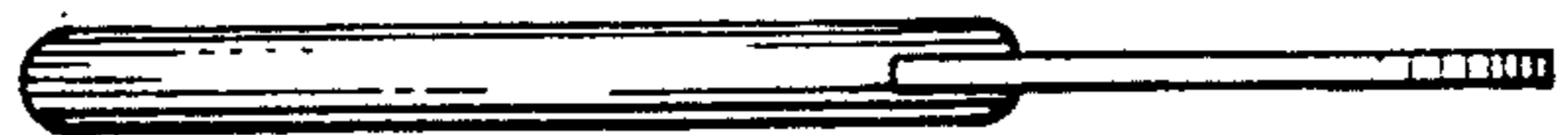

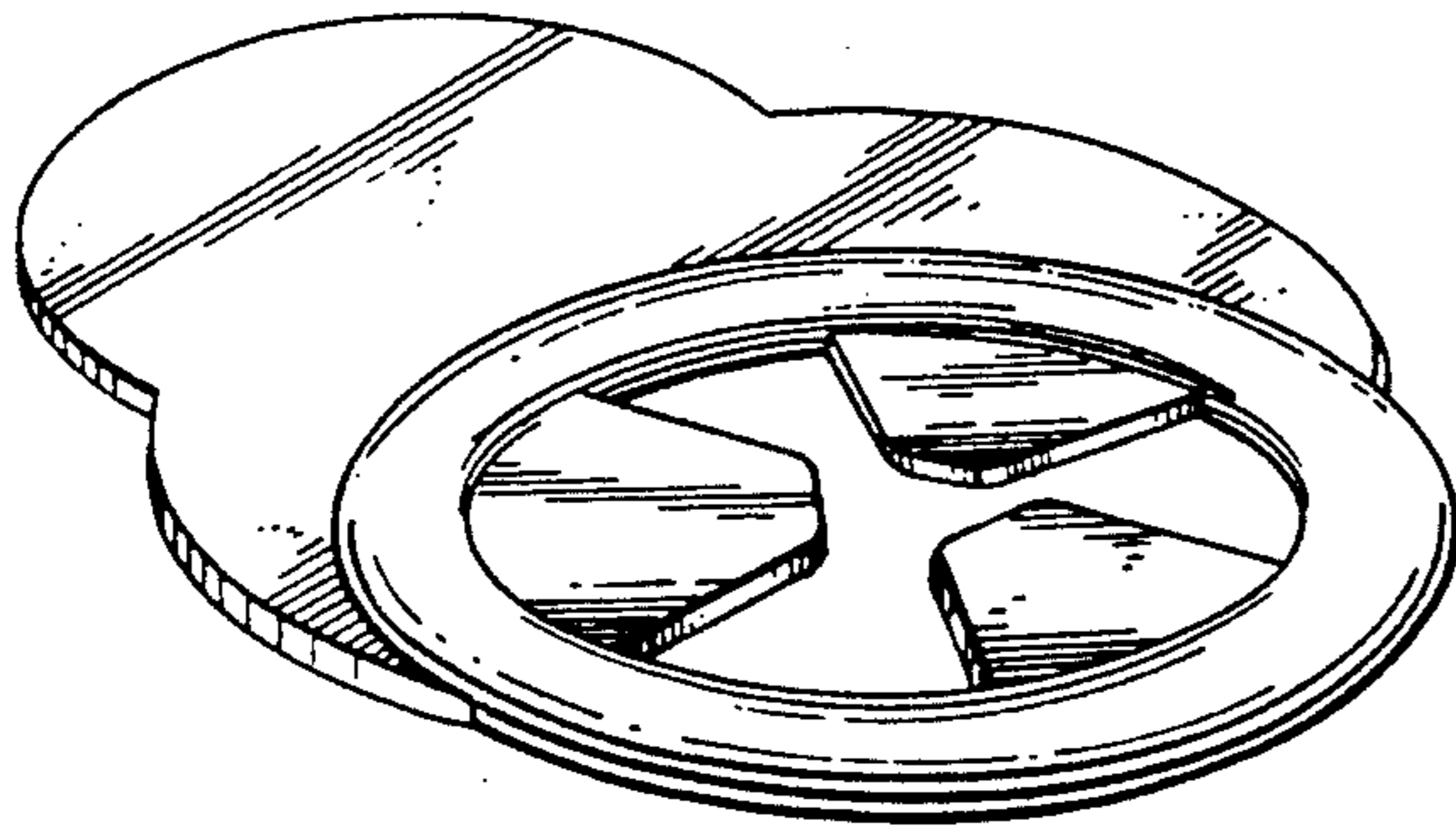

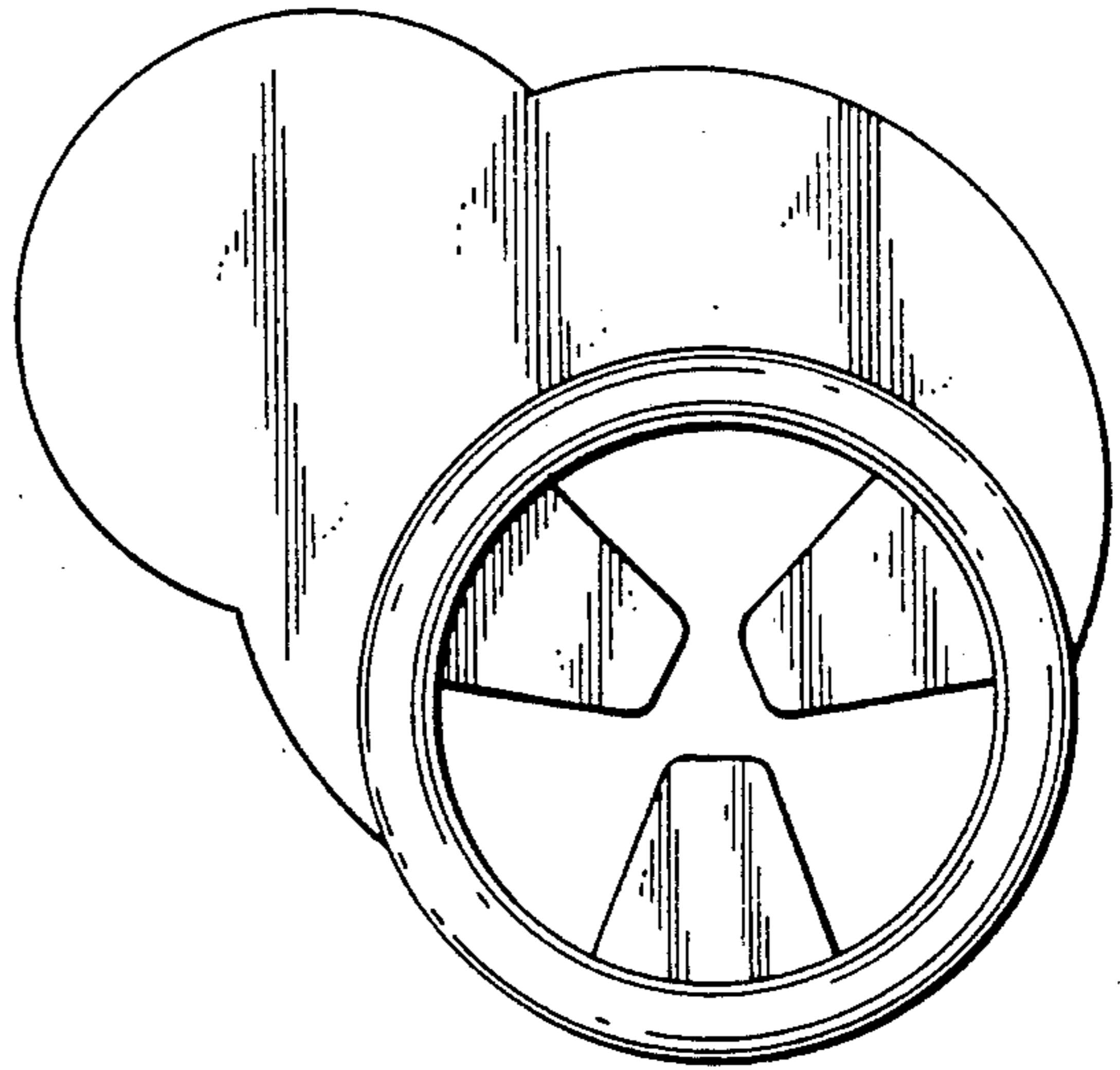

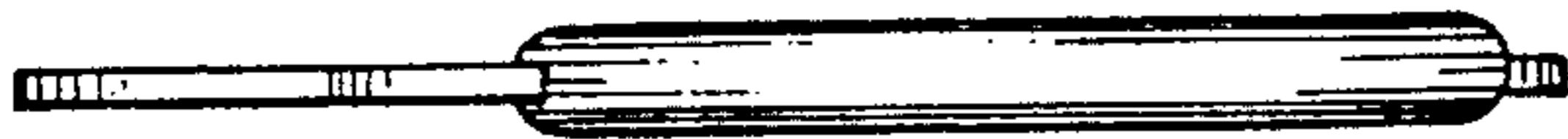

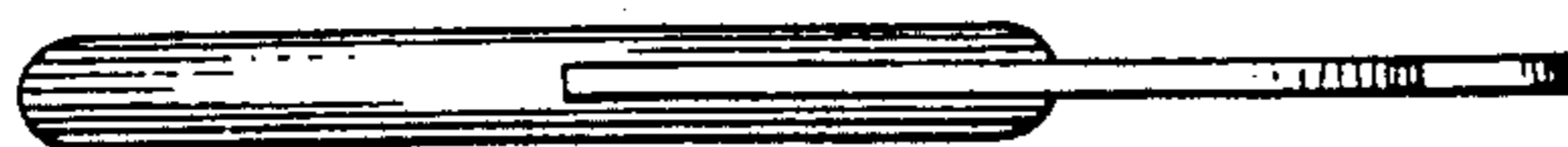

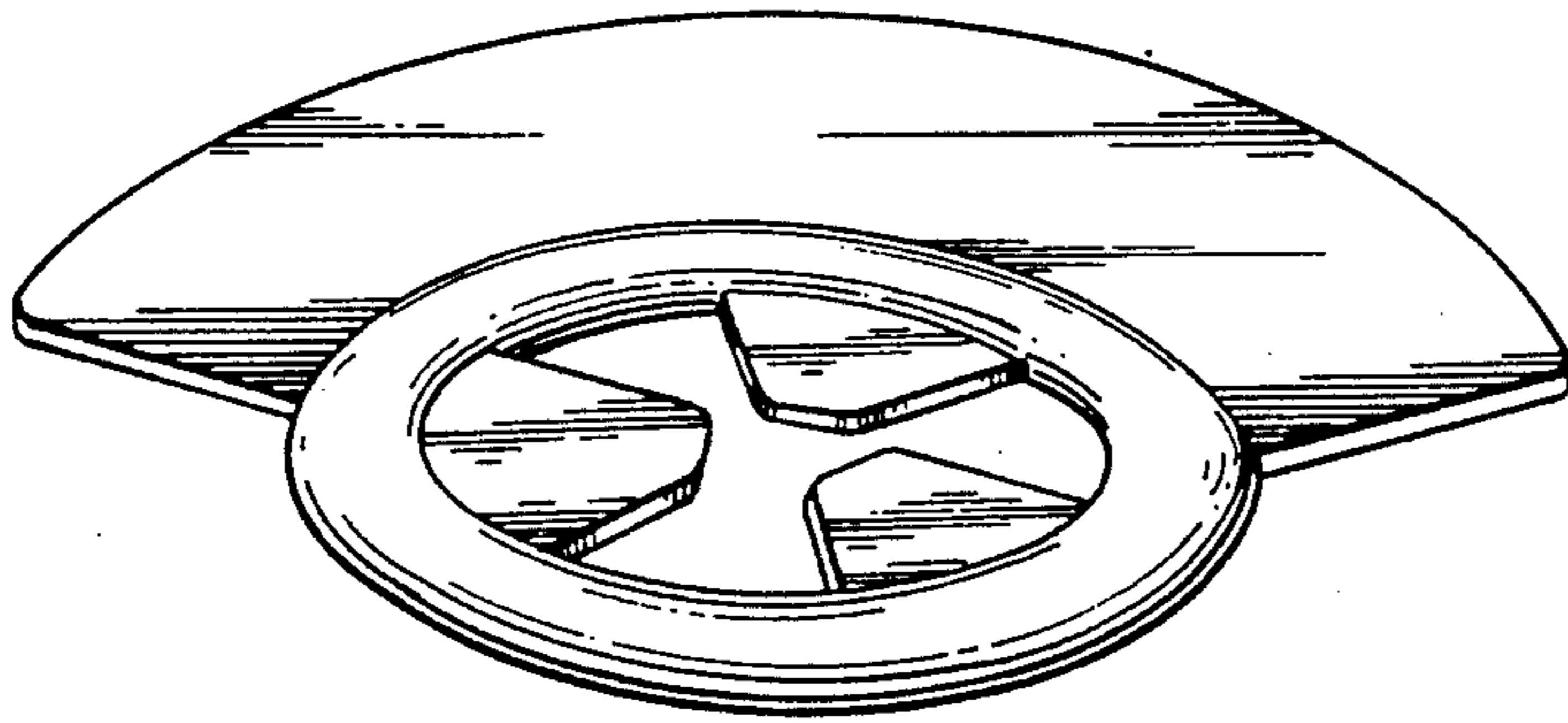

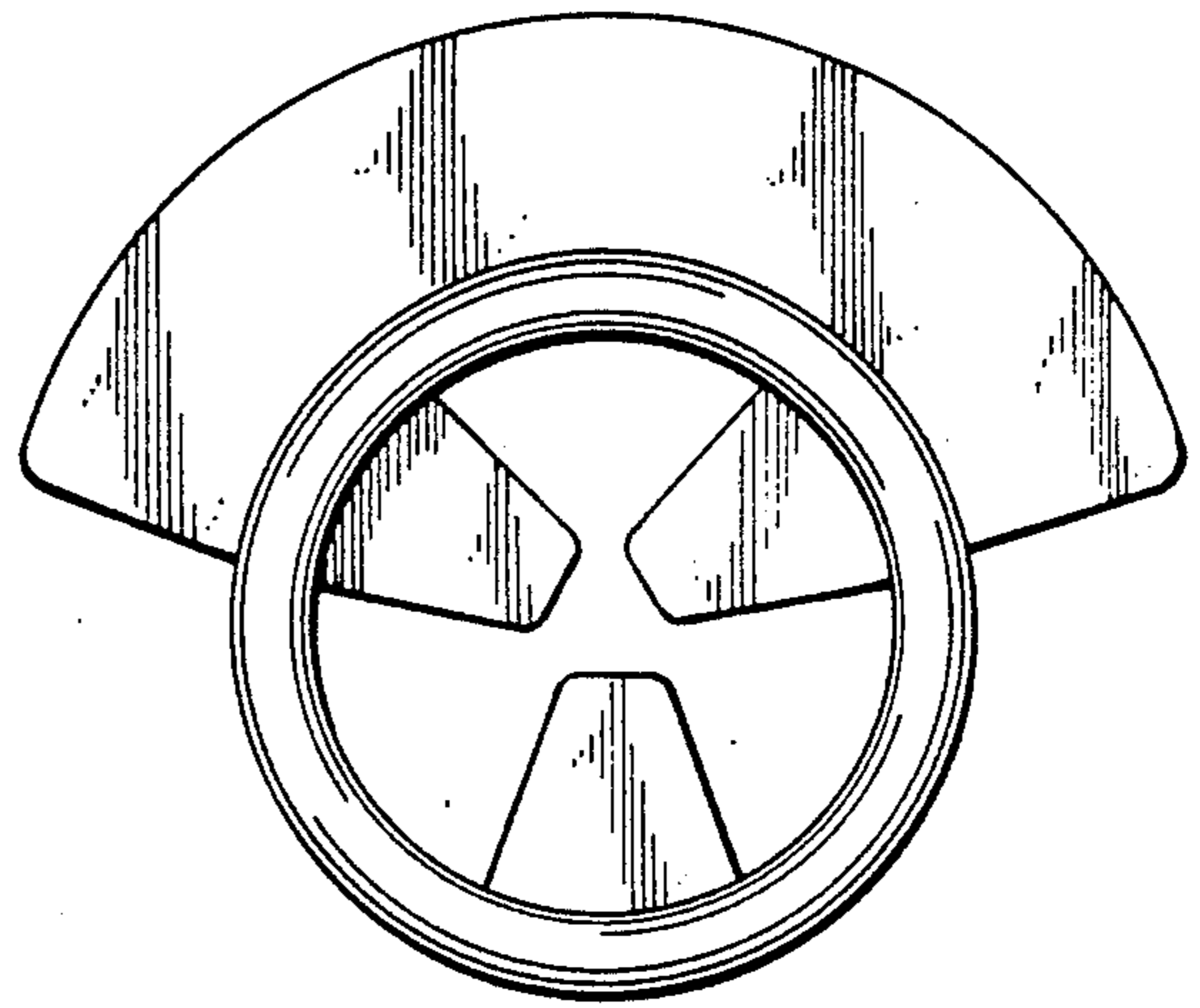

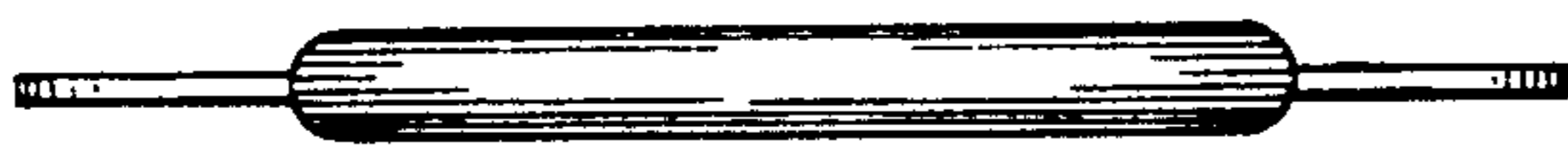

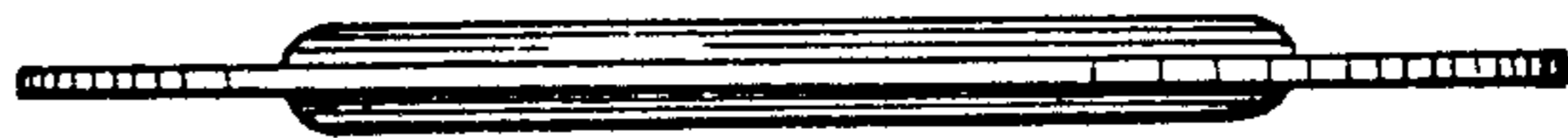
