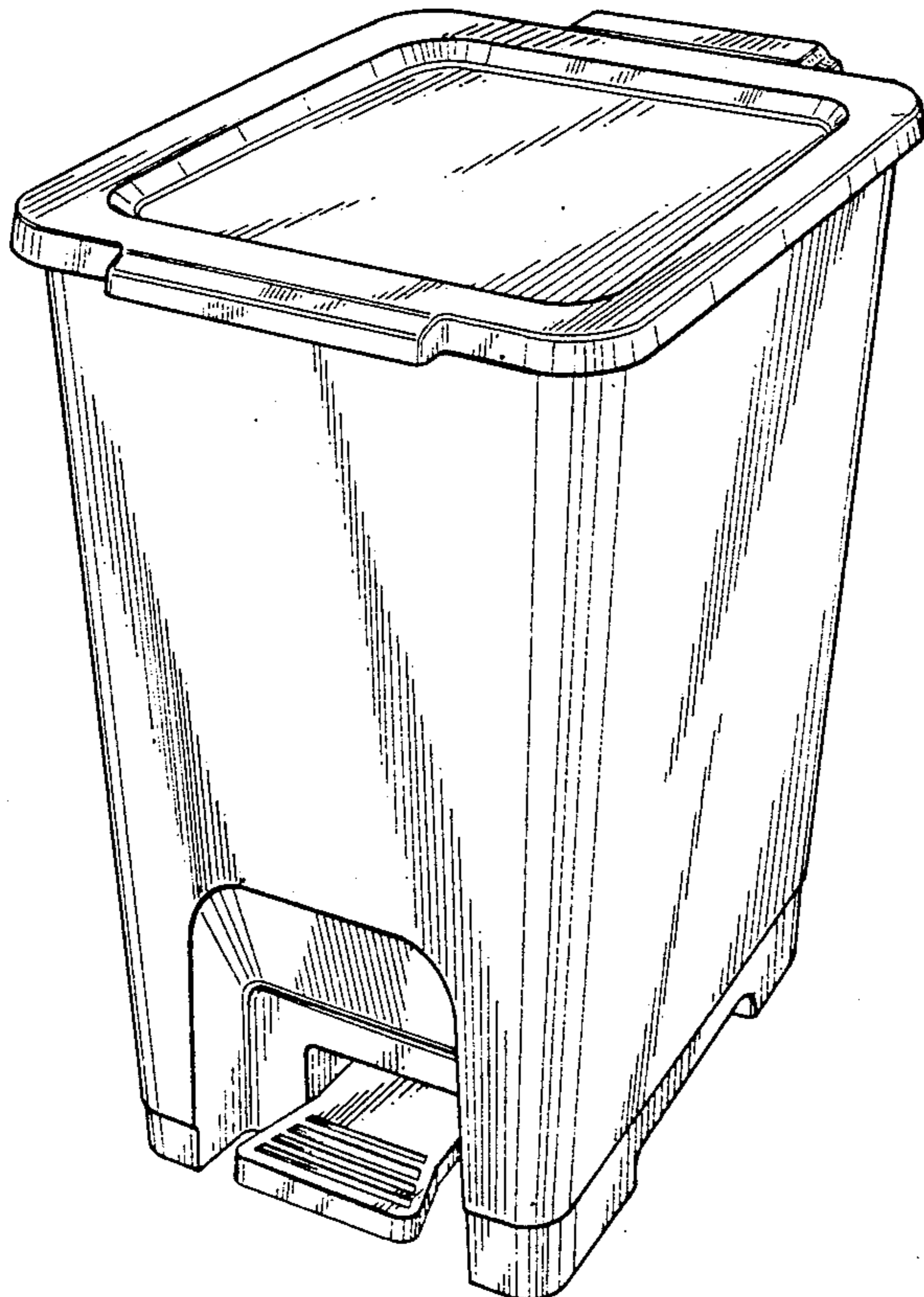

DESCRIPTION

FIG. 1 is a front perspective view of a step-on wastebasket showing my new design, with the lid in an open position;
FIG. 2 is a front perspective view thereof with the lid in a closed position;
FIG. 3 is a front elevational view thereof;
FIG. 4 is a rear elevation view thereof;
FIG. 5 is a top plan view thereof;
FIG. 6 is a bottom plan view thereof;
FIG. 7 is a side elevational view thereof; the opposite side being a mirror image.



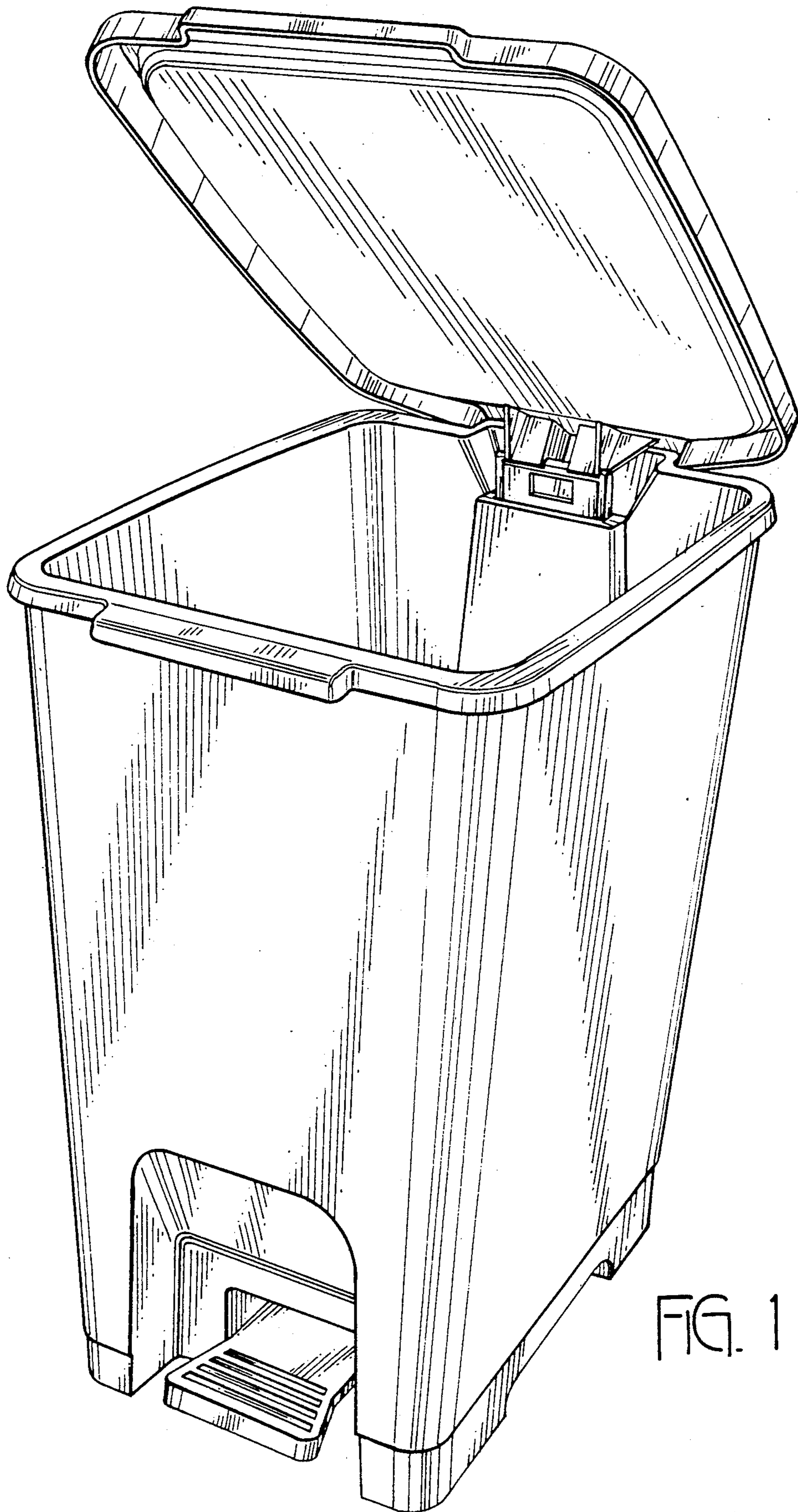

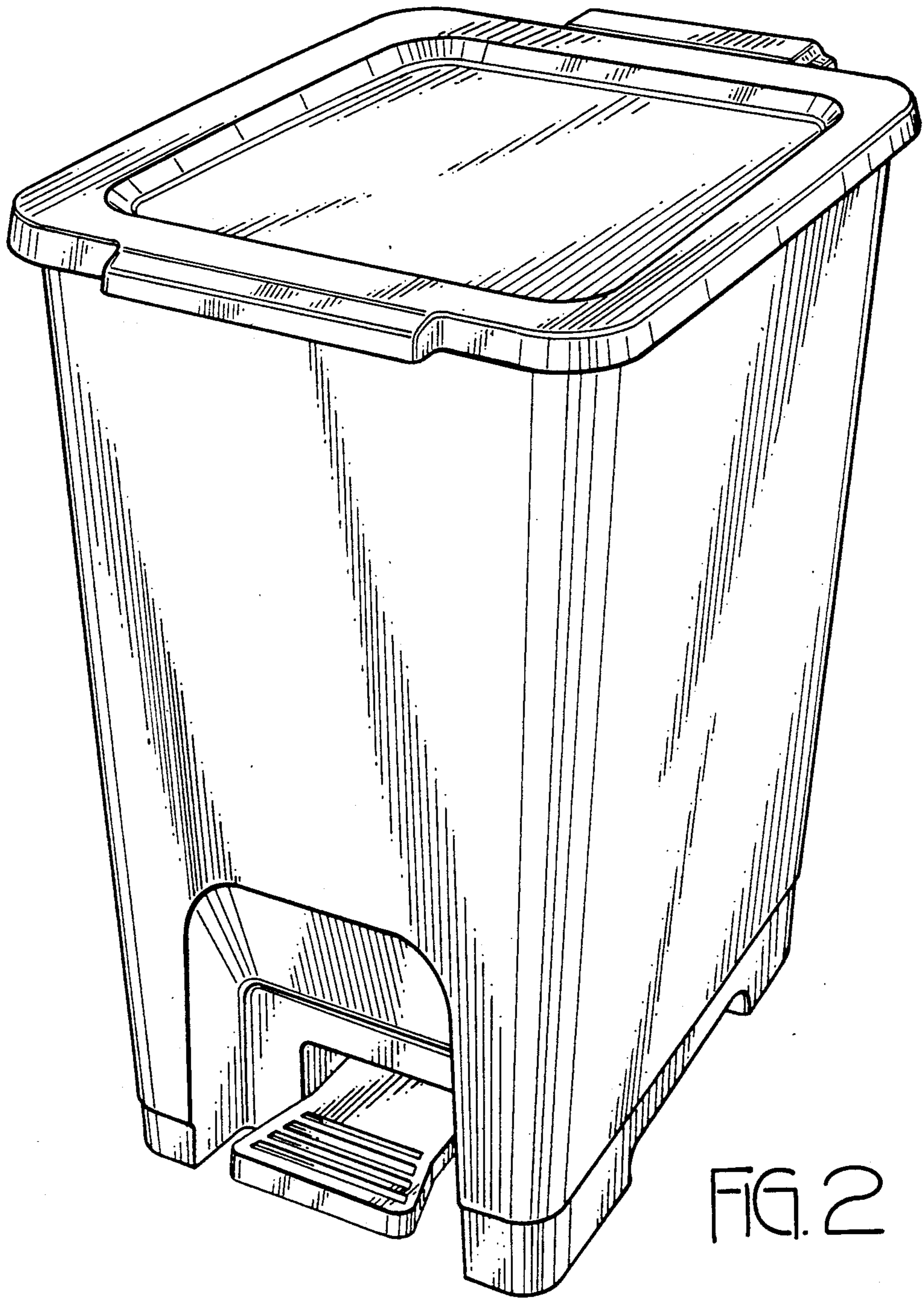

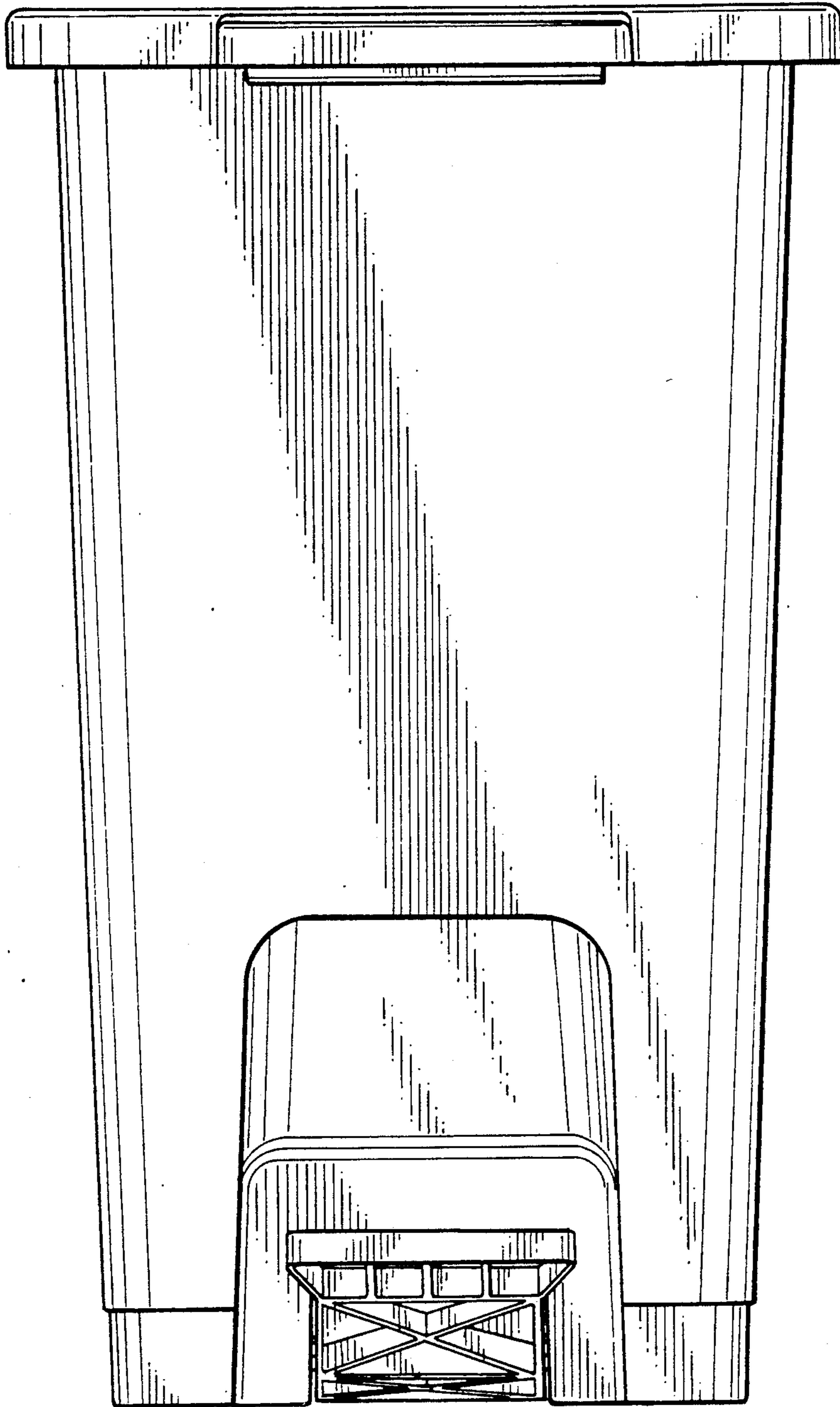

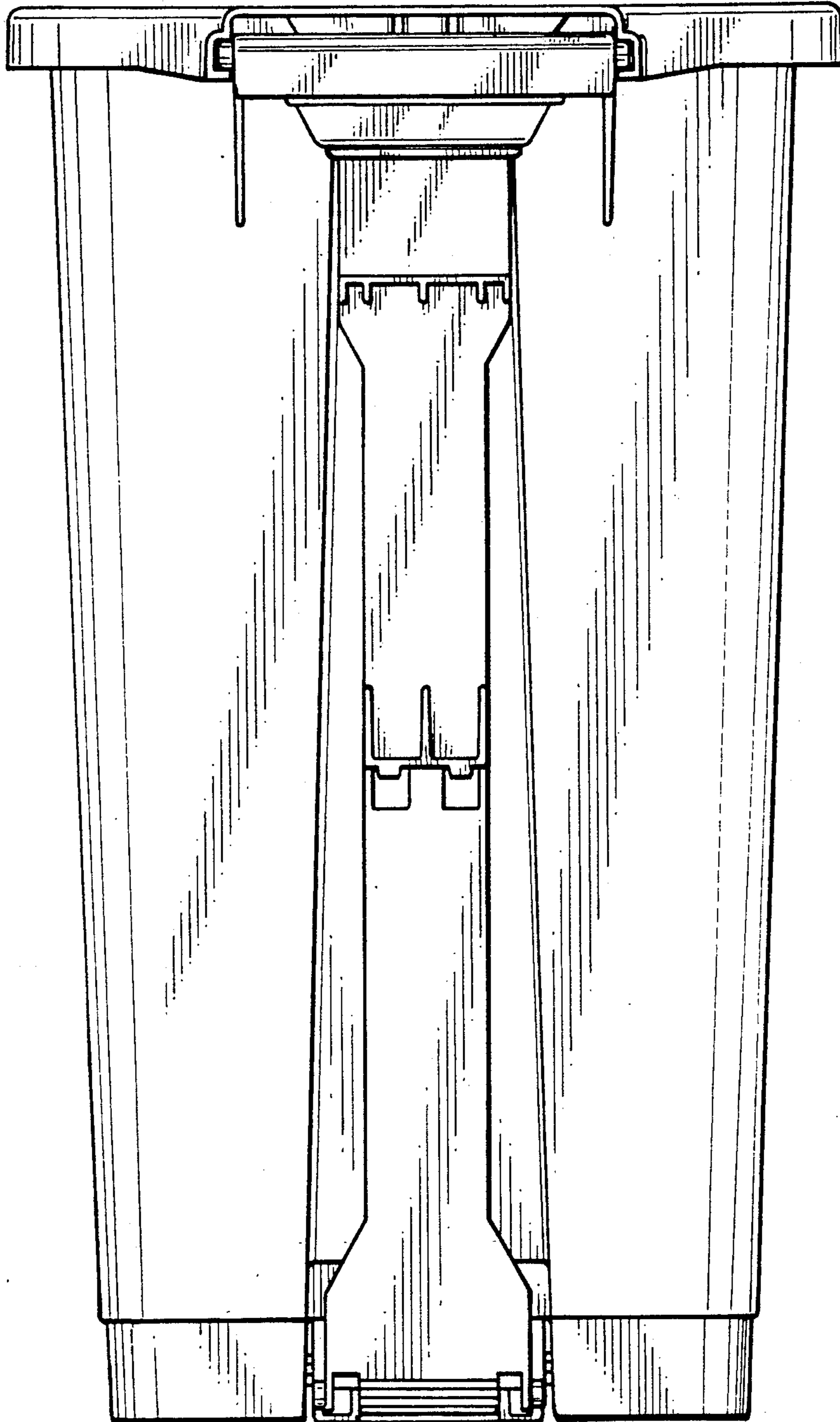

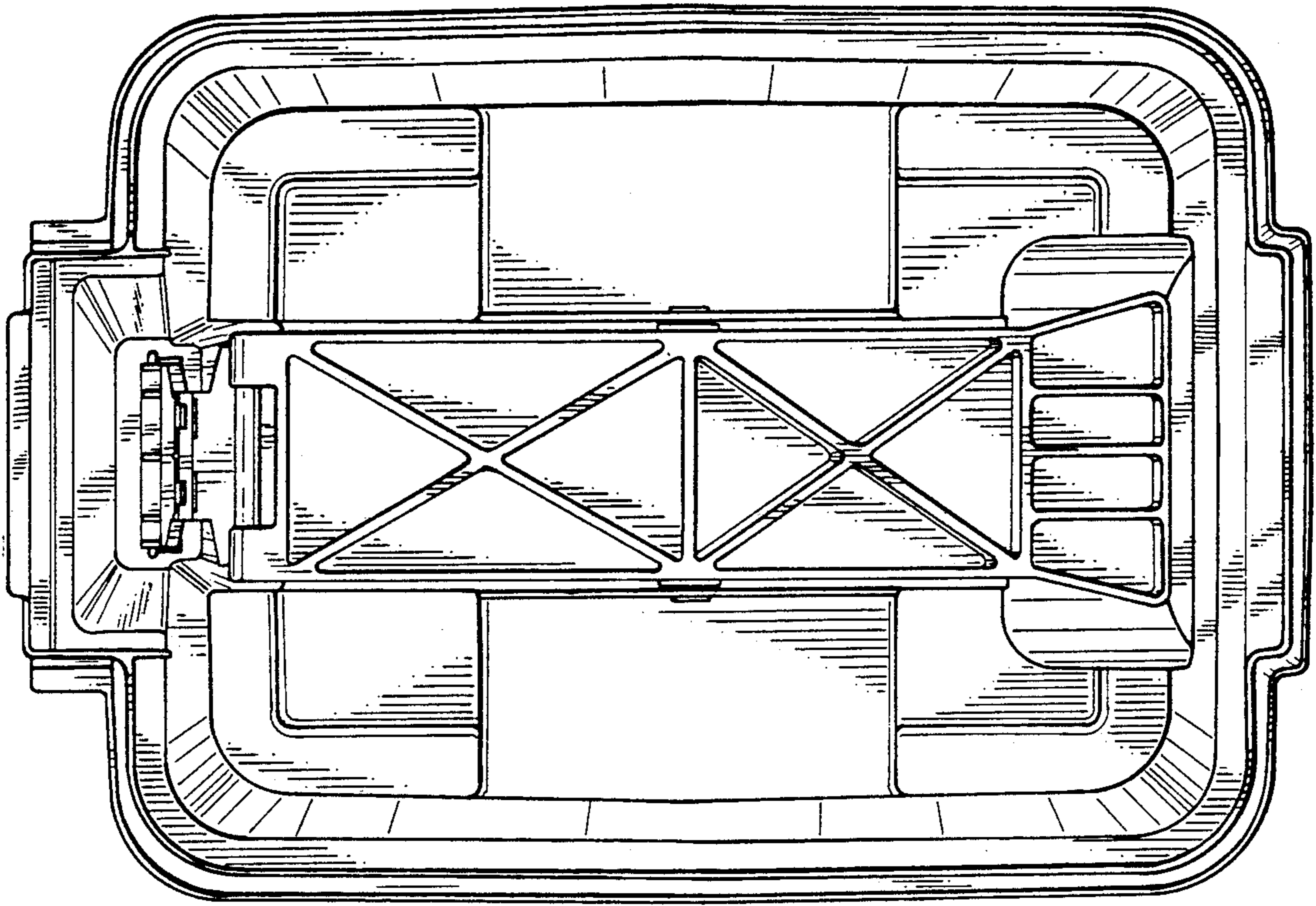

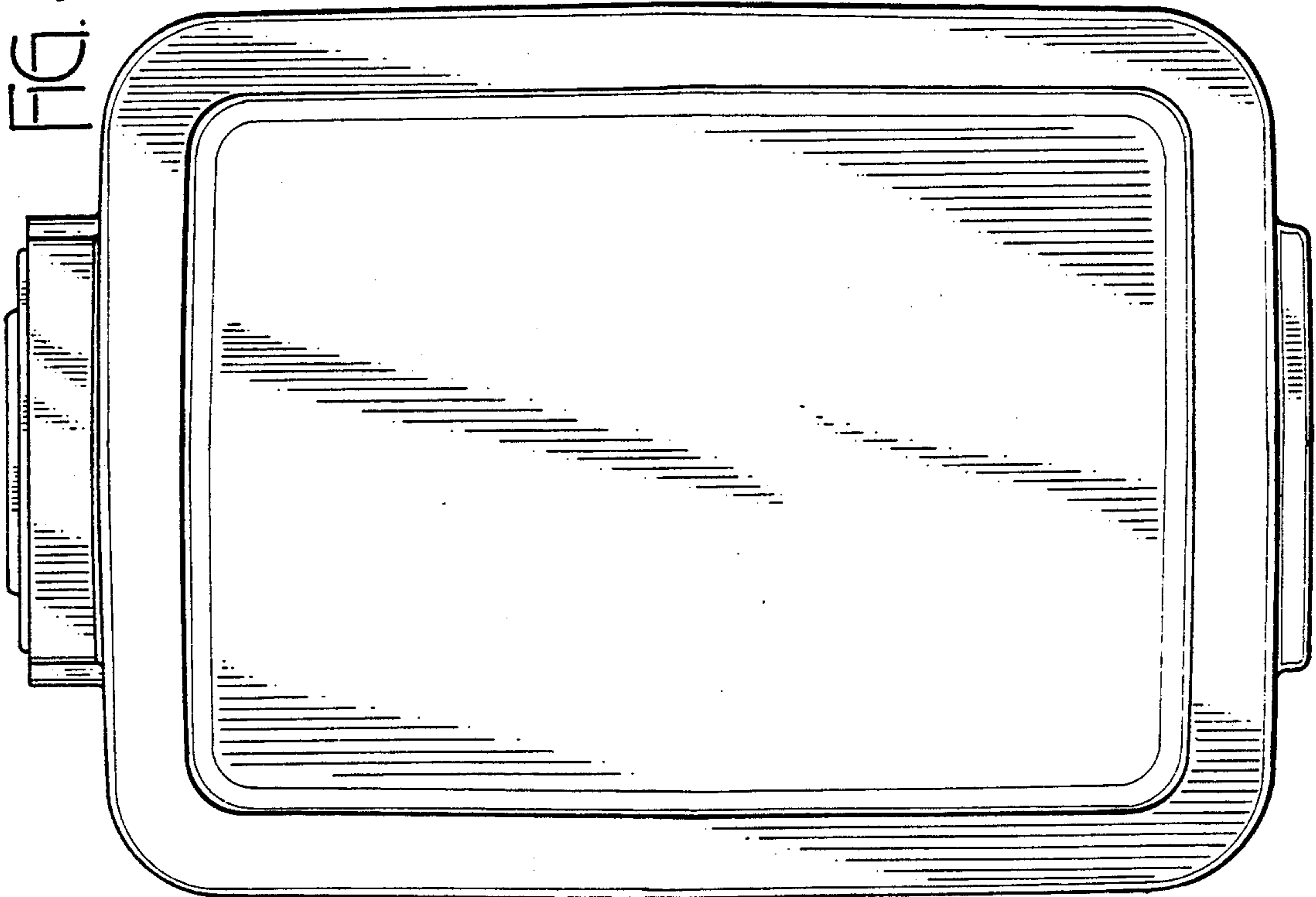

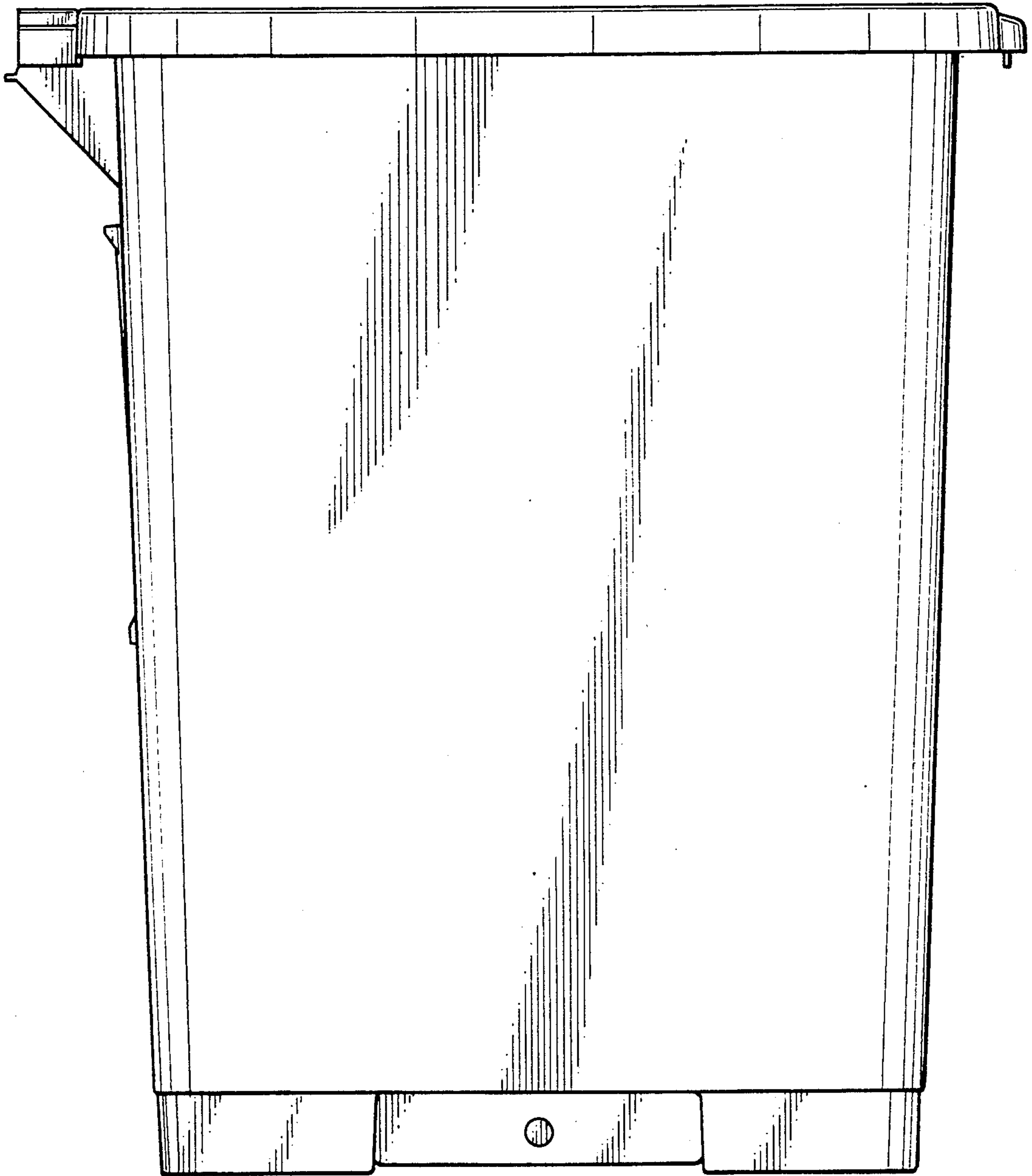
