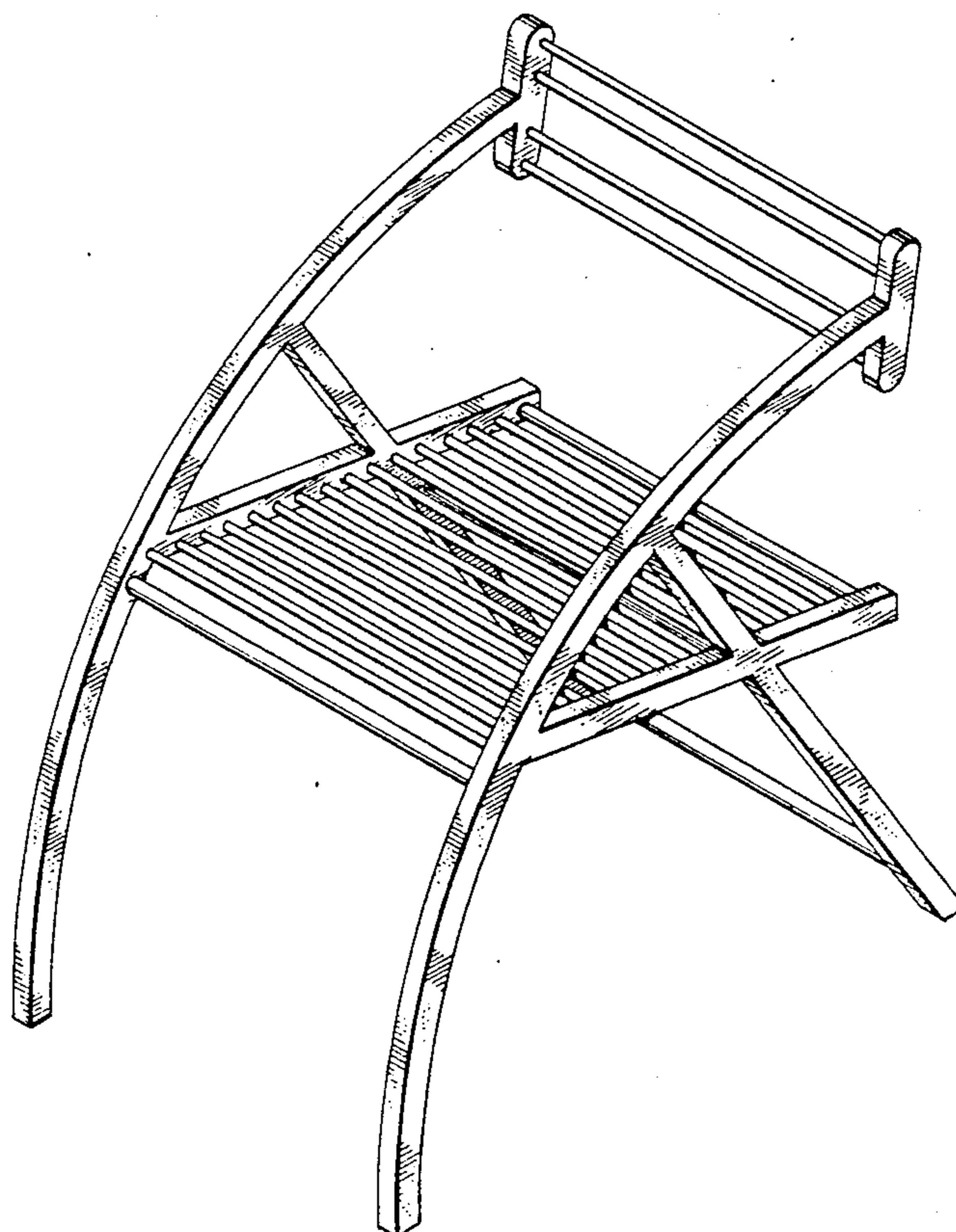

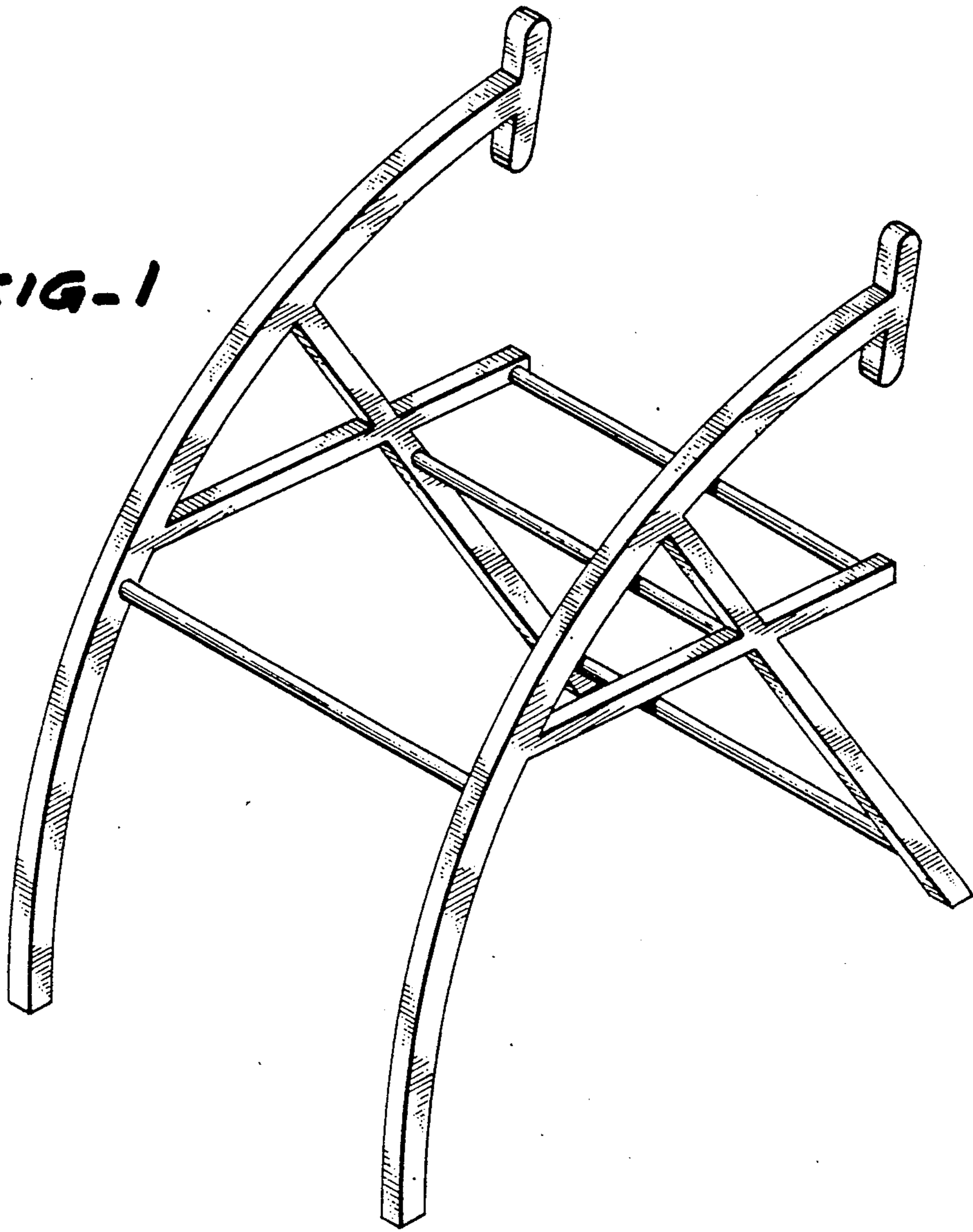
The ornamental design for chair frame or similar article, as shown and described.

**DESCRIPTION**

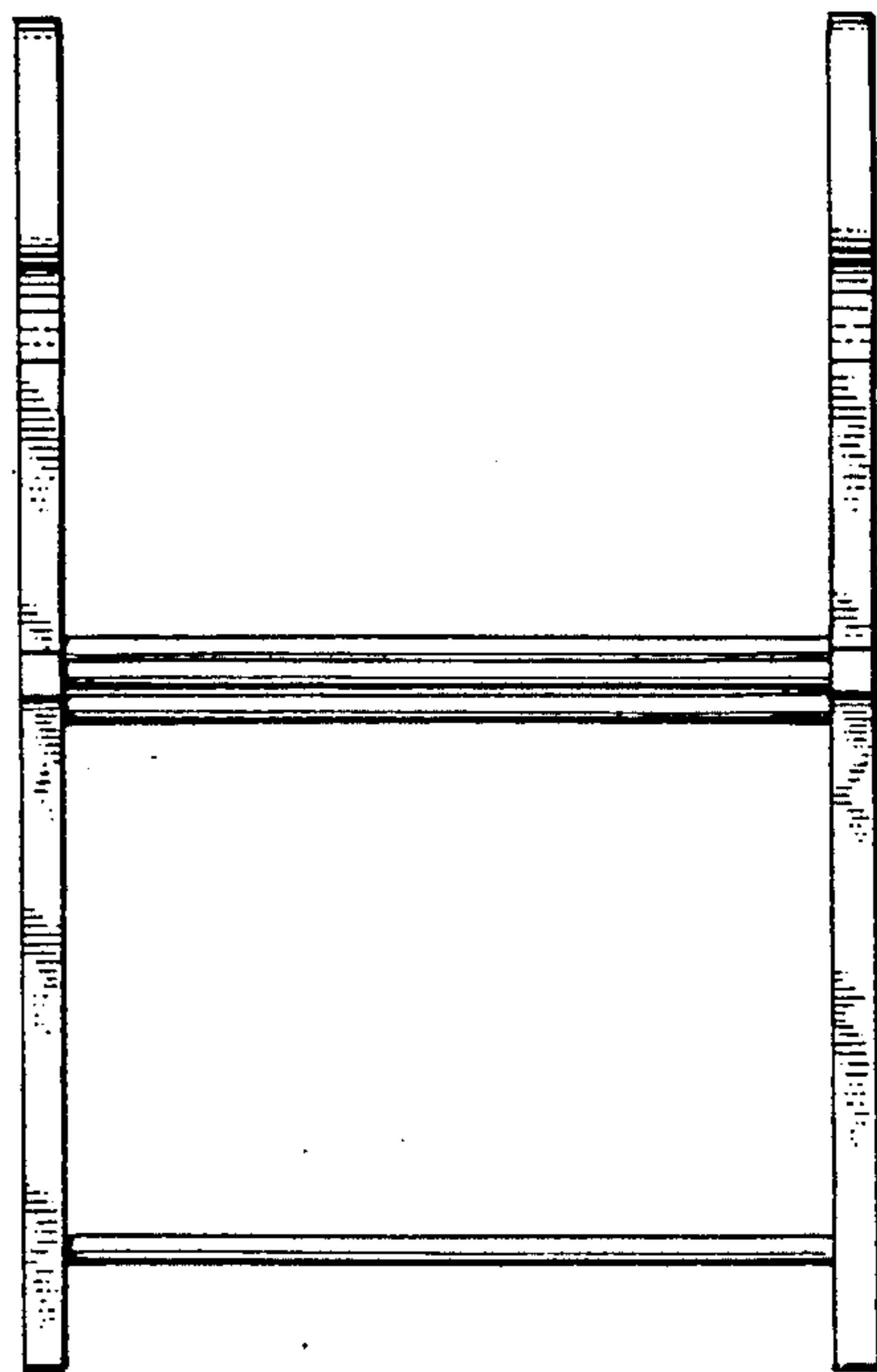
FIG. 1 is a front perspective view of a chair frame or similar article showing my new design;

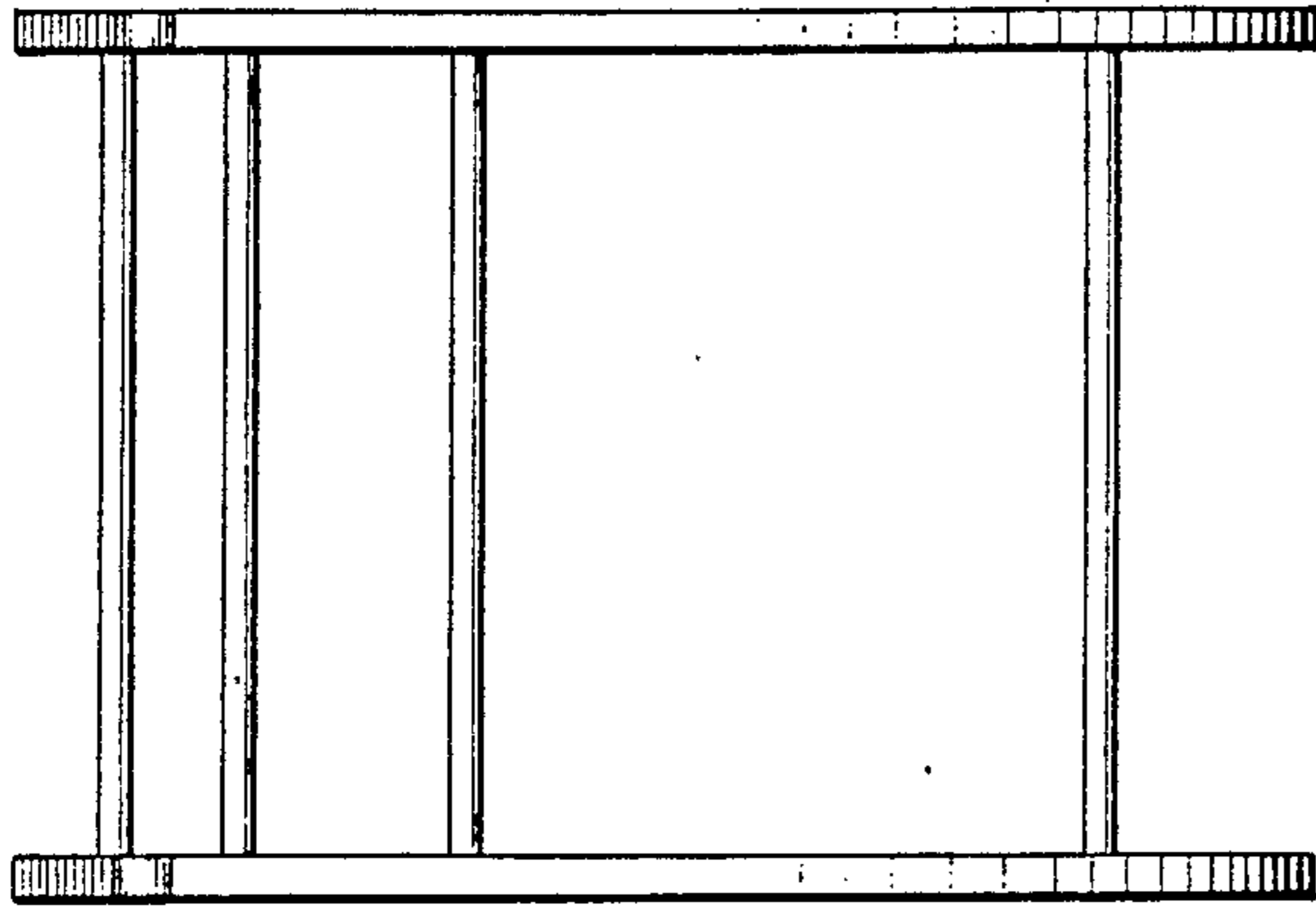

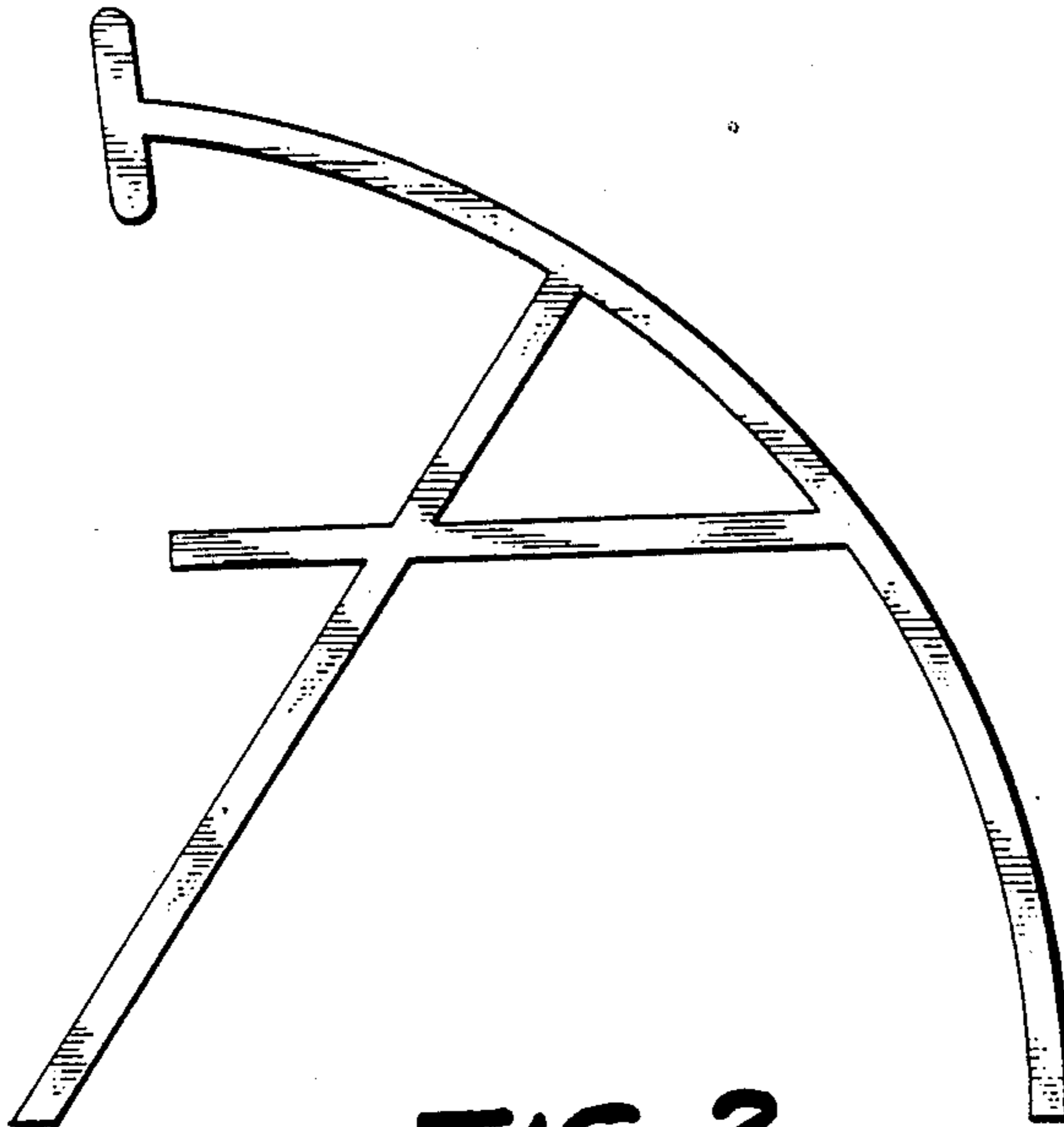

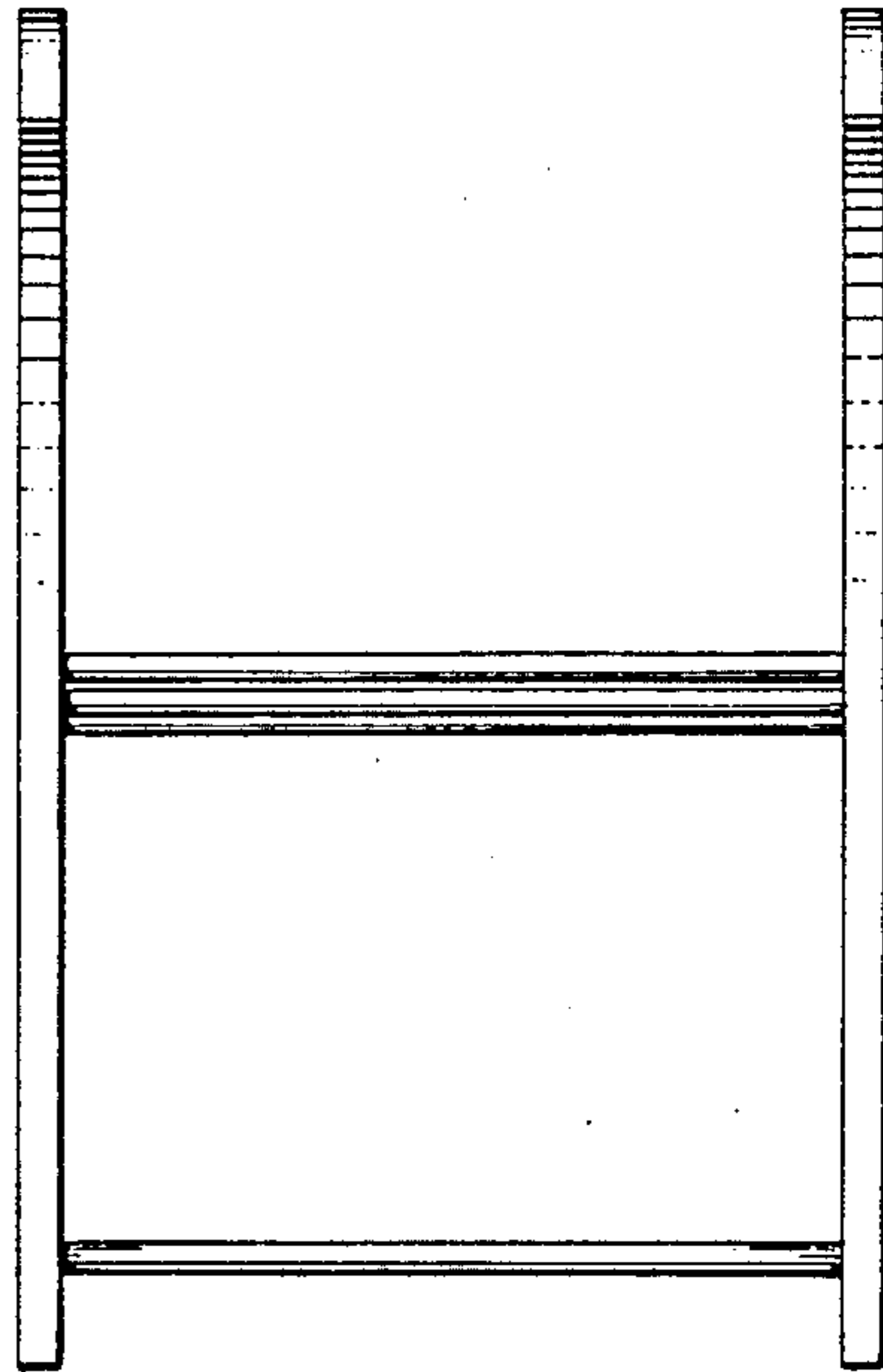

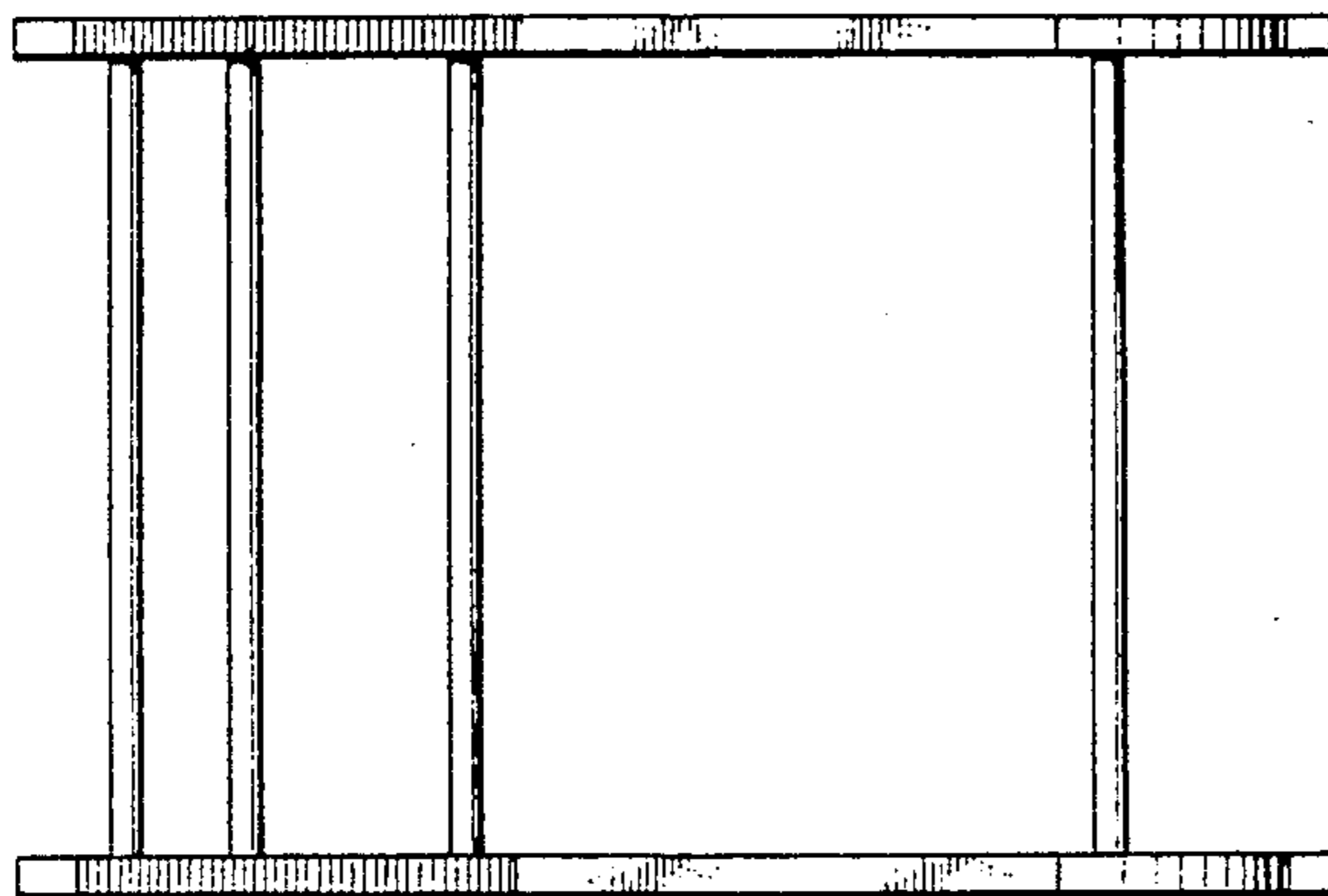
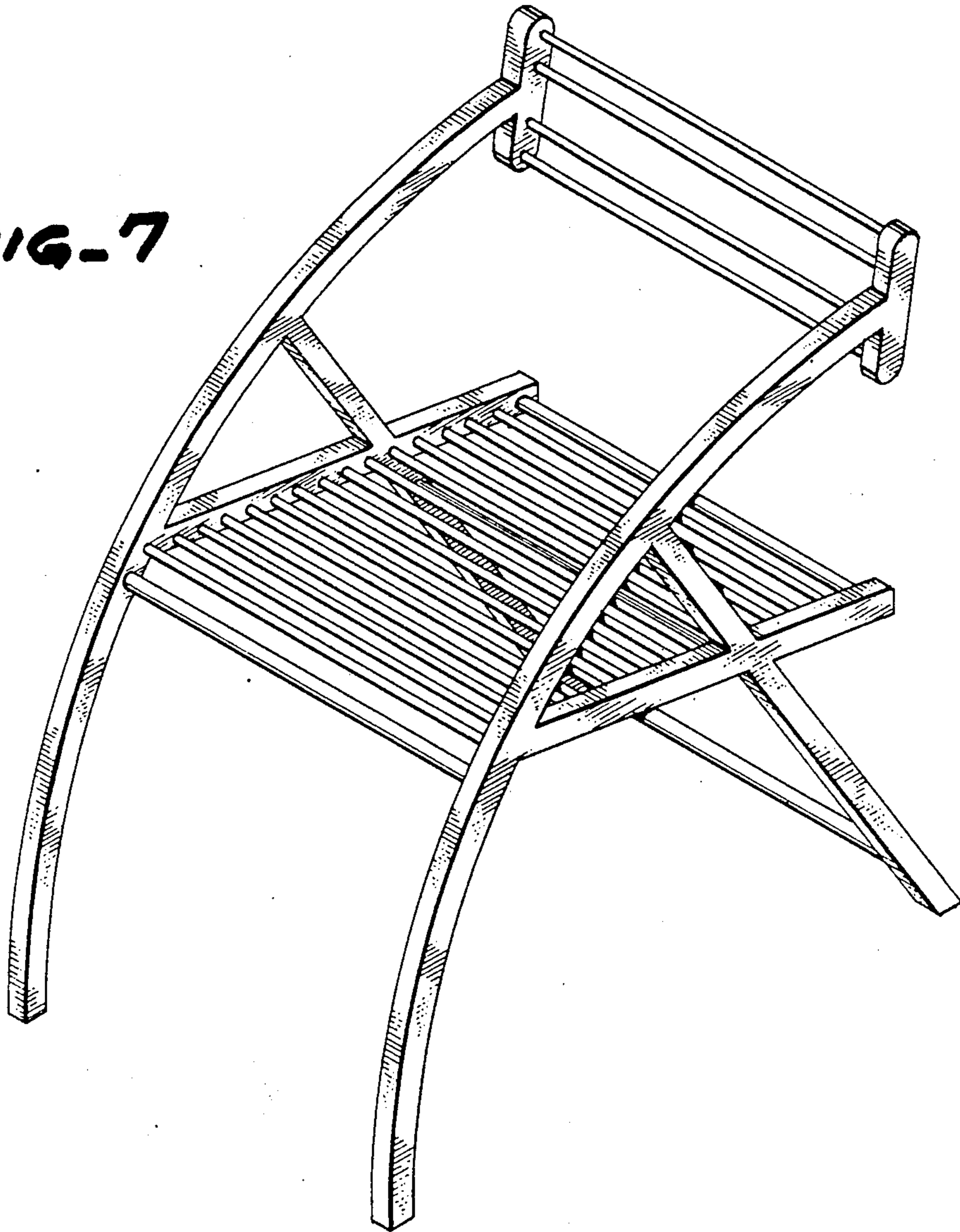
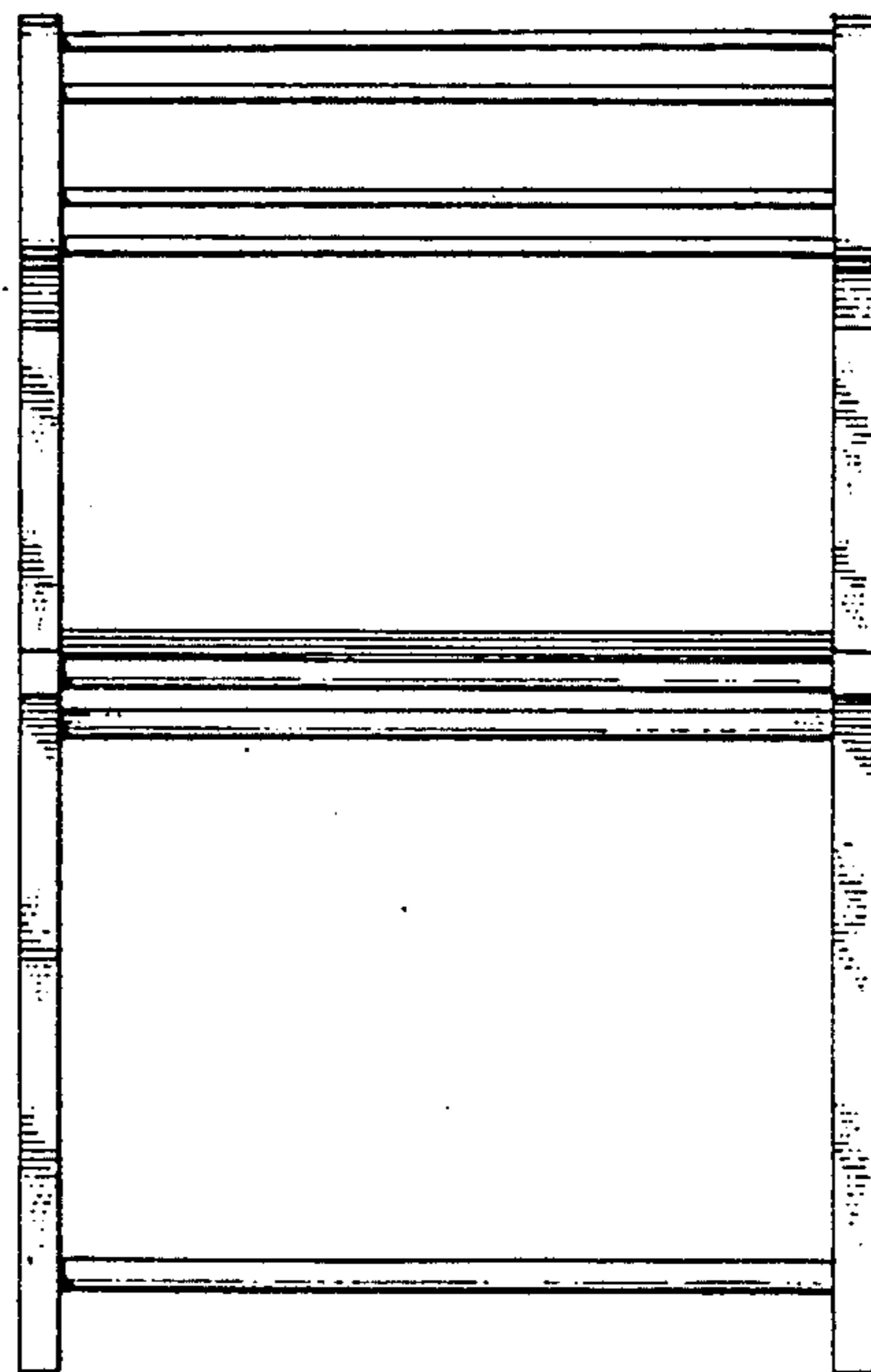

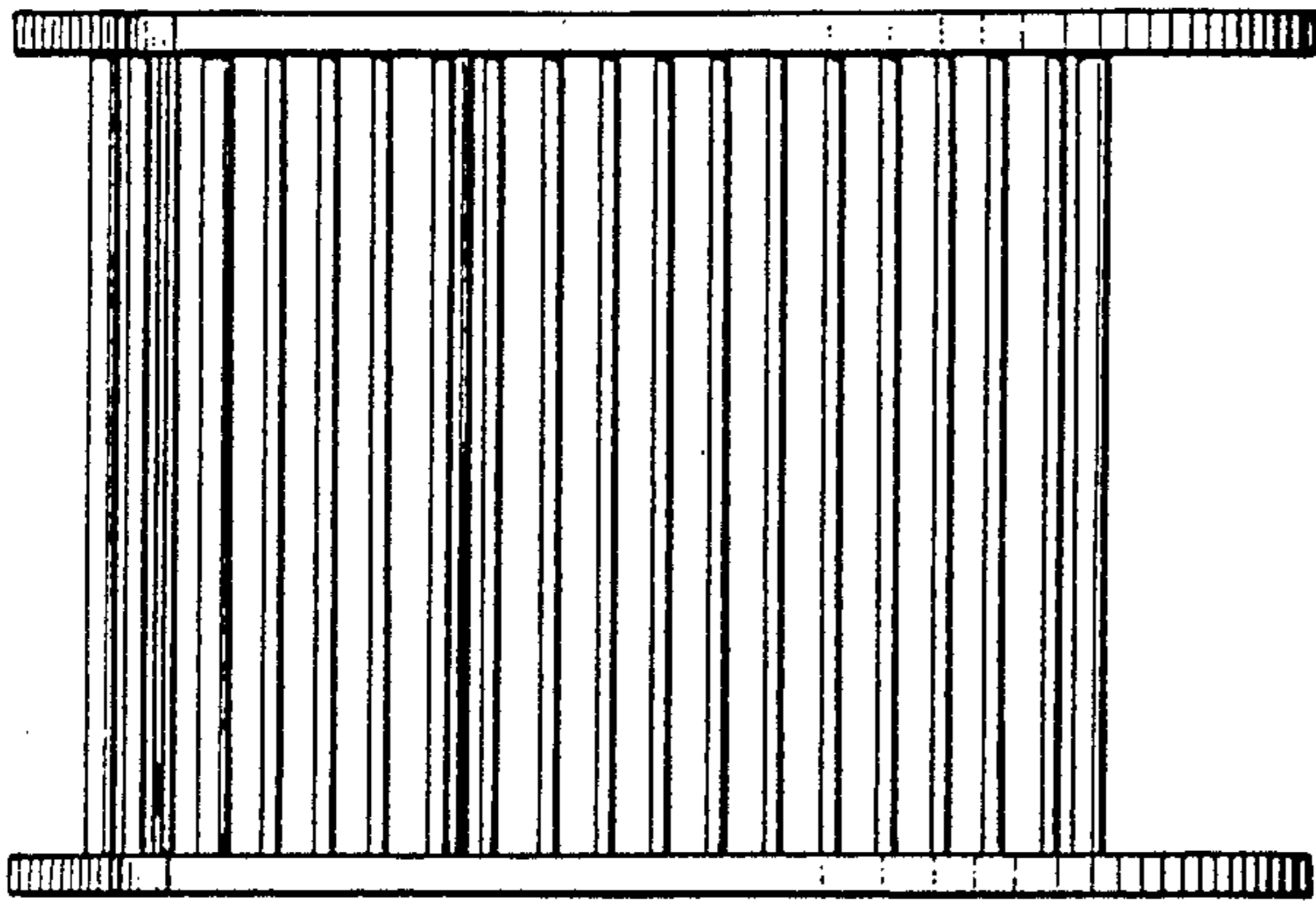

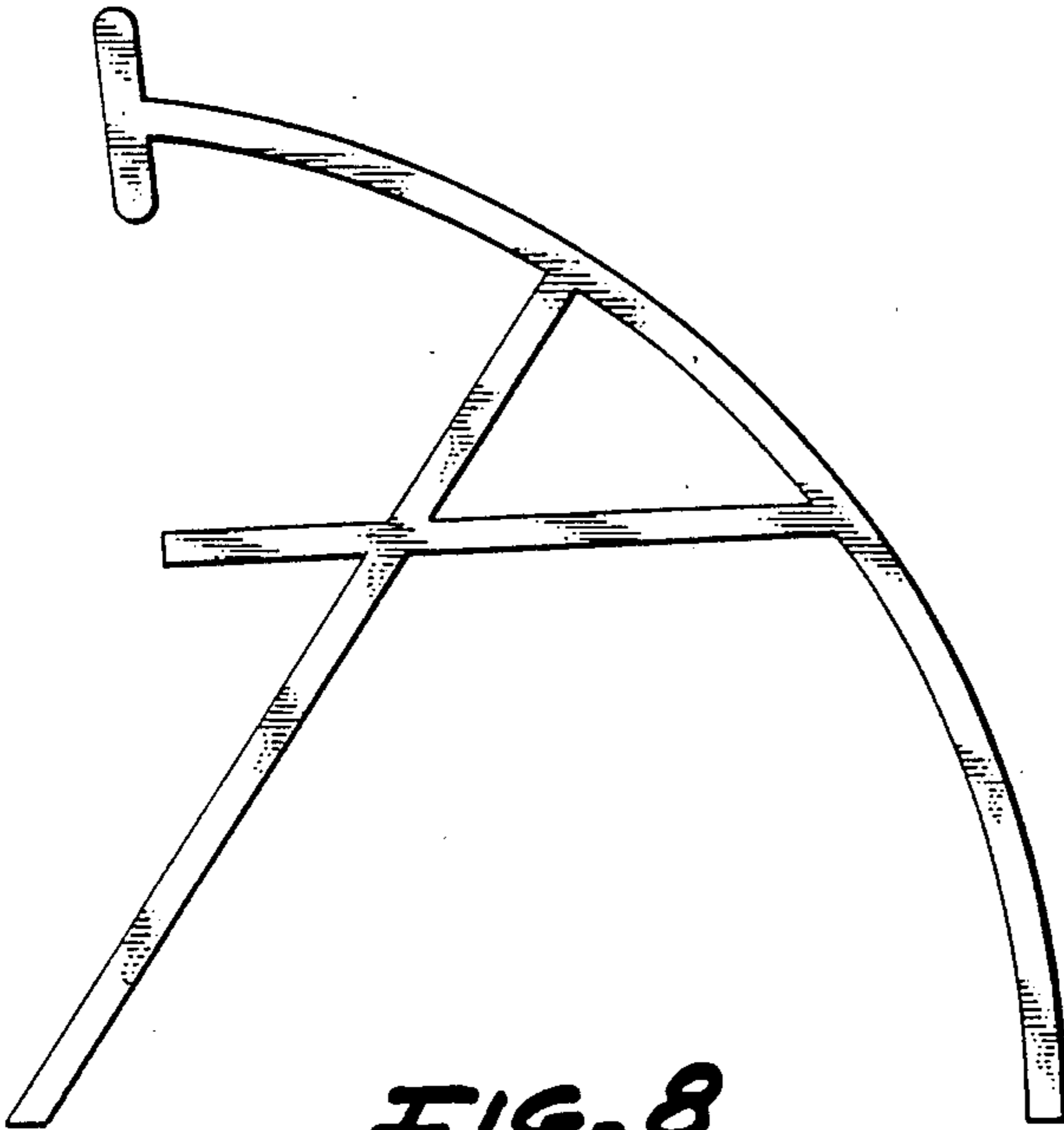

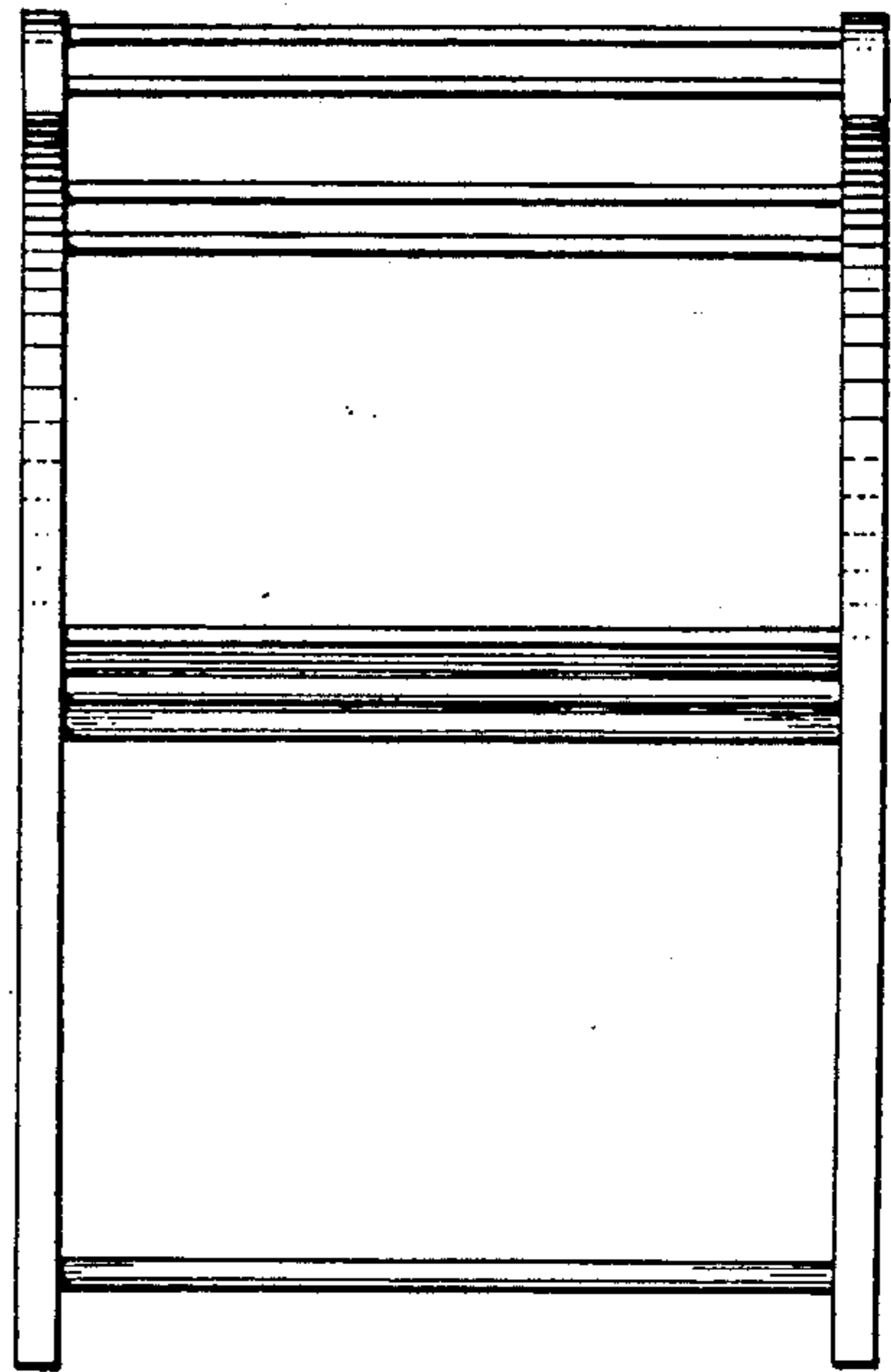

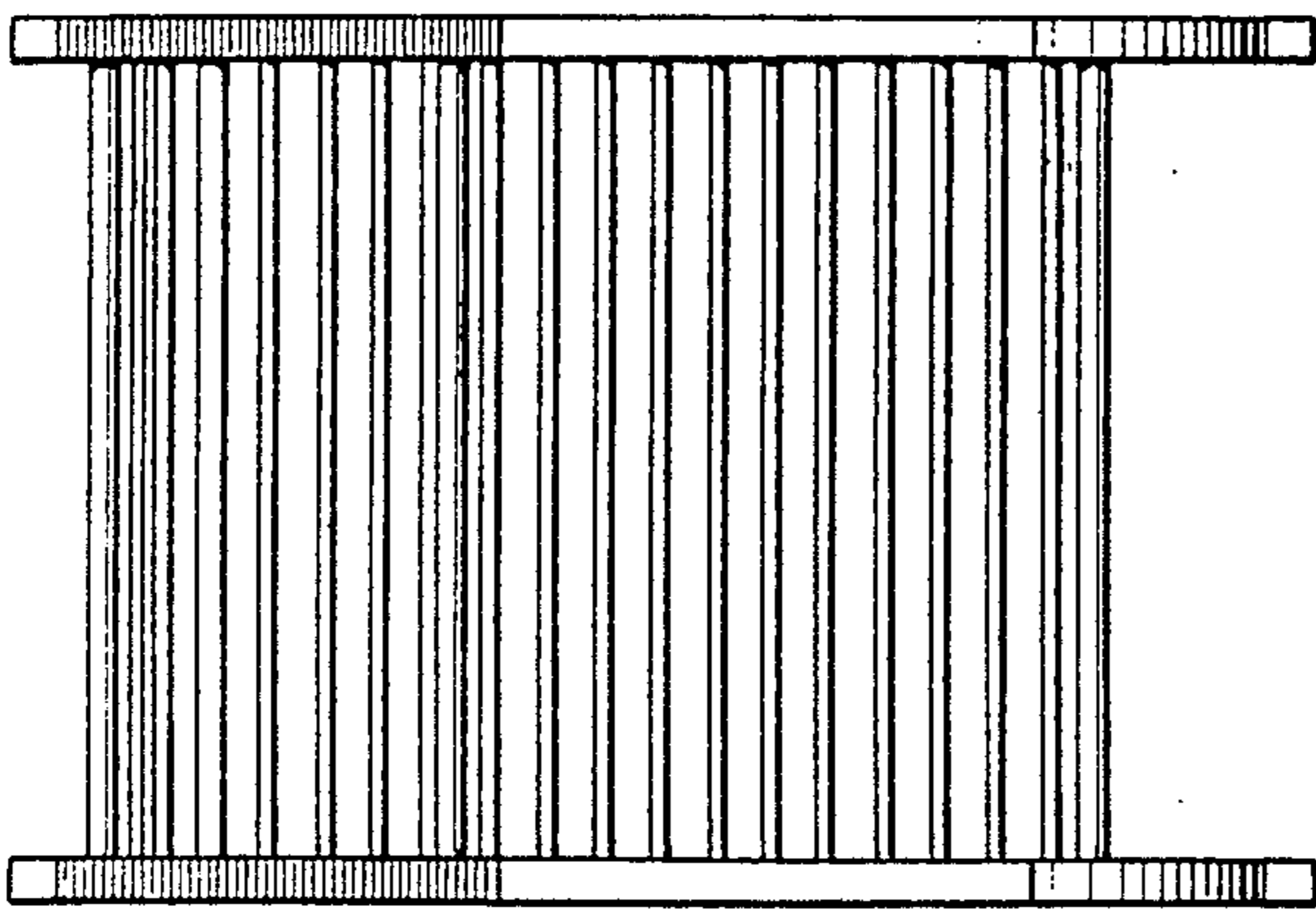
