DESCRIPTION

 FIG. 16 is a bottom plan view thereof.

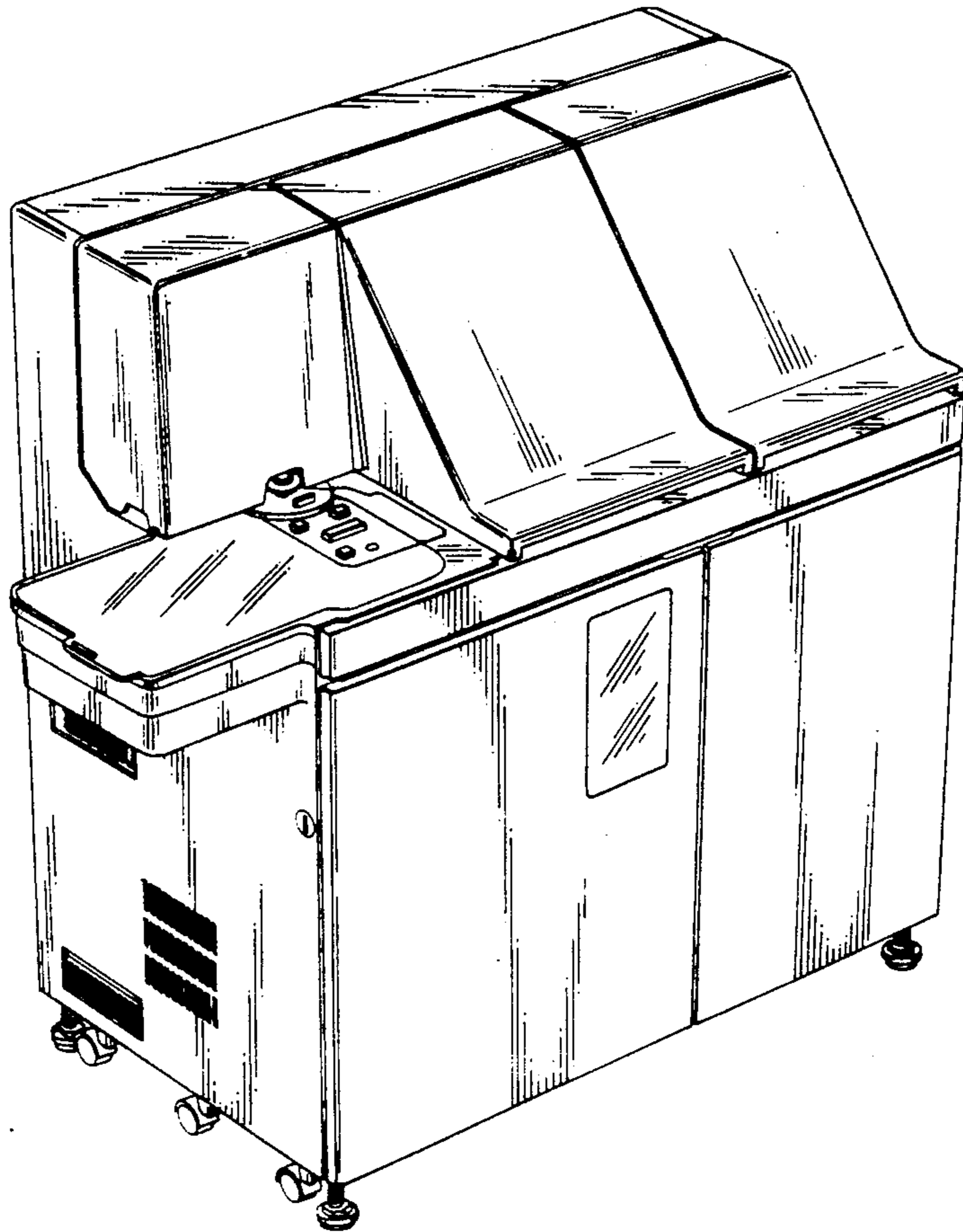

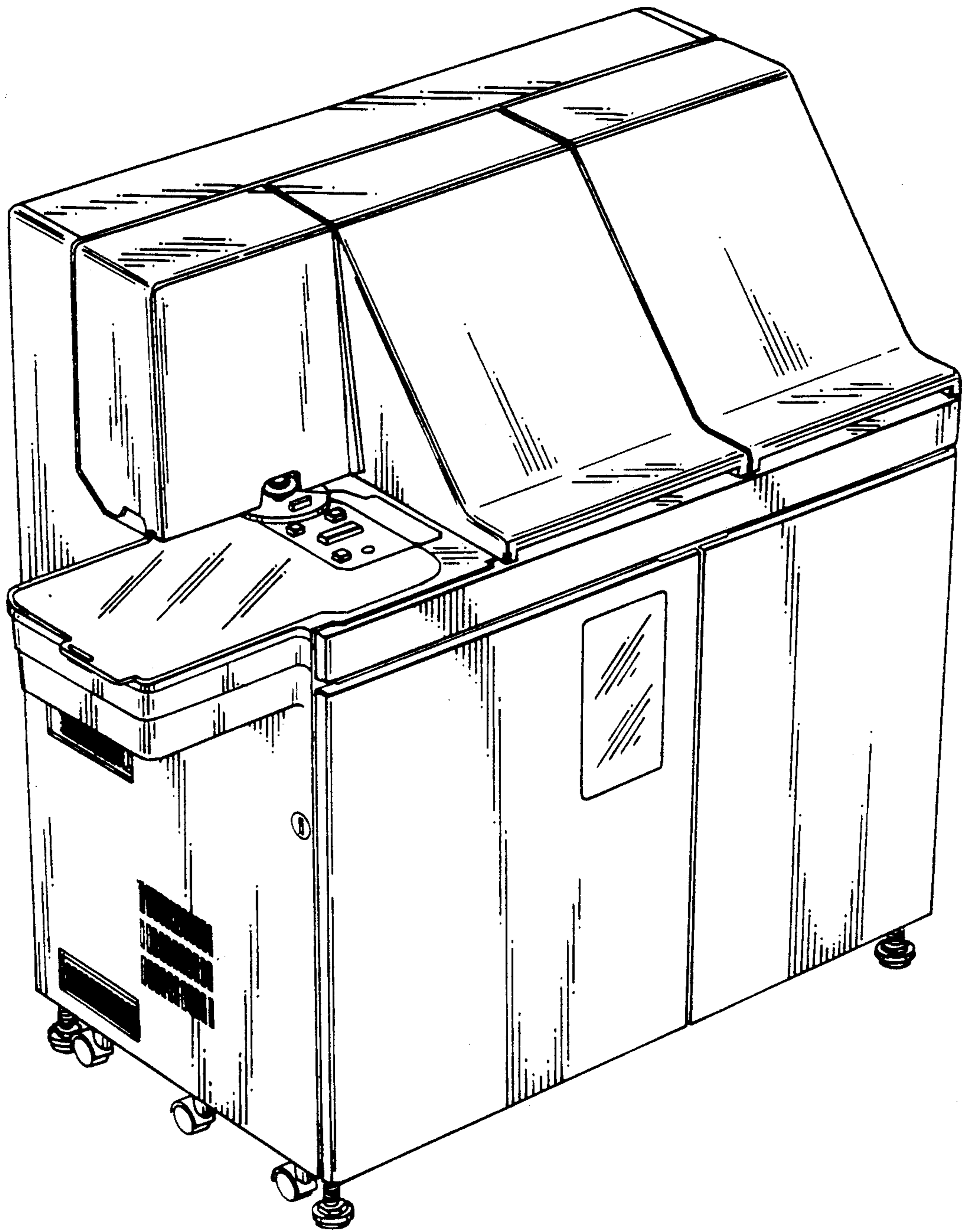

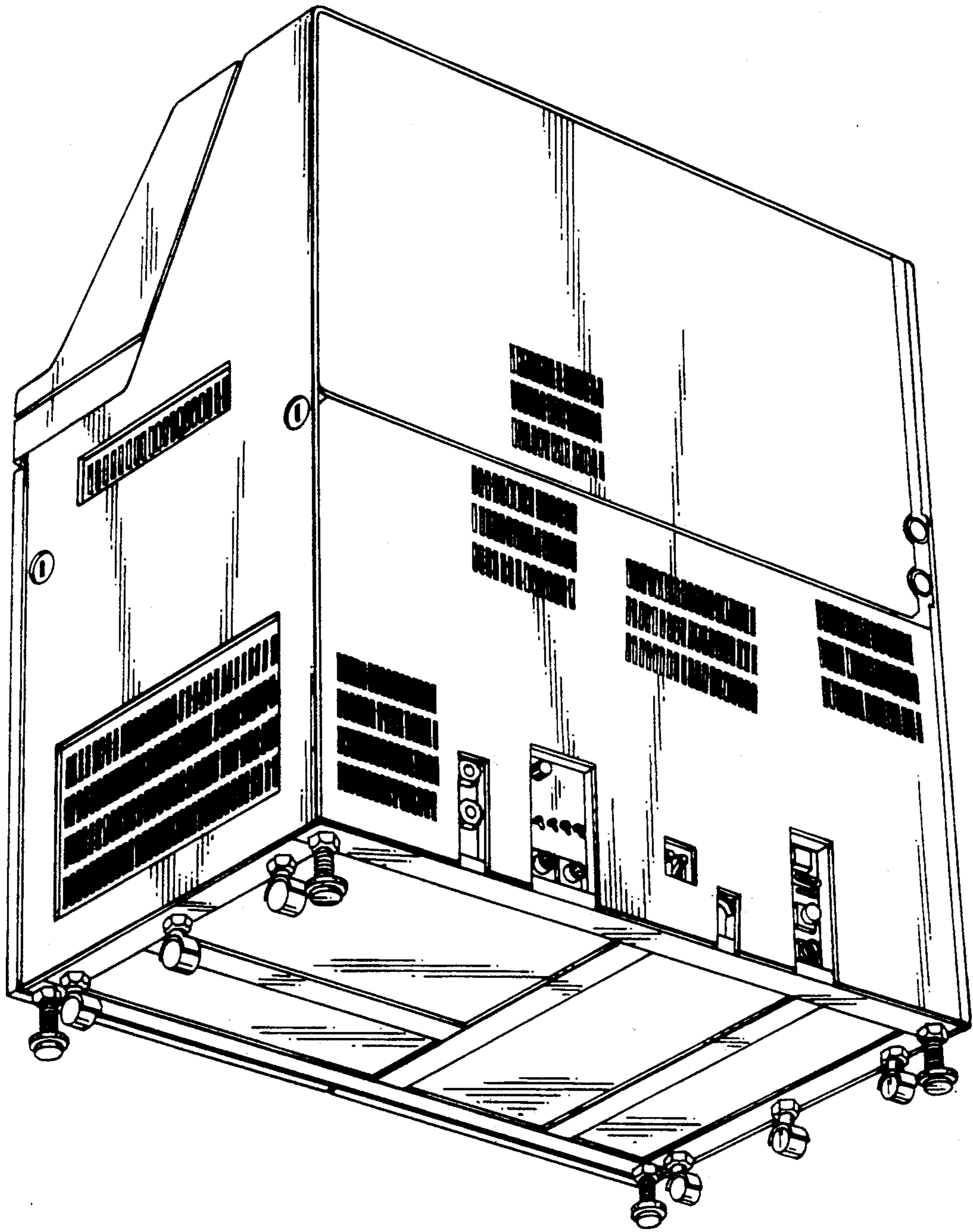

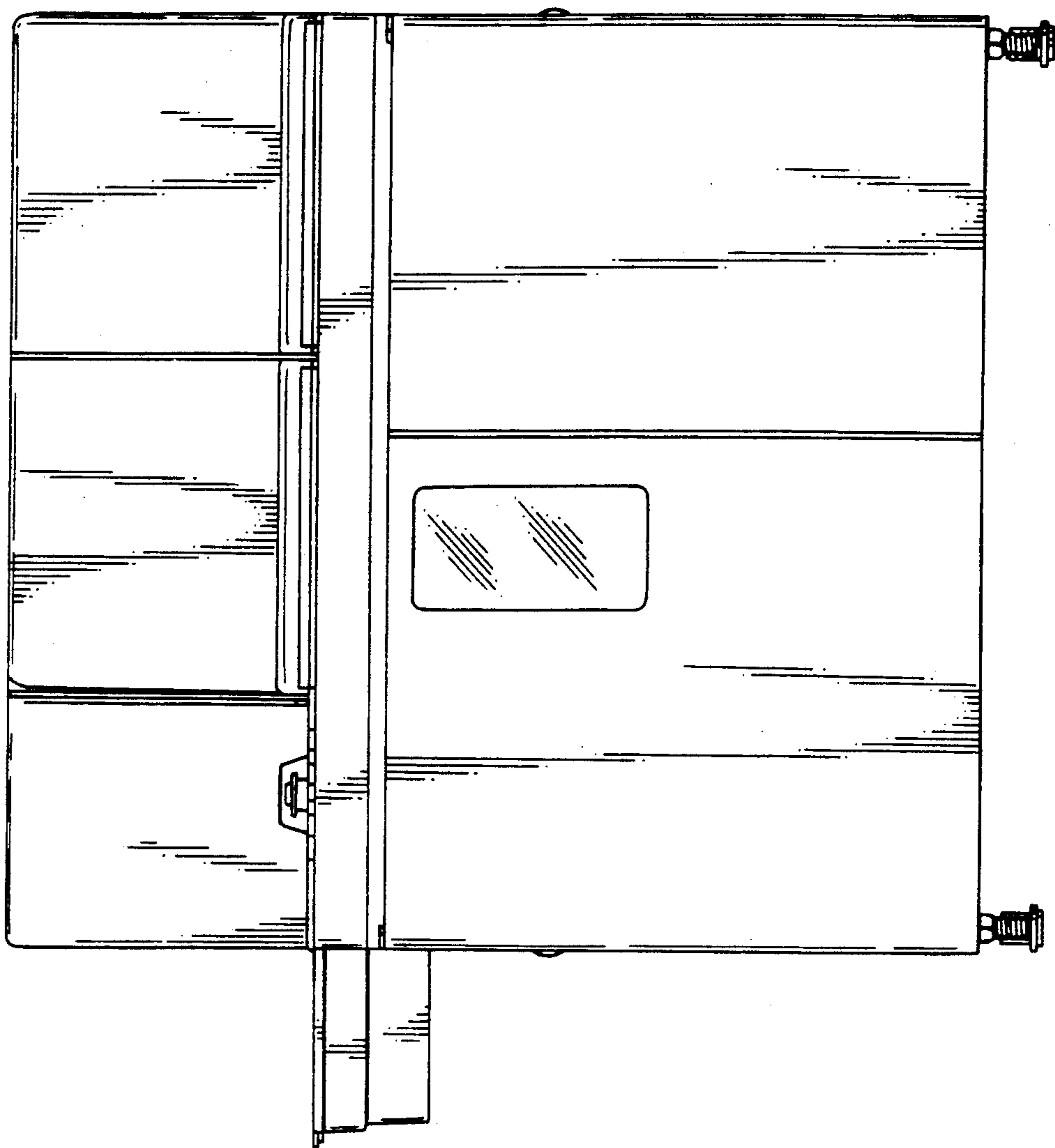

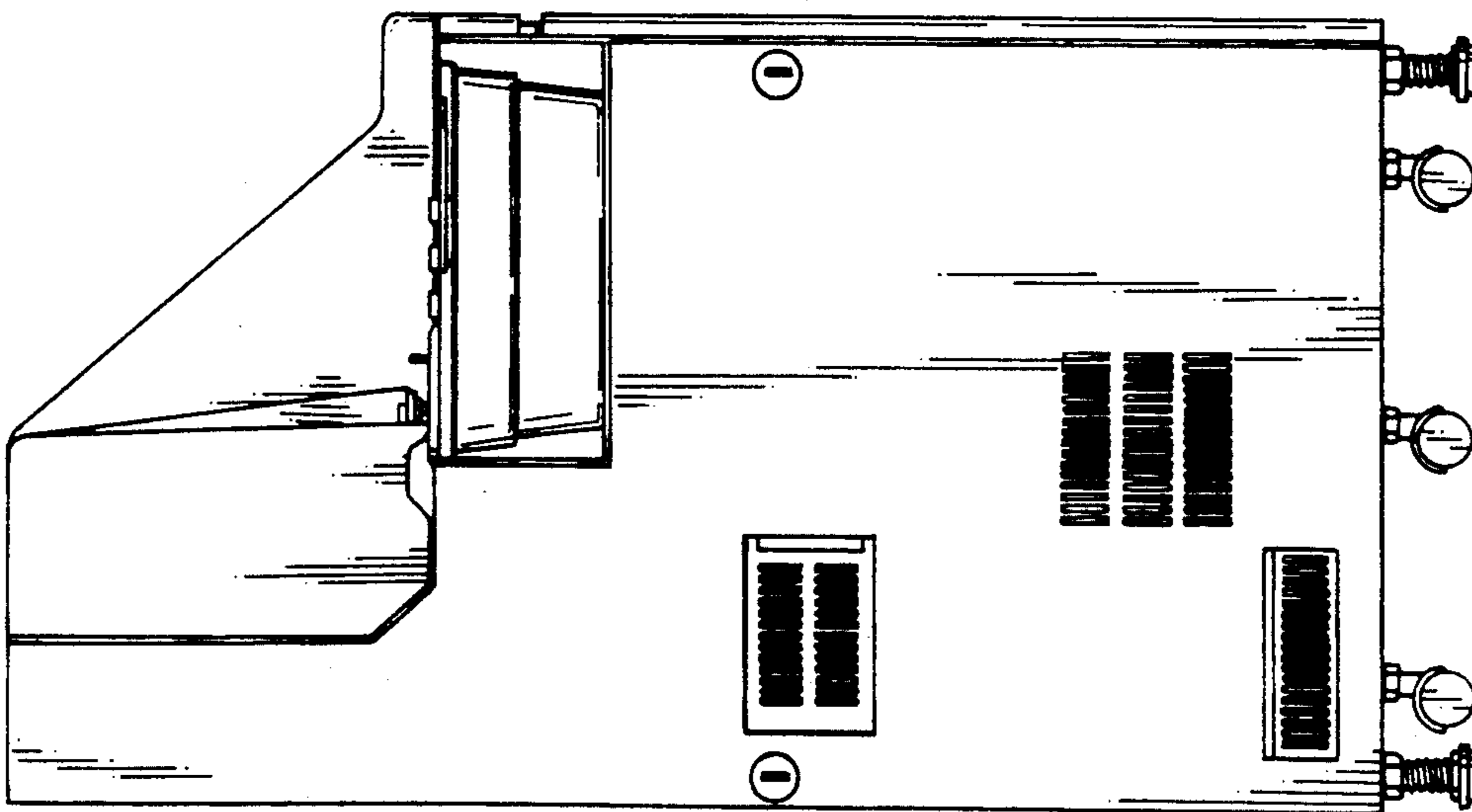

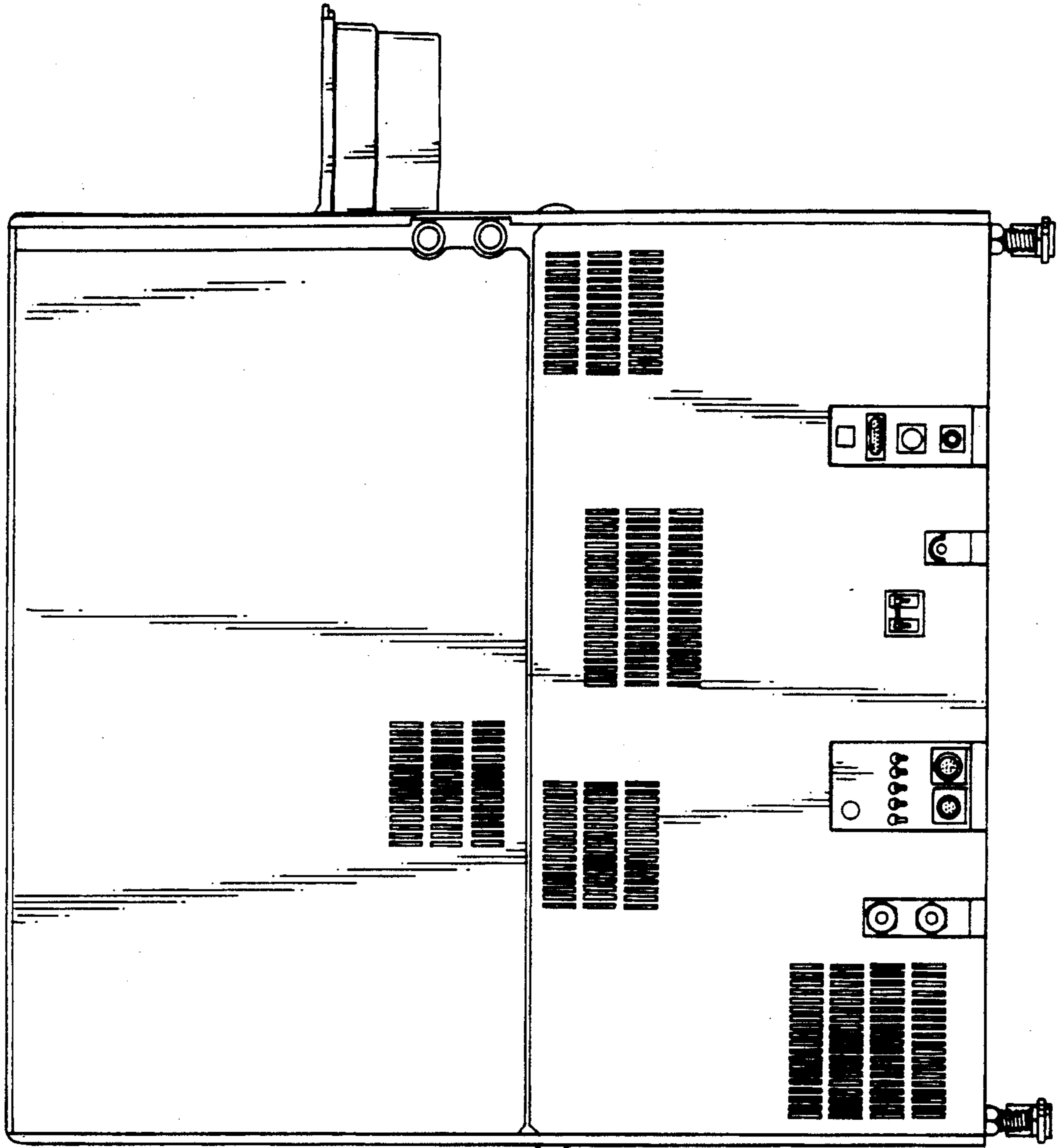

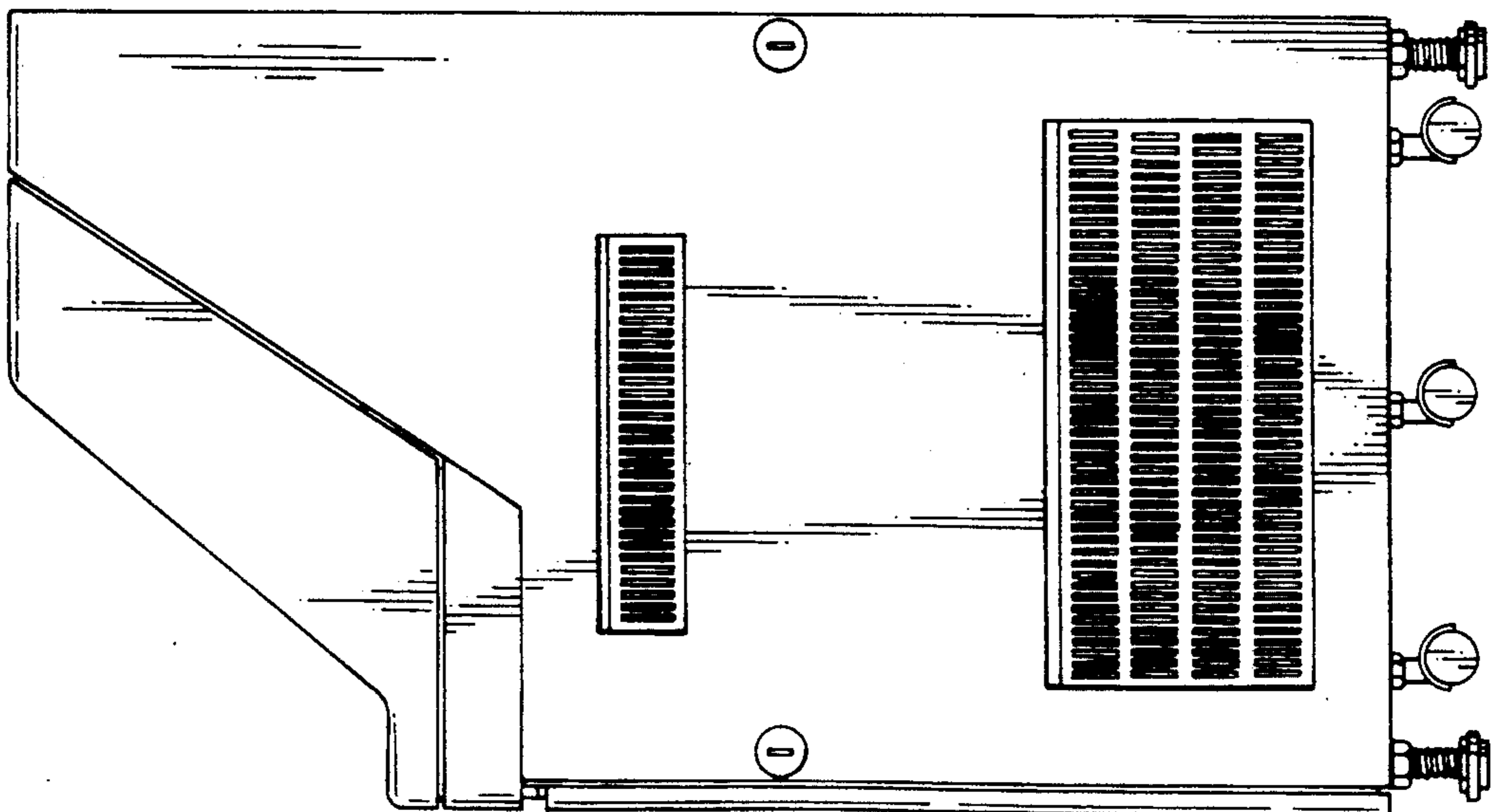

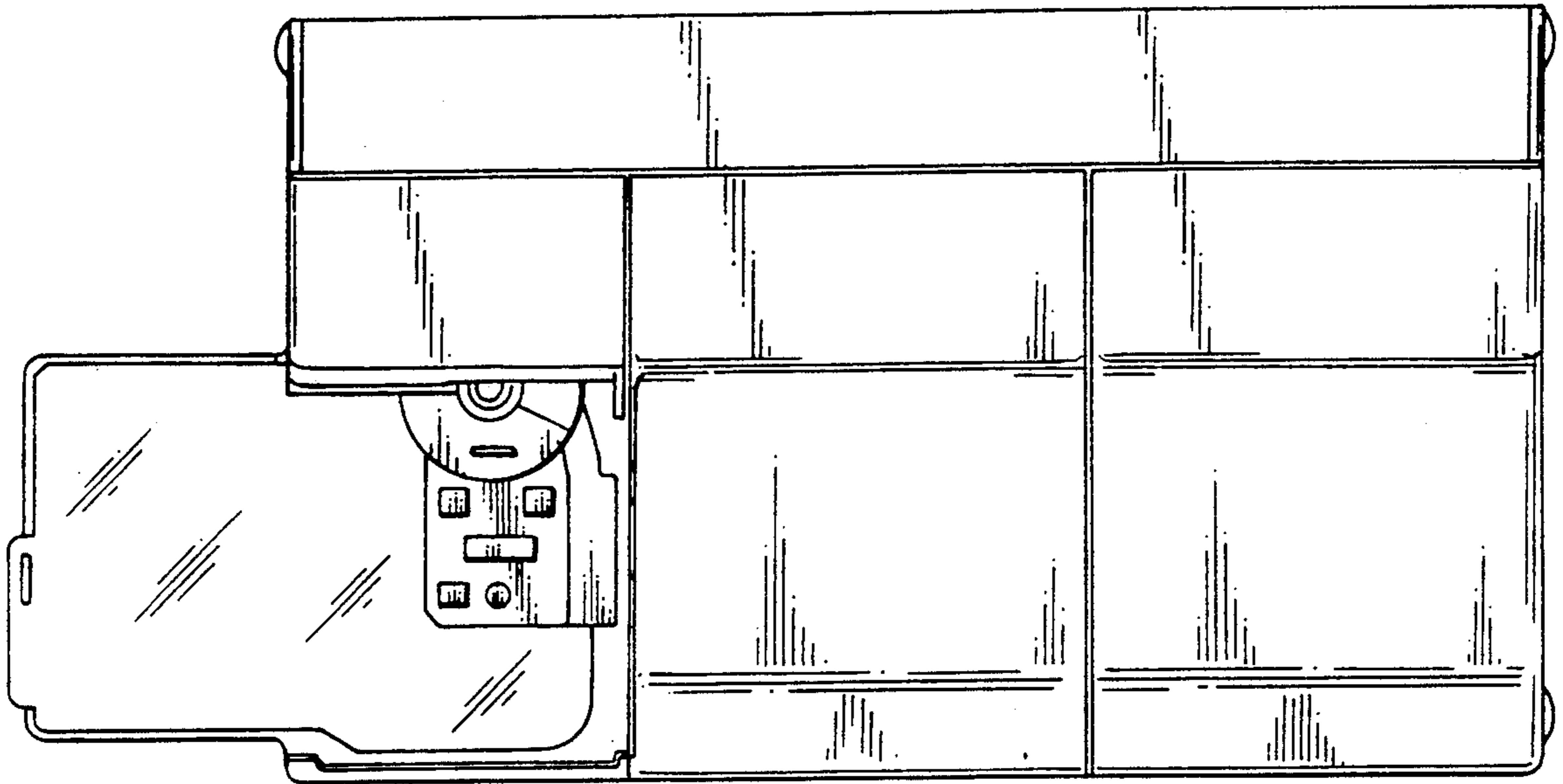

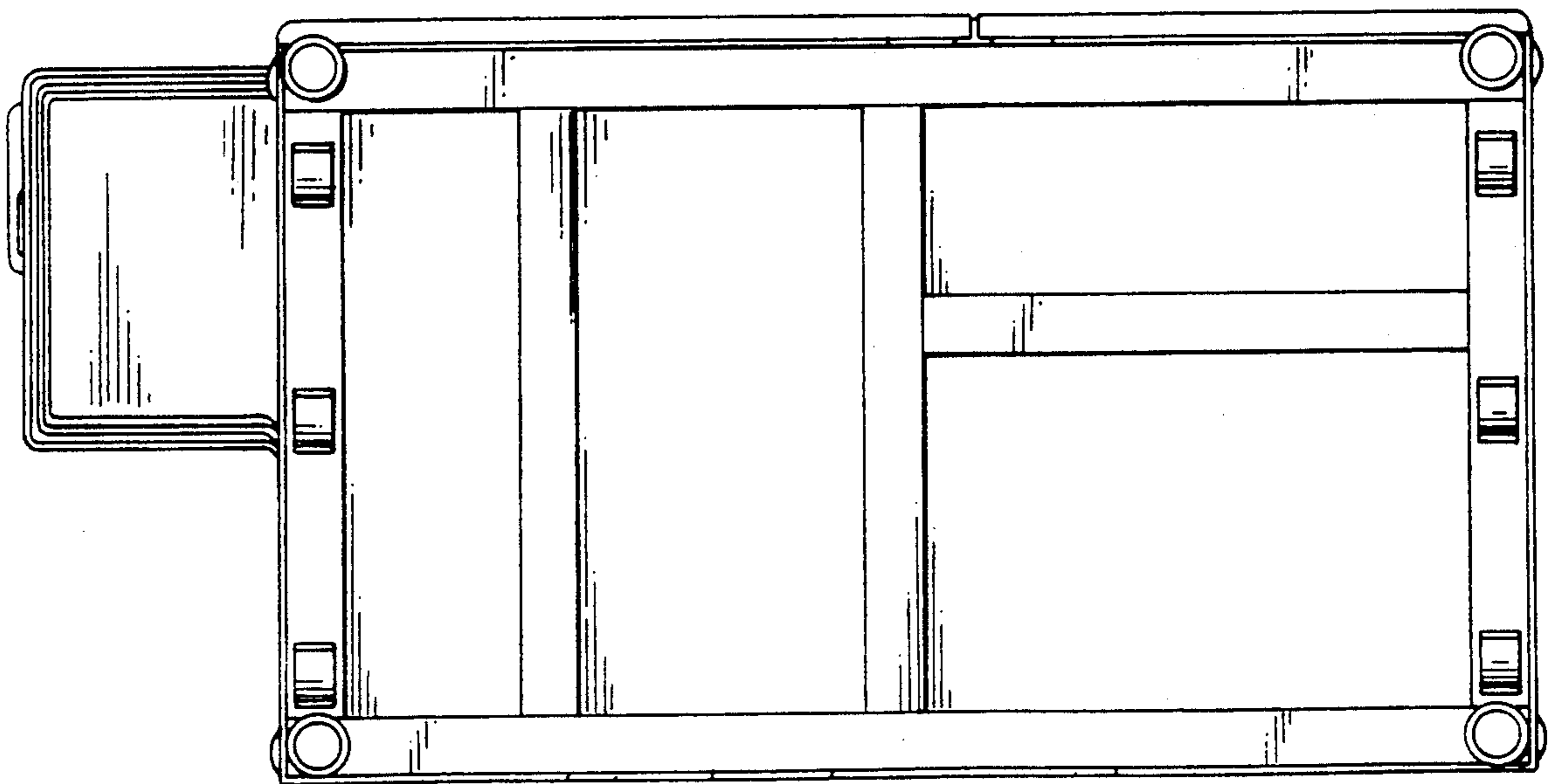

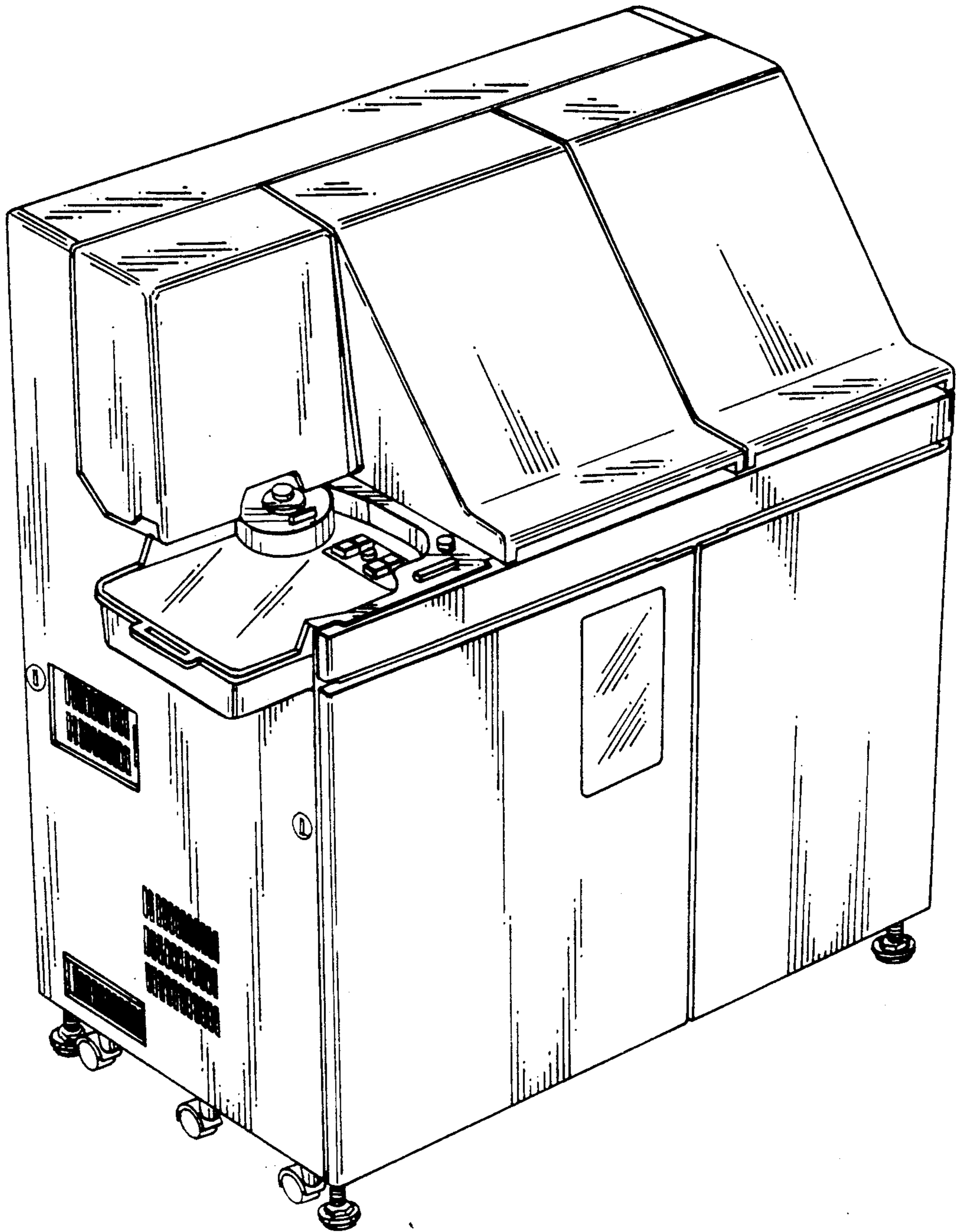

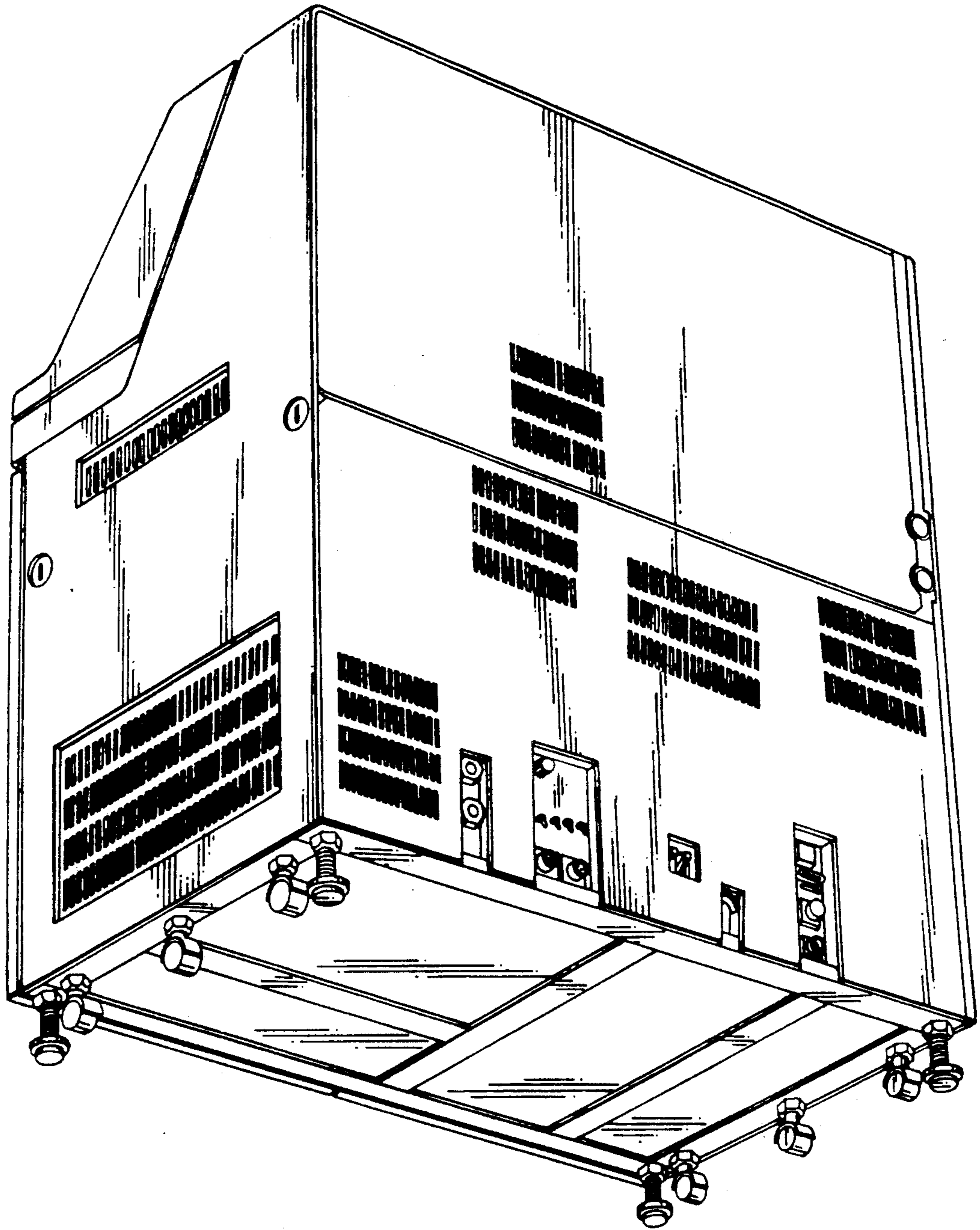

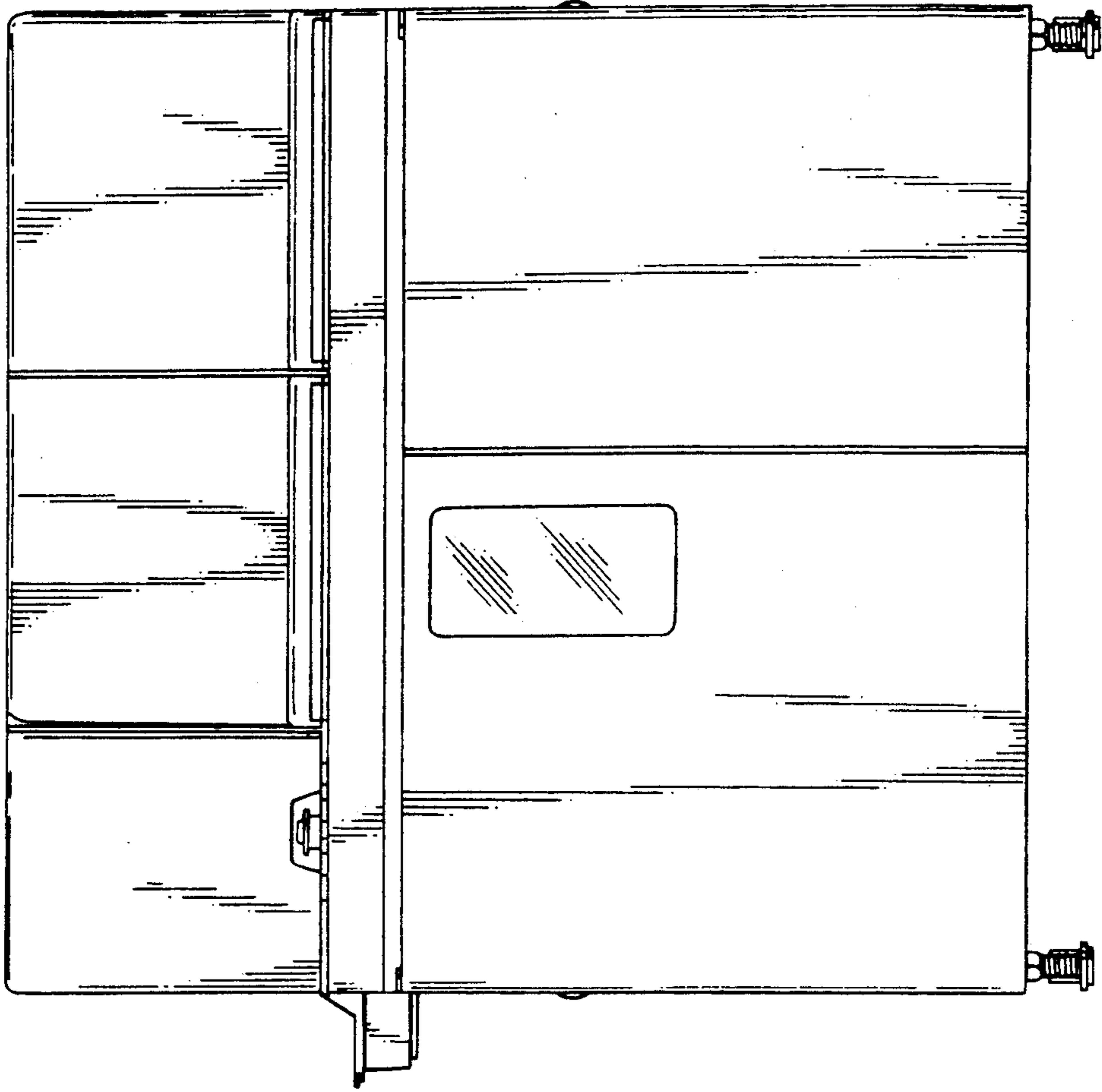

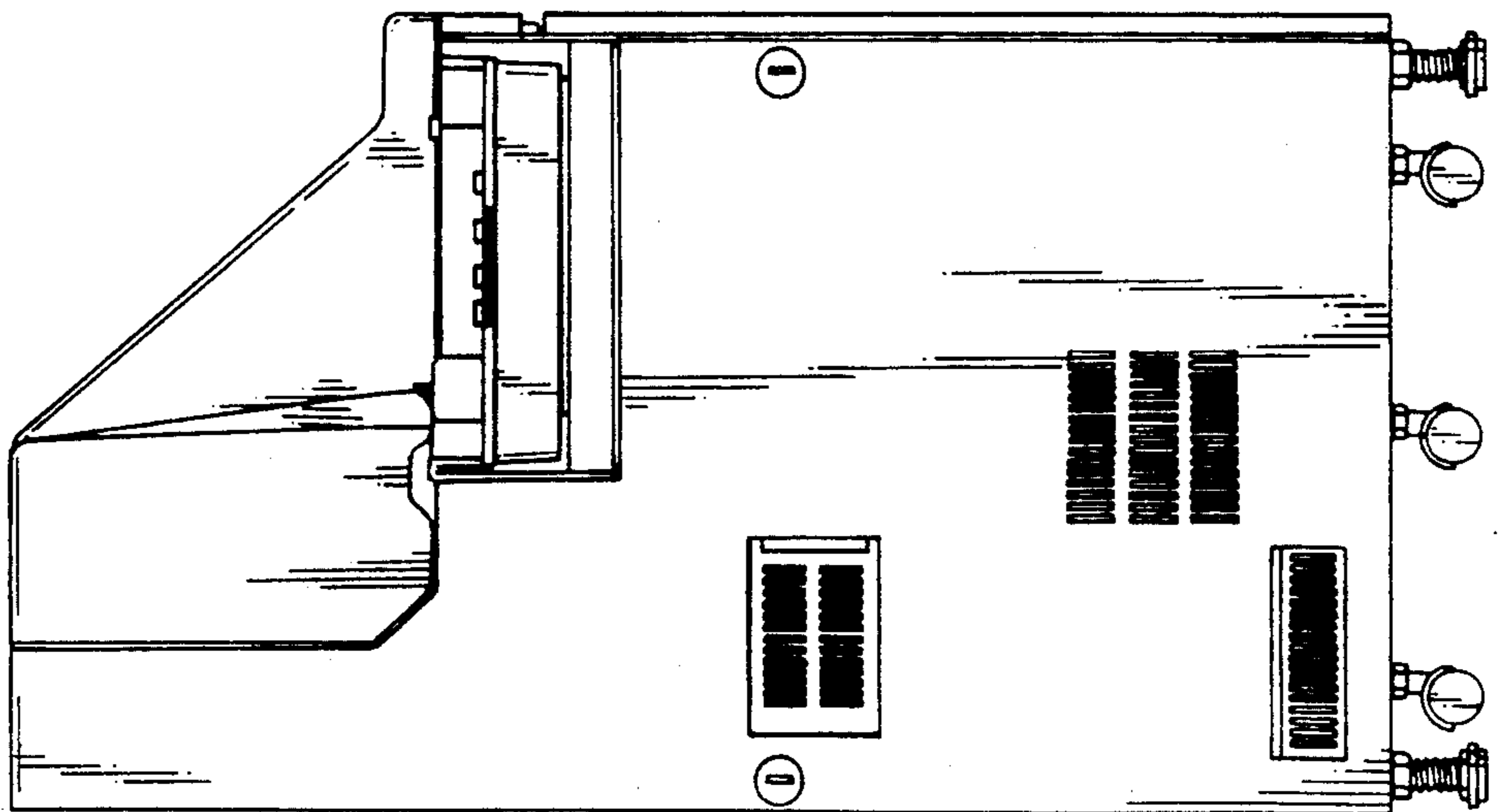

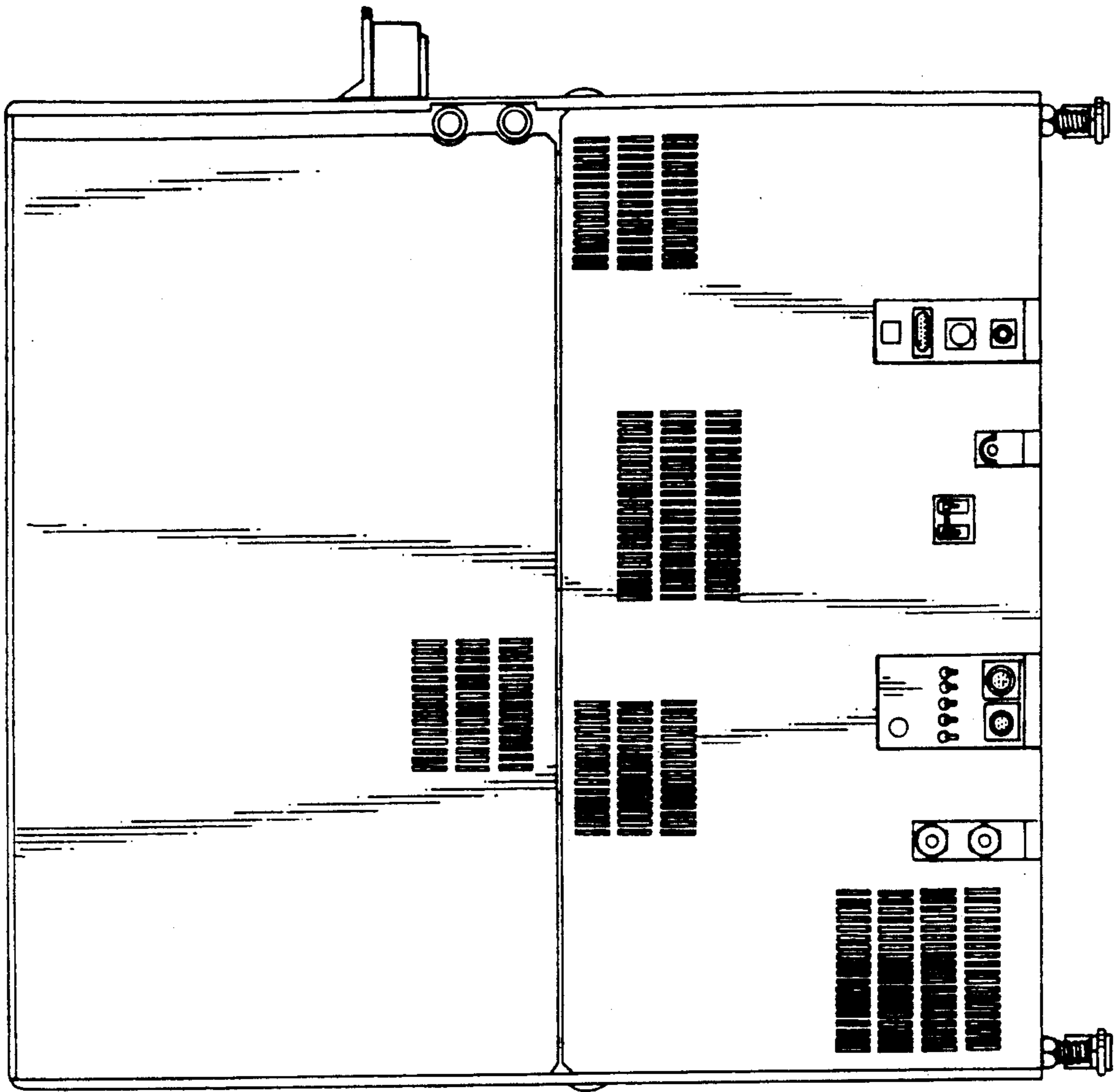

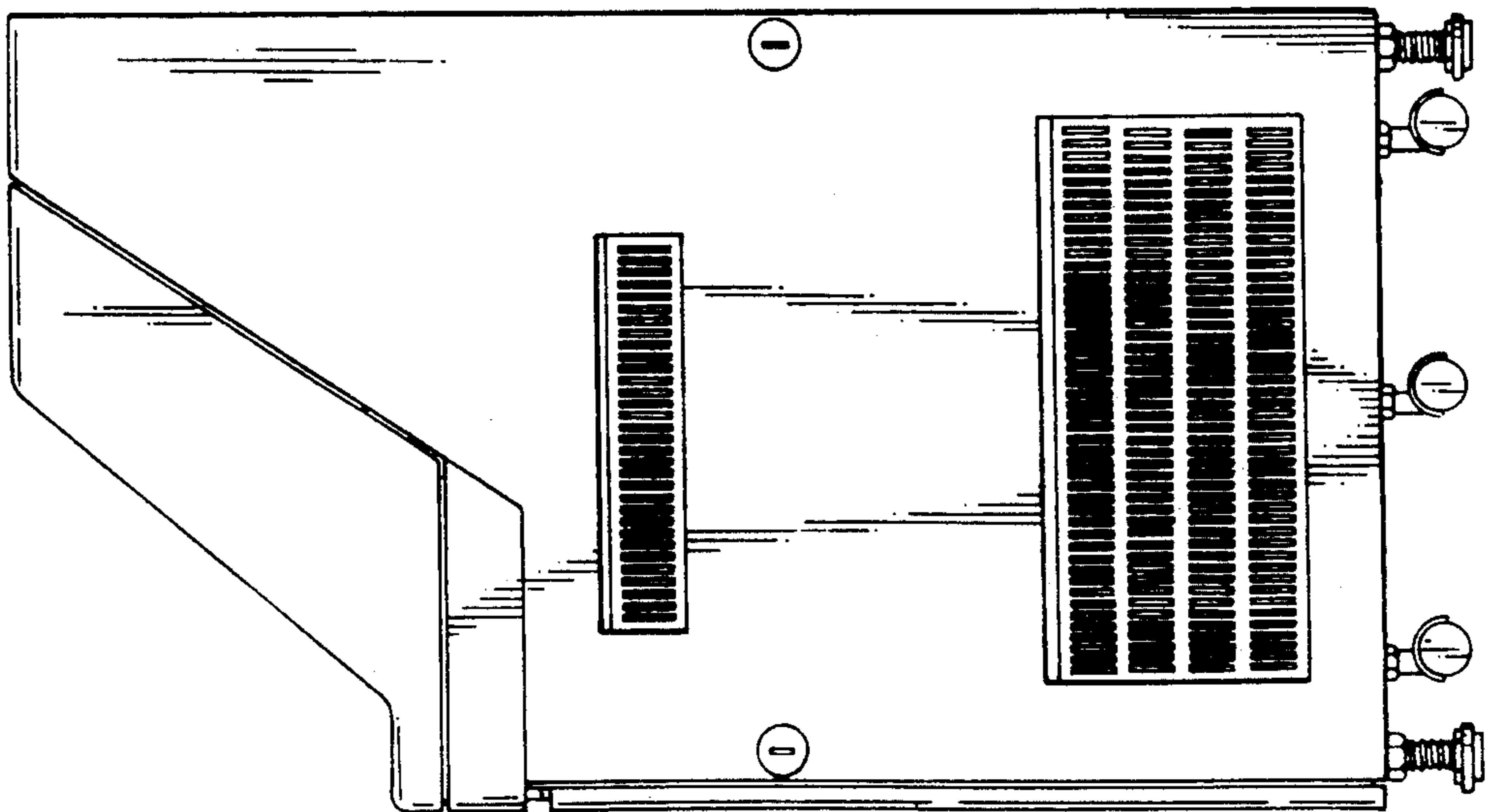

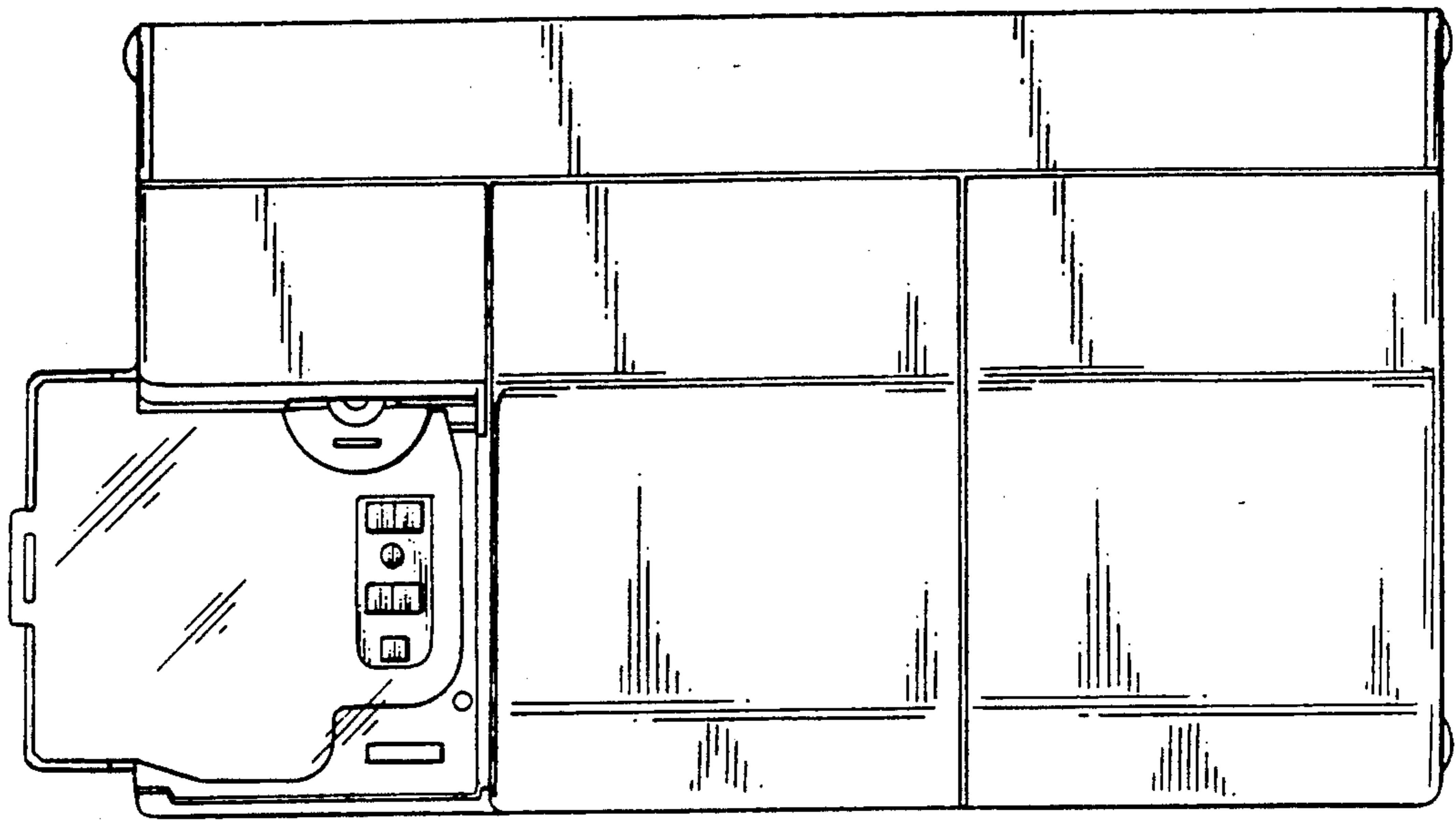
