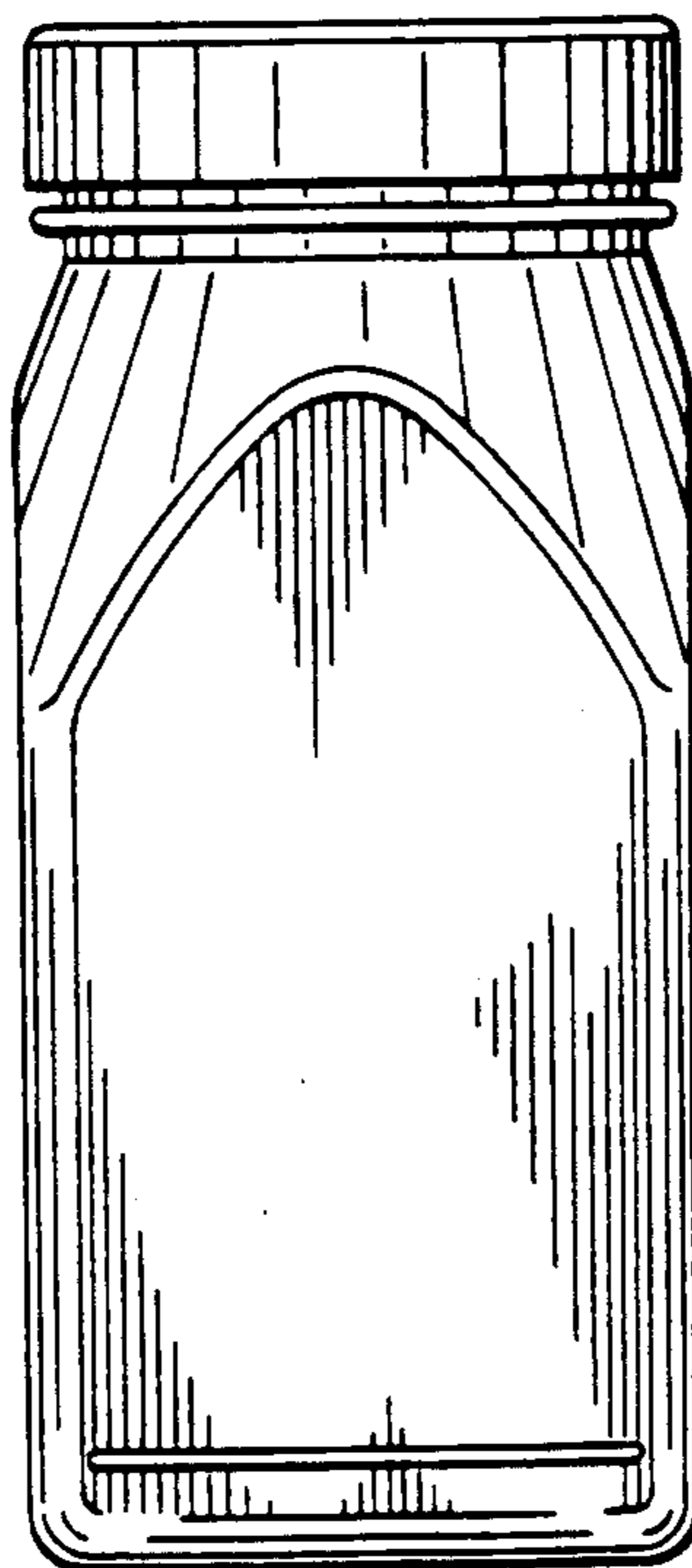

[57] CLAIM

The ornamental design for a bottle or similar article, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a bottle or similar article showing our new design; FIG. 2 is a top plan view thereof; FIG. 3 is a front elevational view thereof; and FIG. 4 is a bottom plan view thereof. The sides opposite those shown in the perspective view are the same in appearance as the respective sides shown.



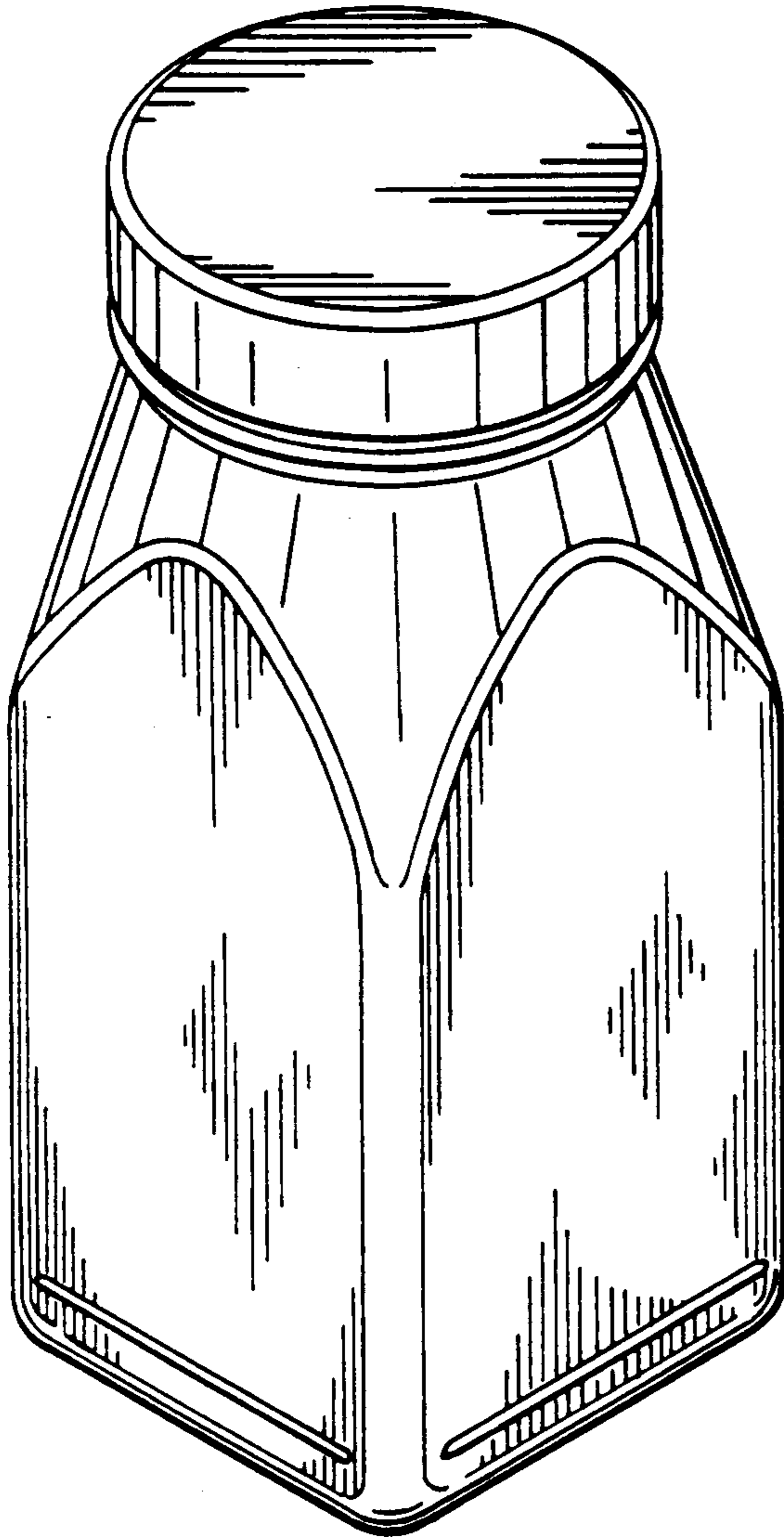

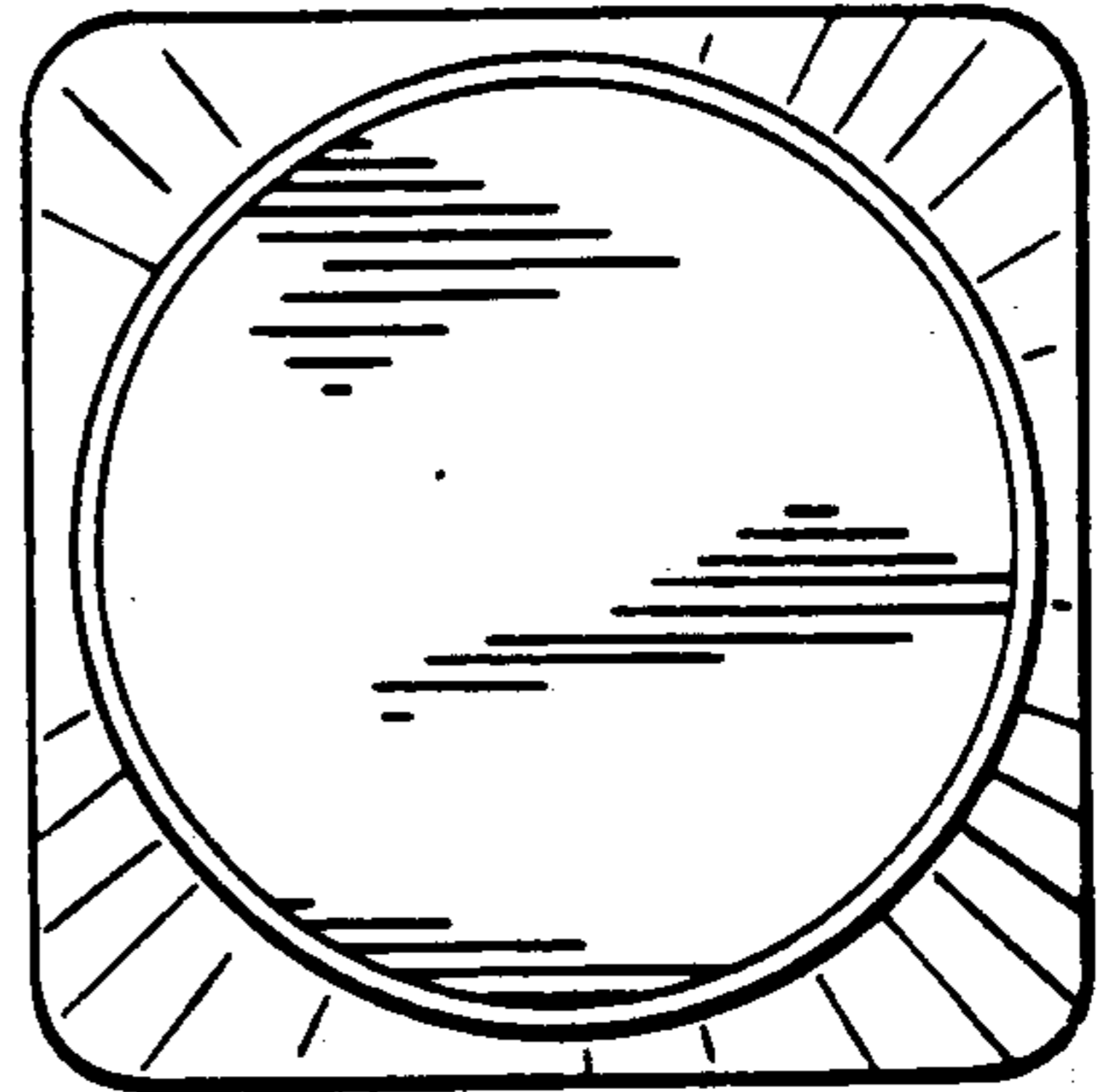

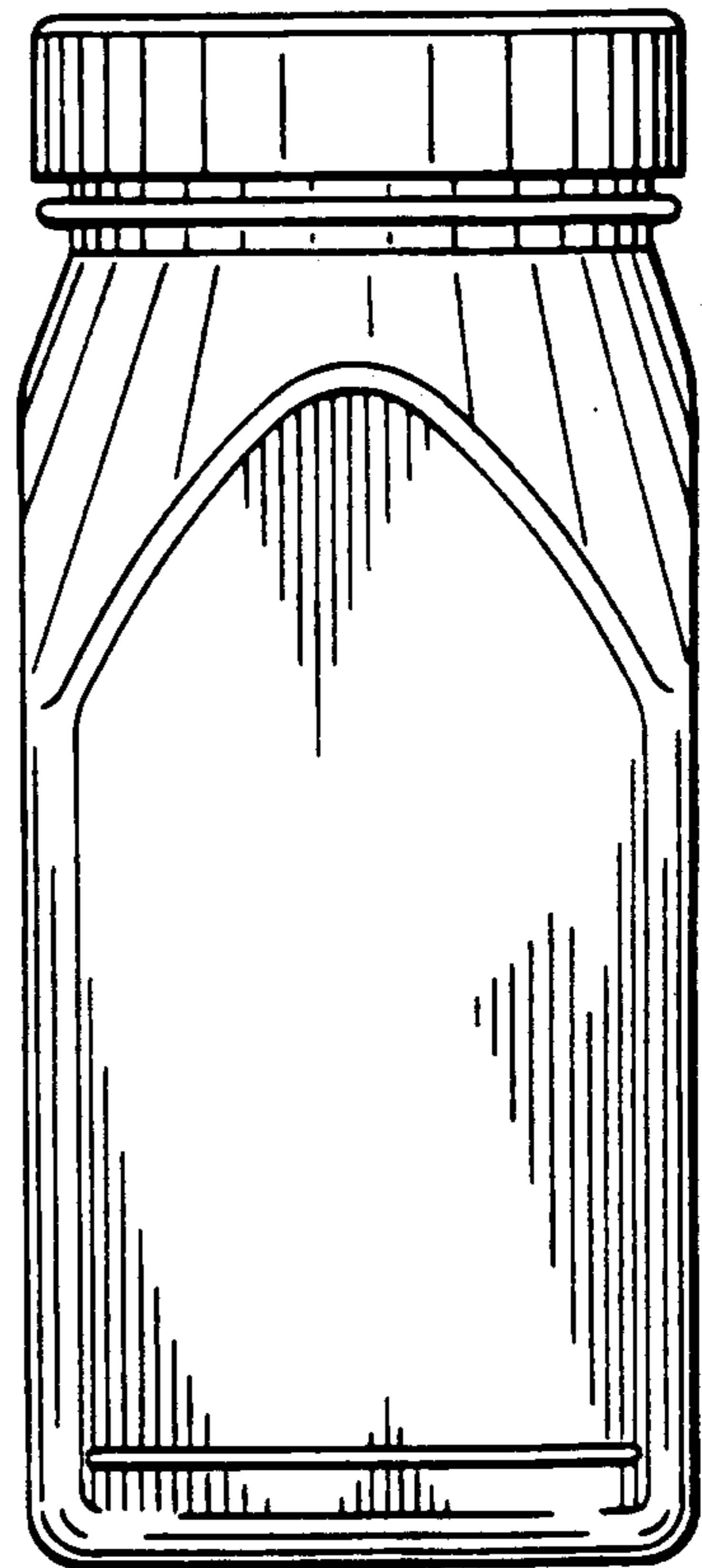

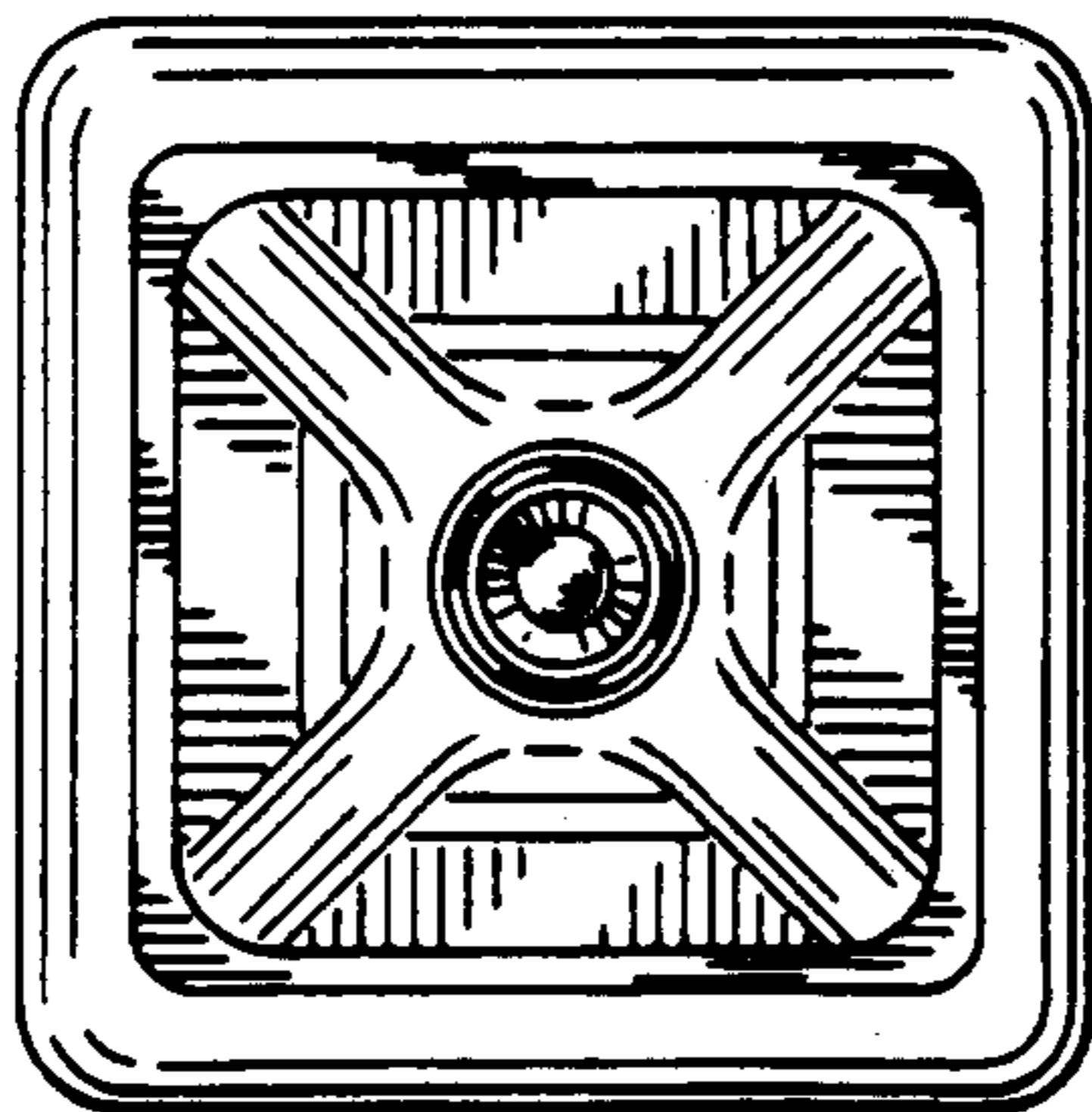
