[57] CLAIM

The ornamental design for a cartridge for game machine, as shown and described.

DESCRIPTION

FIG. 1 is a front, bottom and left side perspective view of a cartridge for a game machine showing my new design;

FIG. 2 is a rear, top and right side perspective view thereof;

FIG. 3 is a front elevational view thereof;

FIG. 4 is a rear elevational view thereof;

FIG. 5 is a top plan view thereof;

FIG. 6 is a bottom plan view thereof;

FIG. 7 is a right side elevational view thereof, the left side being a mirror image;

FIG. 8 is a front, bottom and left side perspective view

of a second embodiment of the cartridge illustrated in FIG. 1;

FIG. 9 is a rear, top and right side perspective view of the embodiment disclosed in FIG. 8;

FIG. 10 is a front elevational view of the embodiment disclosed in FIG. 8;

FIG. 11 is a rear elevational view of the embodiment disclosed in FIG. 8, a top plan view, a bottom plan view, and right side elevational view being respectively the same as FIGS. 5, 6 and 7 and the left side being a mirror image of the right side view;

FIG. 12 is a front, bottom and left side perspective view of a third embodiment of the cartridge illustrated in FIG. 1;

FIG. 13 is a rear, top and right side perspective view of the embodiment disclosed in FIG. 12;

FIG. 14 is a front elevational view of the embodiment disclosed in FIG. 12;

FIG. 15 is a rear elevational view of the embodiment disclosed in FIG. 12;

FIG. 16 is a top plan view of the embodiment disclosed in FIG. 12;

FIG. 17 is a bottom plan view of the embodiment disclosed in FIG. 12, a right side view being the same as FIG. 7 and the left side being a mirror image of the right side view;

FIG. 18 is a front, bottom and left side perspective view of a fourth embodiment of the cartridge illustrated in FIG. 1;

FIG. 19 is a rear, top and right side perspective view of the embodiment disclosed in FIG. 18;

FIG. 20 is a front elevational view of the embodiment disclosed in FIG. 18;

FIG. 21 is a rear elevational view of the embodiment disclosed in FIG. 18;

FIG. 22 is a right side elevational view of the embodiment disclosed in FIG. 18, the left side being a mirror image thereof and a top plan view and a bottom plan view being respectively the same as FIGS. 5 and 6;

FIG. 23 is a front elevational view showing a fifth embodiment of the cartridge illustrated in FIG. 1;

FIG. 24 is a rear elevational view thereof;

FIG. 25 is a top plan view thereof;

FIG. 26 is a bottom plan view thereof; and

FIG. 27 is a right side elevational view thereof, the left side being a mirror image.

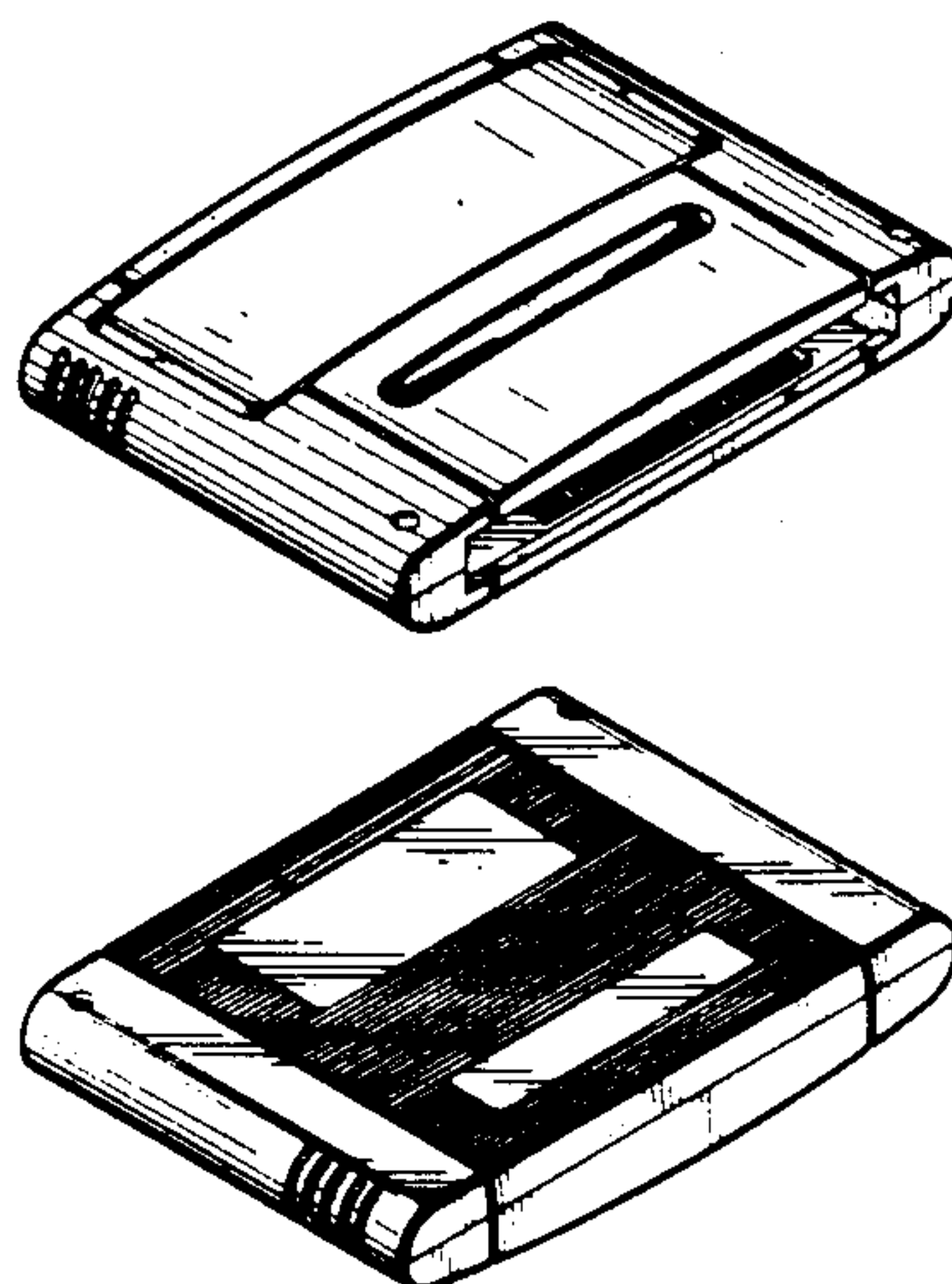

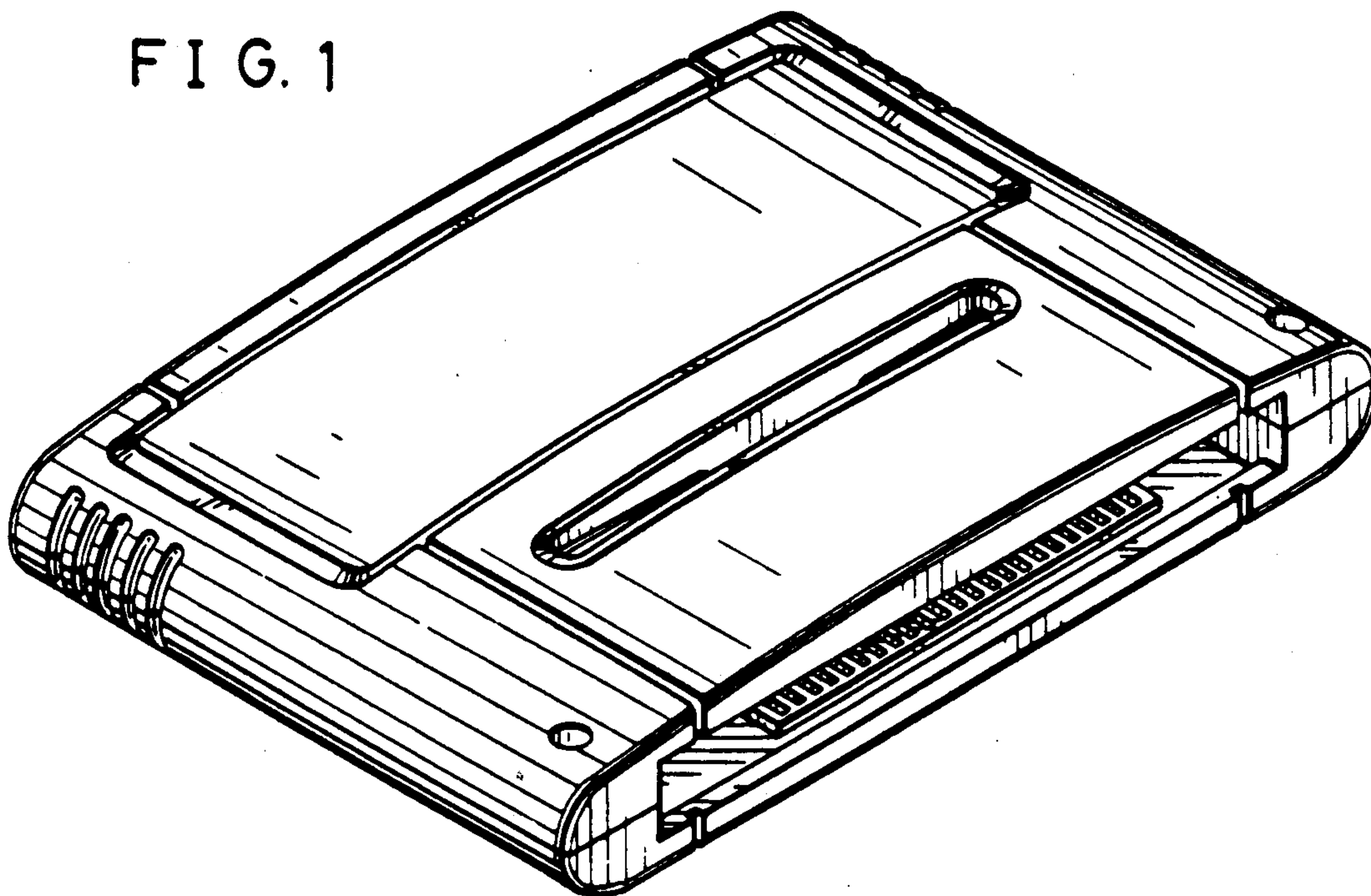

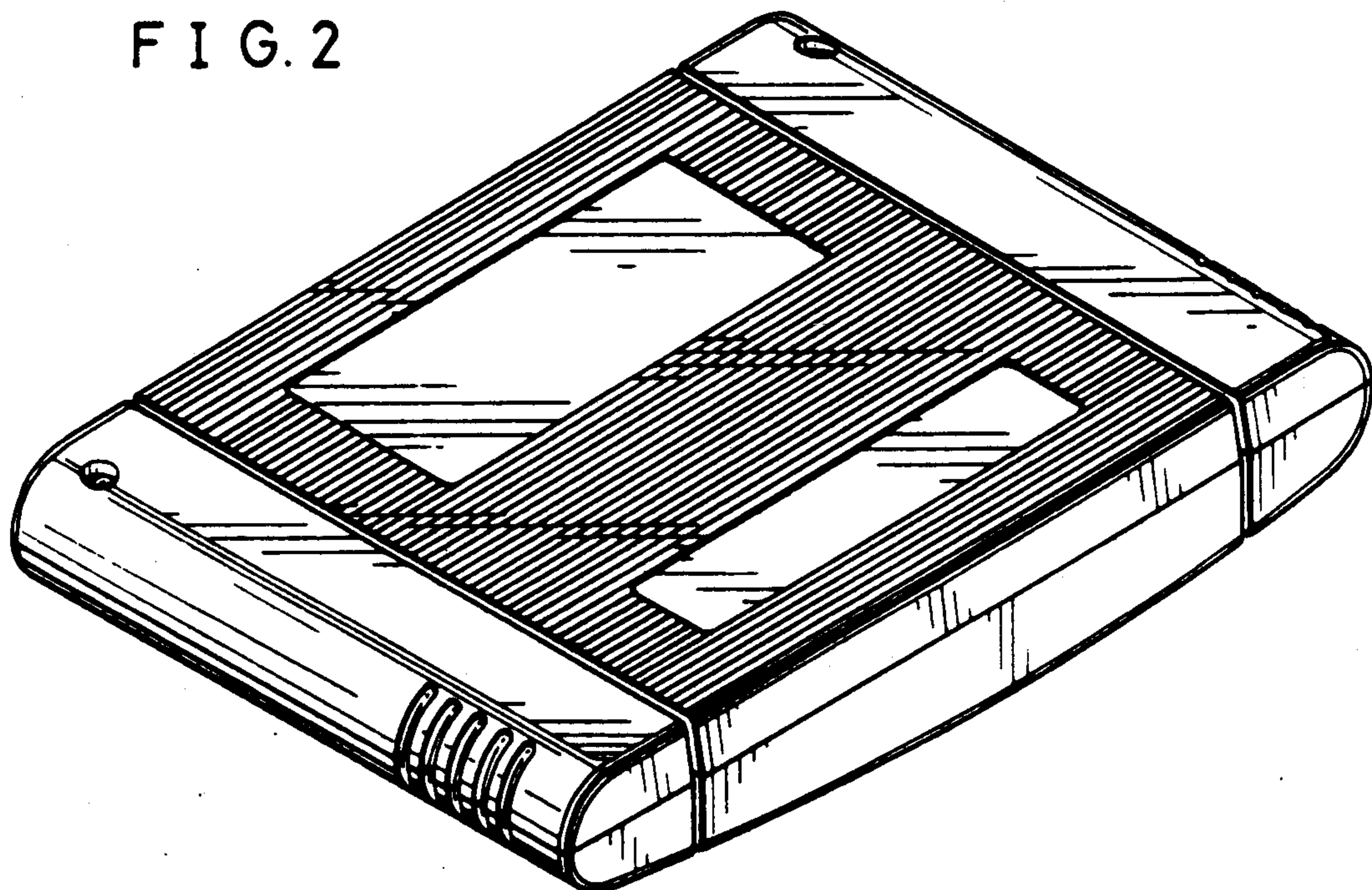

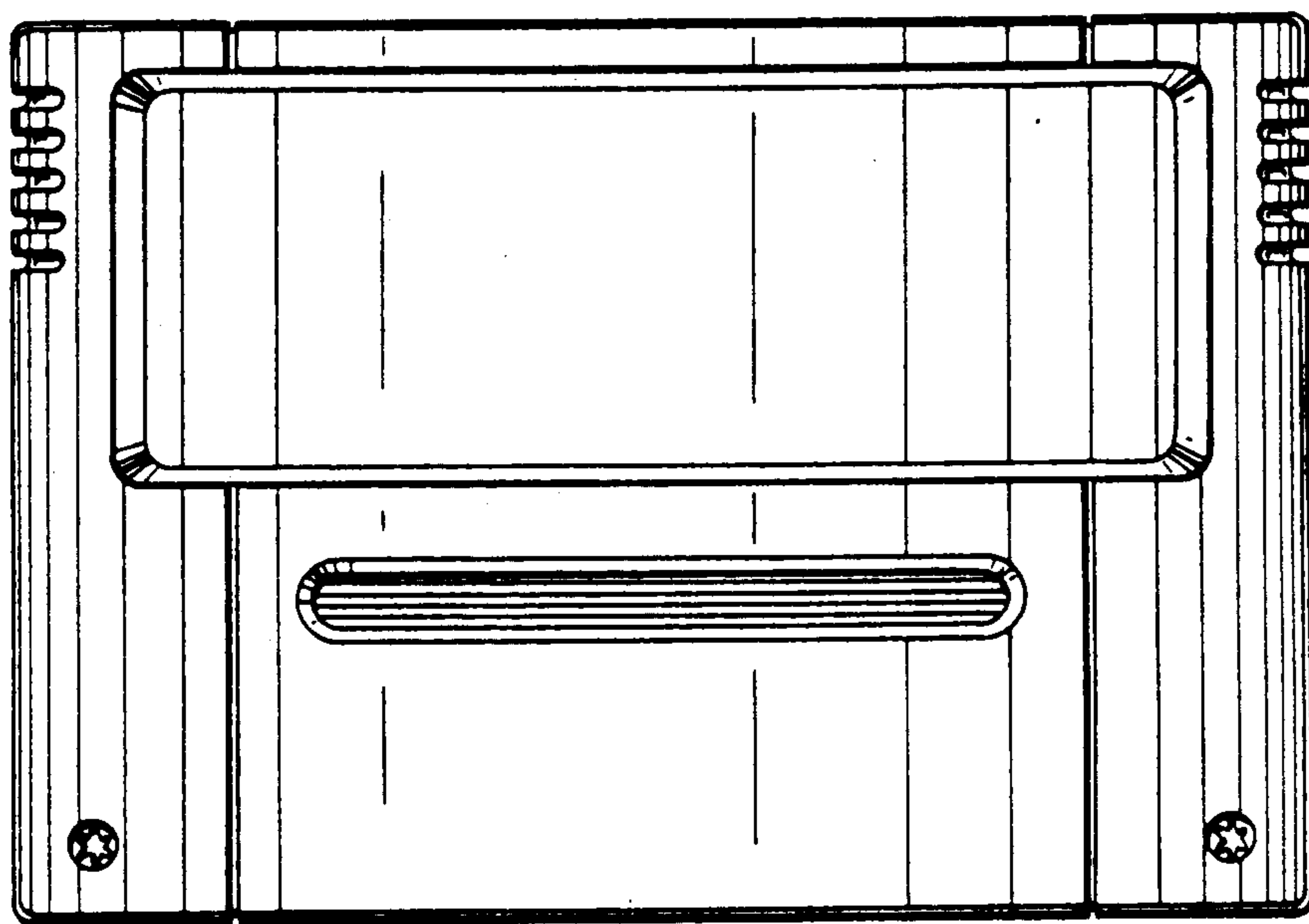

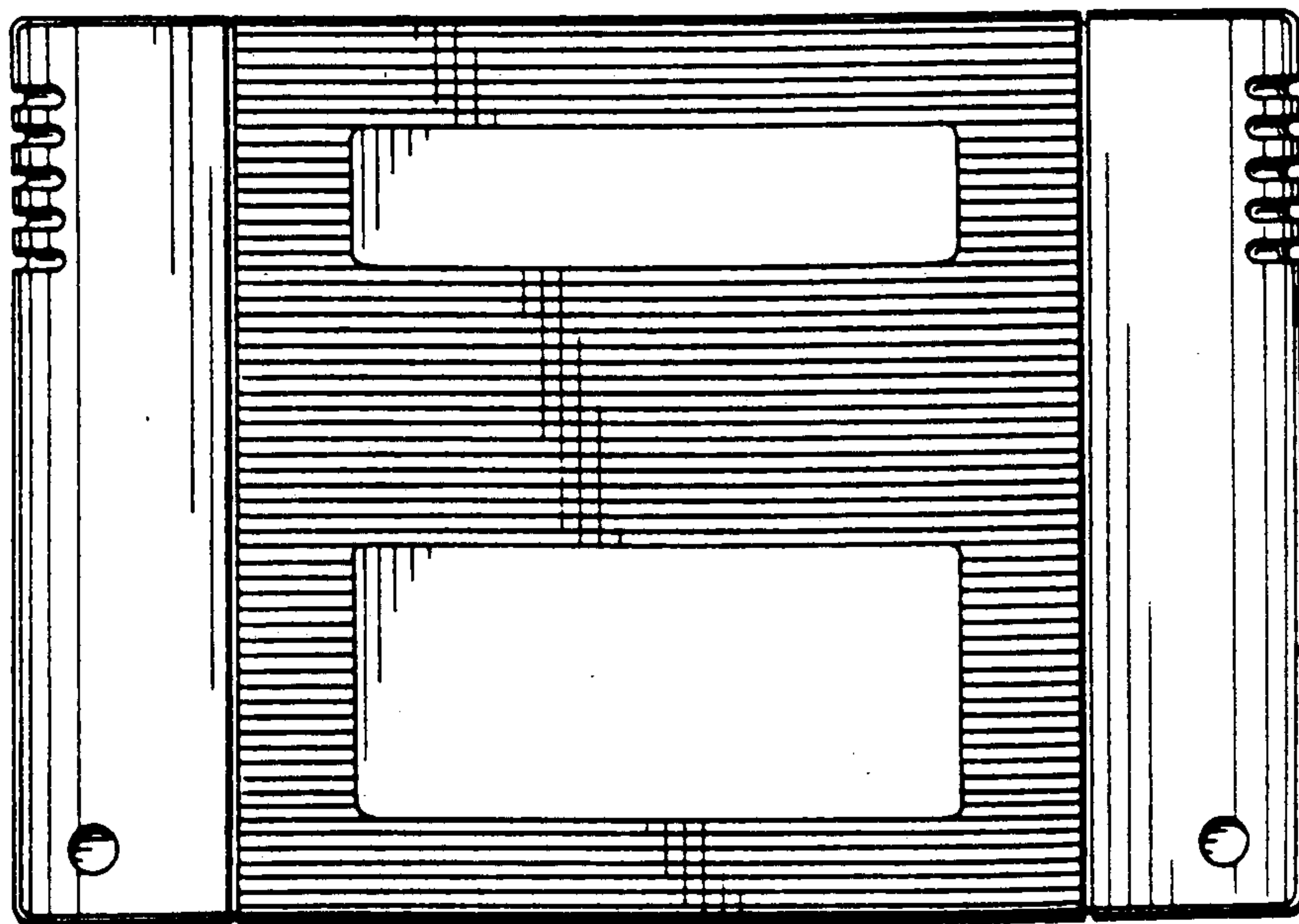

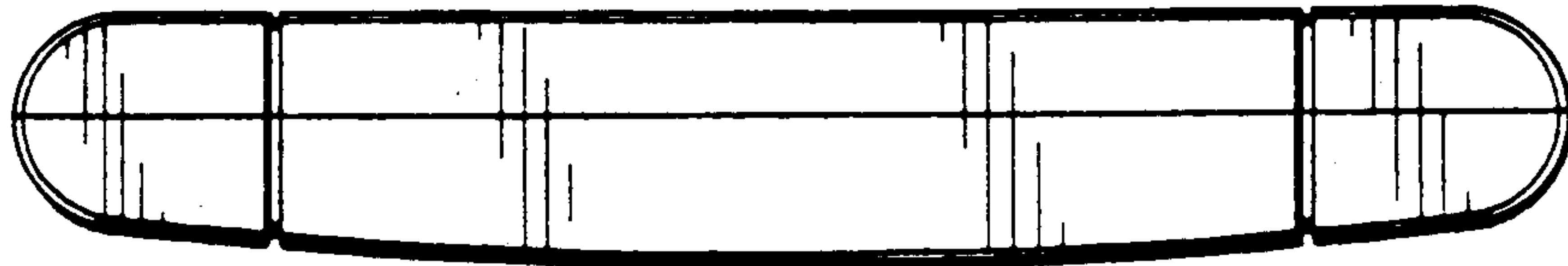

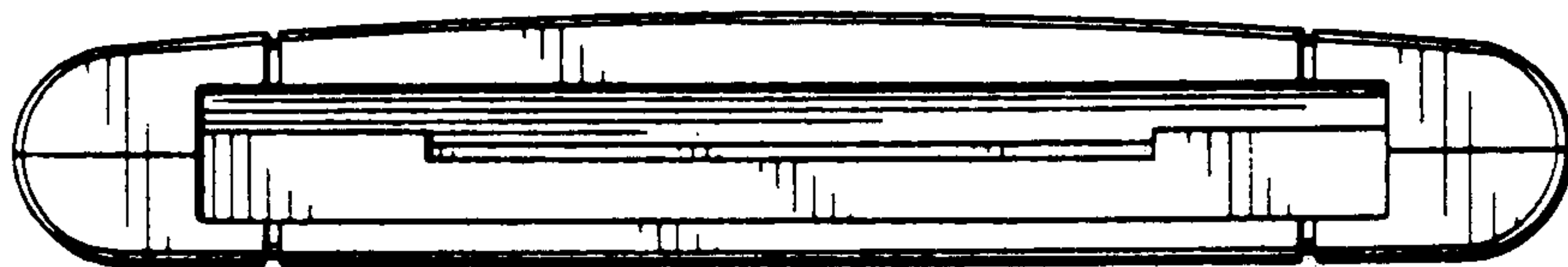

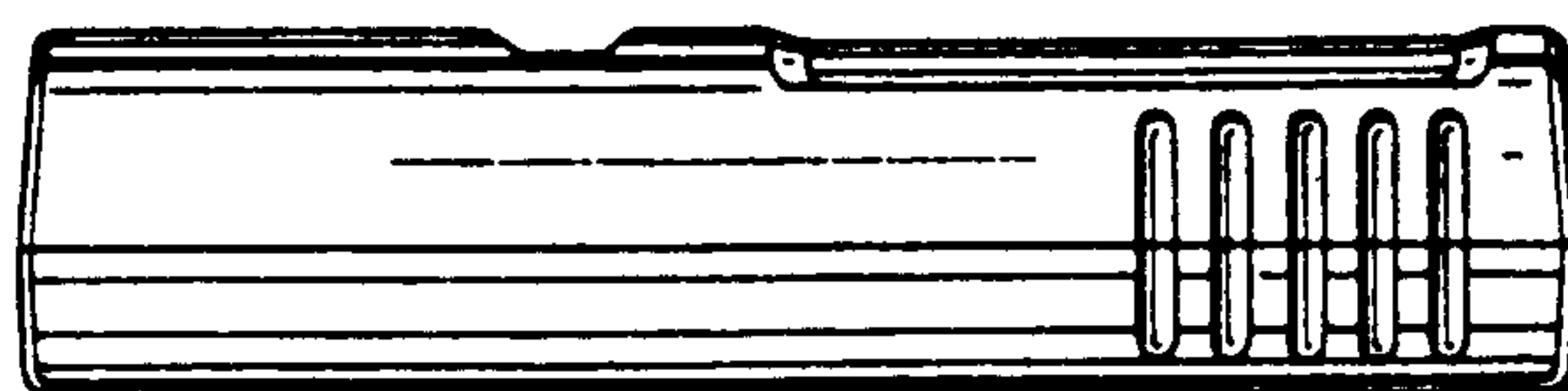

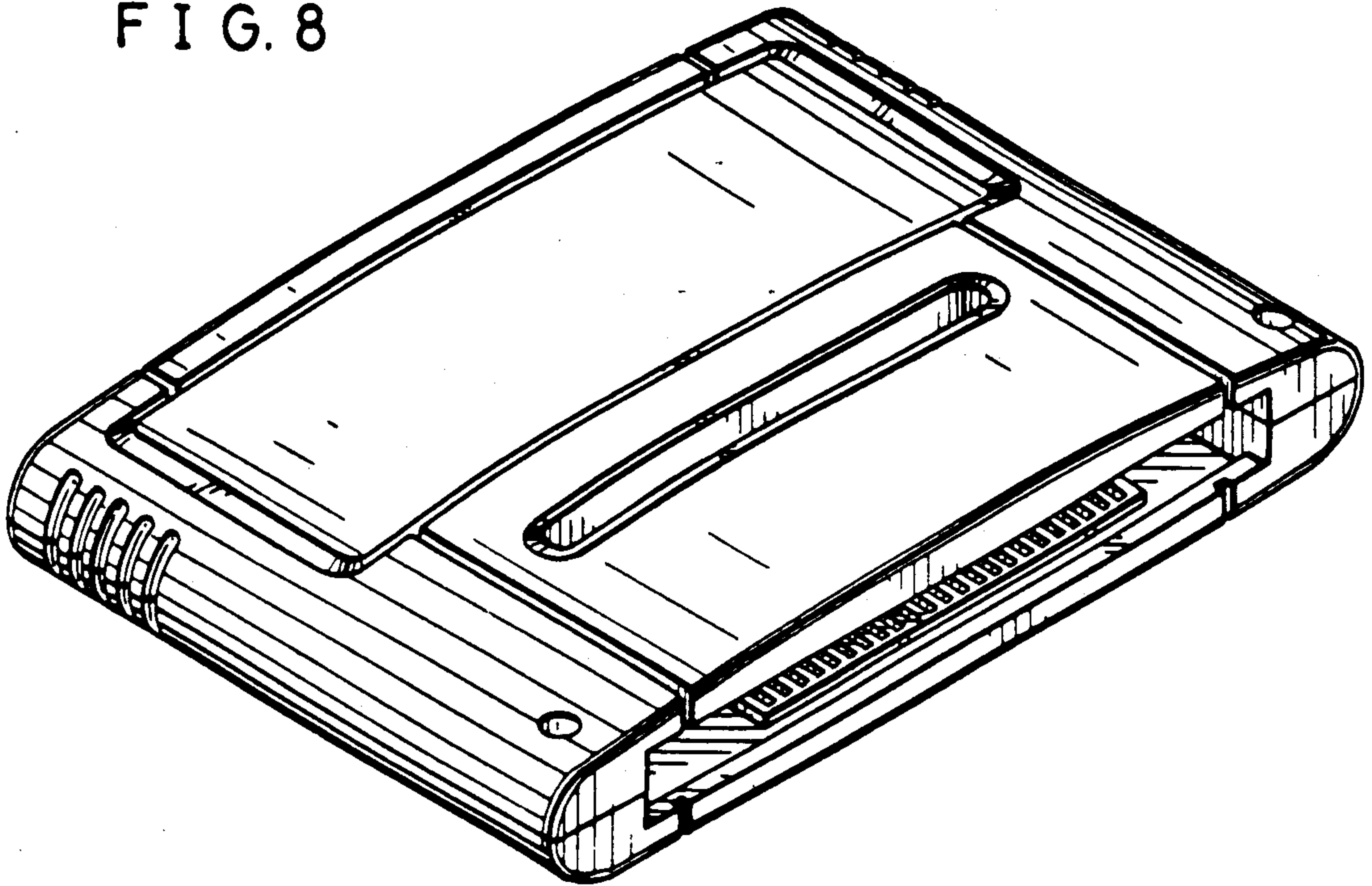

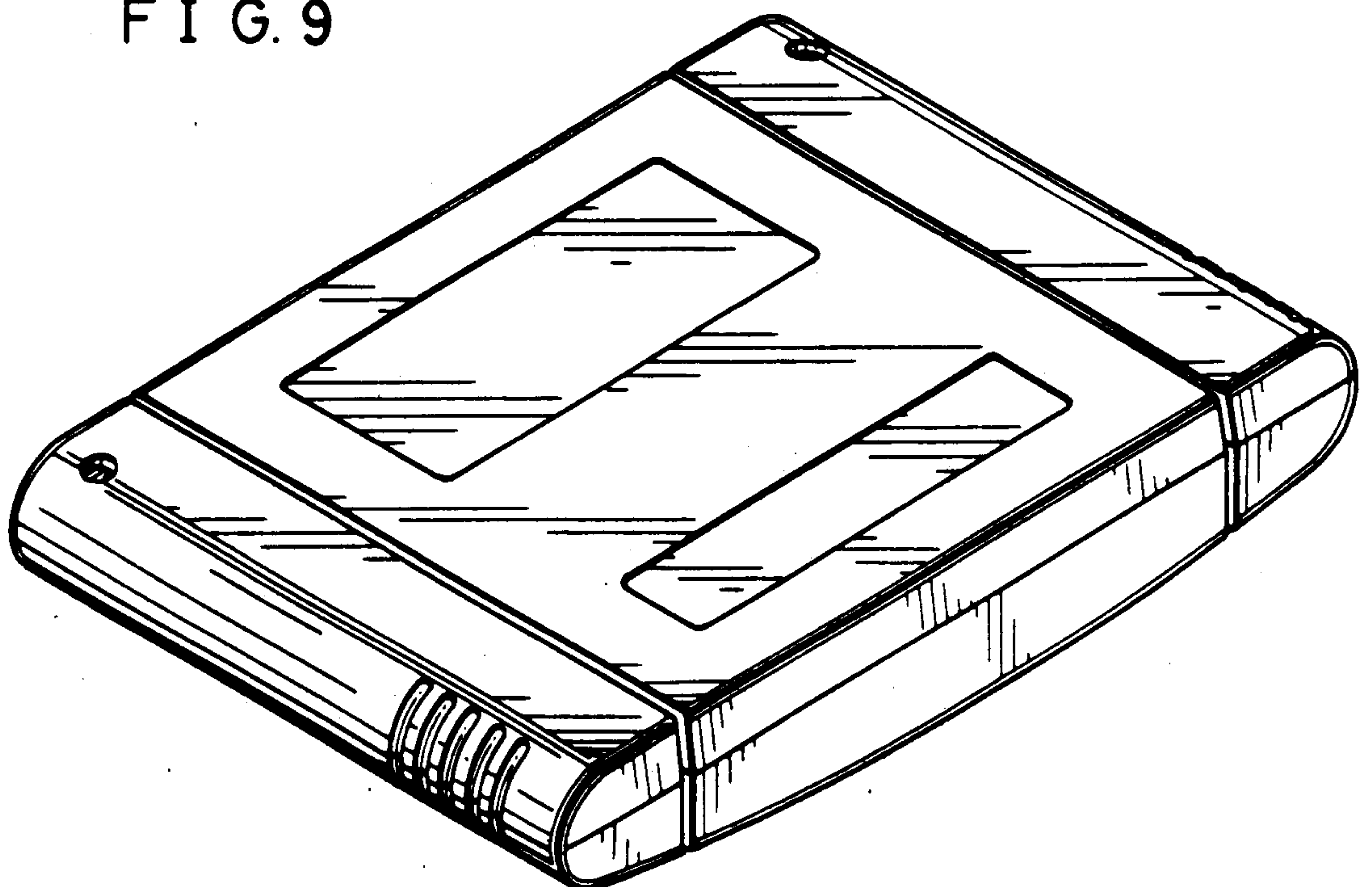

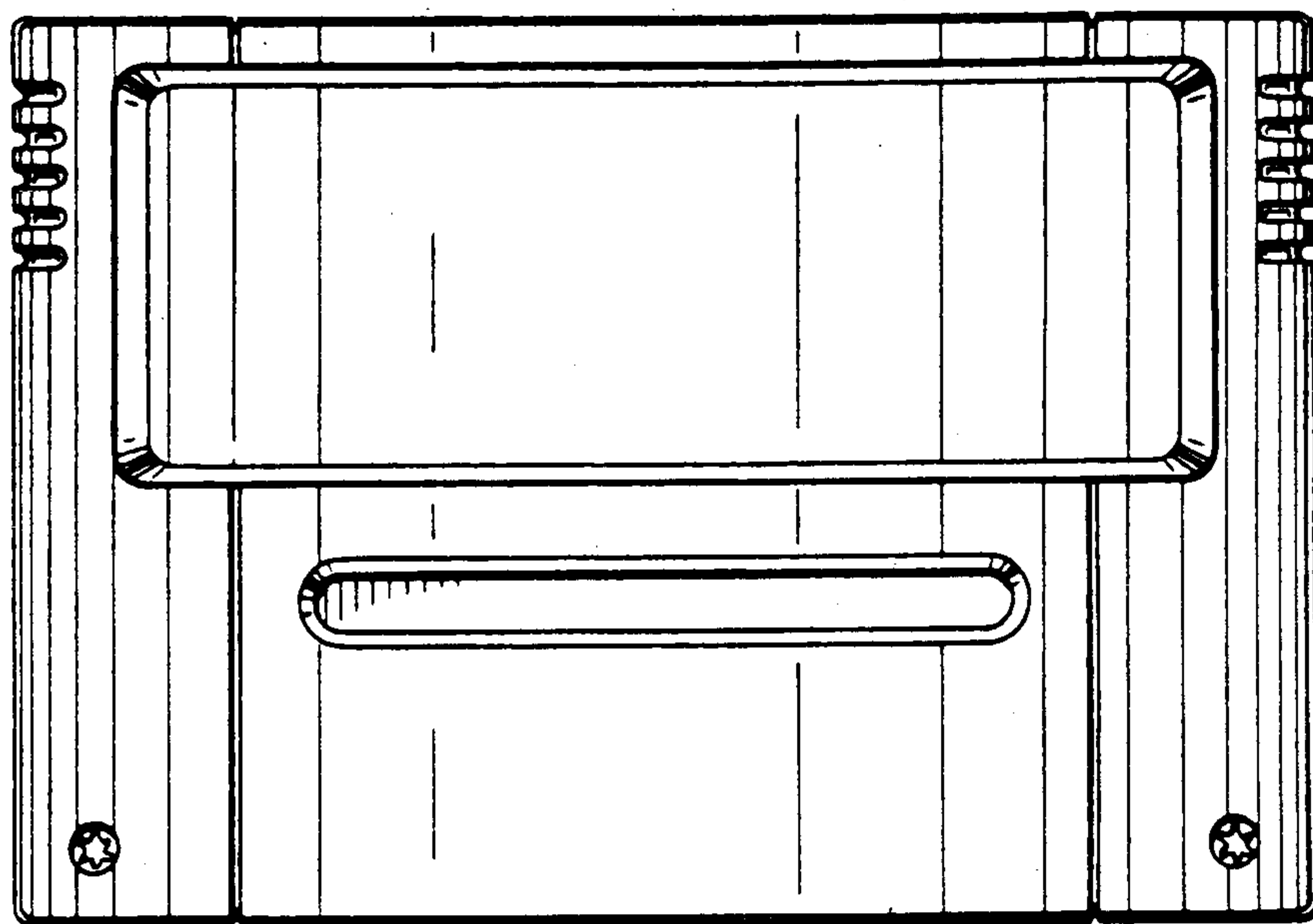

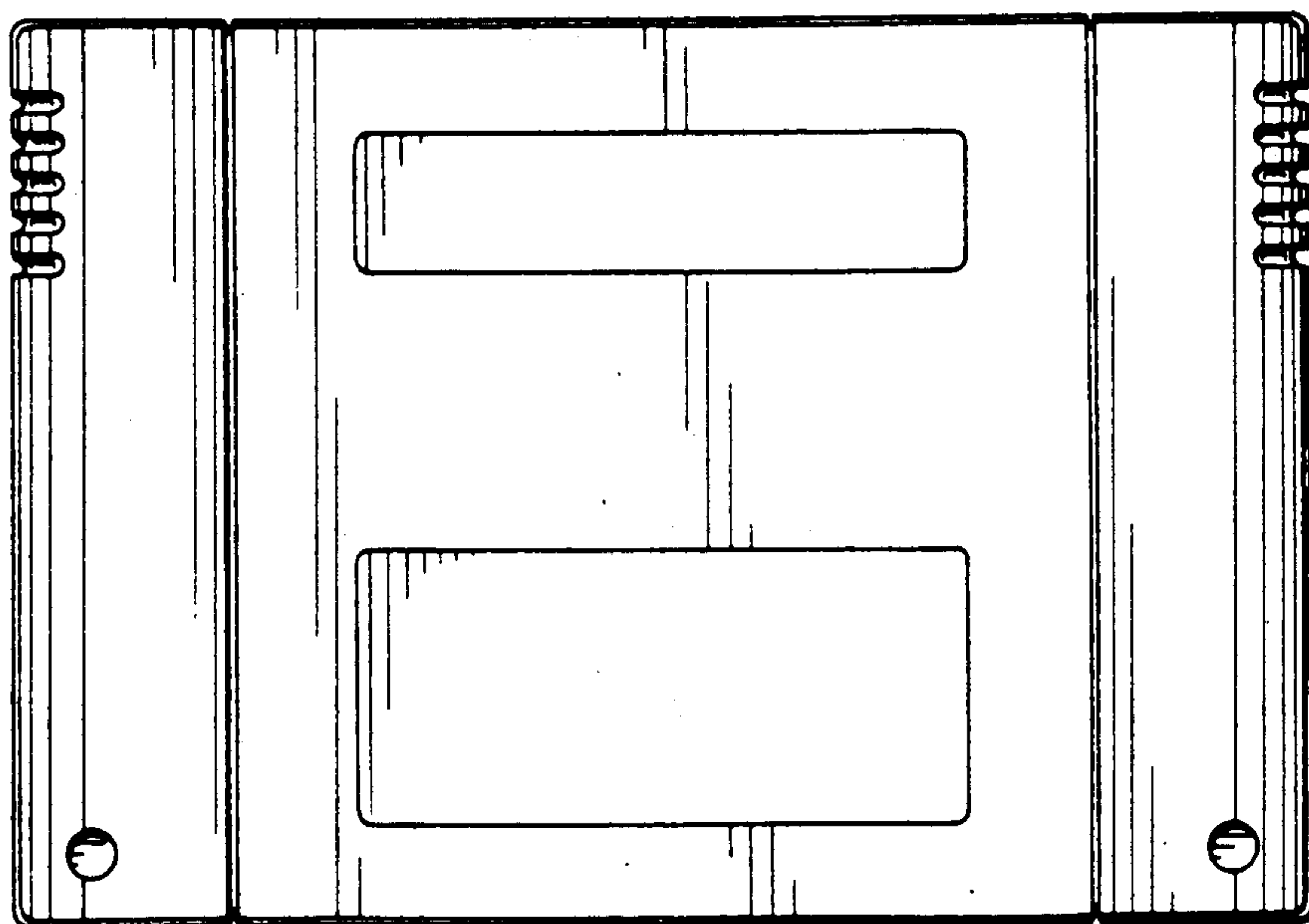

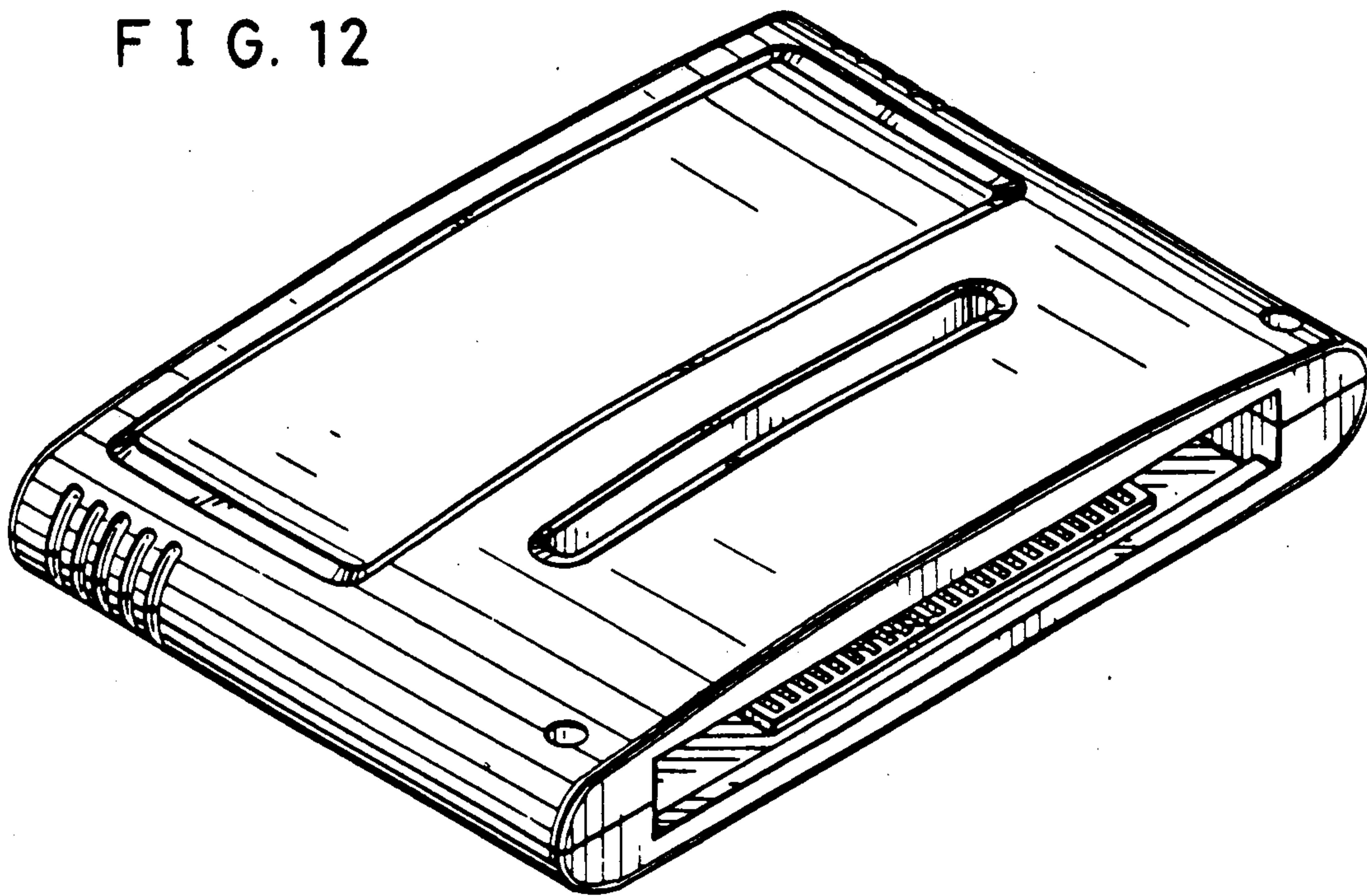

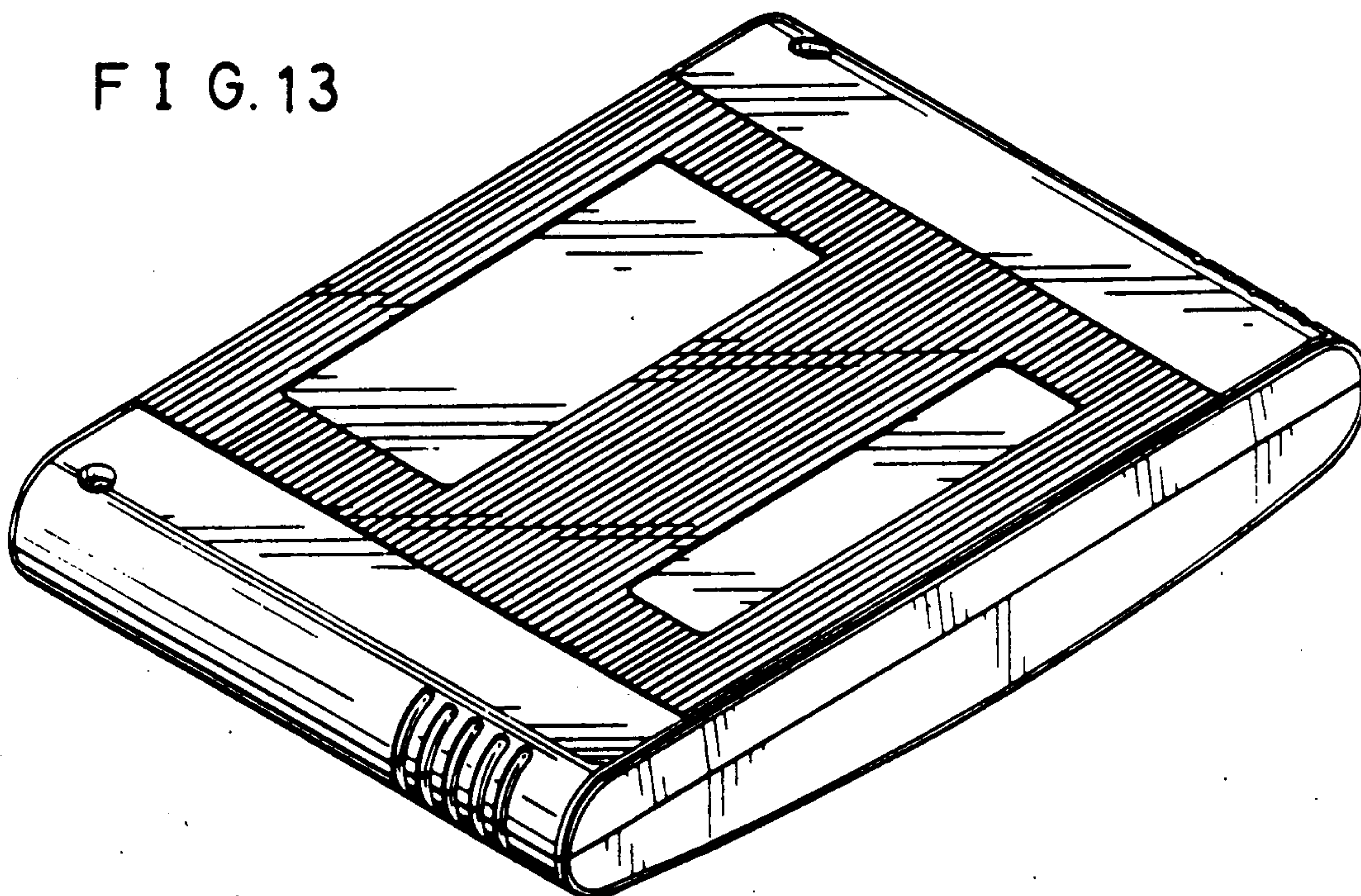

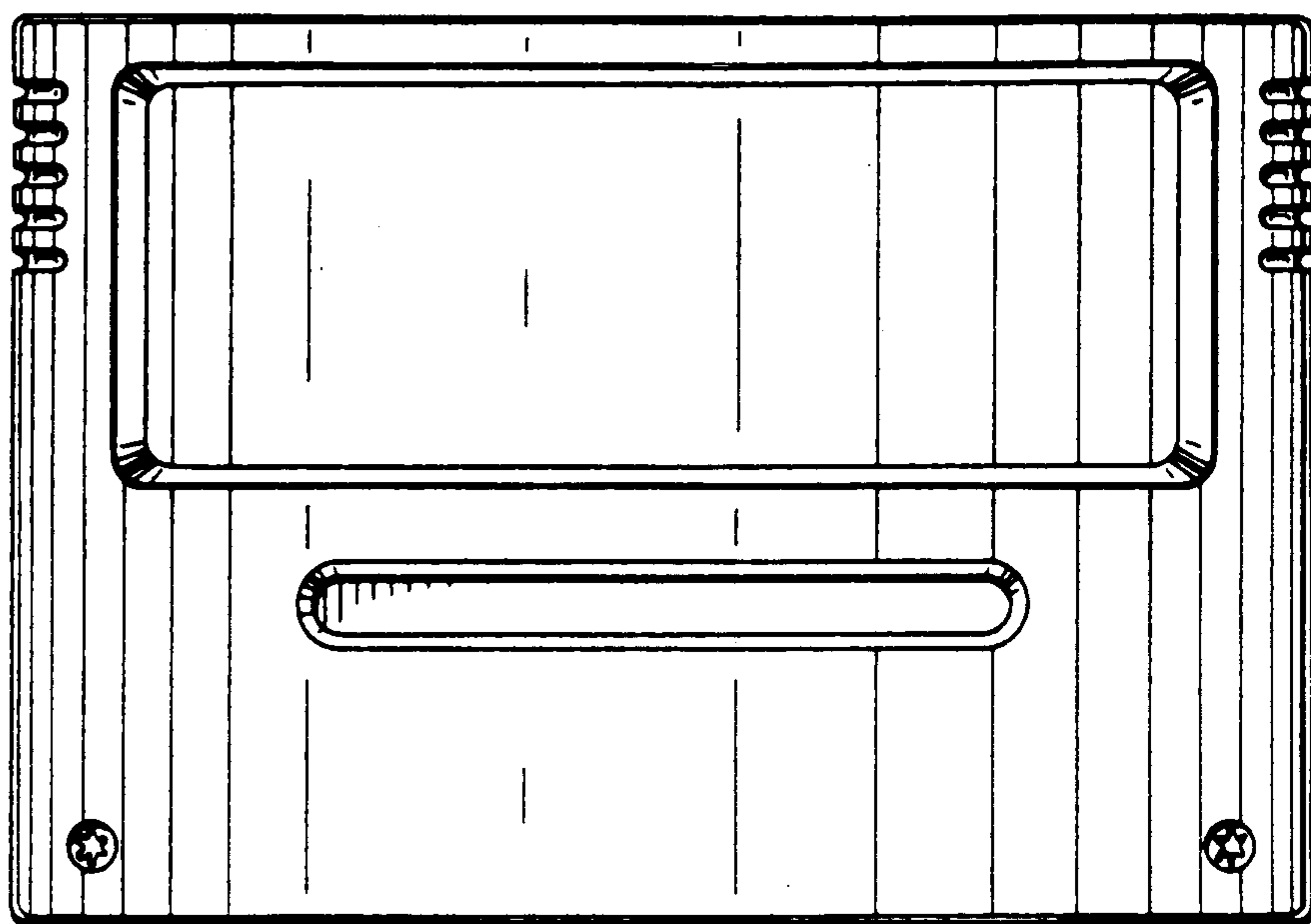

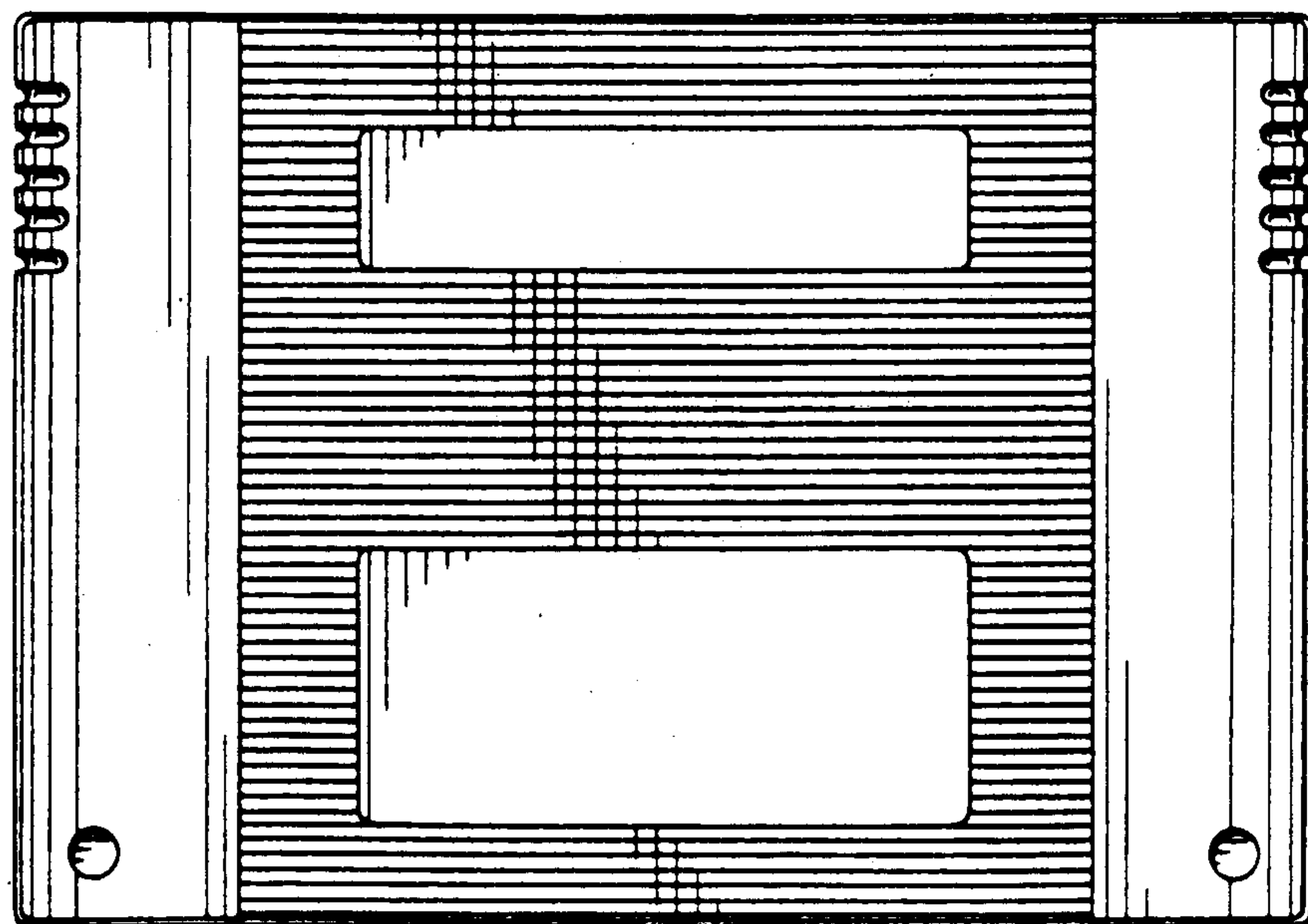

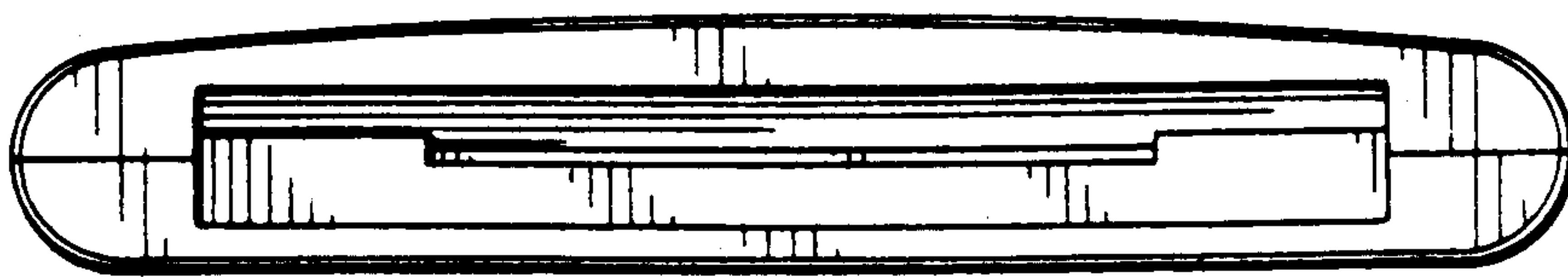

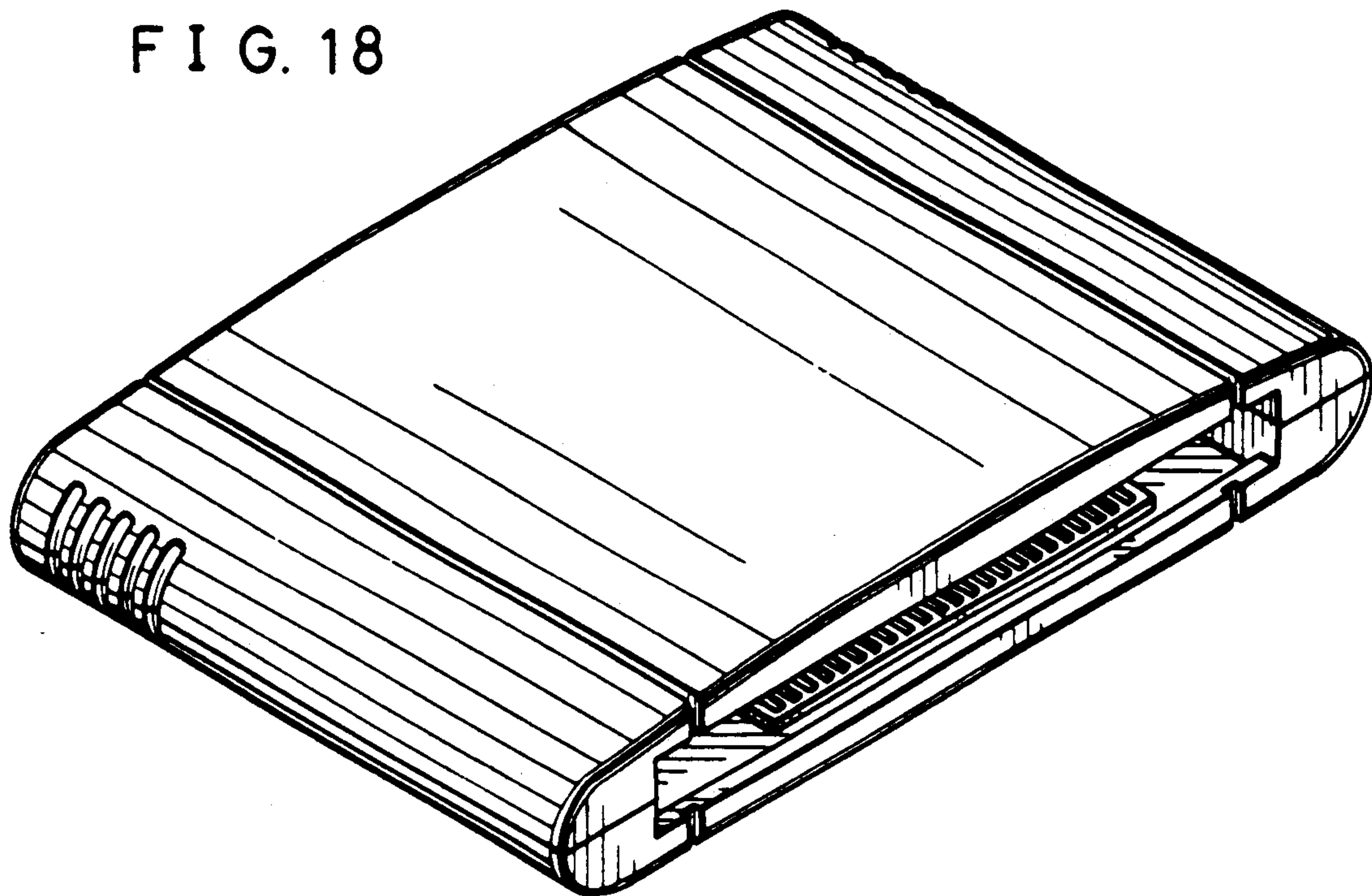

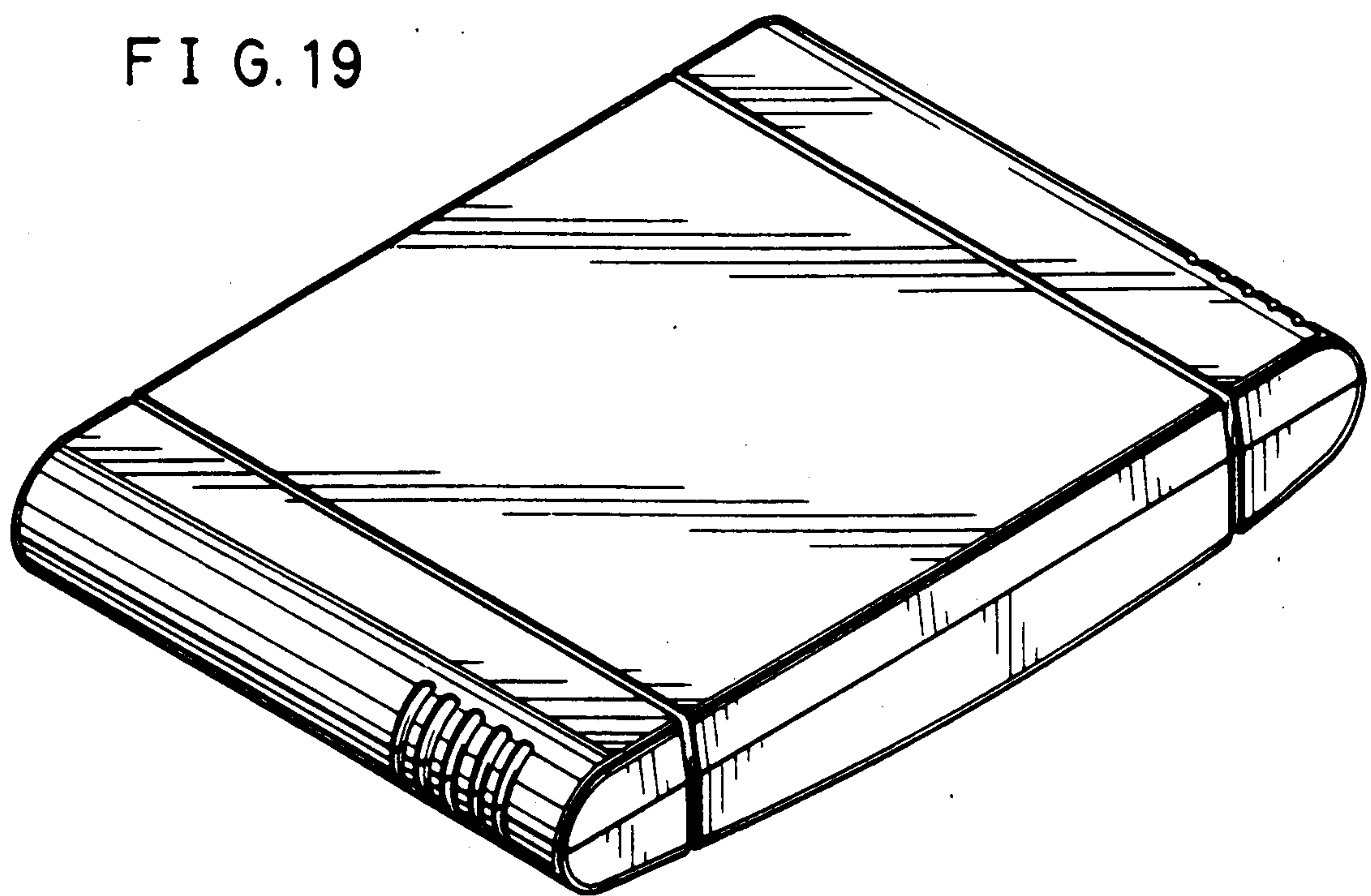

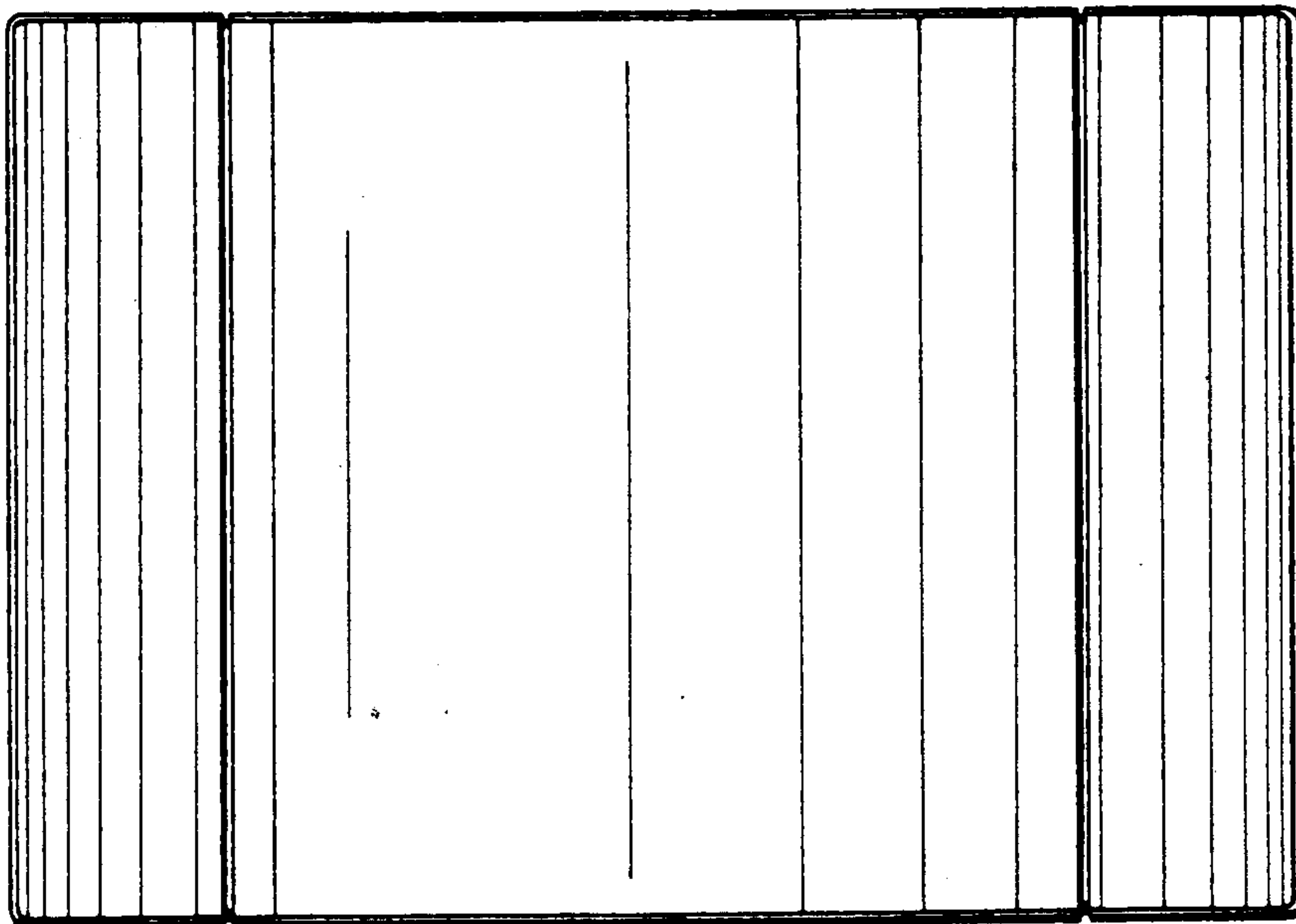

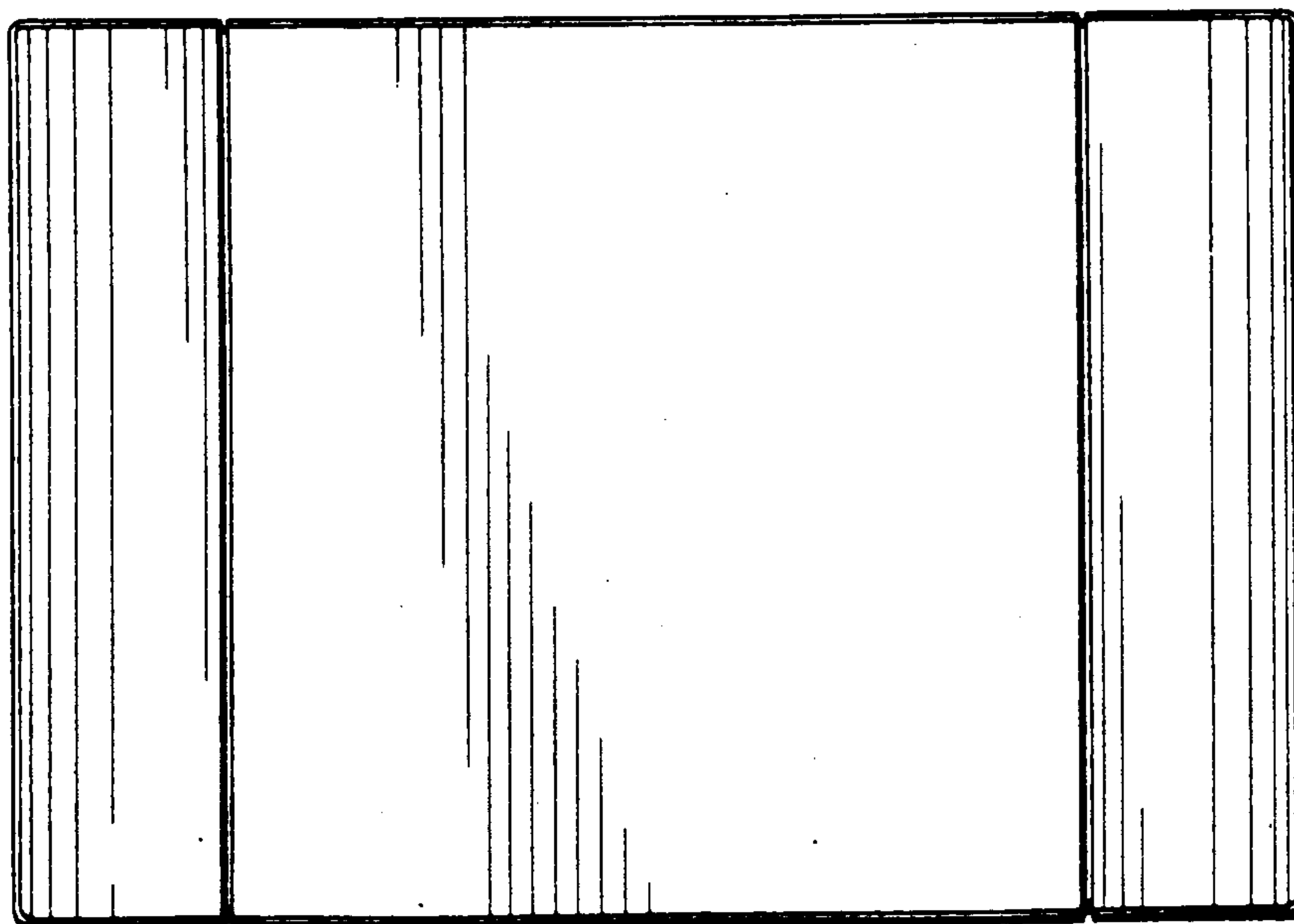

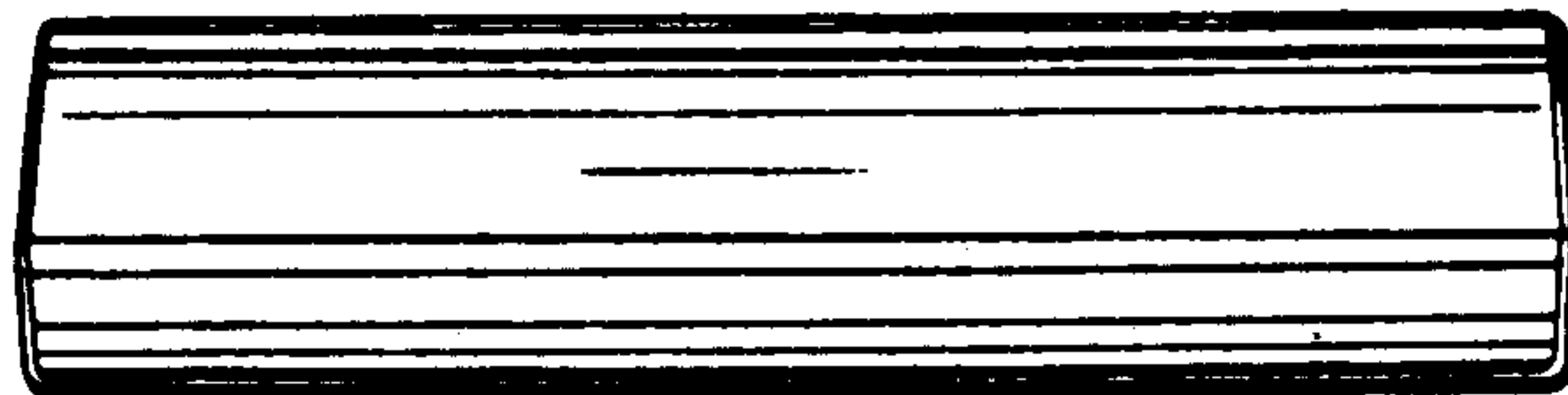

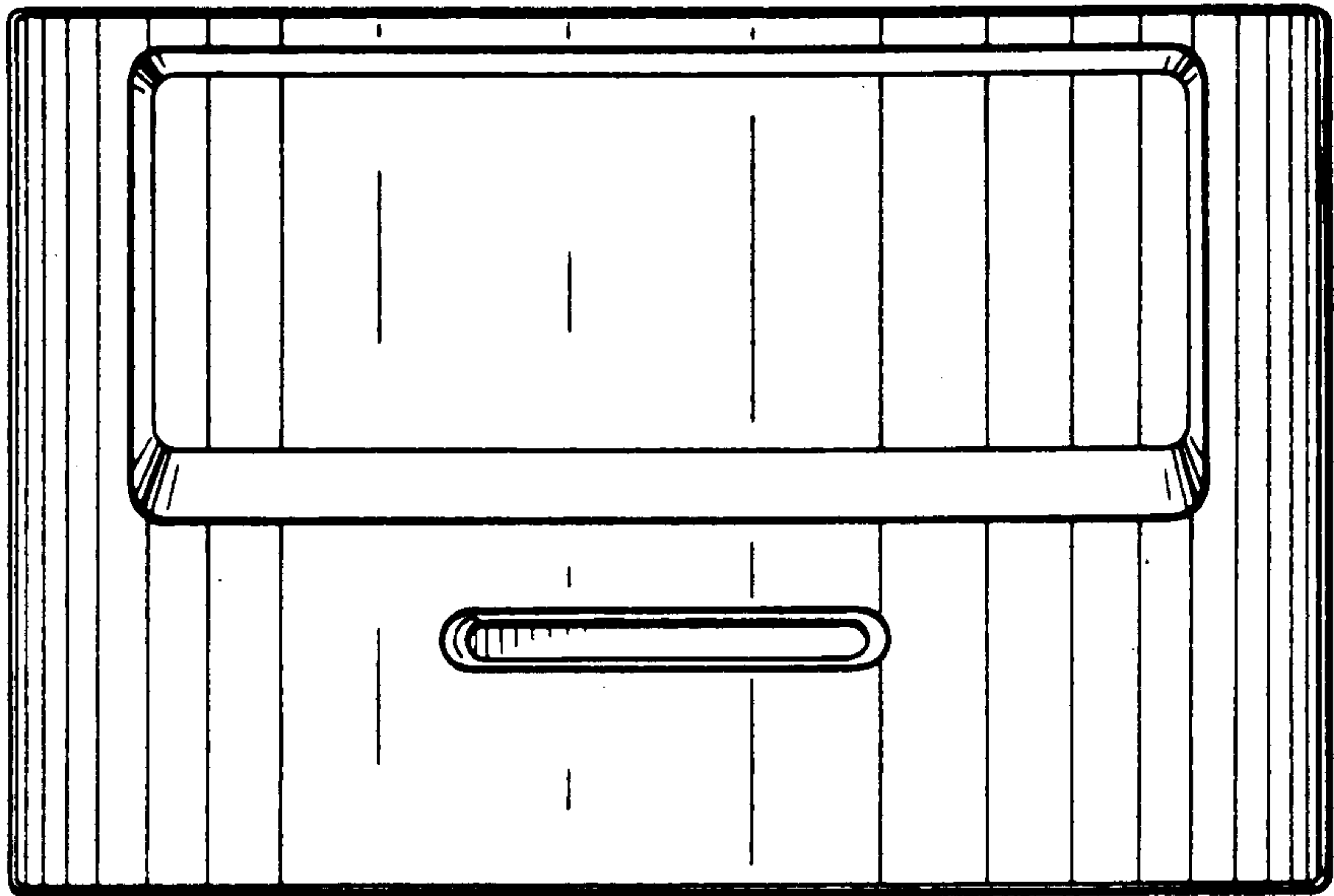

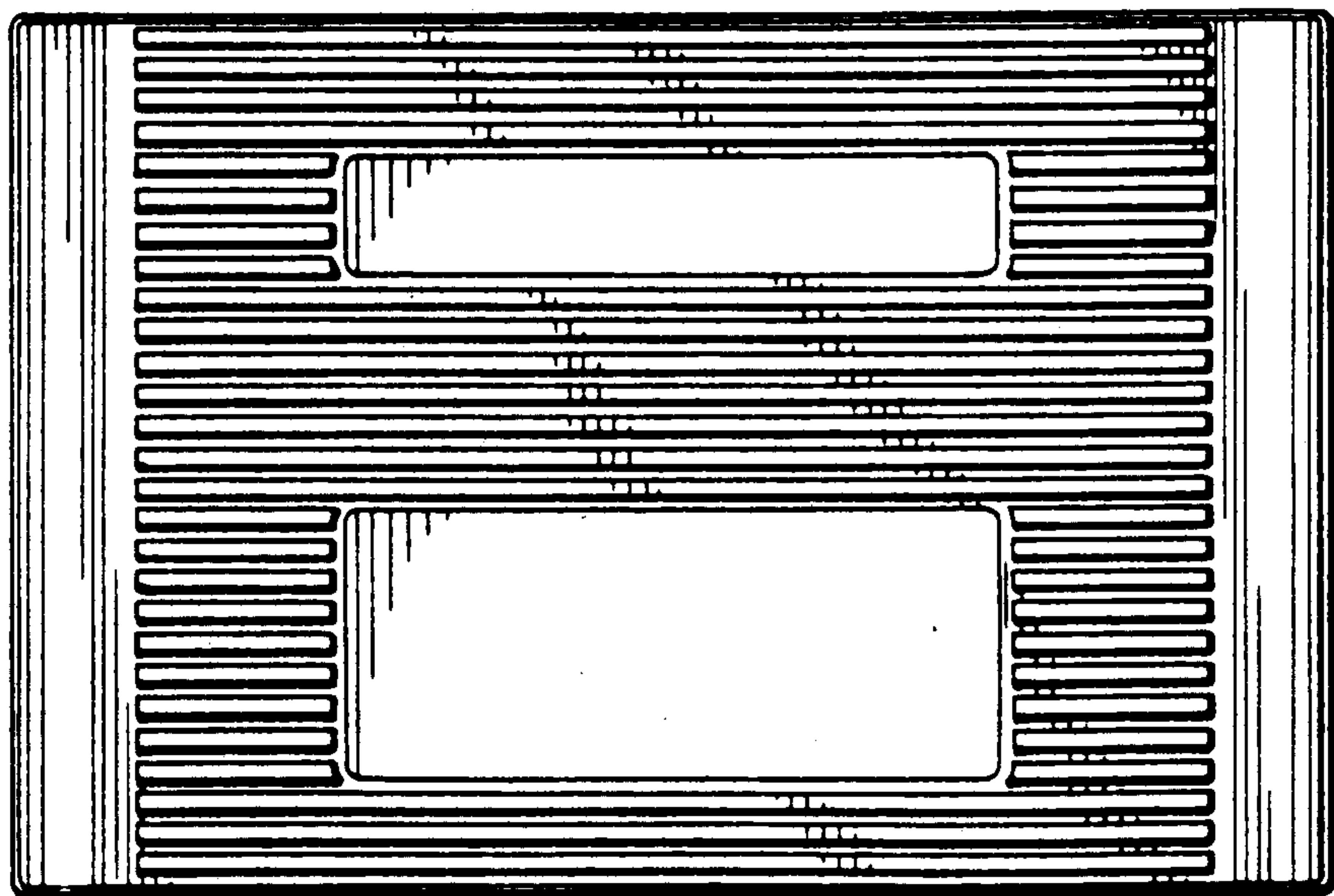

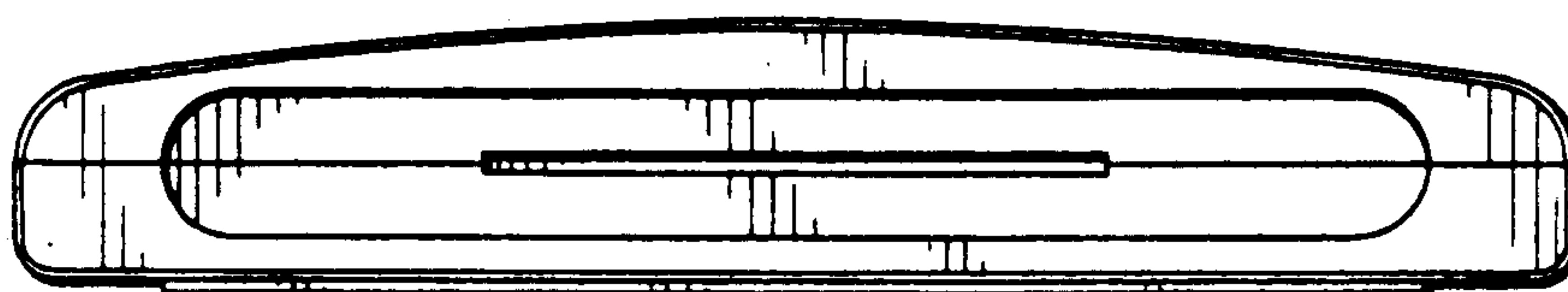
