**DESCRIPTION**

FIG. 1 is a top plan view of an electronic musical keyboard showing my new design;

FIG. 14 is a top, front, right perspective view thereof.

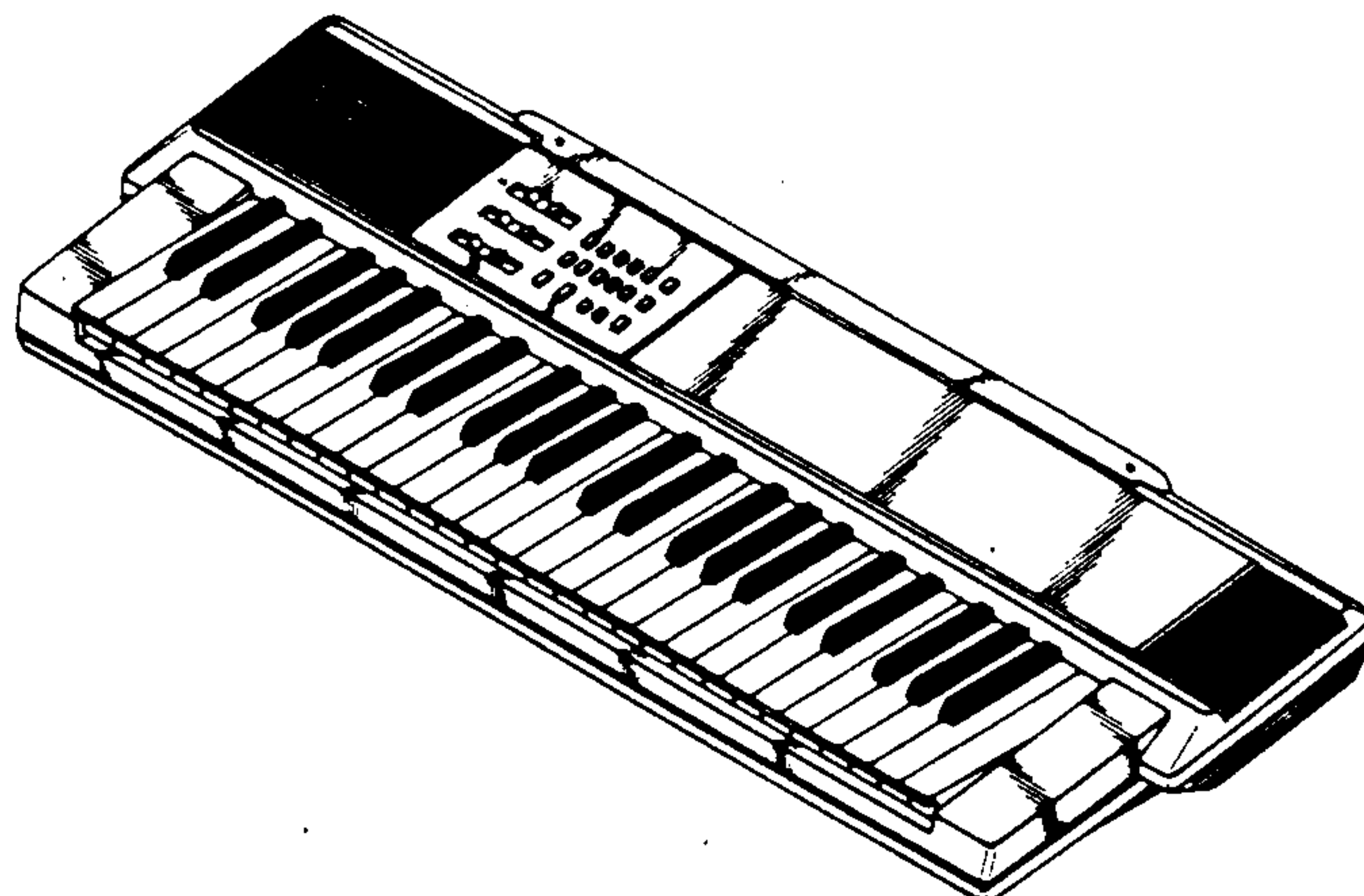
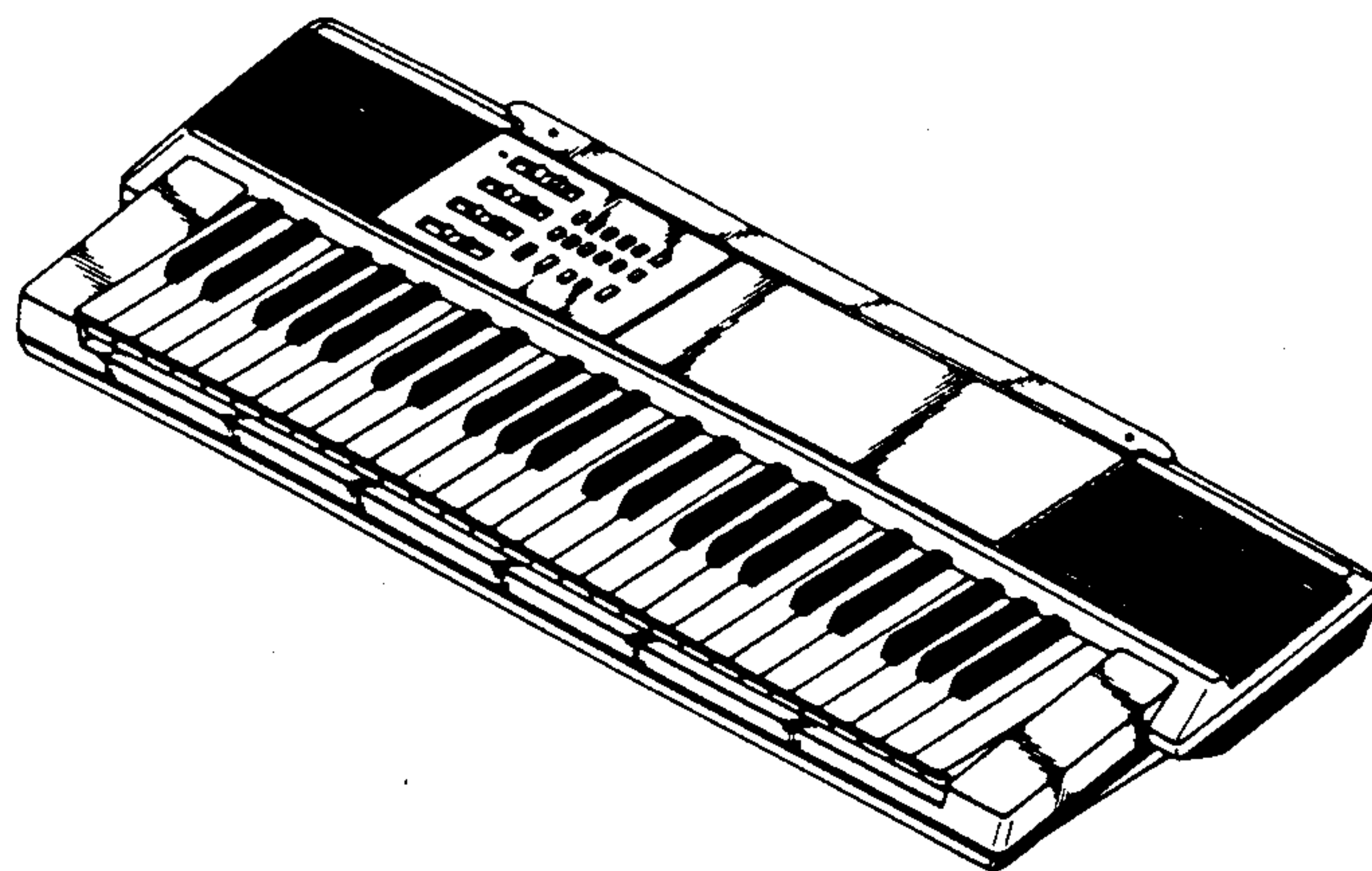

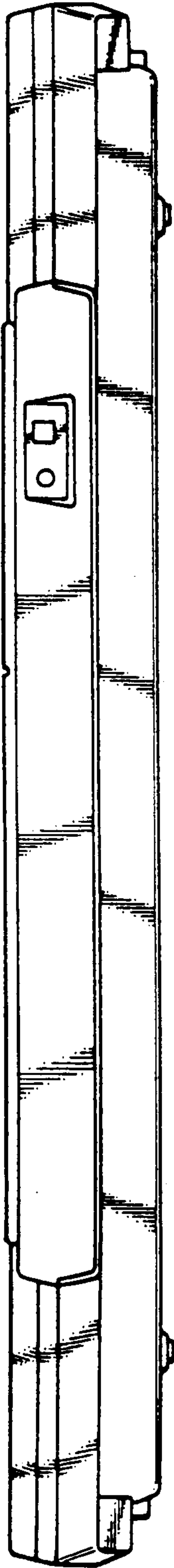

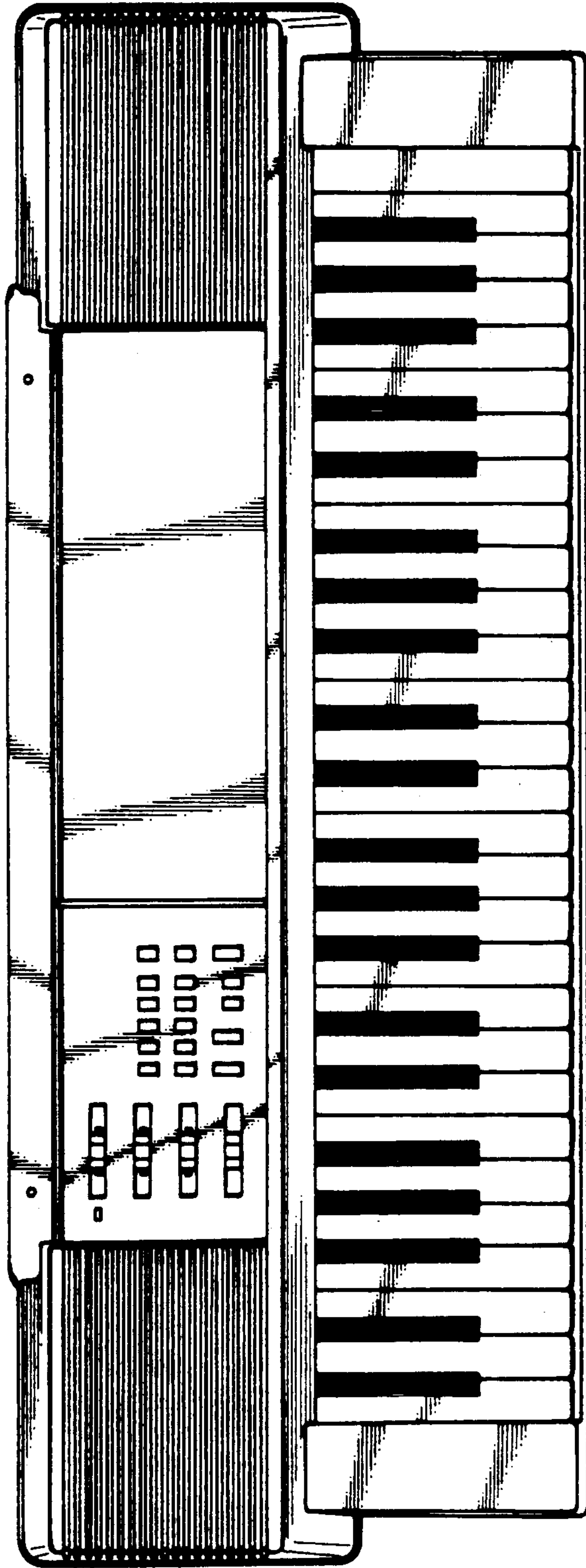

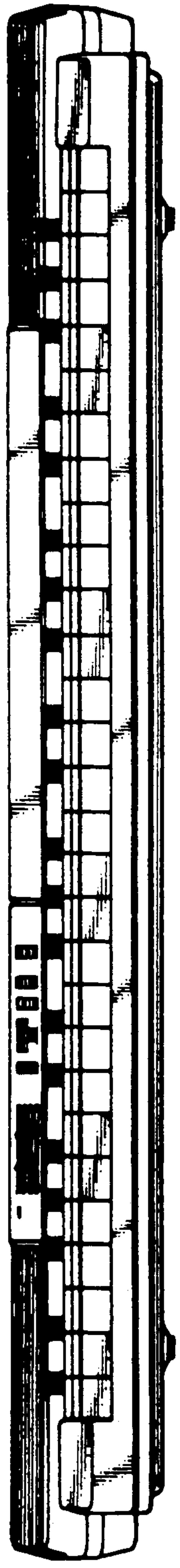

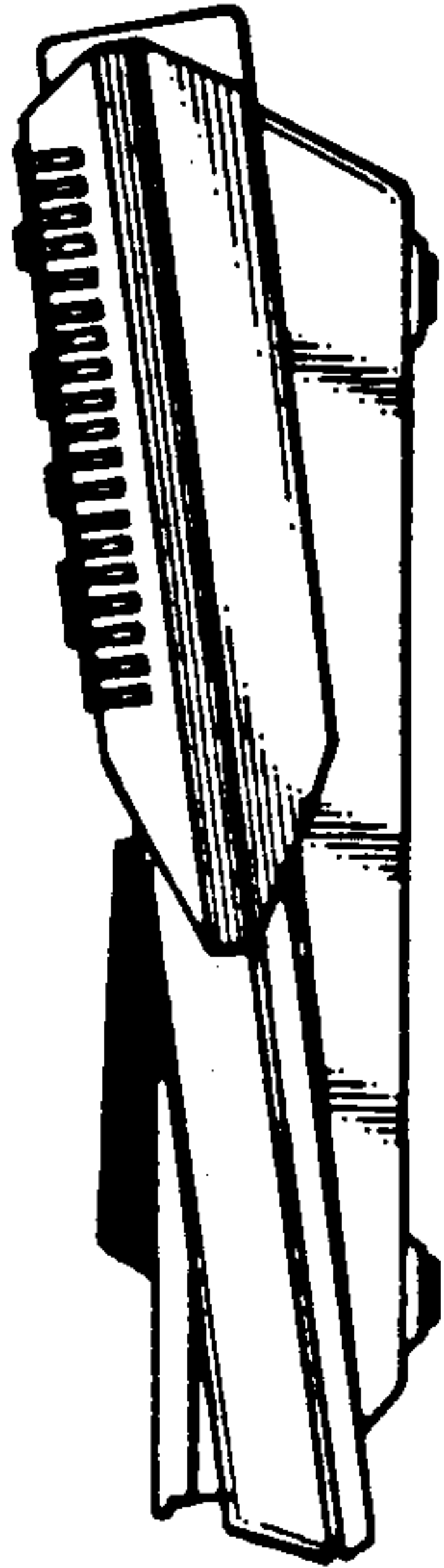

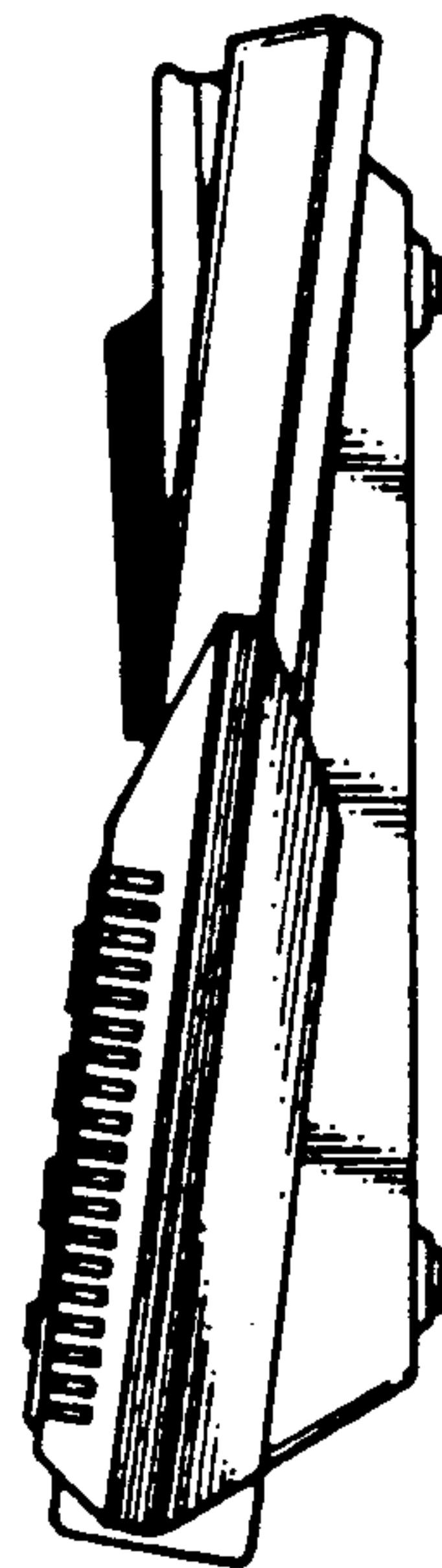
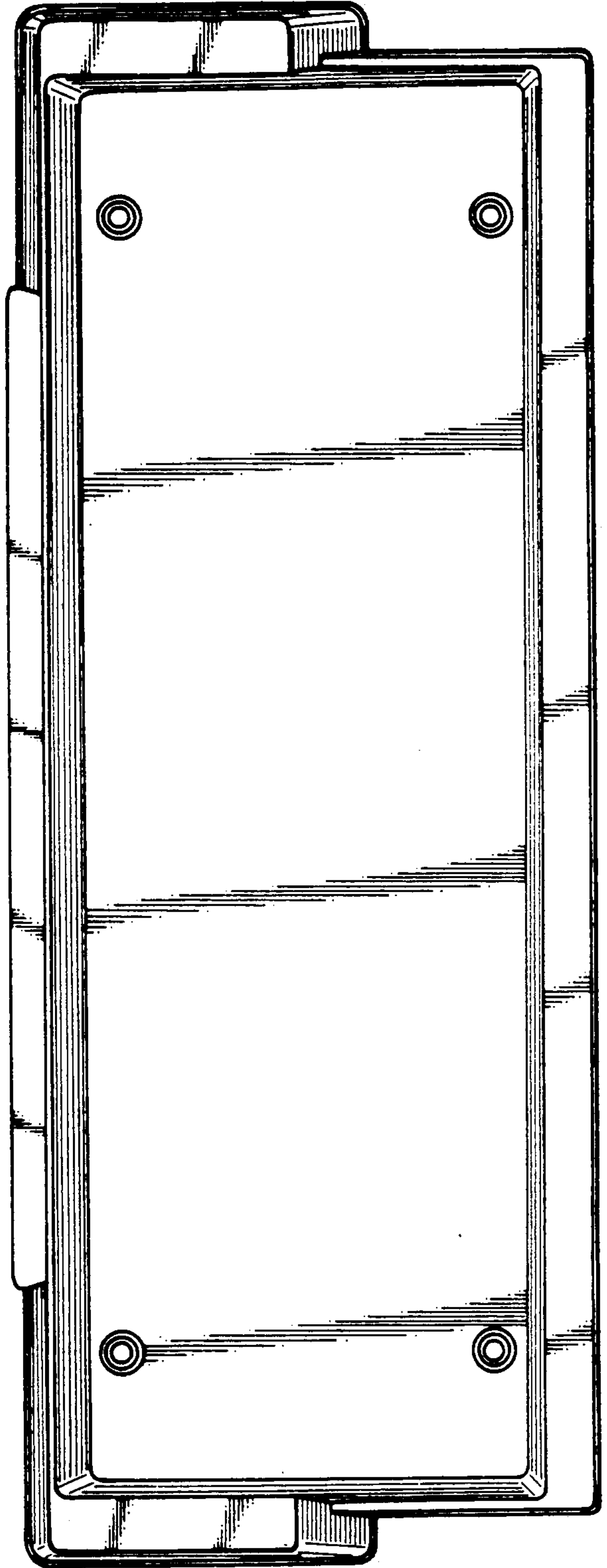

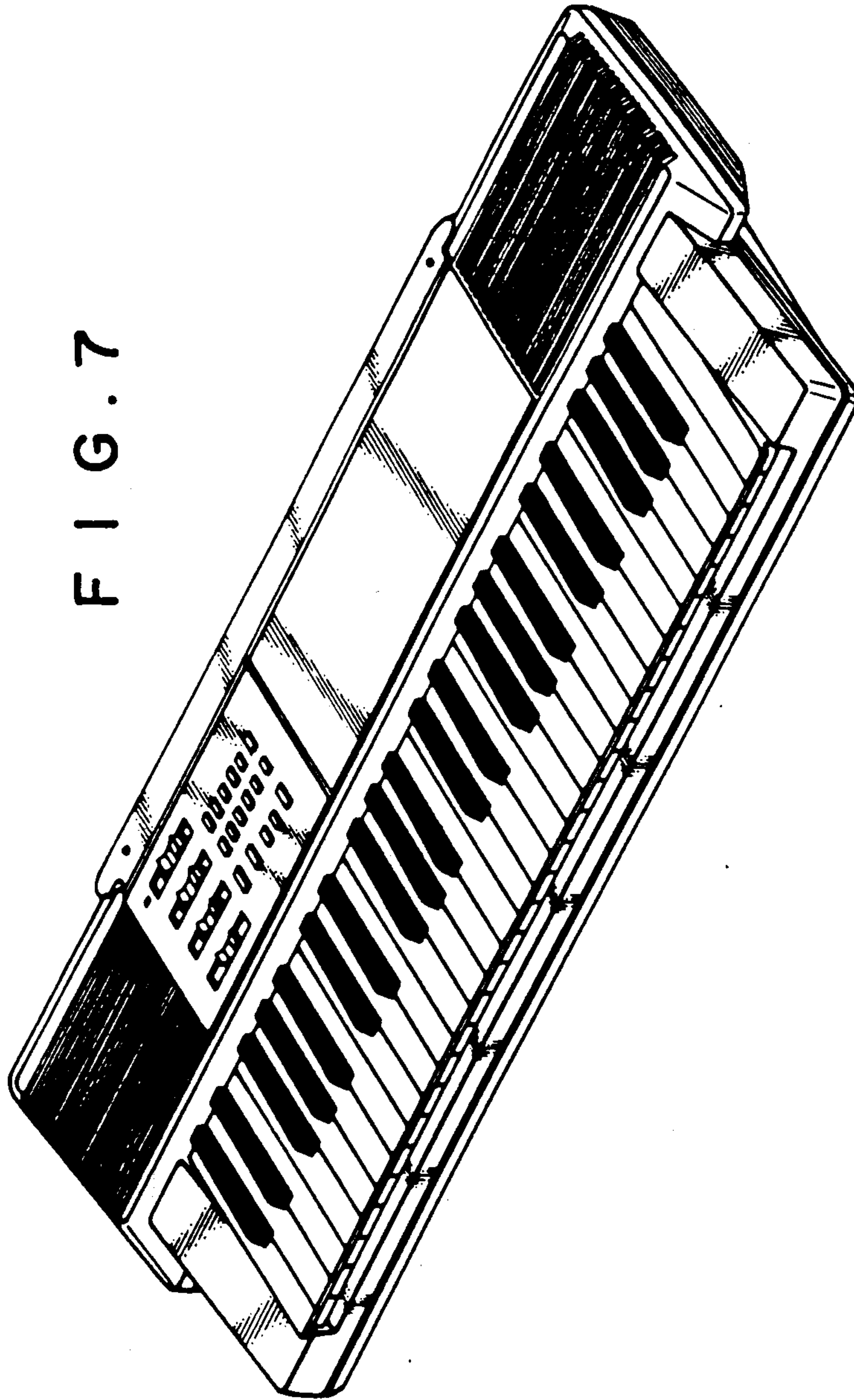

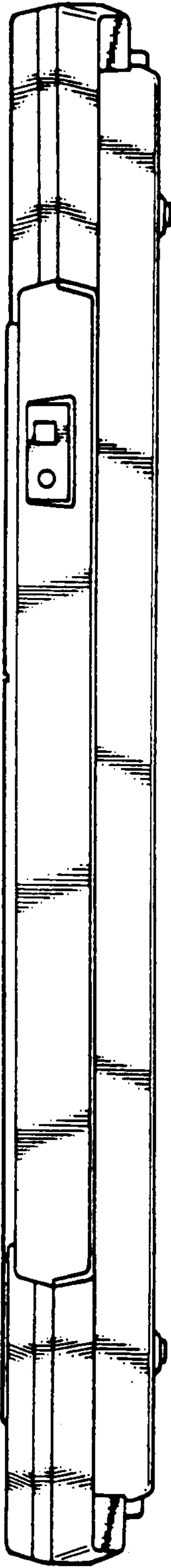

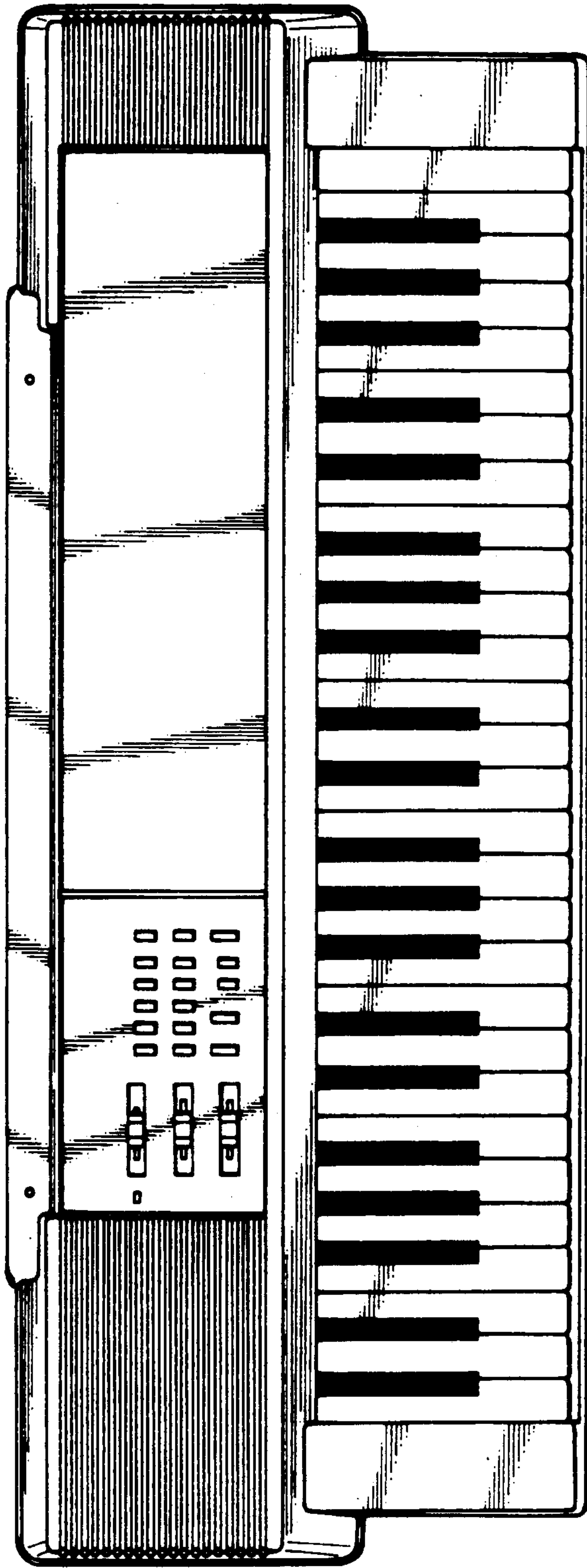

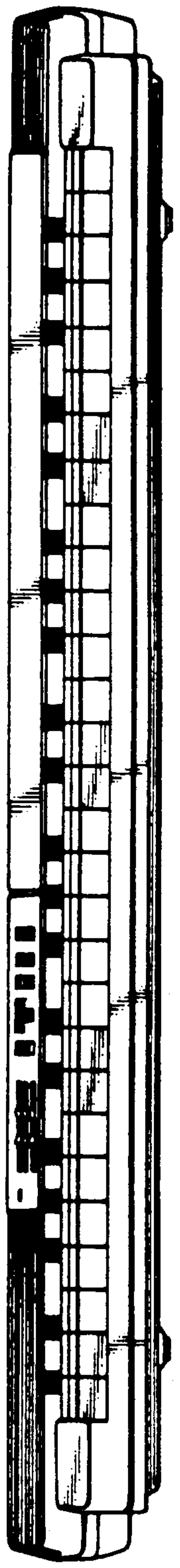

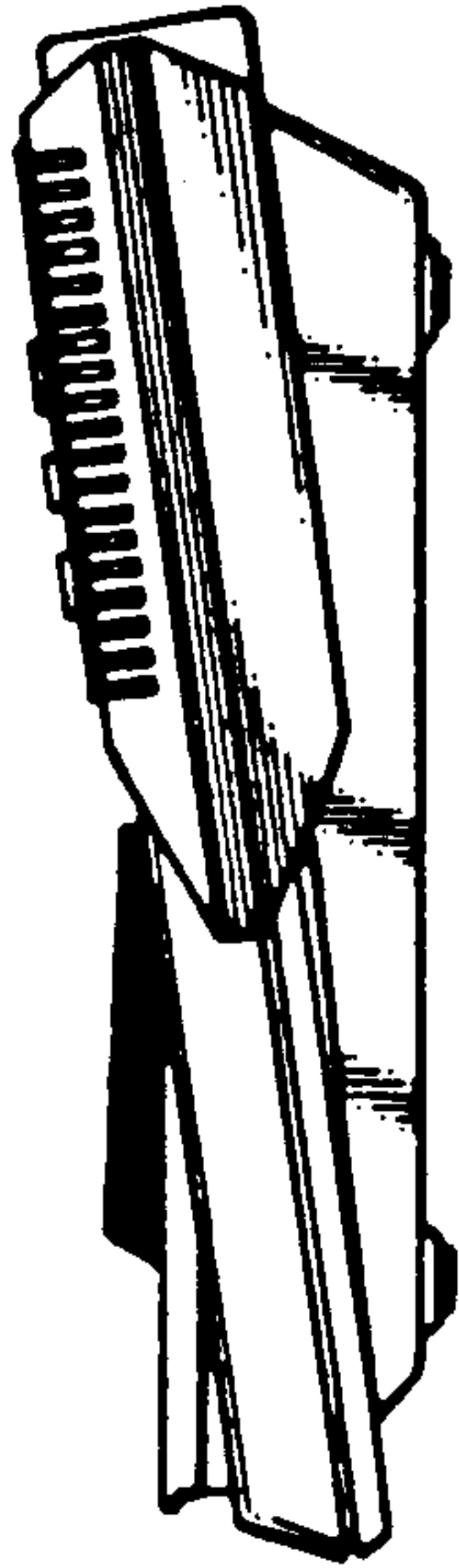

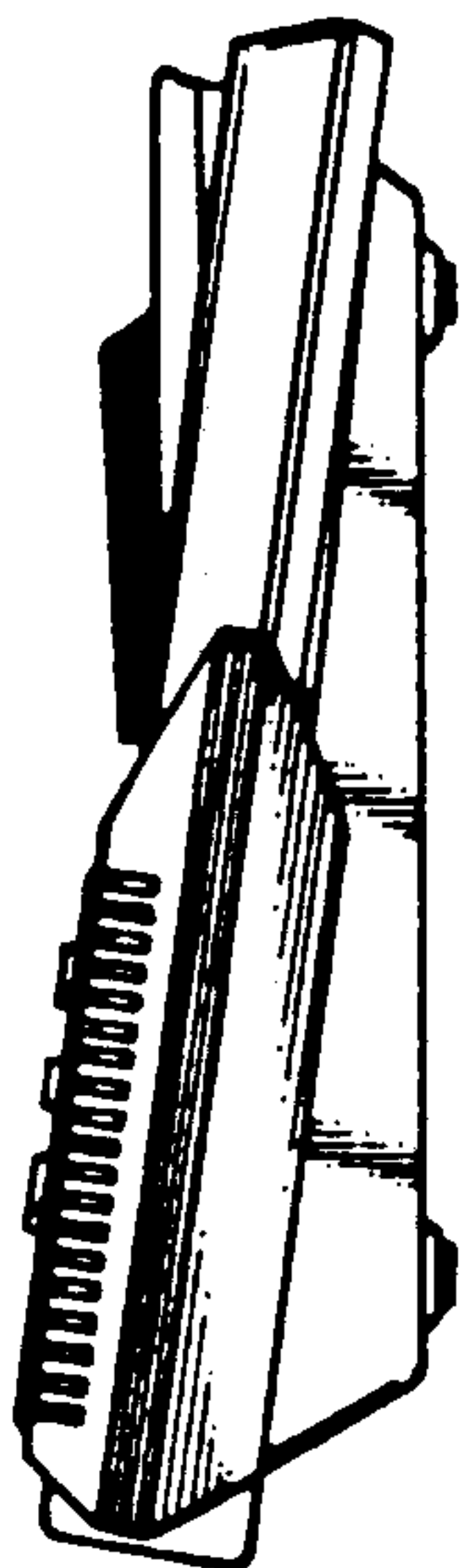

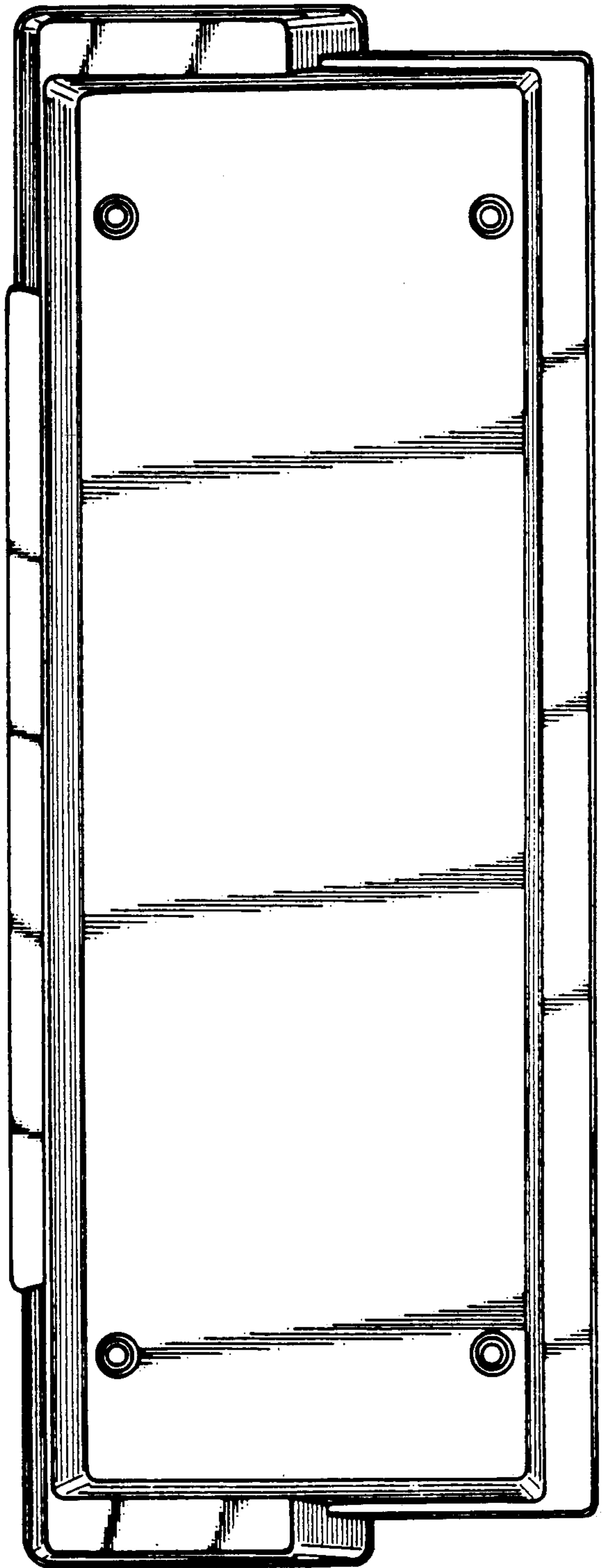
