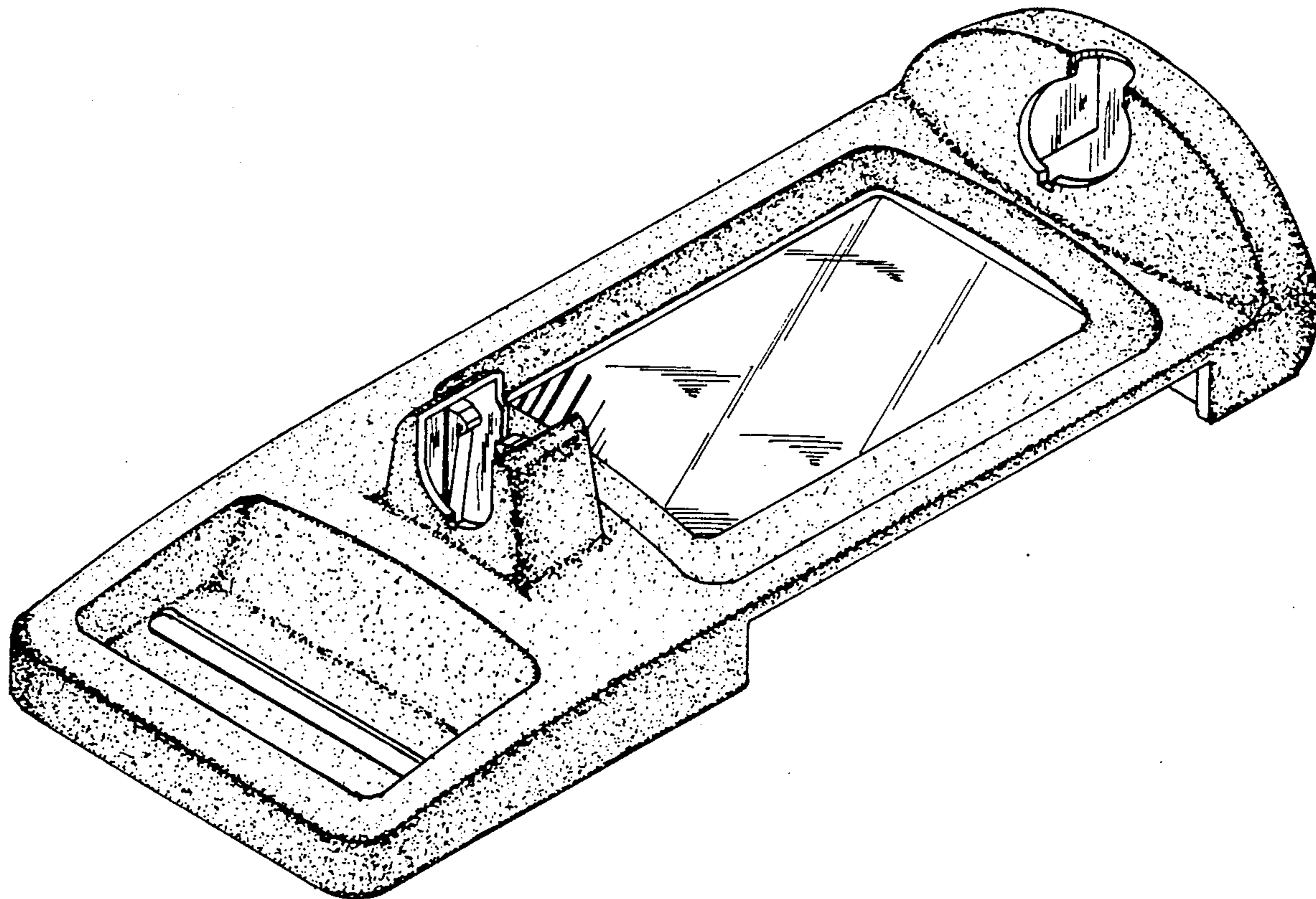

[57] **CLAIM**

The ornamental design for a tray portion of sales packaging for a razor and razor blade cartridges, as shown and described.

**DESCRIPTION**

FIG. 1 is a top plan view of a tray portion of sales packaging for a razor and razor blade cartridges showing my new design;  
FIG. 2 is a left side elevational view thereof;  
FIG. 3 is a bottom view thereof;  
FIG. 4 is a right side elevational view thereof;  
FIG. 5 is a front view elevational thereof;  
FIG. 6 is a rear elevational view thereof, and  
FIG. 7 is a perspective view thereof.



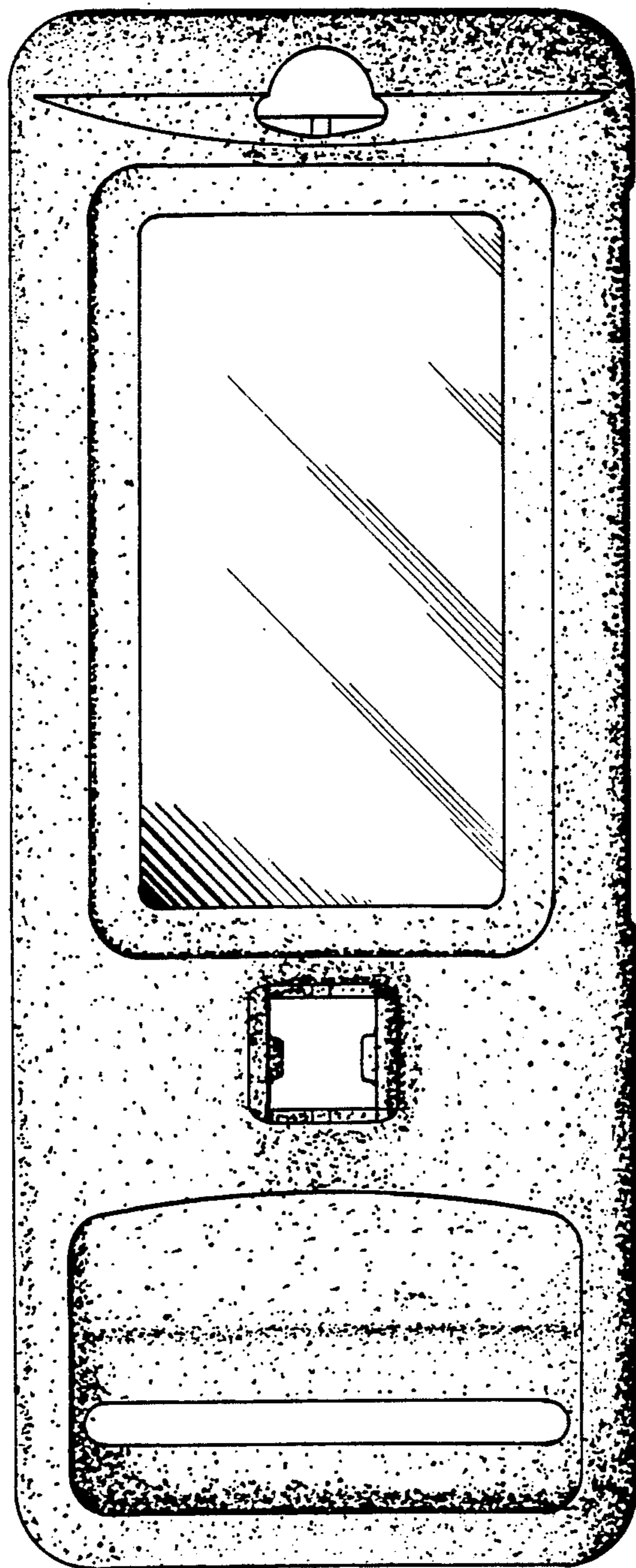

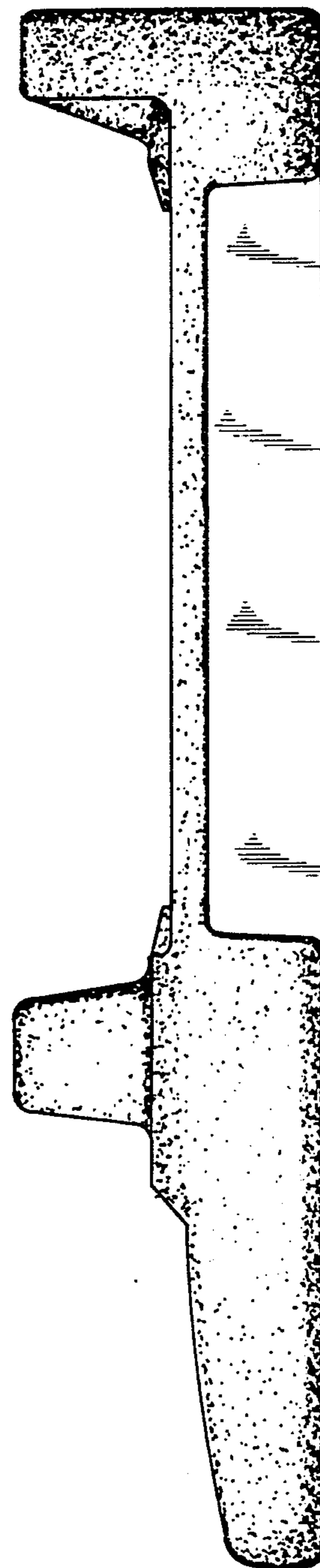

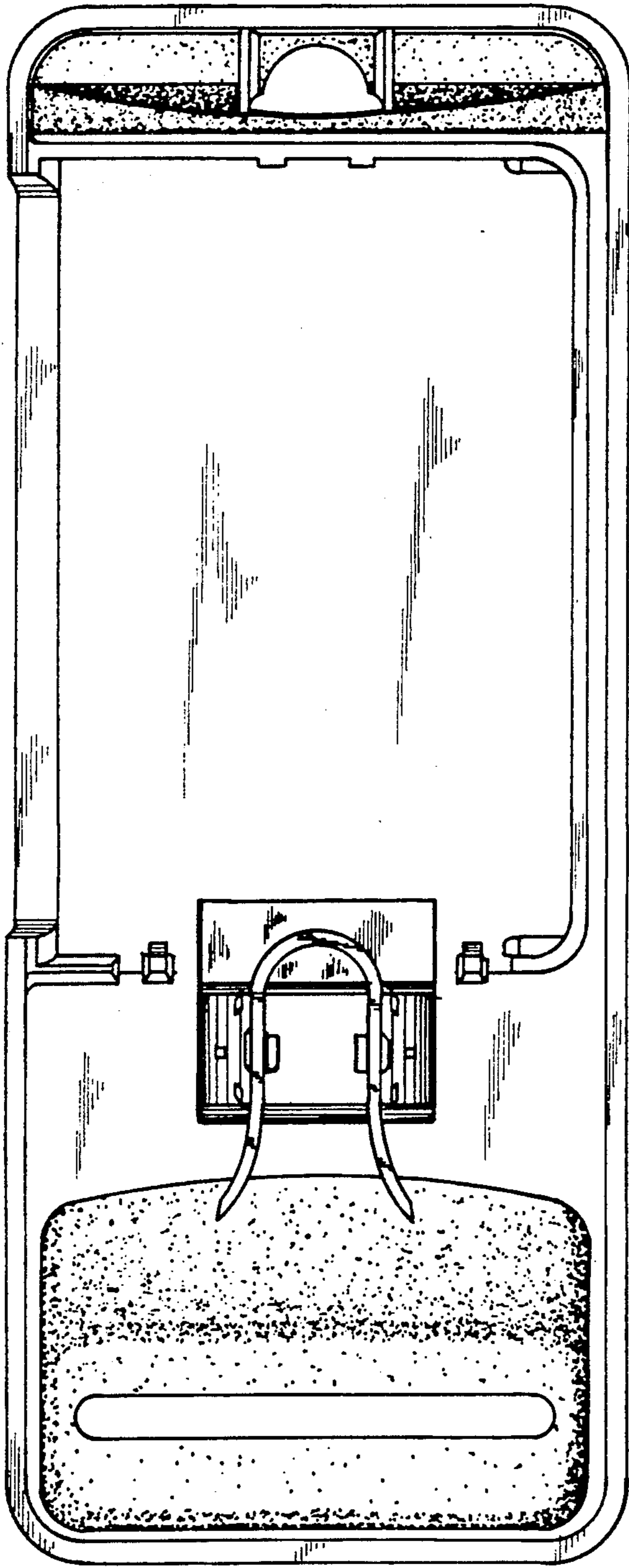

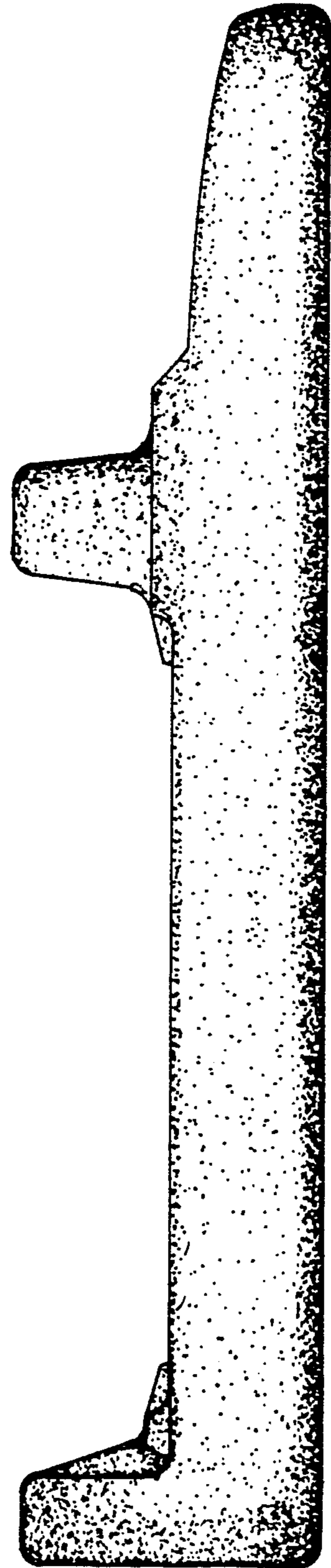

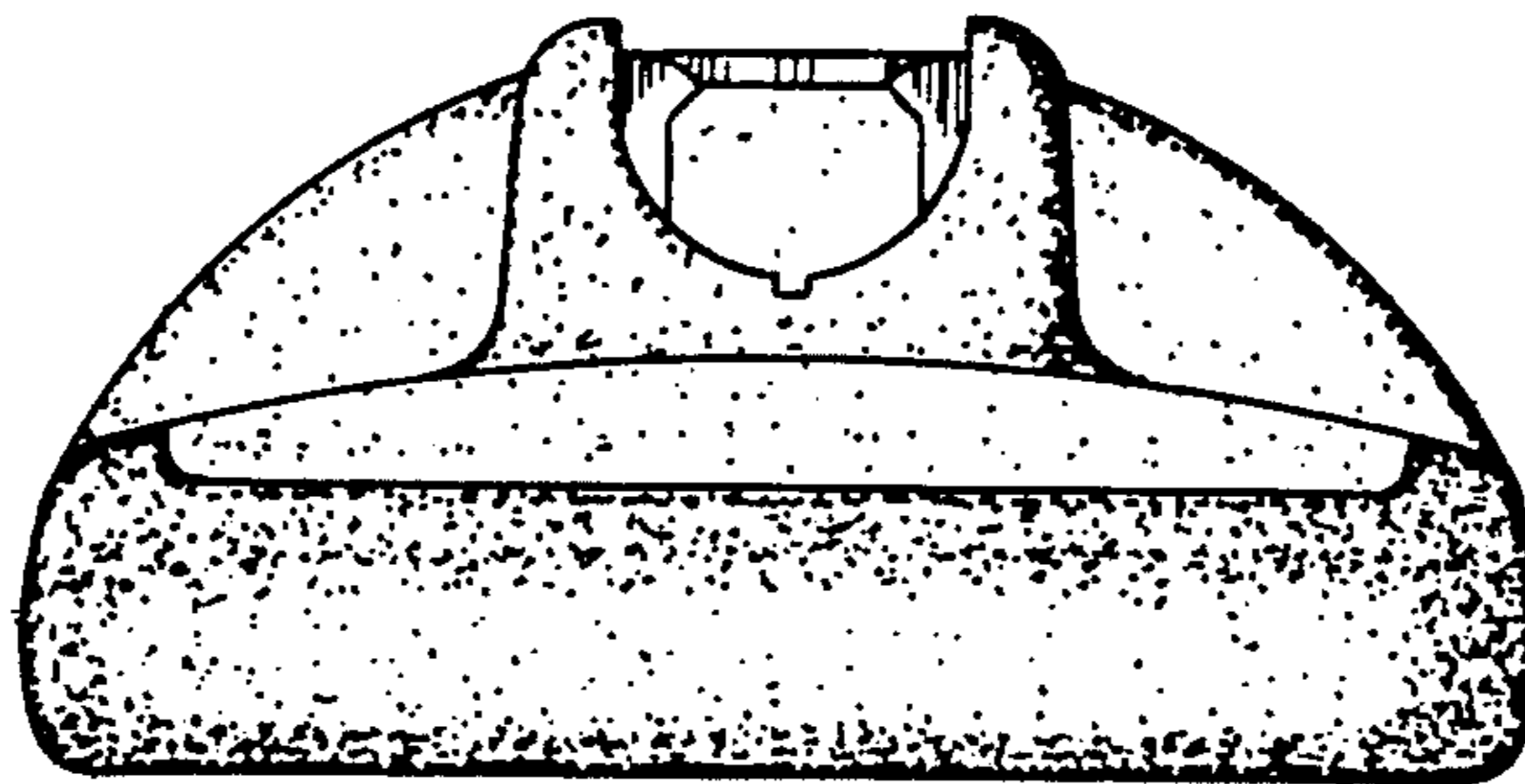

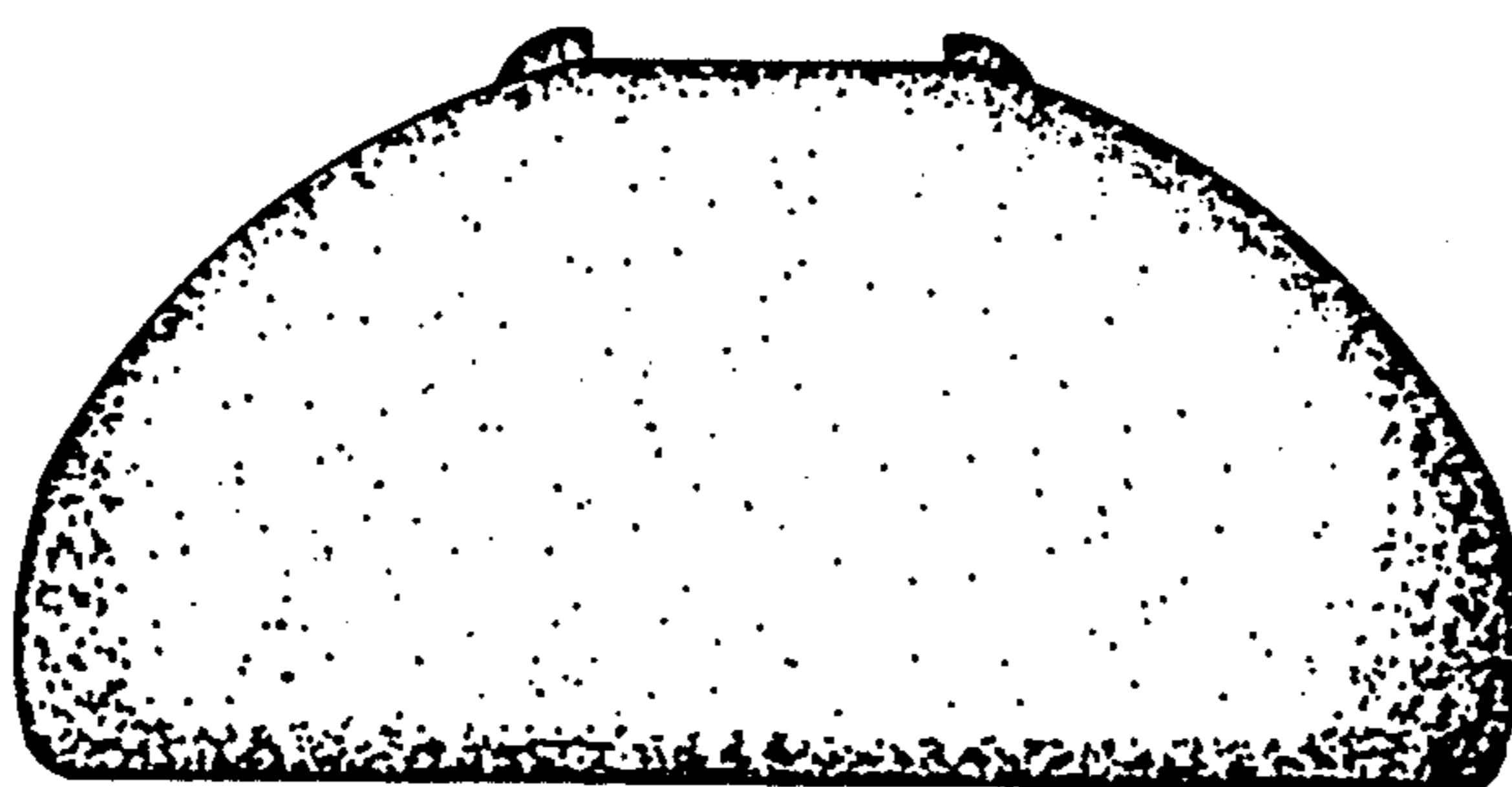

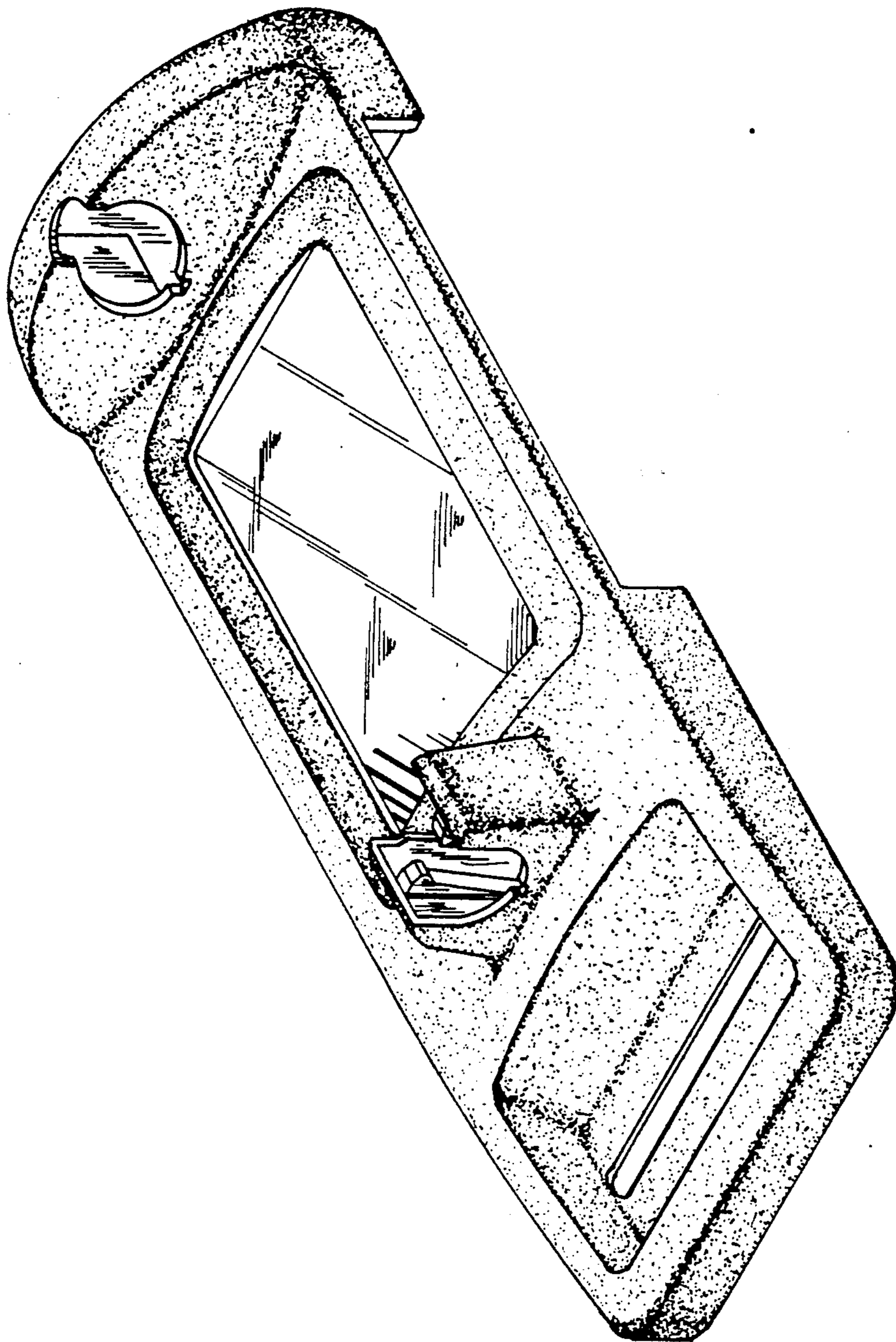
