The ornamental design for a combined wristwatch and strap, as shown and described.

**DESCRIPTION**

FIG. 1 front elevational view of a combined wristwatch and strap showing my new design;  
 FIG. 2 is a right side elevational view;  
 FIG. 3 is a rear elevational view;  
 FIG. 4 is a left side elevational view;  
 FIG. 5 is a top plan view;  
 FIG. 6 is a bottom plan view;  
 FIG. 7 is a right side elevational view, with the strap shown in an open position; and  
 FIG. 8 is a bottom and right perspective view thereof, with the strap shown in an open position and the watch being omitted for ease of illustration.

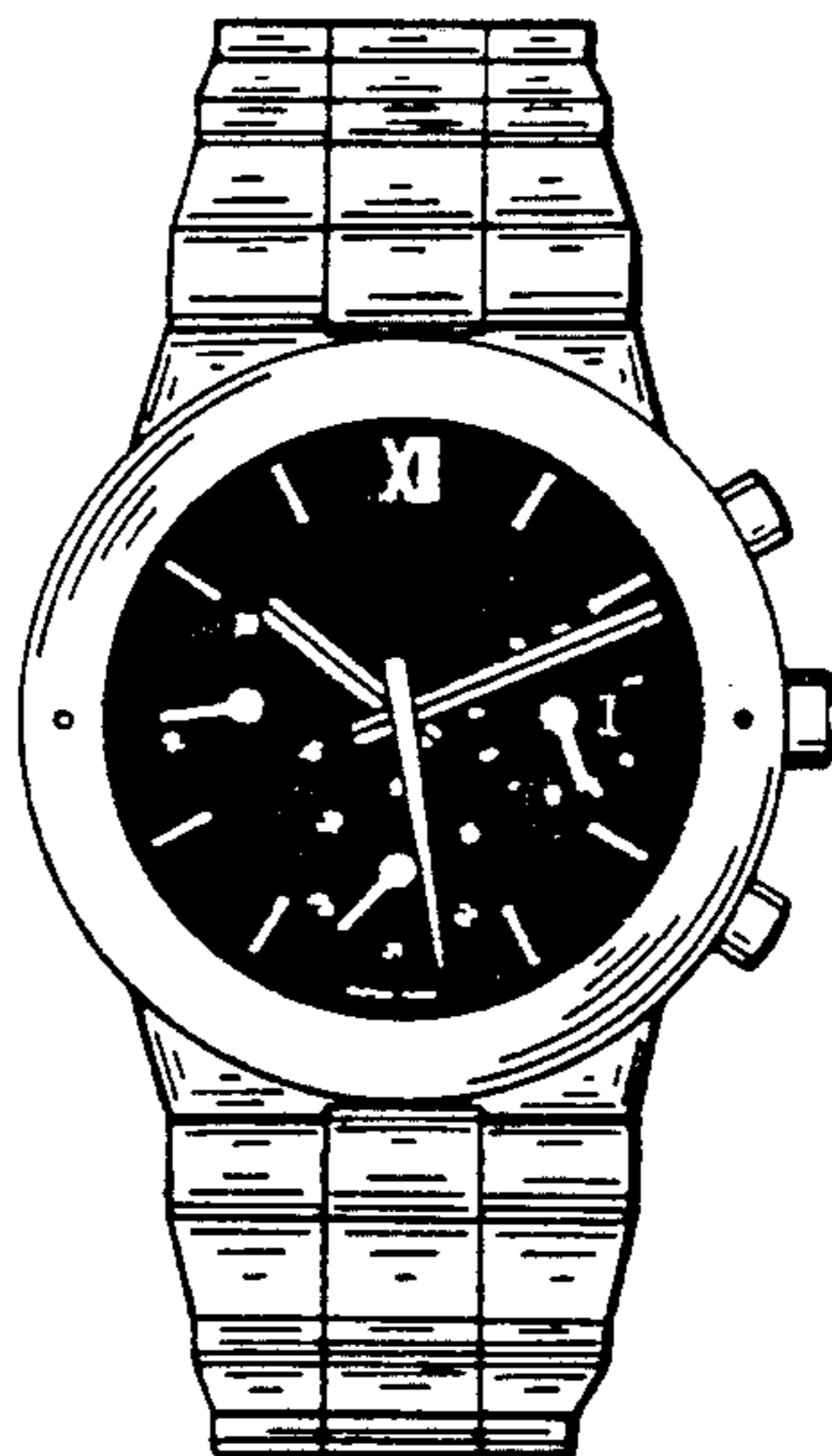

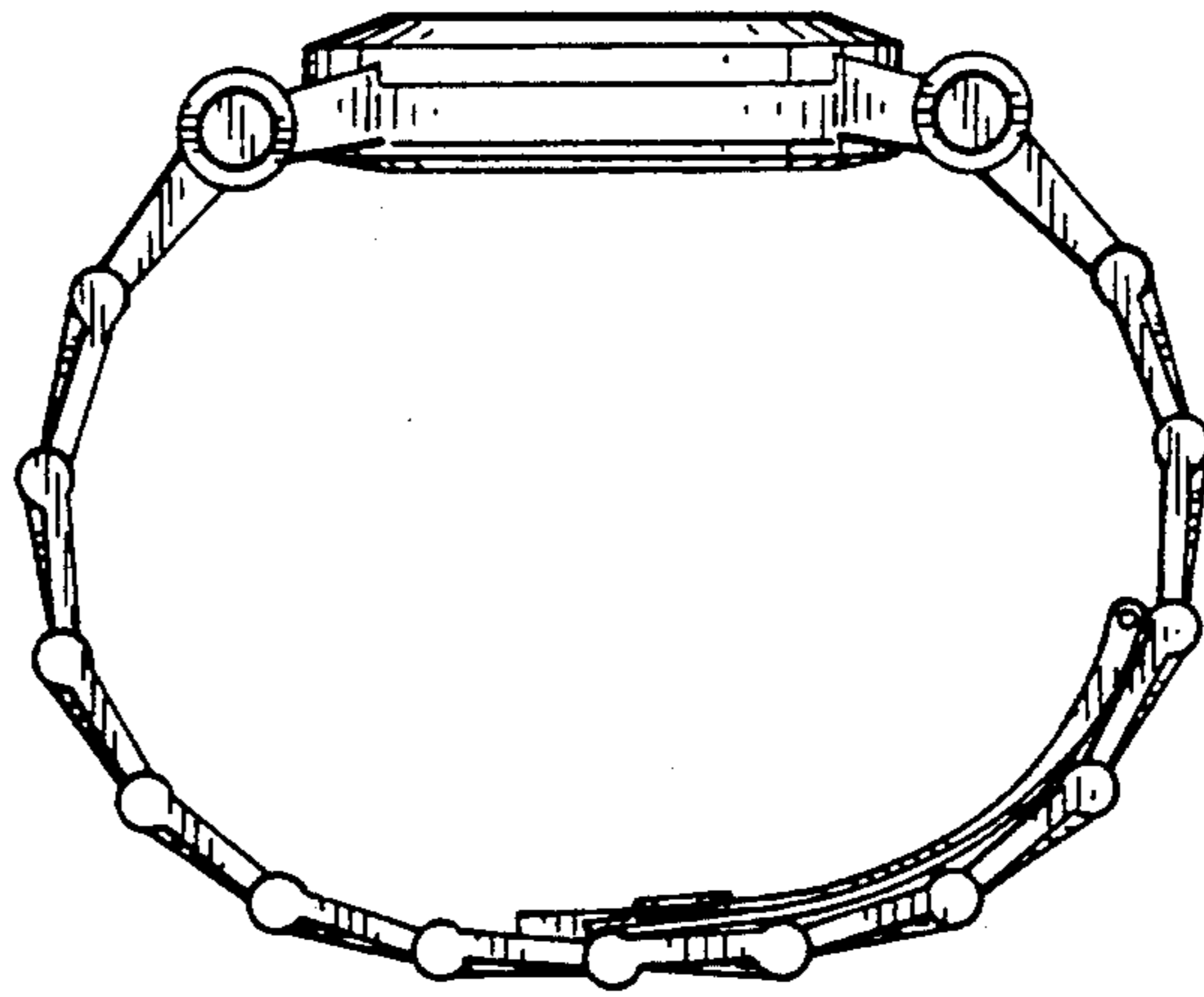

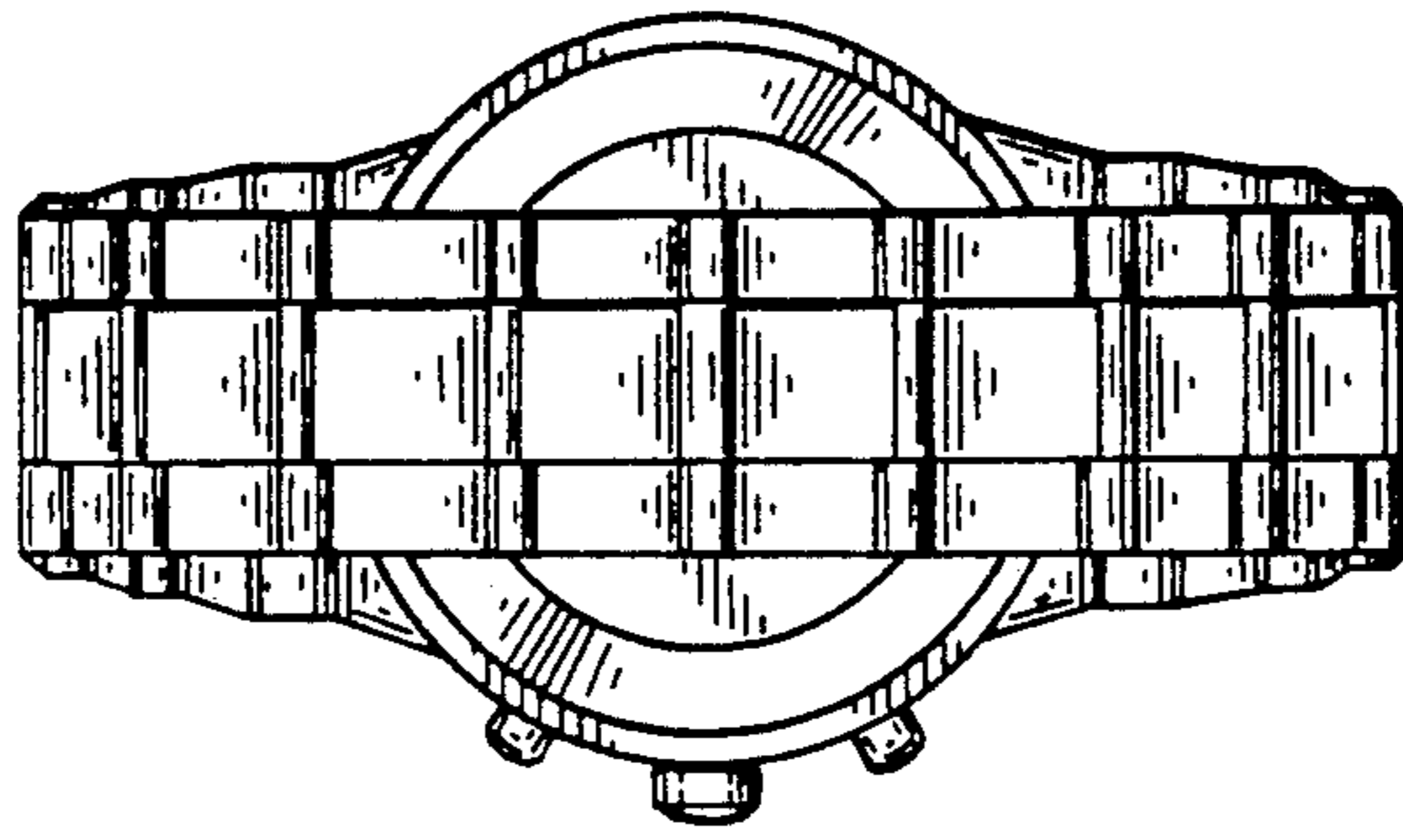

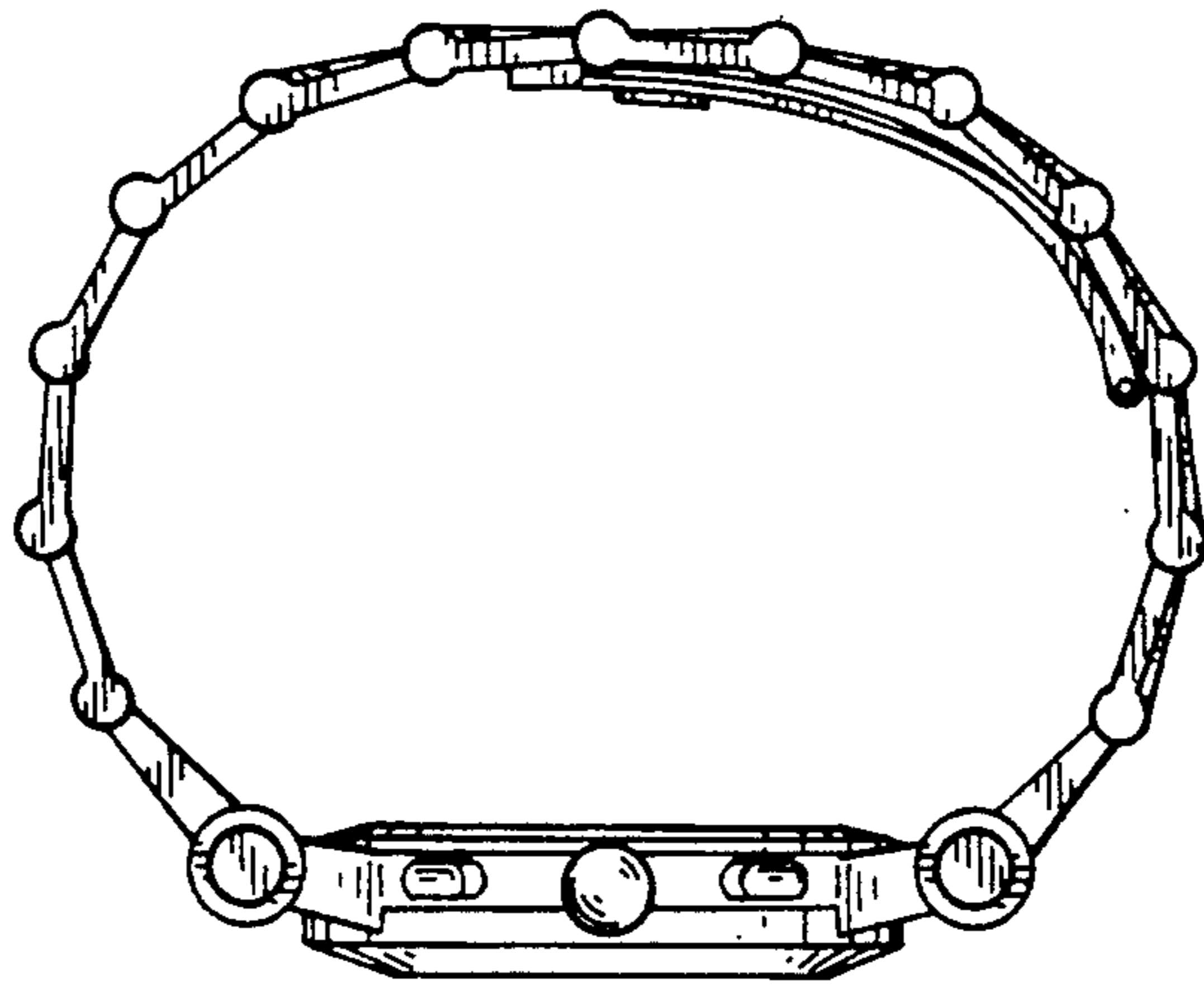

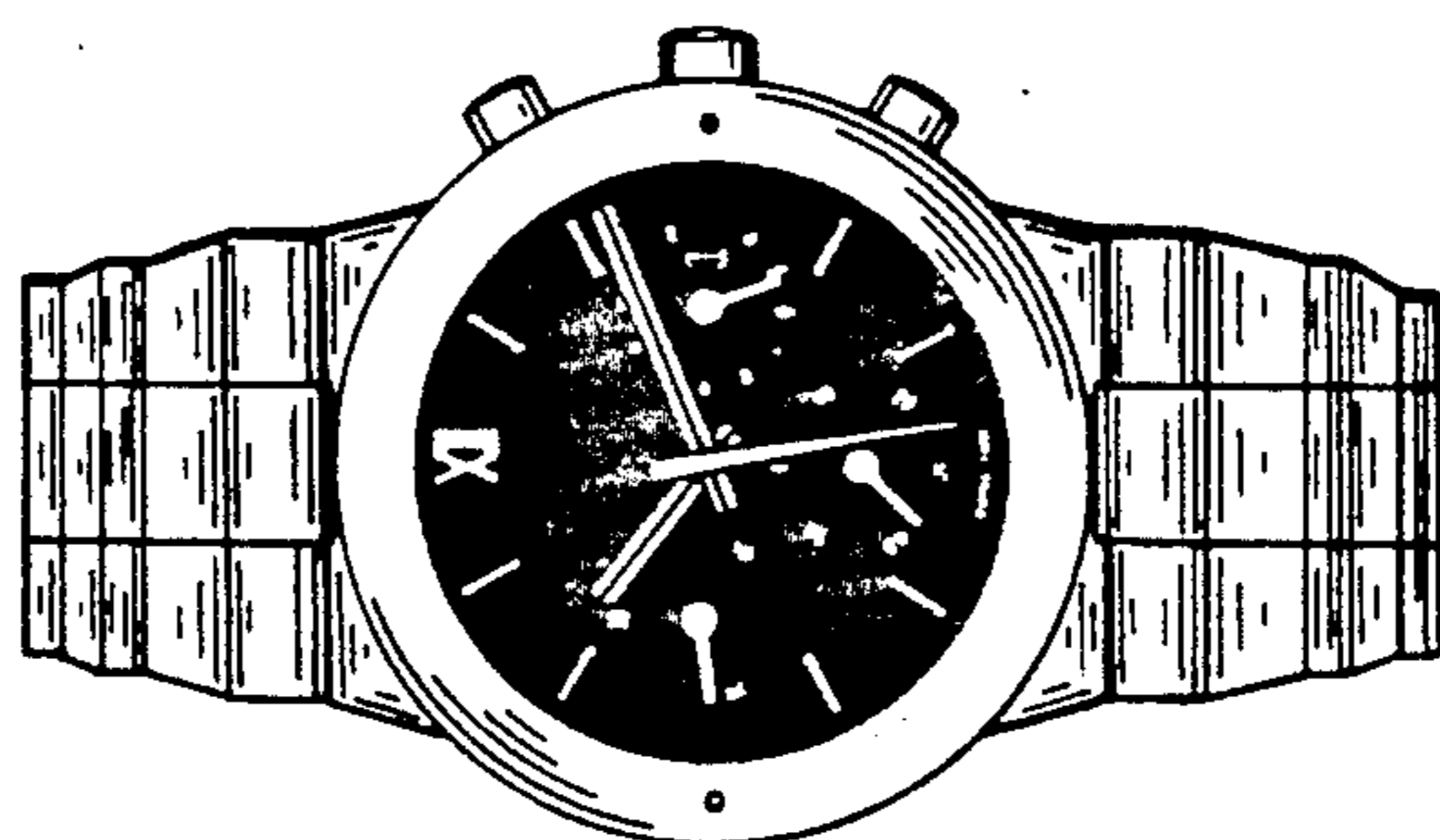

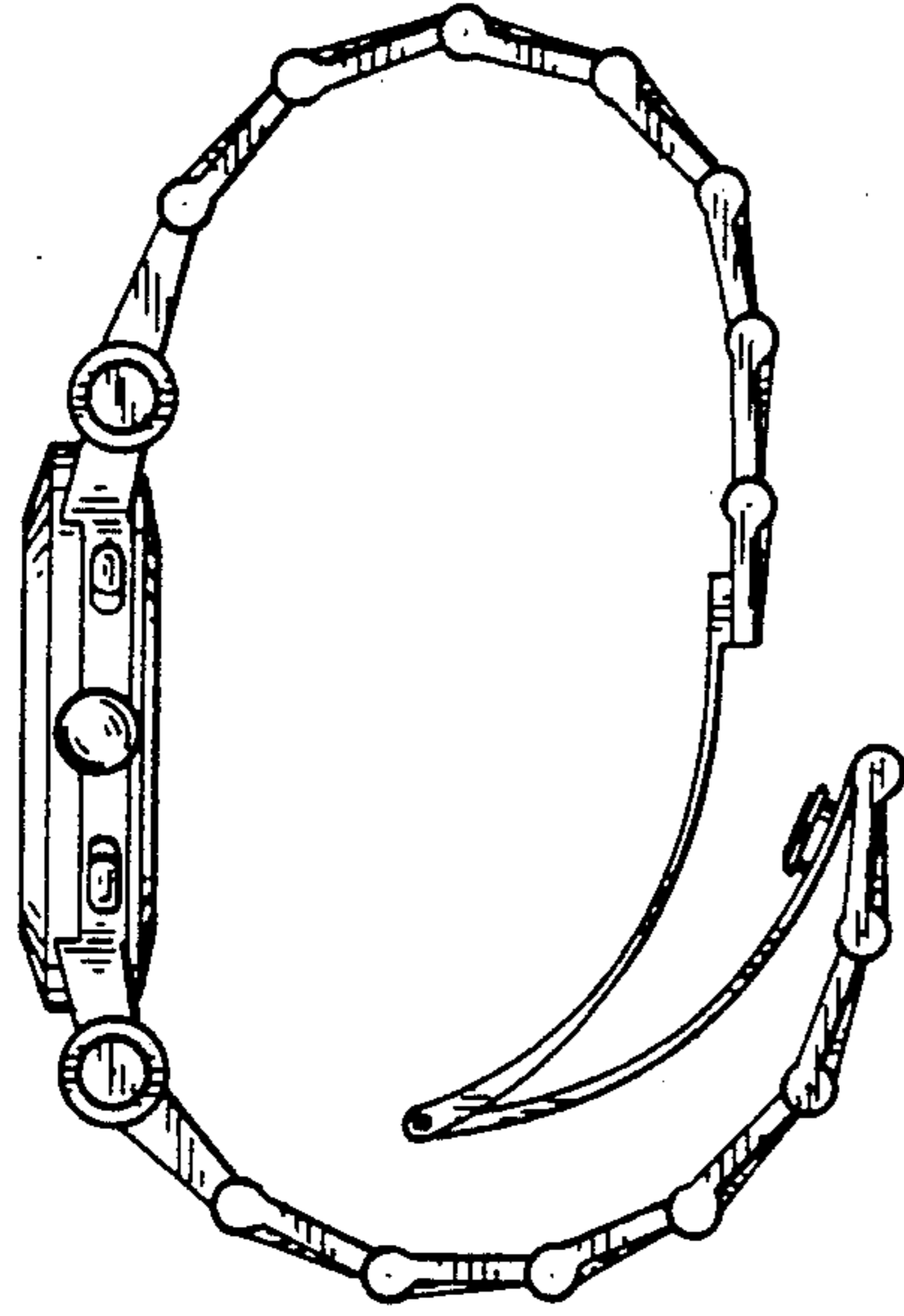

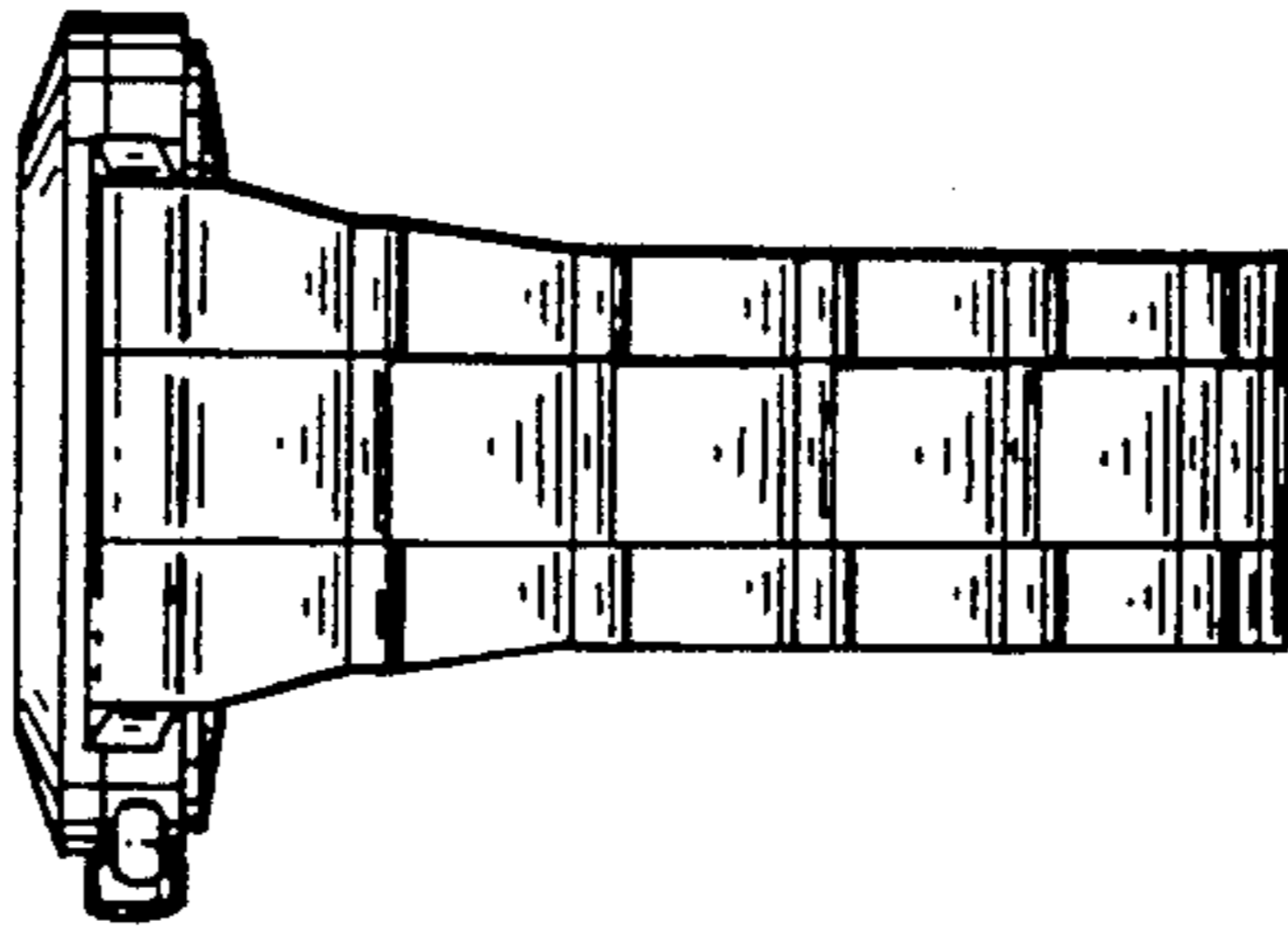

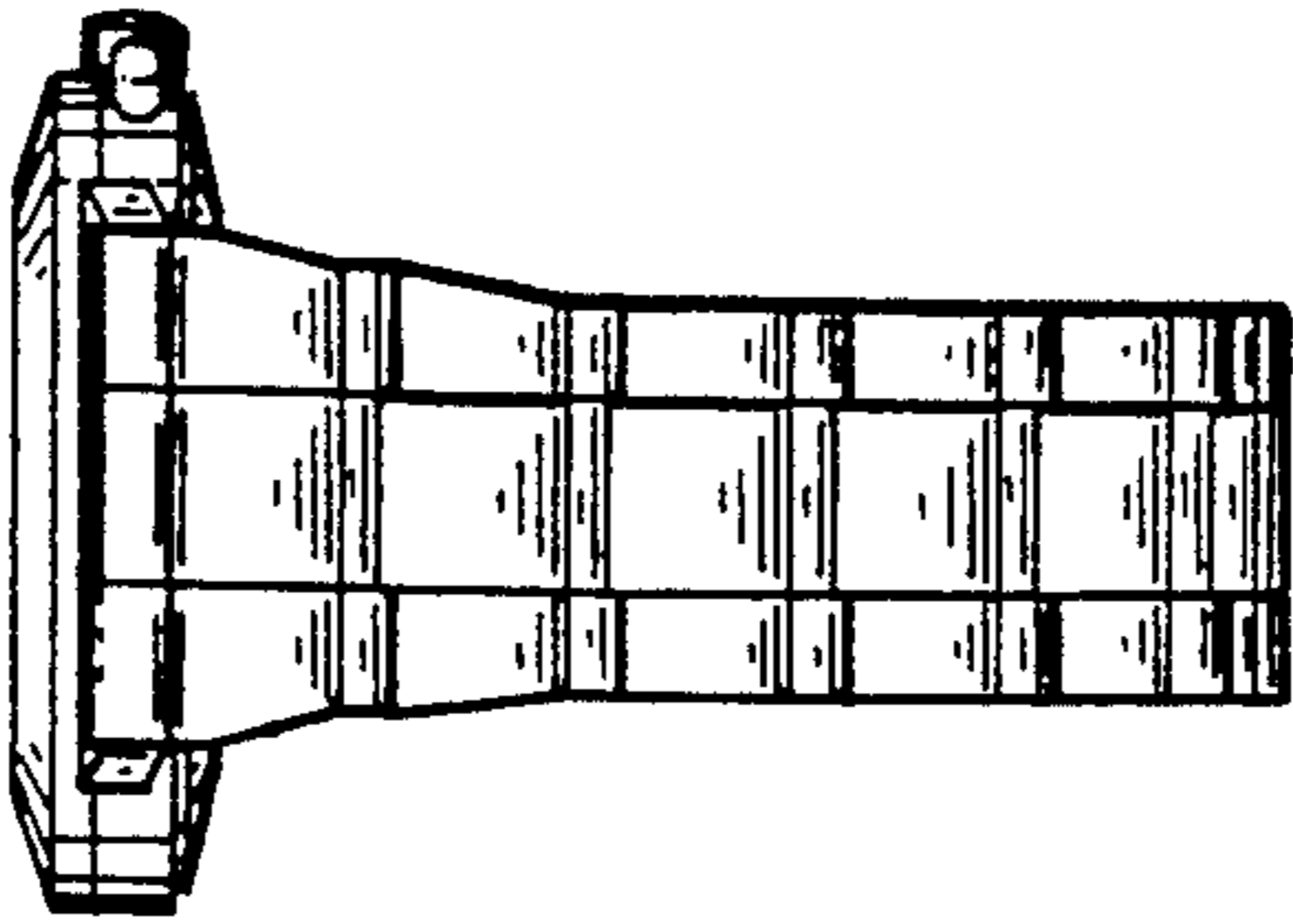
