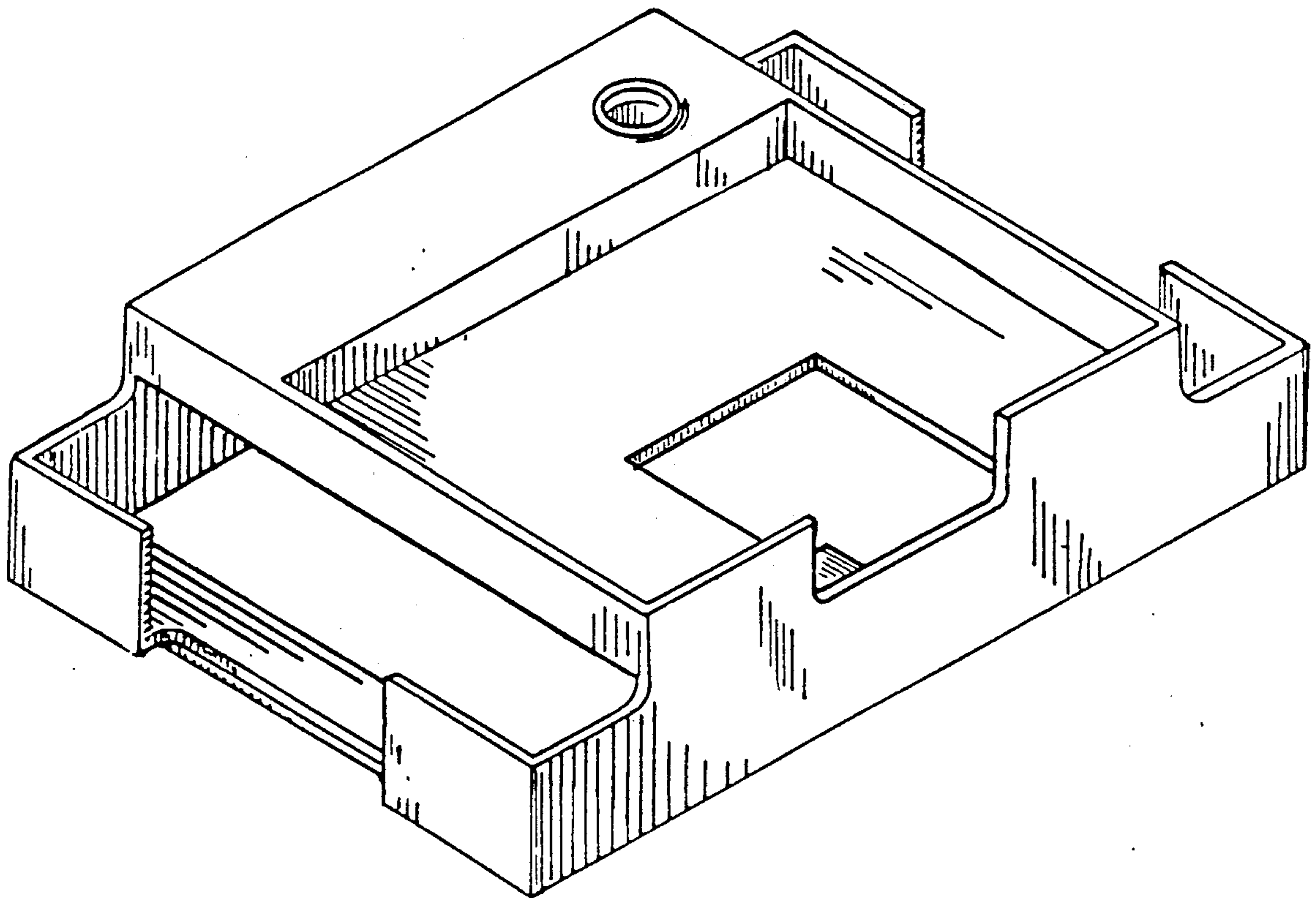

[57] **CLAIM**

The ornamental design for a combined two-level paper tray and writing instrument holder, as shown and described.

DESCRIPTION

FIG. 1 is a top left front perspective view of a combined two-level paper tray and writing instrument holder showing my new design;
FIG. 2 is a top plan view on a reduced scale;
FIG. 3 is a front elevational view of FIG. 2;
FIG. 4 is a rear elevational view of FIG. 2;
FIG. 5 is a left side elevational view of FIG. 2;
FIG. 6 is a right side elevational view of FIG. 2;
FIG. 7 is a bottom plan view of FIG. 2; and
FIG. 8 is a cross-sectional view taken in the direction of arrows 8—8 in FIG. 2.



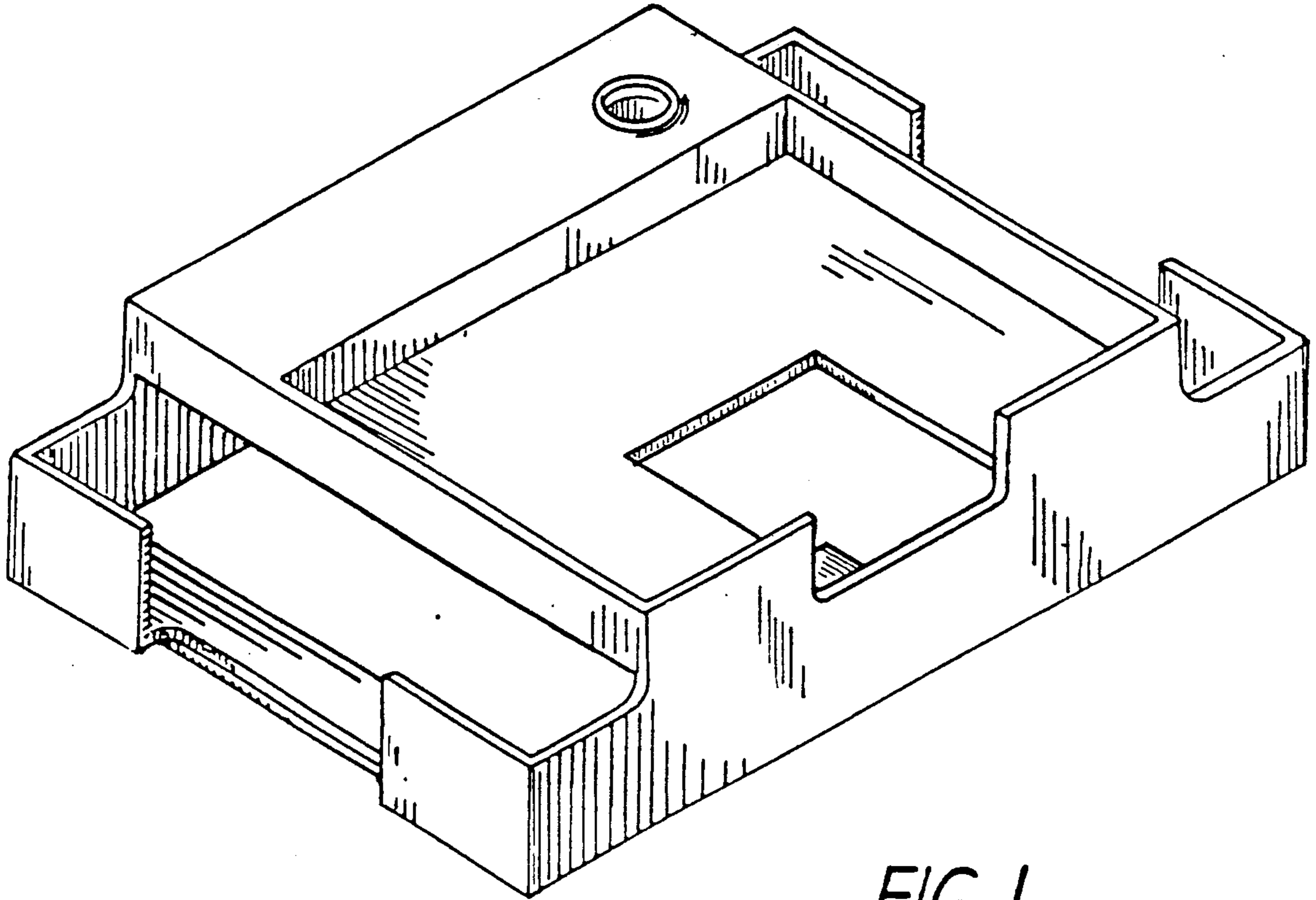

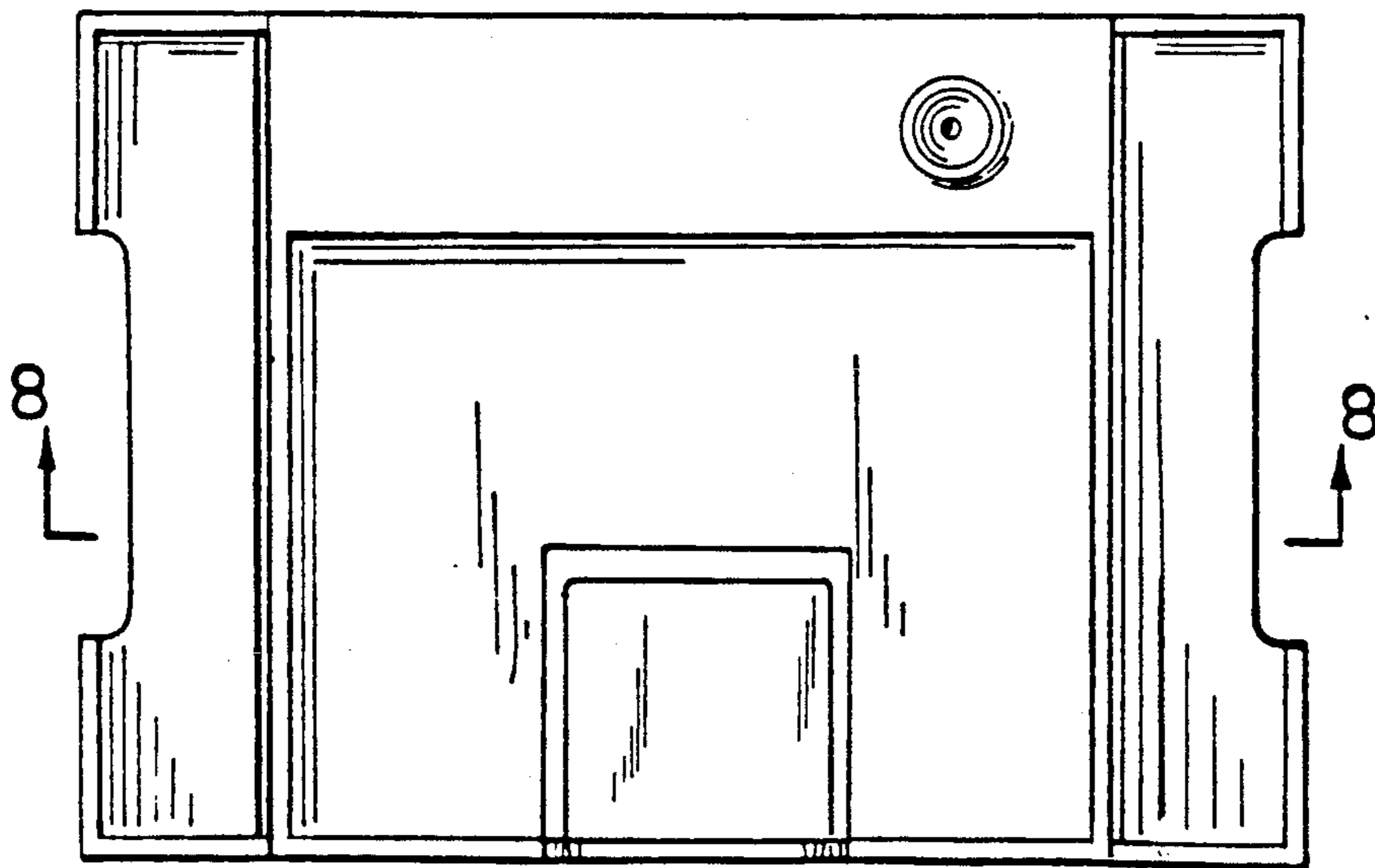

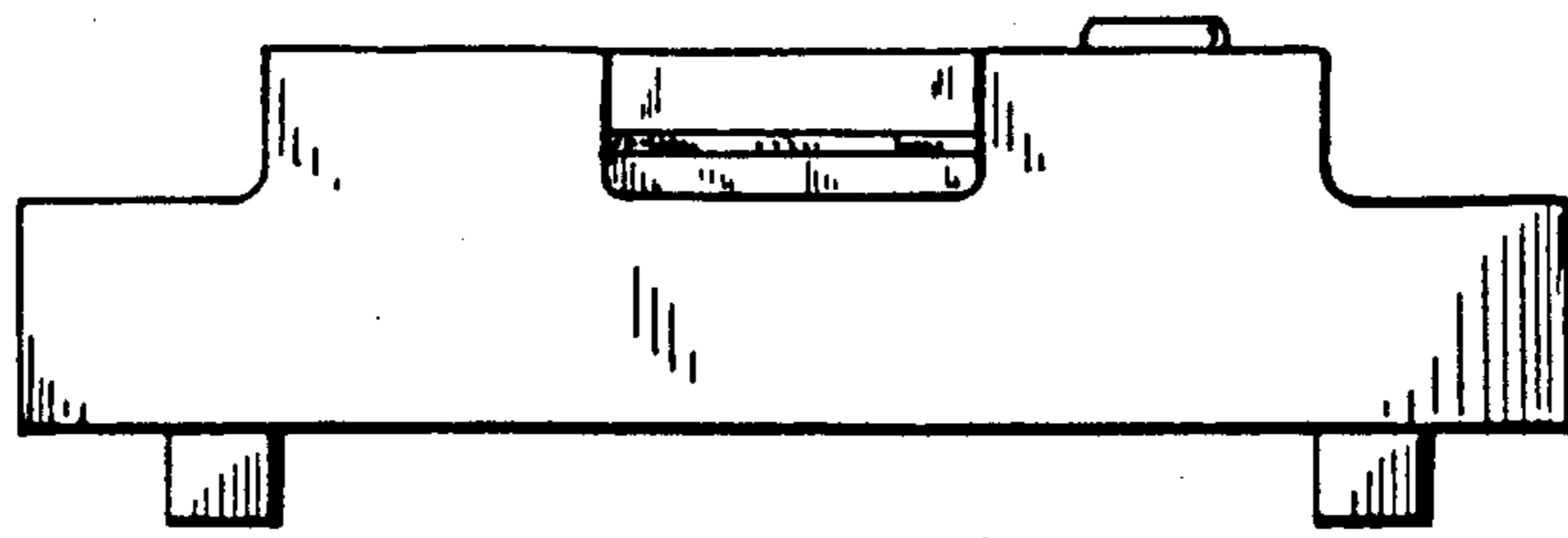

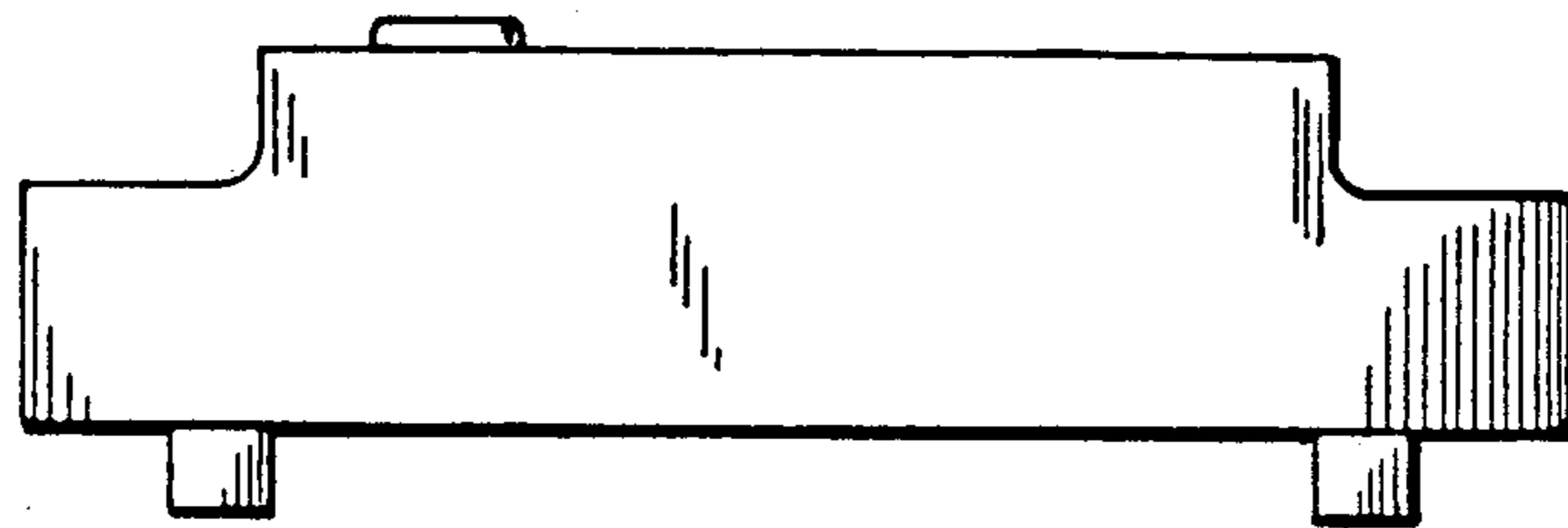

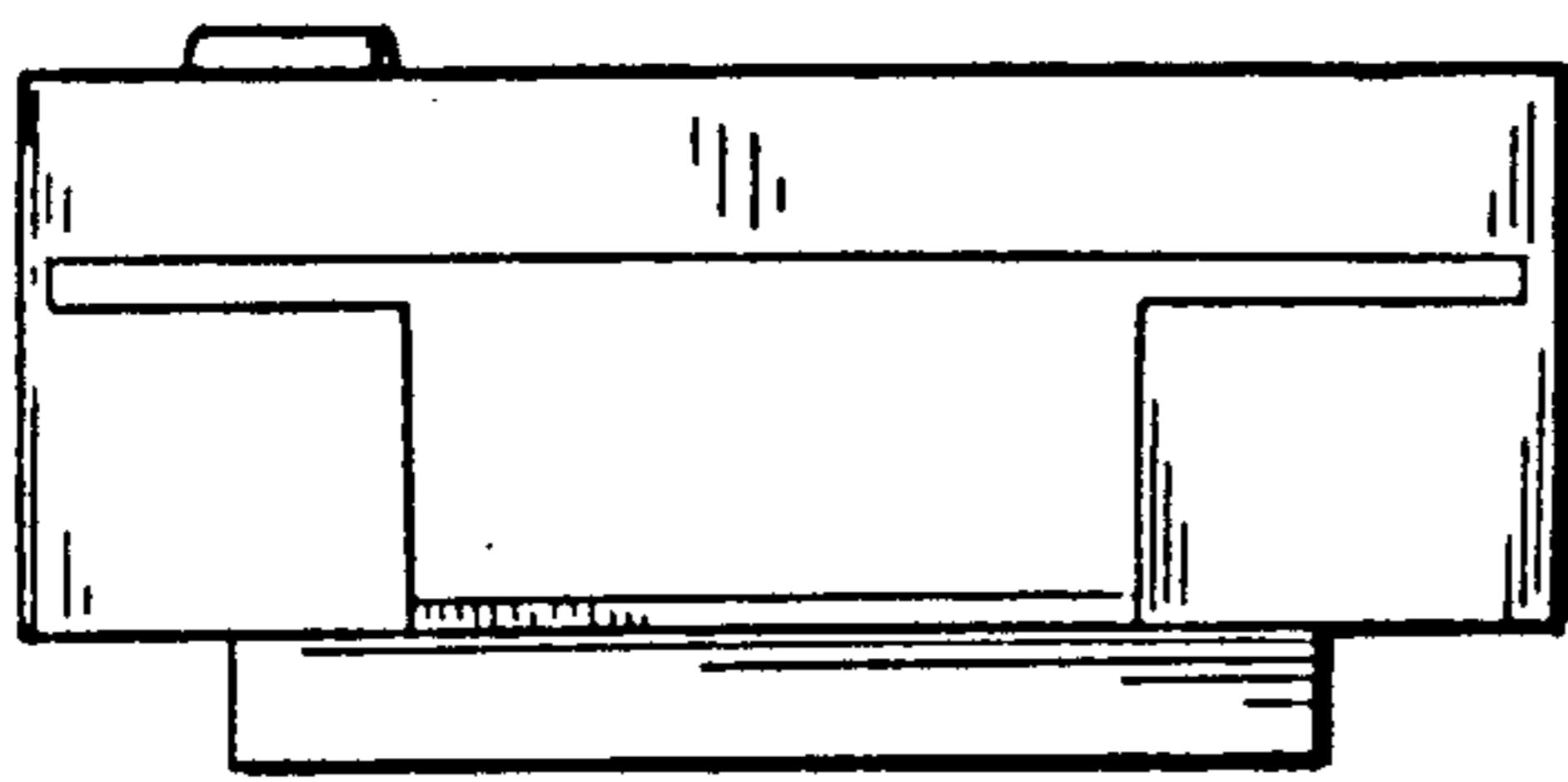

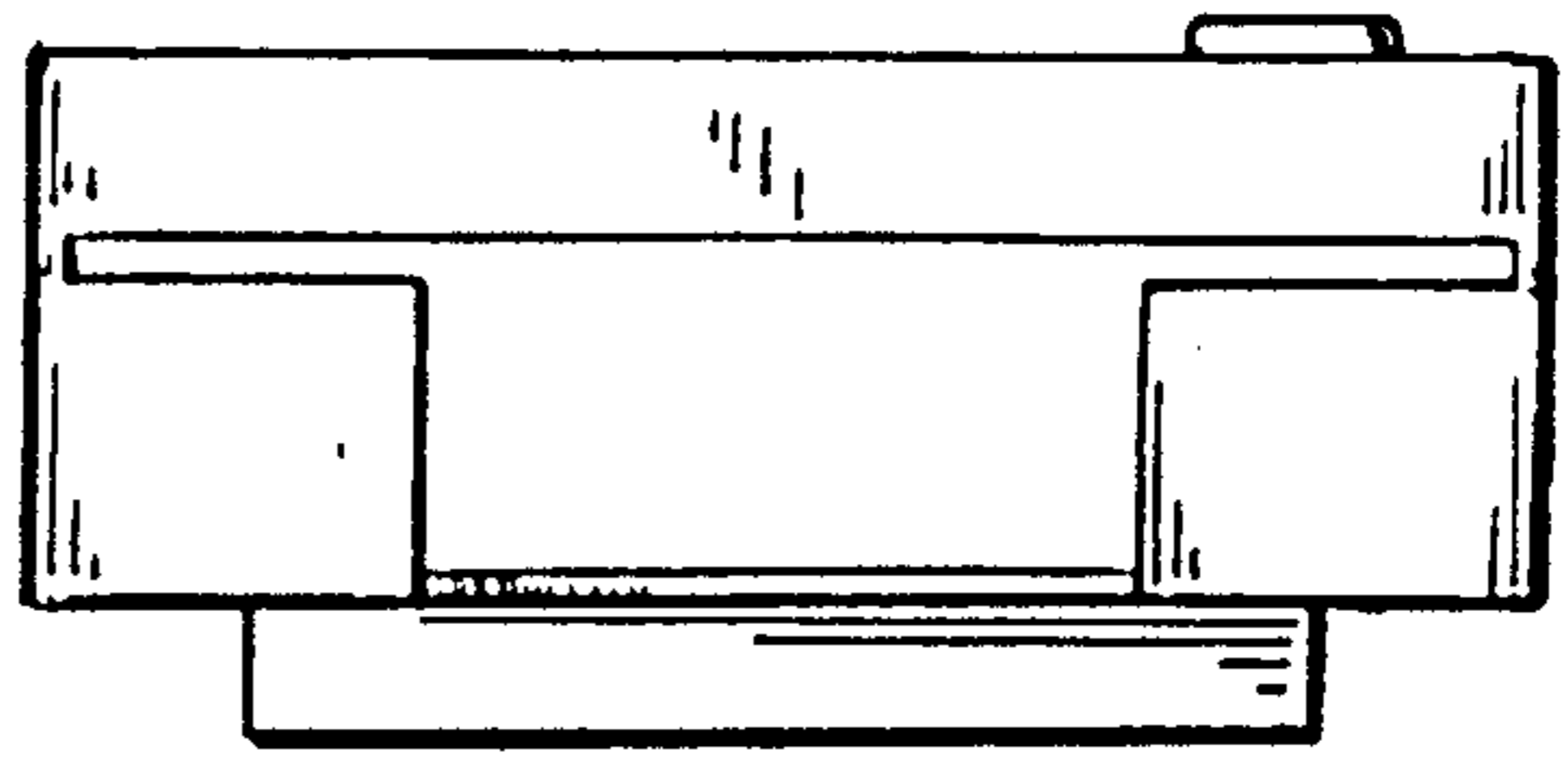

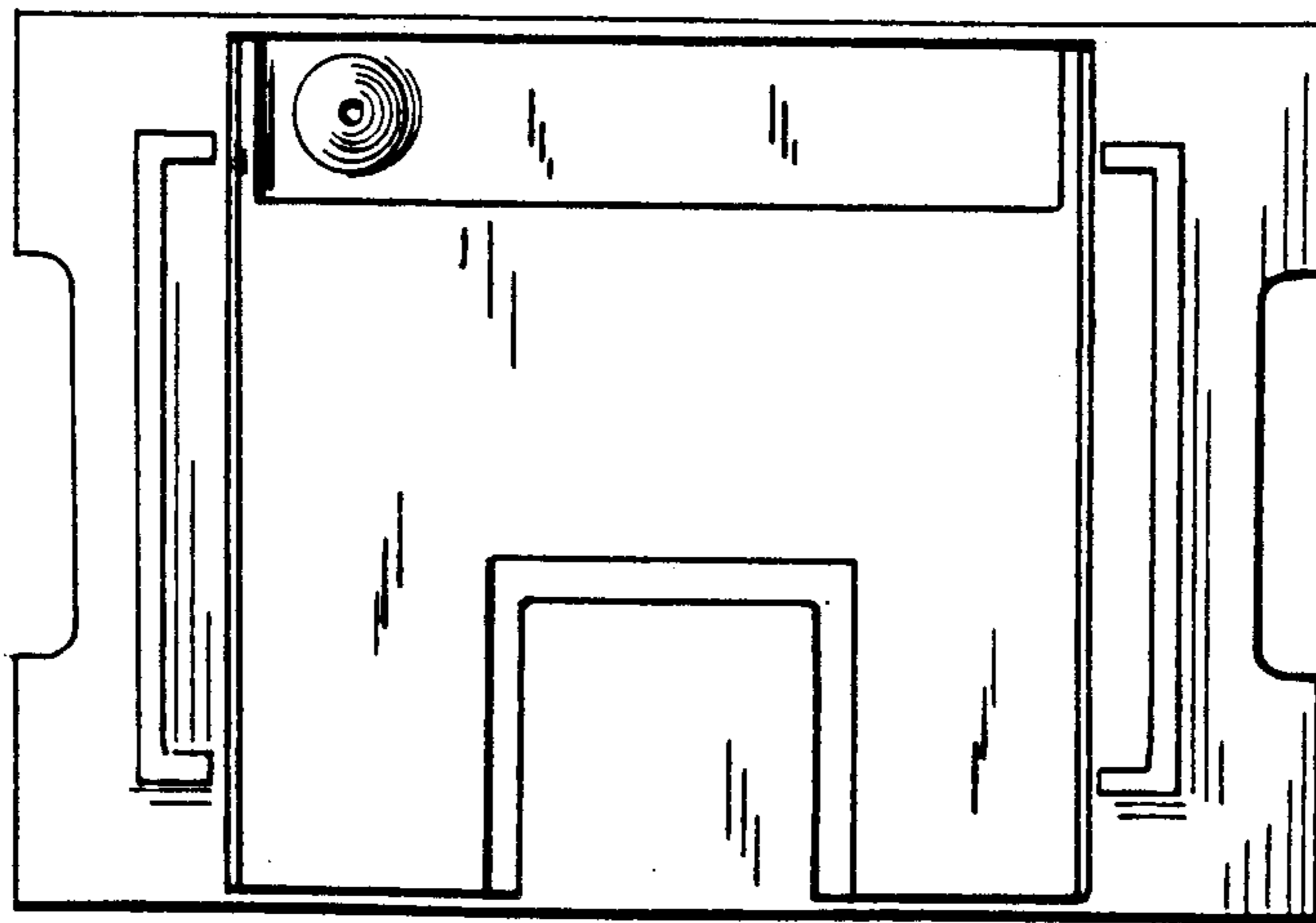

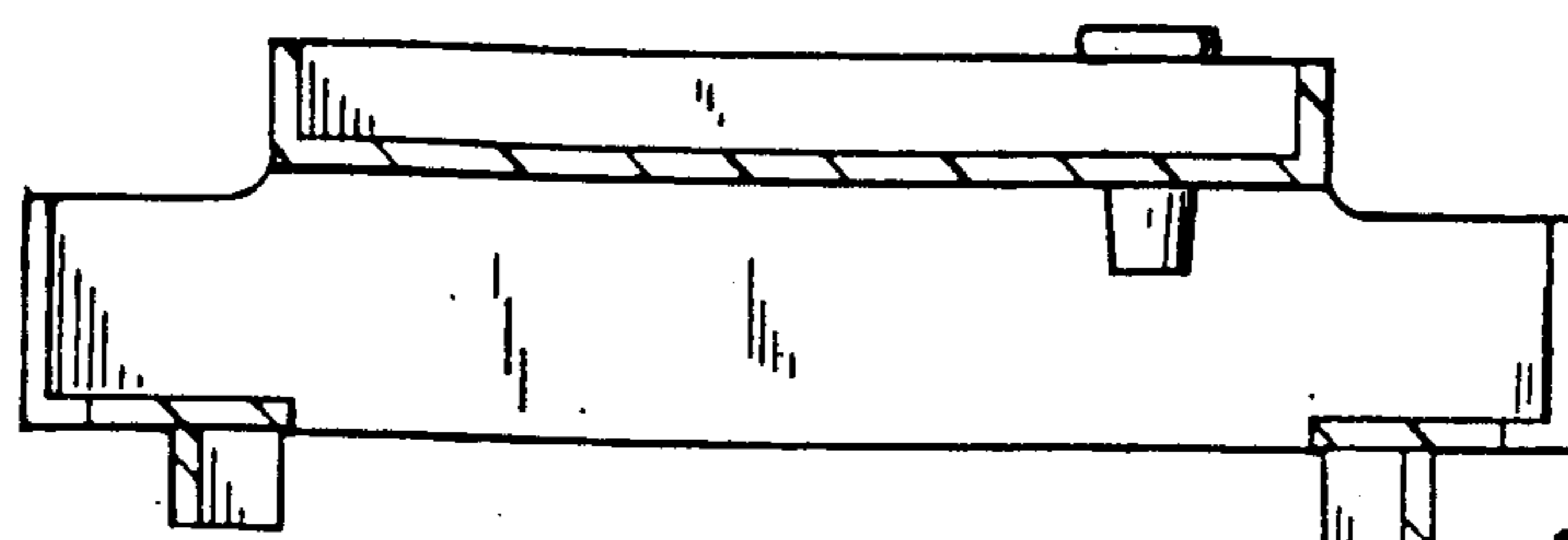
