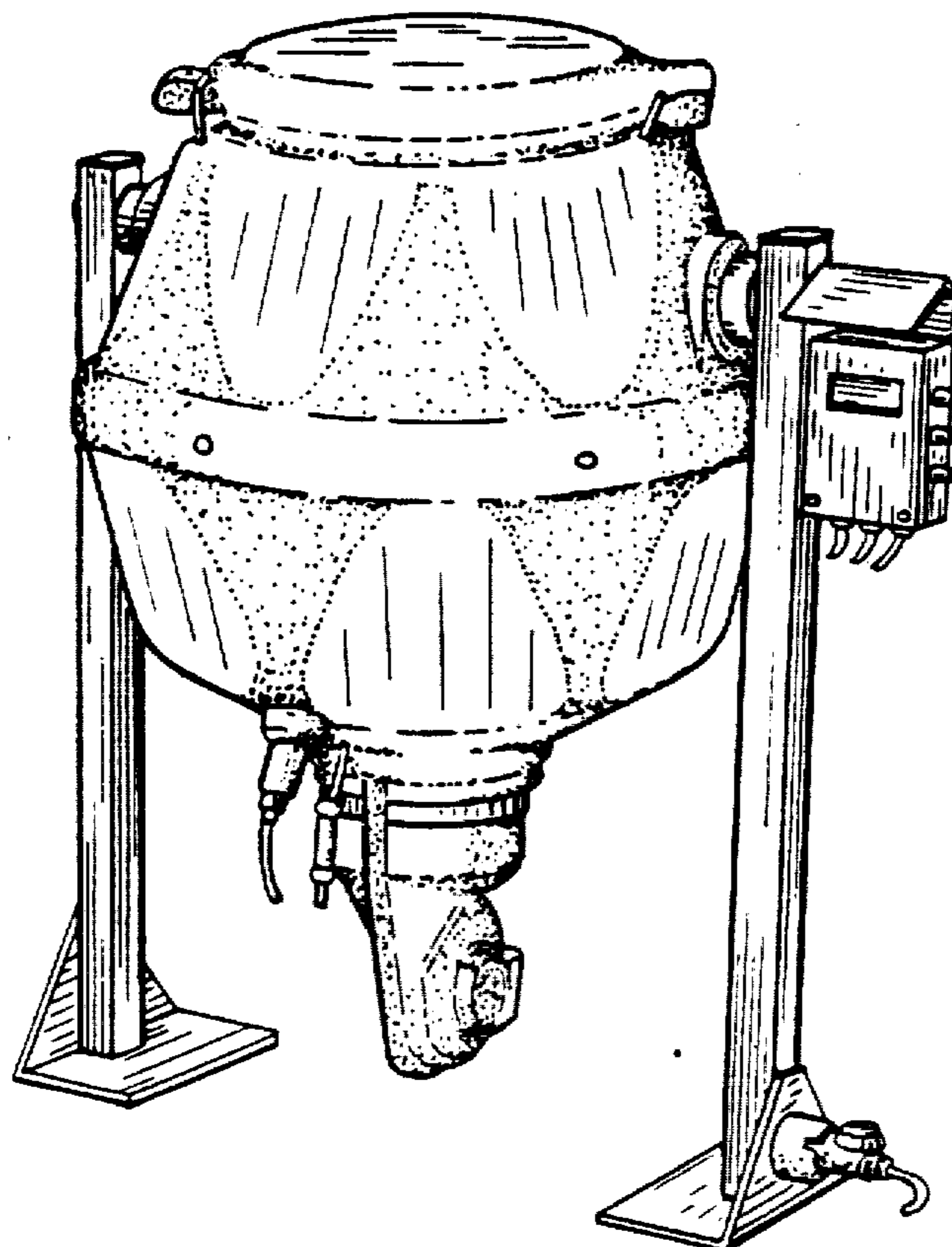

The ornamental design for a fish food dispenser, as shown and described.

DESCRIPTION

FIG. 1 is a bottom perspective view of a fish food dispenser showing my new design;
 FIG. 2 is a top perspective view thereof;
 FIG. 3 is a top perspective view of the container of the fish food dispenser with the lid removed;
 FIG. 4 is a bottom perspective view of the container of the fish food dispenser;
 FIG. 5 is a bottom perspective view of the dispenser portion of the fish food dispenser; and
 FIG. 6 is a top perspective view of the dispenser portion of the fish food dispenser.



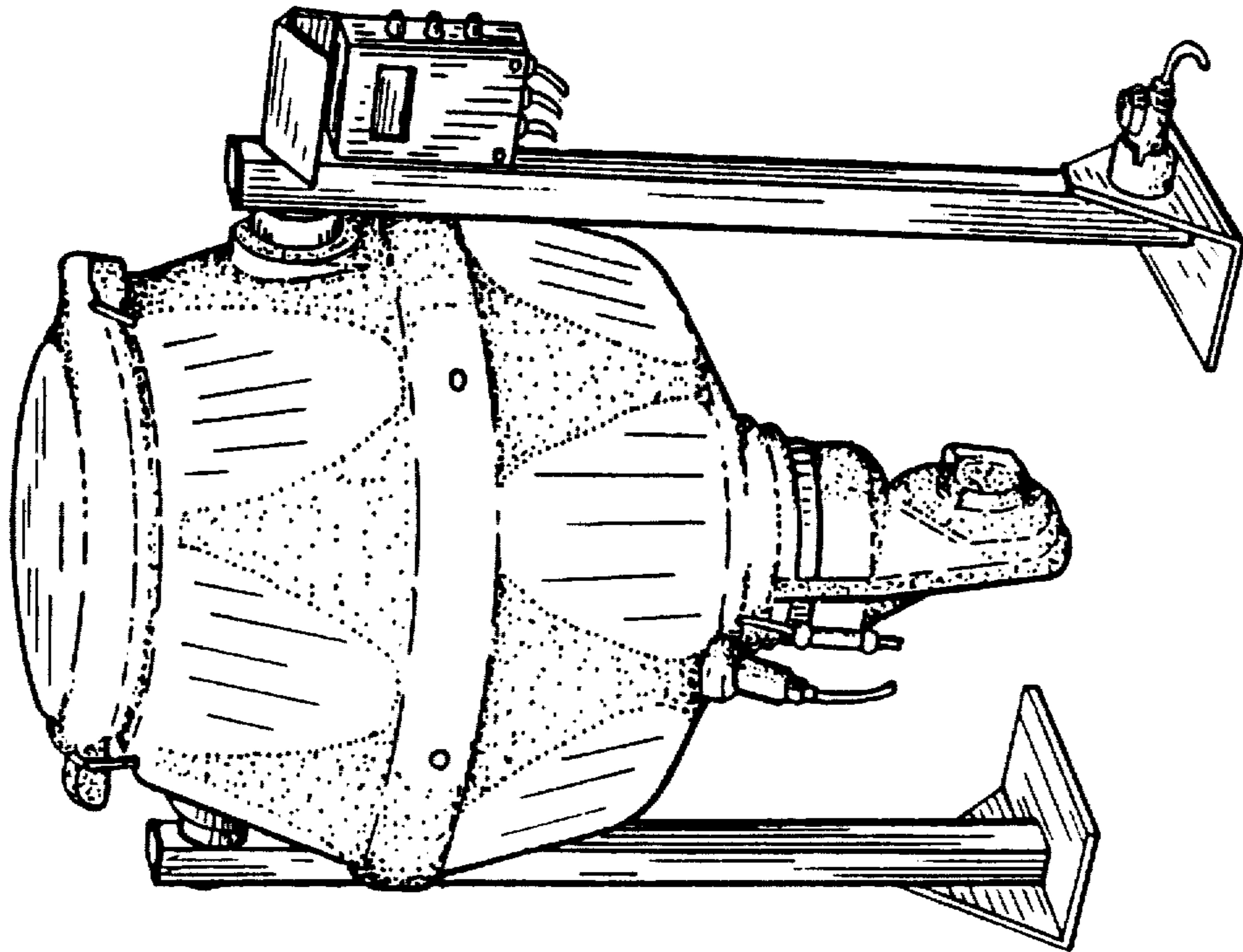

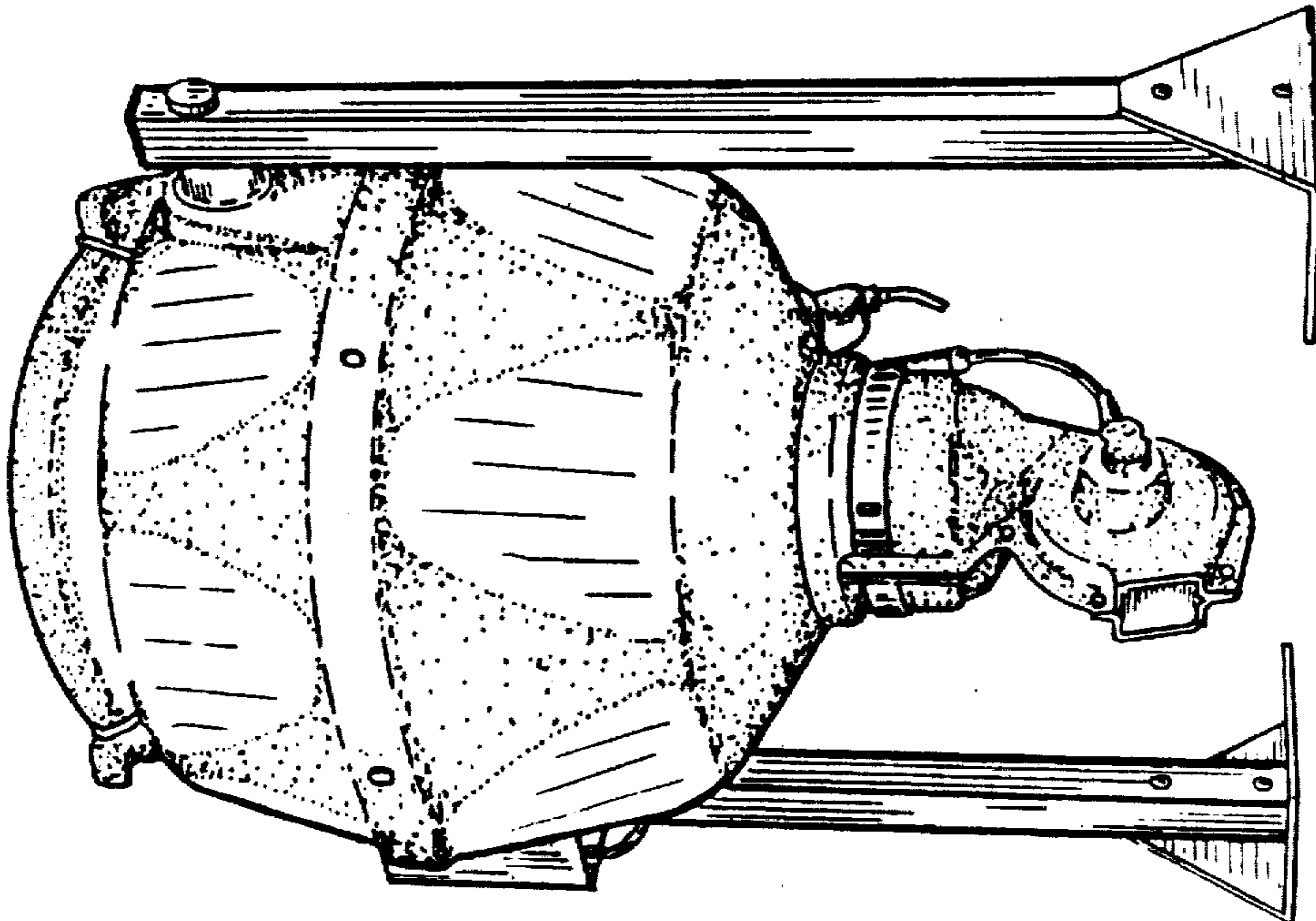

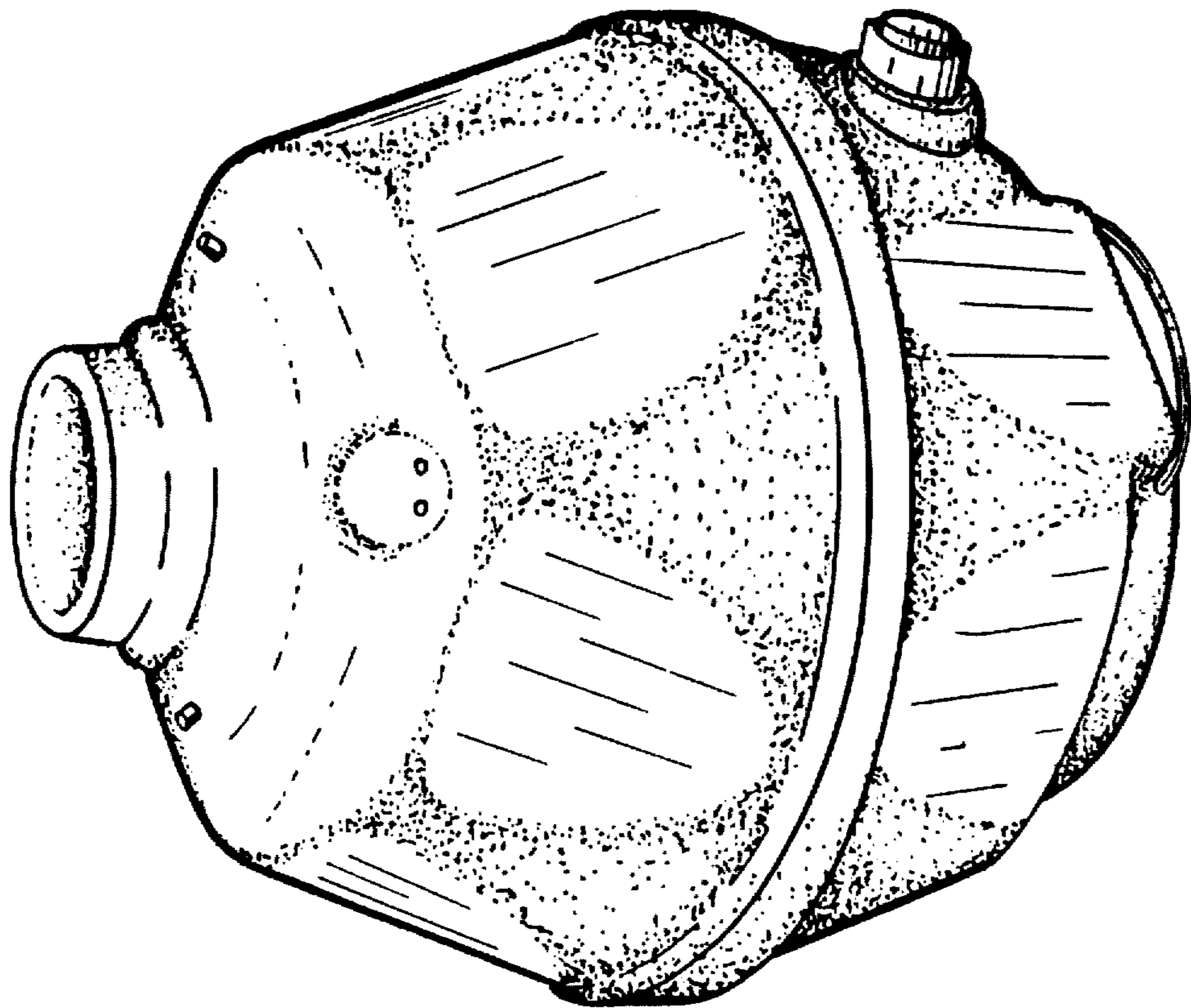

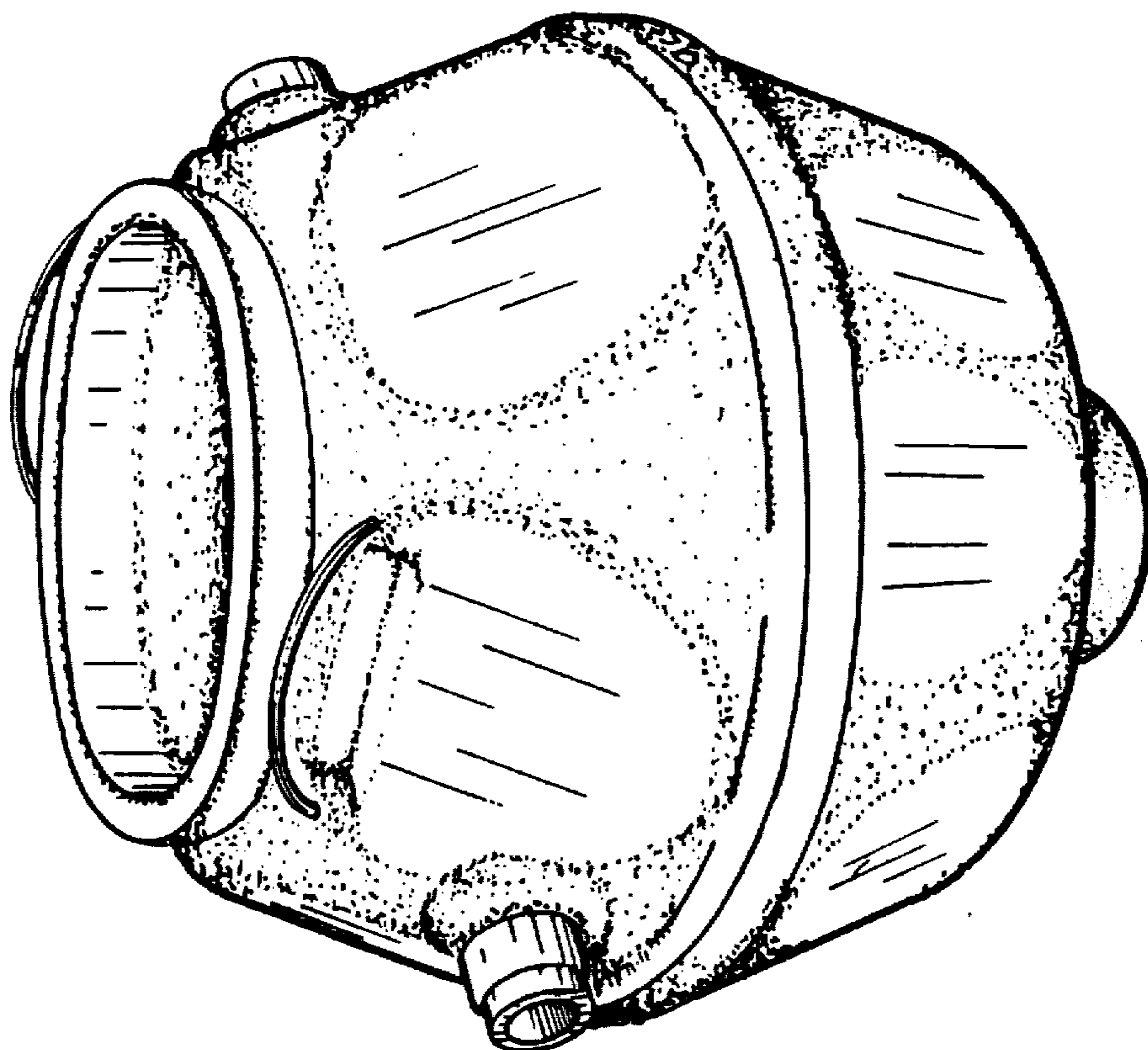

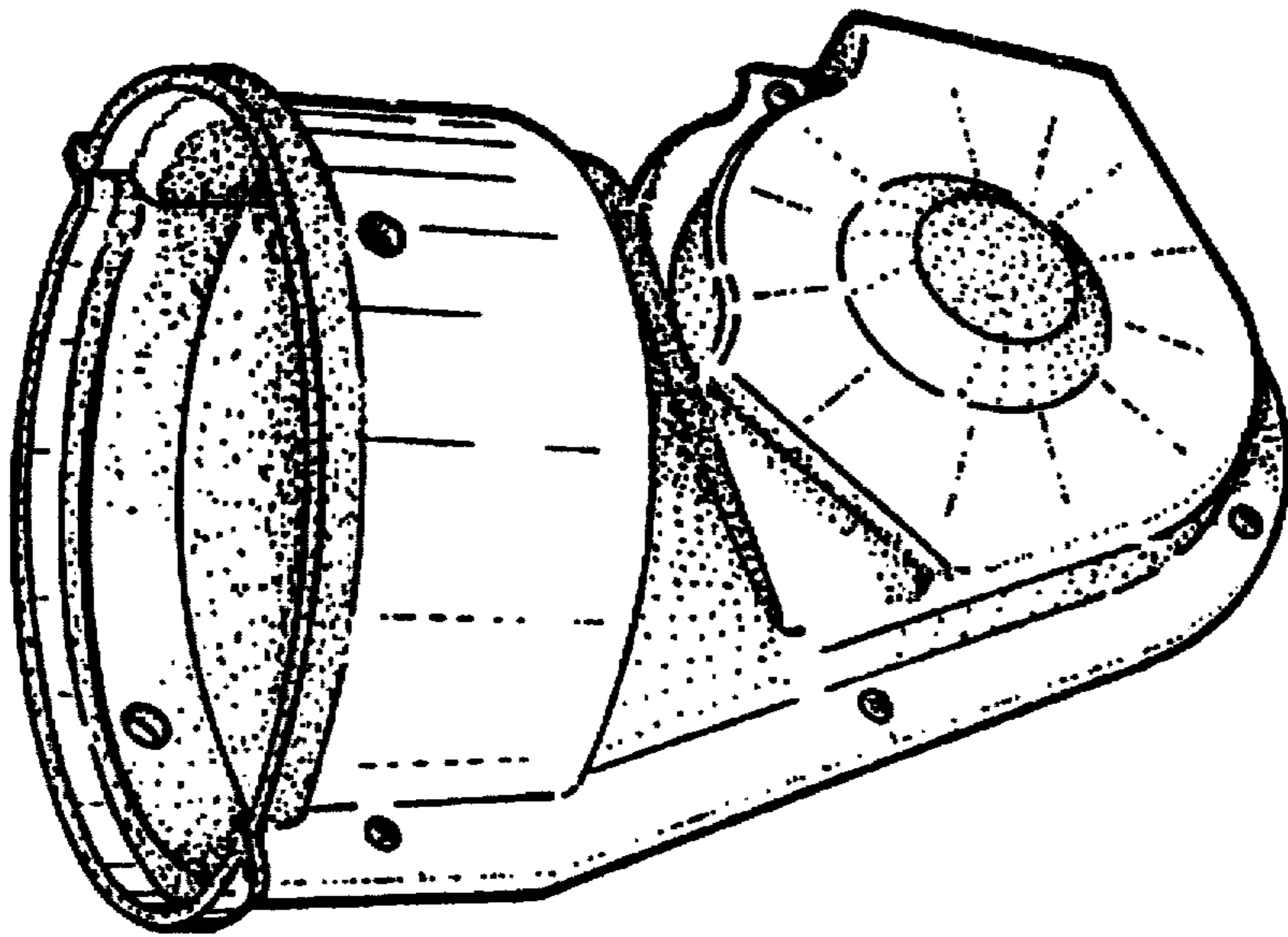

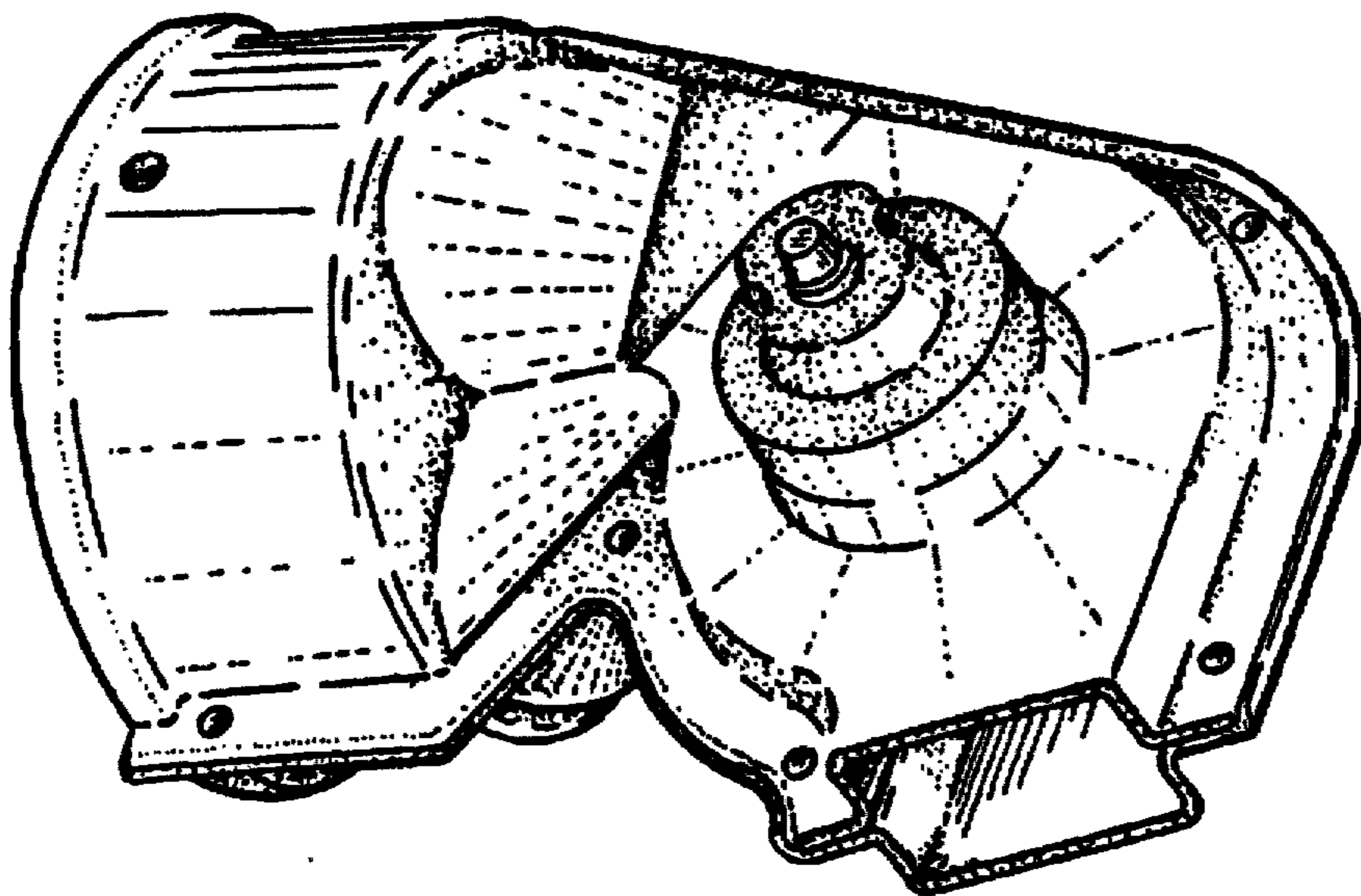
