**DESCRIPTION**

FIG. 1 is a top plan view of a food serving bowl showing our new design;

FIG. 7 is a top plan view of a food serving bowl showing a modification of our new design;


FIG. 8 is a bottom plan view of FIG. 7;



FIG. 9 is a side elevational view of FIG. 7;

FIG. 12 is an elevational view of the end opposite that shown in FIG. 11.
























