The ornamental design for a package, as shown and described.

### DESCRIPTION

FIG. 1 is an exploded sectional view of a package taken along line 1—1 of FIG. 5, showing my new design; FIG. 2 is a top plan view thereof, without cover; FIG. 3 is an exploded sectional view thereof, taken along line 3—3 of FIG. 5; FIG. 4 is a top plan view of the cover thereof; FIG. 5 is a top plan view of the combined package thereof; FIG. 6 is a front elevation of FIG. 5 thereof; FIG. 7 is a rear side elevation of FIG. 5 thereof; FIG. 8 is a right side elevation of FIG. 5 thereof; and FIG. 9 is a left side elevation of FIG. 5 thereof.

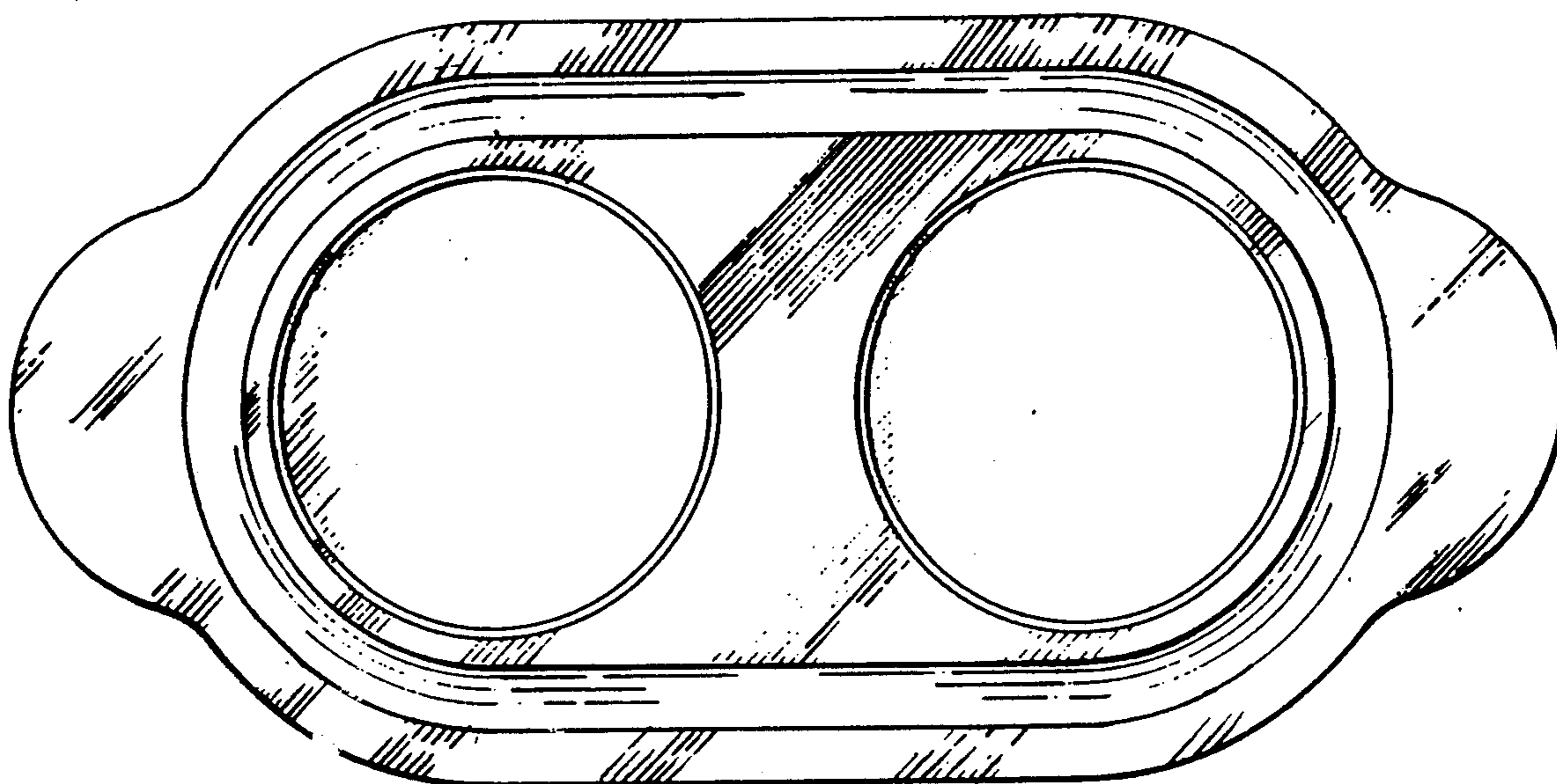
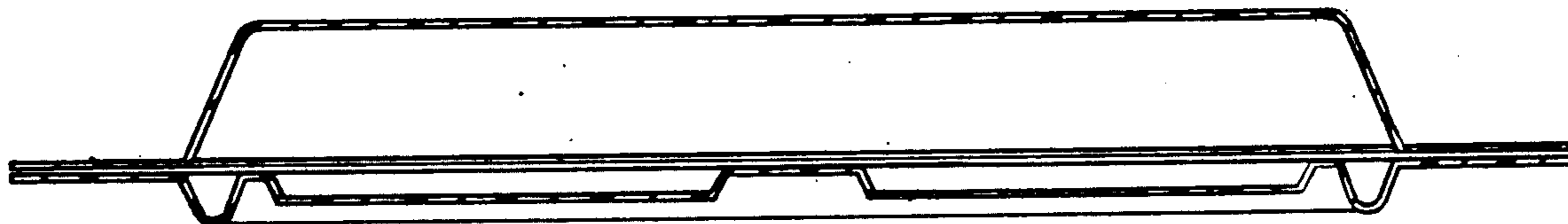

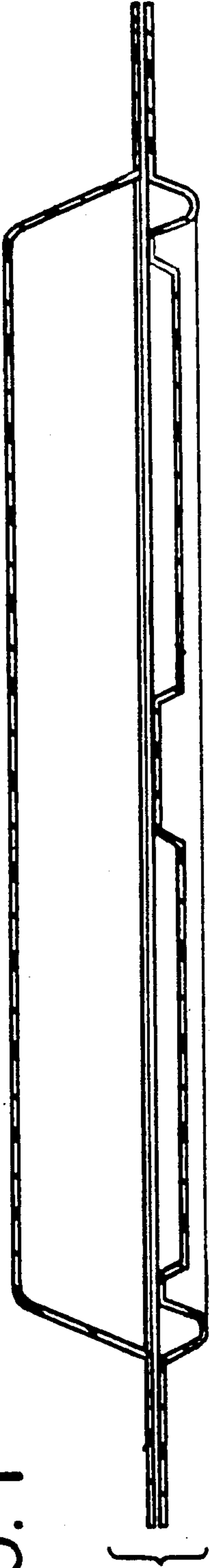
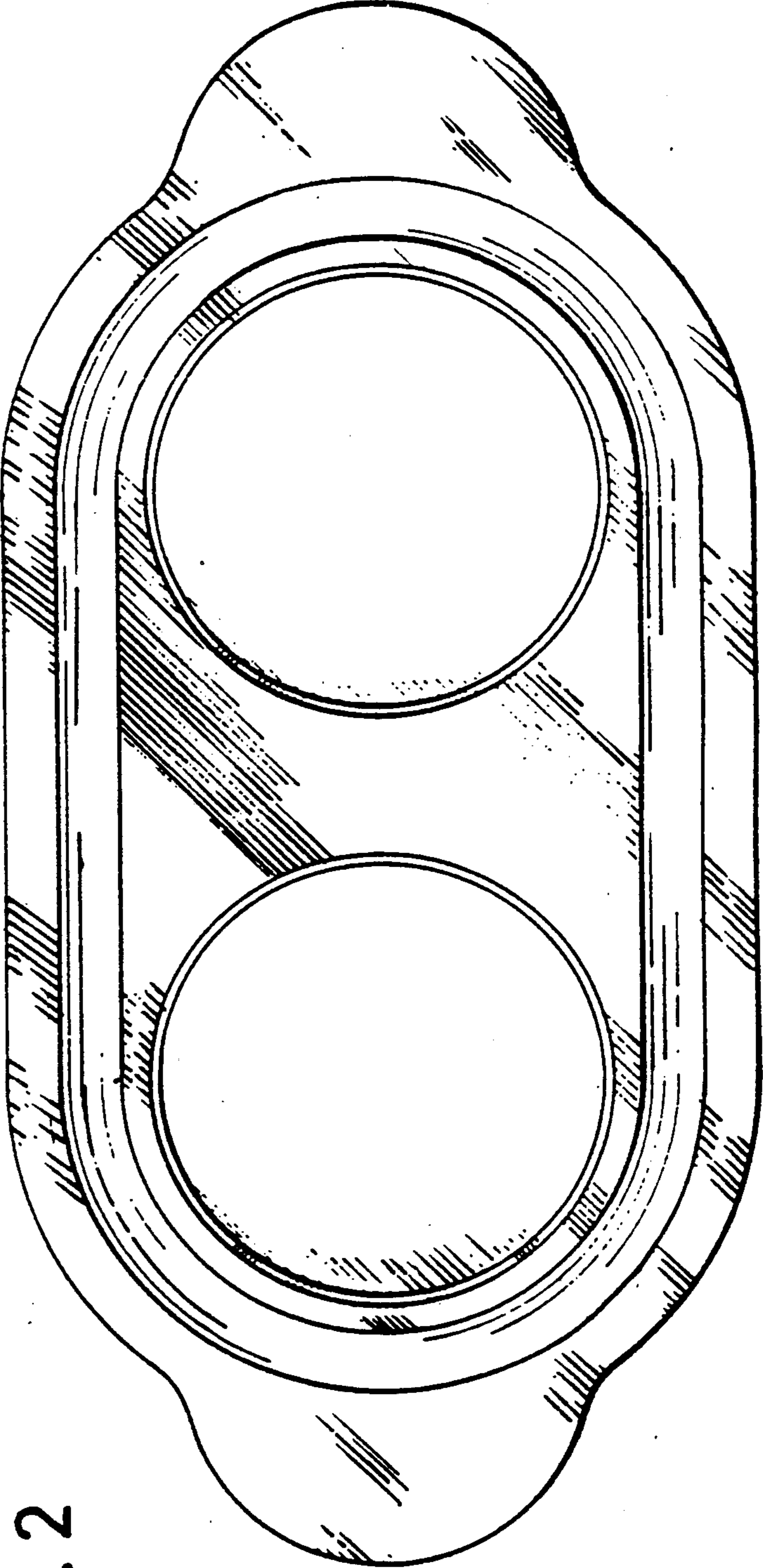

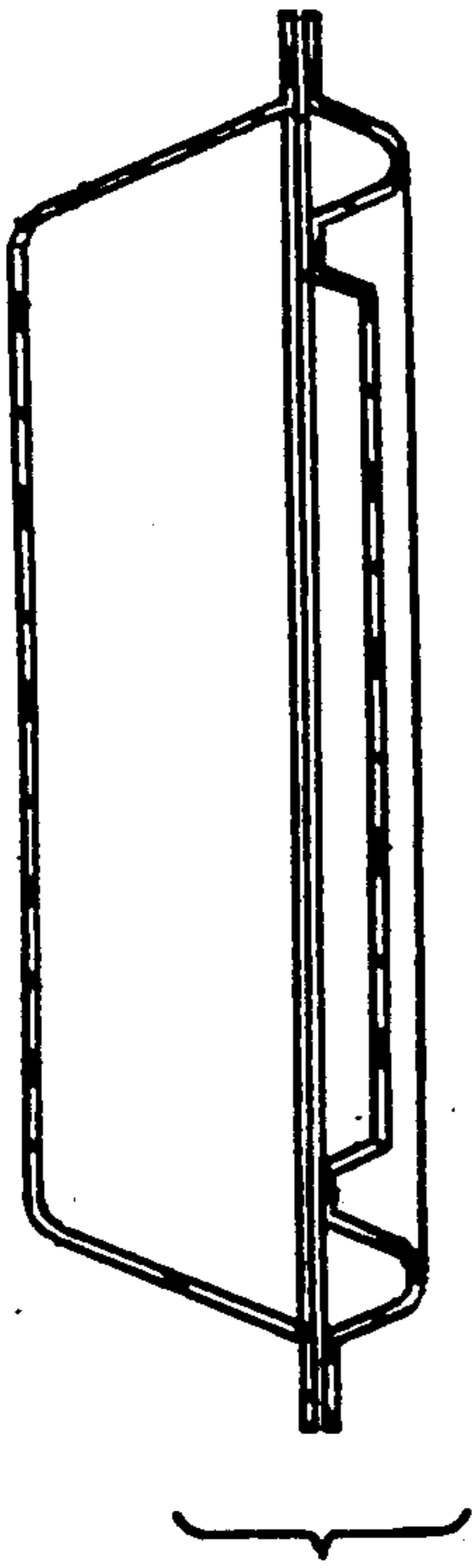

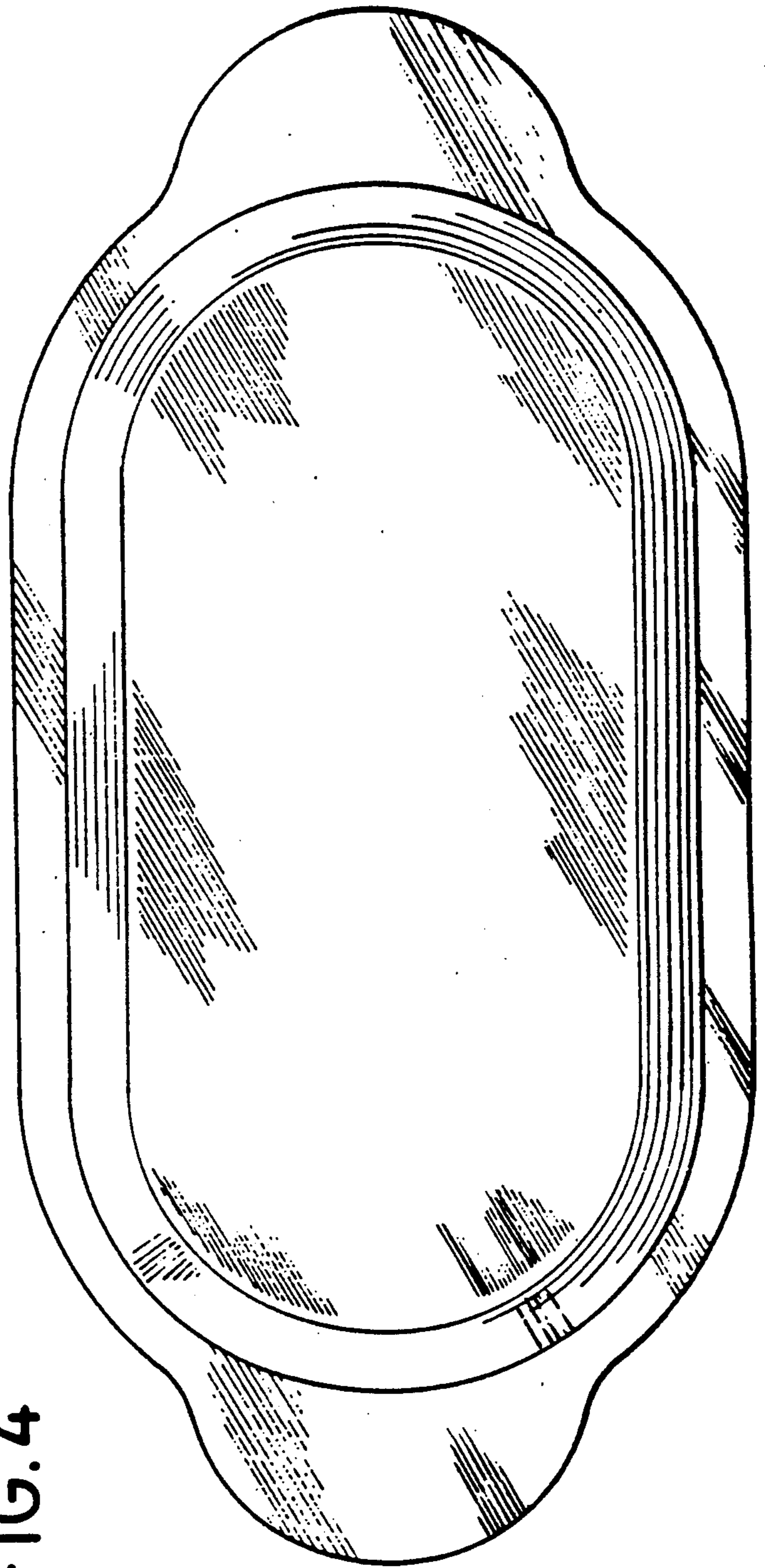

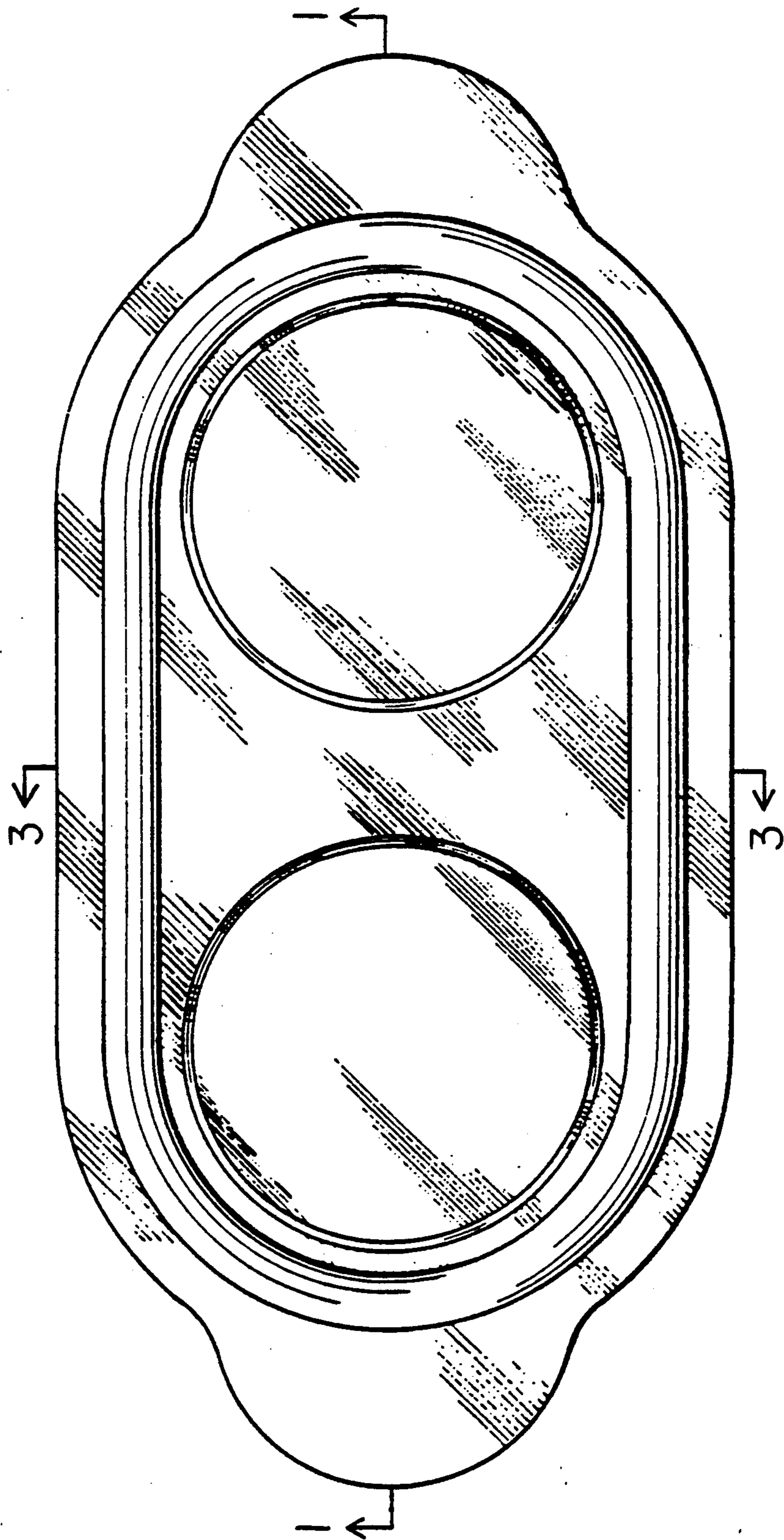

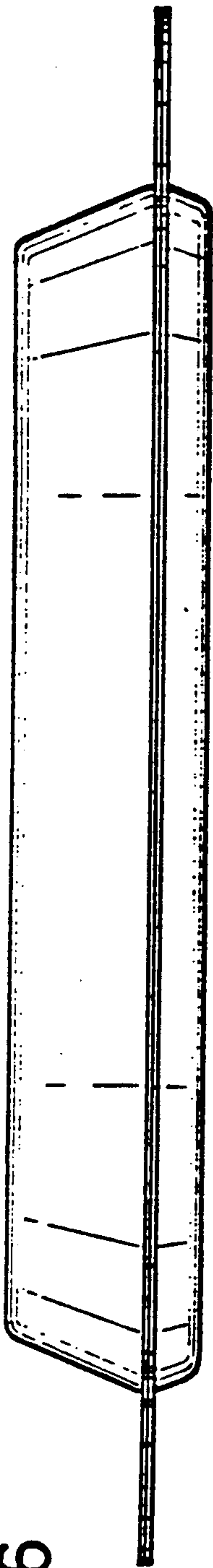

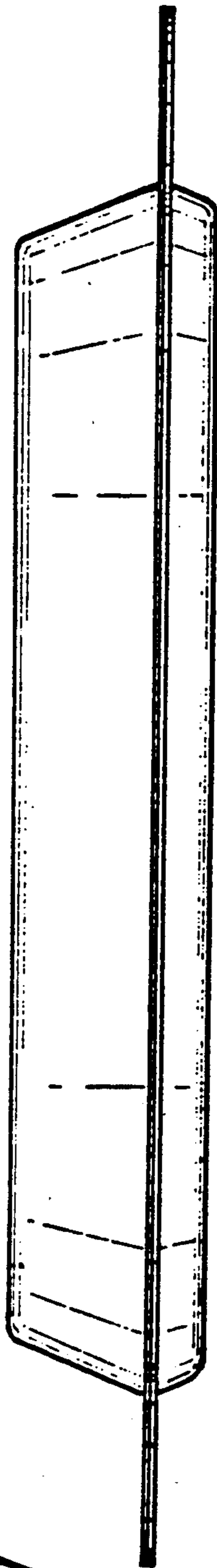

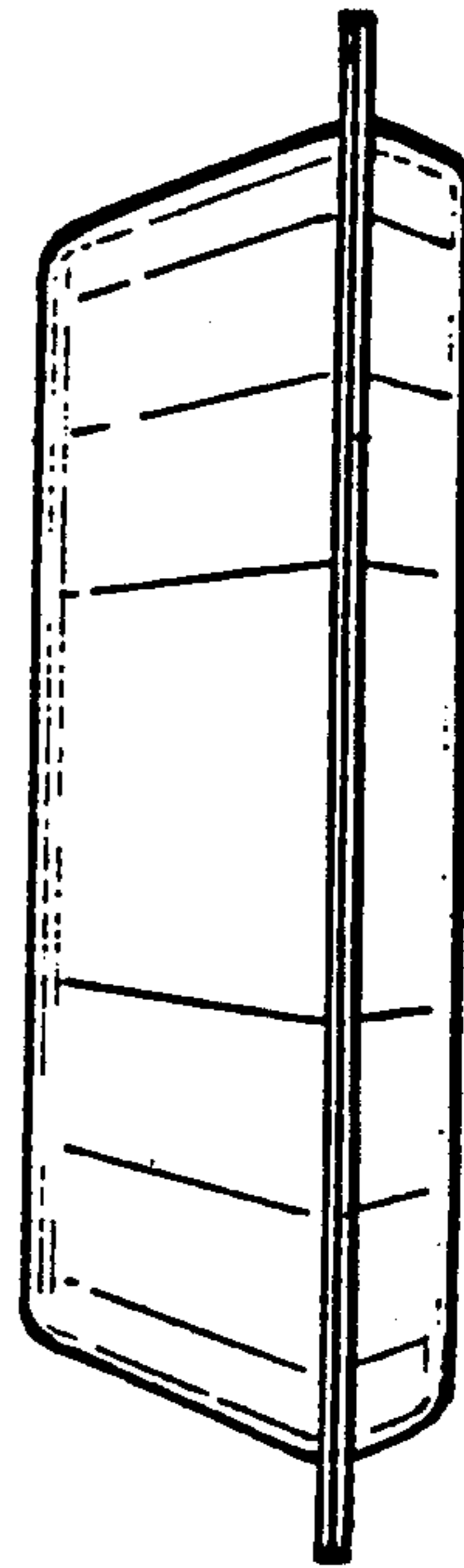
