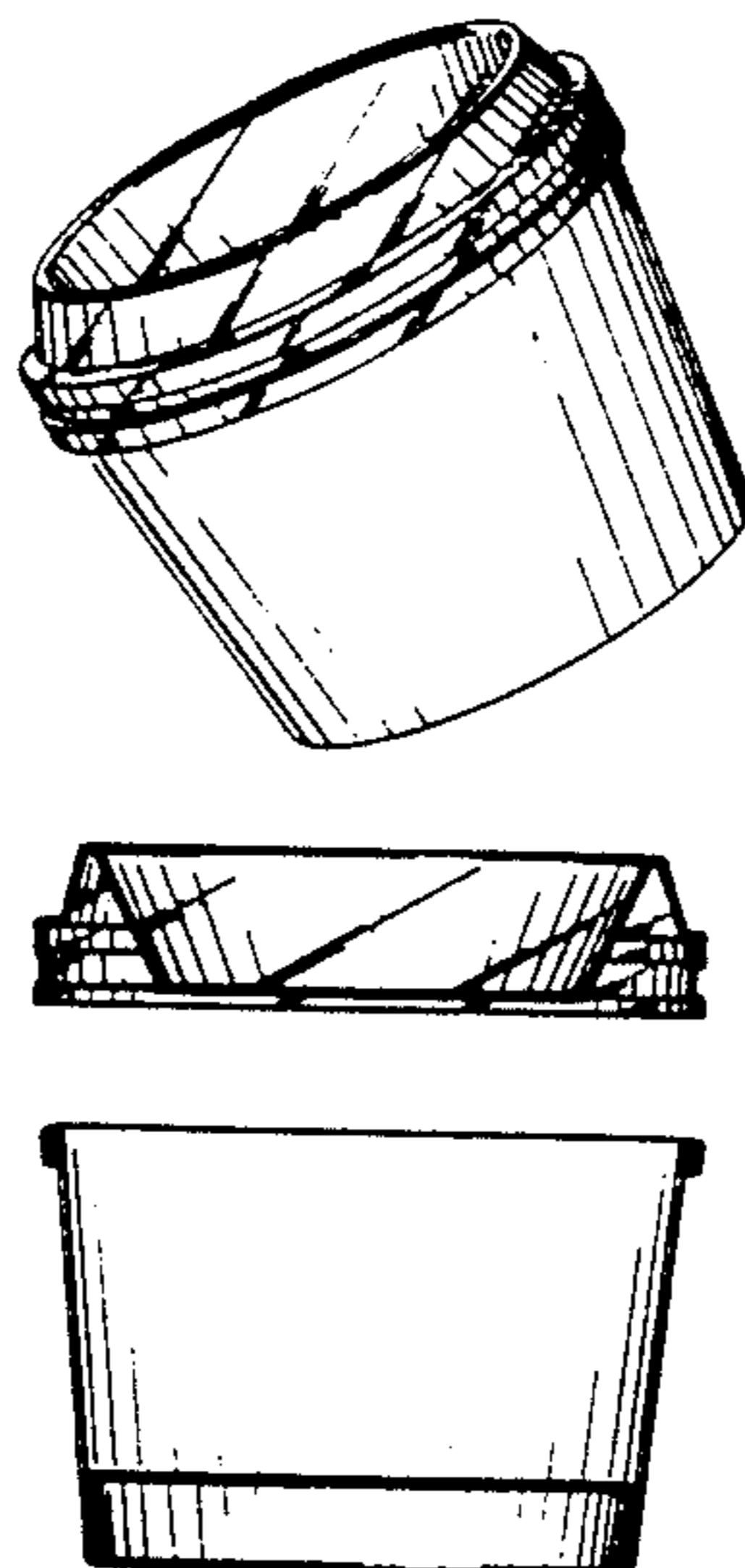

[57] **CLAIM**

The ornamental design for a combined container and closure for frozen comestibles, as shown and described.

**DESCRIPTION**

FIG. 1 is a top perspective view of a combined container and closure for frozen comestibles showing my new design;  
 FIG. 2 is a side elevational view thereof, all sides being identical;  
 FIG. 3 is a top plan view thereof;  
 FIG. 4 is a bottom plan view thereof;  
 FIG. 5 is an exploded cross-sectional view thereof.



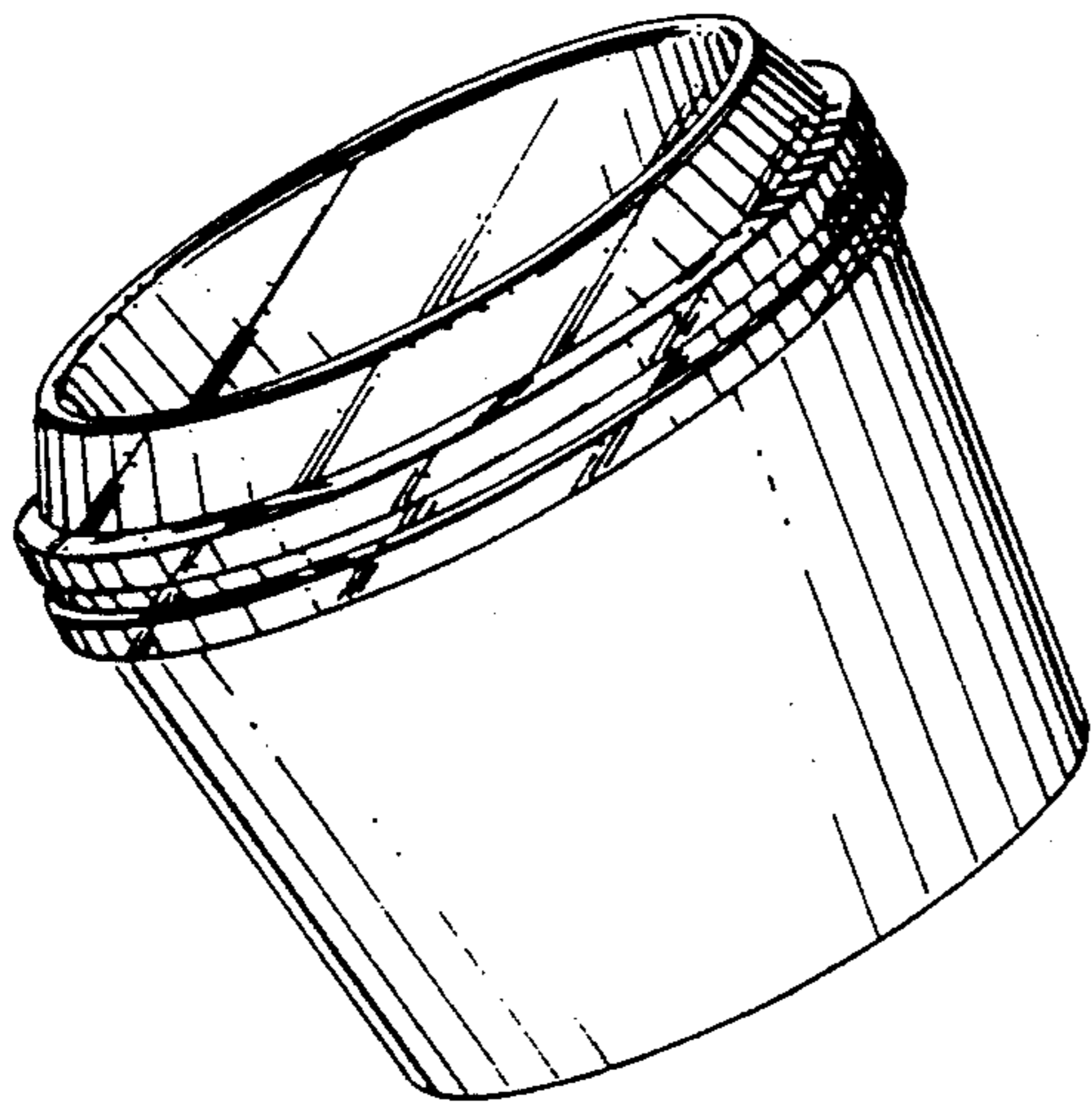

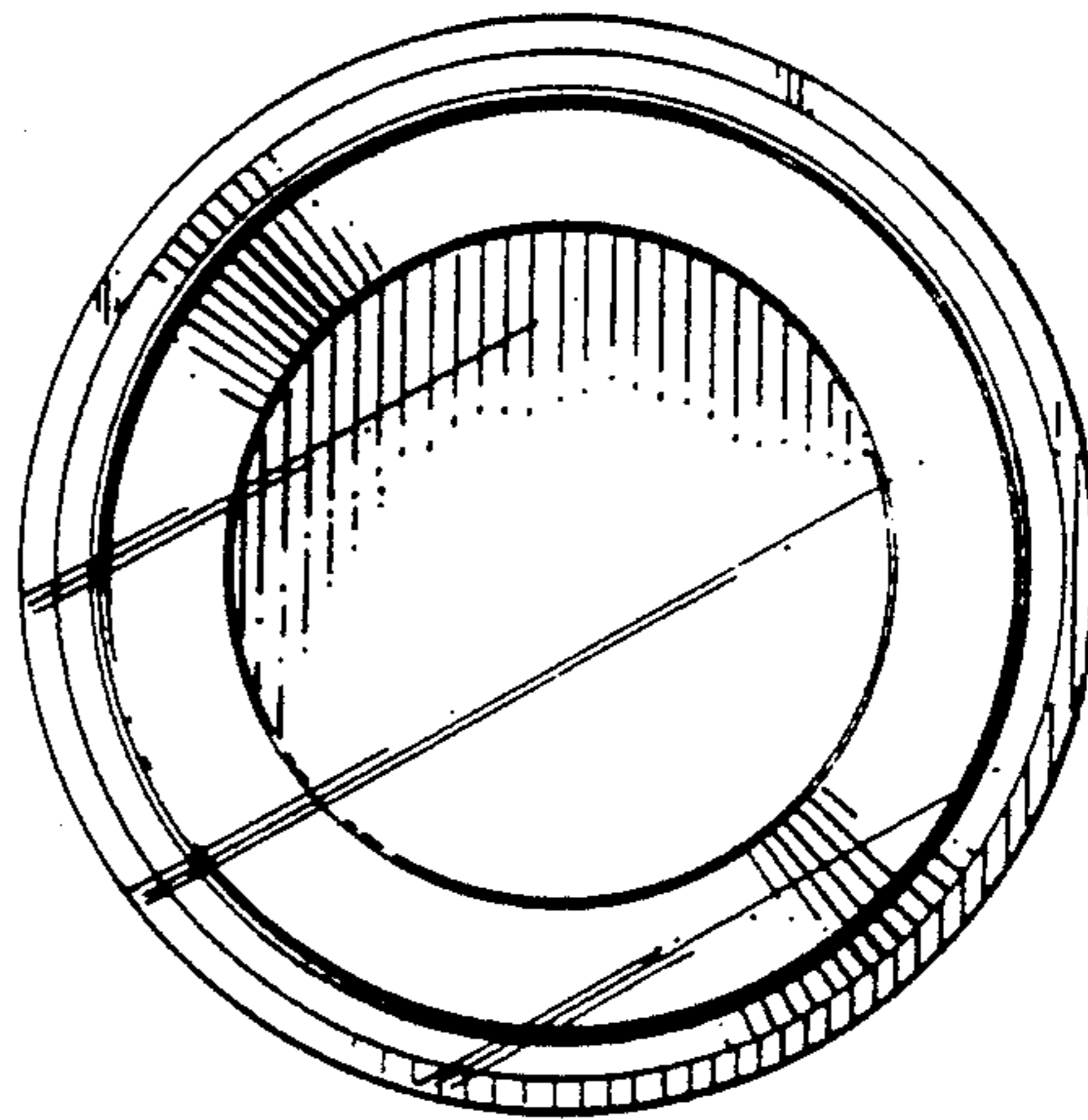

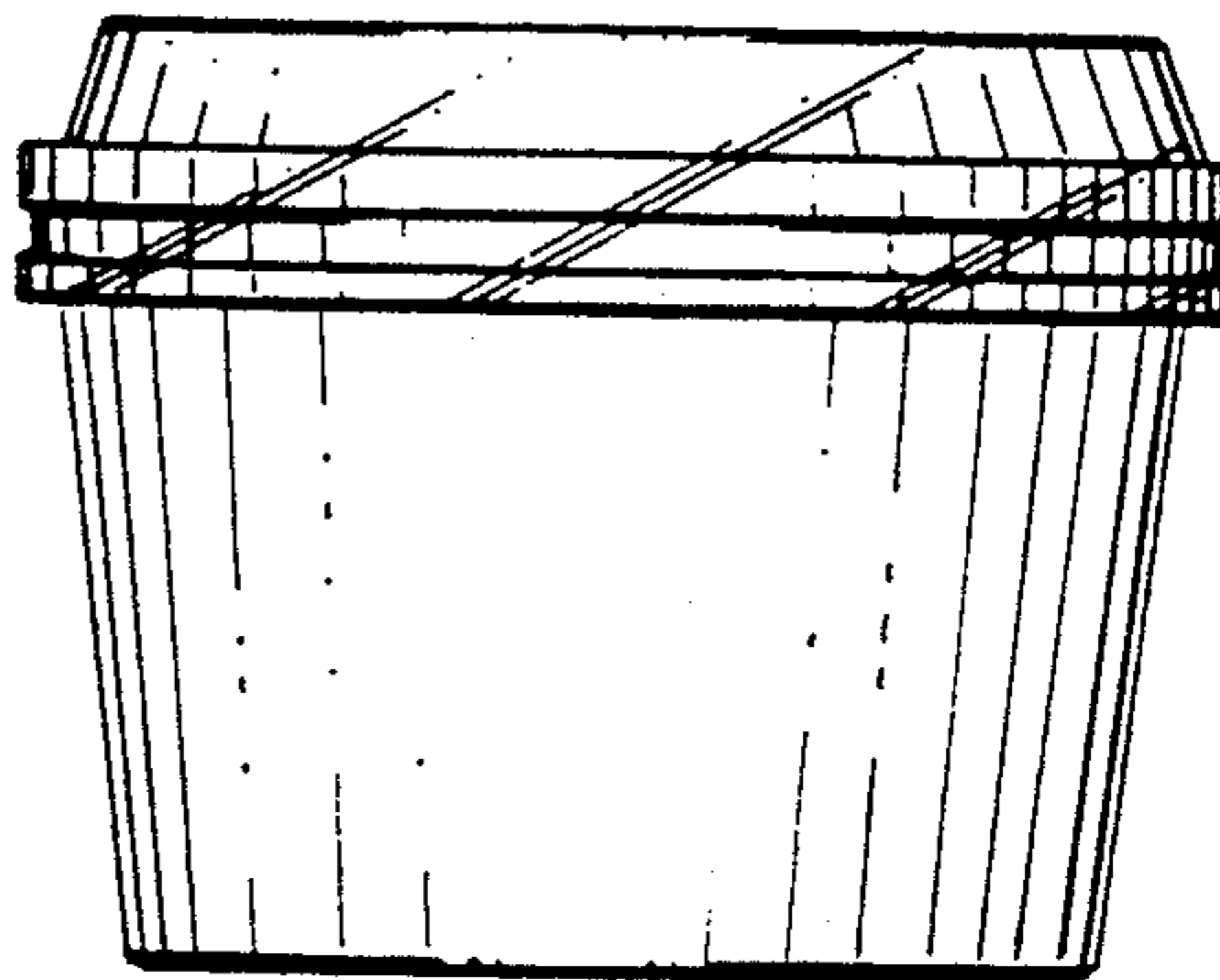

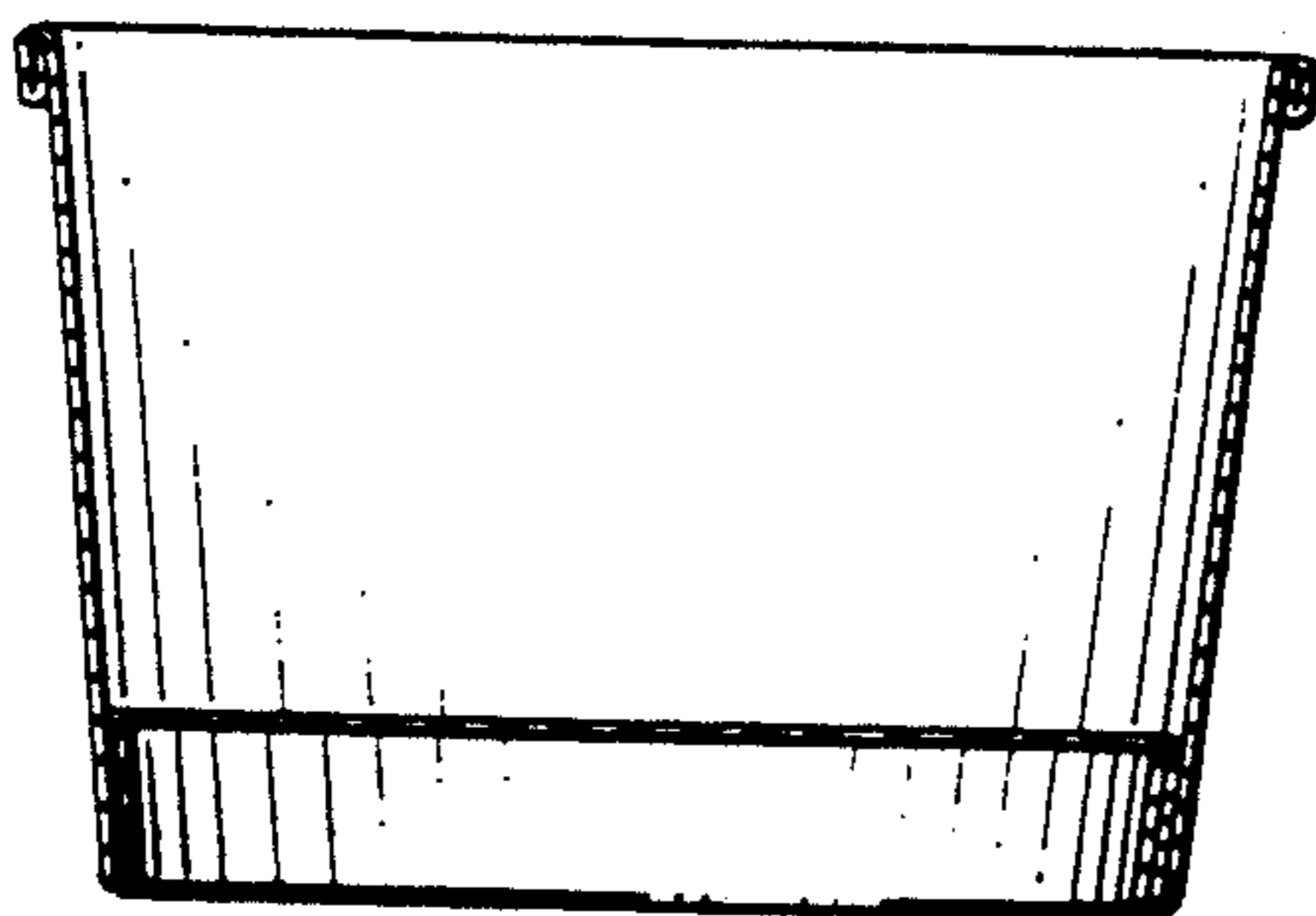
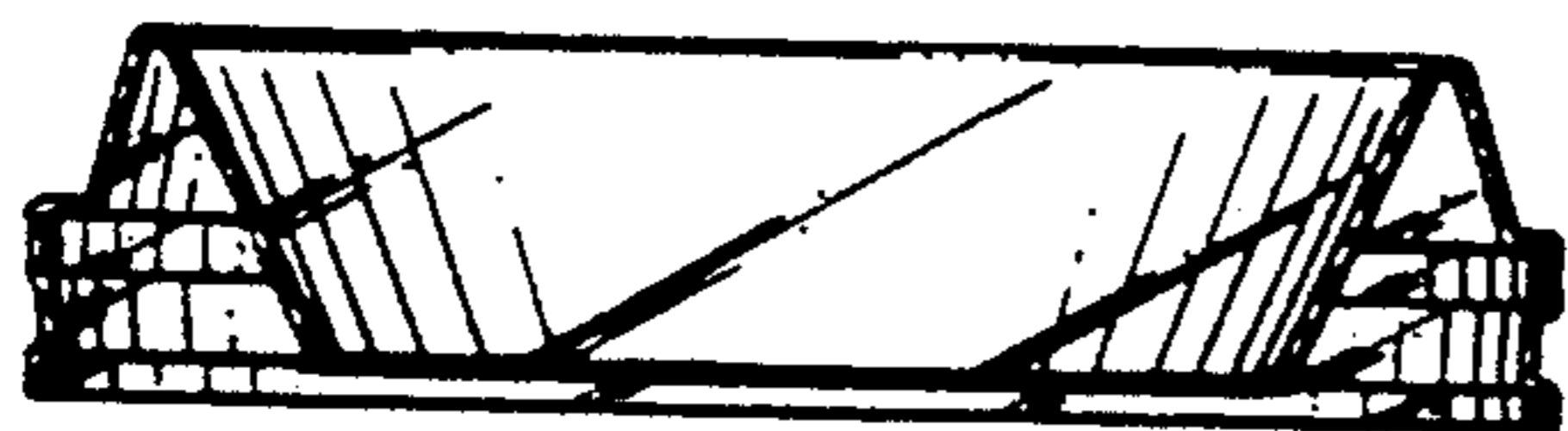

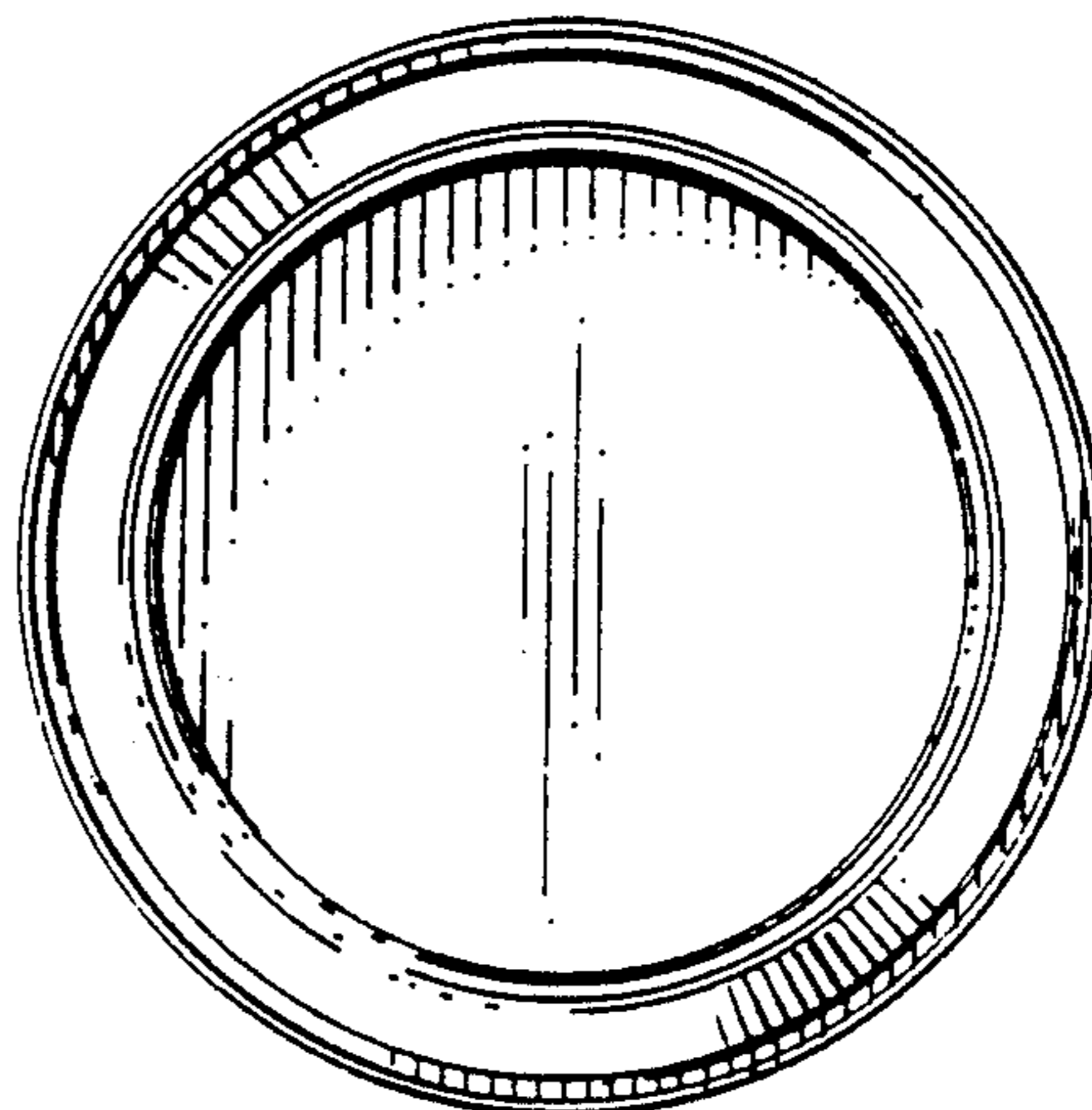
