

The ornamental design for a fuel cap, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a fuel cap showing our new design;
 FIG. 2 is a side view thereof, all sides being identical;
 FIG. 3 is a top view thereof;
 FIG. 4 is a bottom view thereof;
 FIG. 5 is a cross-sectional view thereof, taken in the direction of the arrows along line 5—5 of FIG. 3;
 FIG. 6 is a perspective view of a second embodiment of FIG. 1,
 FIG. 7 is a side view of FIG. 6, all side being identical;
 FIG. 8 is a top view of FIG. 6;
 FIG. 9 is a bottom view of FIG. 6;
 FIG. 10 is a cross-sectional view of FIG. 6, taken in the direction of the arrows along line 10—10 of FIG. 8;
 FIG. 11 is a perspective view of a third embodiment of FIG. 1;
 FIG. 12 is a side view of FIG. 11, all sides being identical;
 FIG. 13 is a top view of FIG. 11;
 FIG. 14 is a bottom view of FIG. 11;
 FIG. 15 is a cross-sectional view of FIG. 11, taken in the direction of the arrows along line 15—15 of FIG. 13.































