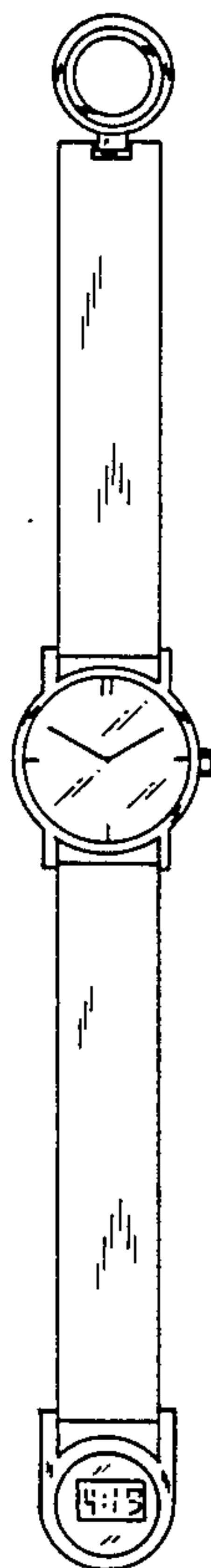

The ornamental design for a wristwatch and strap, as shown and described.

DESCRIPTION

FIG. 1 is a front elevational view of a wristwatch and strap showing my new design;
FIG. 2 is a rear elevational view;
FIG. 3 is a right side elevational view, the left side elevational view being a mirror image;
FIG. 4 is a front elevational view of a second embodiment of FIGS. 1-3 of my new design;
FIG. 5 is a rear elevational view;
FIG. 6 is a right side elevational view, the left side elevational view being a mirror image;
FIG. 7 is a front elevational view of a third embodiment of FIGS. 1-3 of my new design;
FIG. 8 is a rear elevational view;

FIG. 12 is a right side elevational view thereof, the left side elevational view.



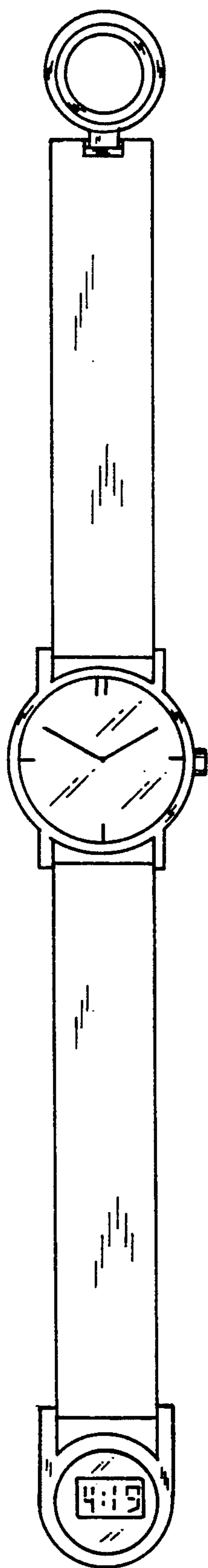

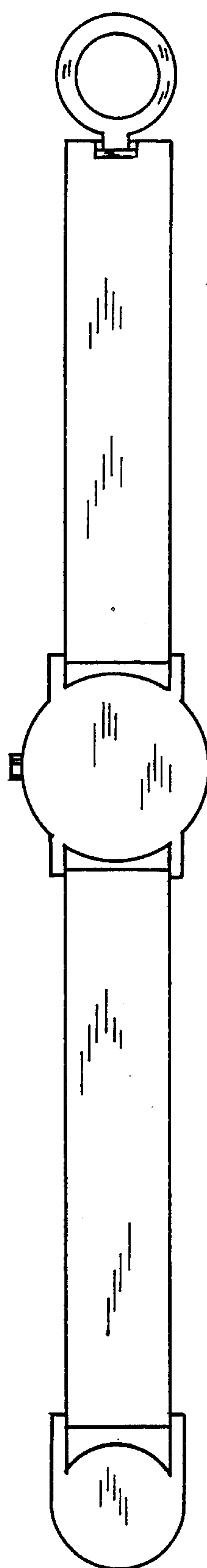

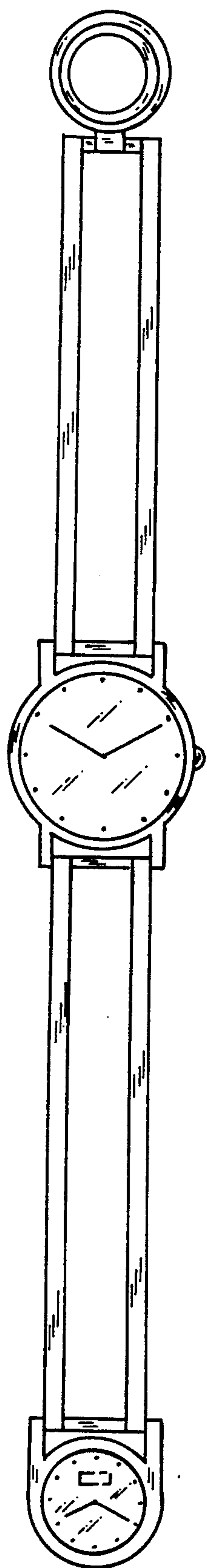

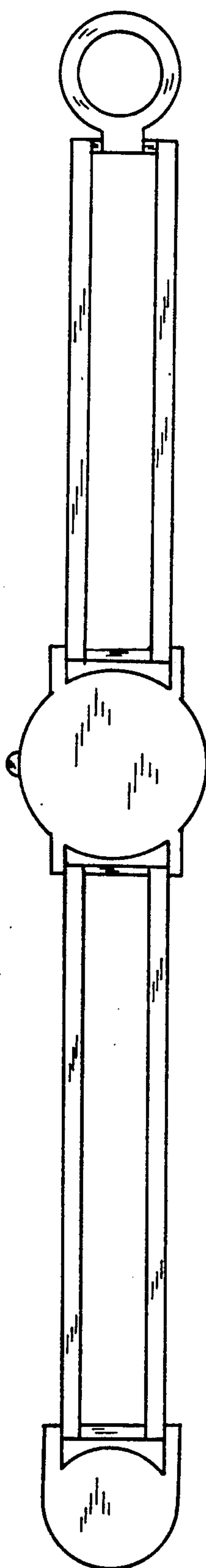

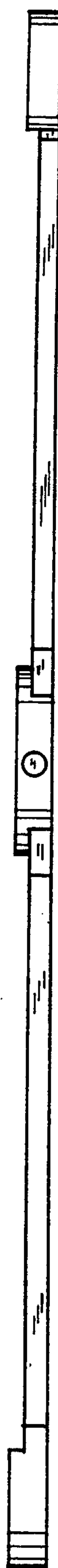

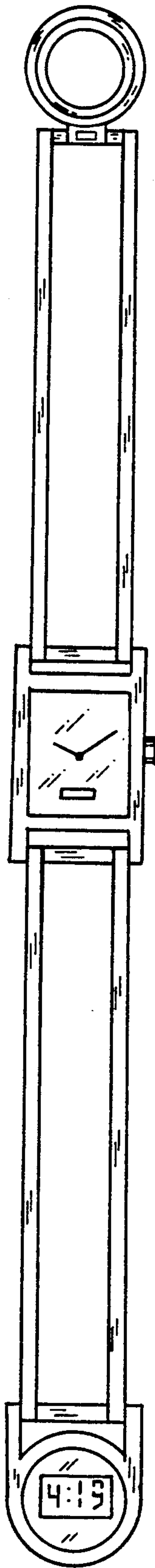

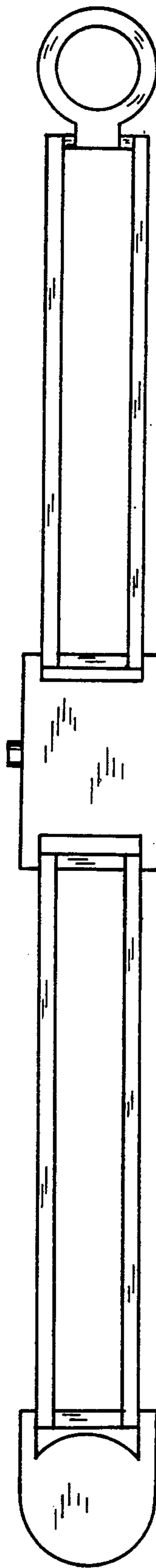

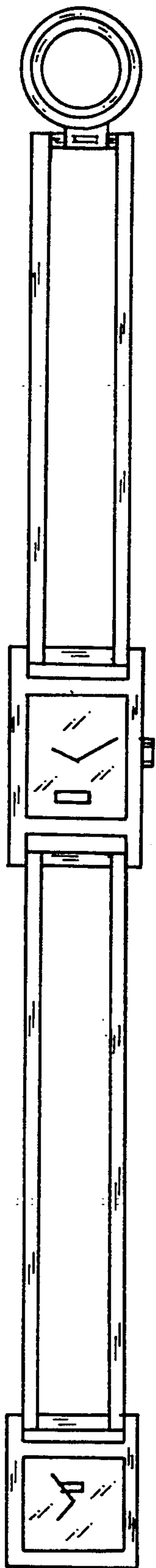

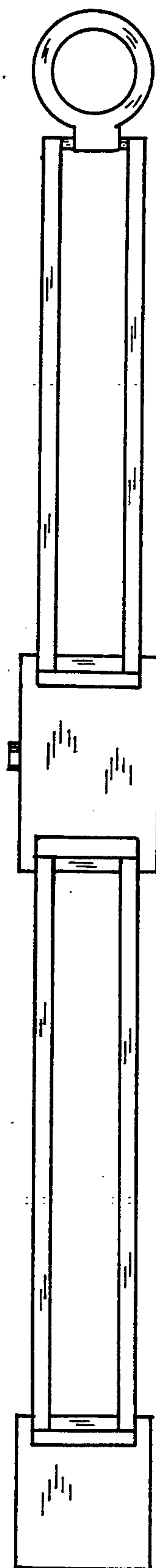
