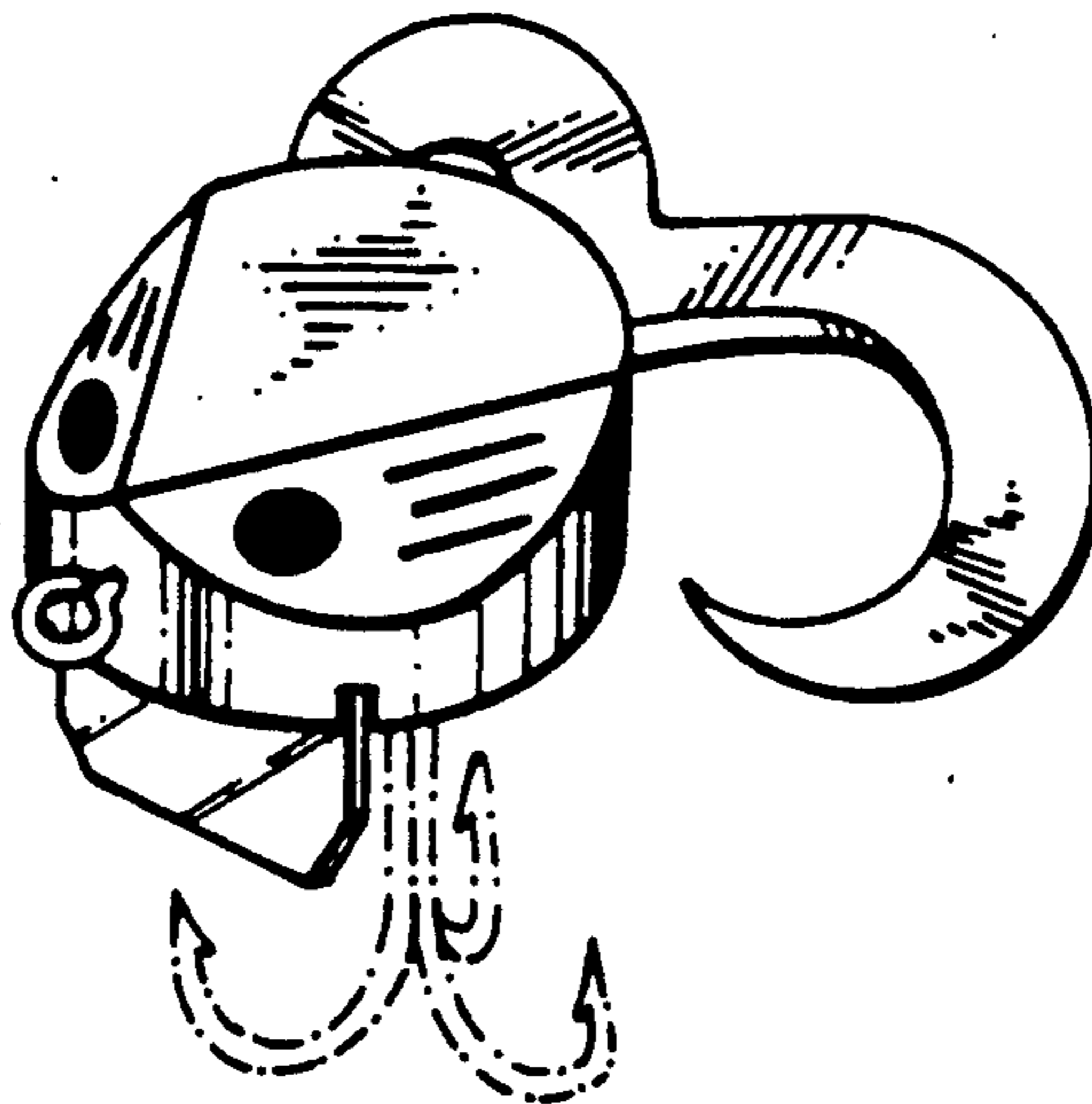

[57] CLAIM

The ornamental design for a fishing lure, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a fishing lure, showing our new design;
FIG. 2 is a front elevational view thereof;
FIG. 3 is a top plan view thereof;
FIG. 4 is a left side elevational view, the right side being a mirror image thereof;
FIG. 5 is a bottom plan view thereof;
FIG. 6 is a perspective view of a second embodiment;
FIG. 7 is a top plan view thereof;
FIG. 8 is a left side elevational view, the right side being a mirror image thereof;
FIG. 9 is a perspective view of a third embodiment;
FIG. 10 is a top plan view thereof; and
FIG. 11 is a left side elevational view, the right side being a mirror image thereof.
The broken line showing of a hook in FIGS. 1, 2, 4, 5, 6, and 7 is for illustrative purposes only and forms no part of the claimed design.



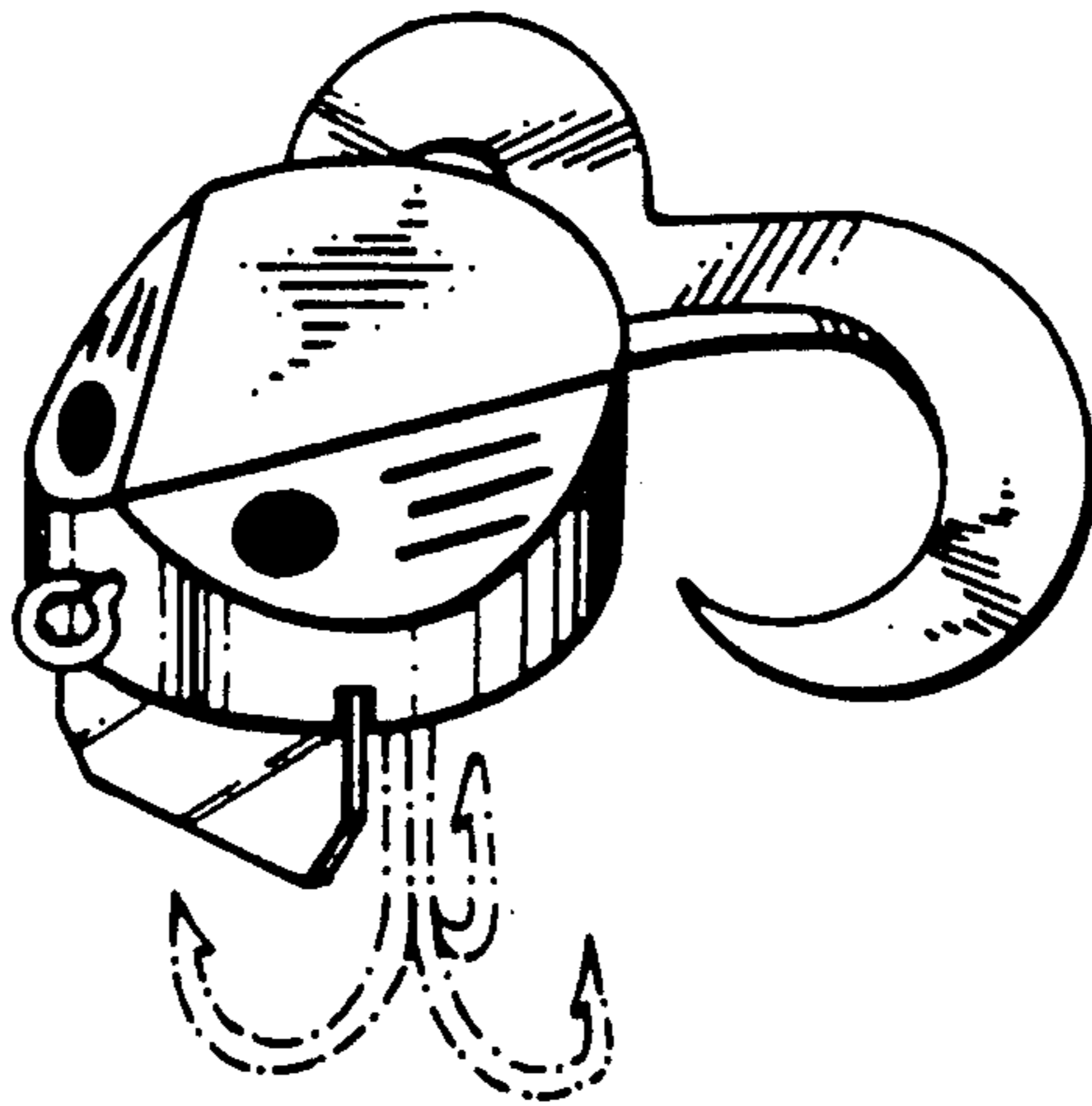

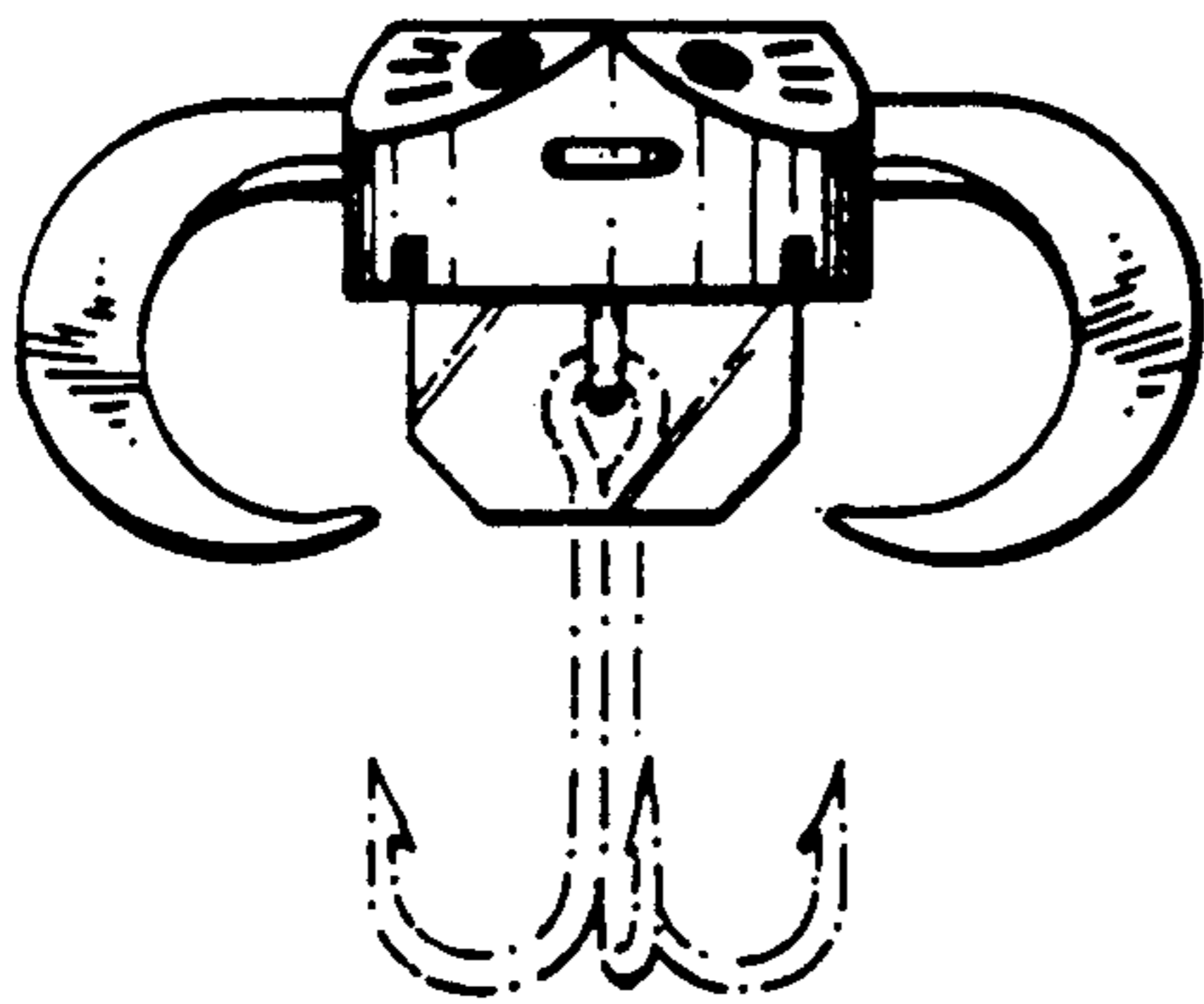

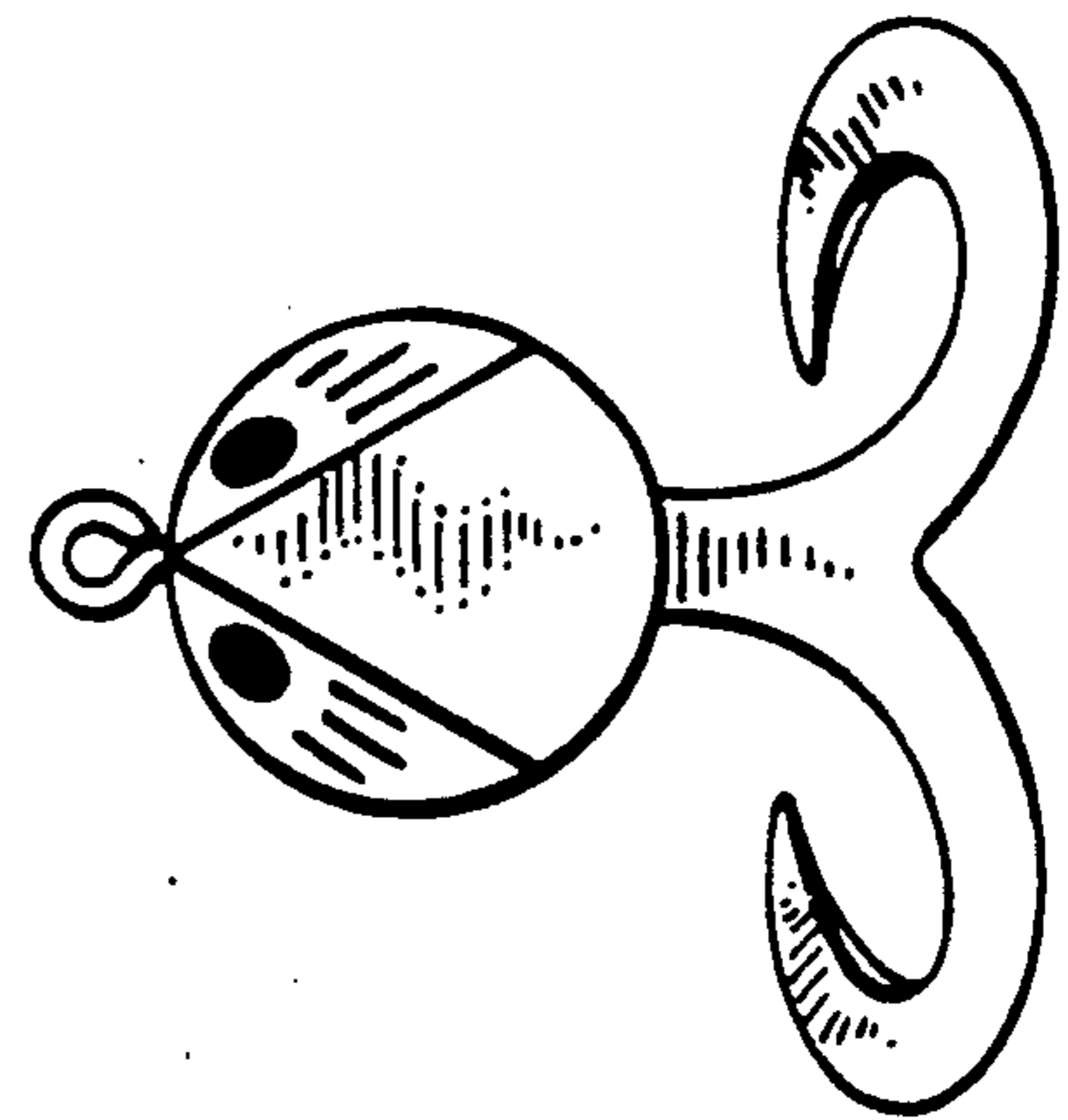

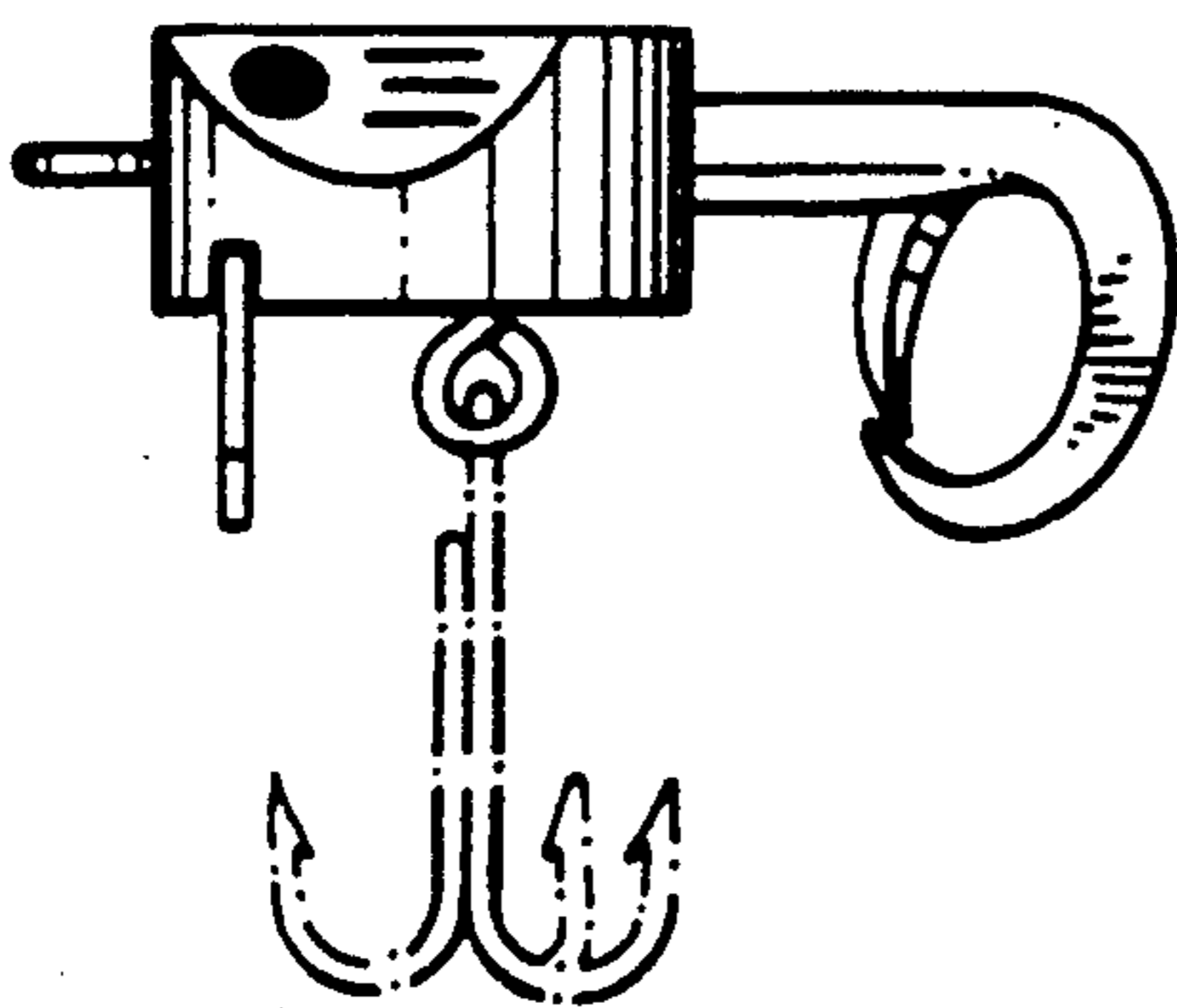

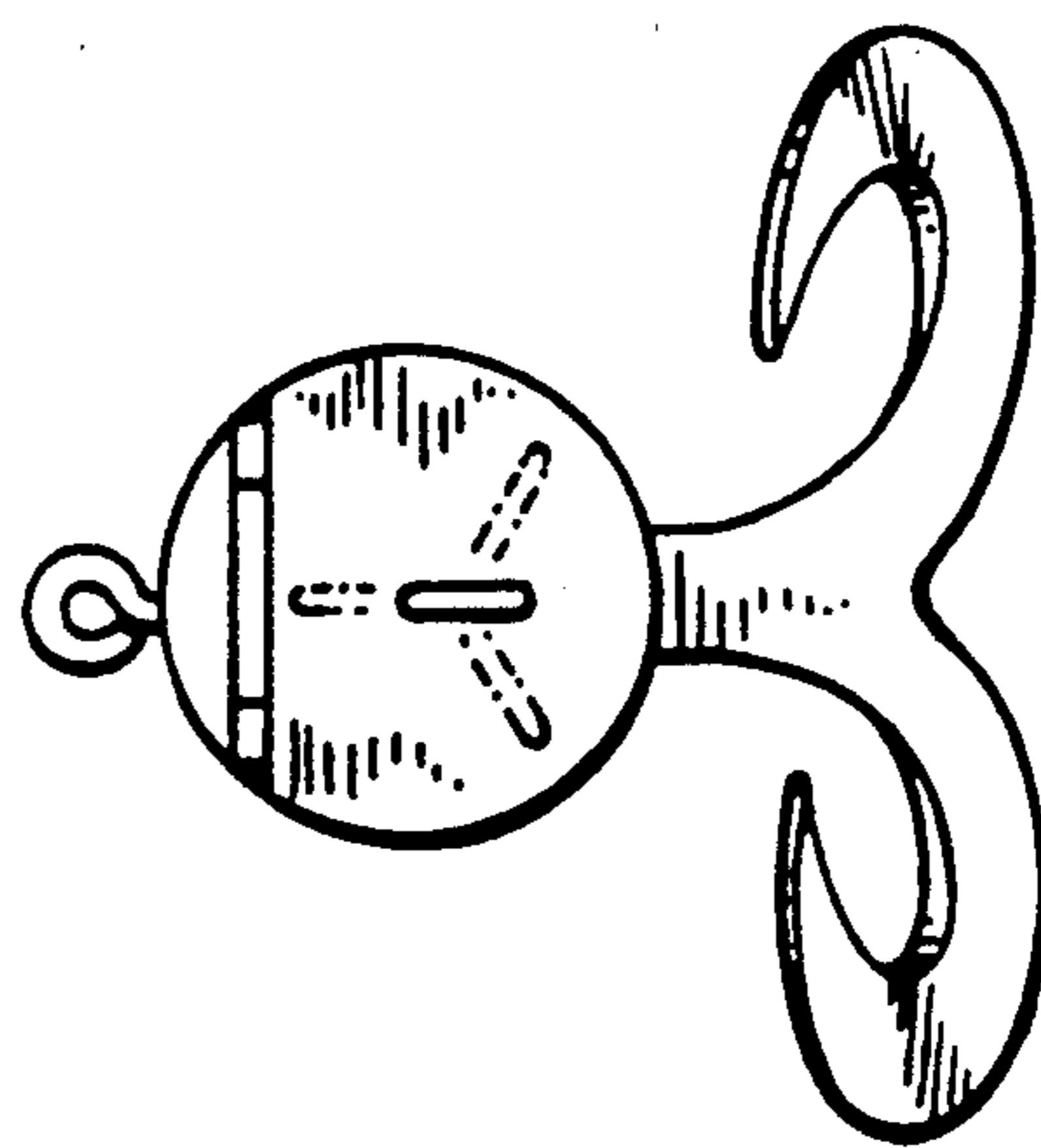

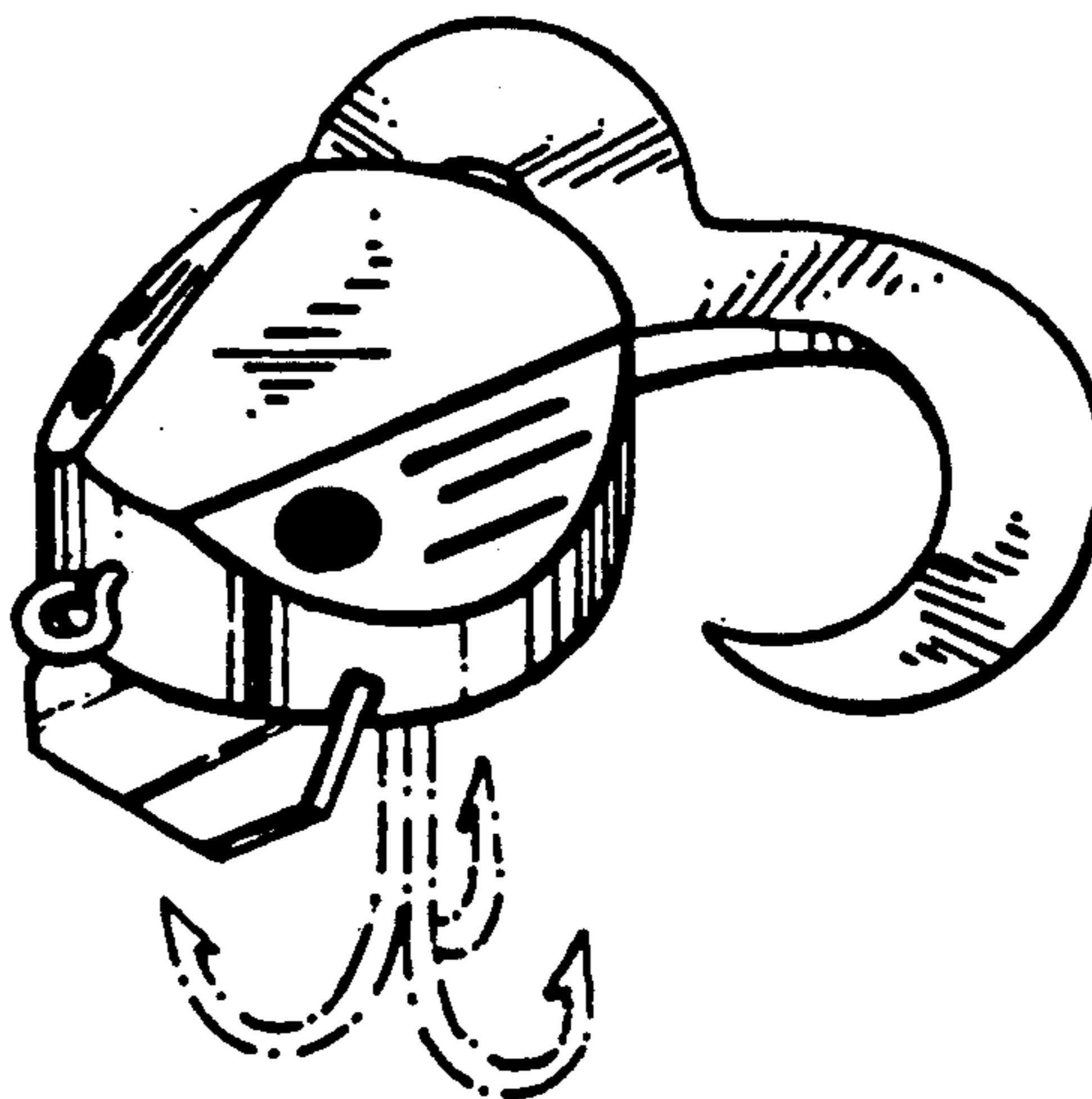

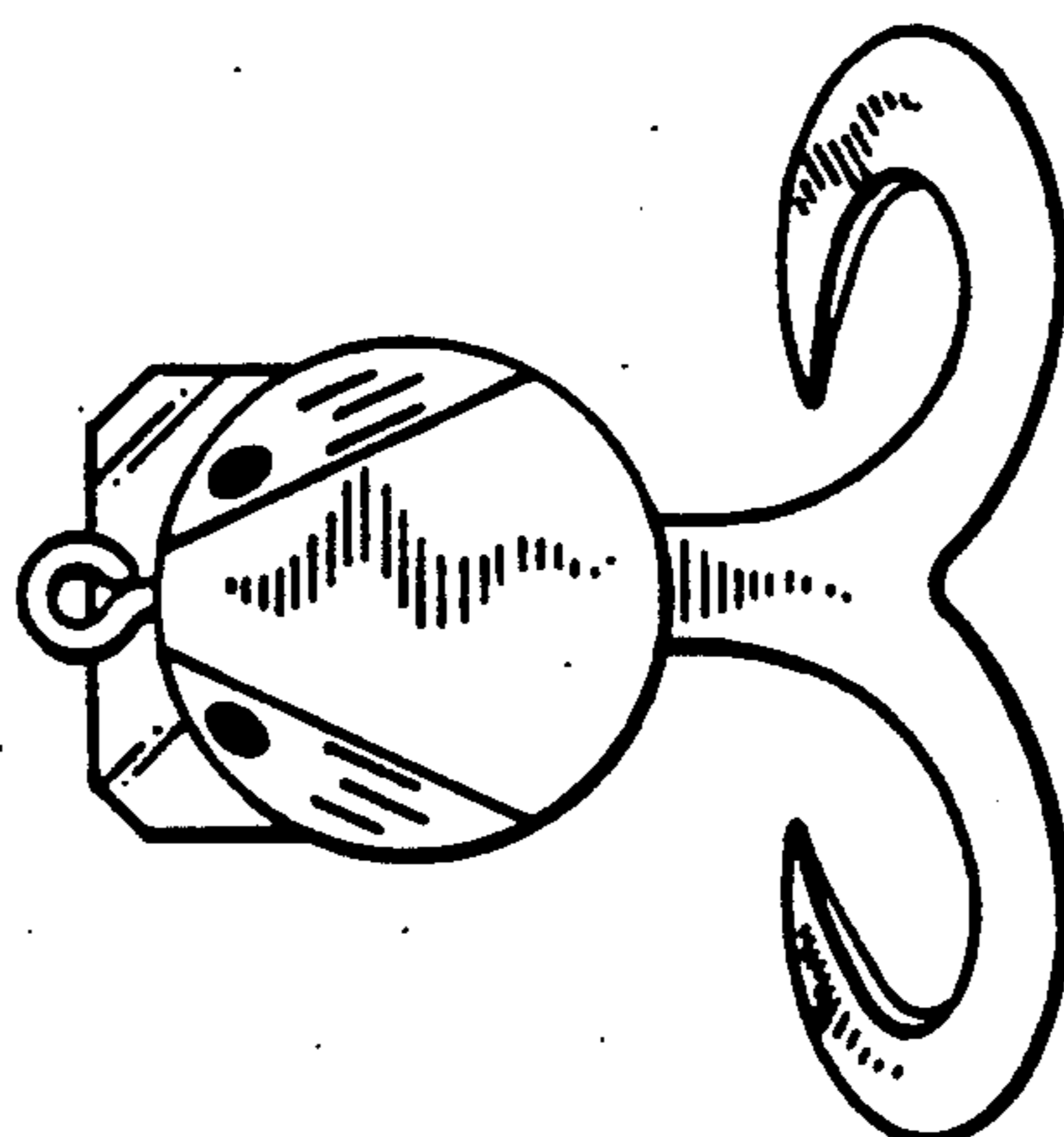

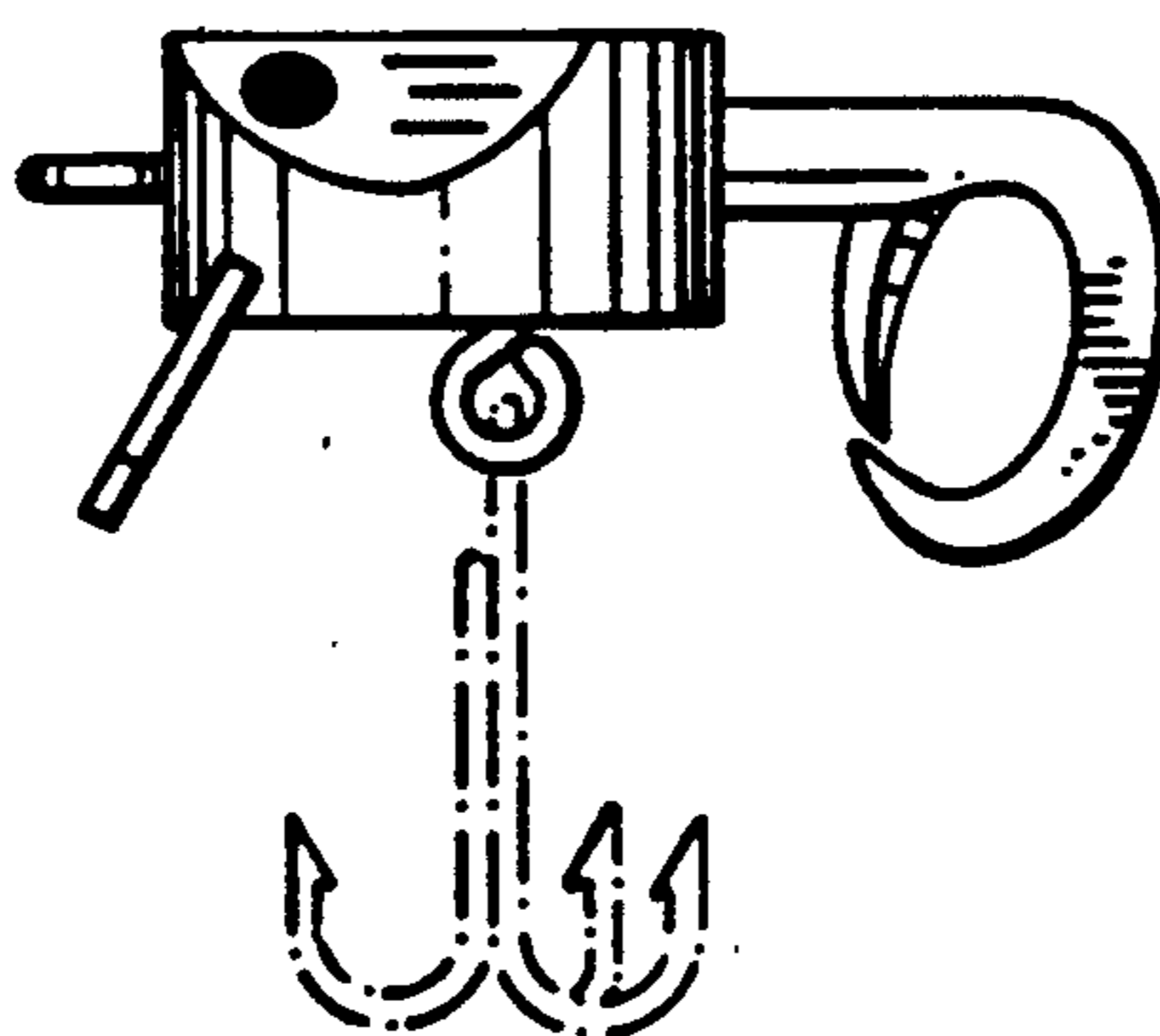

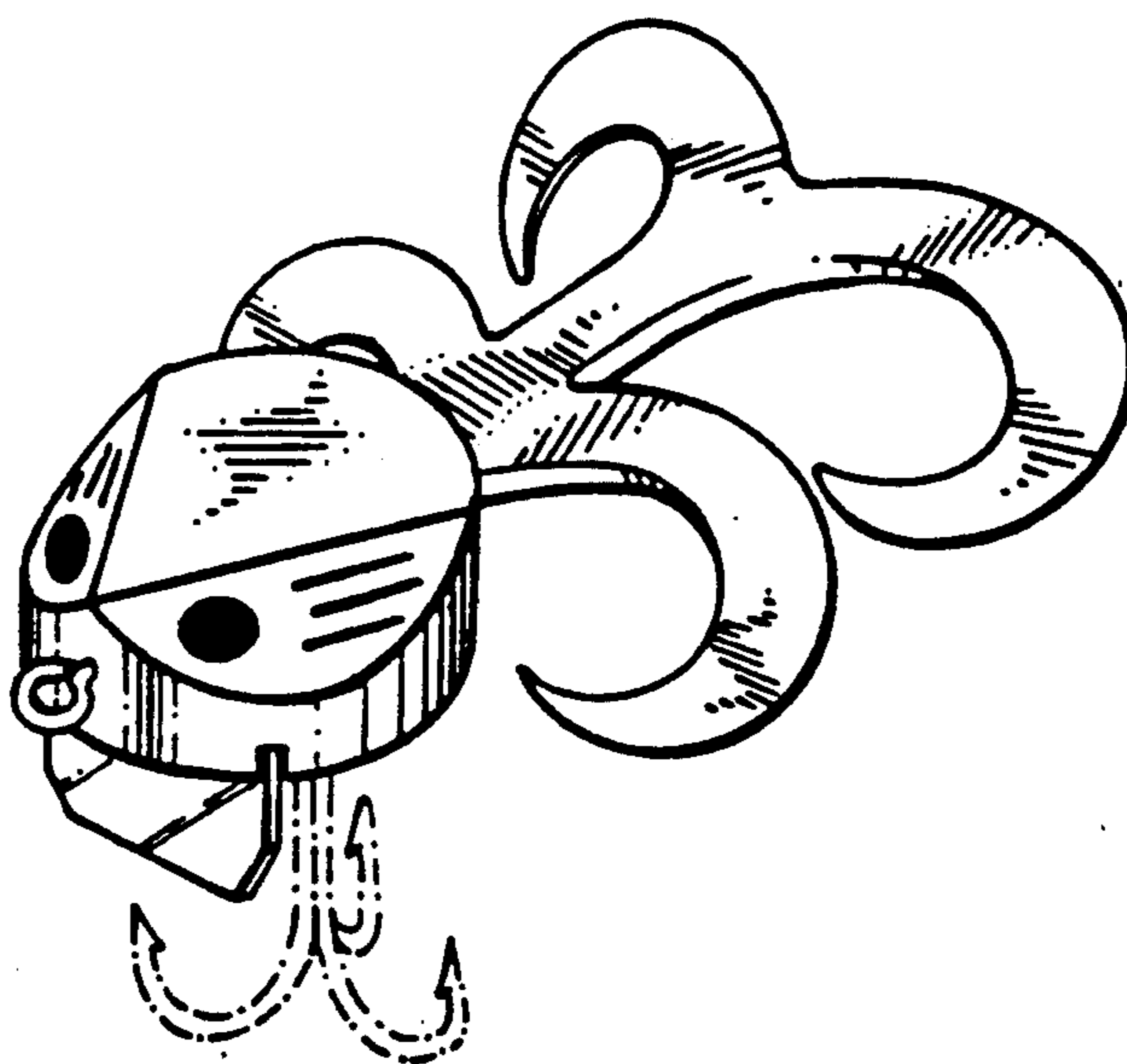

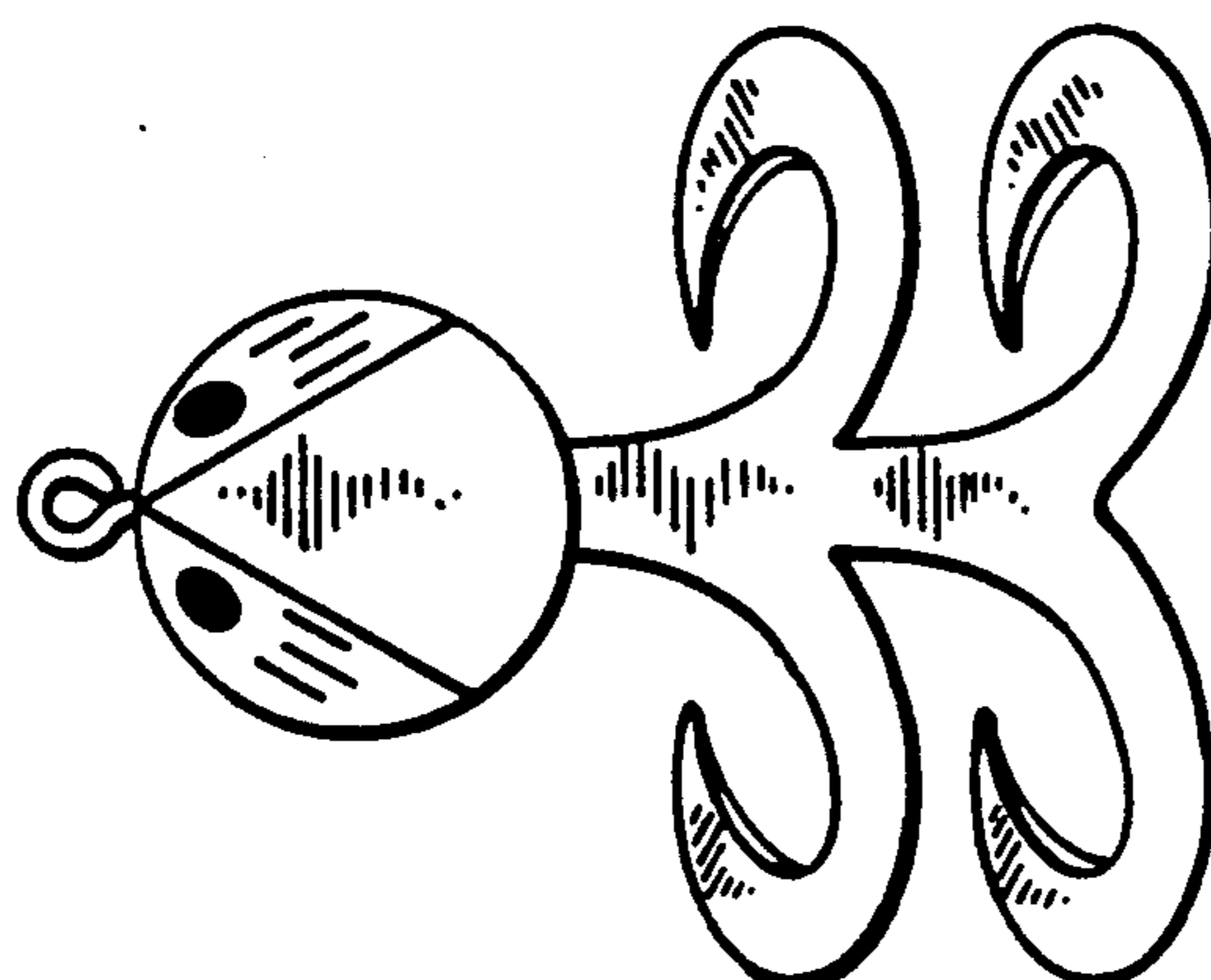

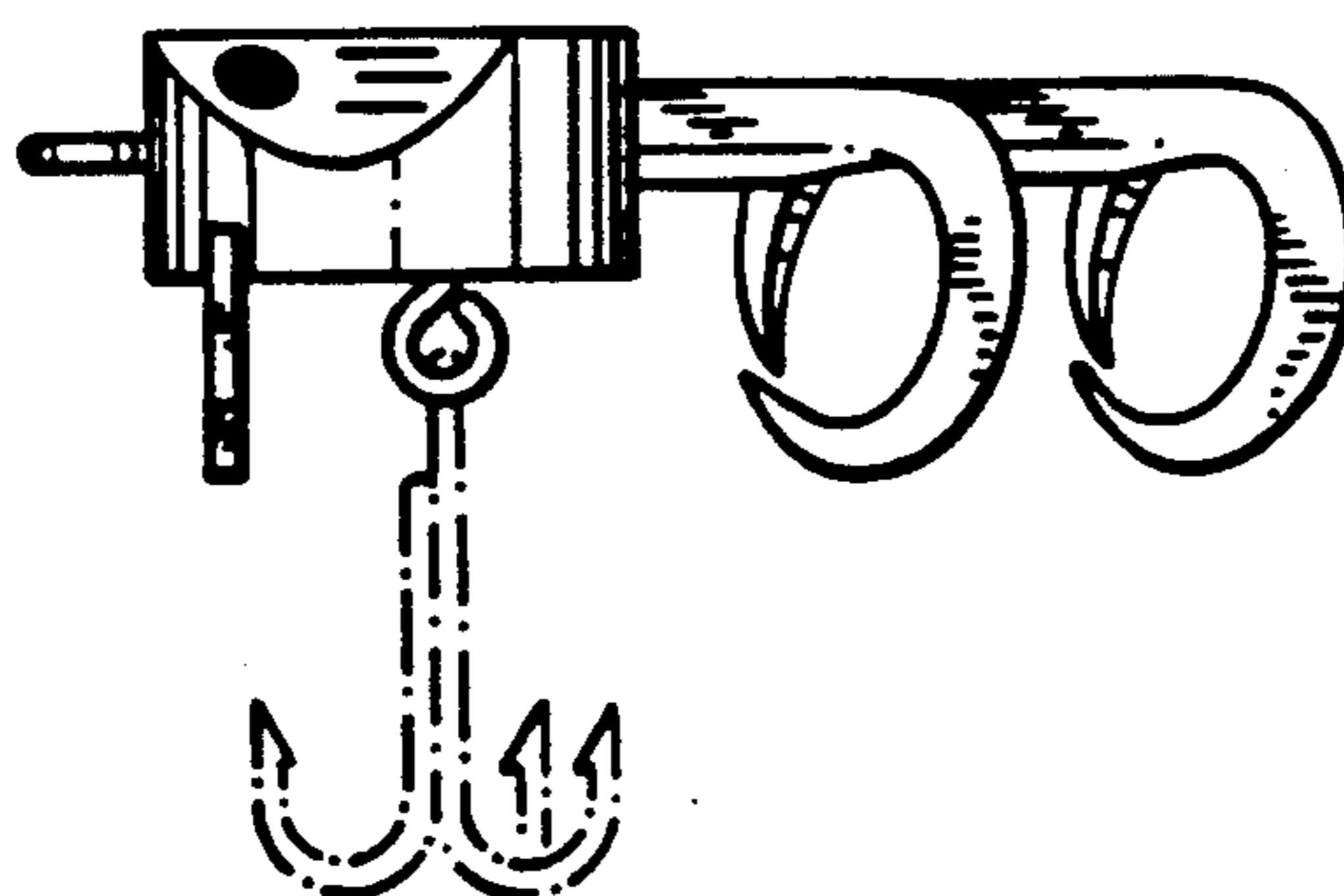
