FIG. 2 is a top plan view thereof;

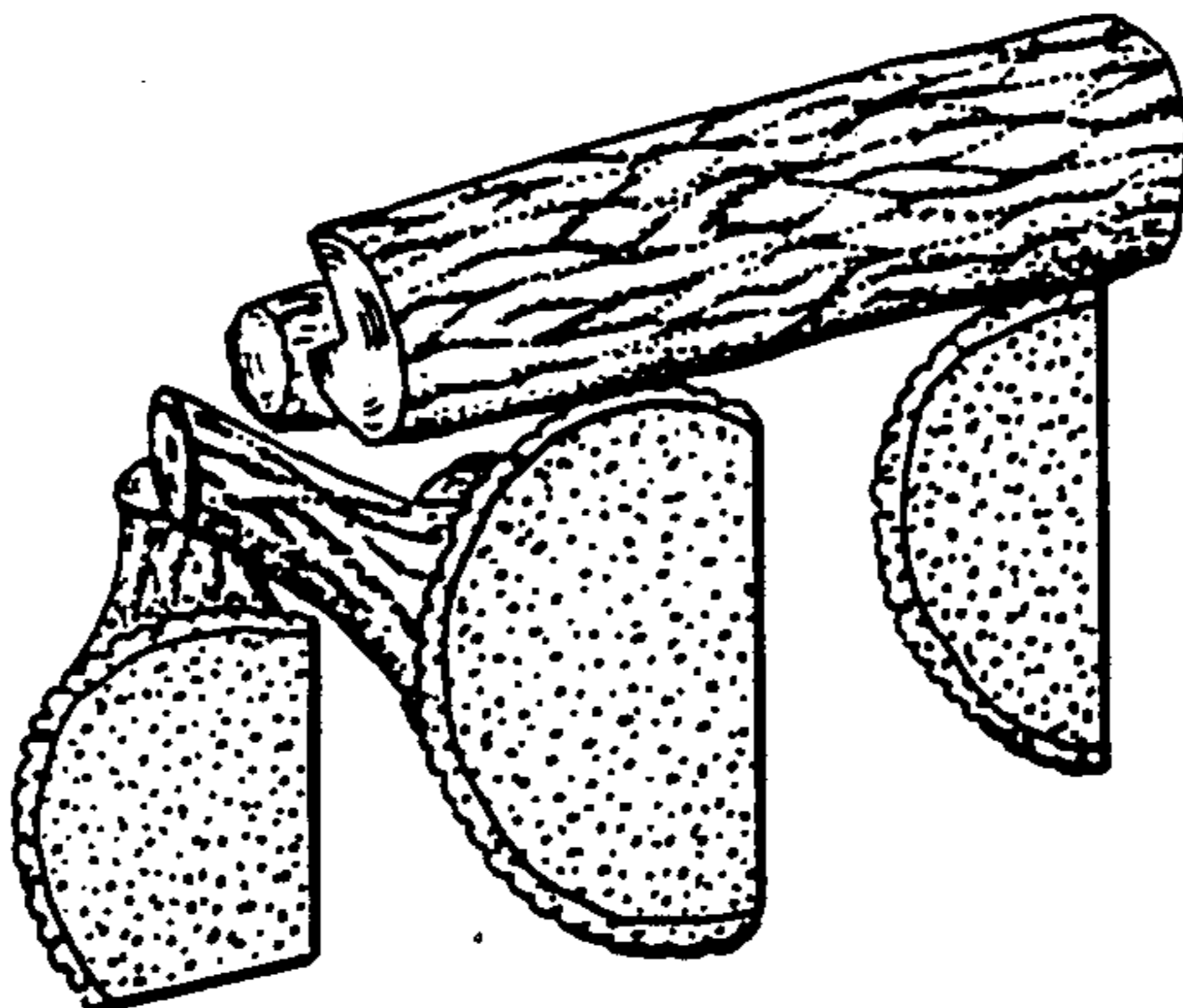
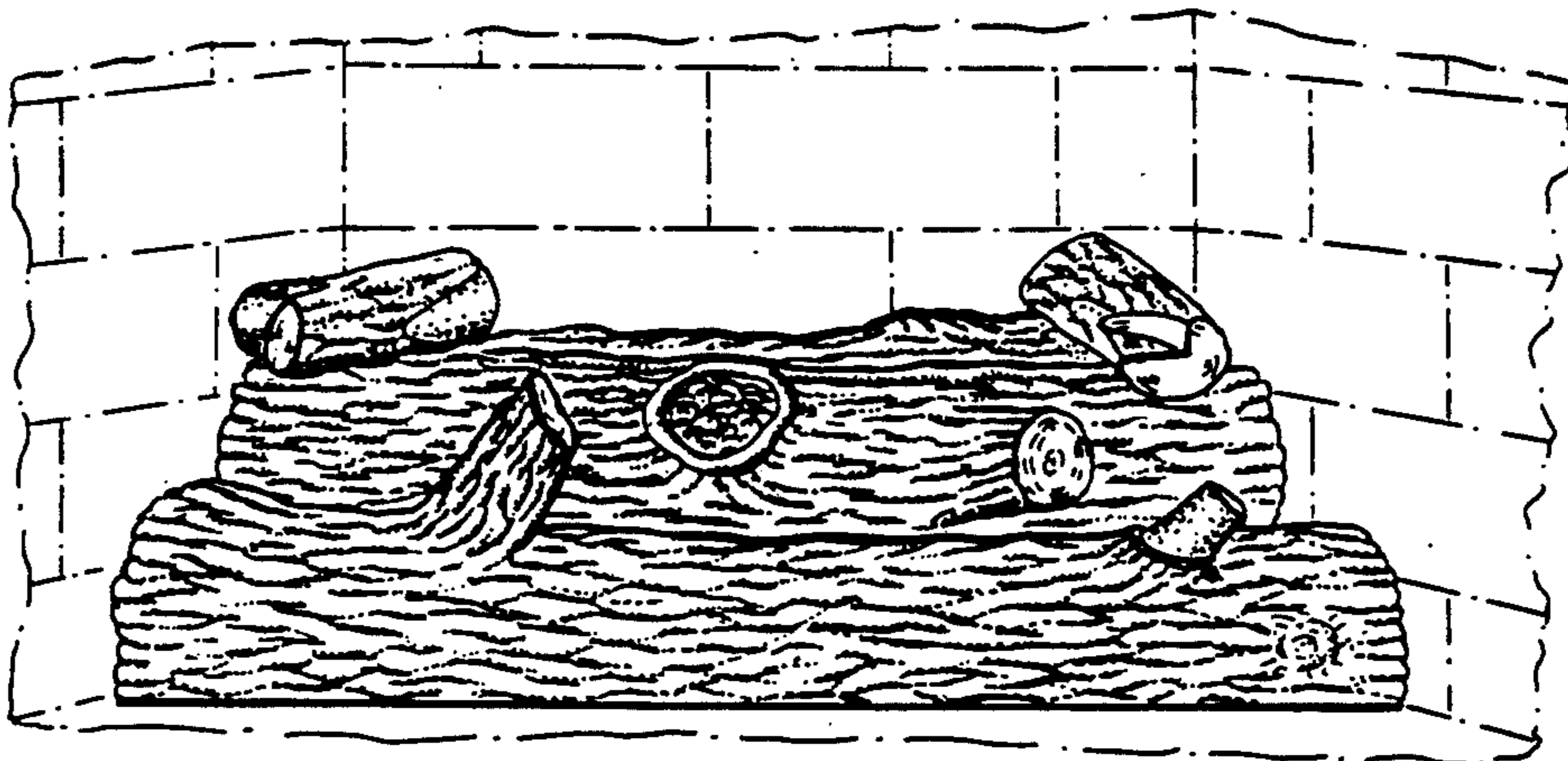
FIG. 3 is a left-side elevational view thereof;

The broken-line showing of environmental structure in FIG. 1 is for illustrative purposes only, and forms no part of the claimed design.



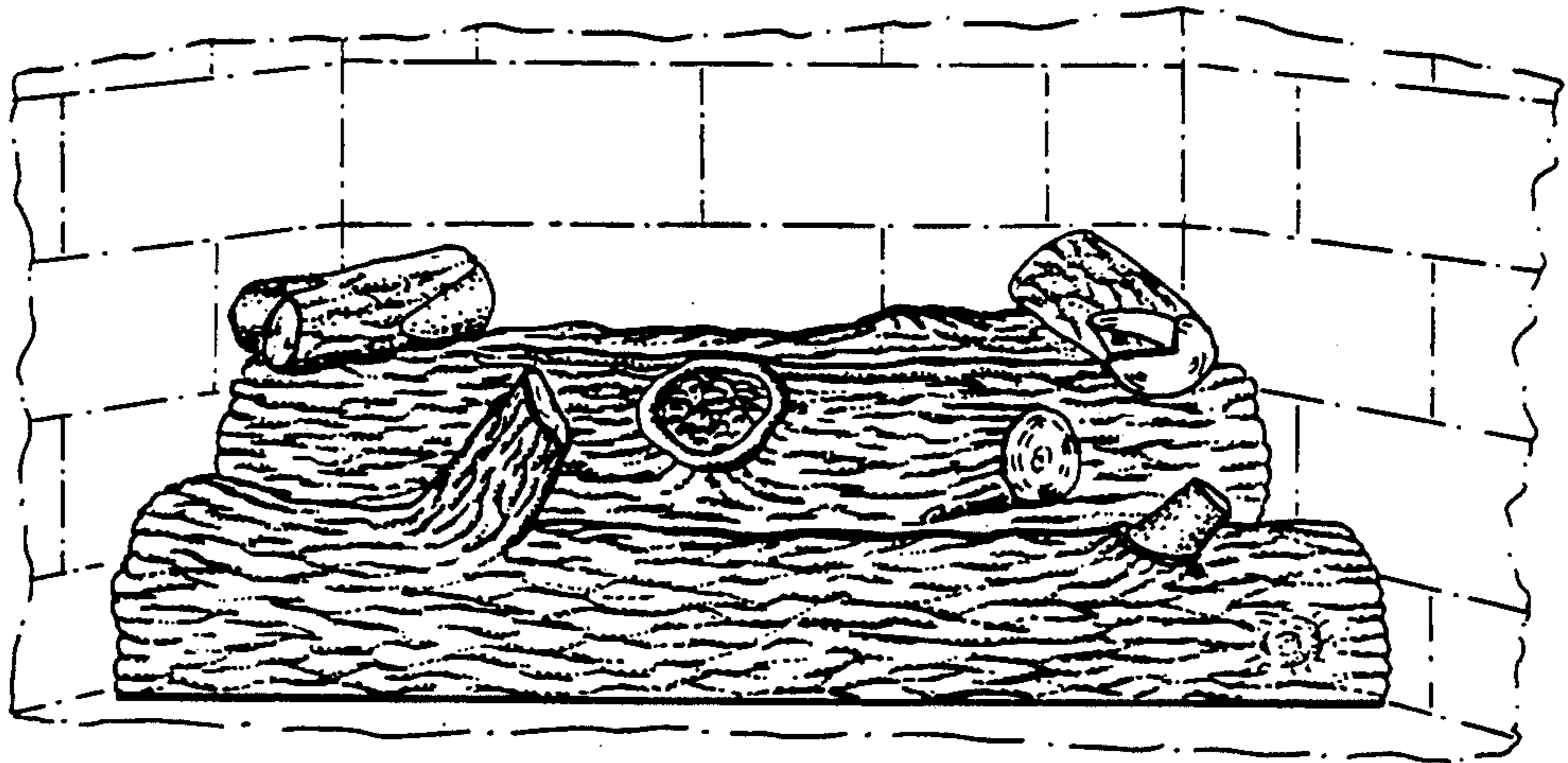

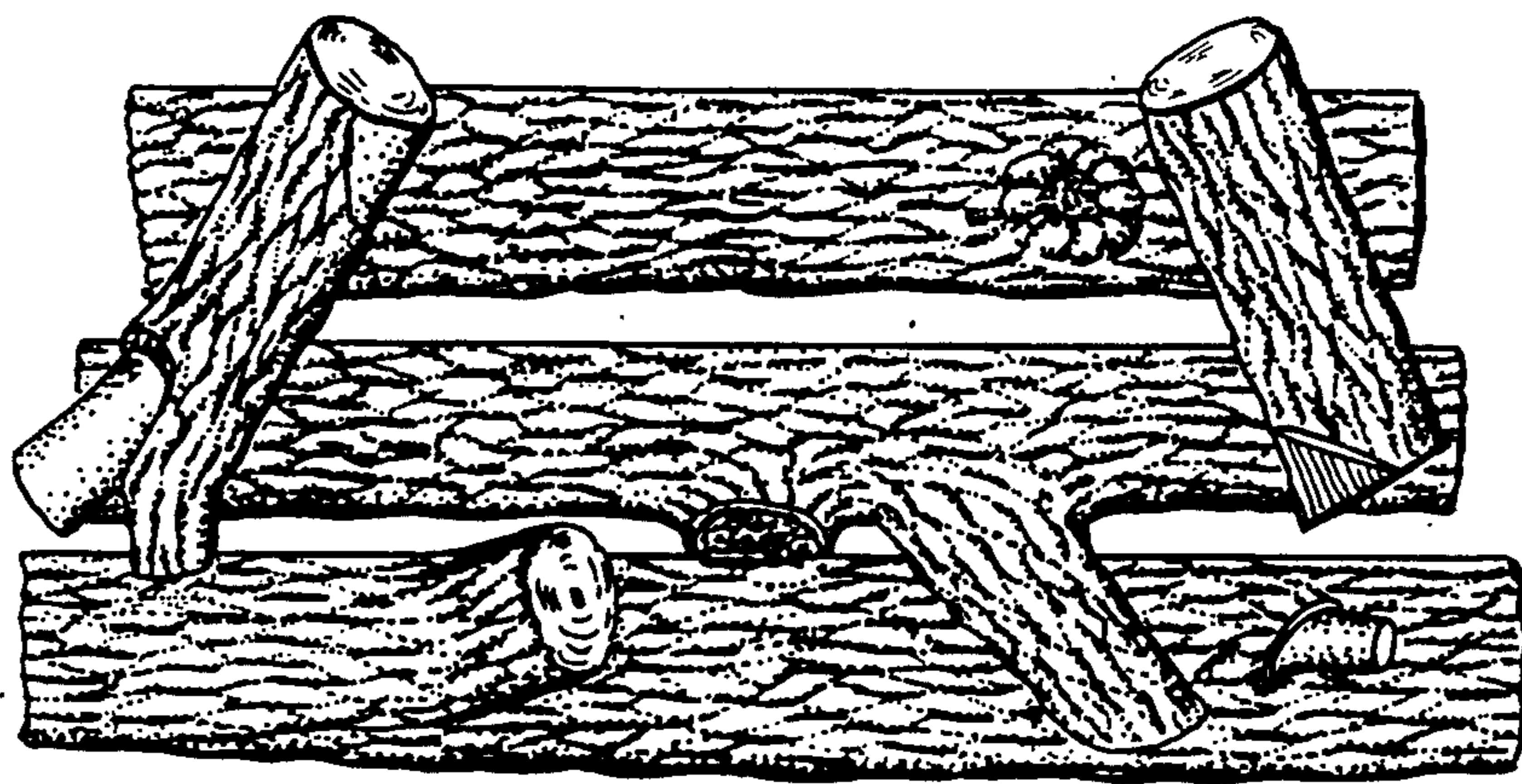

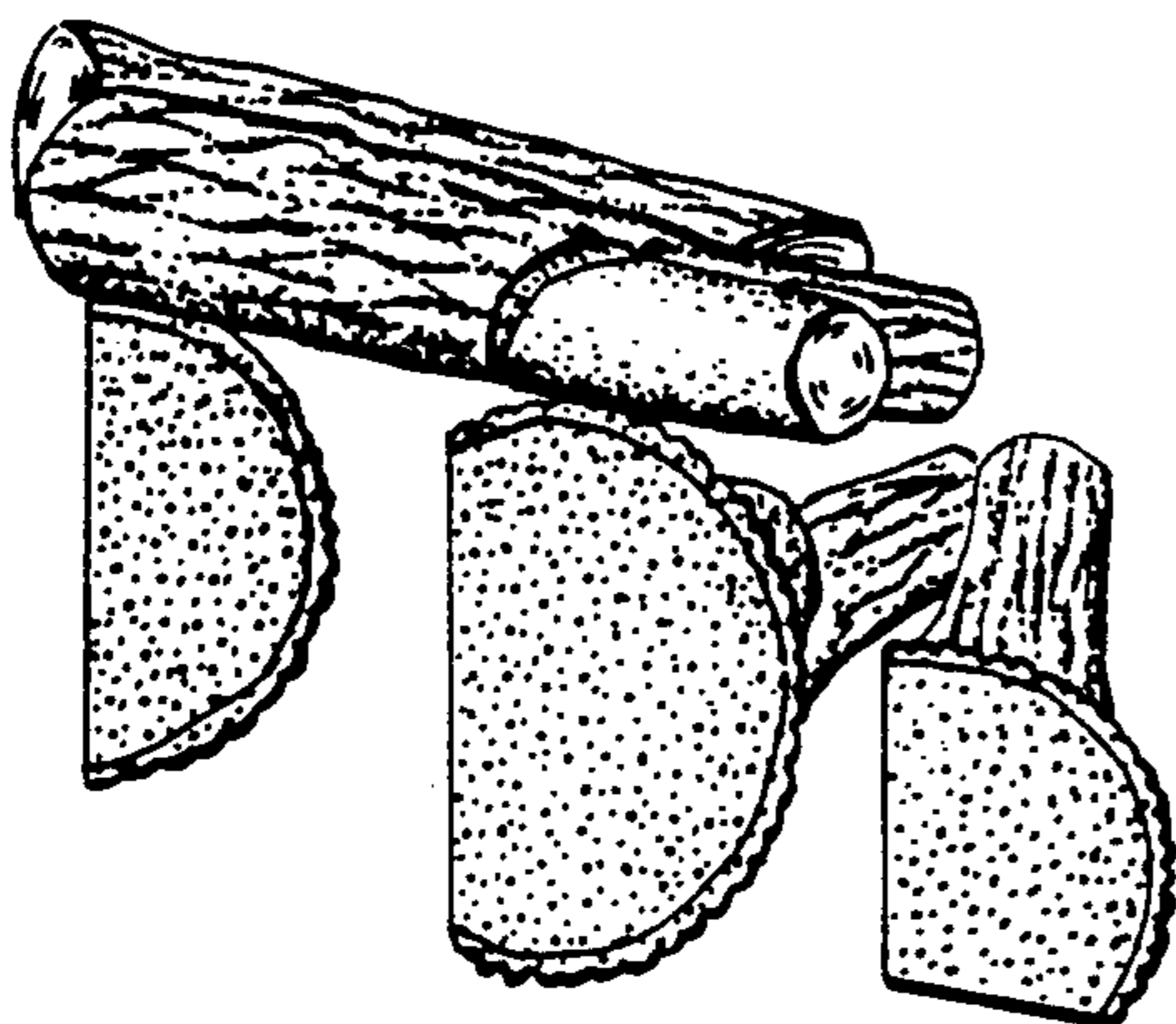

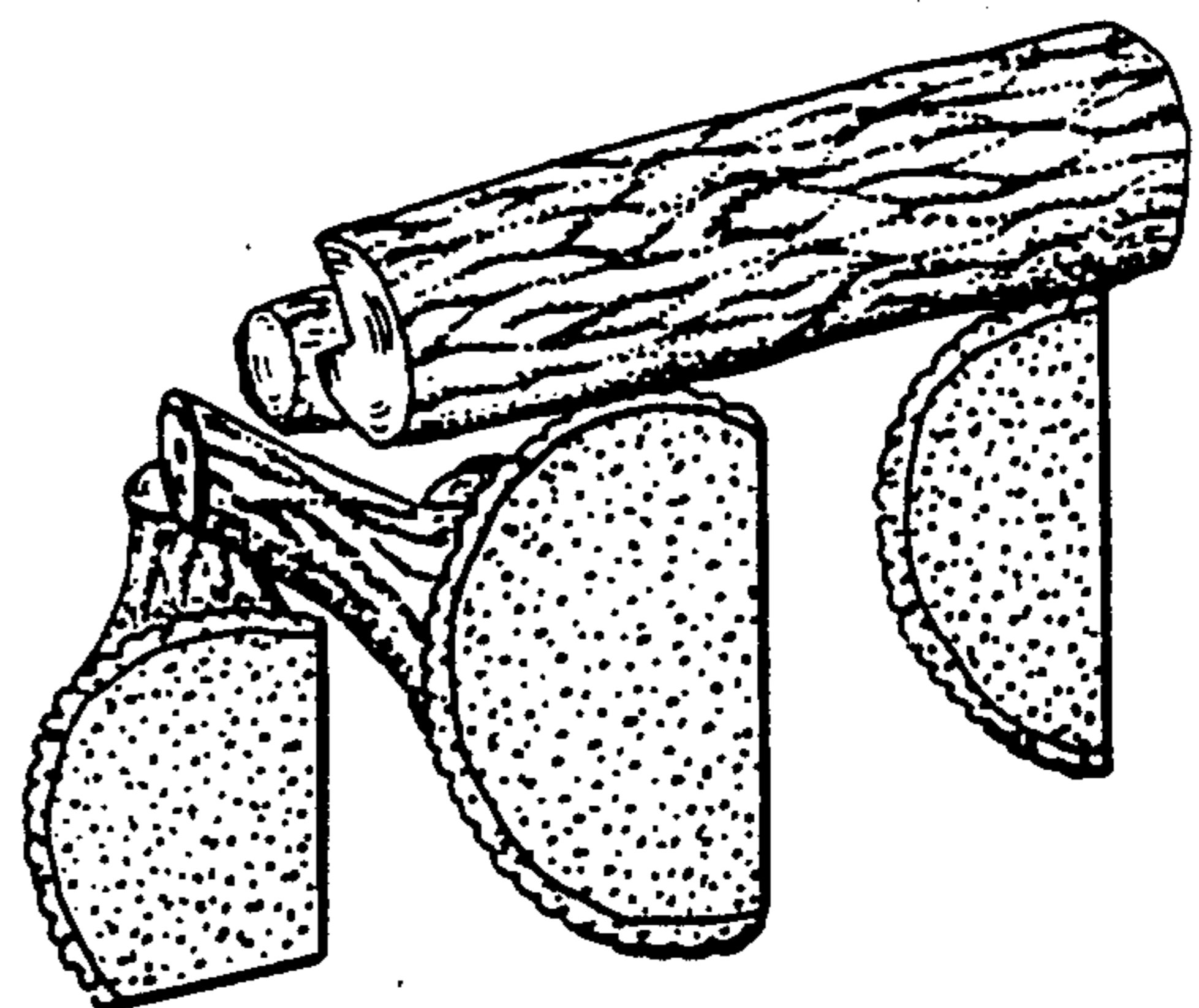

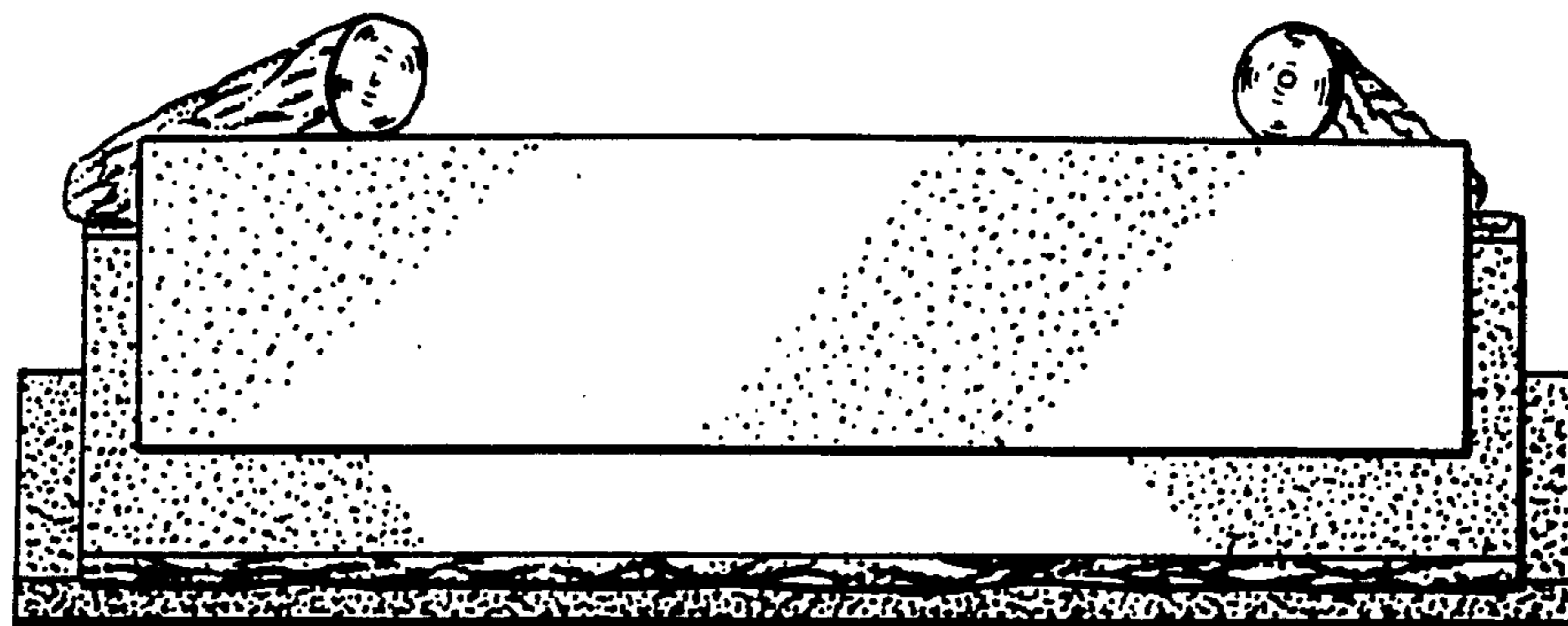

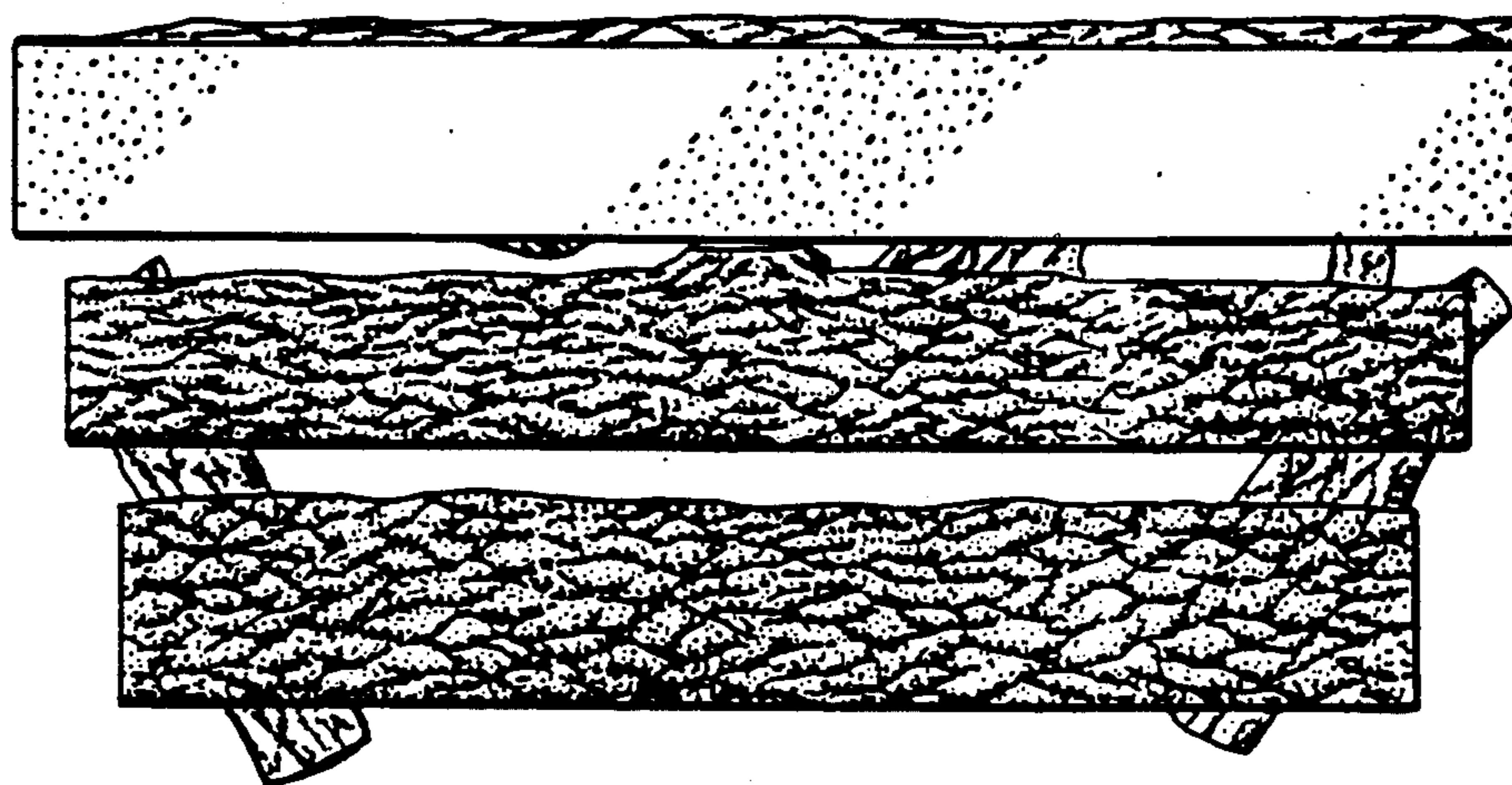
