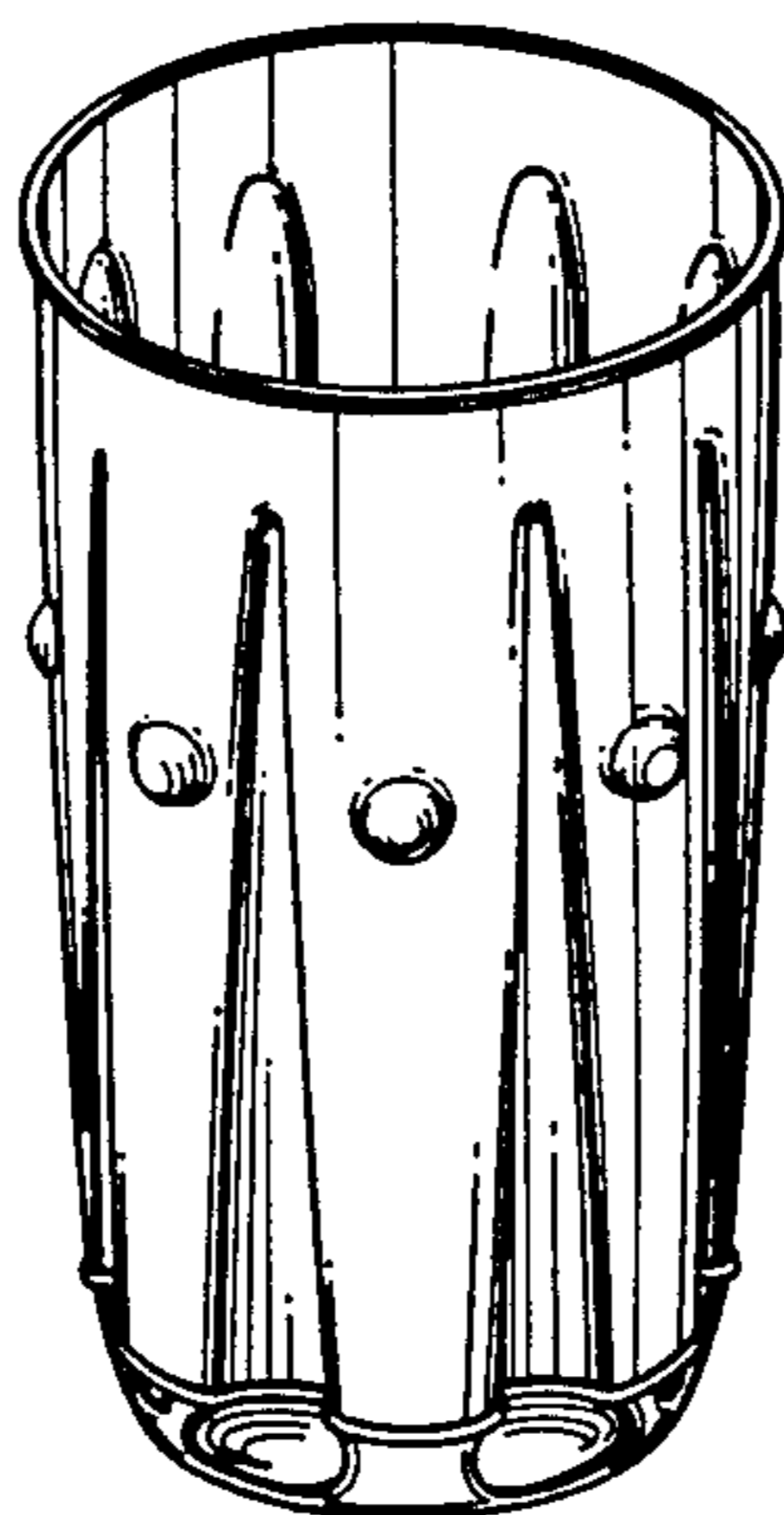

The ornamental design for a stackable container, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a stackable container showing my new design;
 FIG. 2 is a perspective view of a modified form of FIG. 1, thereof;
 FIG. 3 is a typical elevation of FIG. 1;
 FIG. 4 is a top plan view of FIG. 1;
 FIG. 5 is a bottom plan view of FIG. 1;
 FIG. 6 is a sectional elevation taken along line 6—6 of FIG. 4; and,
 FIG. 7 is a sectional elevation taken along line 7—7 of FIG. 4.



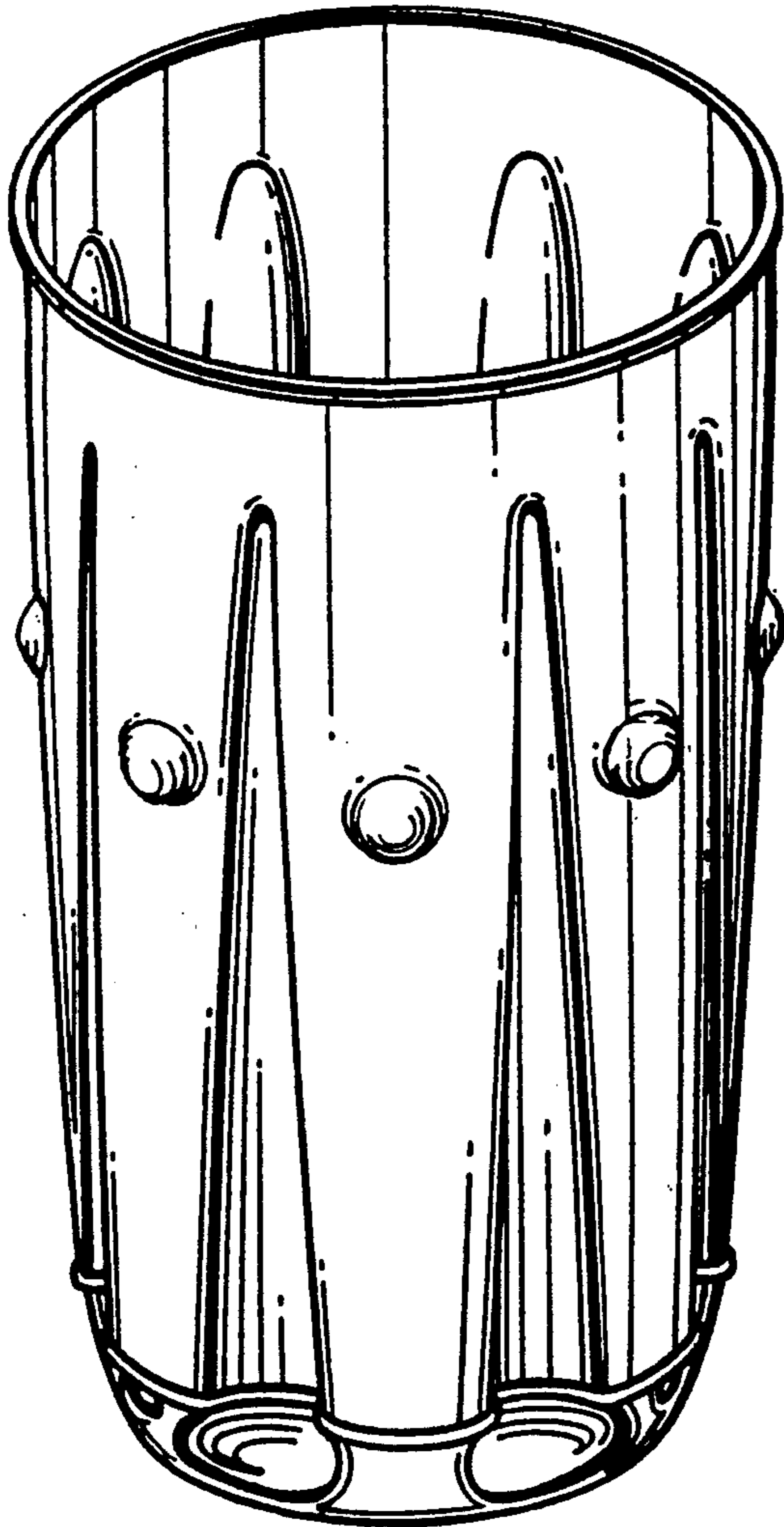

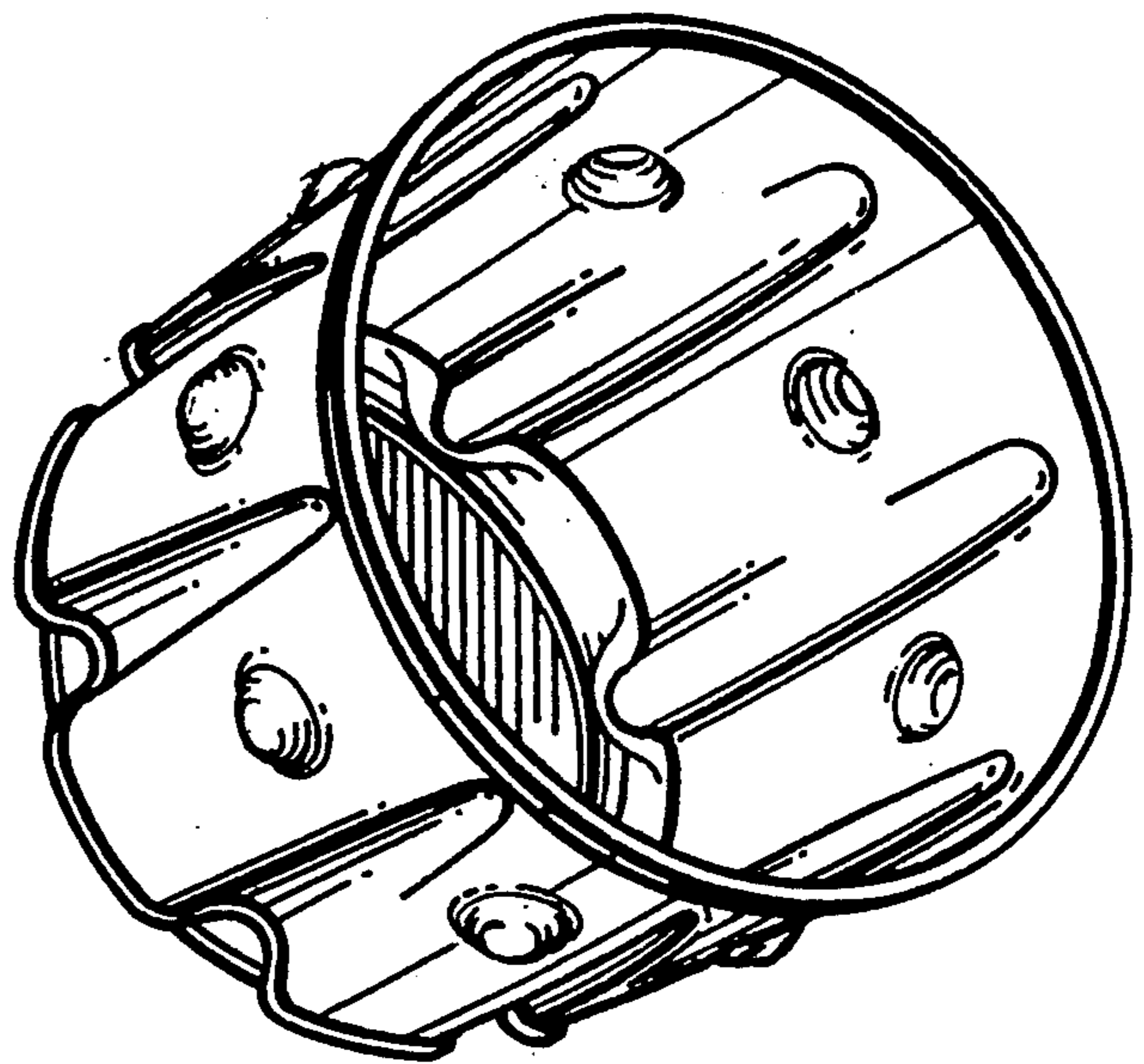

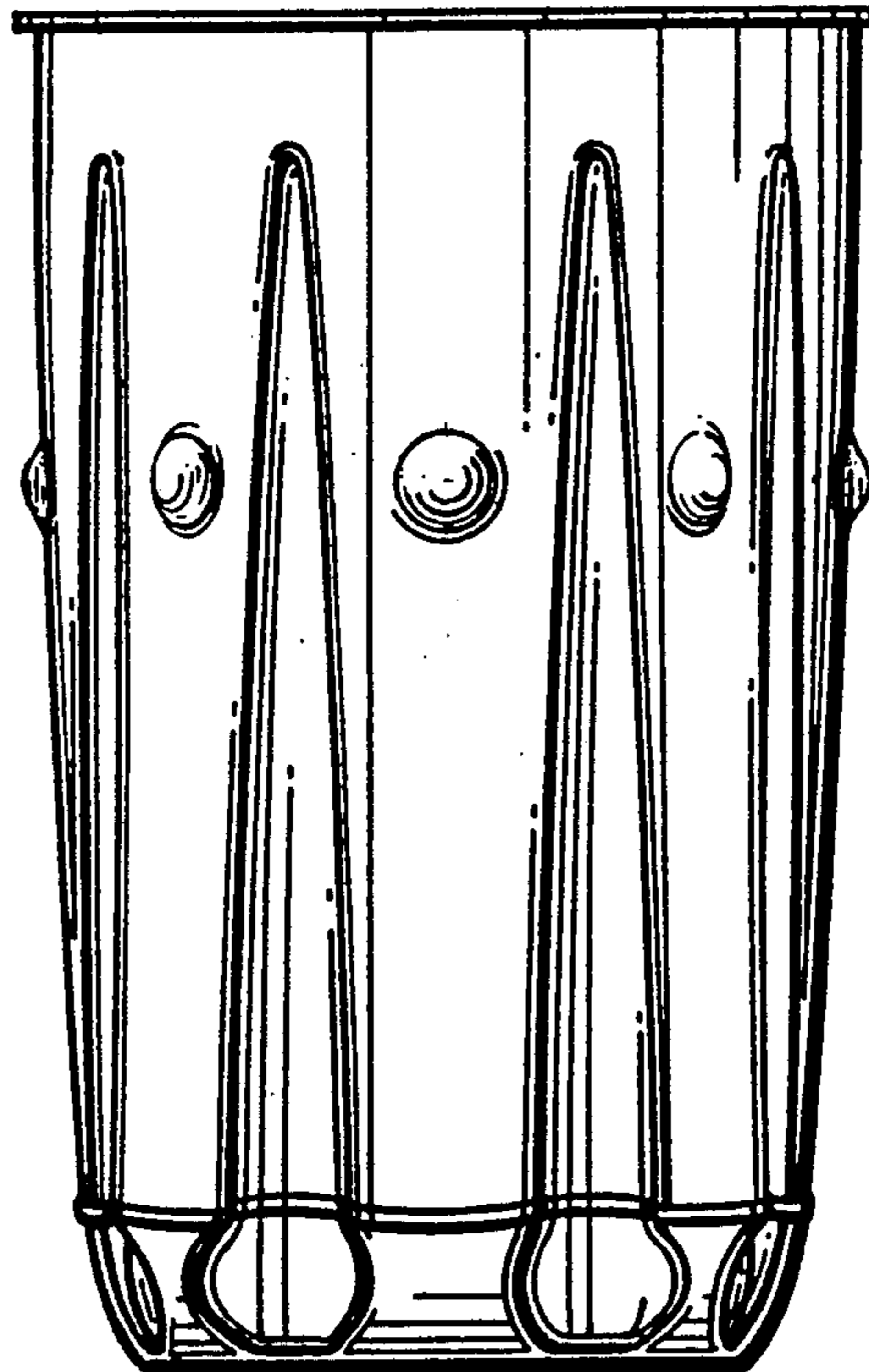

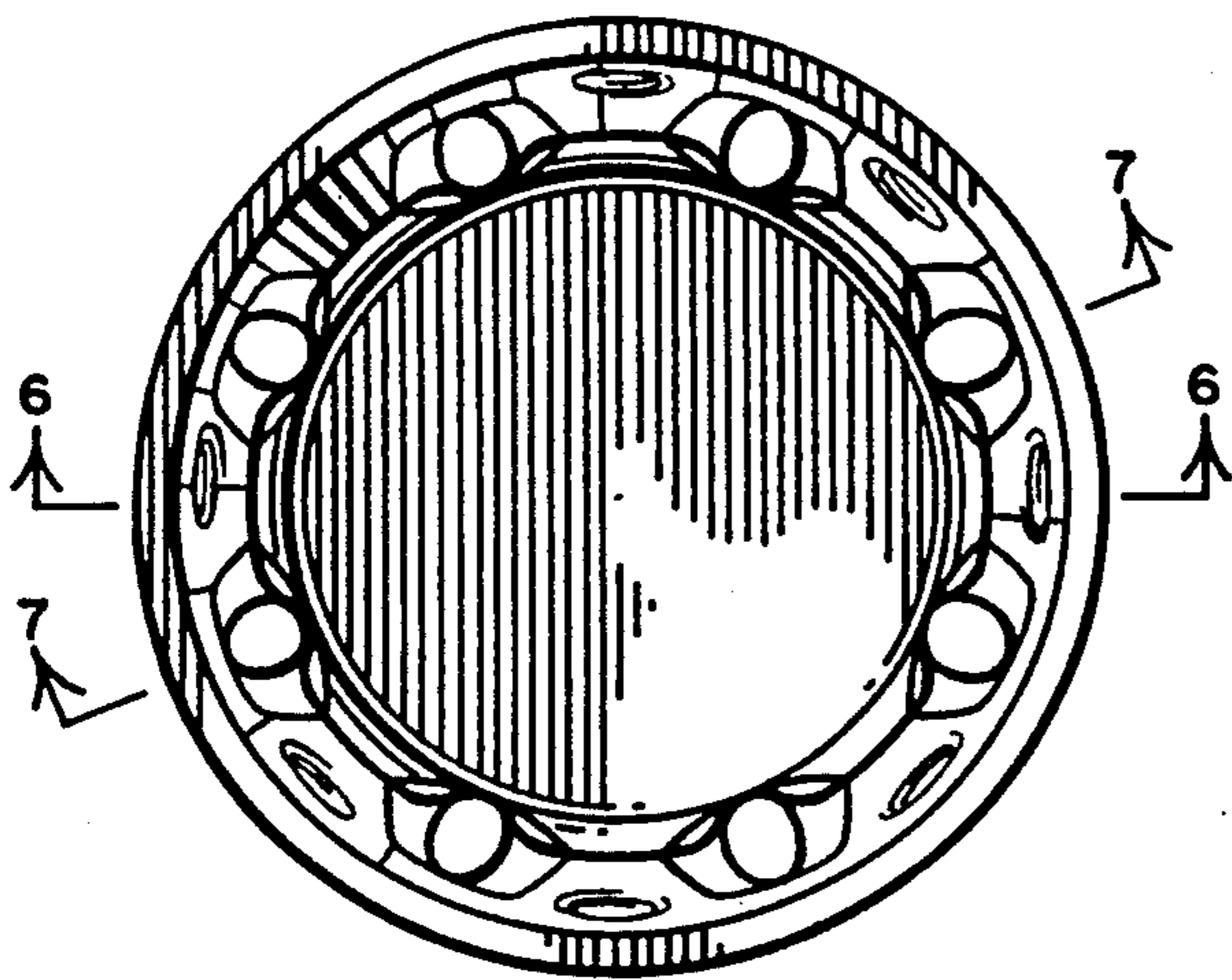

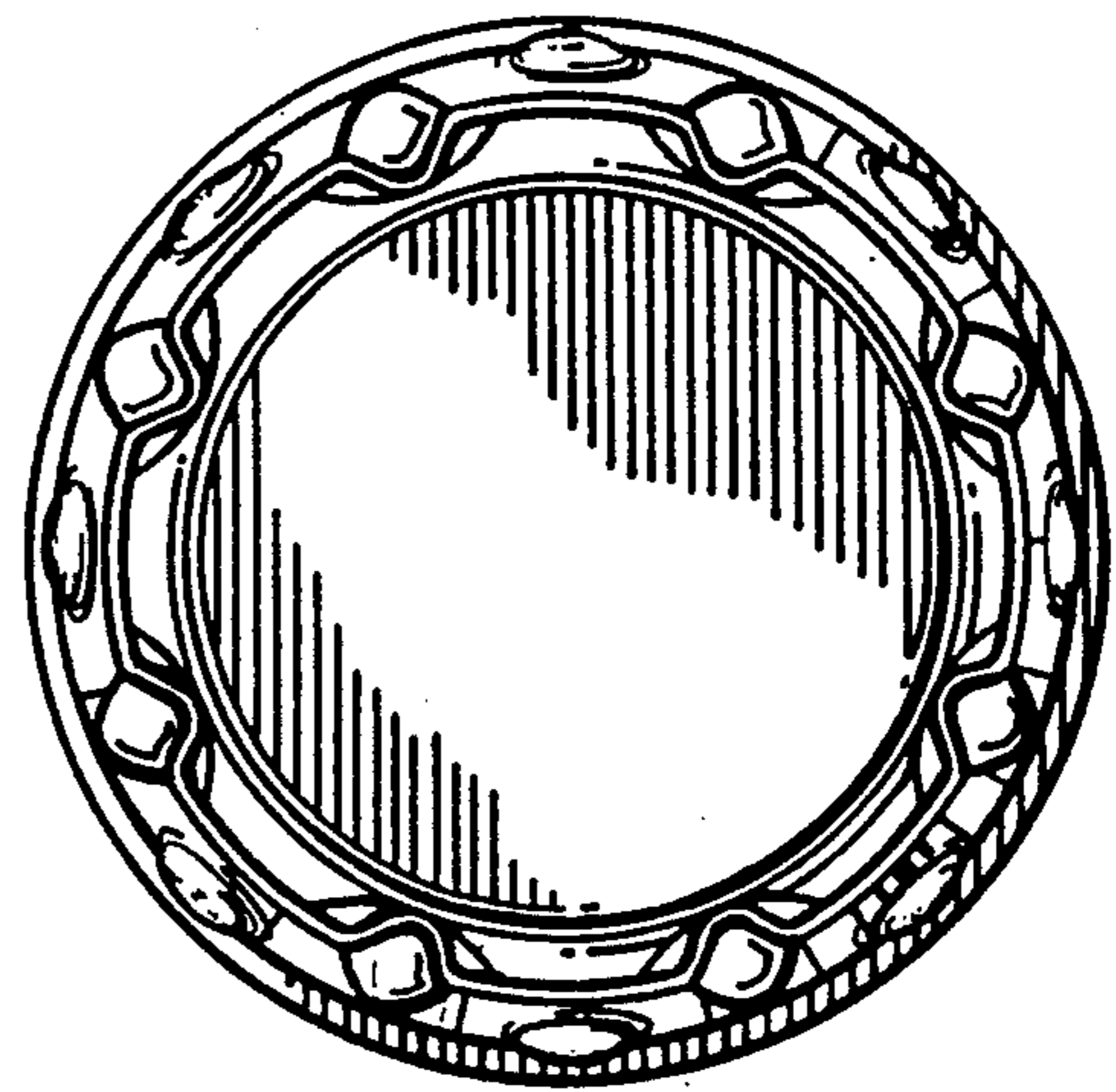

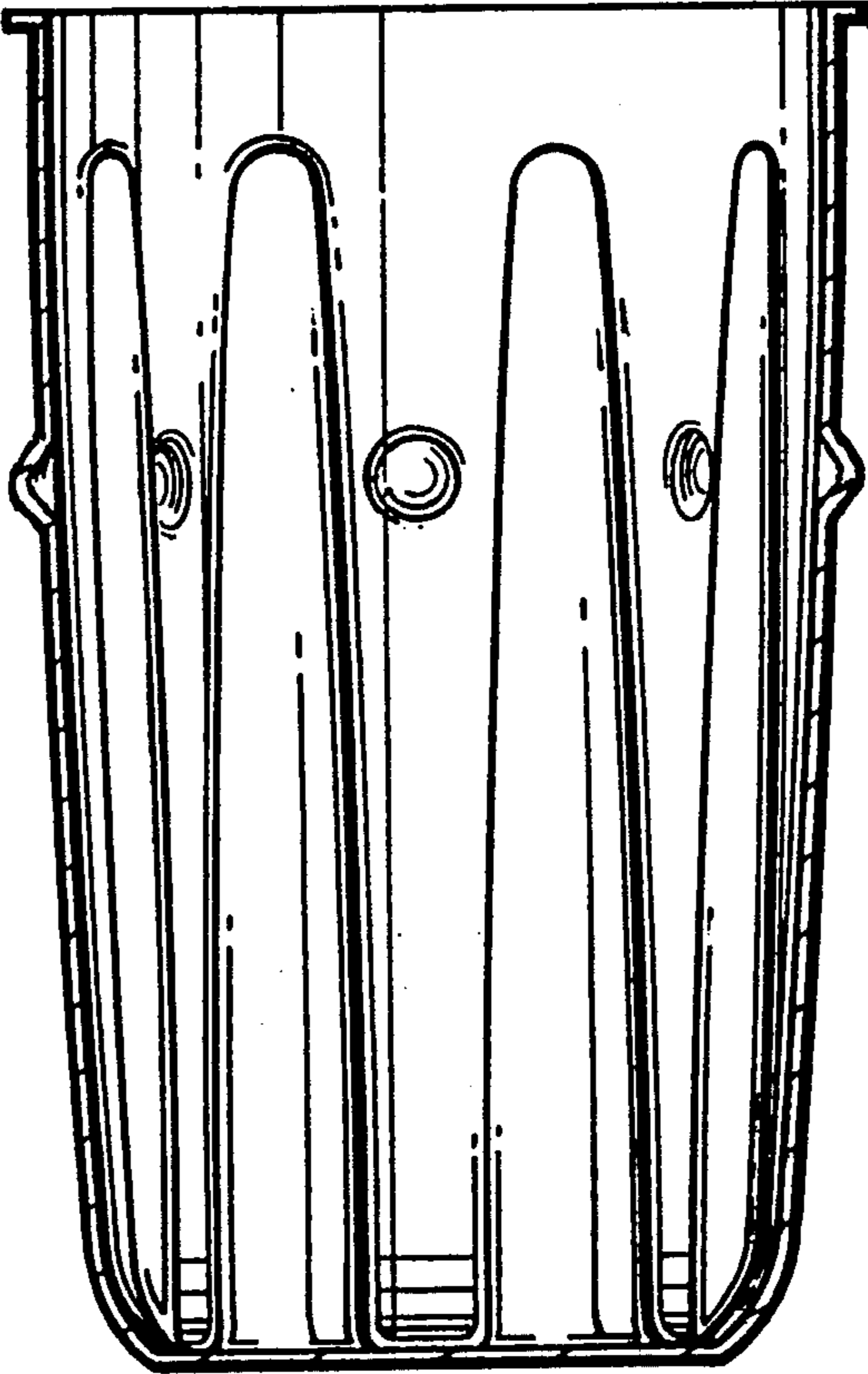

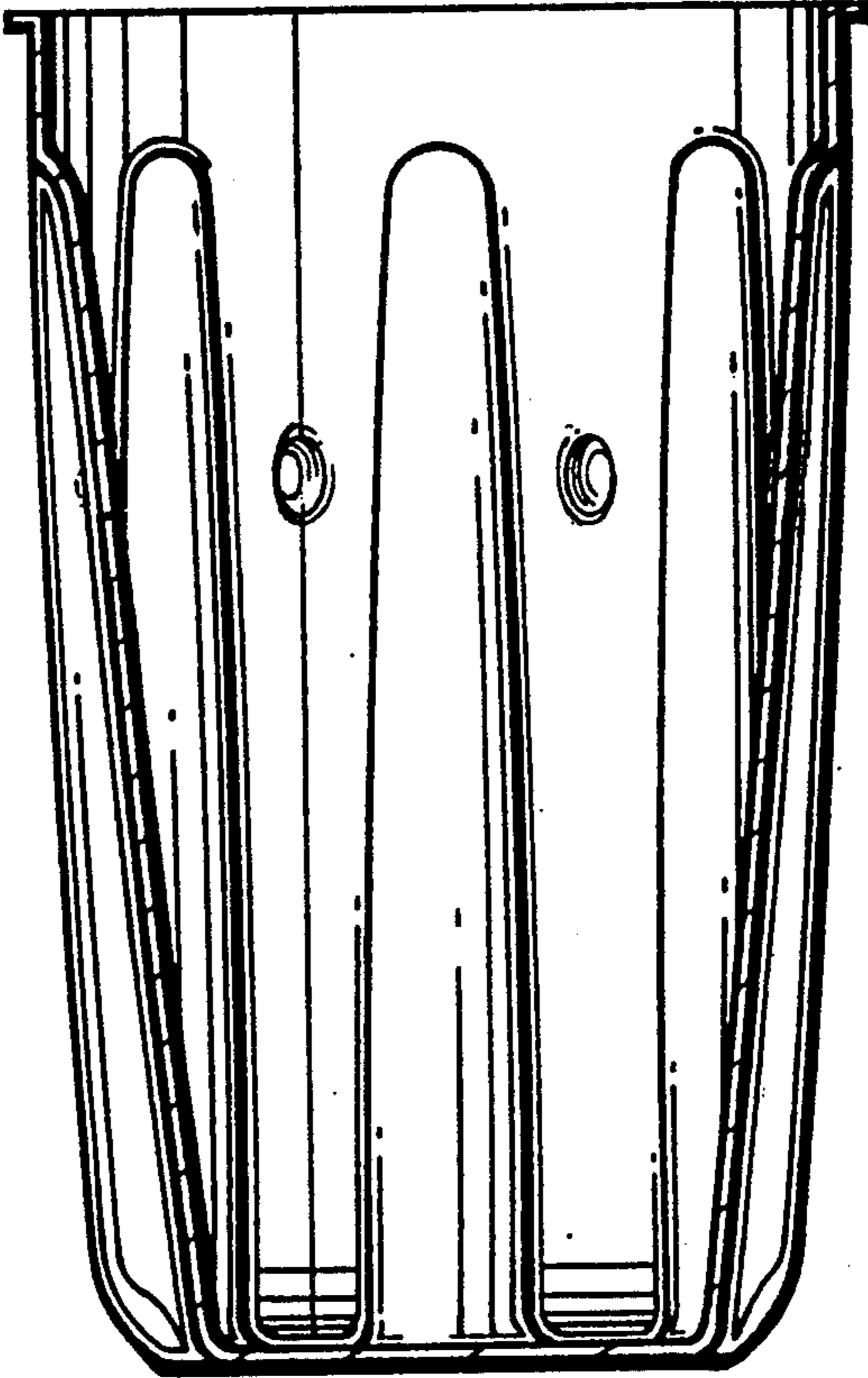
