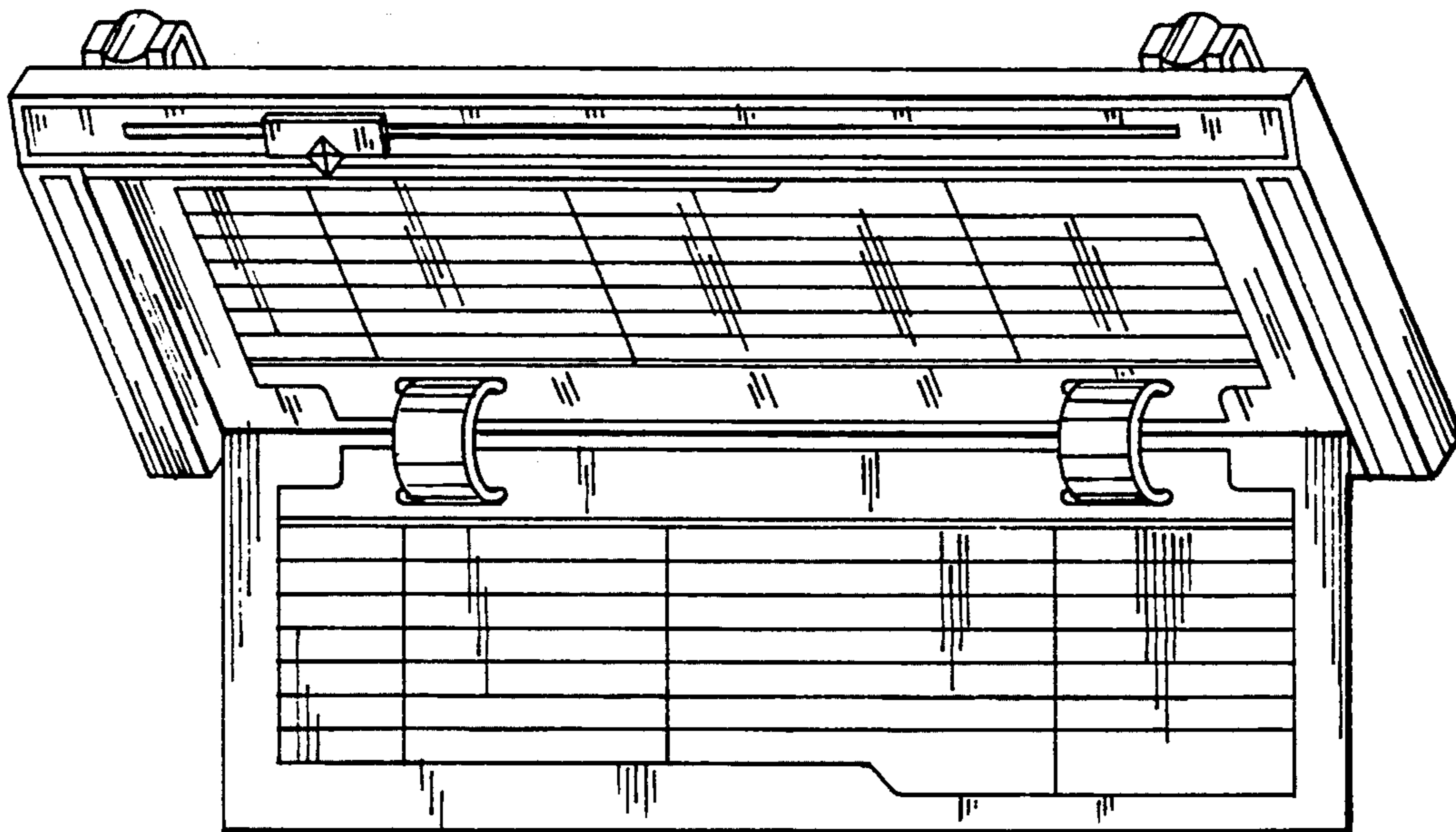

[57] CLAIM

The ornamental design for a visor-mountable telephone index, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a visor-mountable telephone index showing my new design, with the cover in an opened position;
FIG. 2 is a top plan view, with the cover in a closed position;
FIG. 3 is a left side elevational view of FIG. 2, the right side being a mirror image thereof;
FIG. 4 is a front elevational view of FIG. 2;
FIG. 5 is a bottom plan view of FIG. 2; and
FIG. 6 is a rear elevational view of FIG. 2.



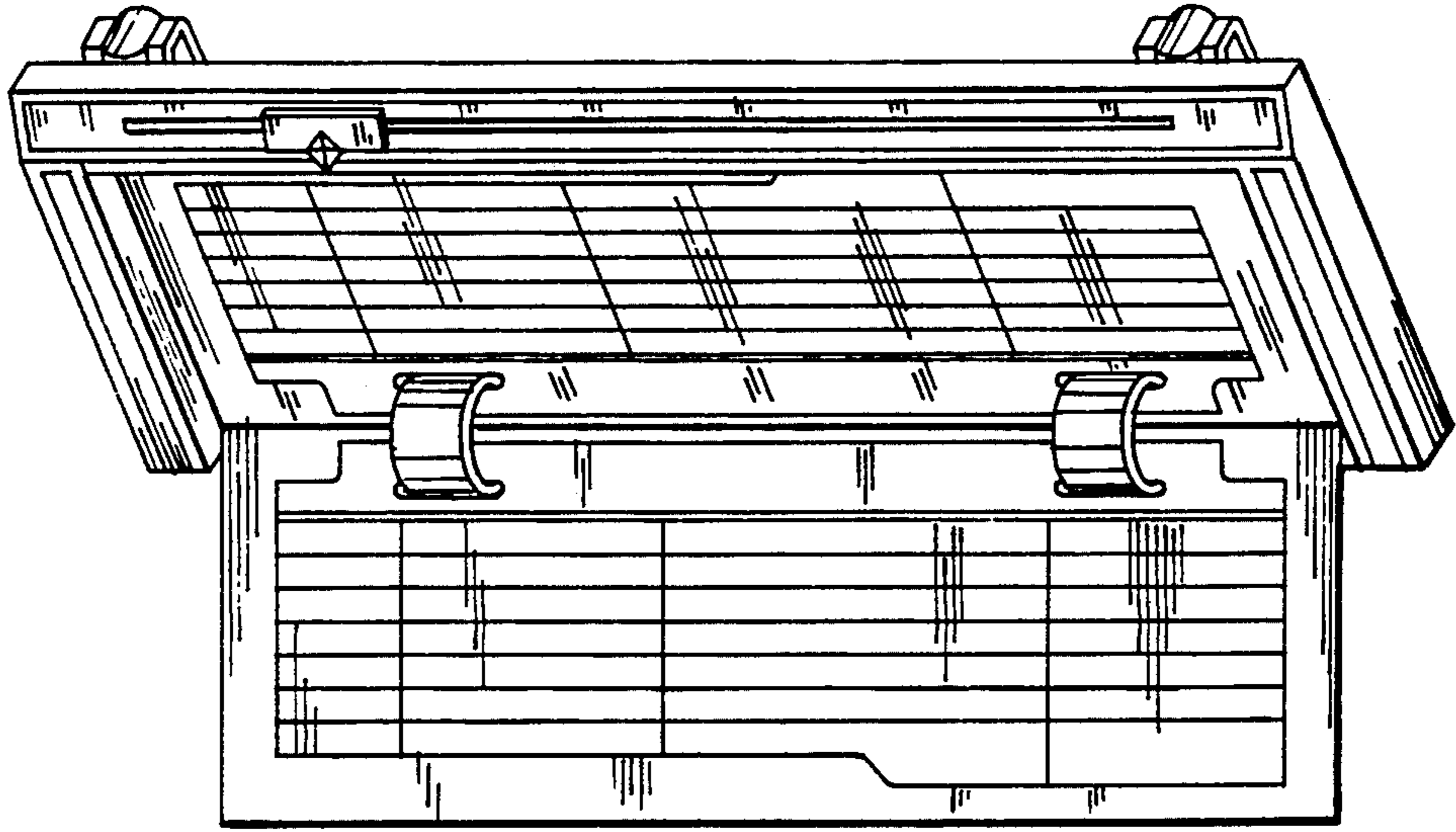

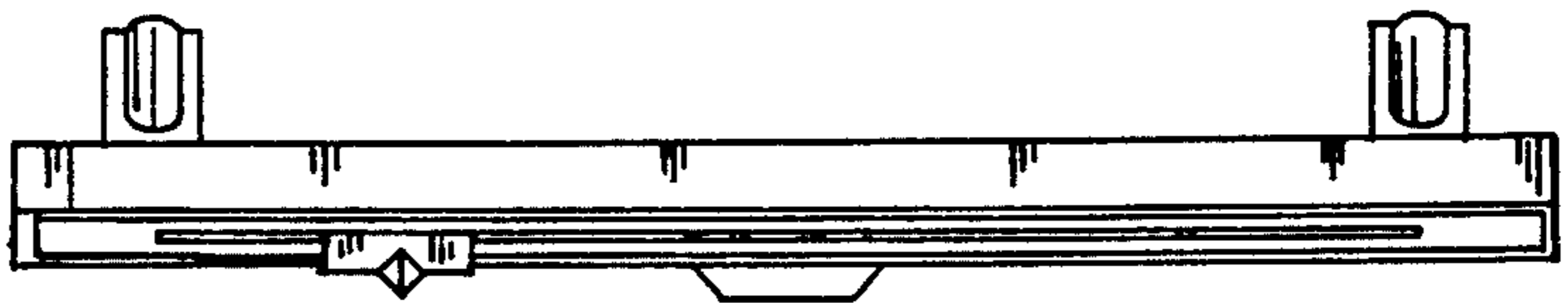

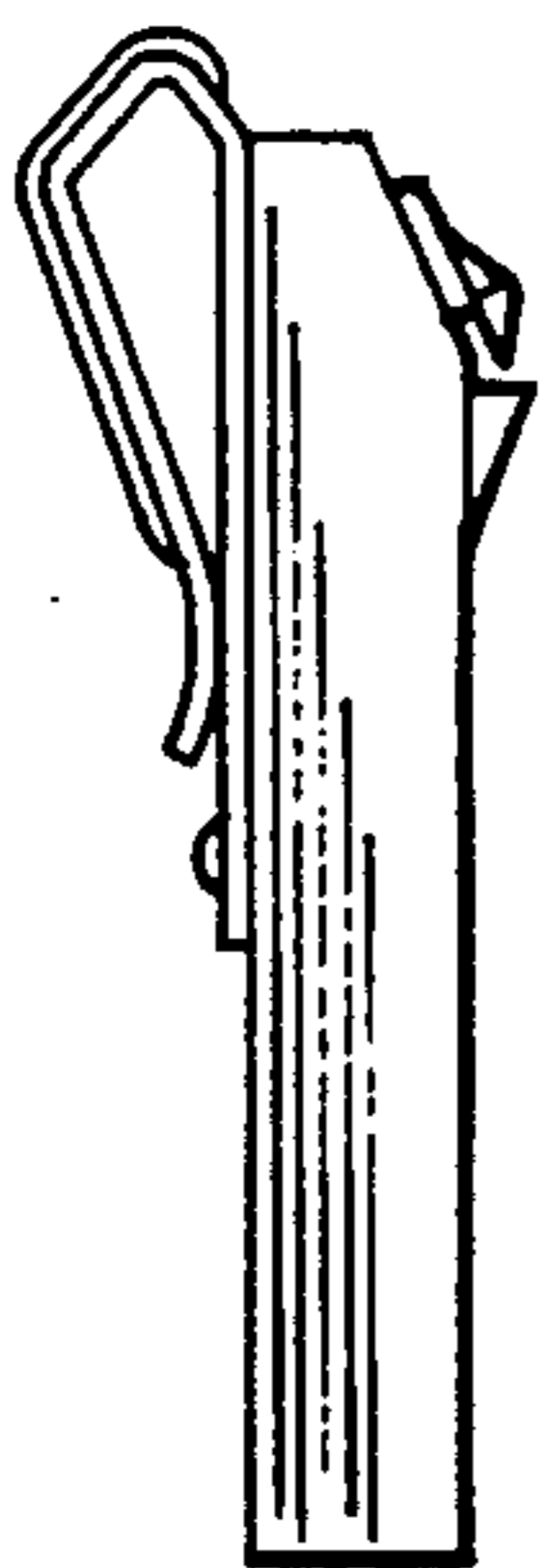

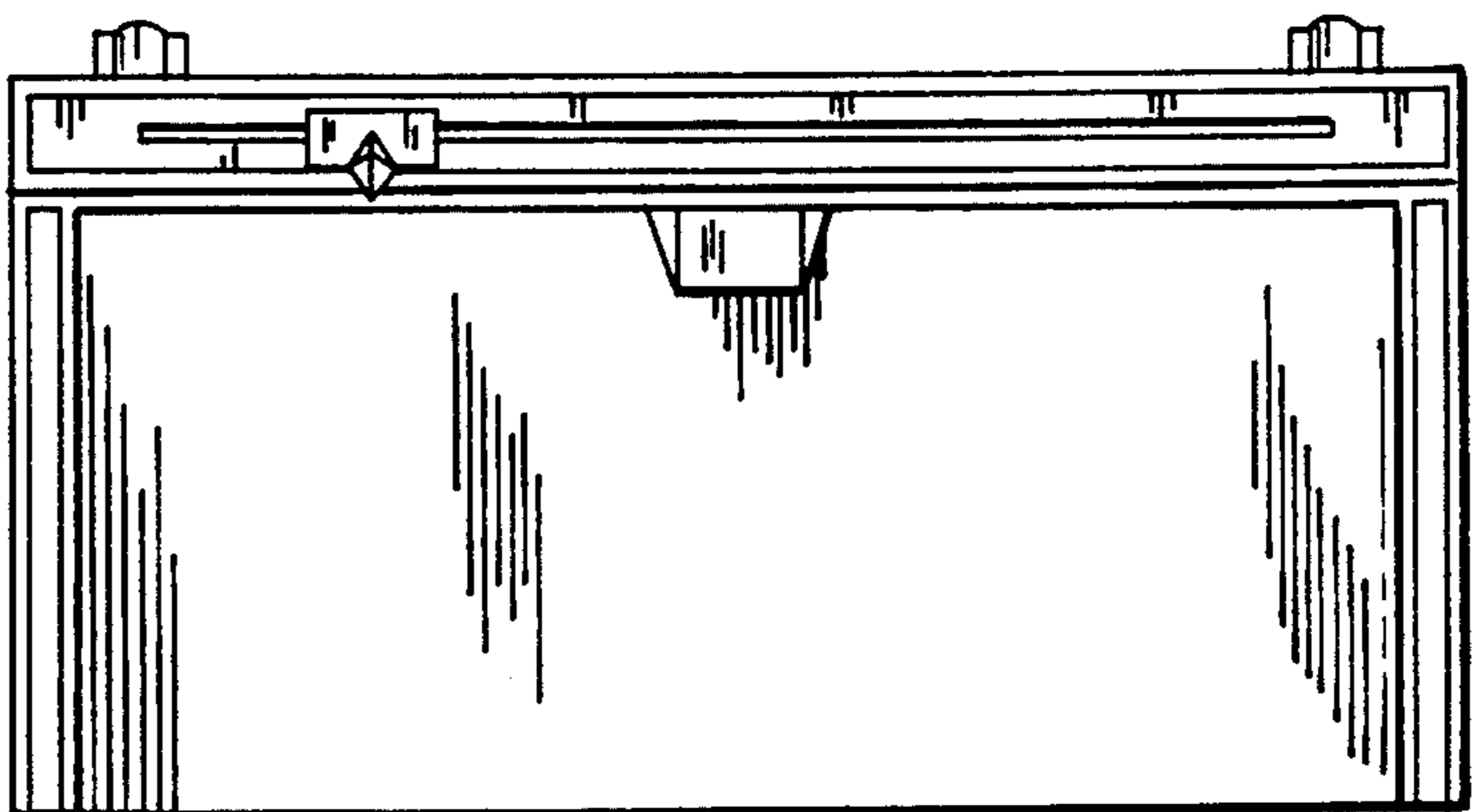

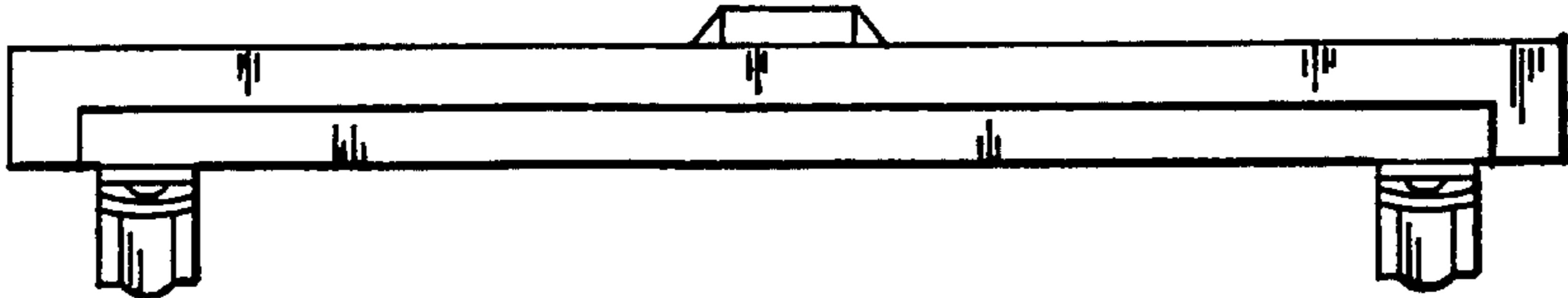

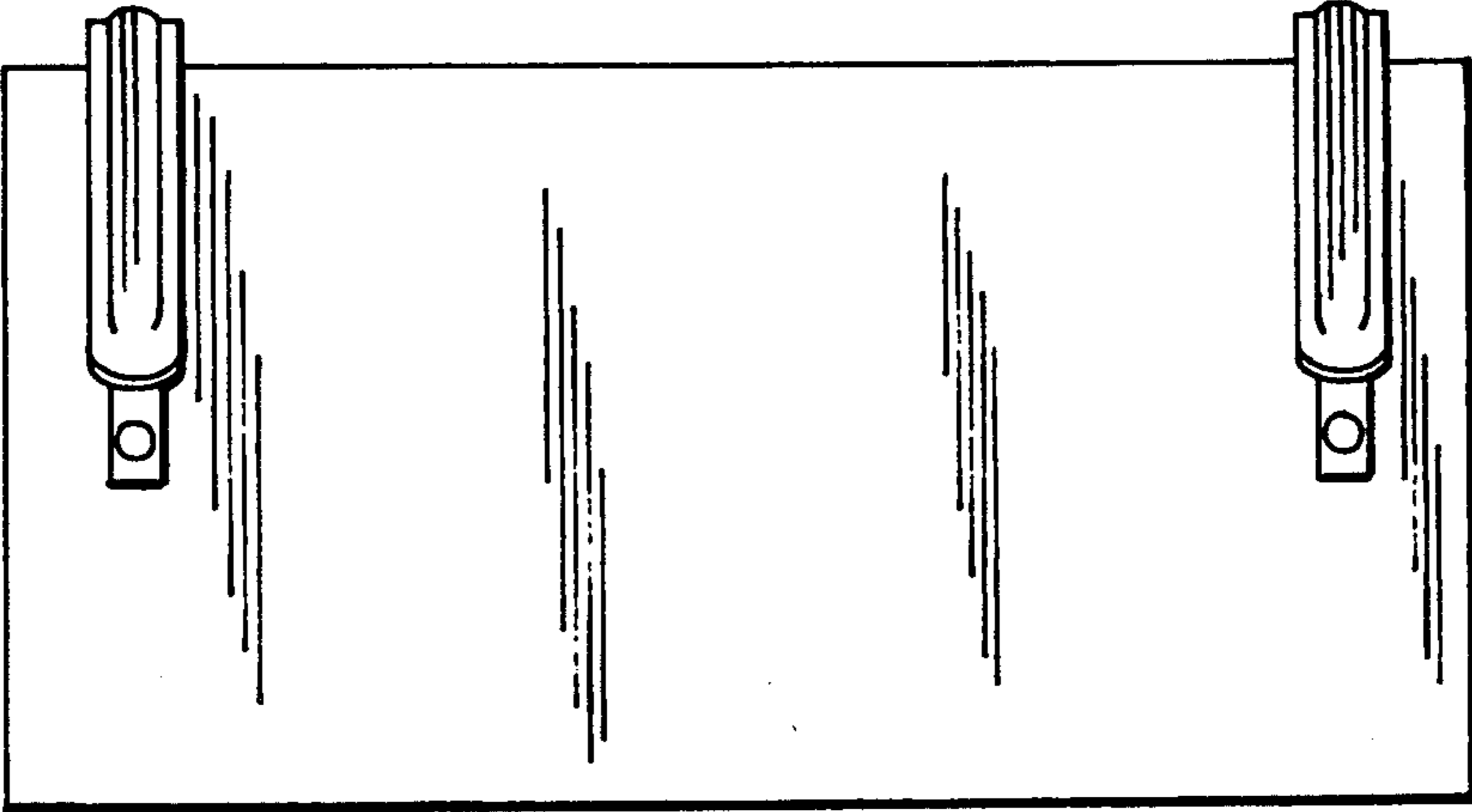
