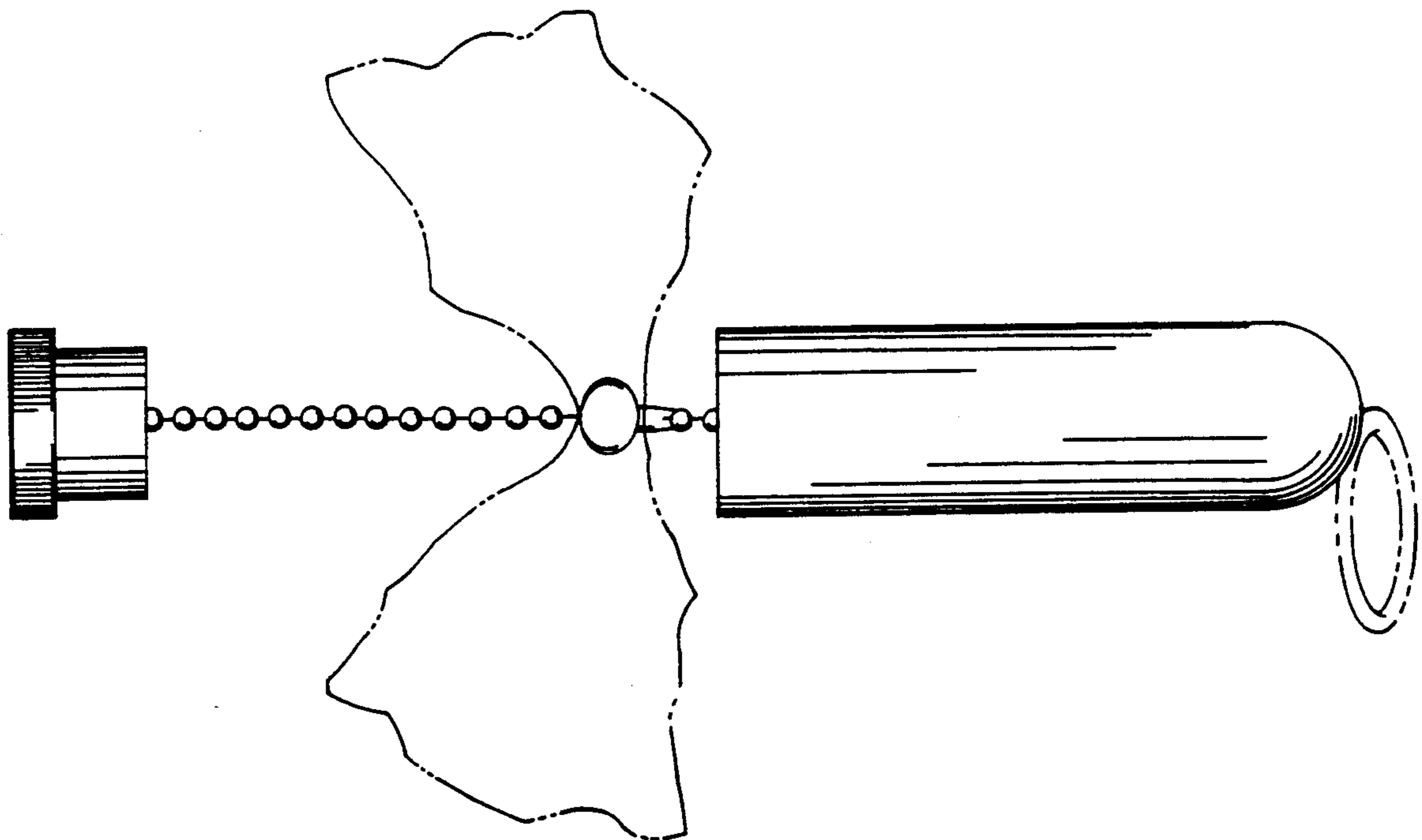

[57] **CLAIM**

The ornamental design for a container for a removable lens cleaning material, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a container for a removable lens cleaning material showing my new design, the broken lines showing the key ring in this and subsequent figures being for illustrative purposes only and forming no part of the claimed design;

 FIG. 17 is a bottom plan view.



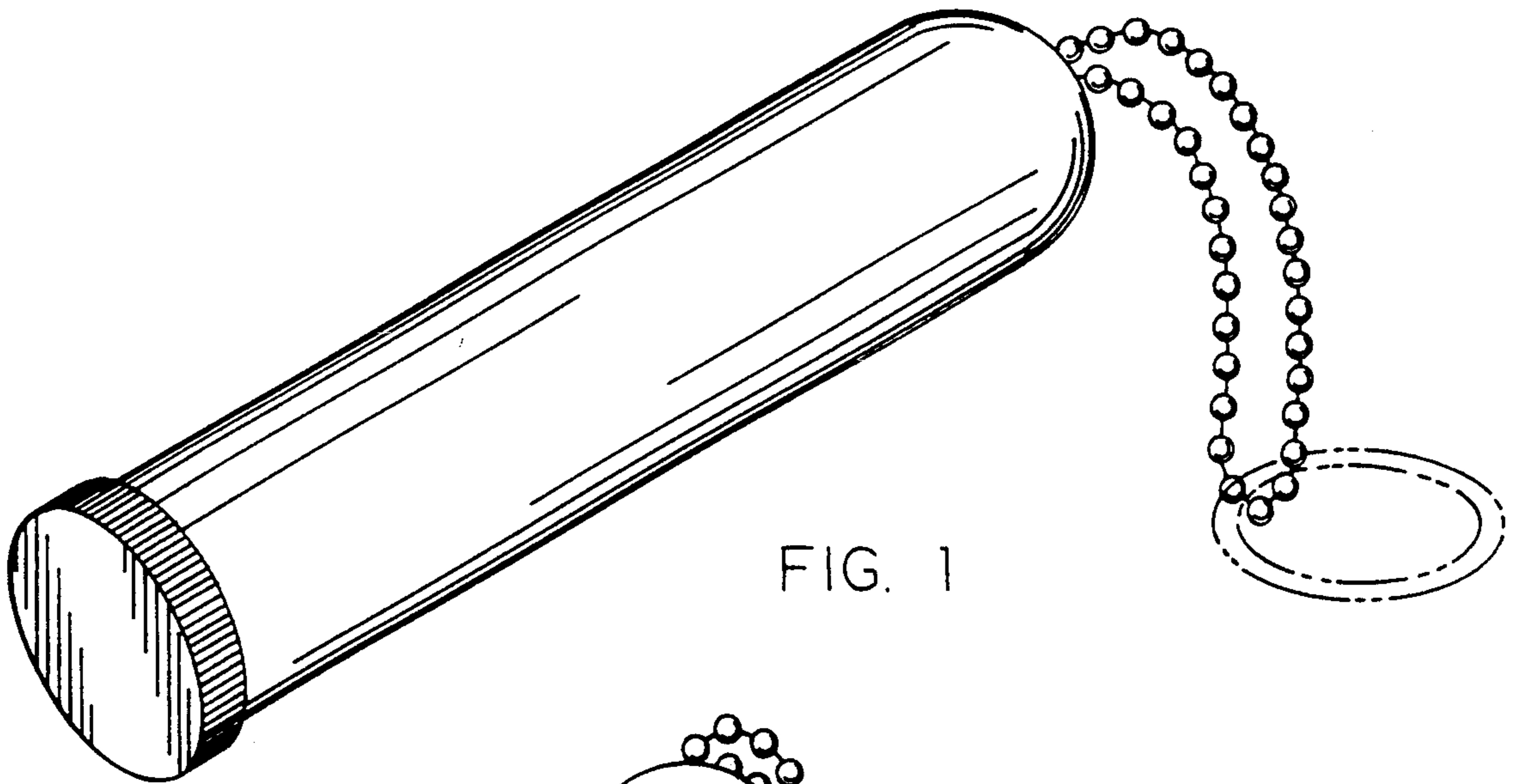

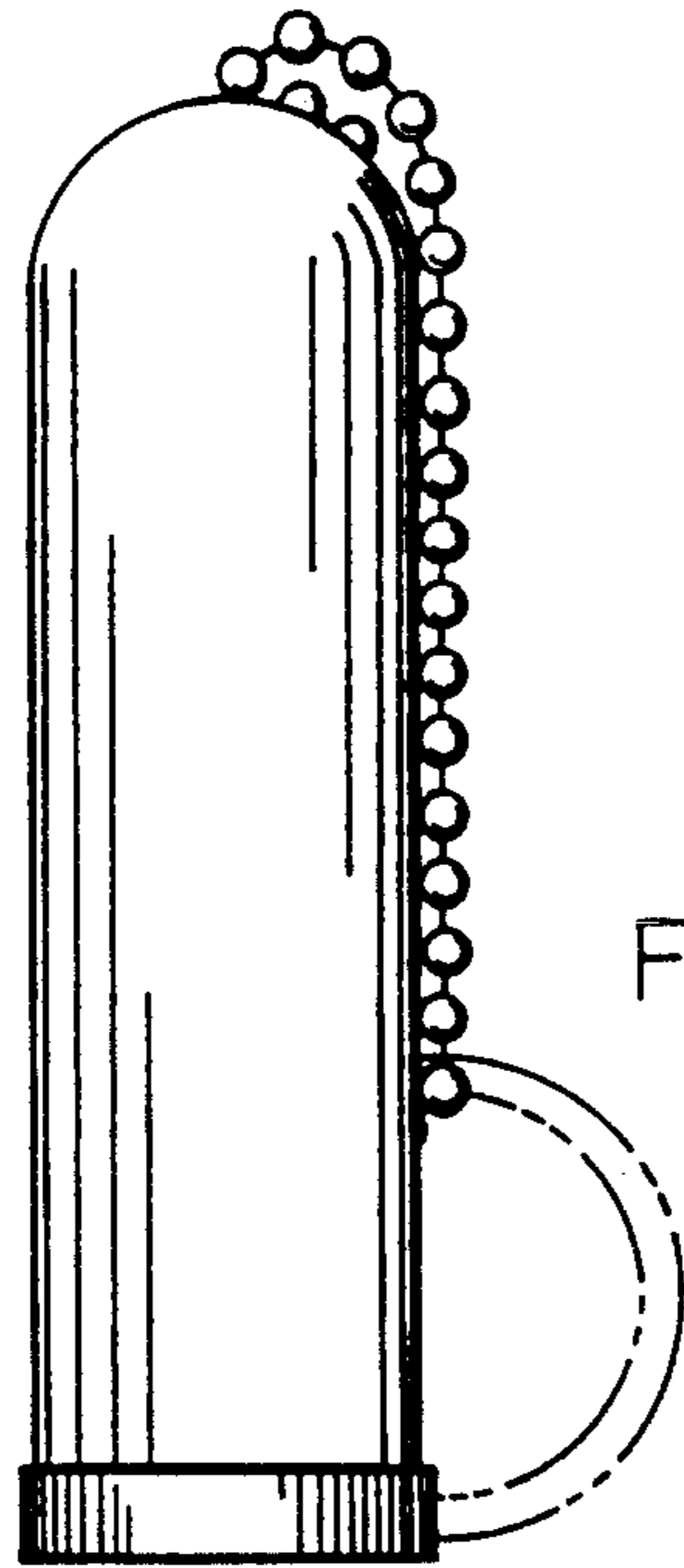

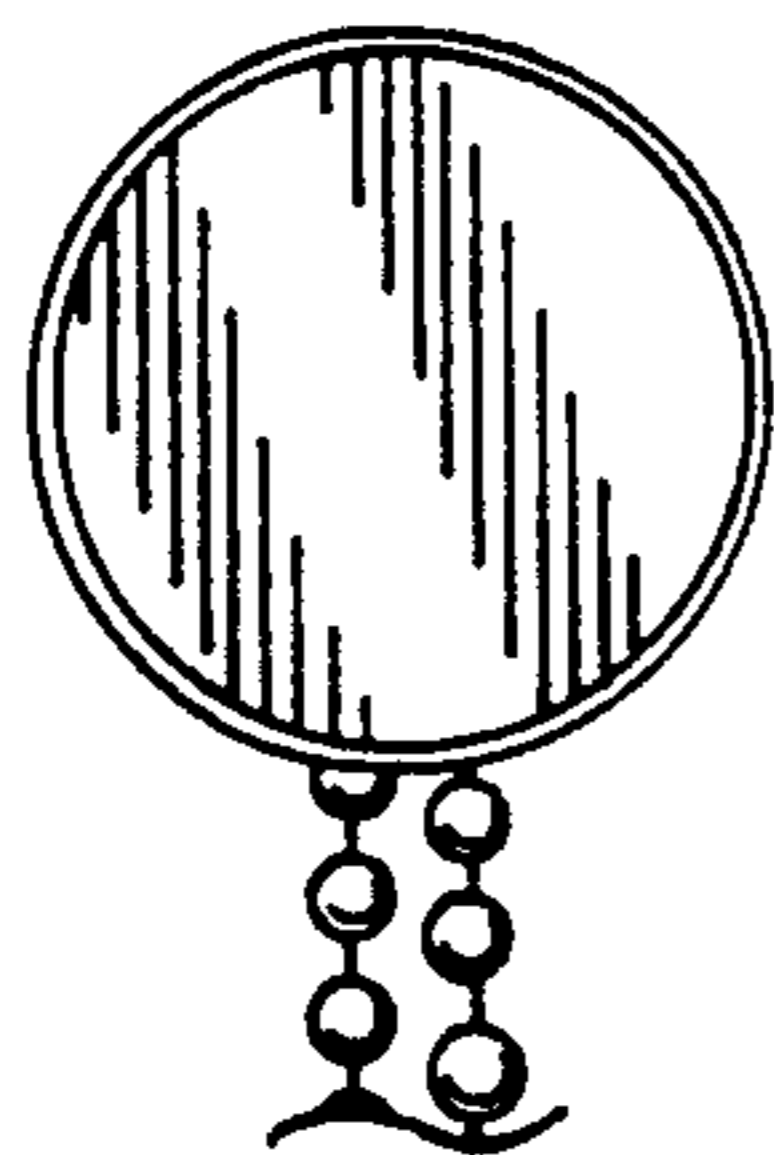

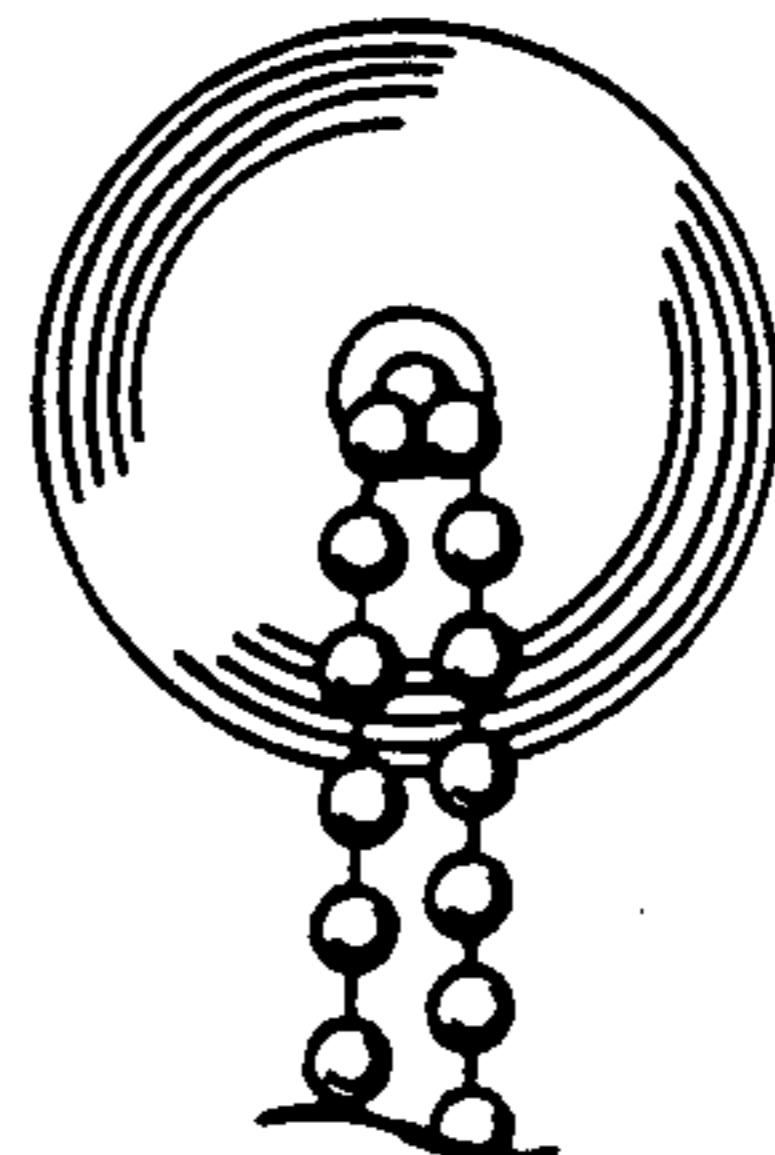

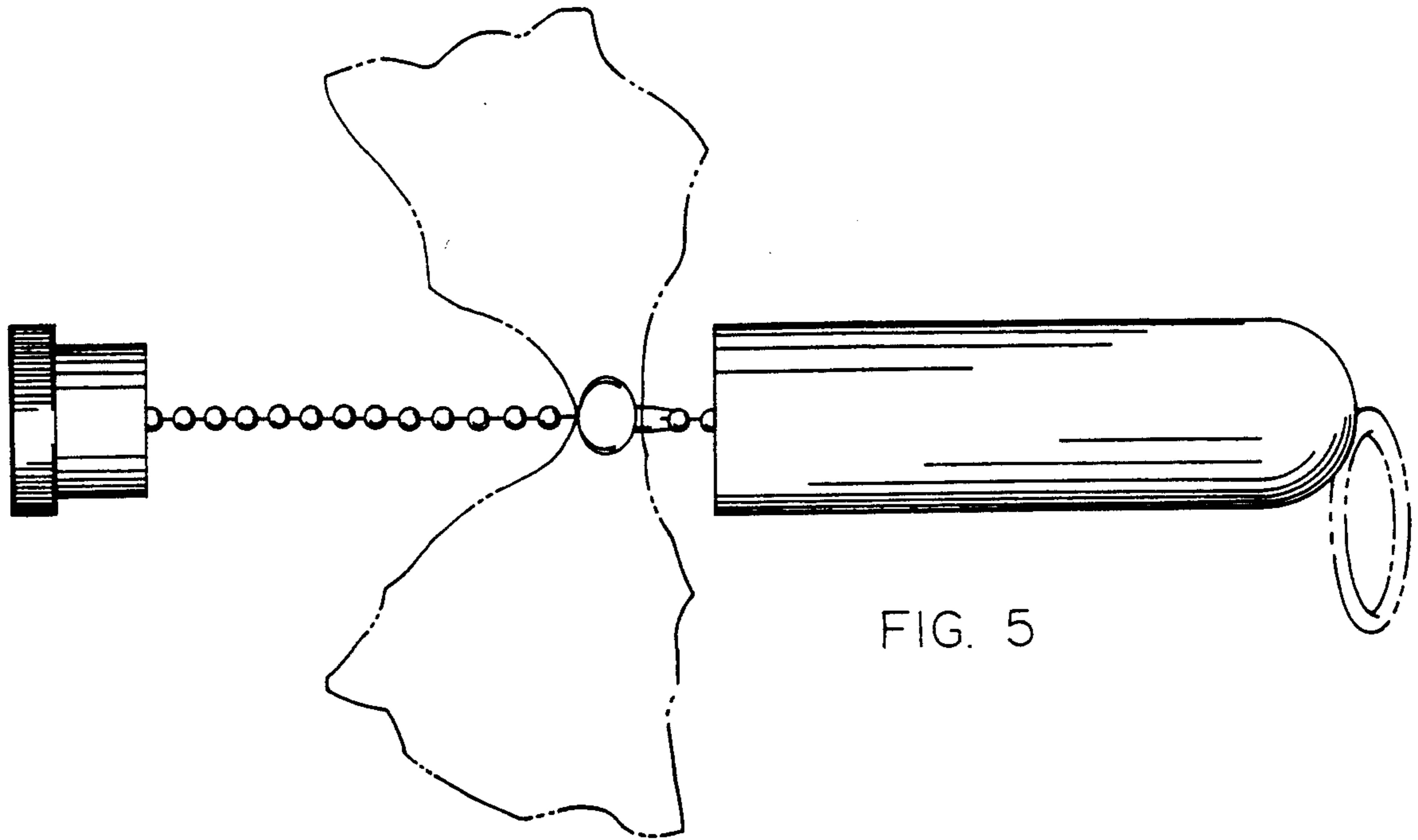

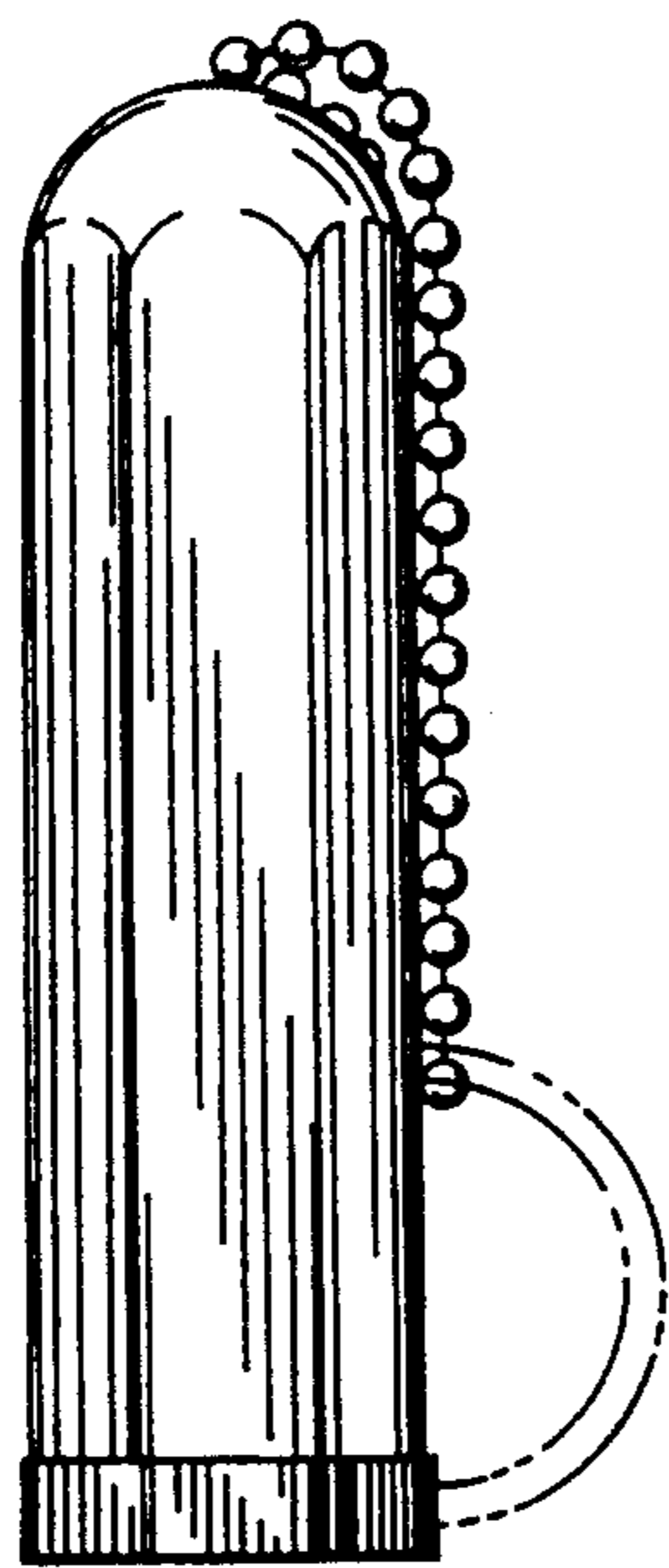

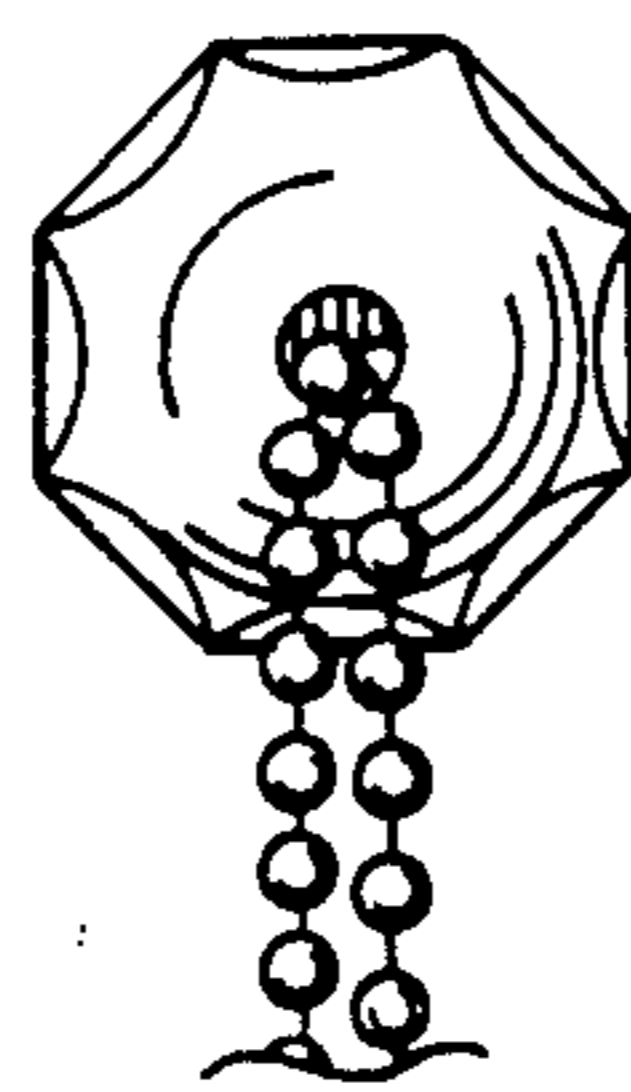

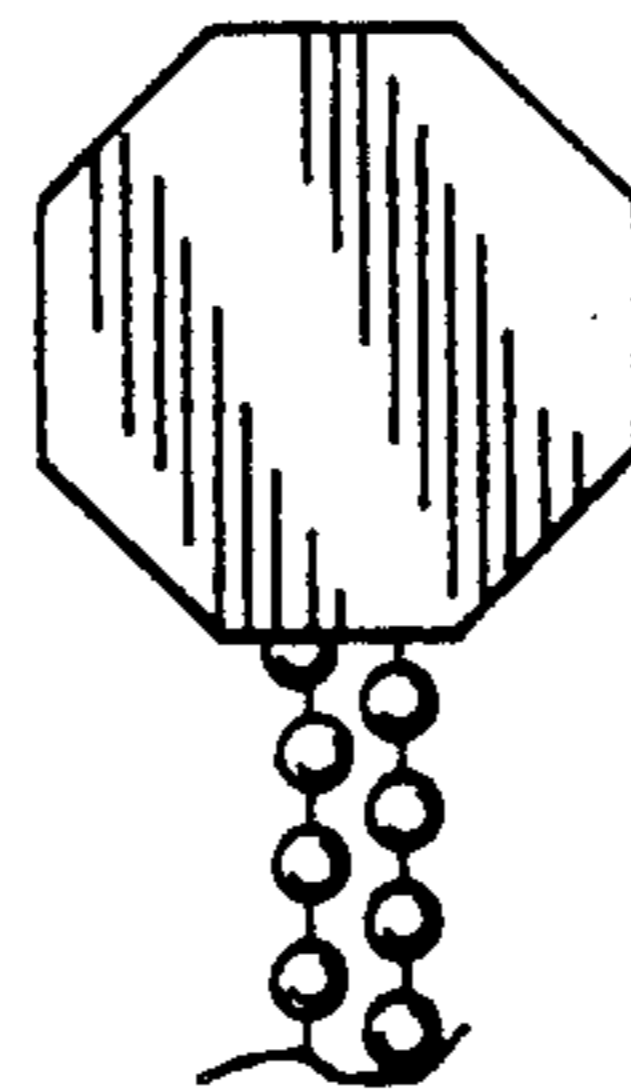

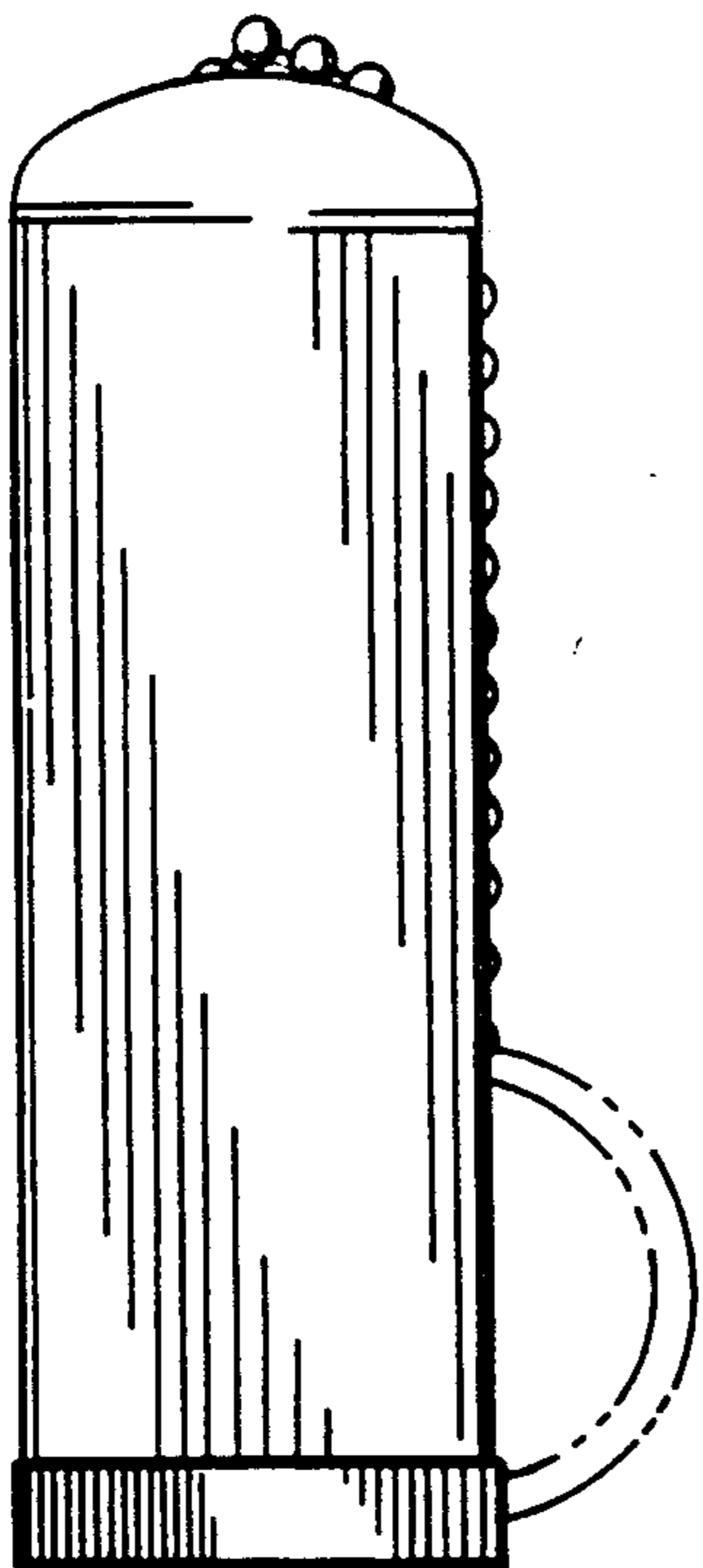

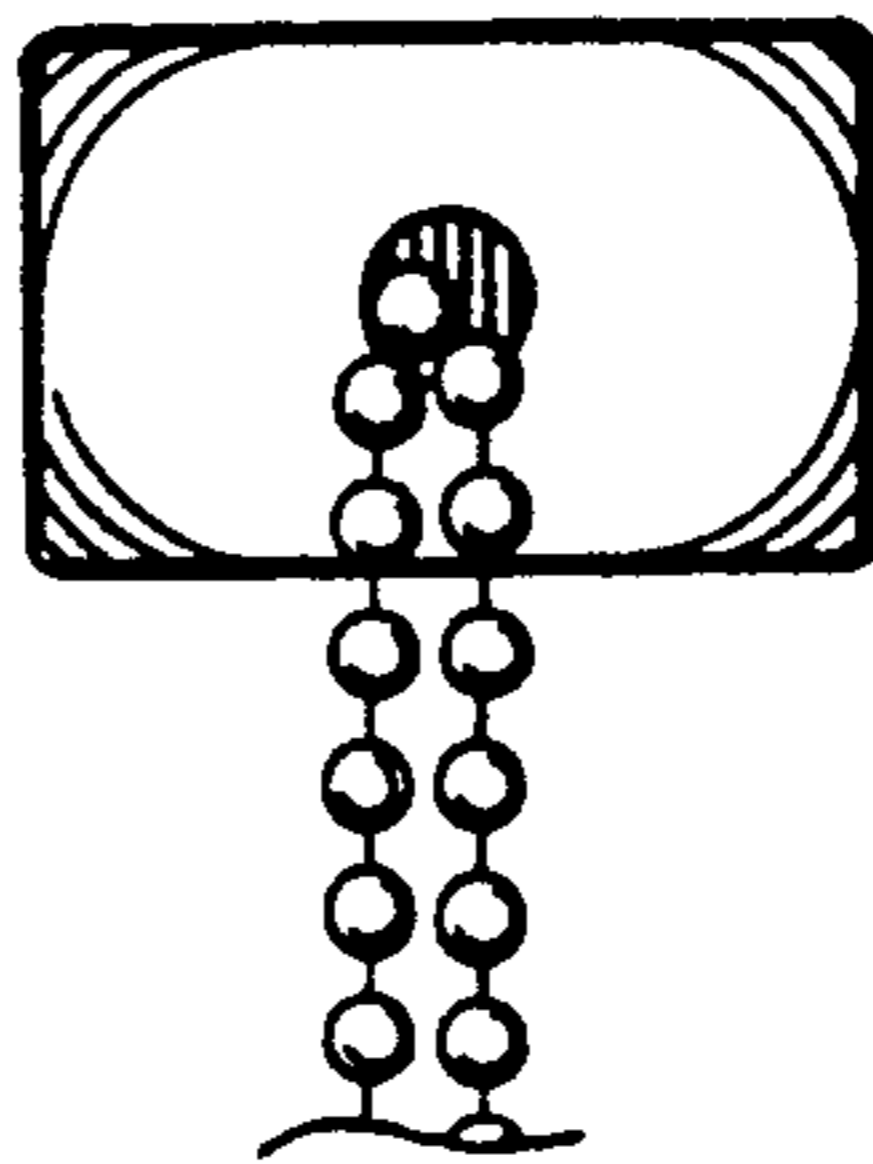

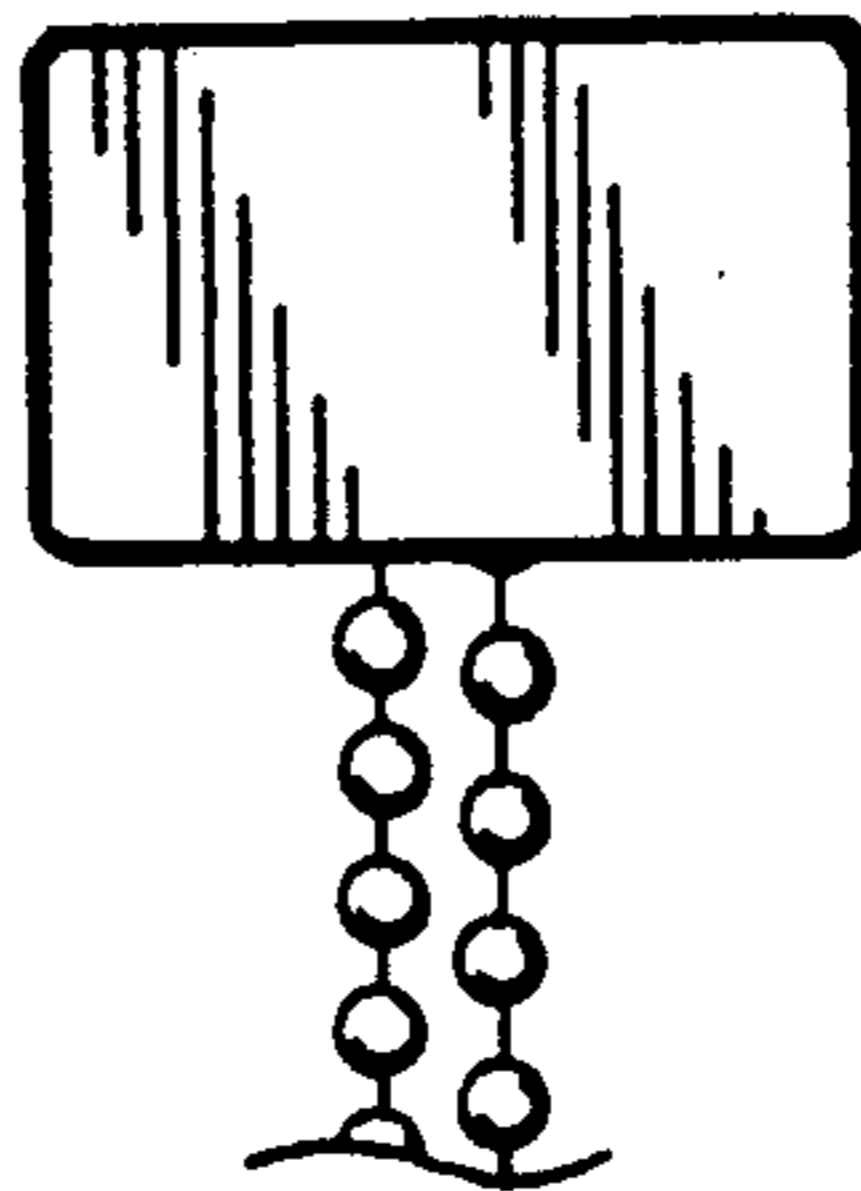

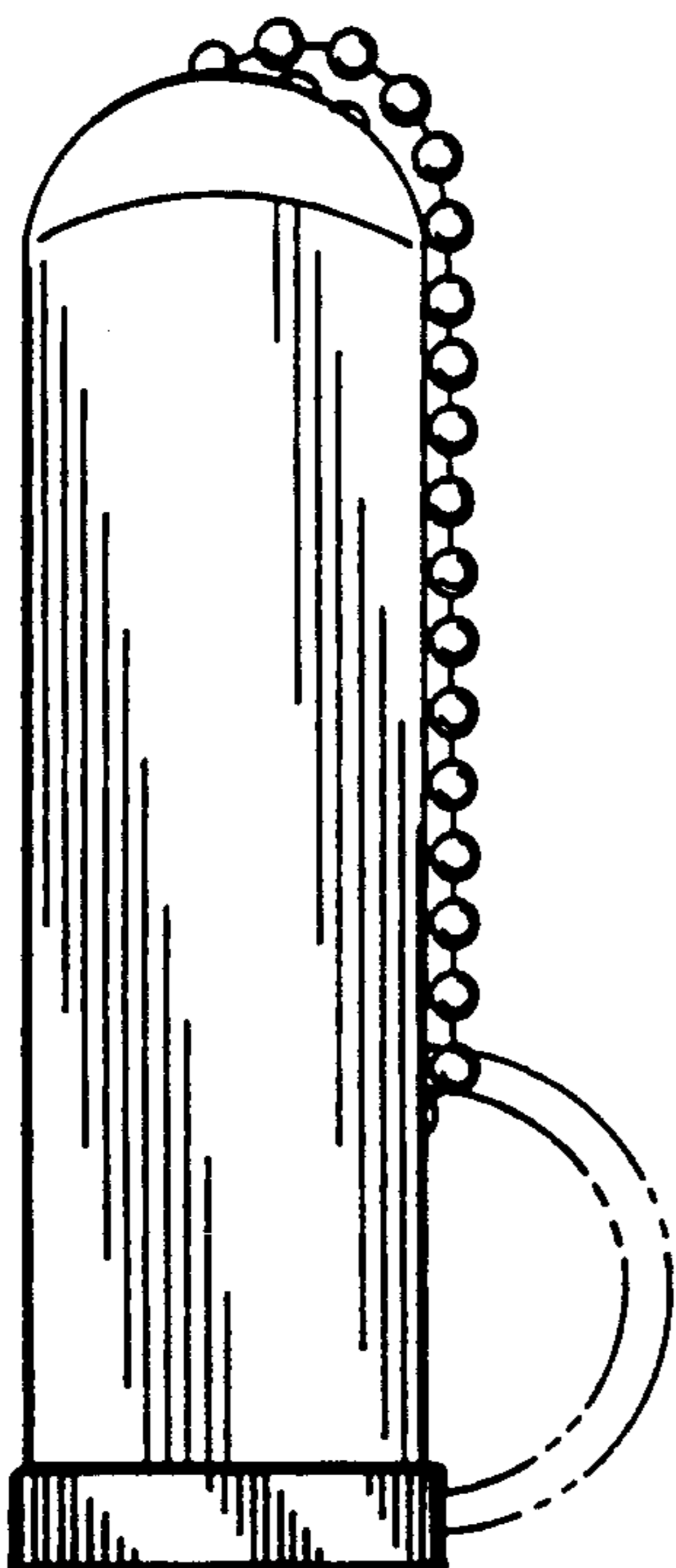

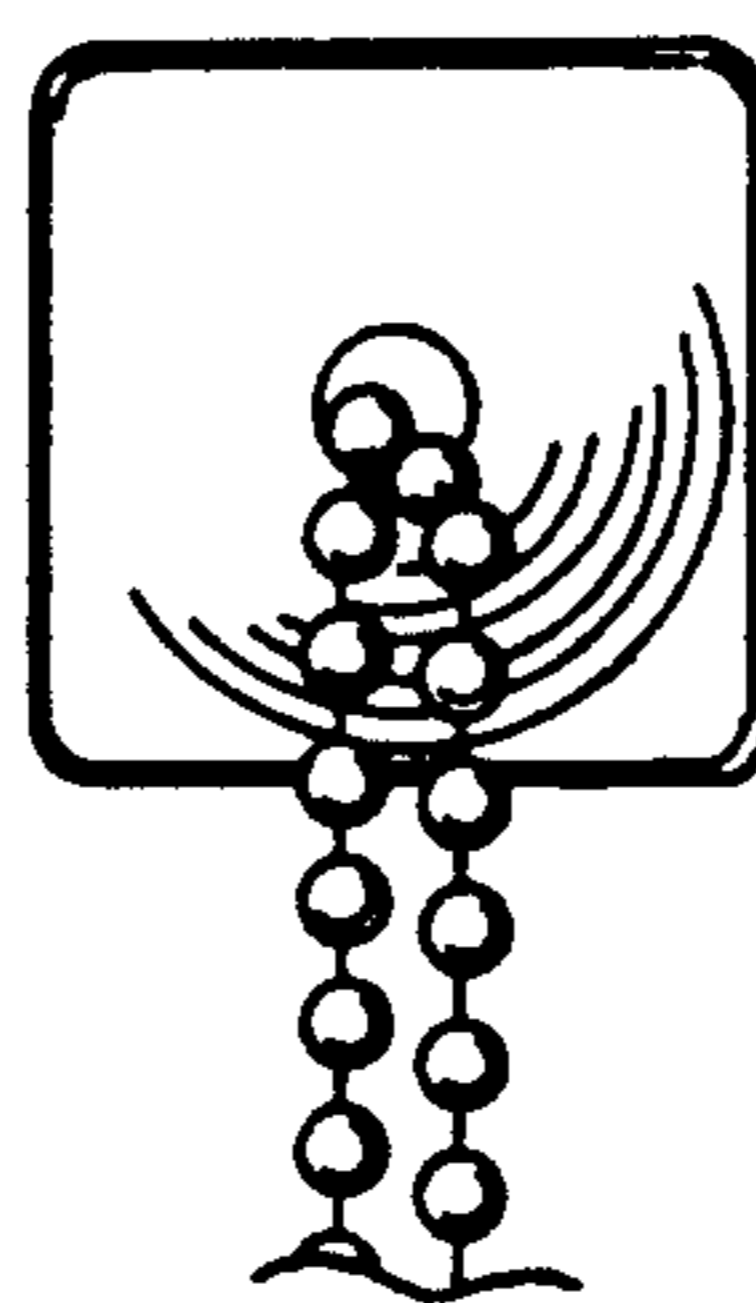

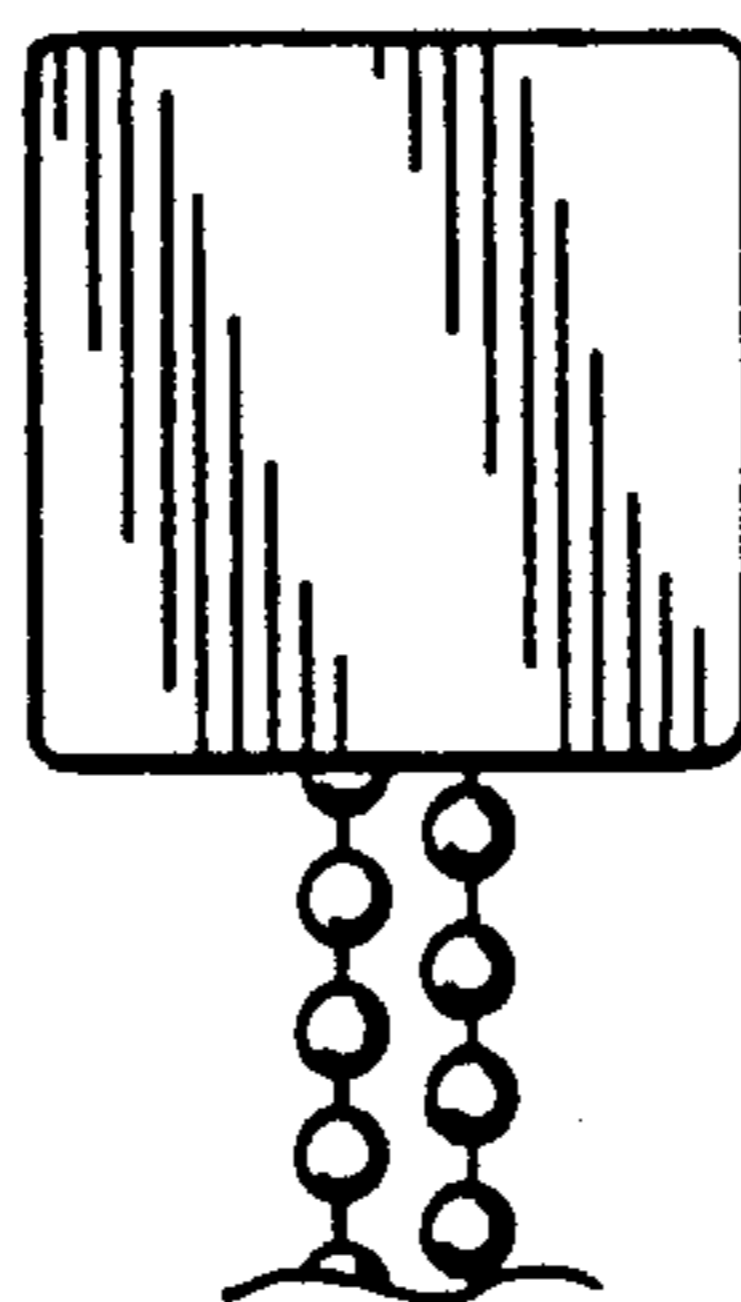

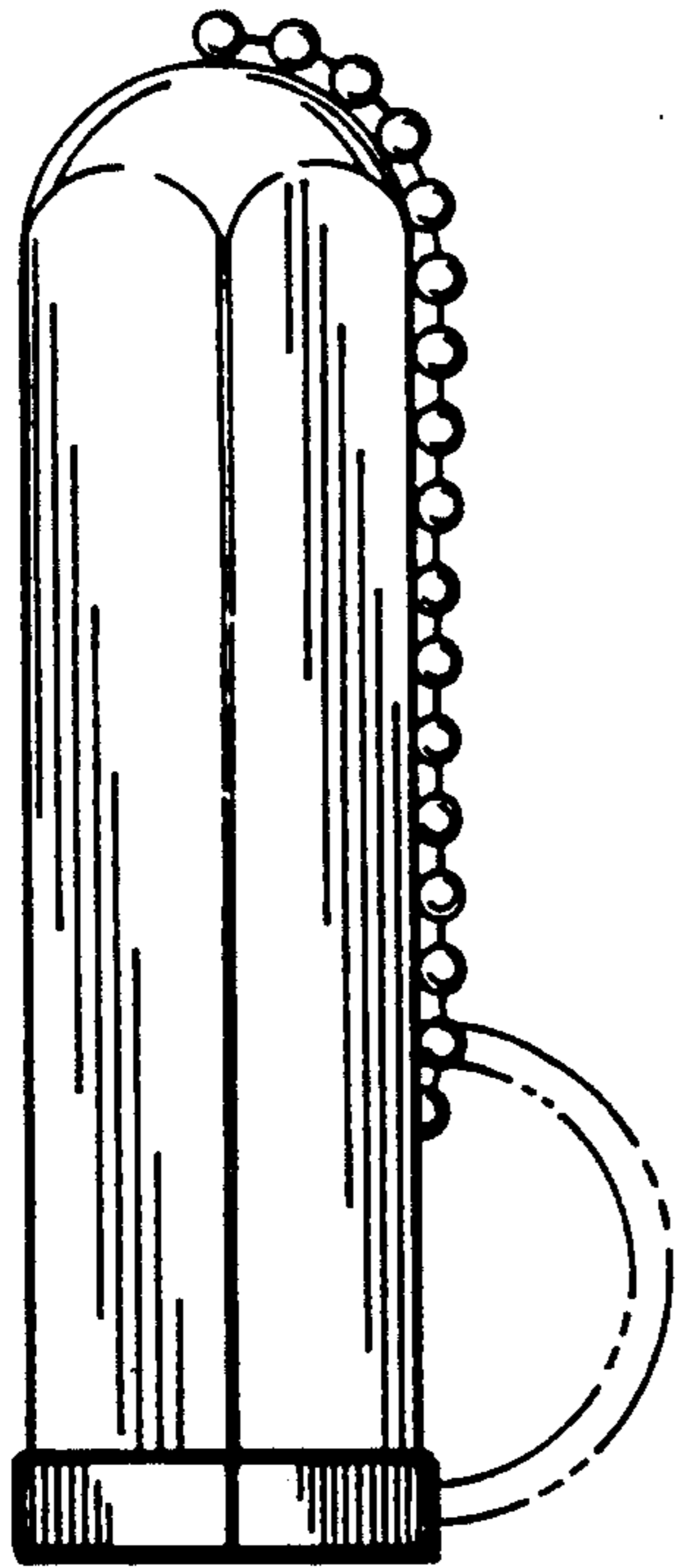

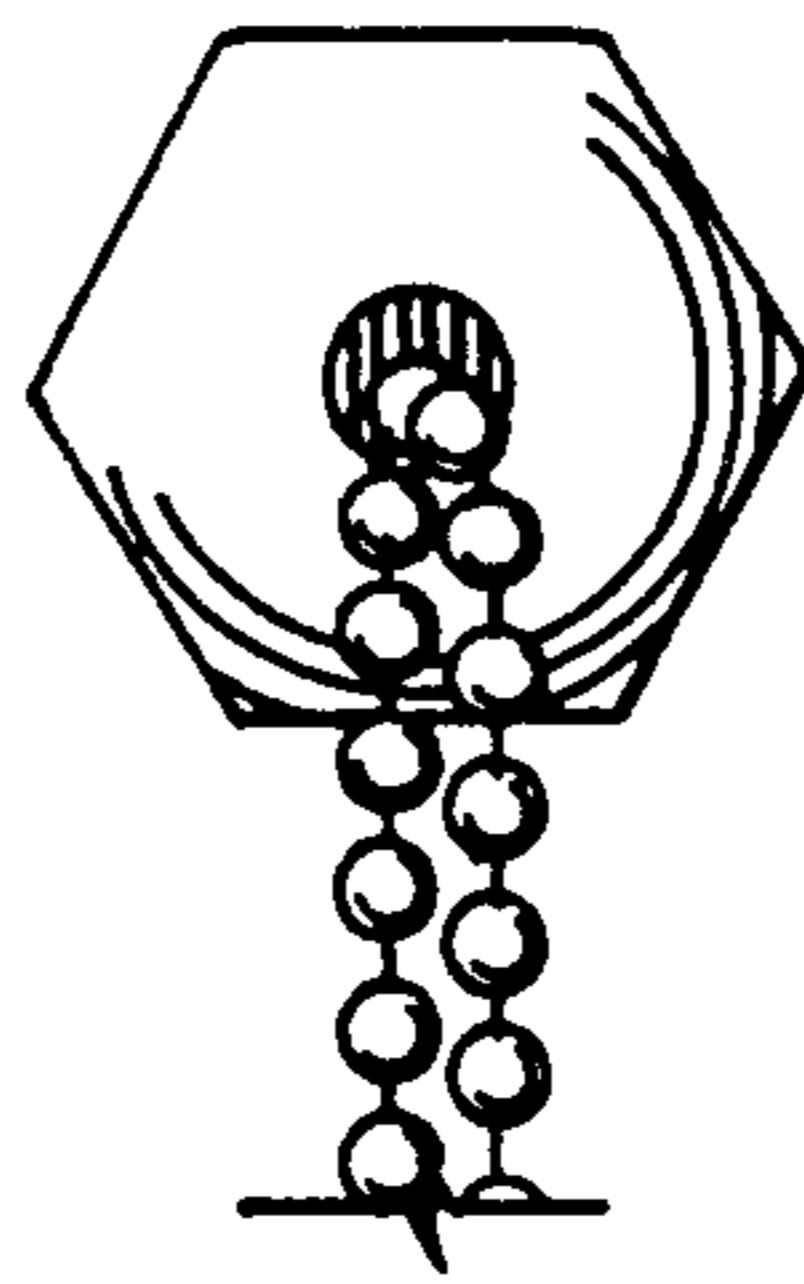

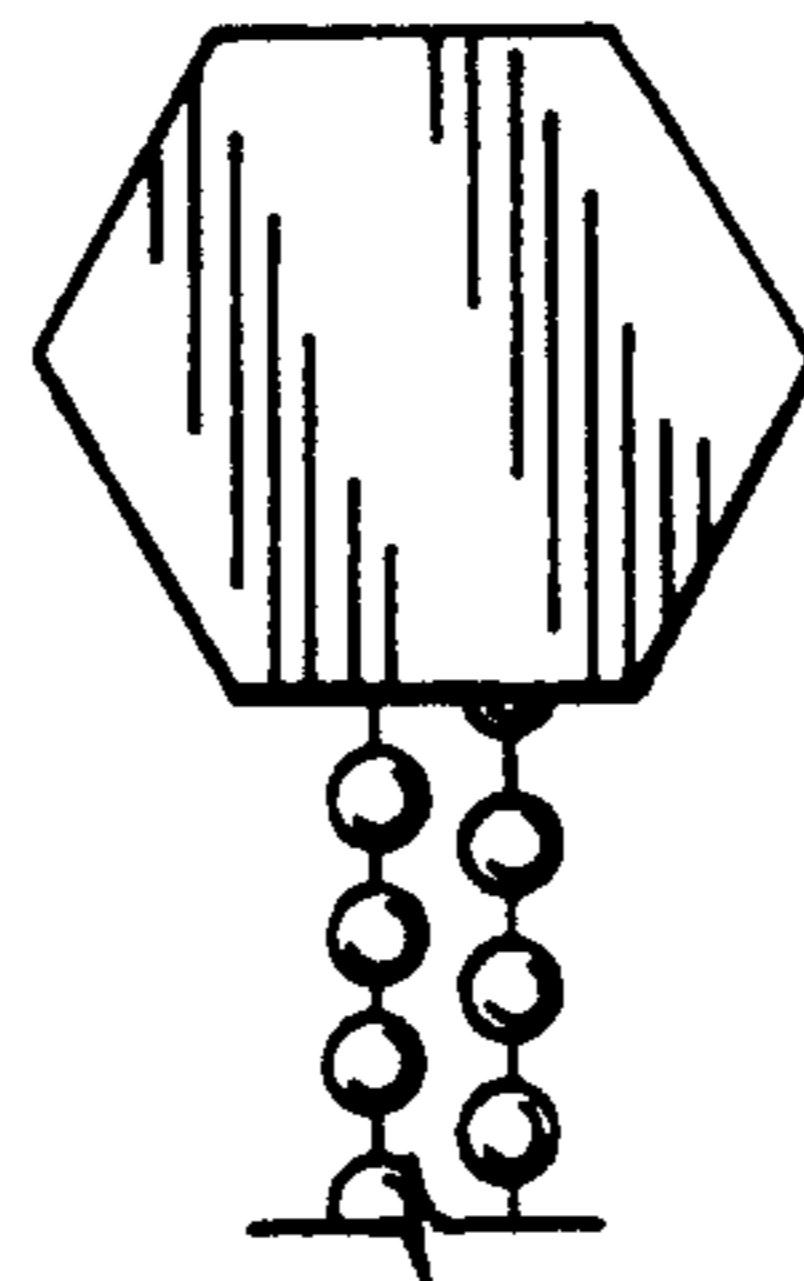
