[57] **CLAIM**

The ornamental design for a poly-v pulley, as shown and described.

**DESCRIPTION**

FIG. 1 is a top plan view of a poly-v pulley embodying my new design;  
 FIG. 2 is a front elevation view thereof, the view from the opposite side being substantially the same;  
 FIG. 3 is a side elevation view thereof, the view from the opposite side being substantially the same;  
 FIG. 4 is a bottom plan view thereof;  
 FIG. 5 is a section view along lines 5—5 in FIG. 1;  
 FIG. 6 is a top plan view of a further embodiment thereof, including holes in the body;  
 FIG. 7 is a front elevation of the embodiment of FIG. 6, the view from the opposite side being substantially the same;  
 FIG. 8 is a side elevation view thereof, the view from the opposite side being substantially the same;  
 FIG. 9 is a bottom plan view thereof;  
 FIG. 10 is a section view along lines 10—10 in FIG. 6.

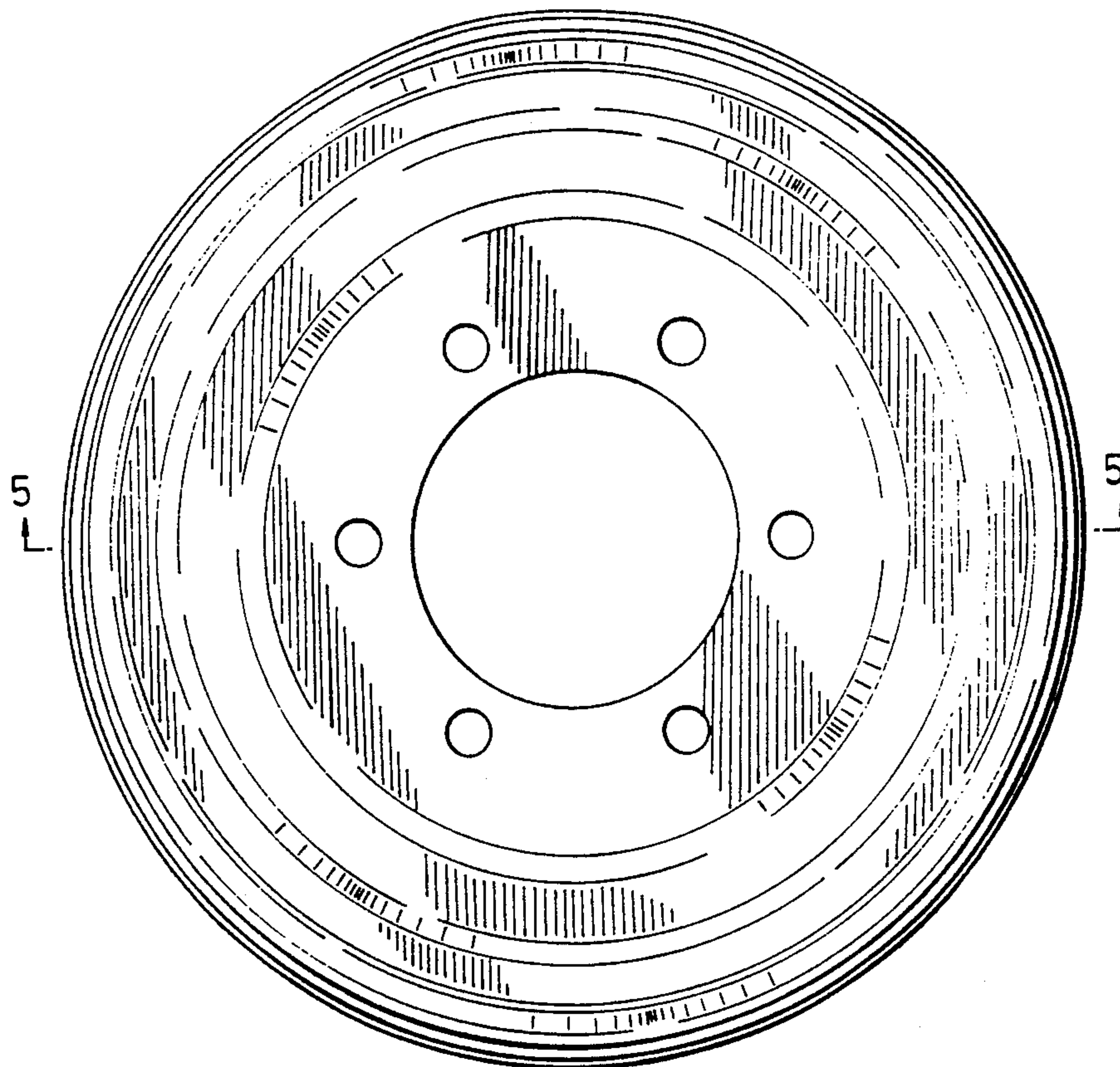

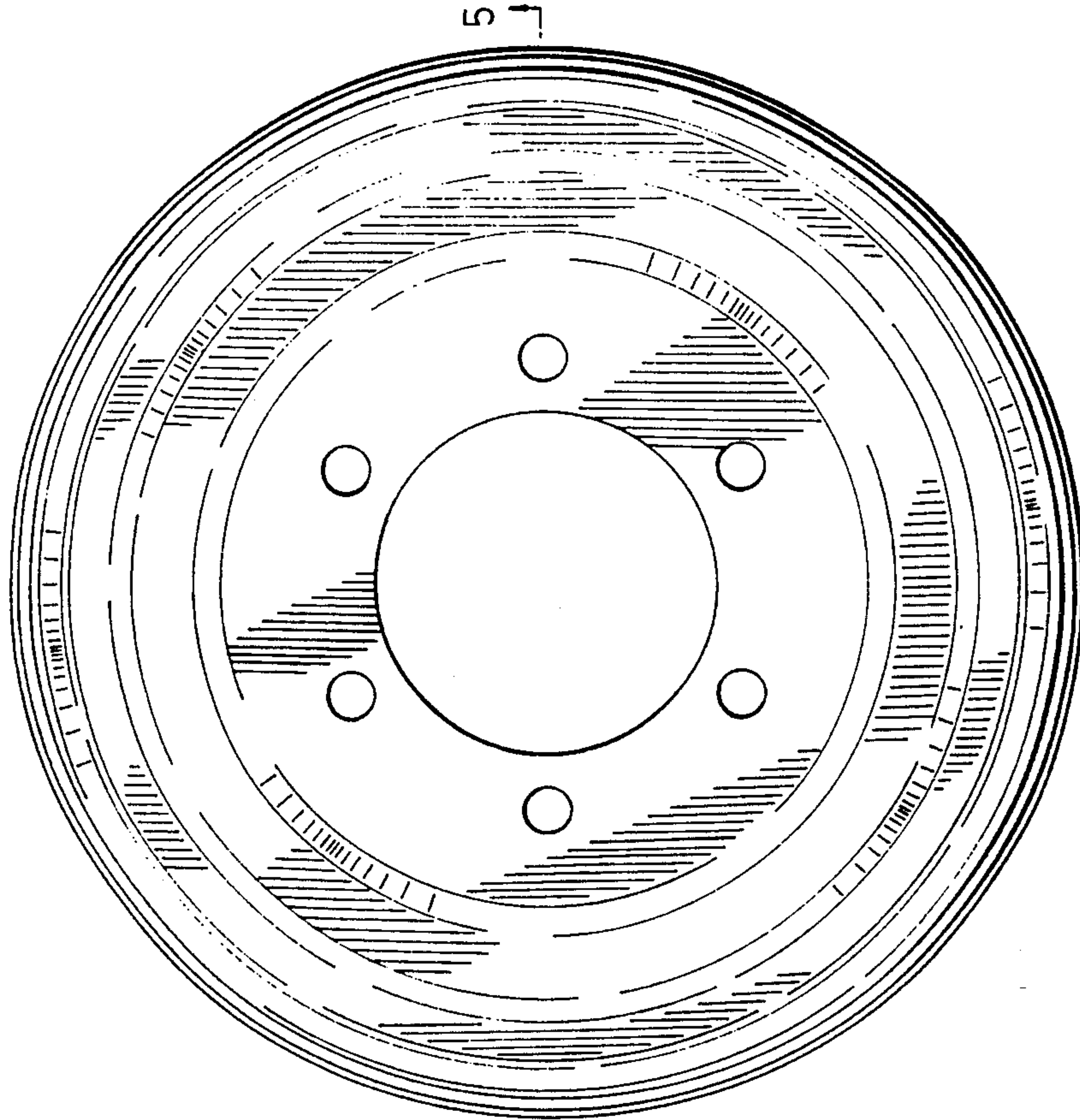

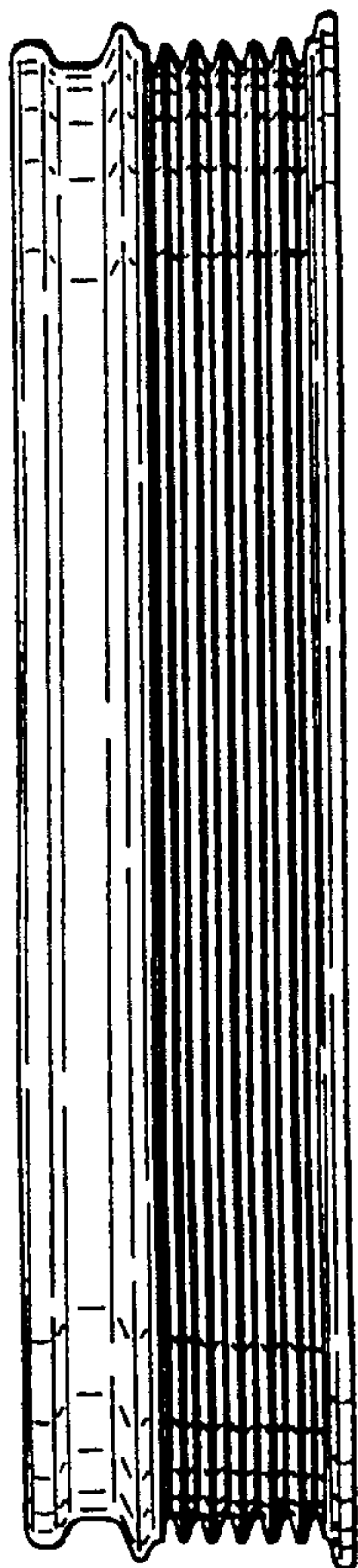
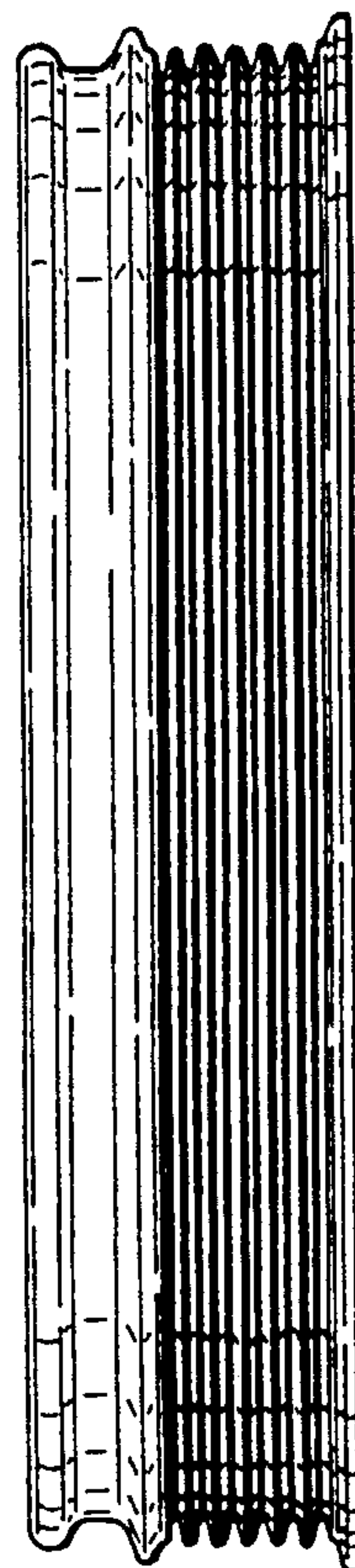

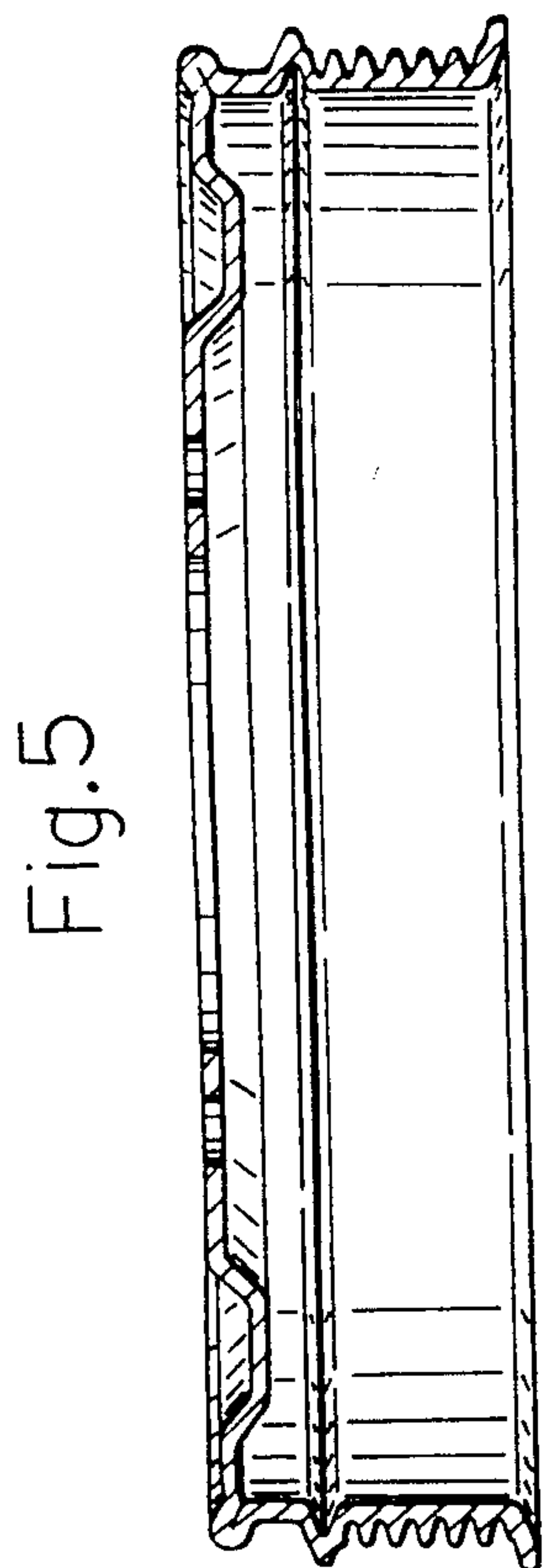

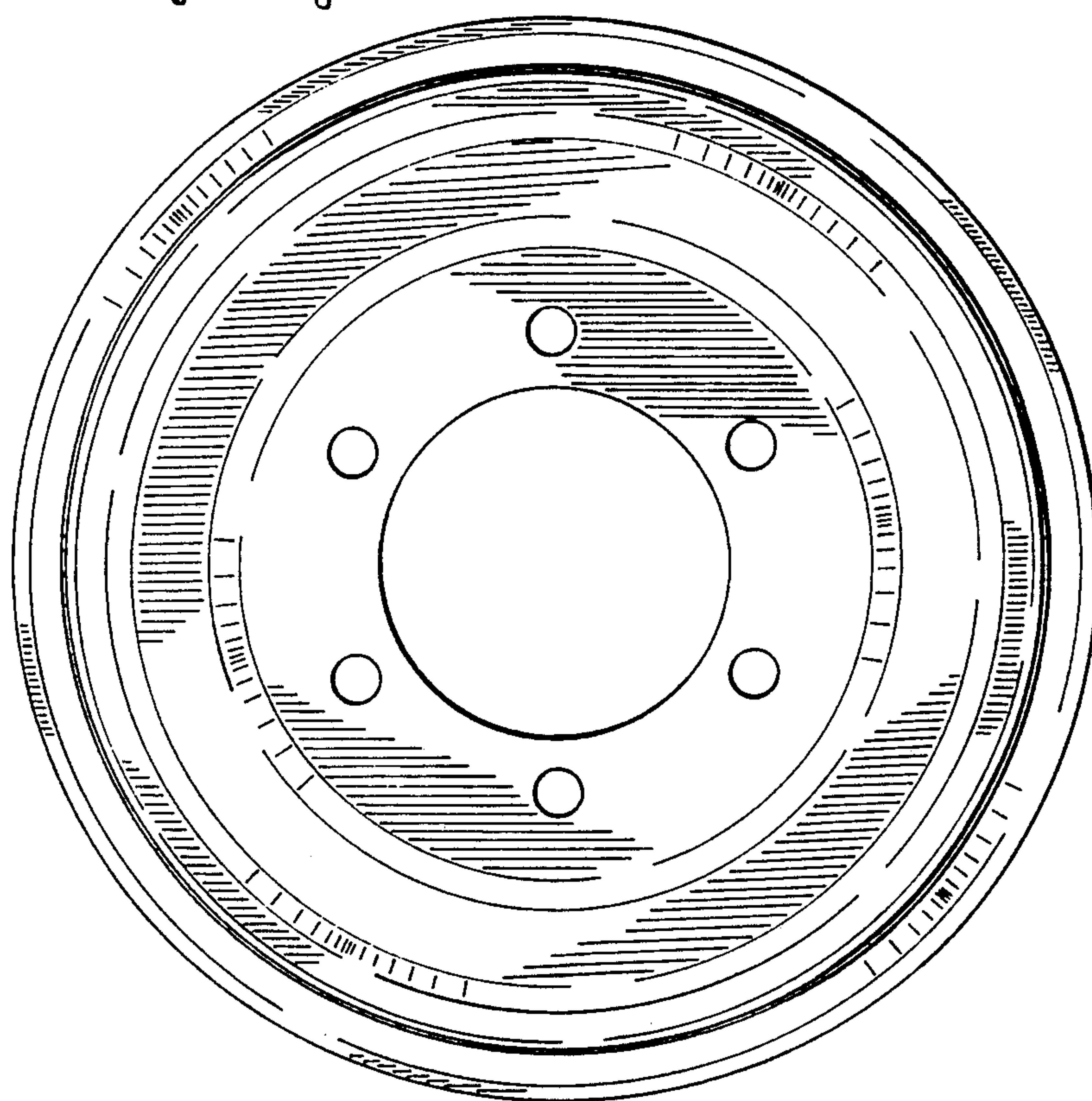

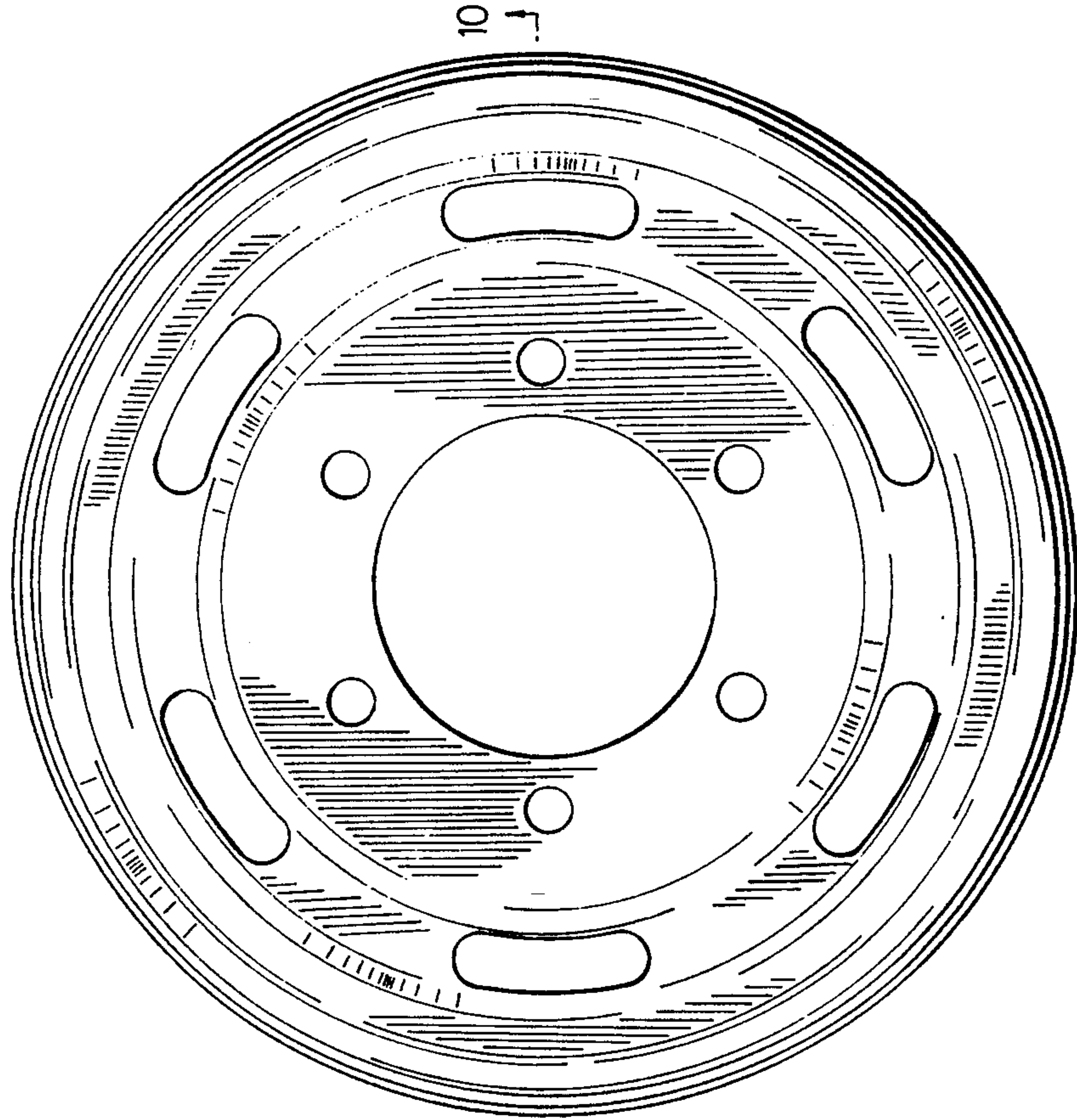

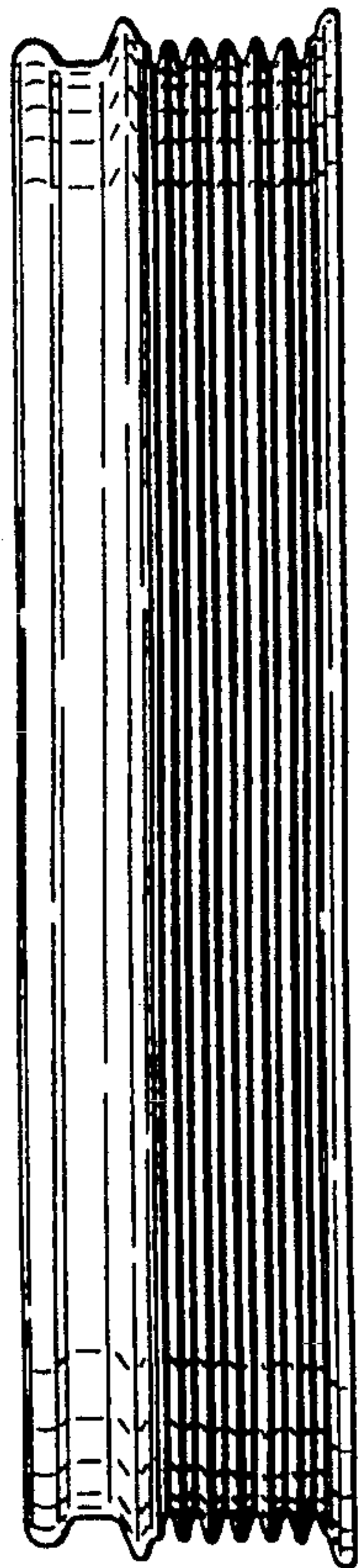

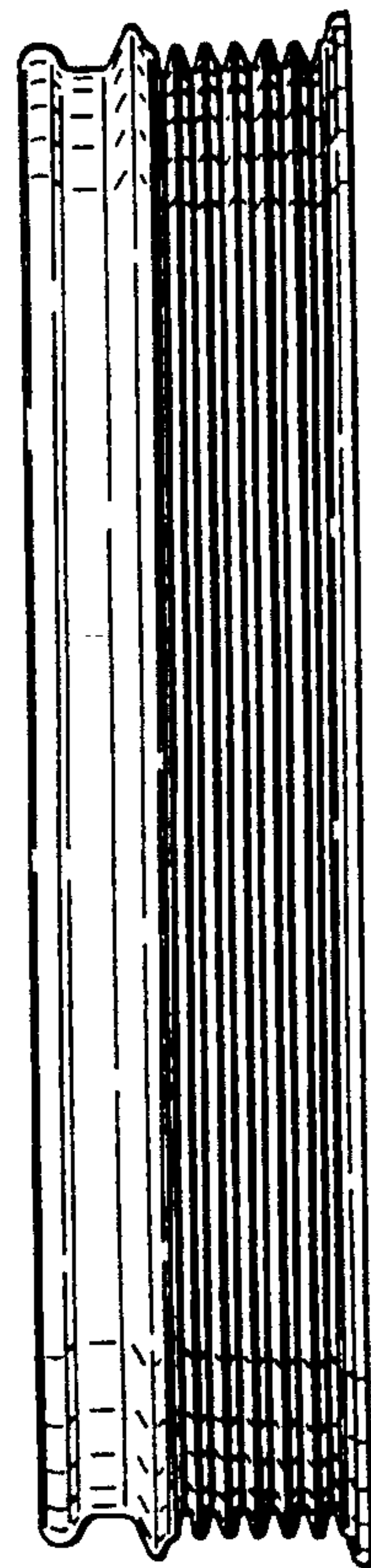

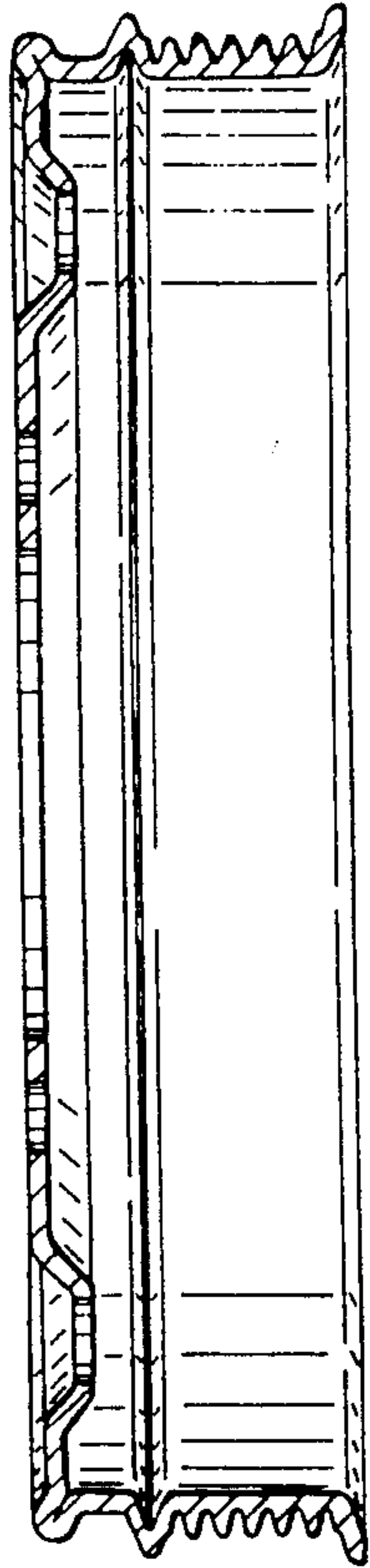
