FIG. 4 is a cross-sectional view thereof.

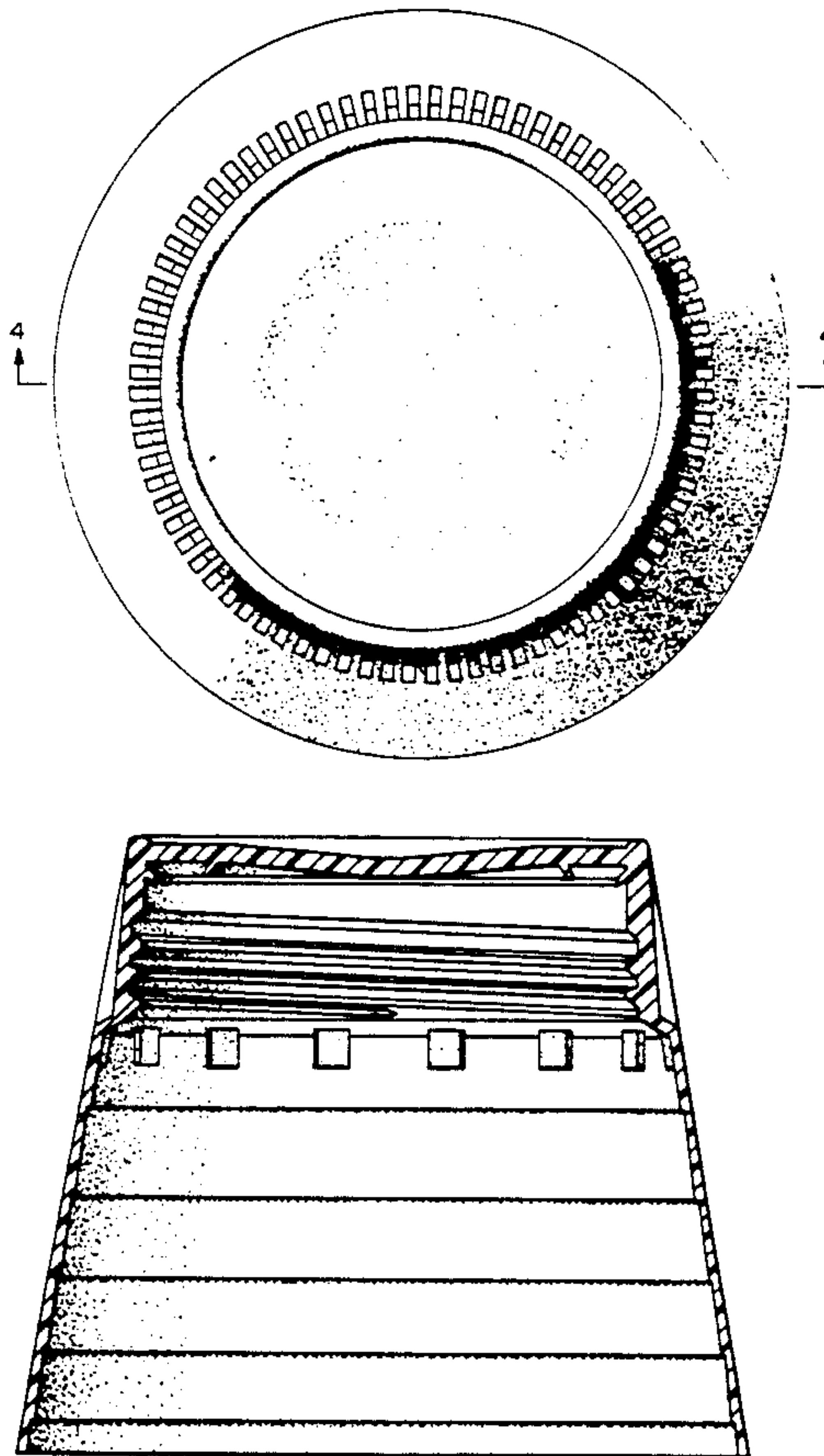

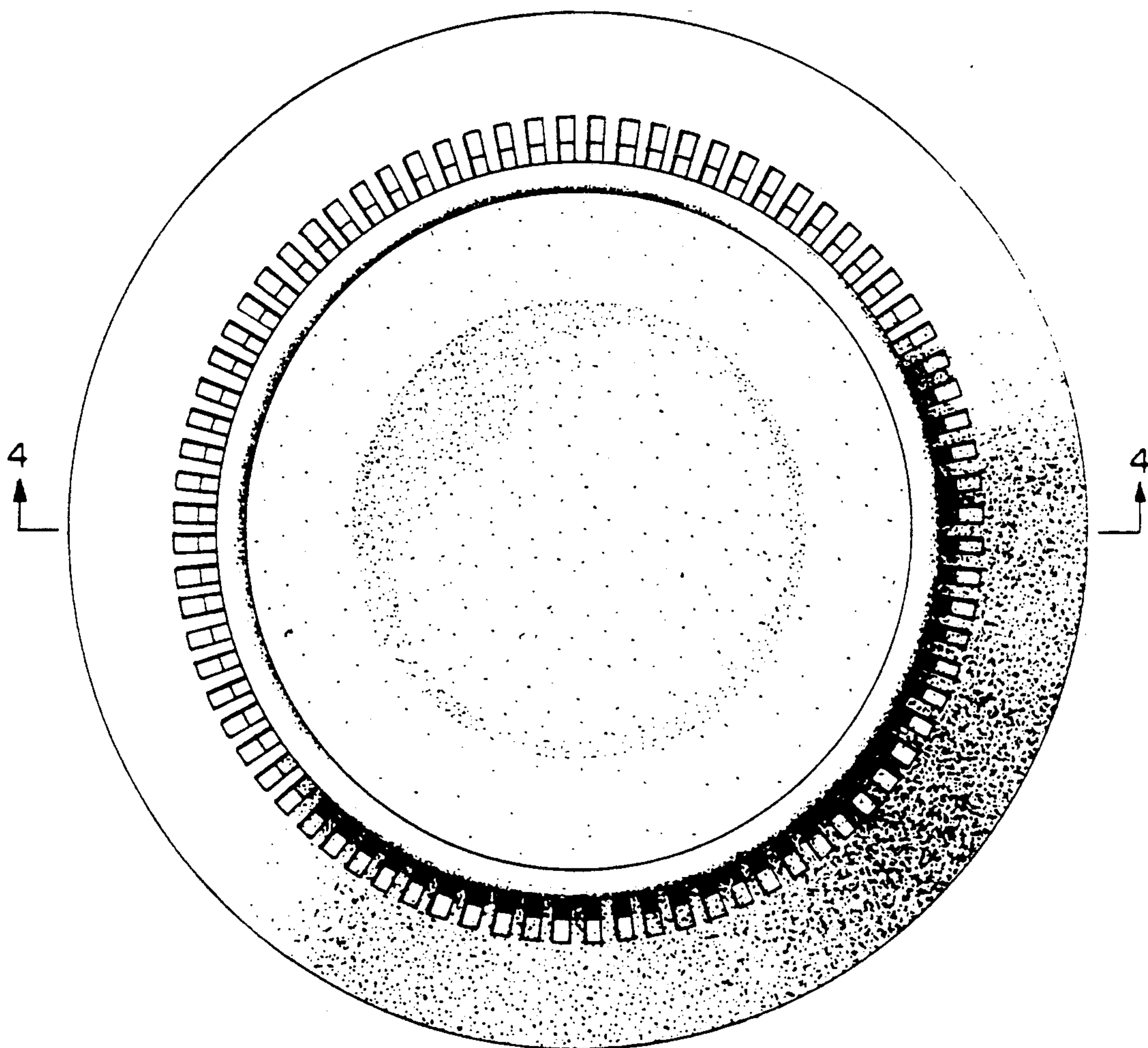

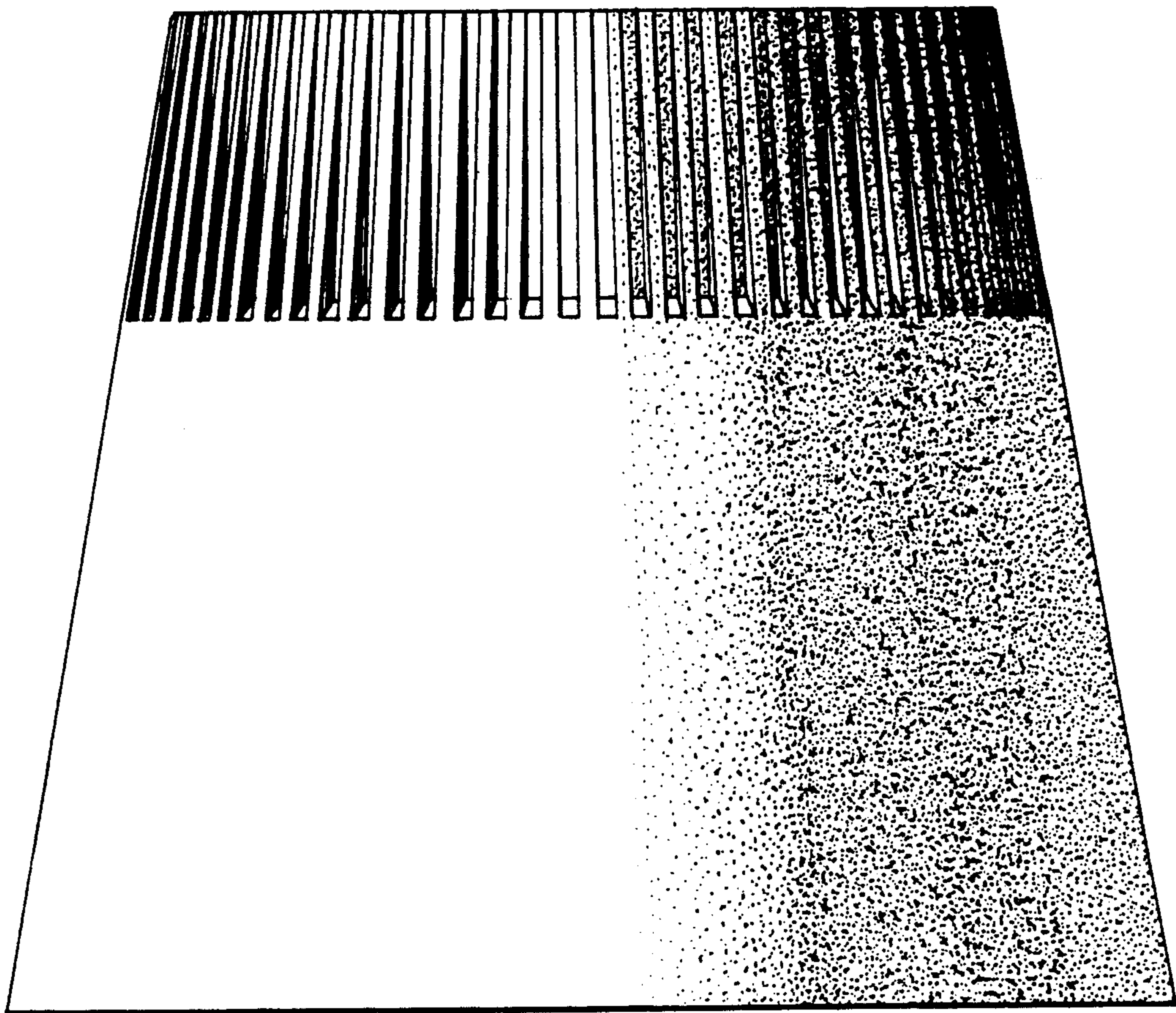

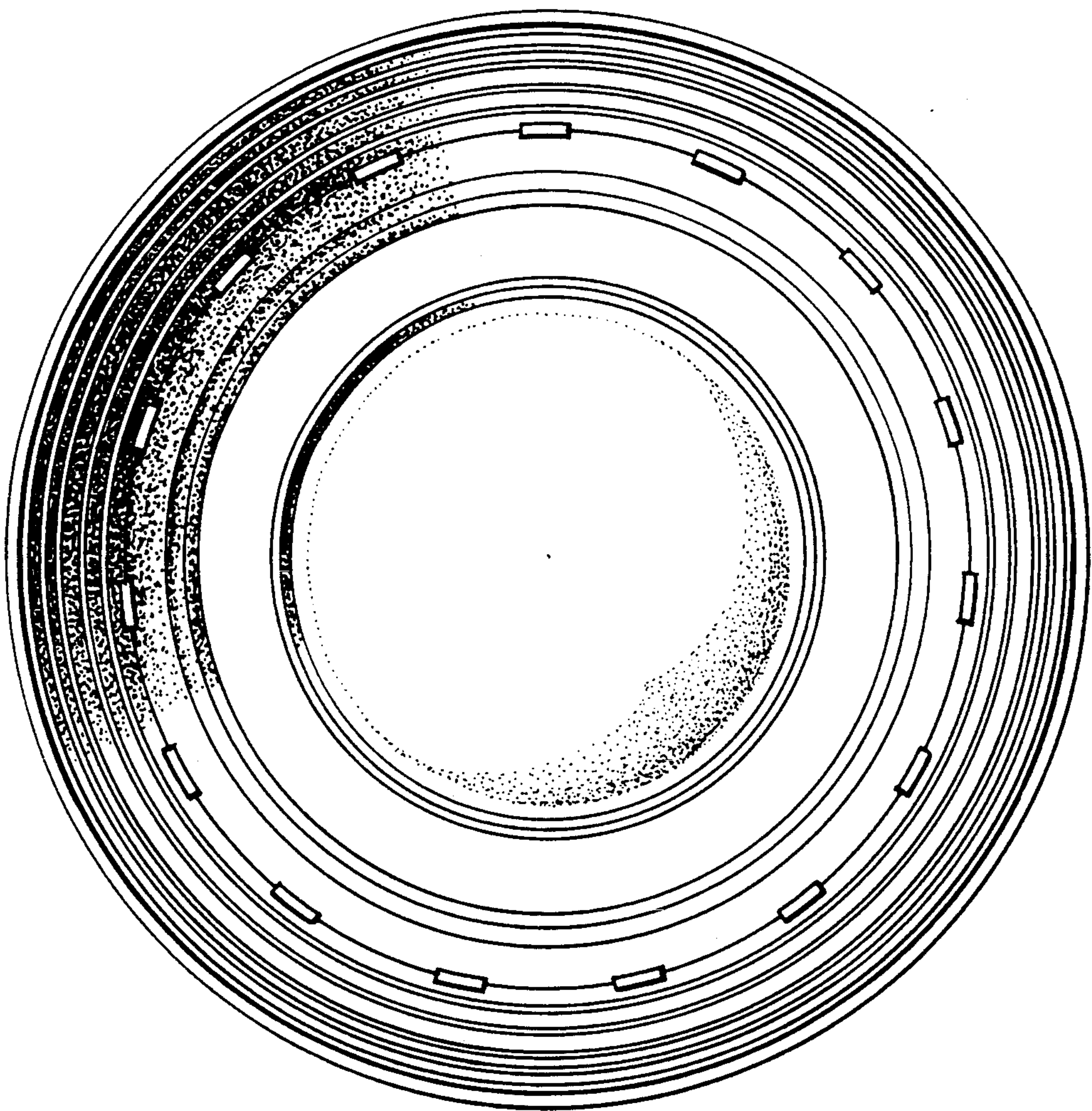
