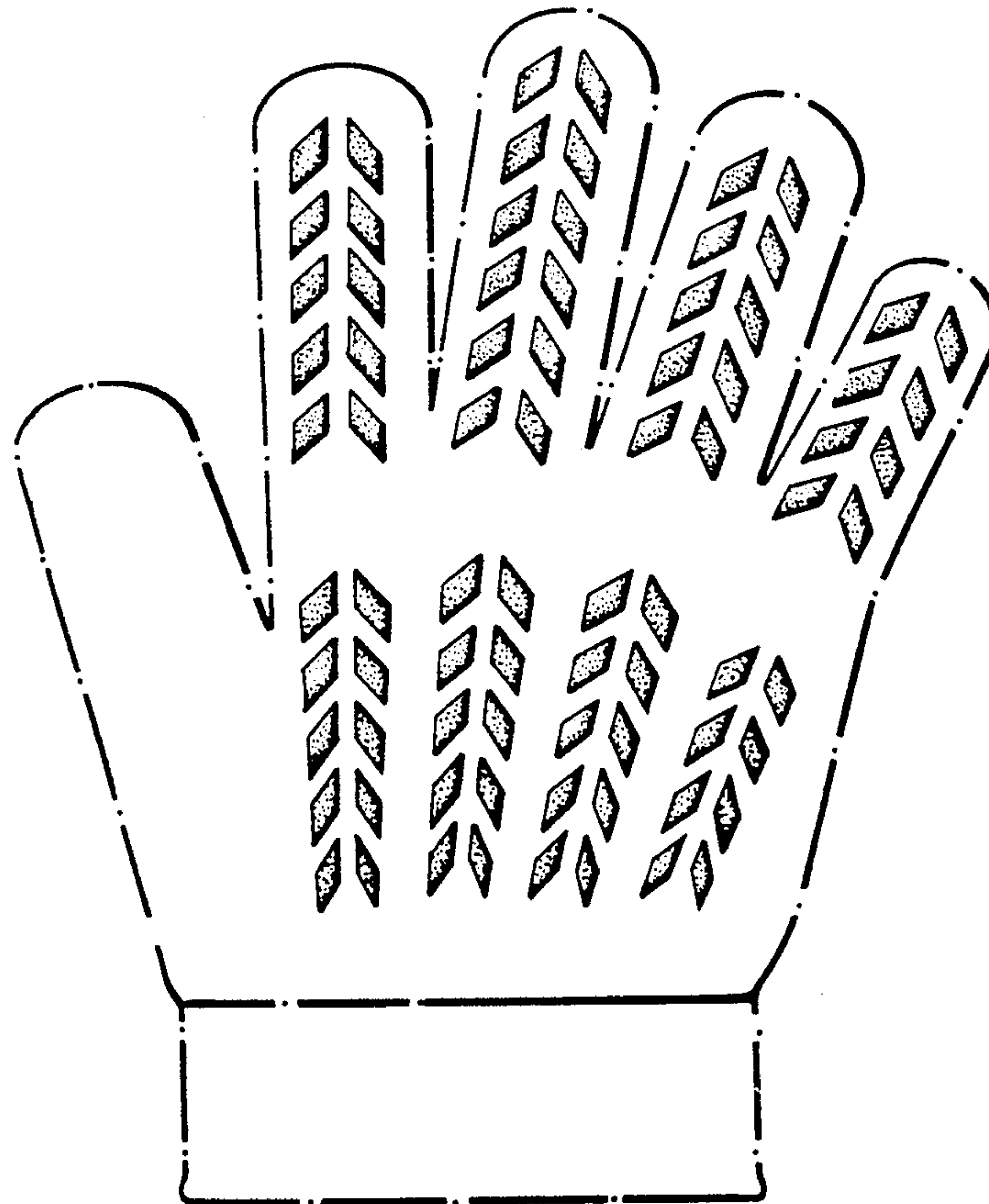
[57] **CLAIM**

The ornamental design for a tread for a glove, as shown and described.

**DESCRIPTION**

FIG. 1 is a front elevational view of a tread for a glove showing my new design, the rear of the tread being a mirror image thereof;  
 FIG. 2 is a side elevation view thereof;  
 FIG. 3 is the other side elevational view thereof;  
 FIG. 4 is a top plan view thereof;  
 FIG. 5 is a bottom plan view thereof;  
 FIG. 6 is a front elevational view of another embodiment thereof, the rear of the tread being a mirror image thereof;  
 FIG. 7 is a an opposite side elevational view thereof;  
 FIG. 8 is an opposite side elevational view thereof;  
 FIG. 9 is a top plan view thereof; and  
 FIG. 10 is a bottom plan view thereof.  
 The broken line showing of the glove is for illustrative purposes only and forms no part of the claimed design.

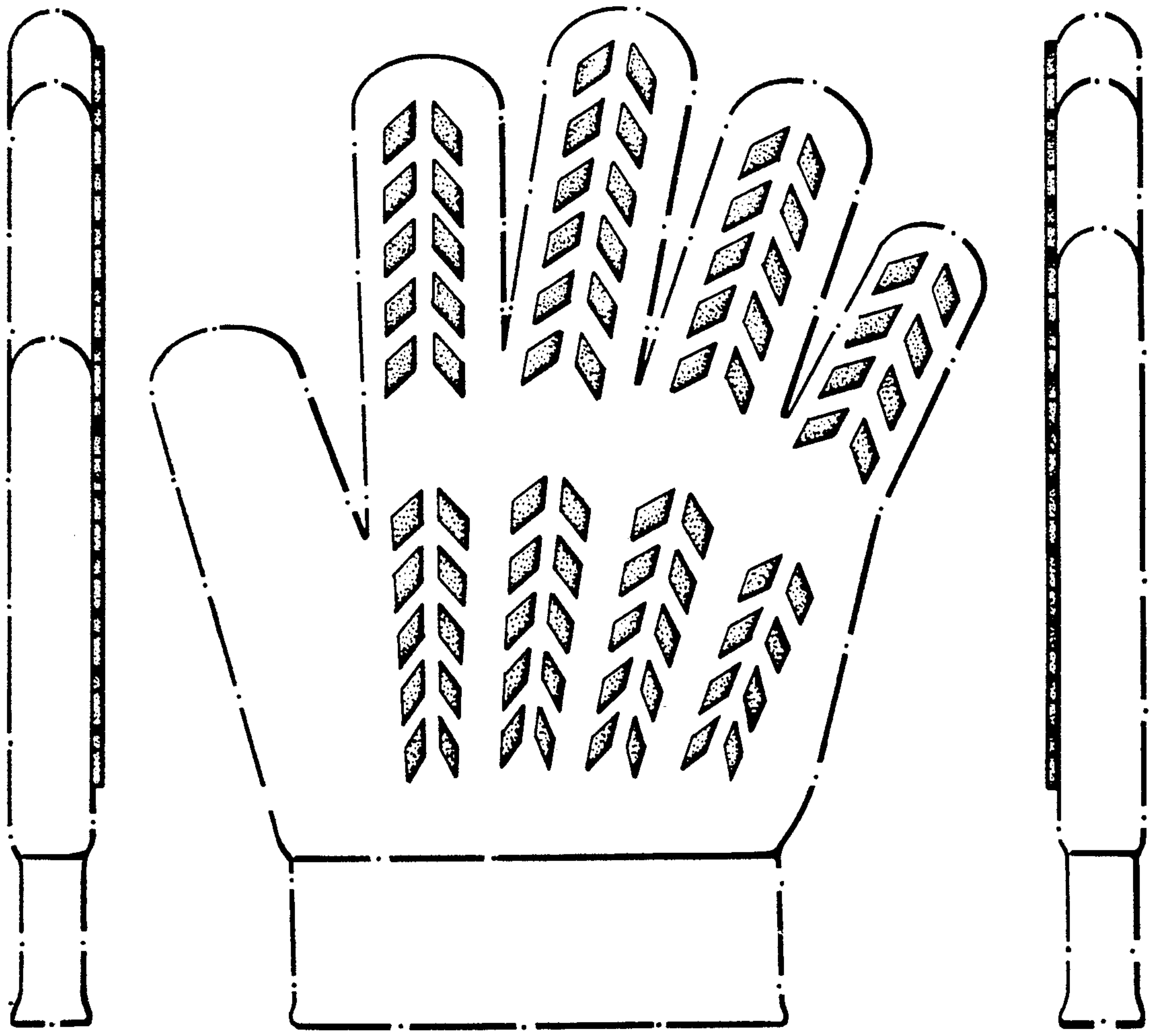

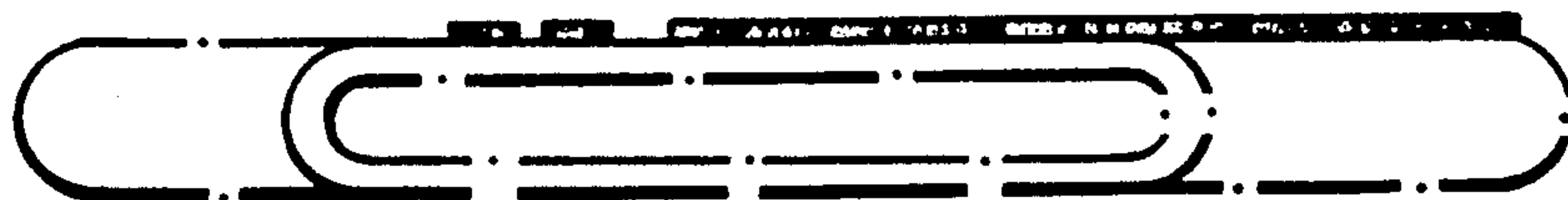

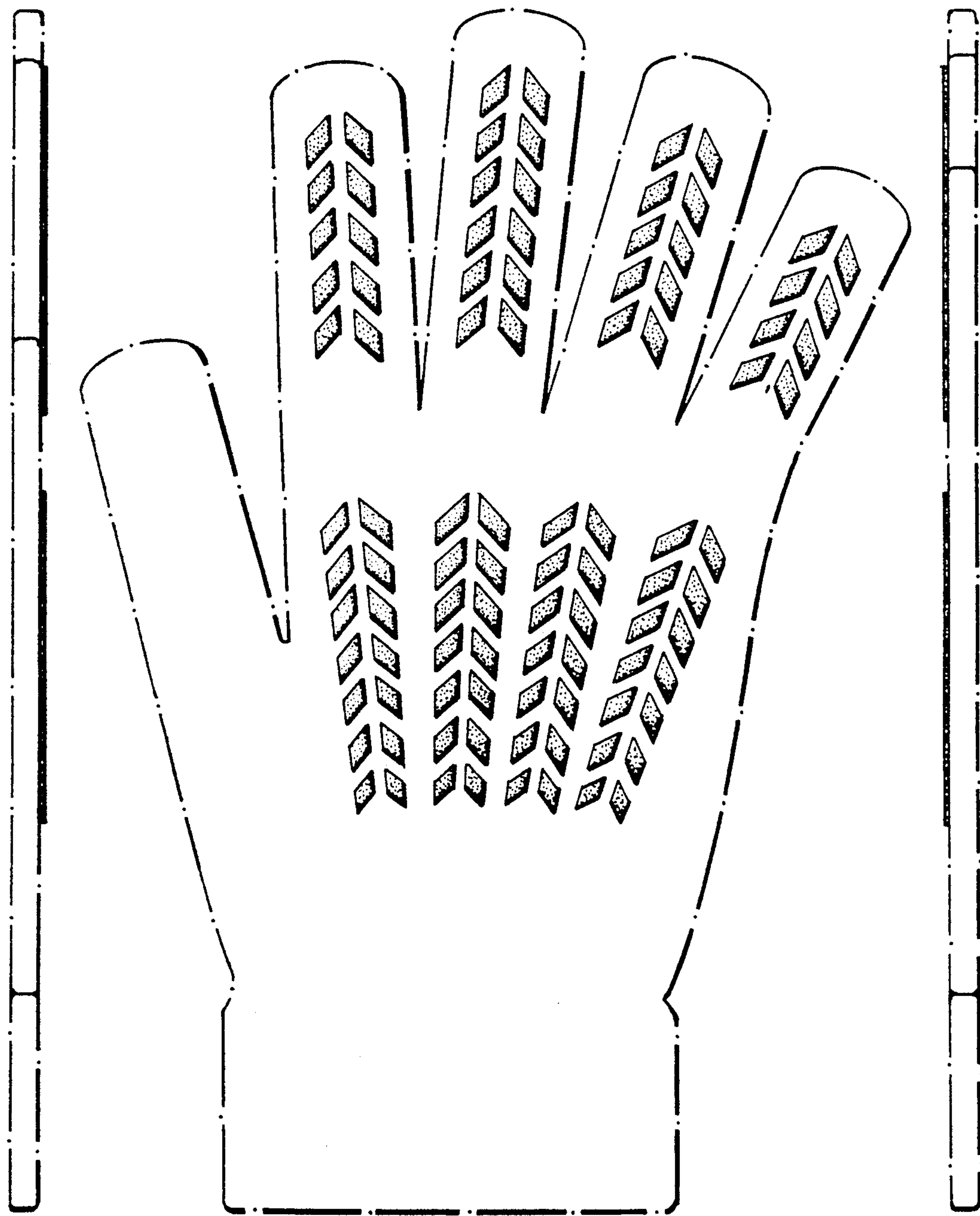

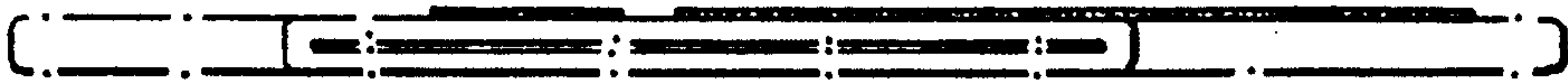
