FIG. 1 is a right rear perspective view of an accessory shoe for a camera showing my new design;


FIG. 2 is a top plan view thereof;

FIG. 3 is a rear elevational view thereof;


FIG. 4 is an enlarged top plan view thereof;

The broken line portions of the drawings are for illustrative purposes only and form no part of the claimed design.












