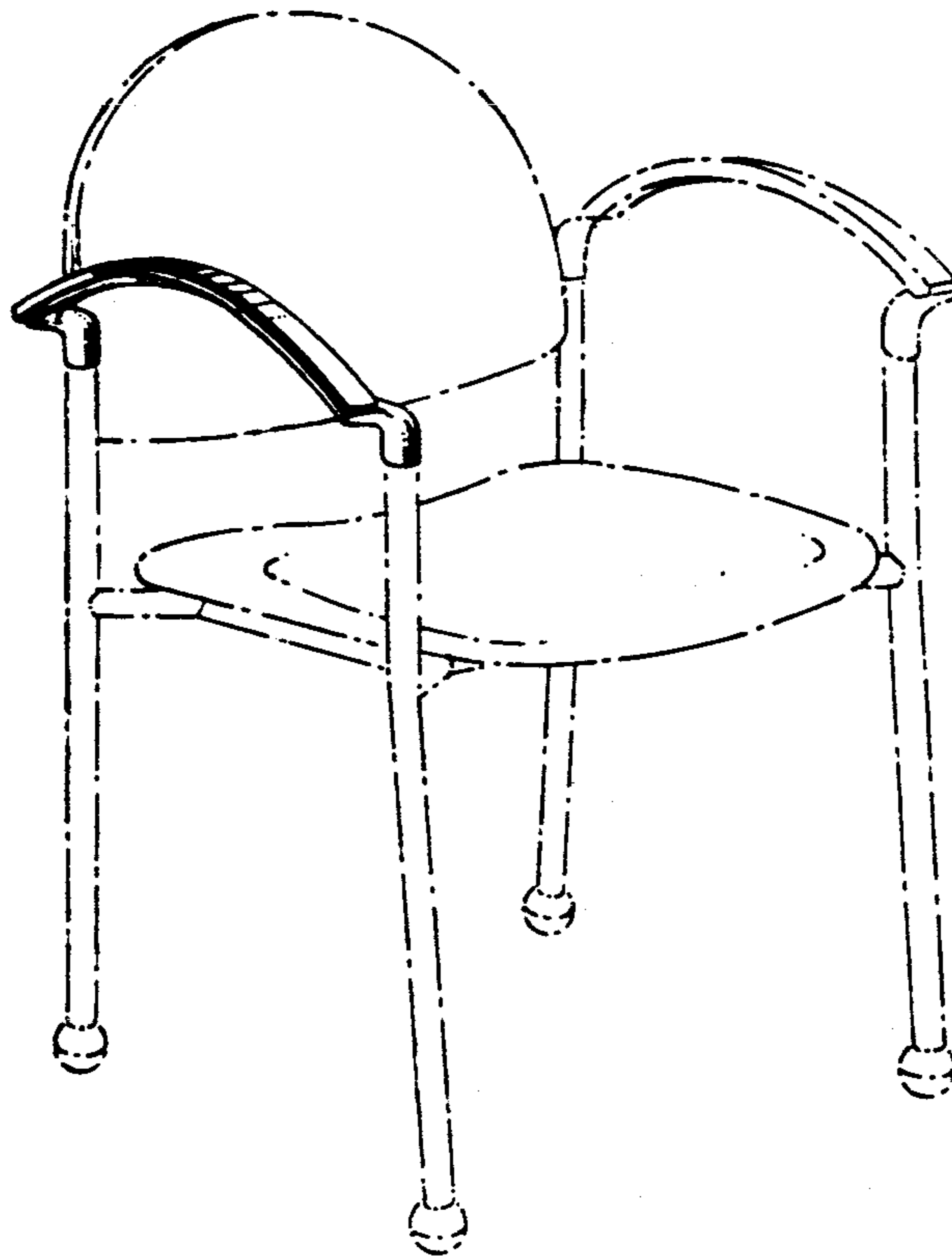

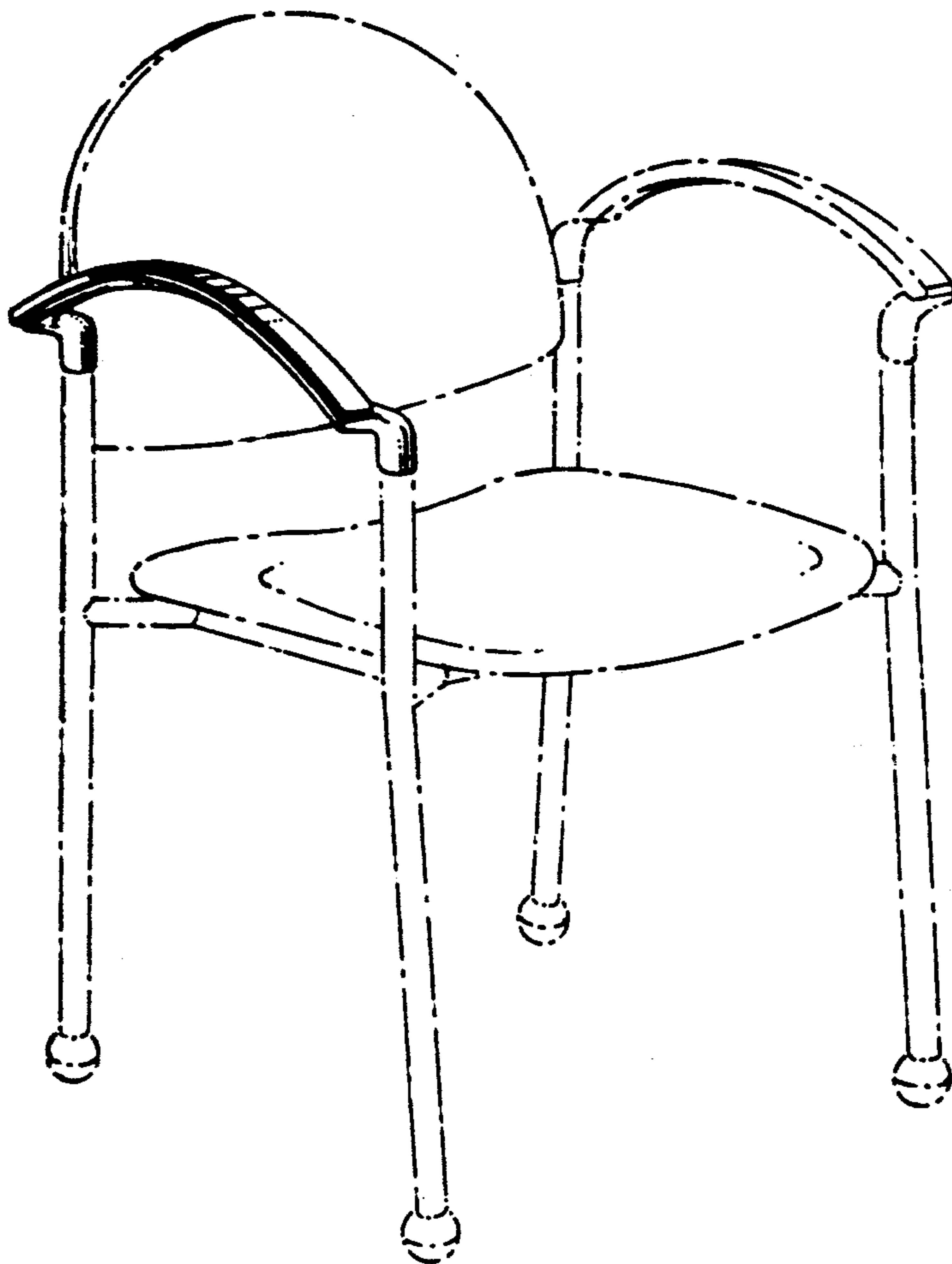
The ornamental design for a chair arm, as shown and described.

DESCRIPTION

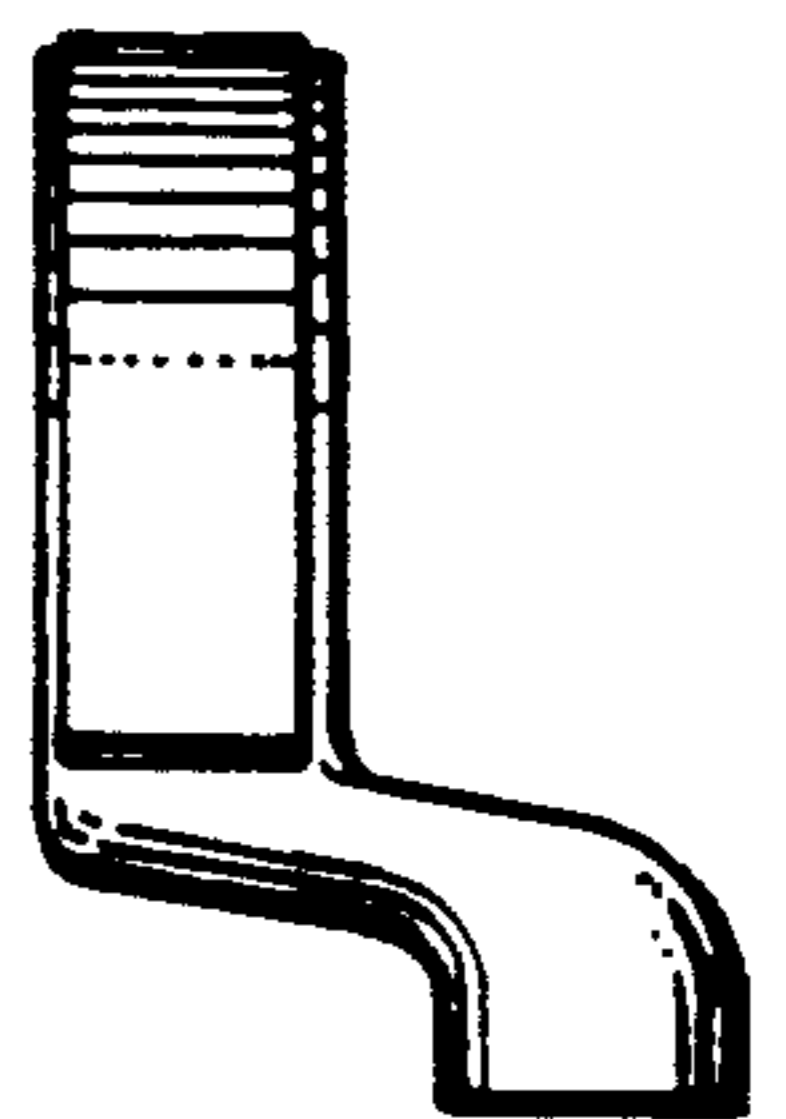
FIG. 1 is a perspective view of a chair arm, showing my new design, the broken lines are for illustrative purposes only;

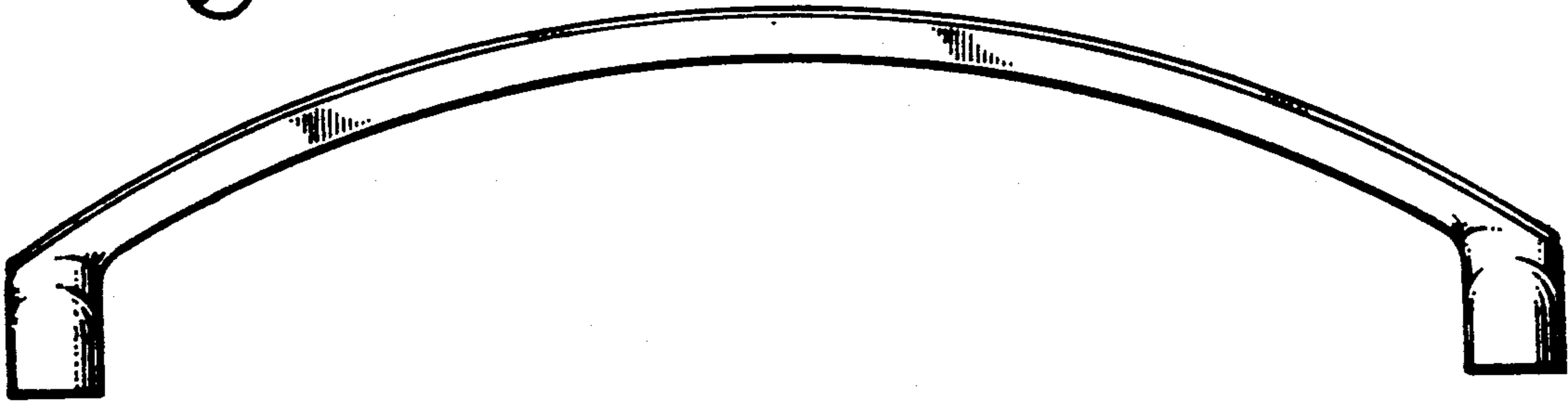

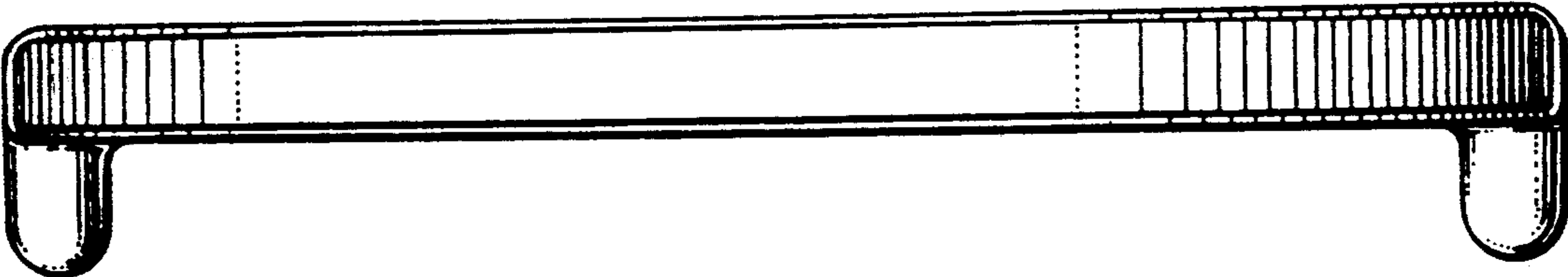
