[57] CLAIM

The ornamental design for a travel alarm clock, as shown and described.

DESCRIPTION

FIG. 1 is a front elevational view of a travel alarm clock showing my new design in an open position;
FIG. 2 is a rear elevational view thereof;
FIG. 3 is a top plan view thereof;
FIG. 4 is a bottom plan view thereof;
FIG. 5 is a left side elevational view thereof;
FIG. 6 is a right side elevational view thereof;
FIG. 7 is a front and top-right perspective view thereof;
FIG. 8 is a front elevational view thereof in the closed condition;
FIG. 9 is a rear elevational view thereof in the closed condition;
FIG. 10 is a top plan view thereof in the closed condition;
FIG. 11 is a bottom plan view thereof in the closed condition;
FIG. 12 is a left side elevational view thereof in the closed condition;
FIG. 13 is a right side elevational view thereof in the closed condition; and
FIG. 14 is a front and top-right perspective view thereof in the closed position.

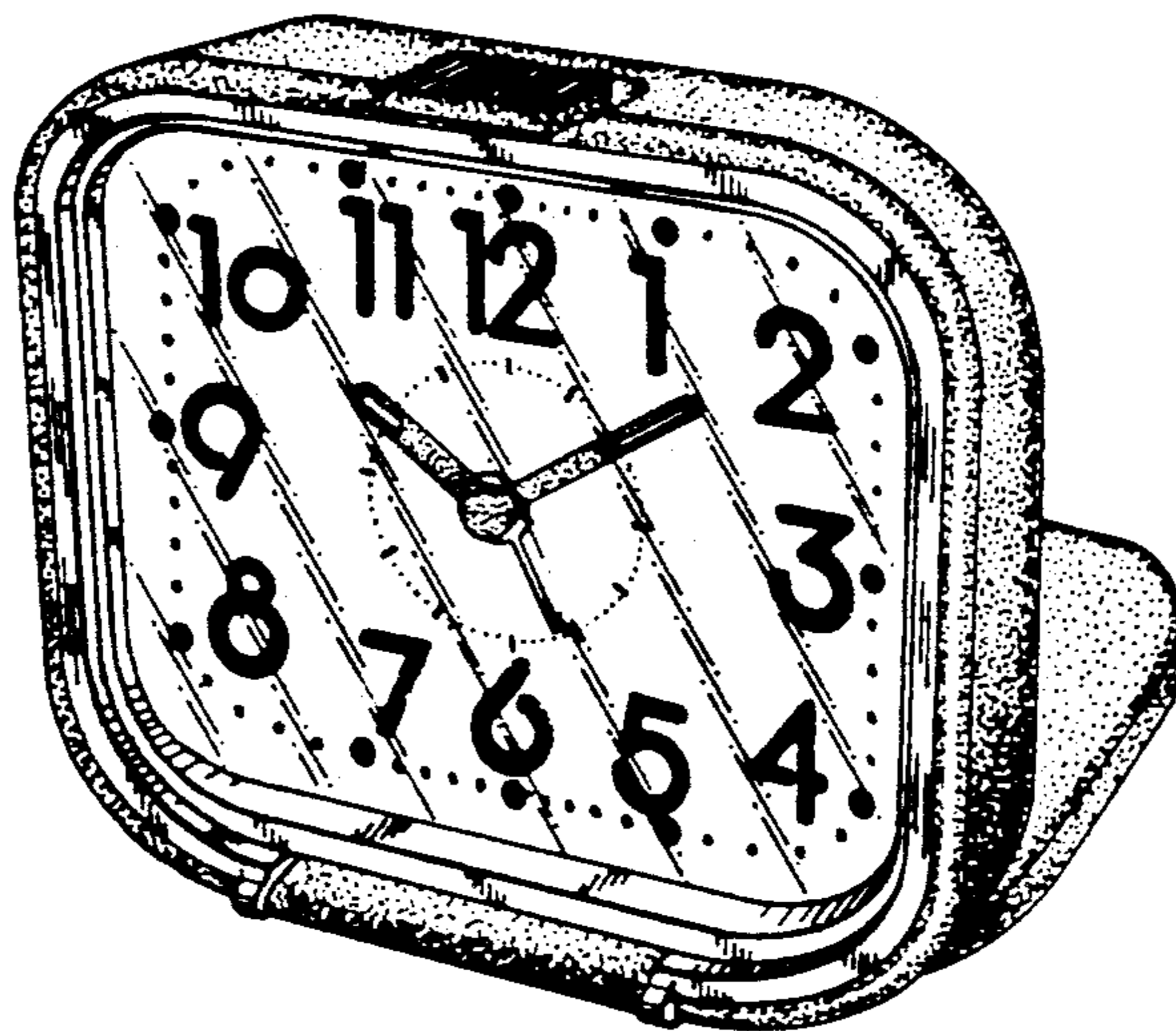

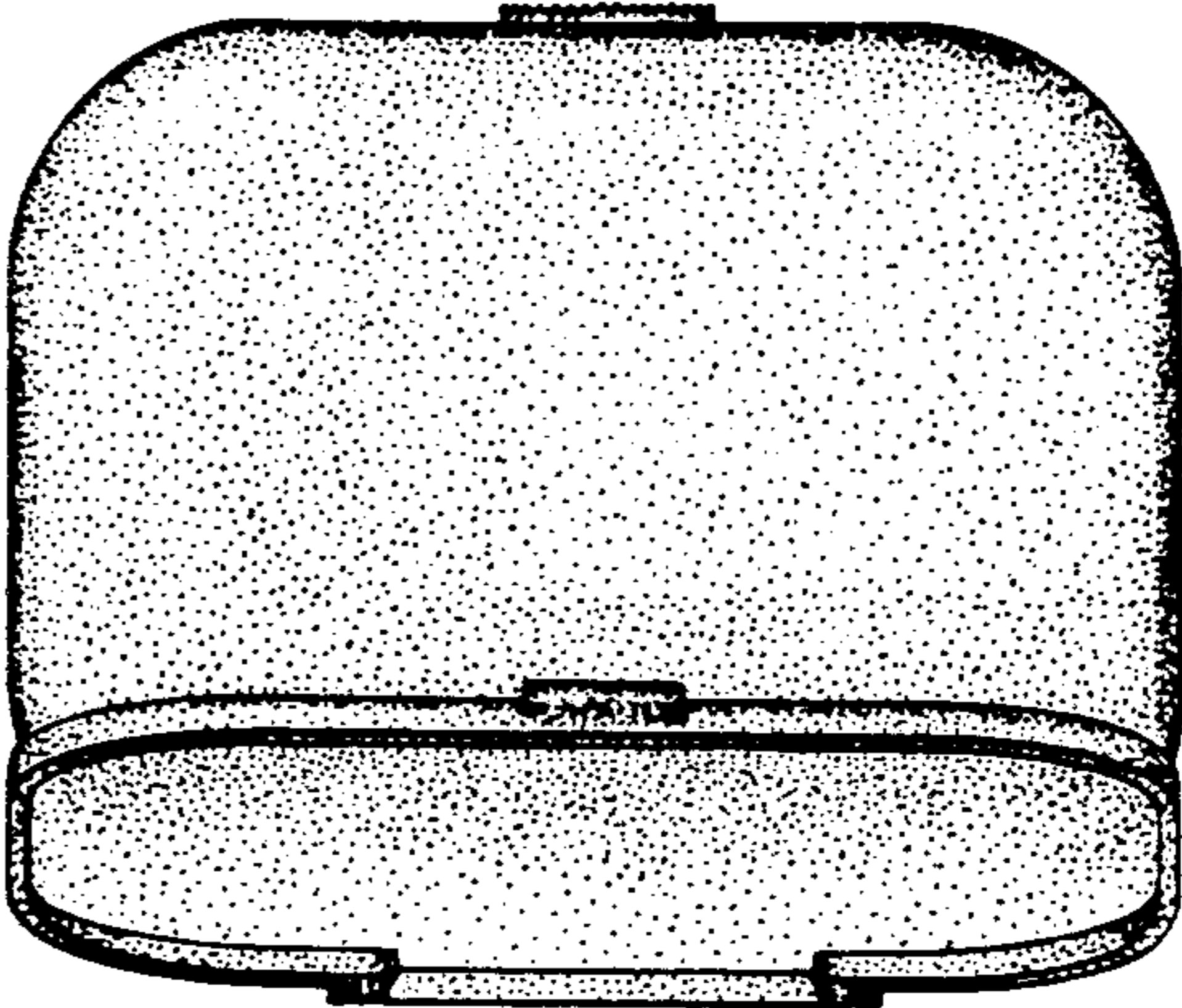

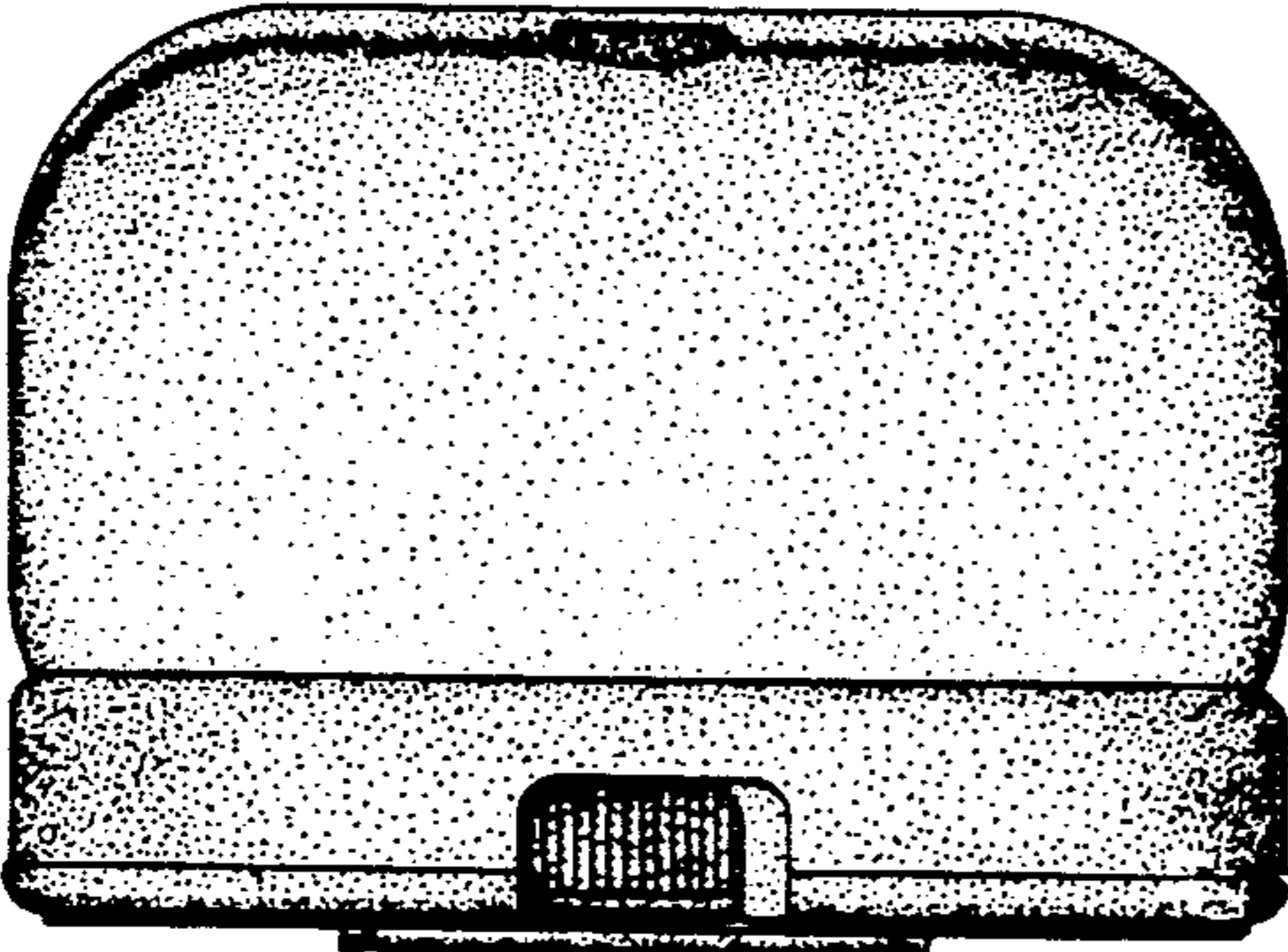

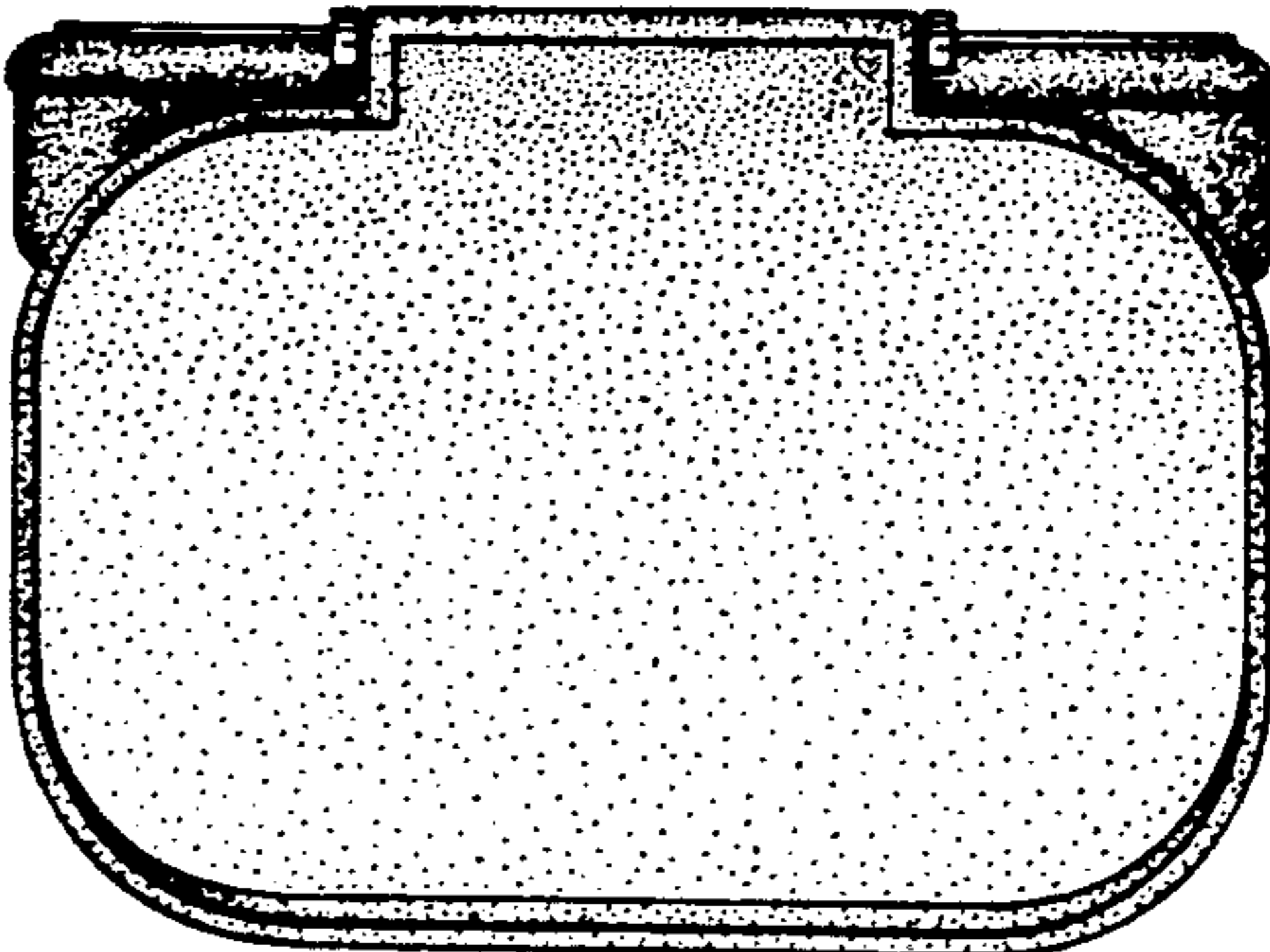

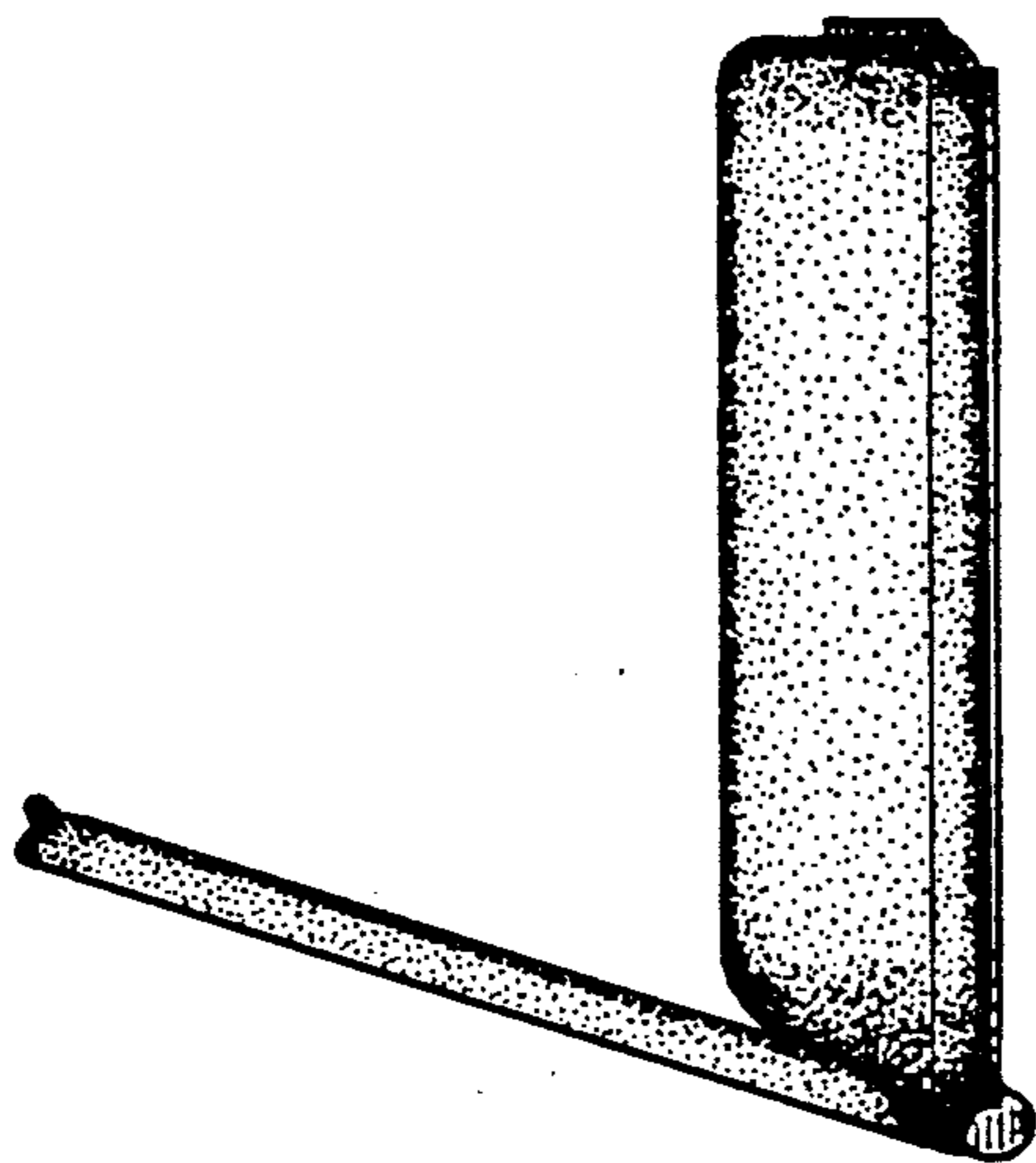

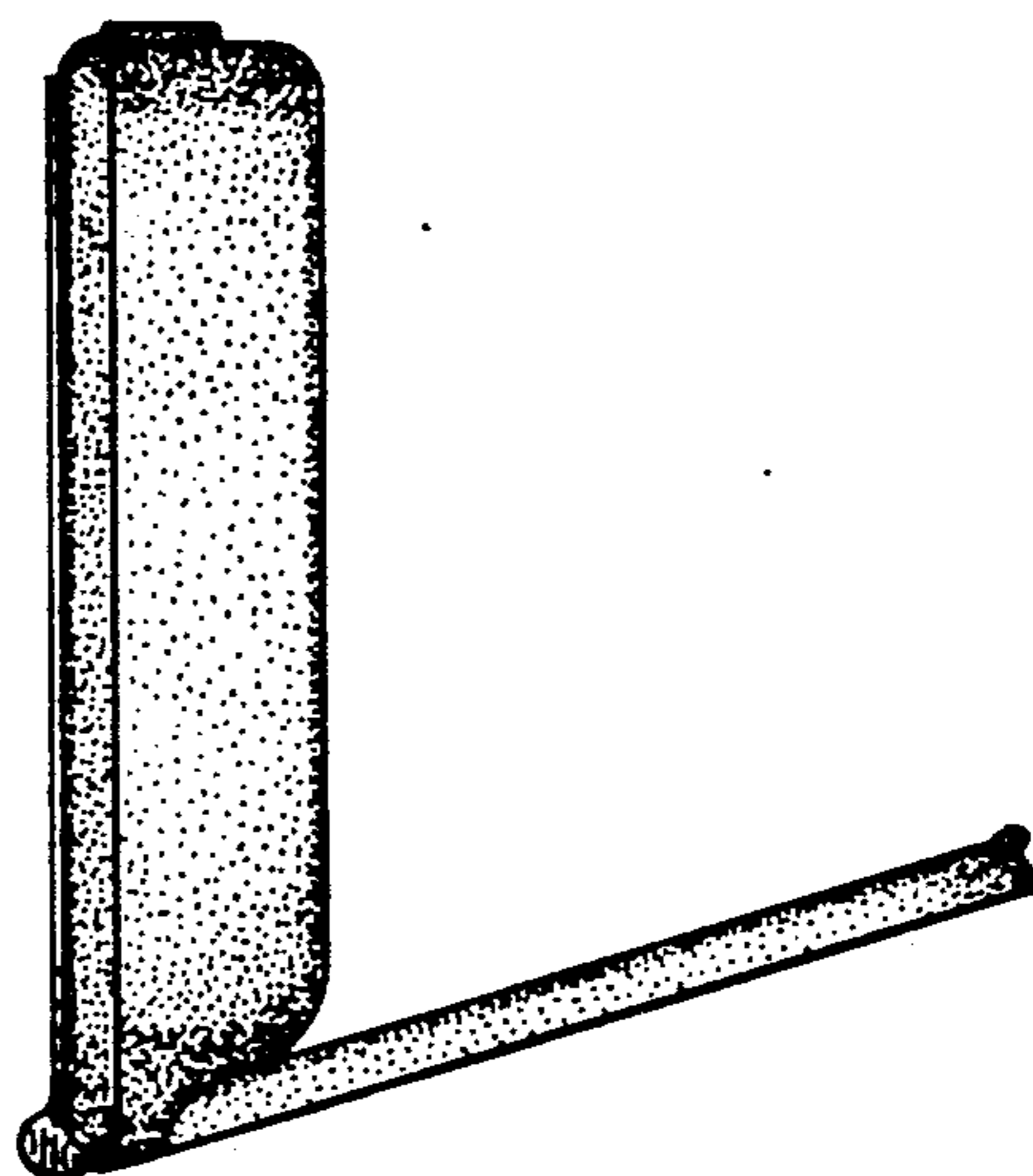

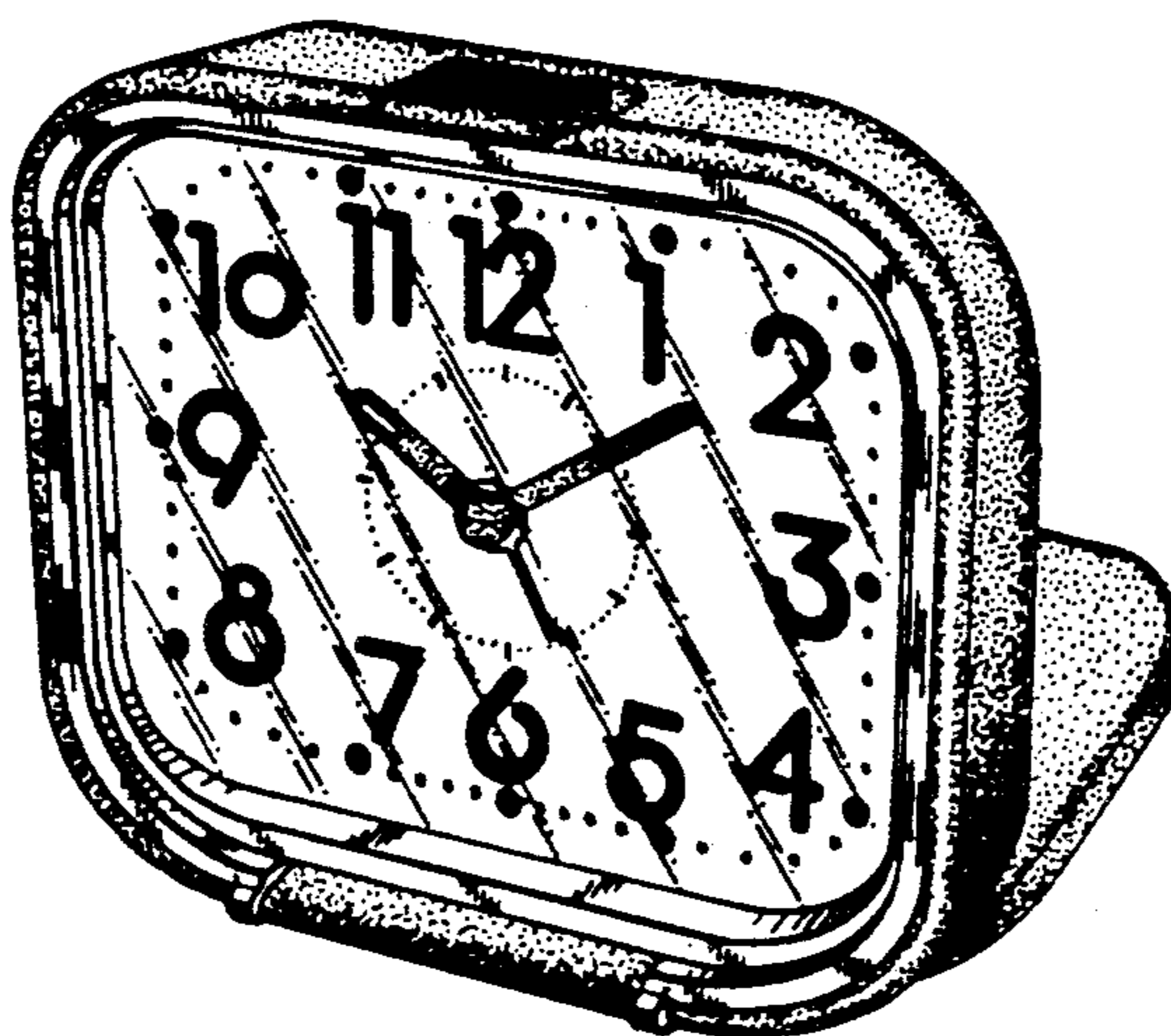

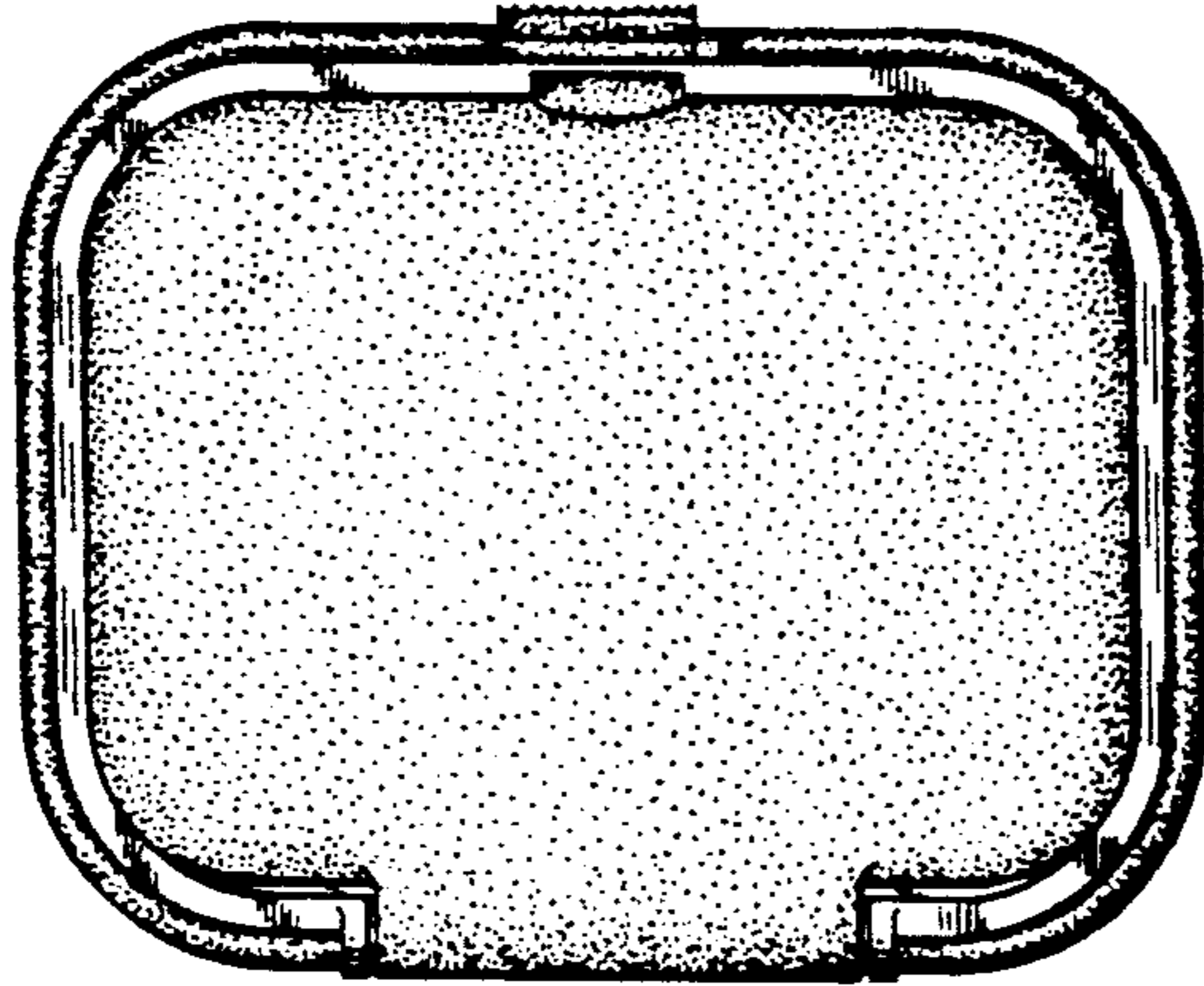

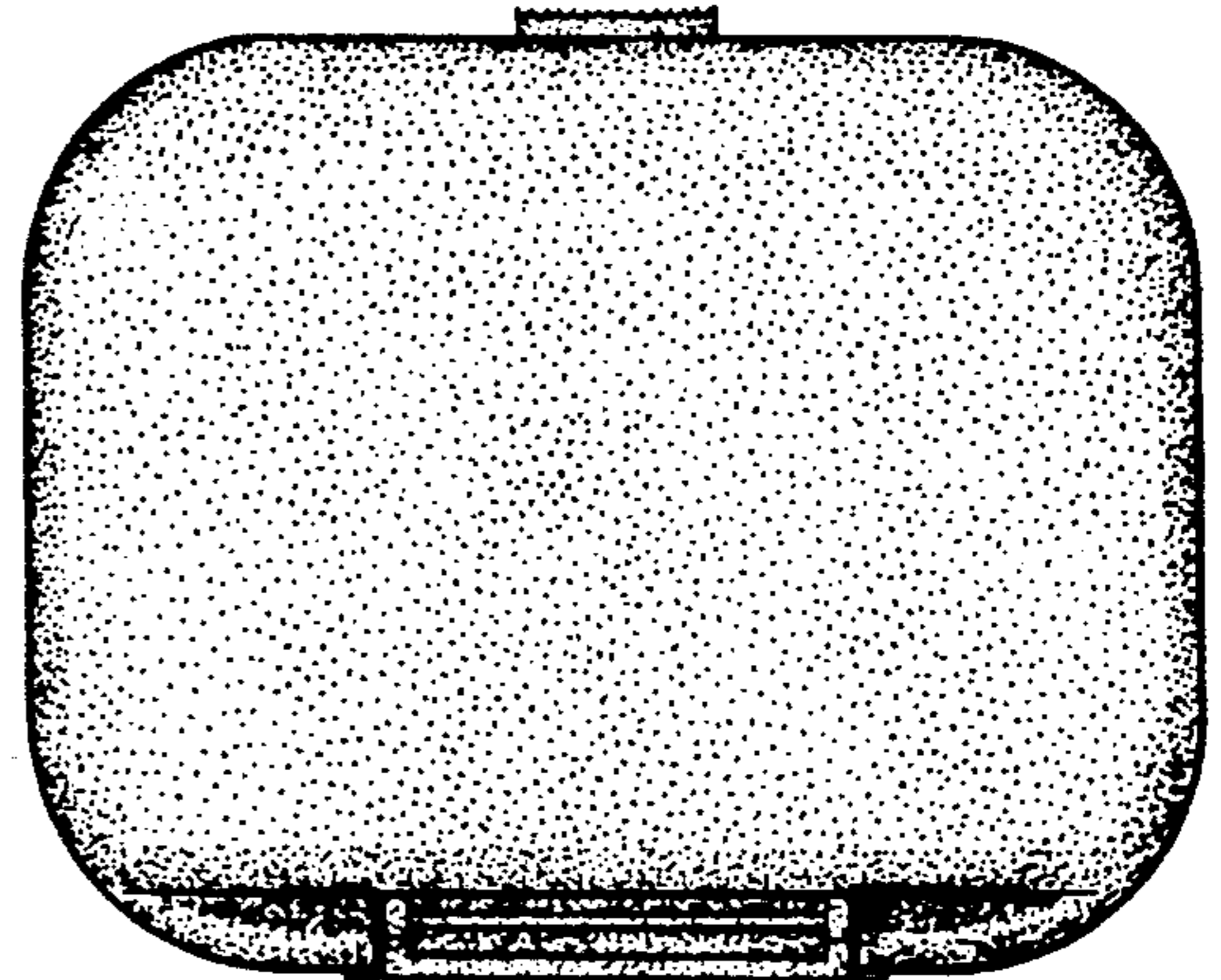

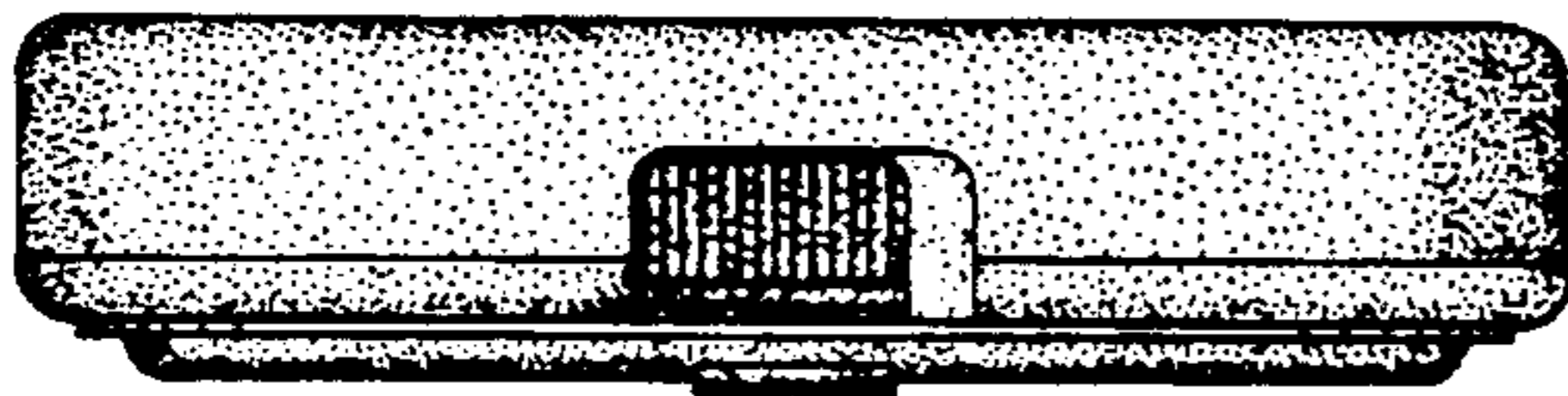

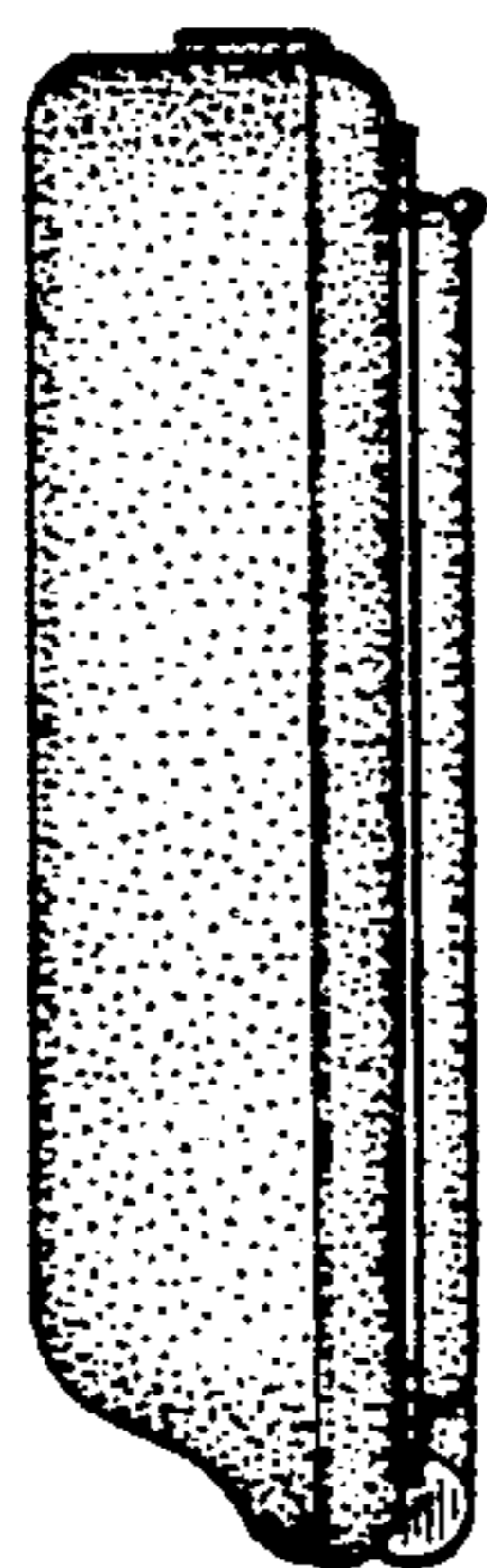

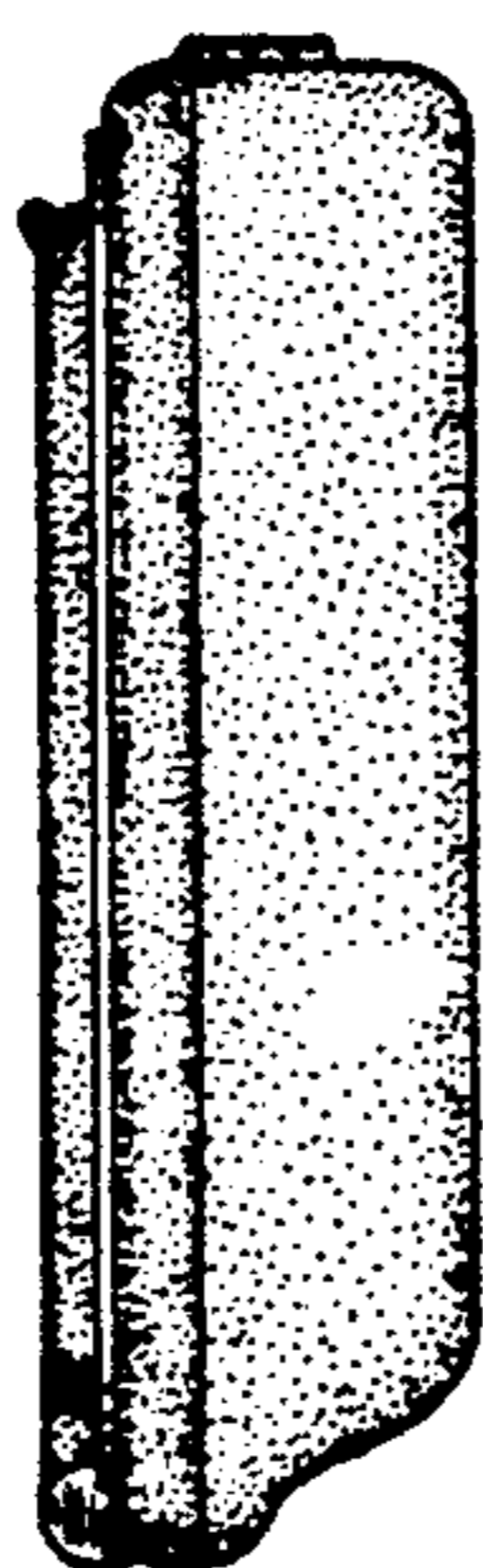

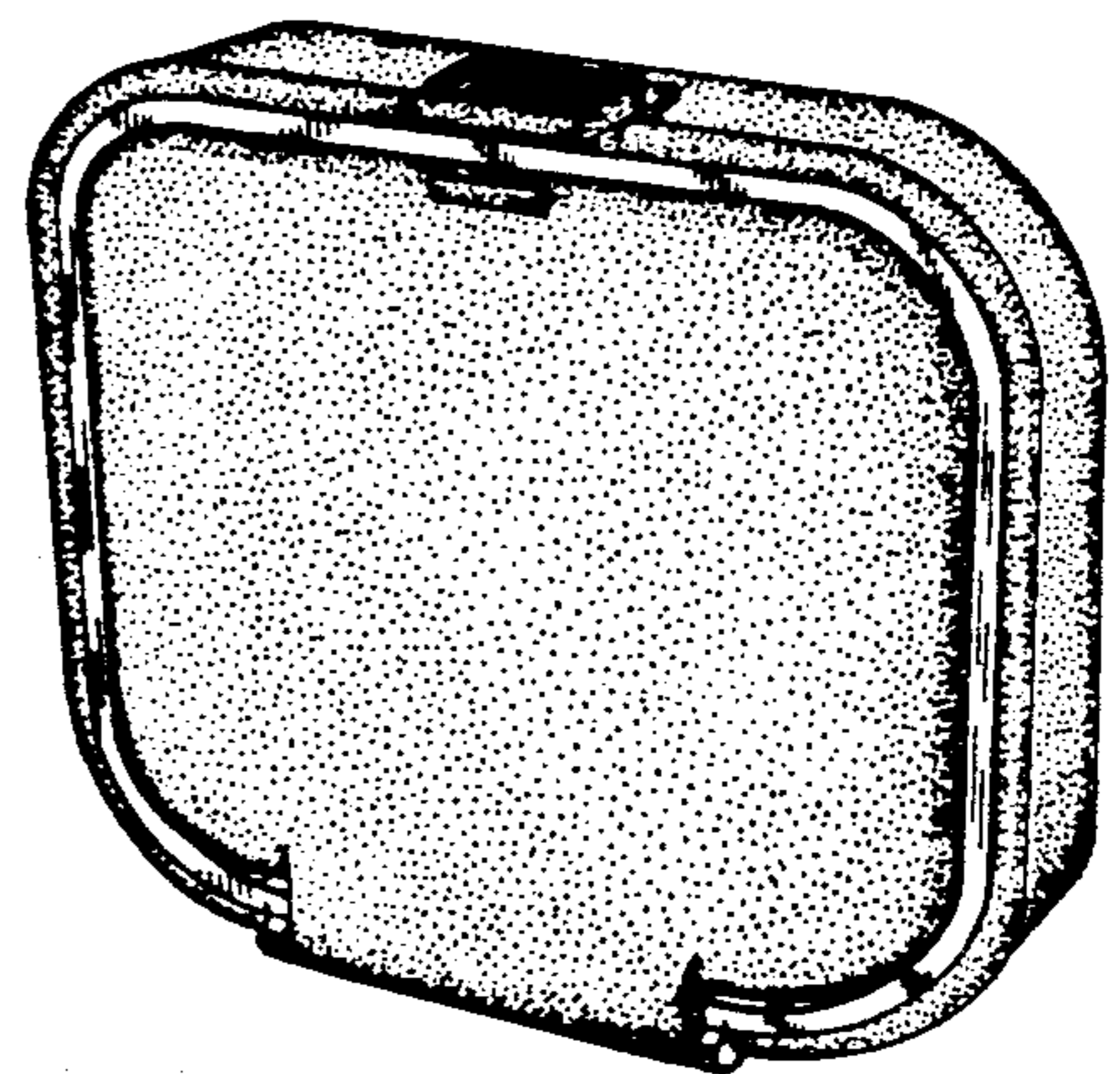
